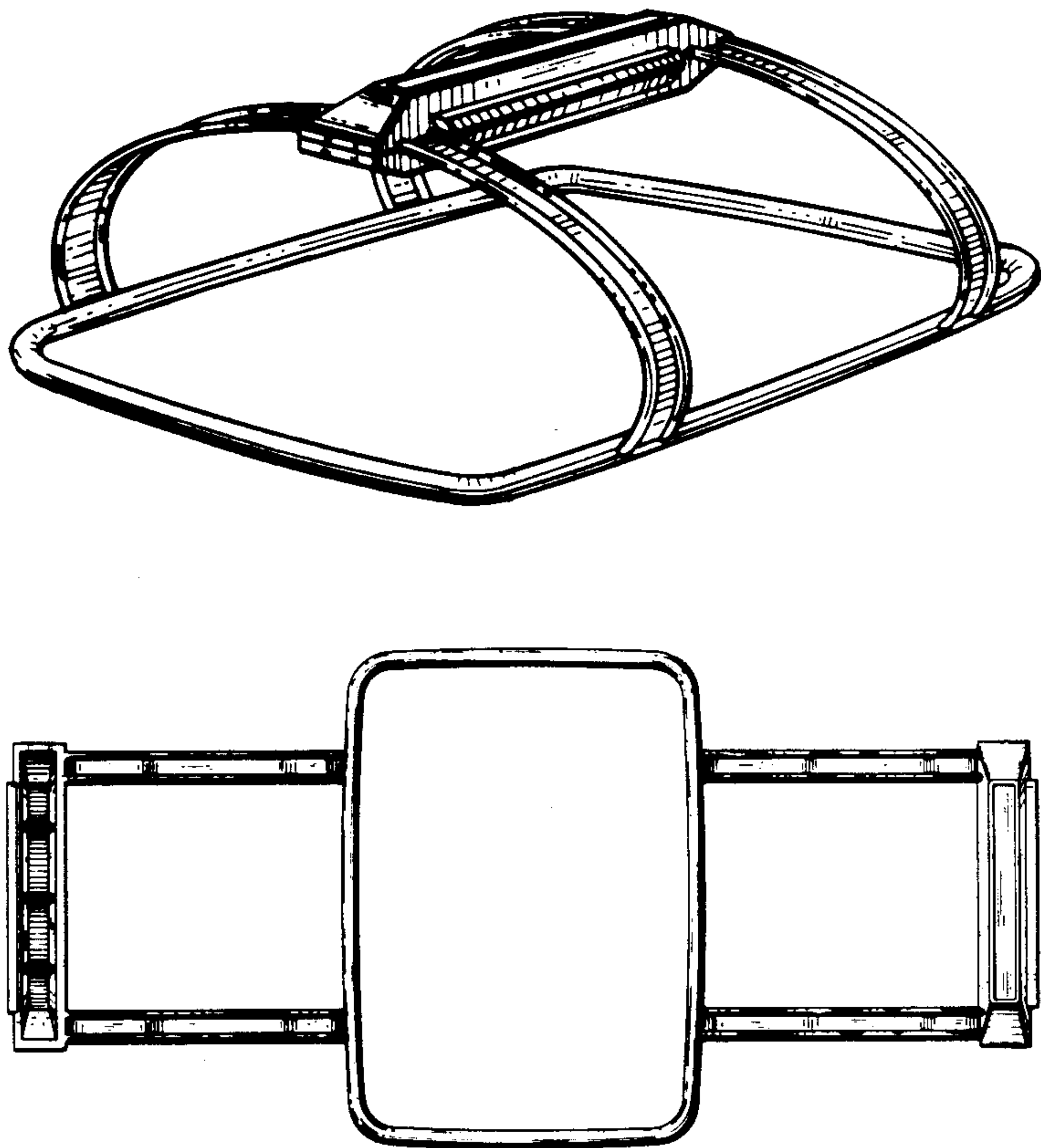

[57] **CLAIM**

The ornamental design for a combined removable carrying handle and frame for a food storage container, as shown and described.

DESCRIPTION

FIG. 1 is an upper perspective view of a combined removable carrying handle and frame for a food storage container showing our new design; FIG. 2 is an end elevational view thereof from the left end of FIG. 1 but also including in phantom for environmental and illustrative purposes a typical vessel structure with which the combined removable carrying handle and frame may be employed; FIG. 3 is a side elevational view thereof from the right side of FIG. 1 but also including in phantom for environmental and illustrative purposes a typical vessel structure with which the combined removable carrying handle and frame may be employed; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a side elevational view thereof as it would appear in an unstressed condition; FIG. 7 is a top plan view thereof of FIG. 6; FIG. 8 is a side elevational view thereof opposite that shown in FIG. 6; FIG. 9 is a bottom plan view thereof of FIG. 7; FIG. 10 is an end elevational view thereof from the left of FIG. 9; and FIG. 11 is an end elevational view from the right of FIG. 9.



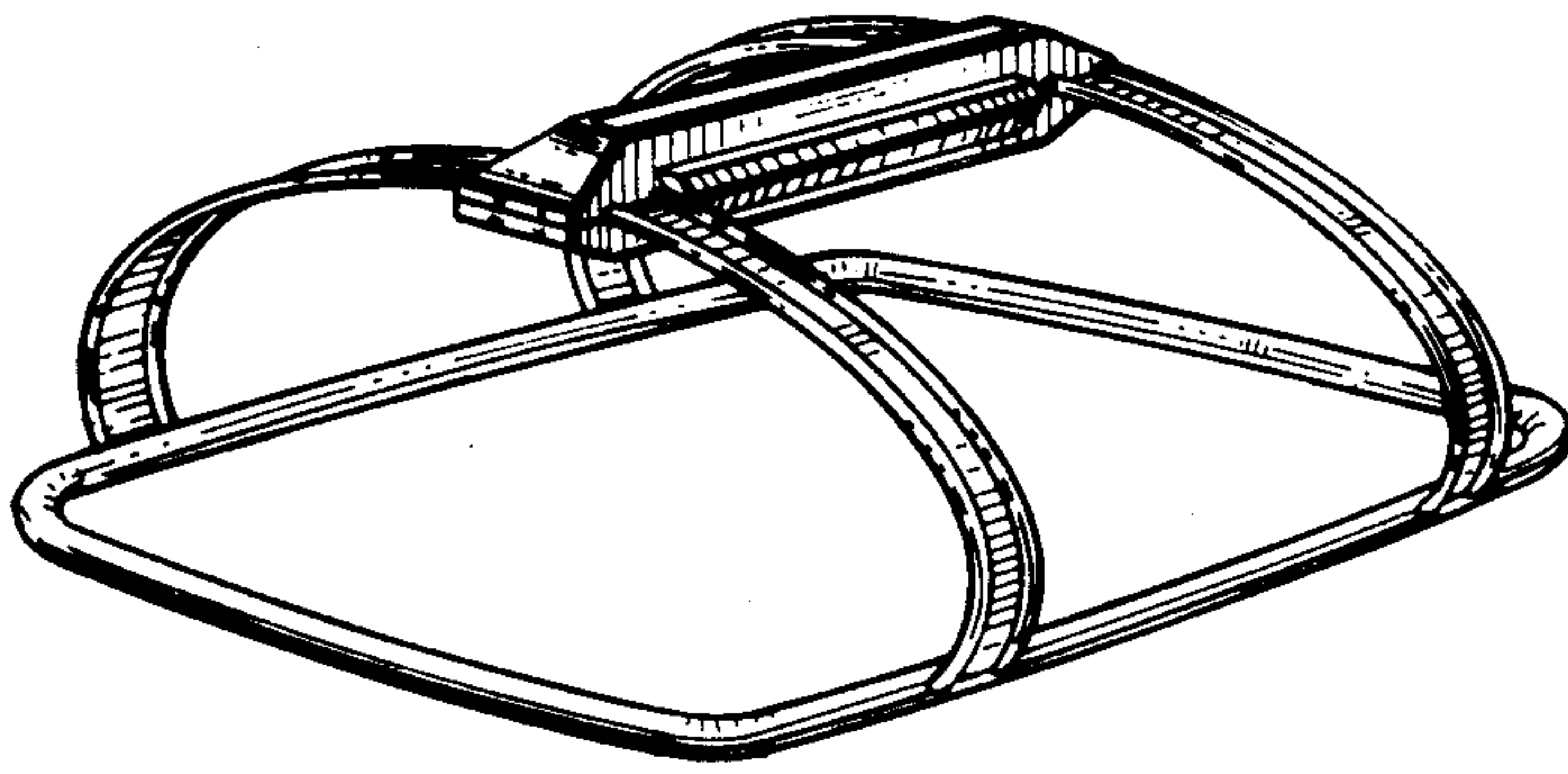

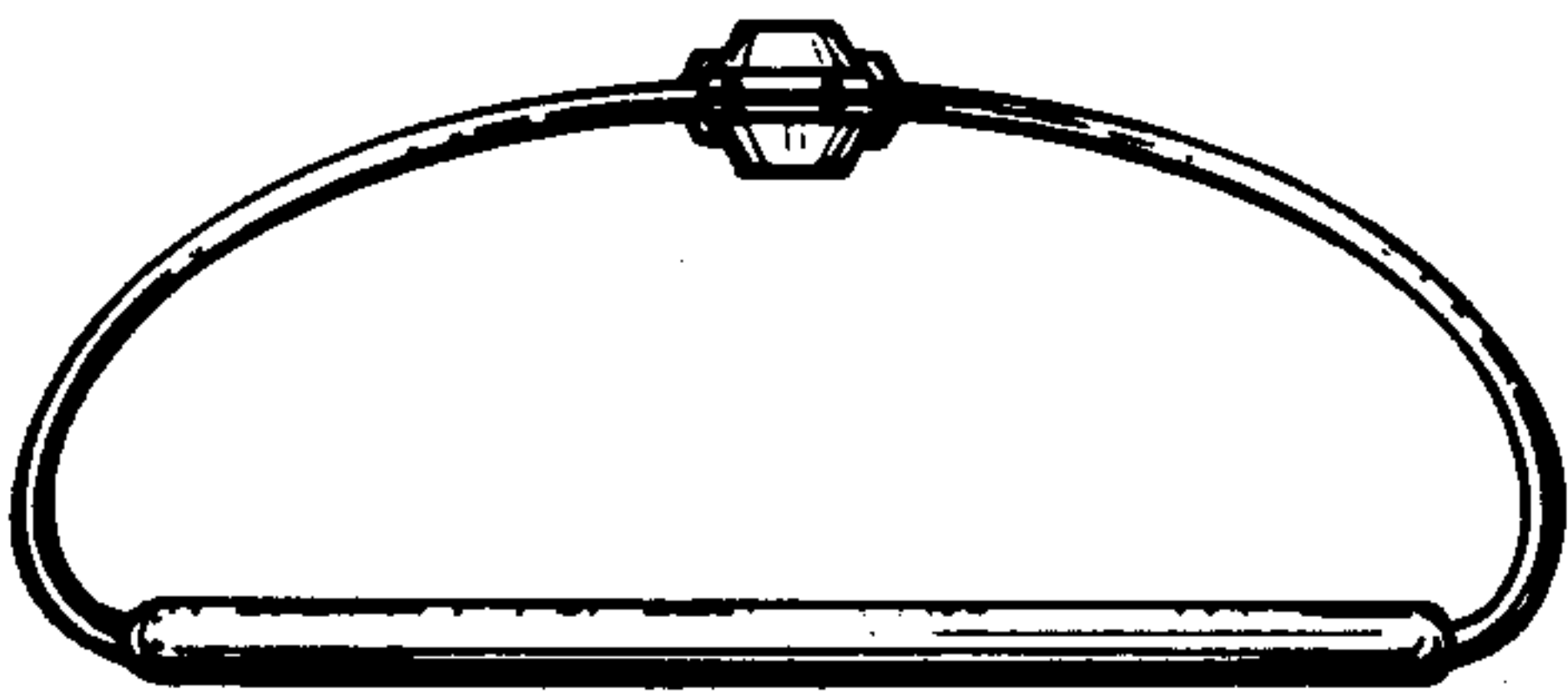

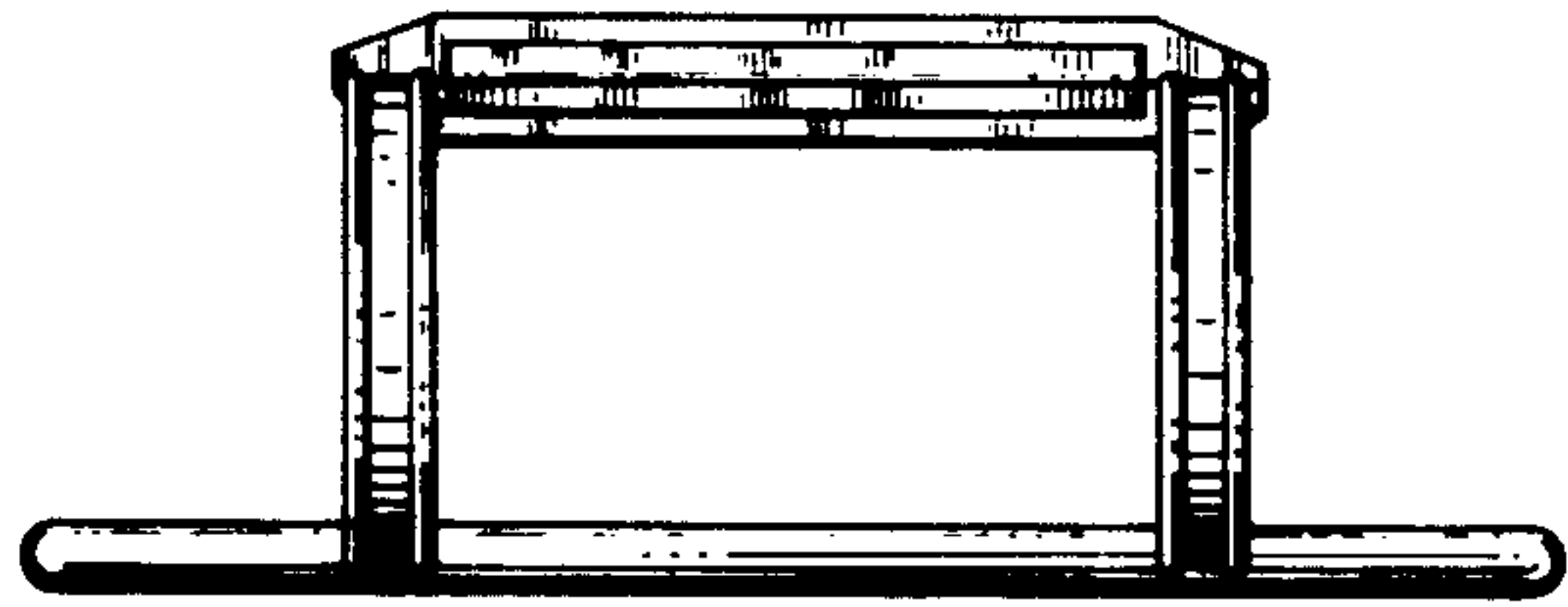

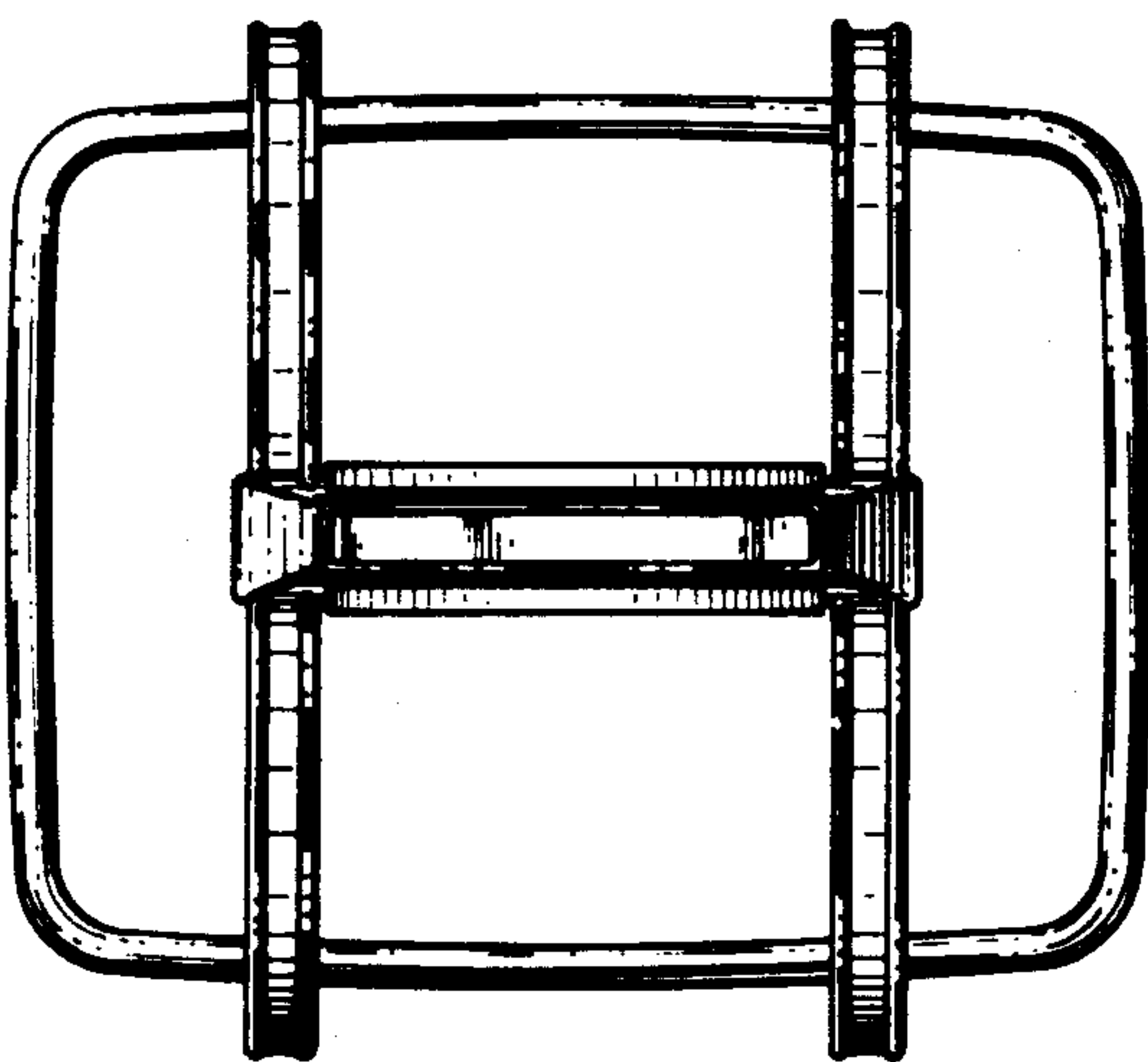

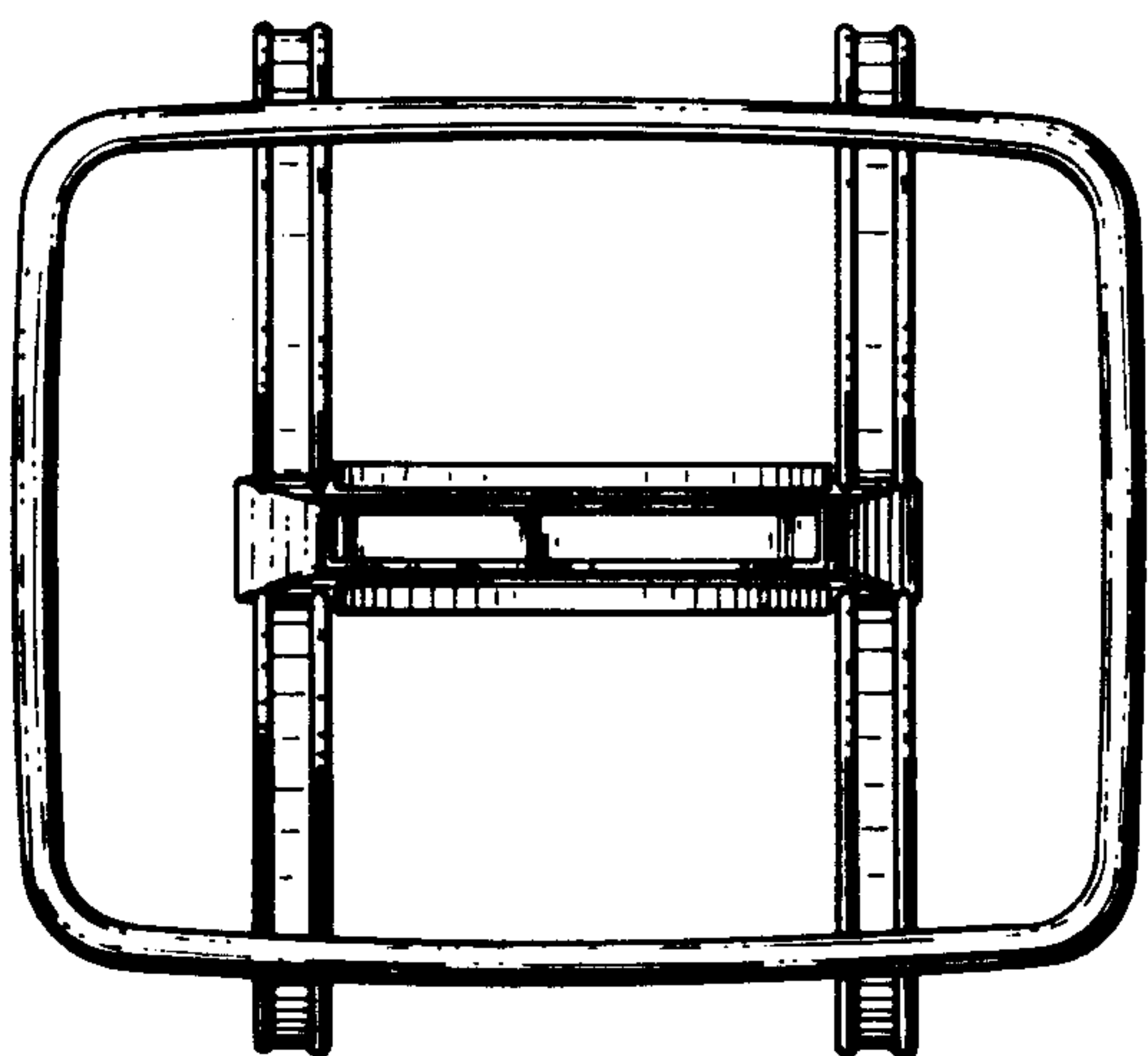

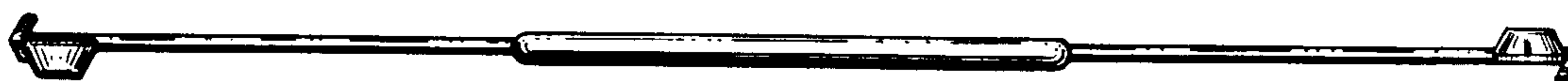

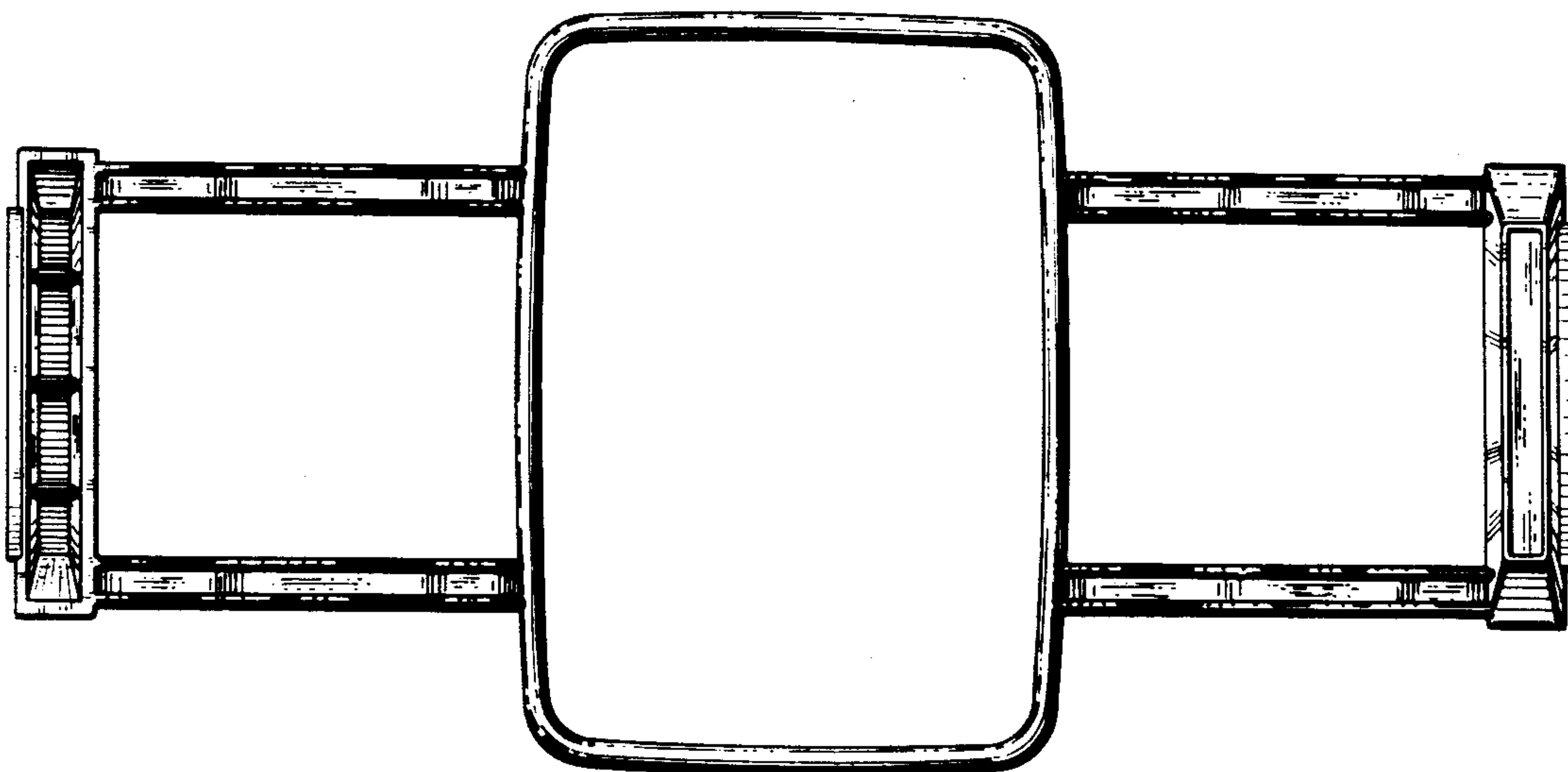

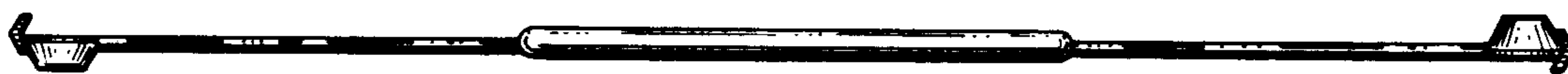

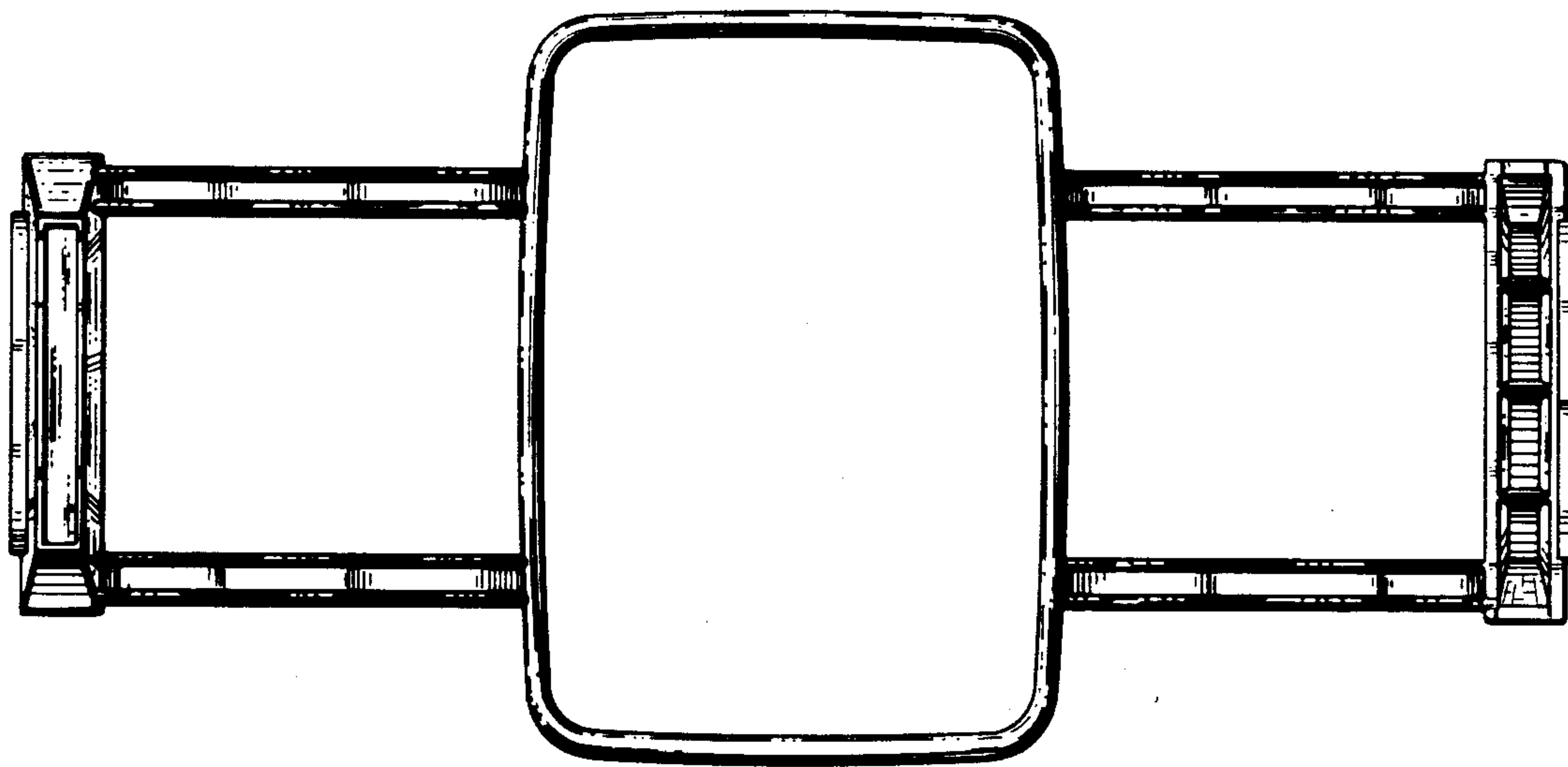

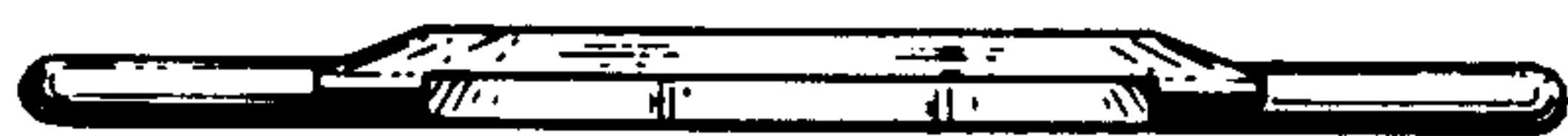
