The ornamental design for an orthopedic insole, substantially as shown and described.

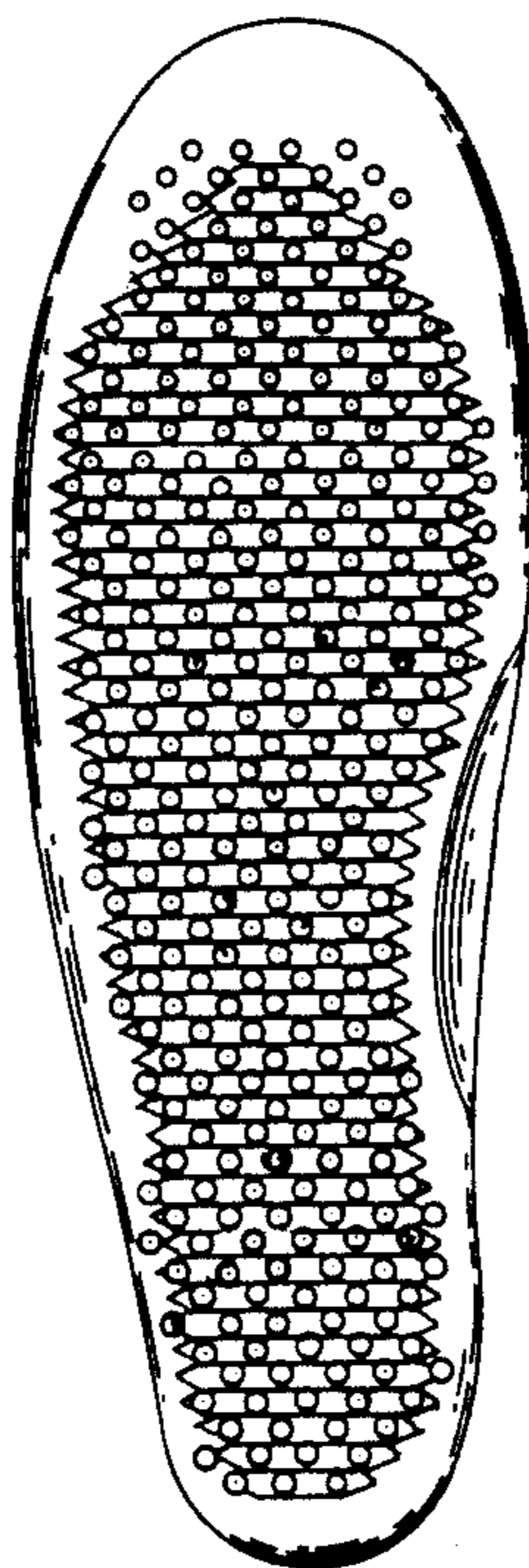

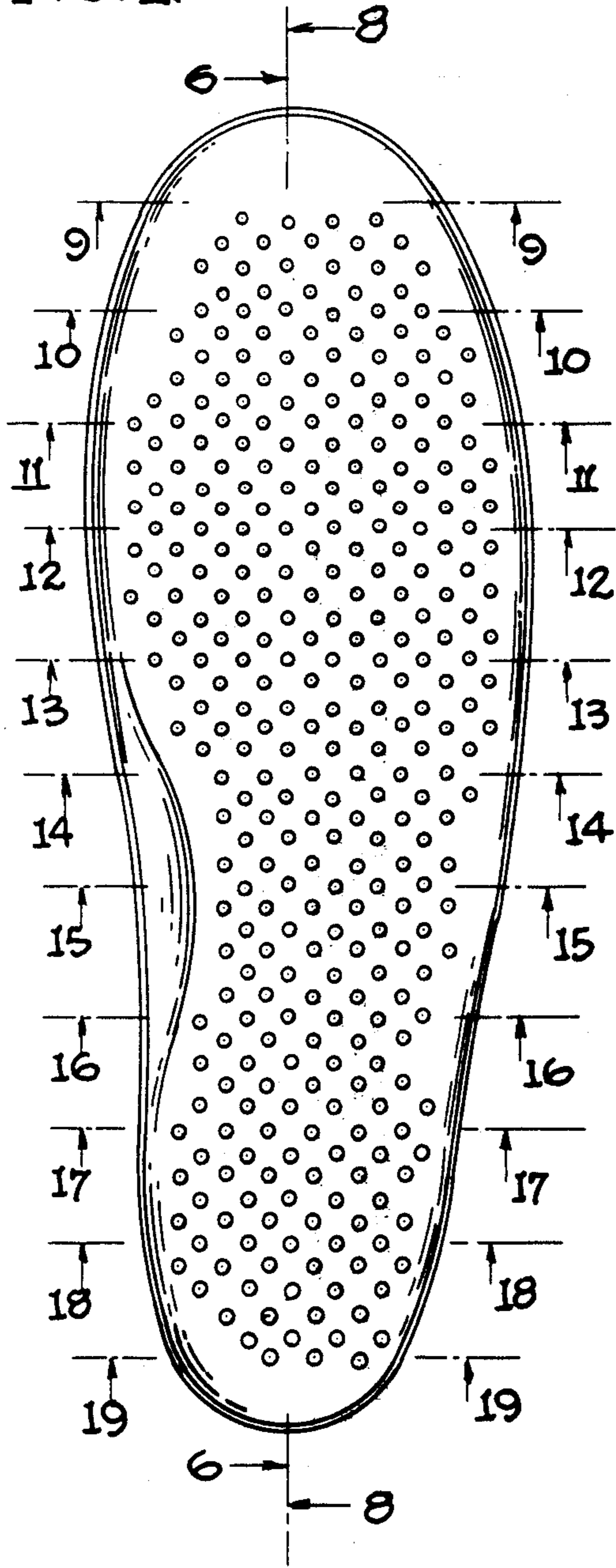

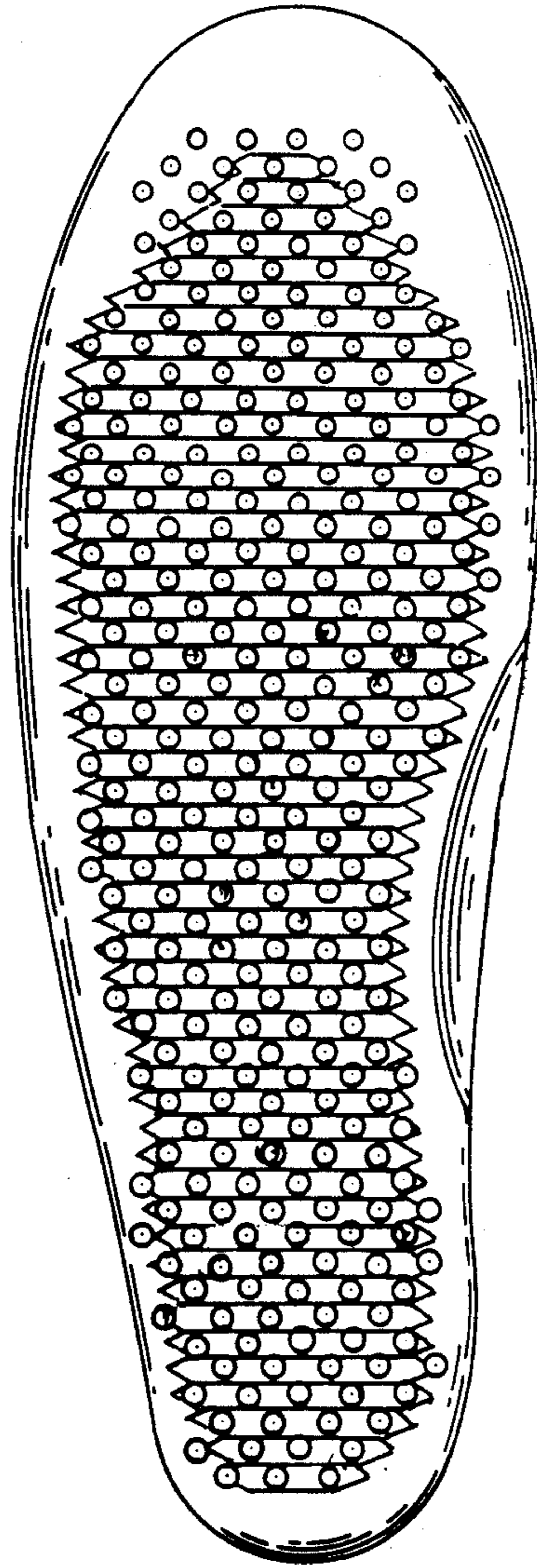

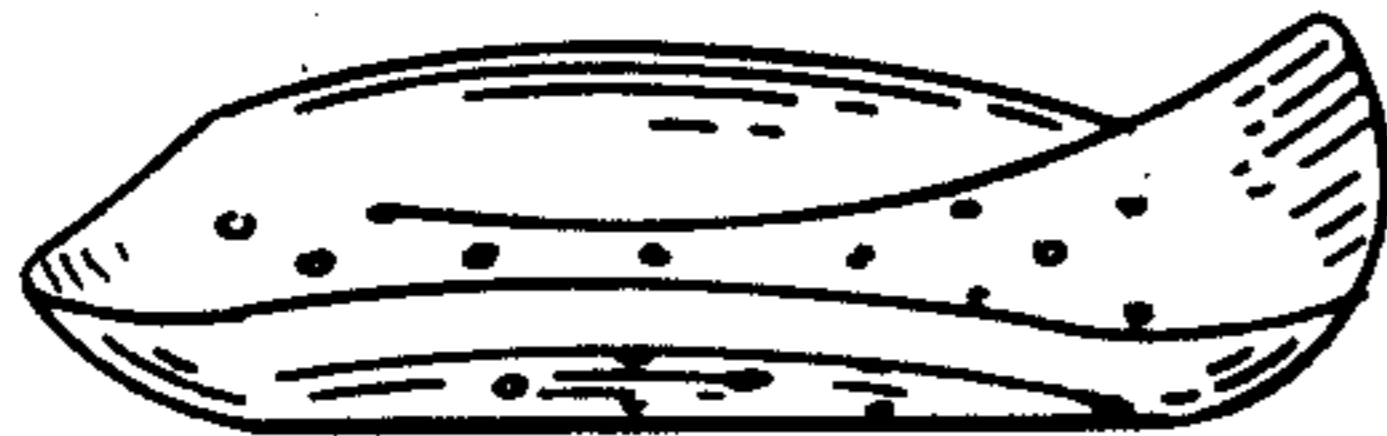

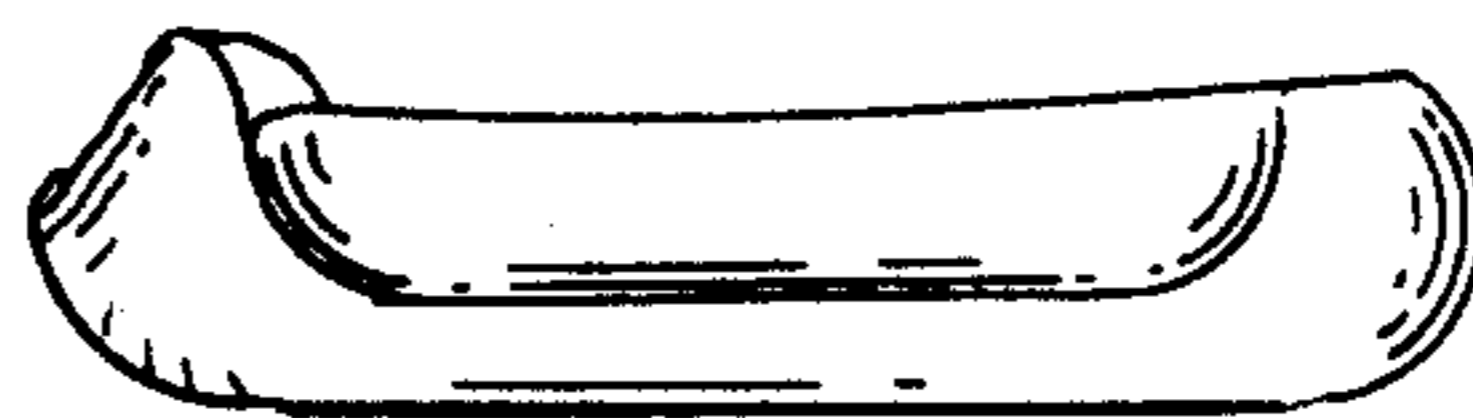
