[57] CLAIM

The ornamental design for a housing for vibration-abrasive surface finishing machines, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a housing for vibration-abrasive surface finishing machines showing our design; FIG. 2 is a right side view of the housing of FIG. 1 with the base partly broken away; FIG. 3 is a left side view of the housing of FIG. 1 with the base partly broken away; FIG. 4 is a top plan view of the housing of FIG. 1; FIG. 5 is a front elevational view of the housing of FIG. 1 with the base partly broken away; FIG. 6 is a rear elevational view of the housing of FIG. 1 with the base partly broken away; FIG. 7 is a right side view of another embodiment of an arena-shaped vibration-abrasive container for surface finishing machines showing our design; FIG. 8 is a left side view of the housing of FIG. 7; FIG. 9 is a top plan view of the housing of FIG. 7; FIG. 10 is a front elevational view of the housing of FIG. 7 with the base partly broken away; and FIG. 11 is a rear elevational view of the housing of FIG. 7 with the base partly broken away. FIGS. 1, 4 and 9 show an abrasive material in broken lines for illustrative purposes only.

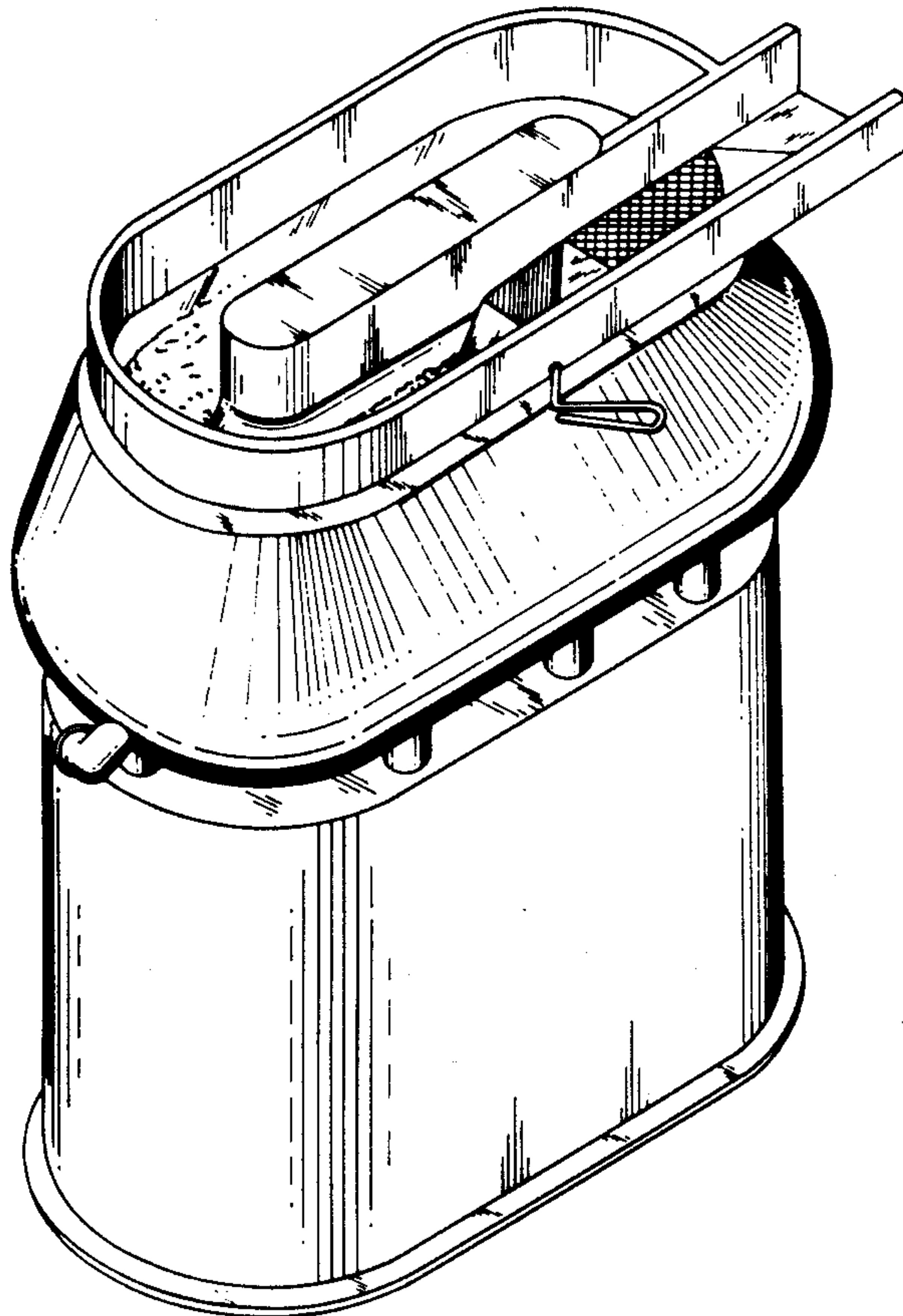
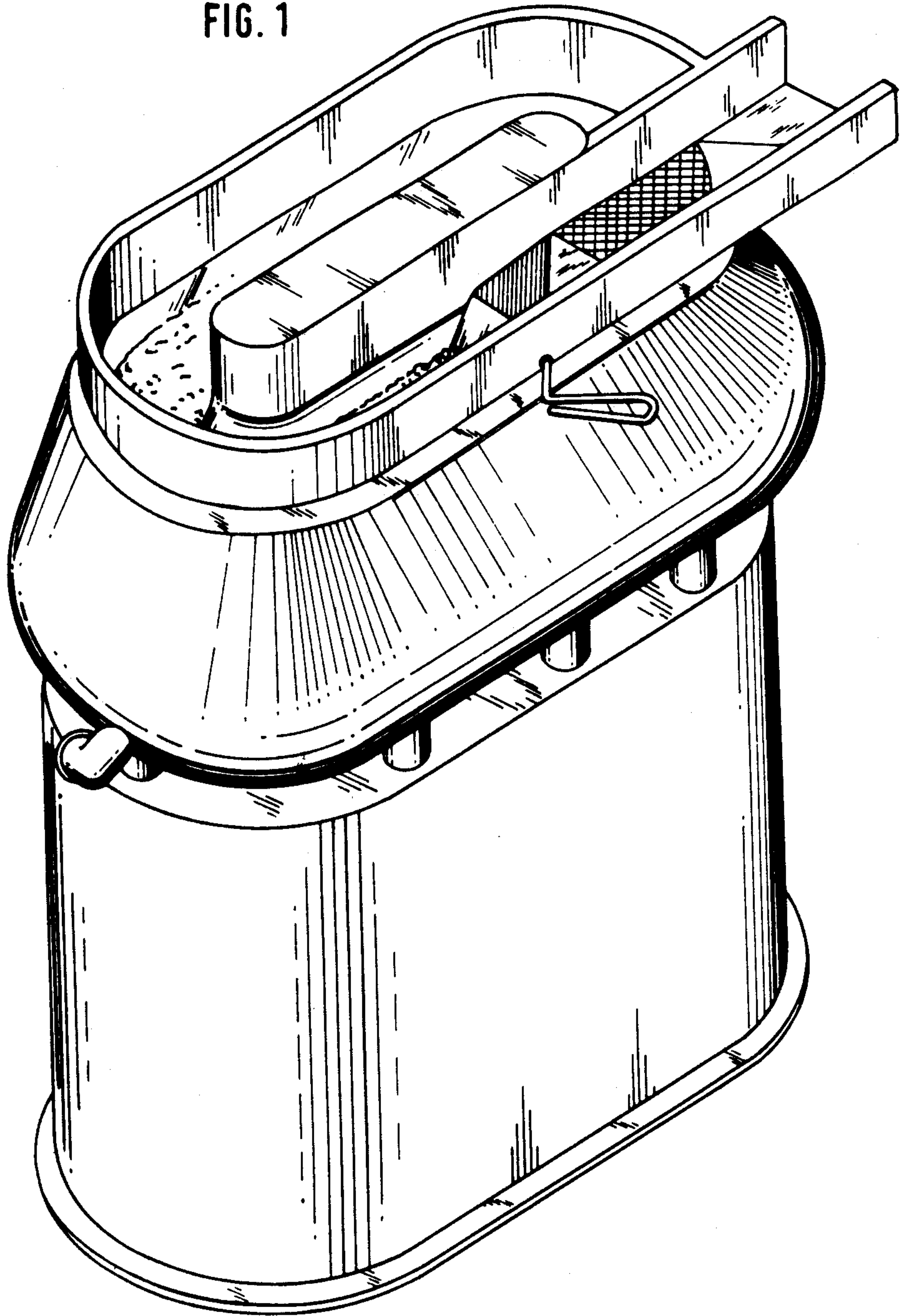

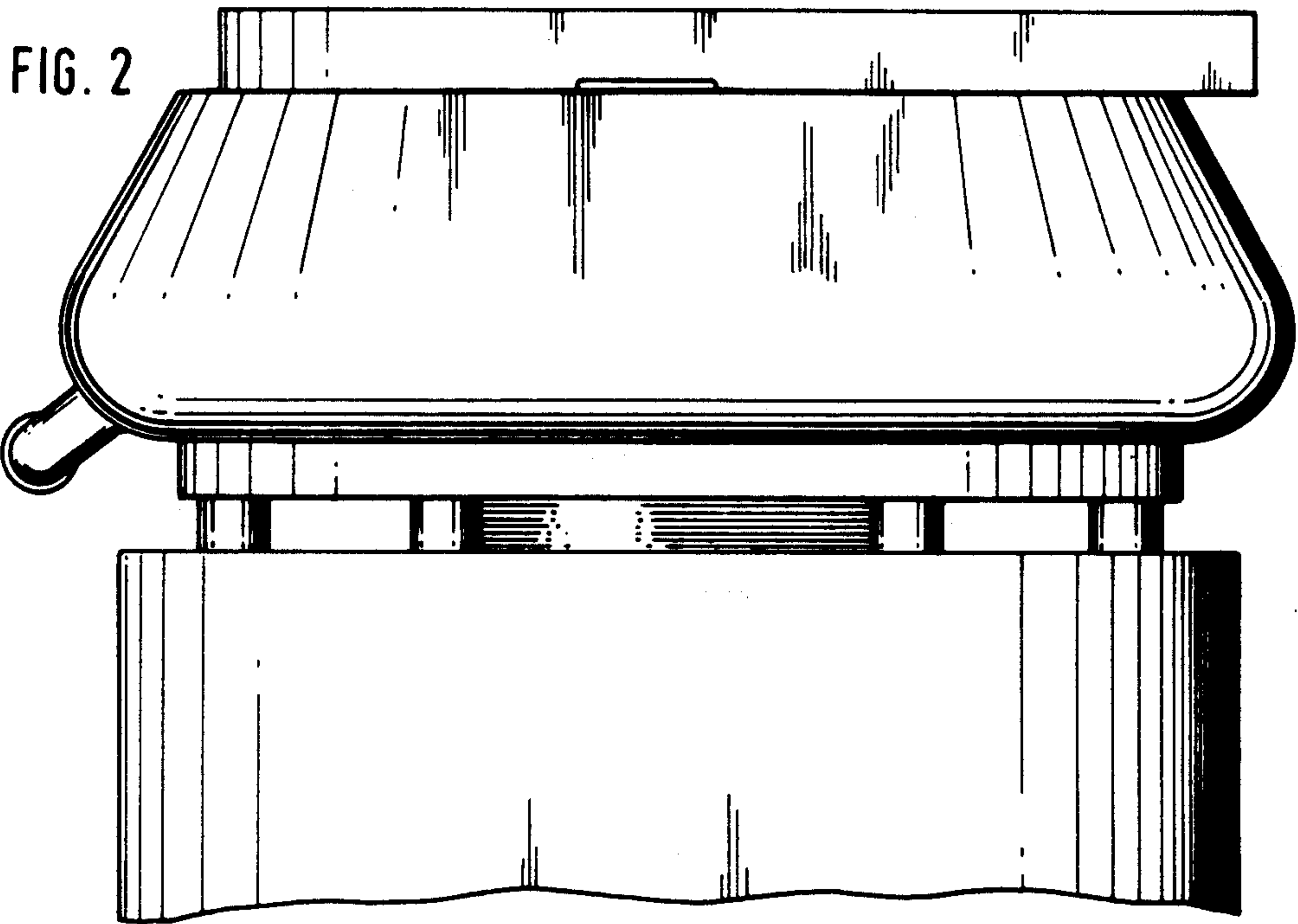

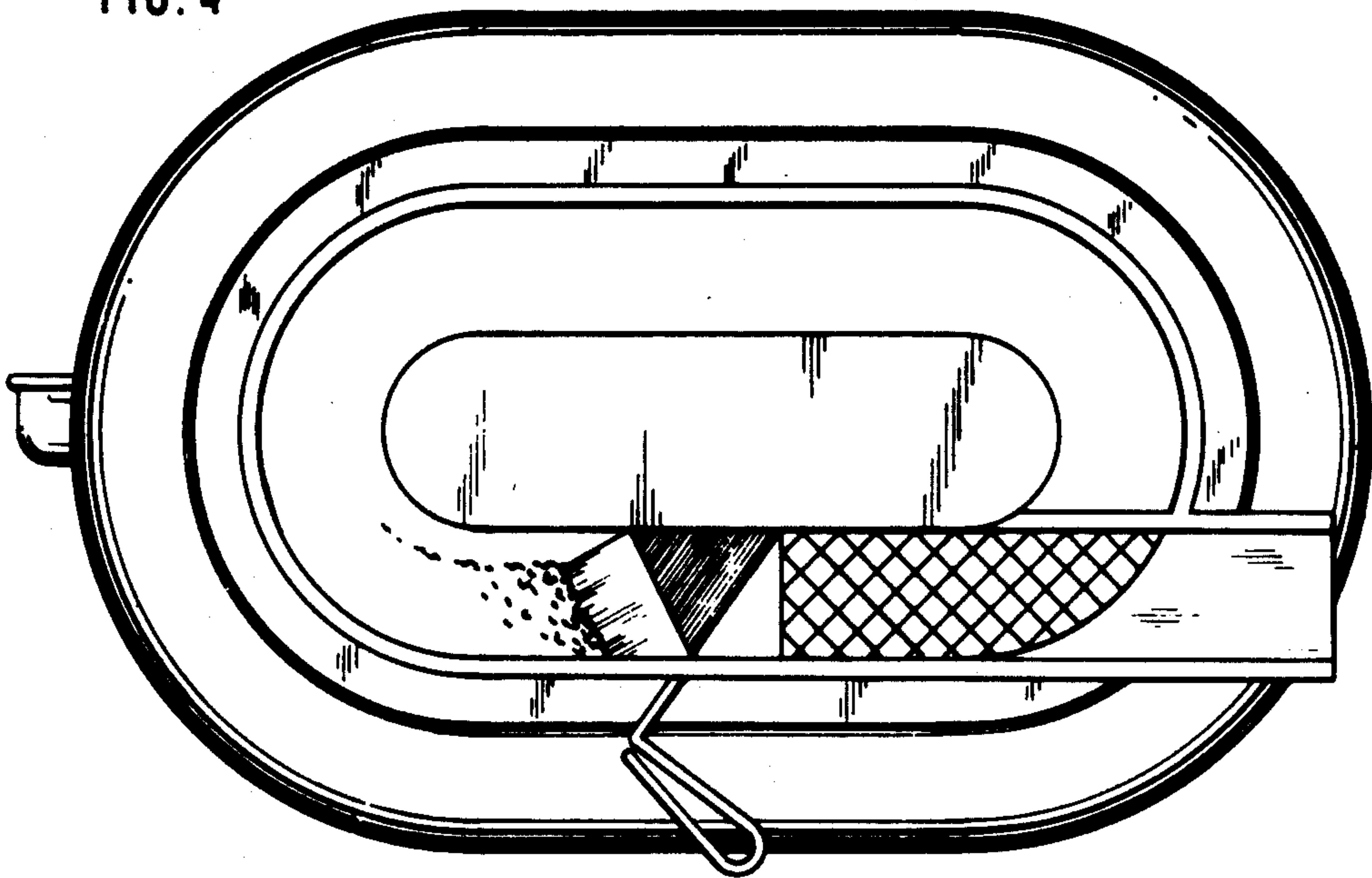
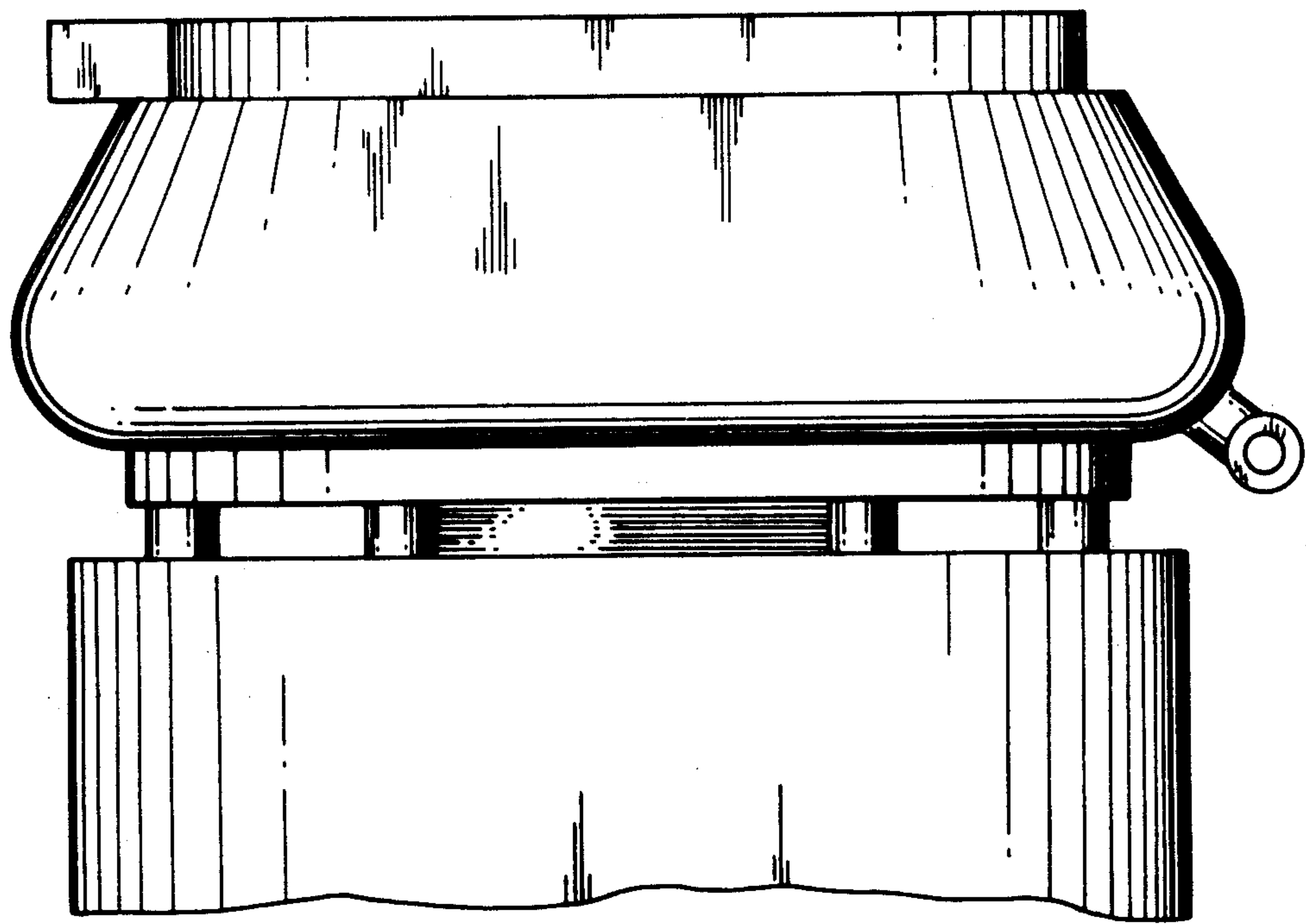

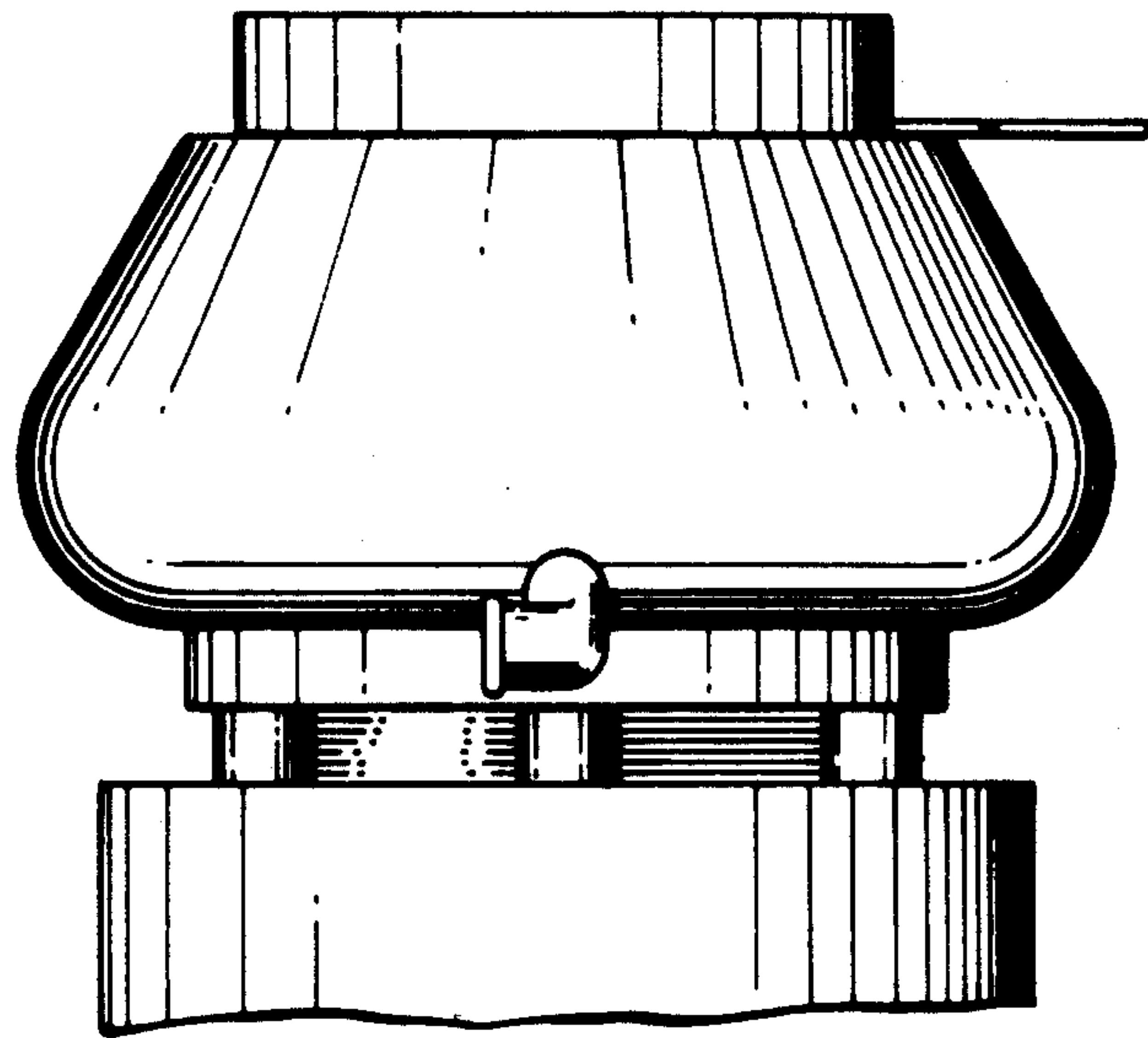

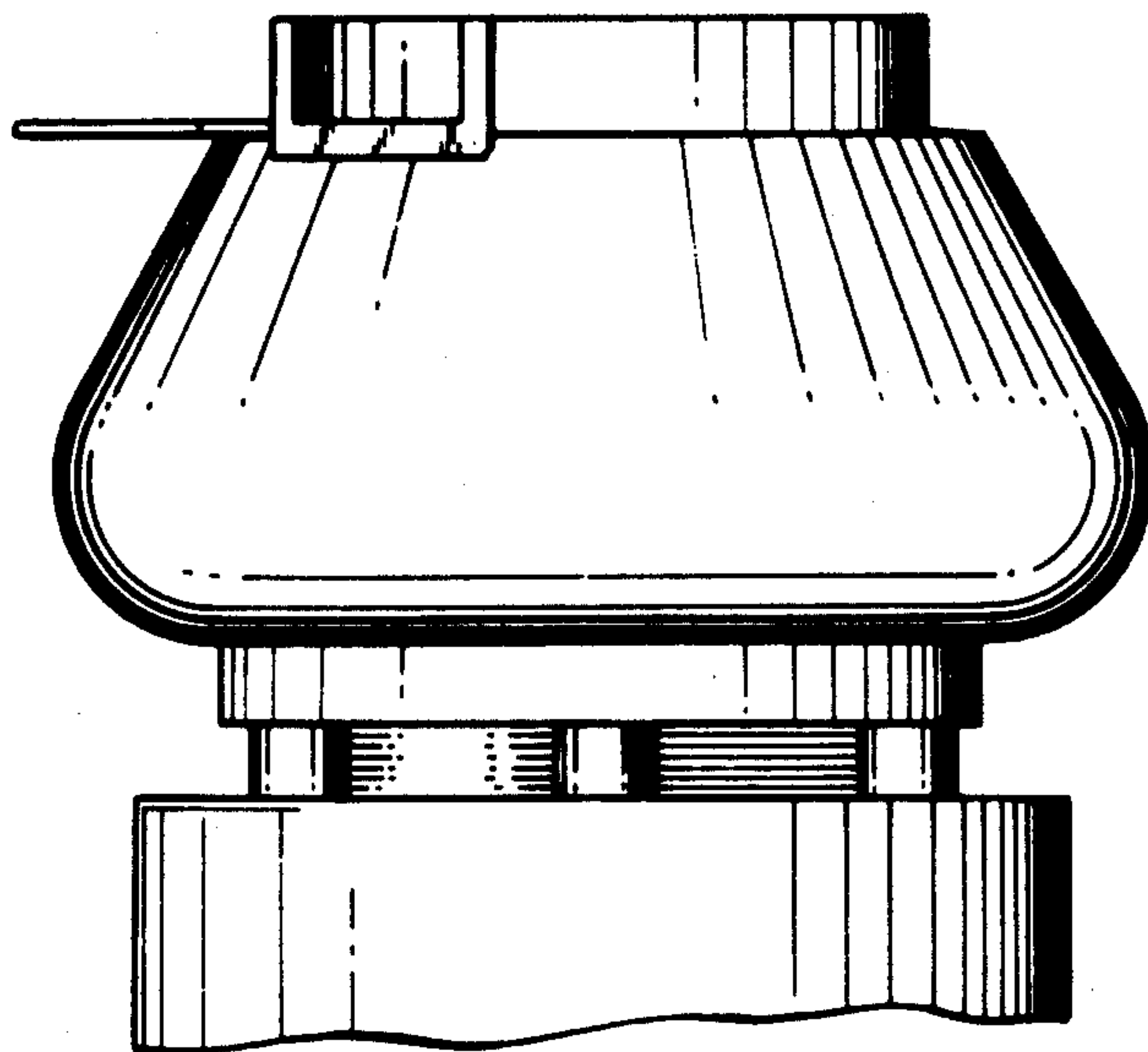
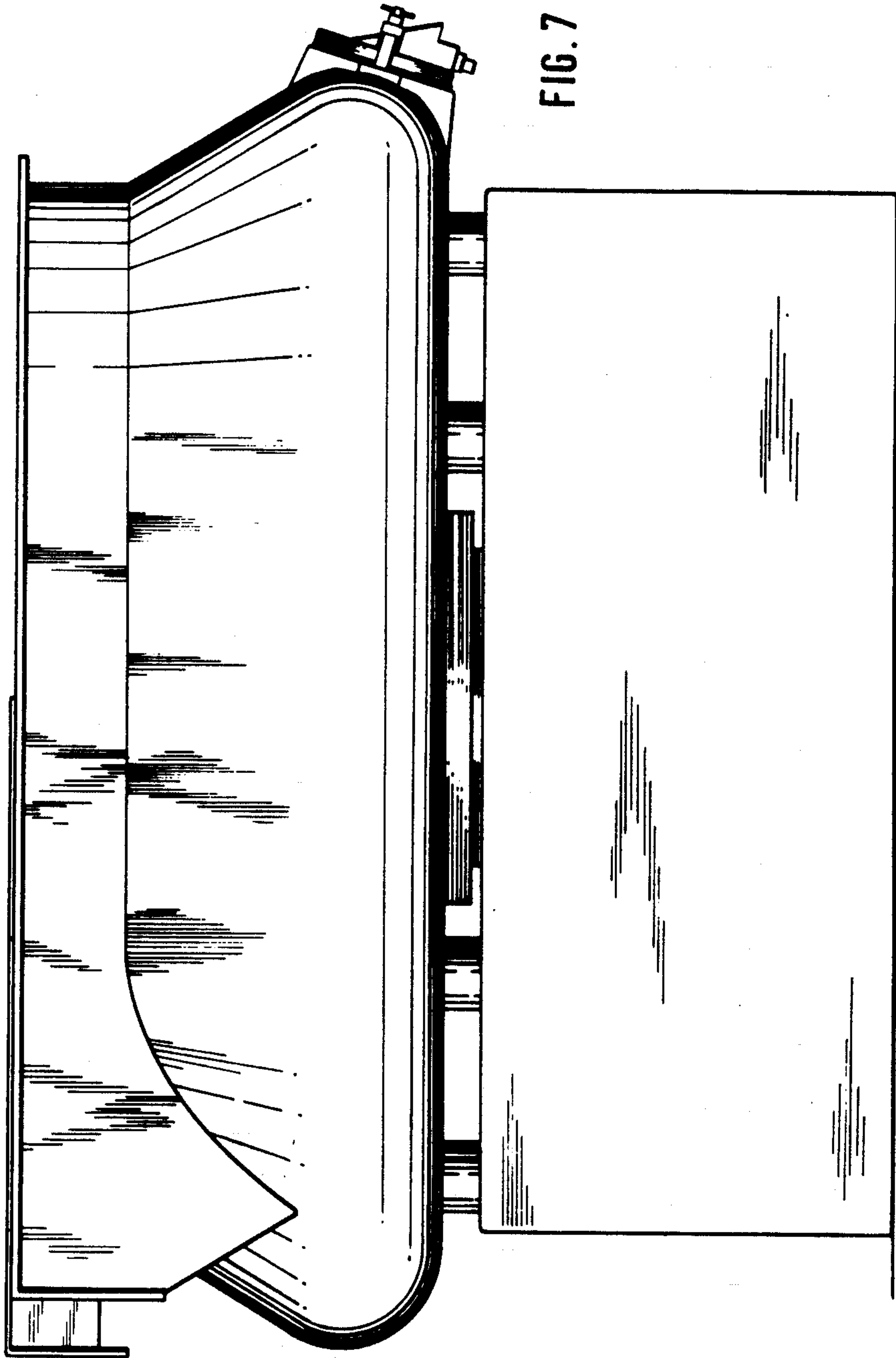

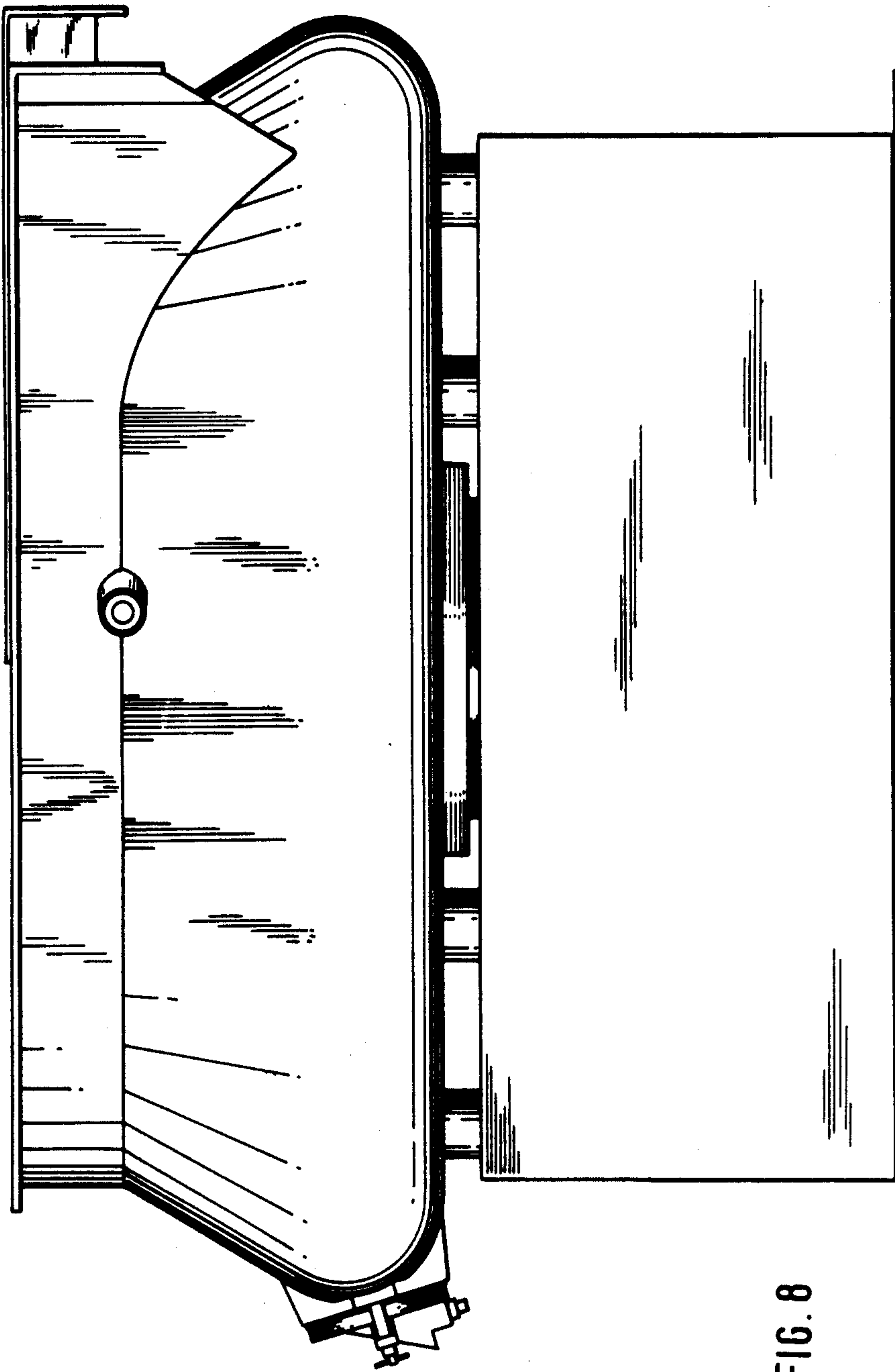

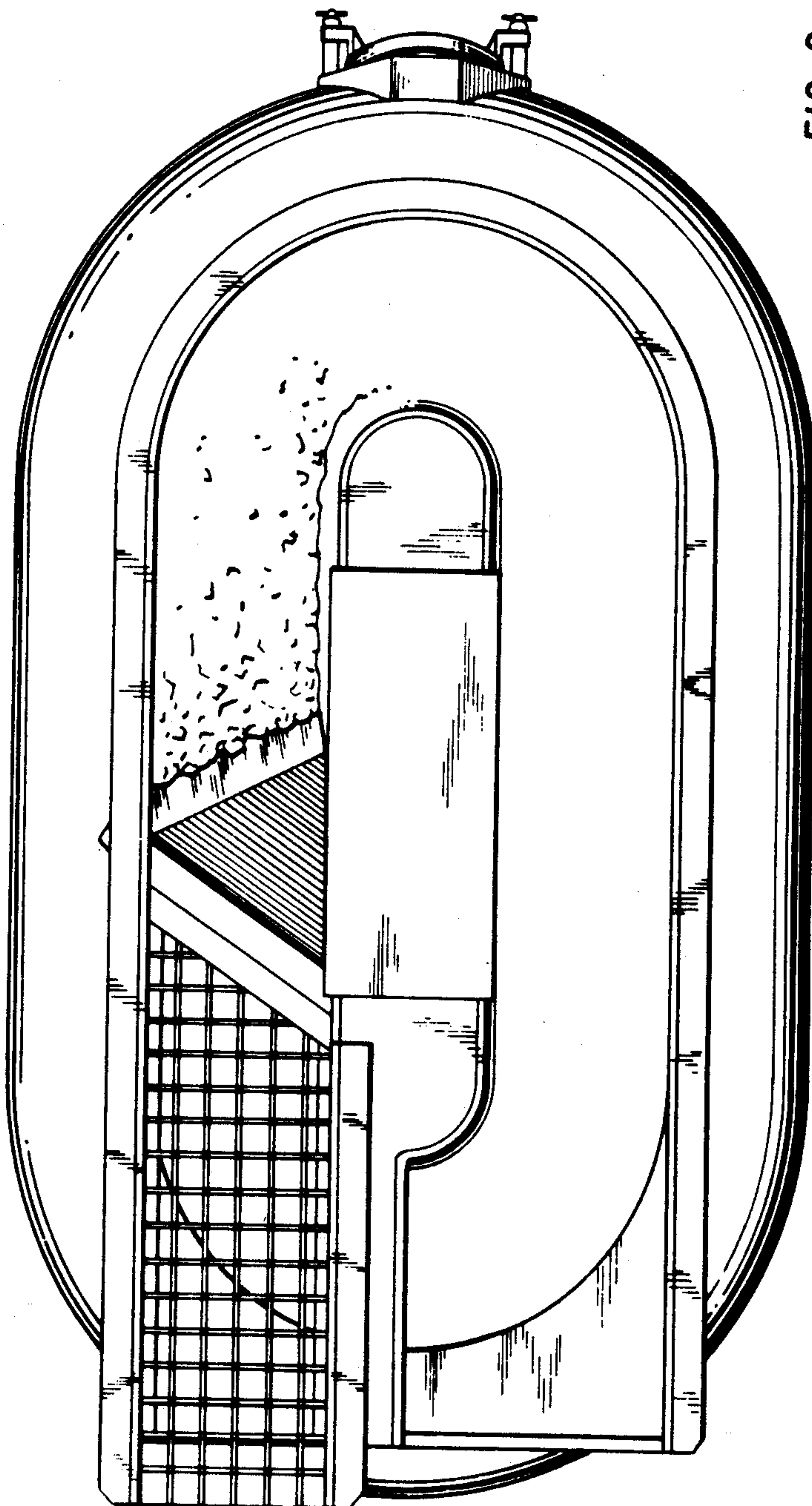

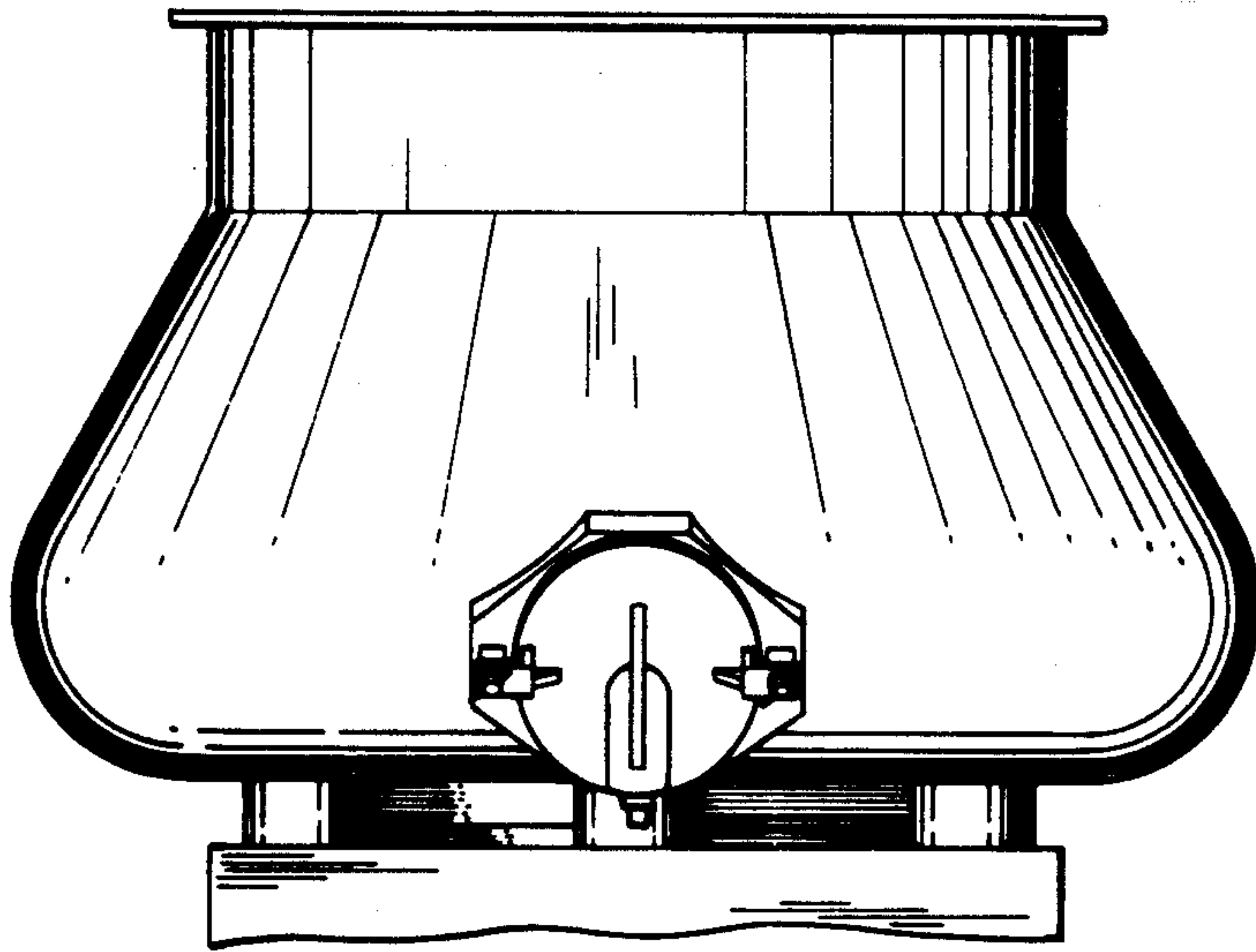

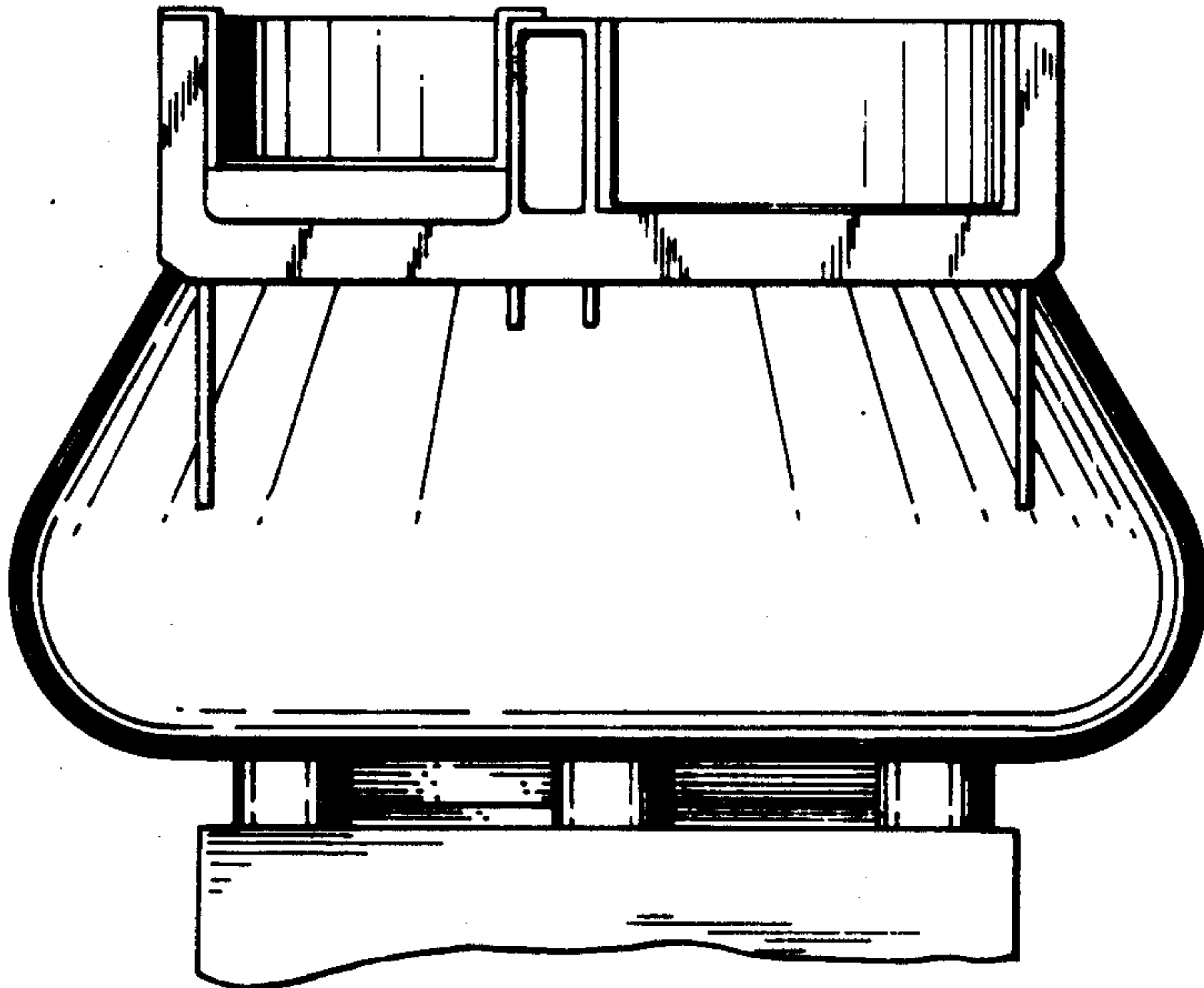
