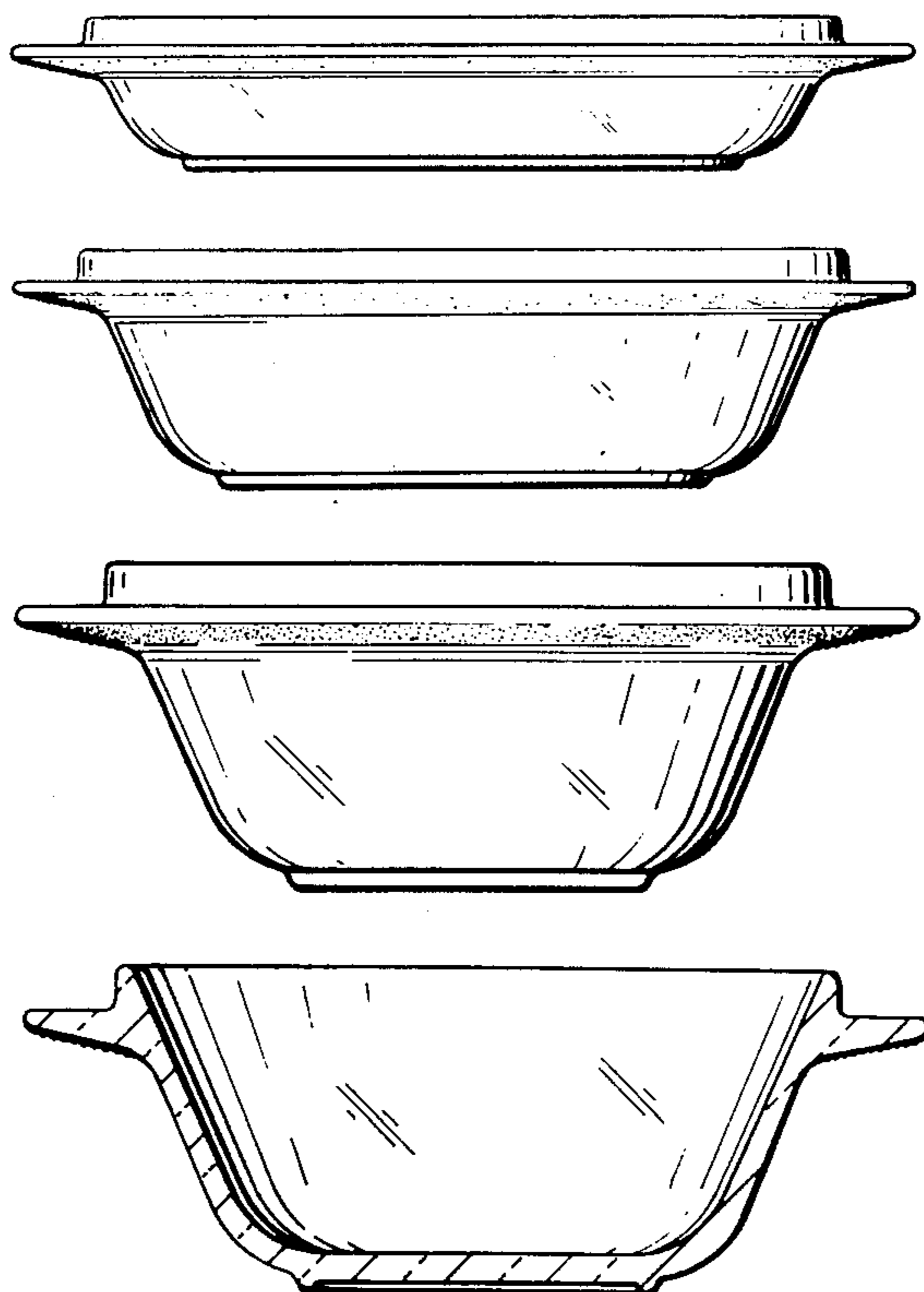

The ornamental design for a glass dish, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a glass dish showing my new design;  
 FIG. 2 is a side elevational view of the glass dish of FIG. 1;  
 FIG. 3 is a bottom plan view of the glass dish of FIG. 1;  
 FIG. 4 is a sectional view of the glass dish of FIG. 1 along line 4-4;  
 FIG. 5 is a top plan view of a second embodiment of a glass dish showing my new design;  
 FIG. 6 is a side elevational view of the glass dish of FIG. 5;  
 FIG. 7 is a bottom plan view of the glass dish of FIG. 5;  
 FIG. 8 is a sectional view of the glass dish of FIG. 5 along line 8-8;  
 FIG. 9 is a top plan view of a third embodiment of a glass dish showing my new design;  
 FIG. 10 is a side elevational view of the glass dish of FIG. 9;  
 FIG. 11 is a bottom plan view of the glass dish of FIG. 9; and  
 FIG. 12 is a sectional view of the glass dish of FIG. 9 along line 12-12.



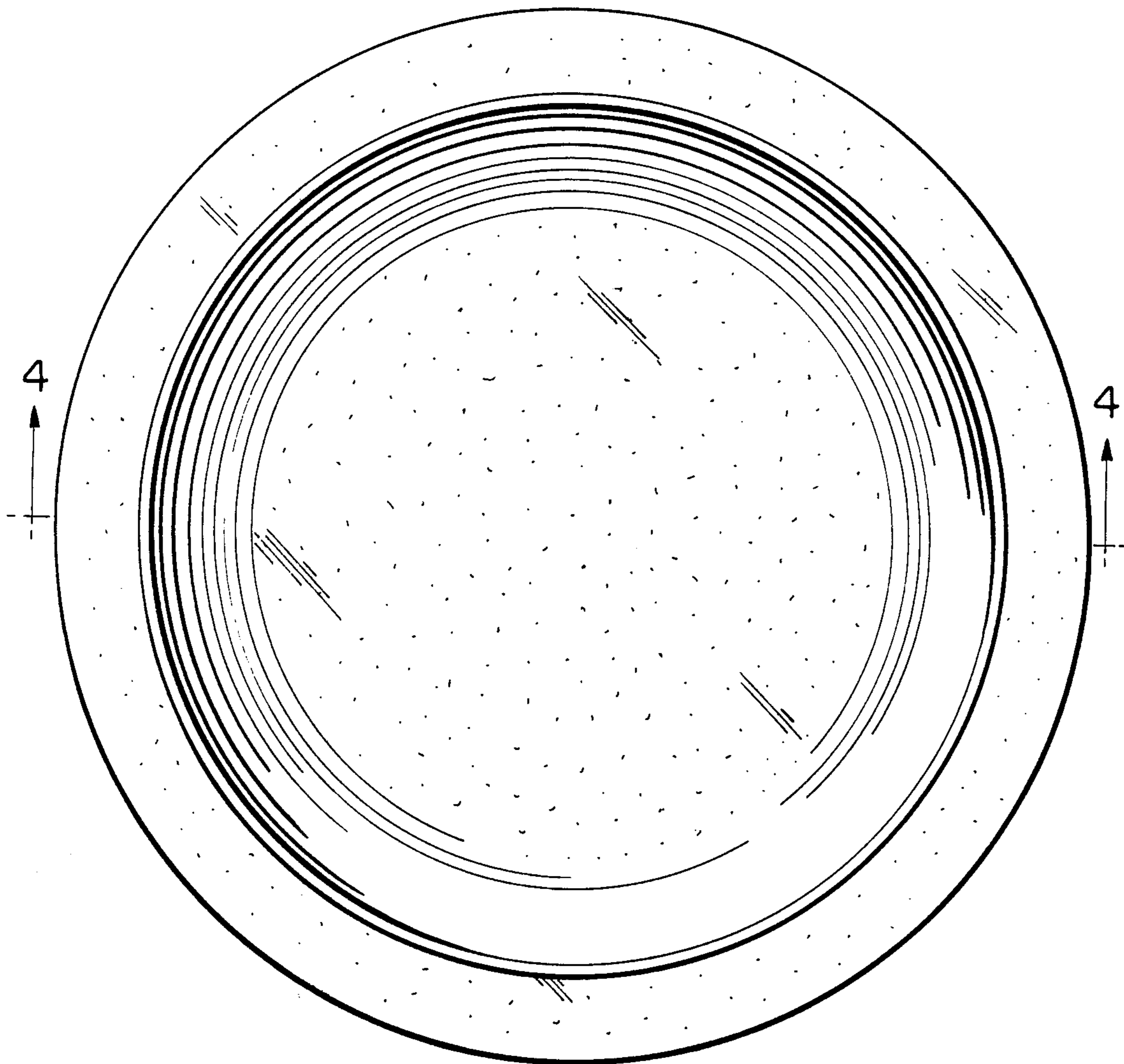

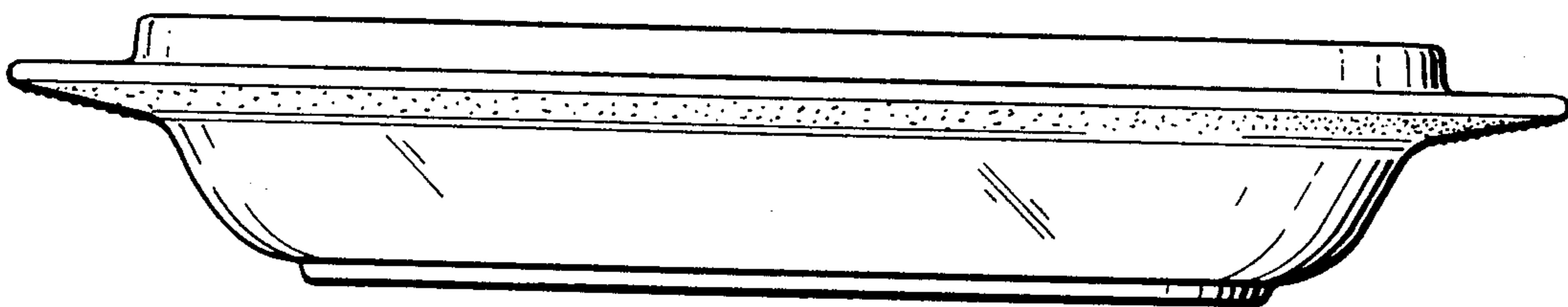

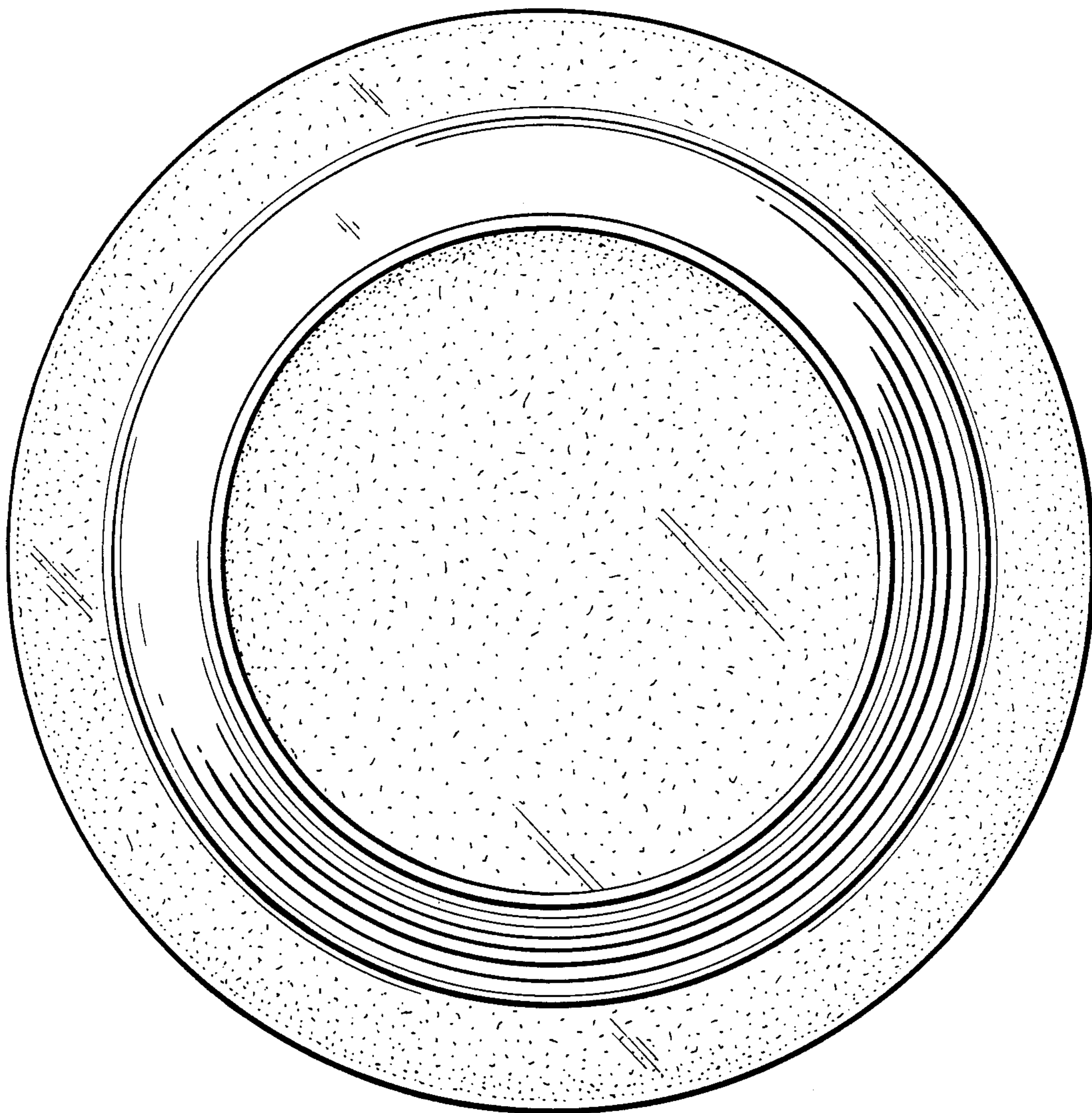

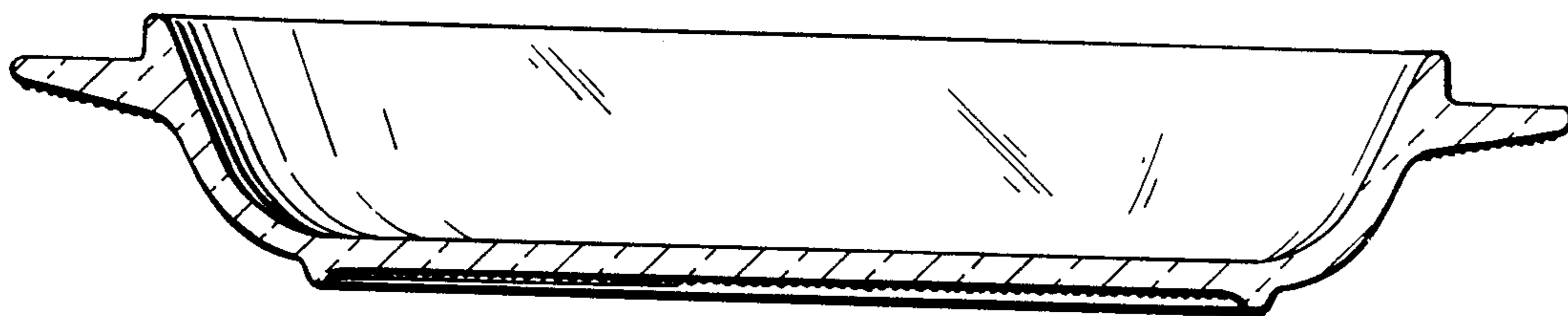

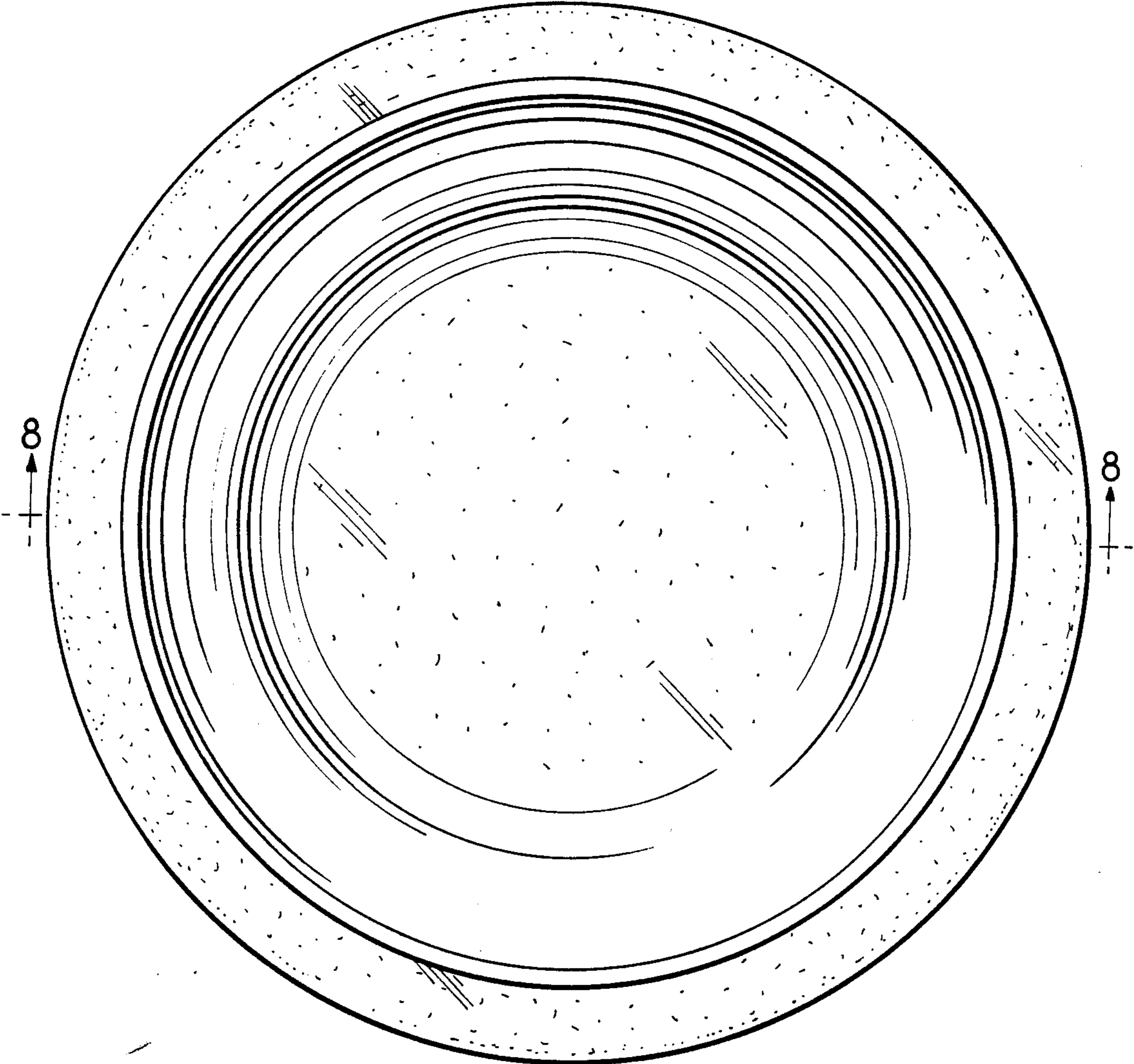

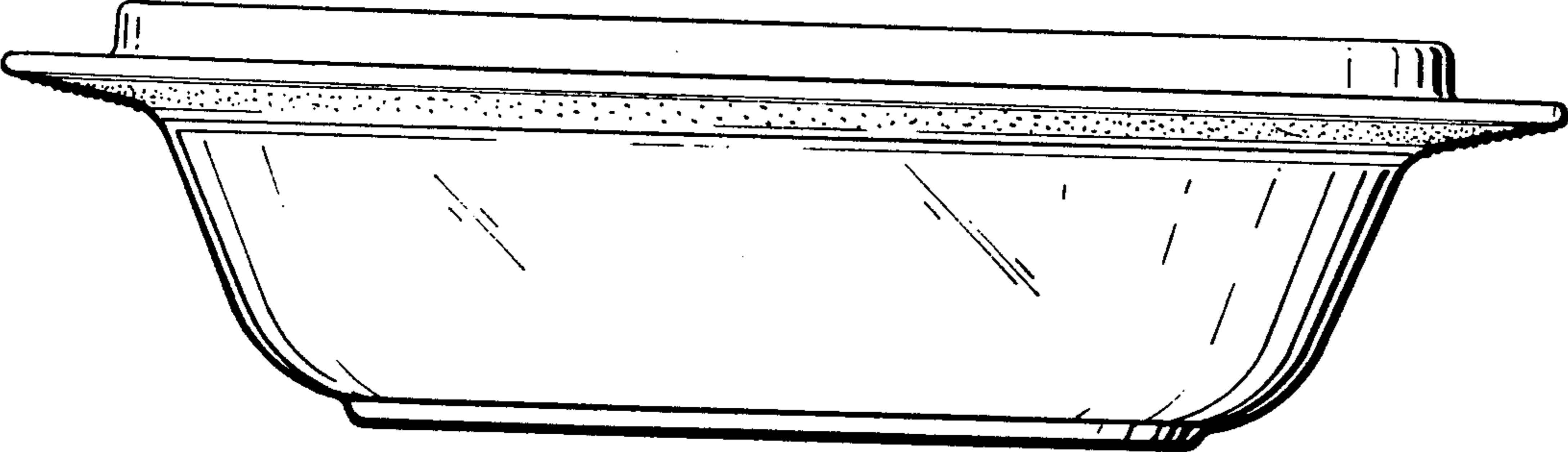

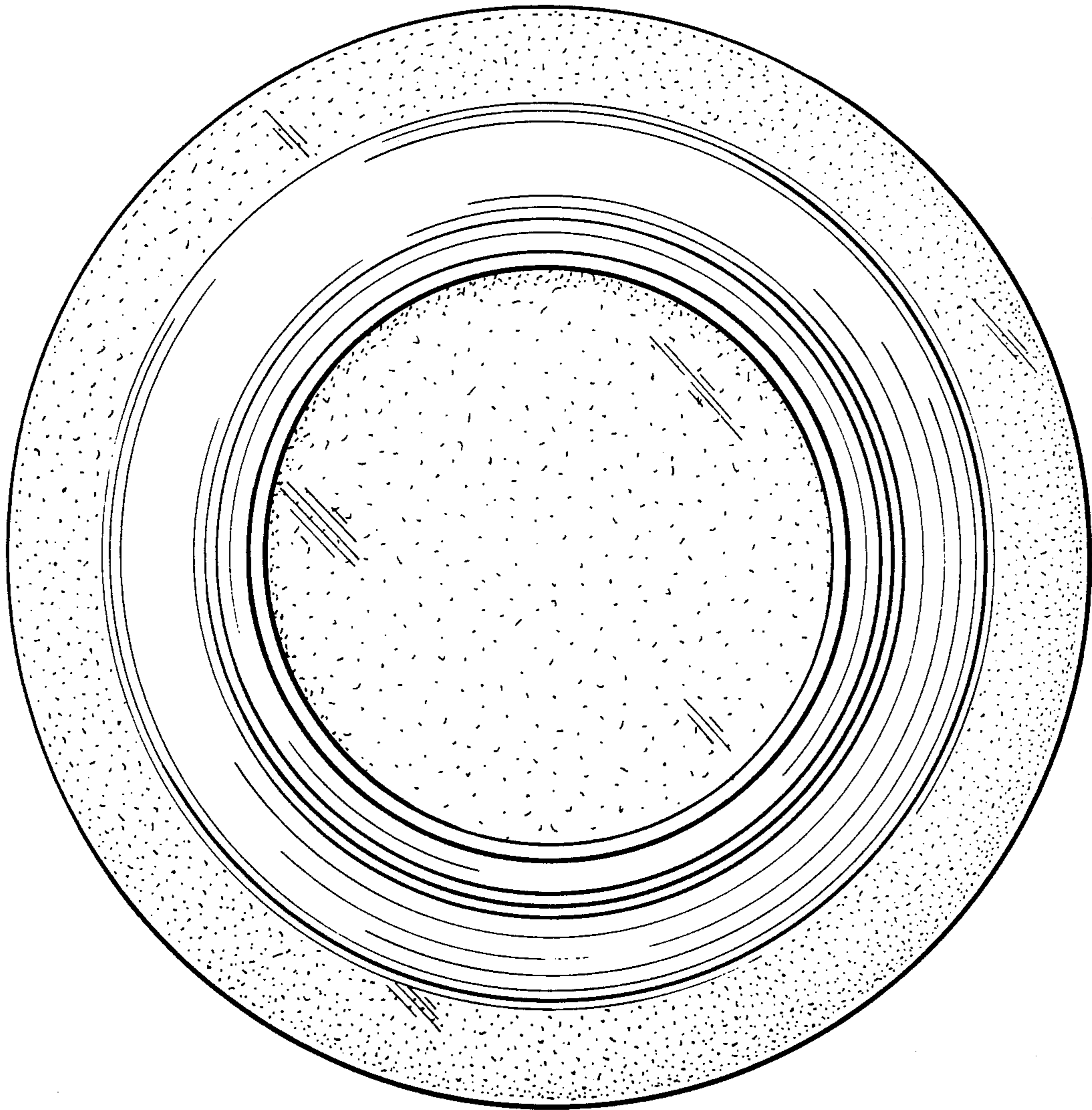

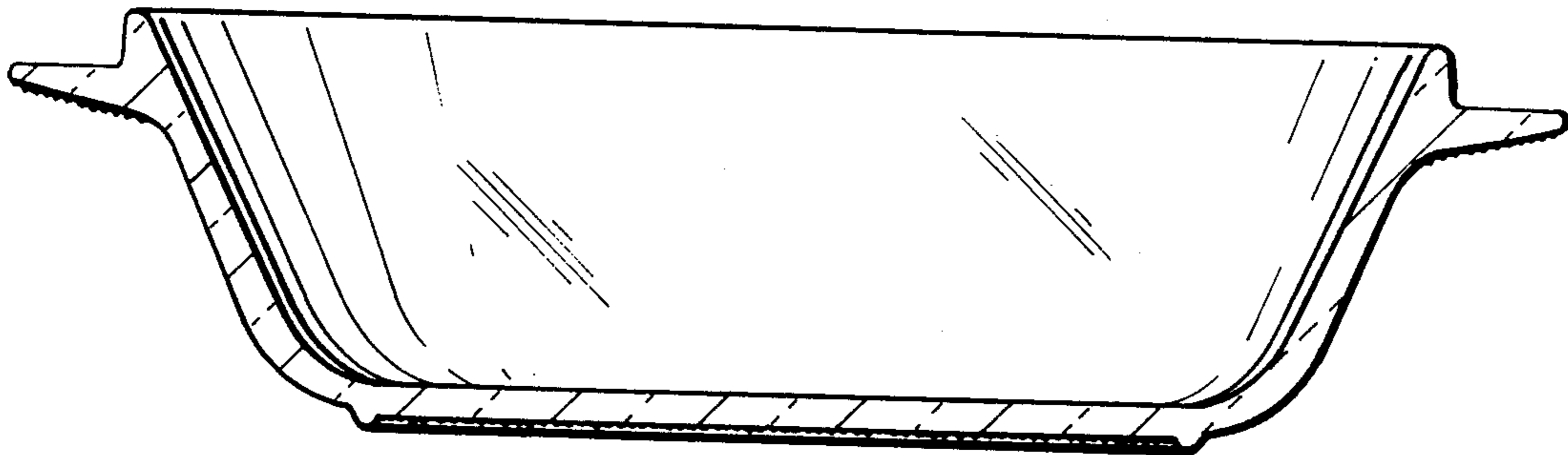

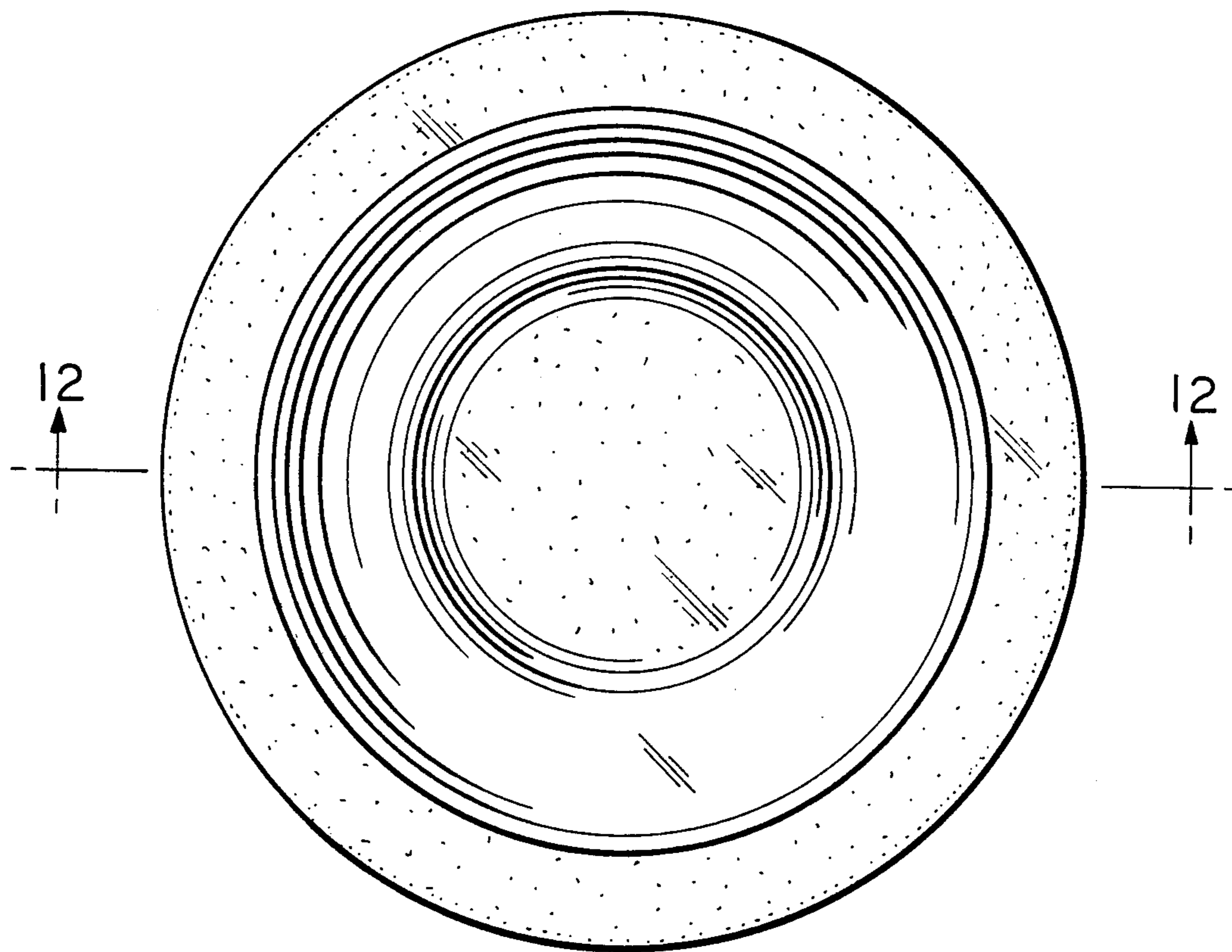

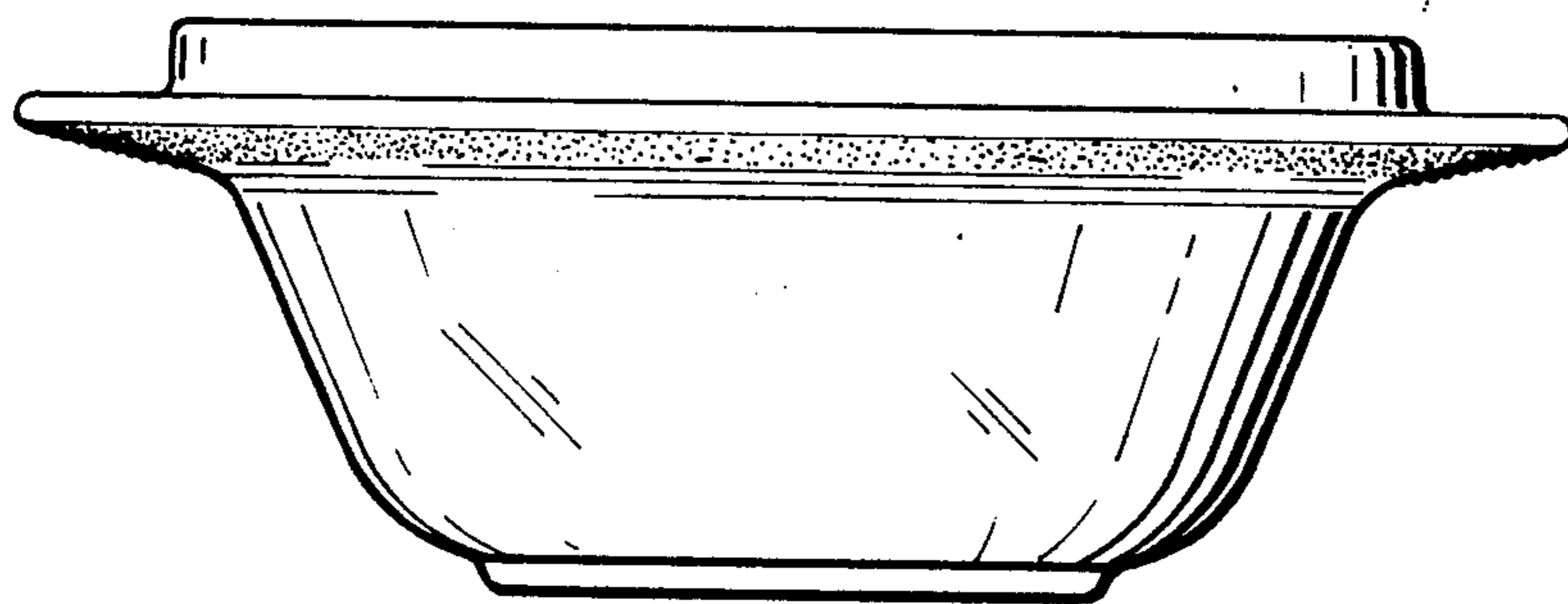

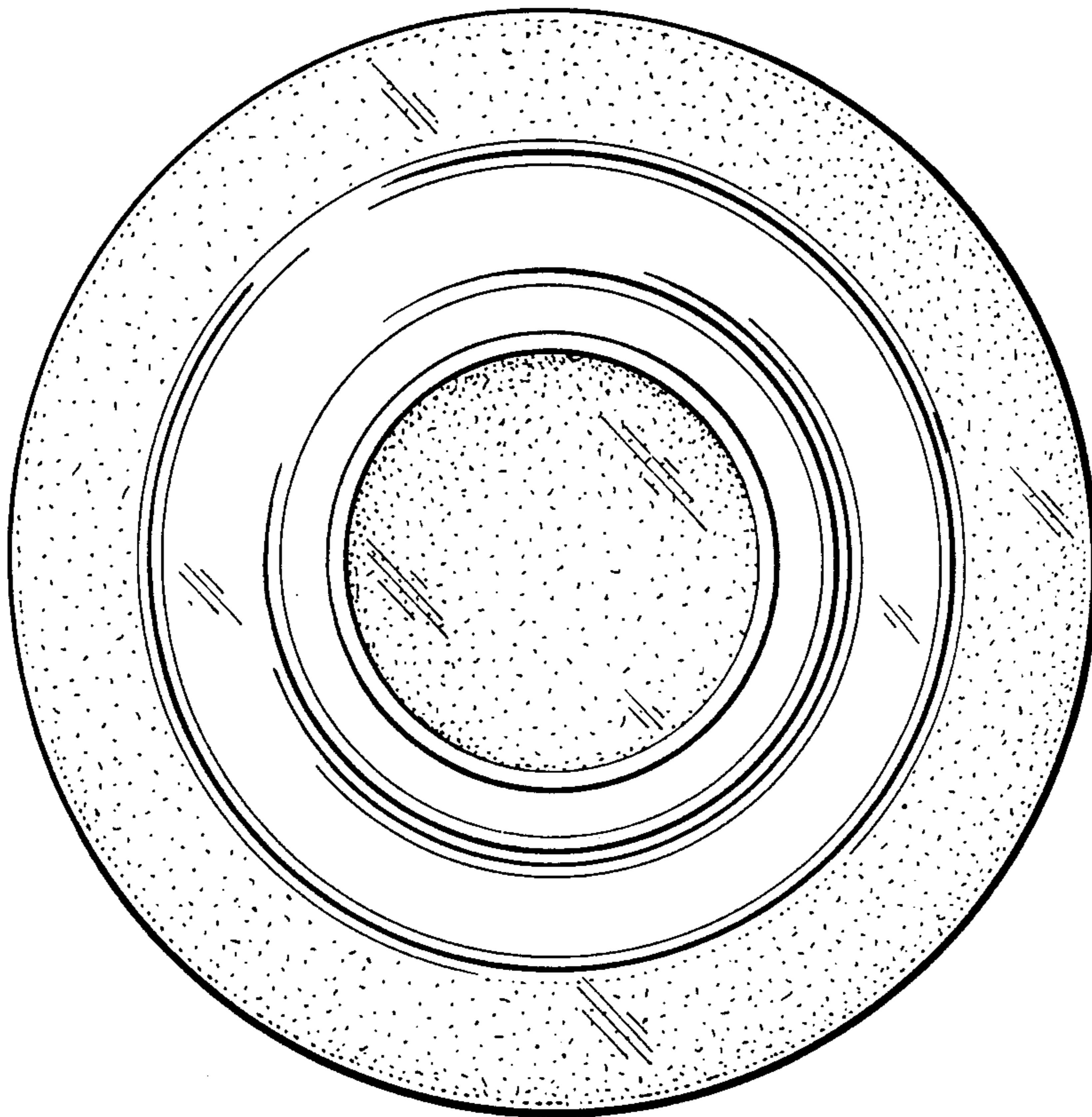

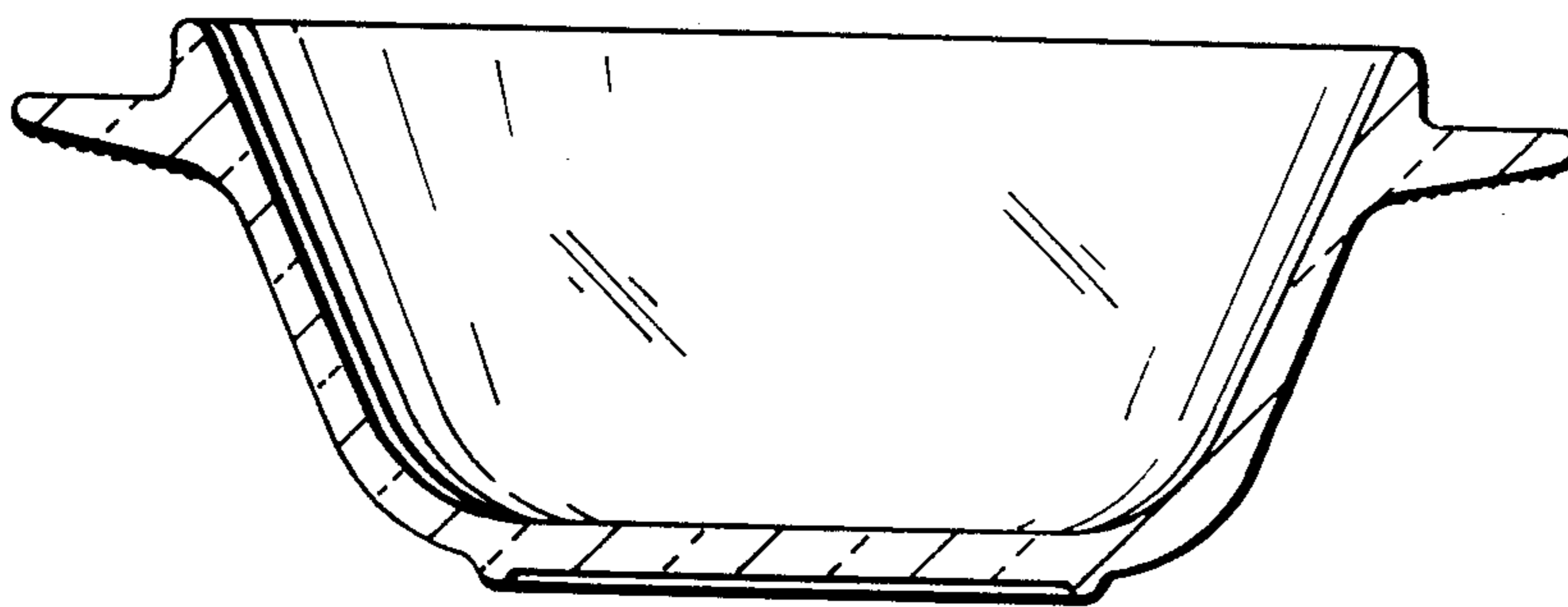
