[57] **CLAIM**

The ornamental design for a blank for a combined vent and baffle, substantially as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a blank for a combined vent and baffle showing my new design, the bottom plan view being a mirror image of the top shown; FIG. 2 is a right side elevational view thereof, the left side being the same as the right side shown; FIG. 3 is a top view of FIG. 1; FIG. 4 is a bottom view of FIG. 1; FIG. 5 is a top plan view of a modified form of the blank for a combined vent and baffle shown in FIG. 1, the bottom being a mirror image of the top shown; FIG. 6 is a right side elevational view of FIG. 5, the left side being the same as the right side shown; FIG. 7 is a top view of FIG. 5; FIG. 8 is a bottom view of FIG. 5; FIG. 9 is a top plan view of a second modified form of the blank for a combined vent and baffle shown in FIG. 1, the bottom being a mirror image of the top shown; FIG. 10 is a right side elevational view of FIG. 9, the left side being the same as the right side shown; FIG. 11 is a top view of FIG. 9; FIG. 12 is a bottom view of FIG. 9; FIG. 13 is a top plan view of a third modified form of the blank for a combined vent and baffle shown in FIG. 1, the bottom being a mirror image of the top shown; FIG. 14 is a right side elevational view of FIG. 13, the left side being the same as the right side shown; FIG. 15 is a top view of FIG. 13; and FIG. 16 is a bottom view of FIG. 13.

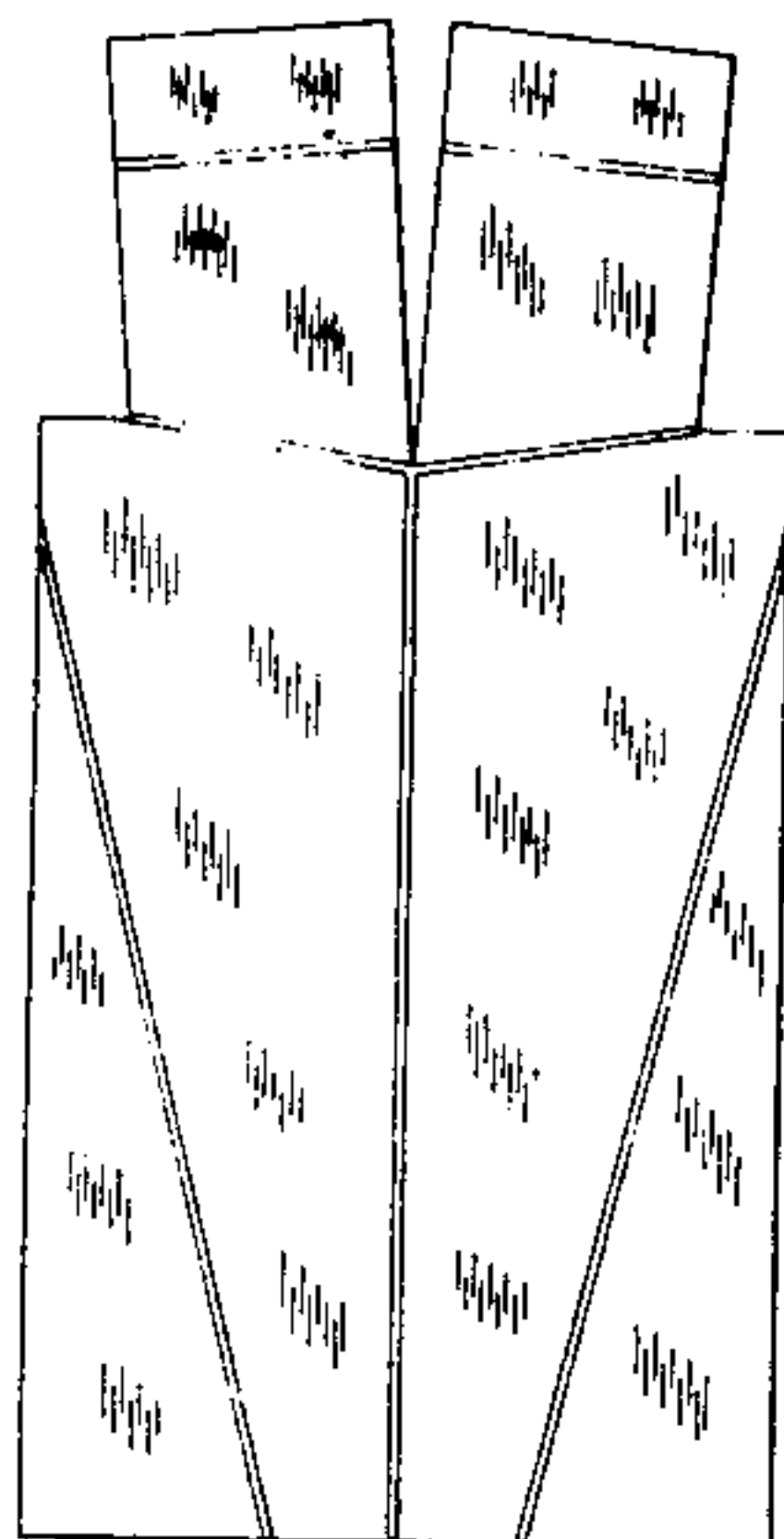

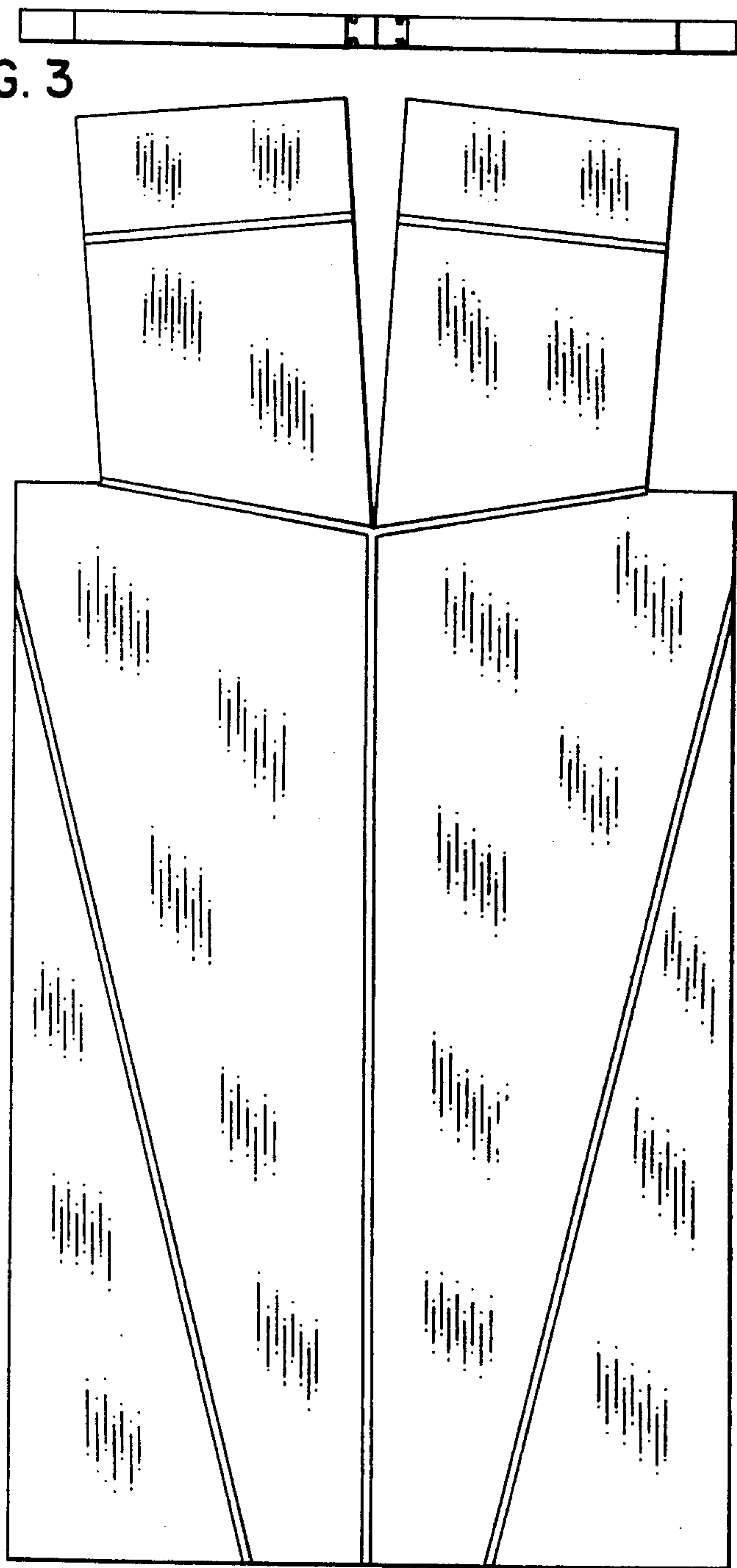

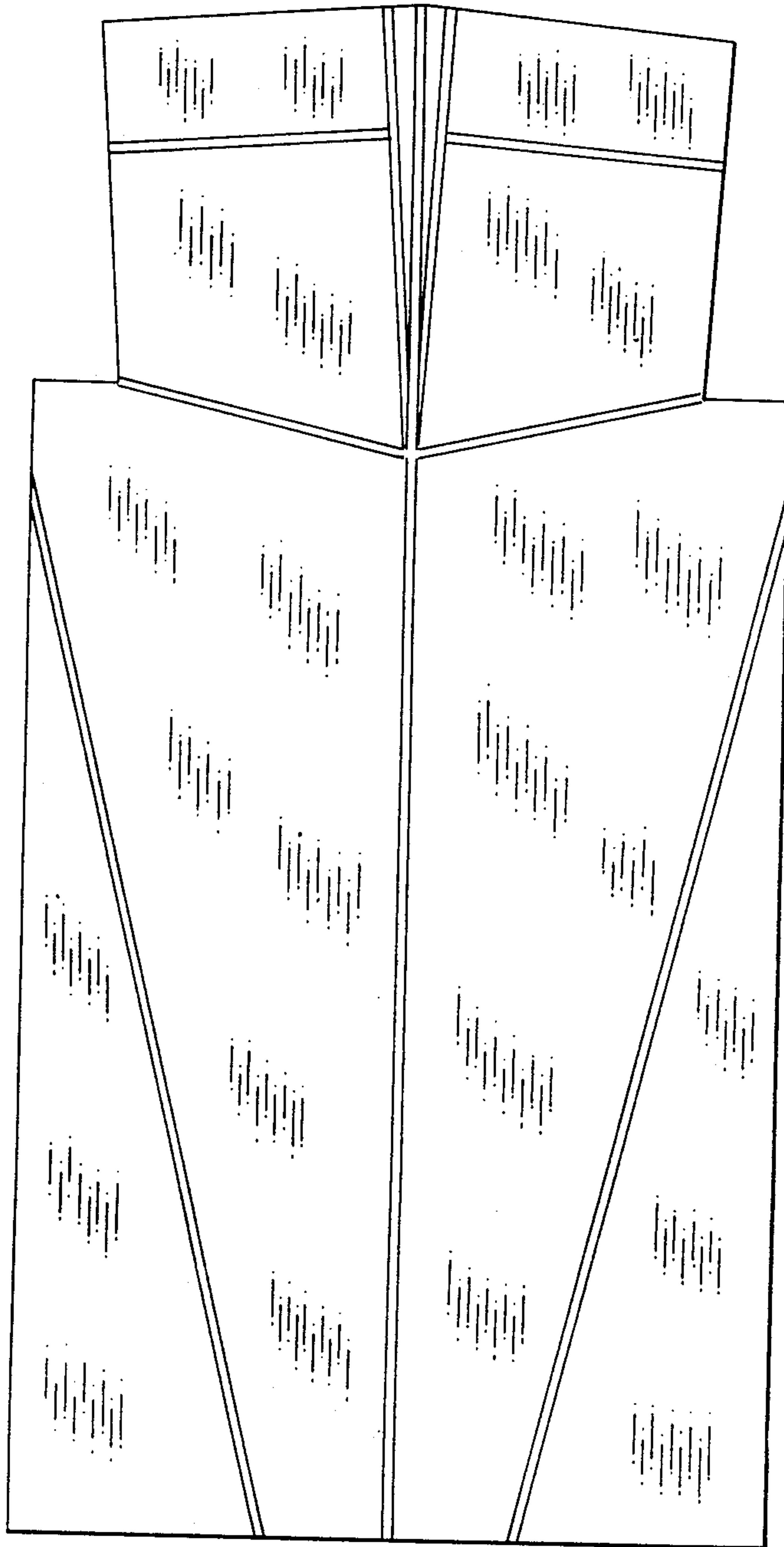

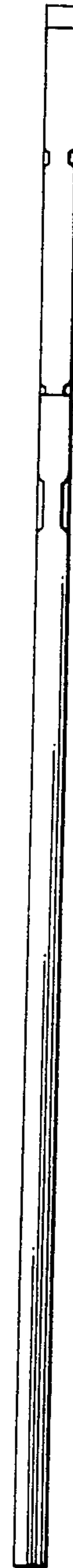

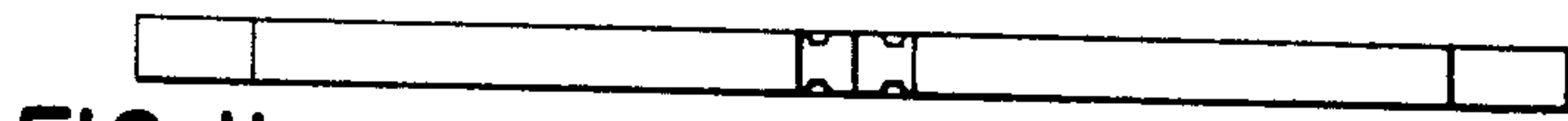

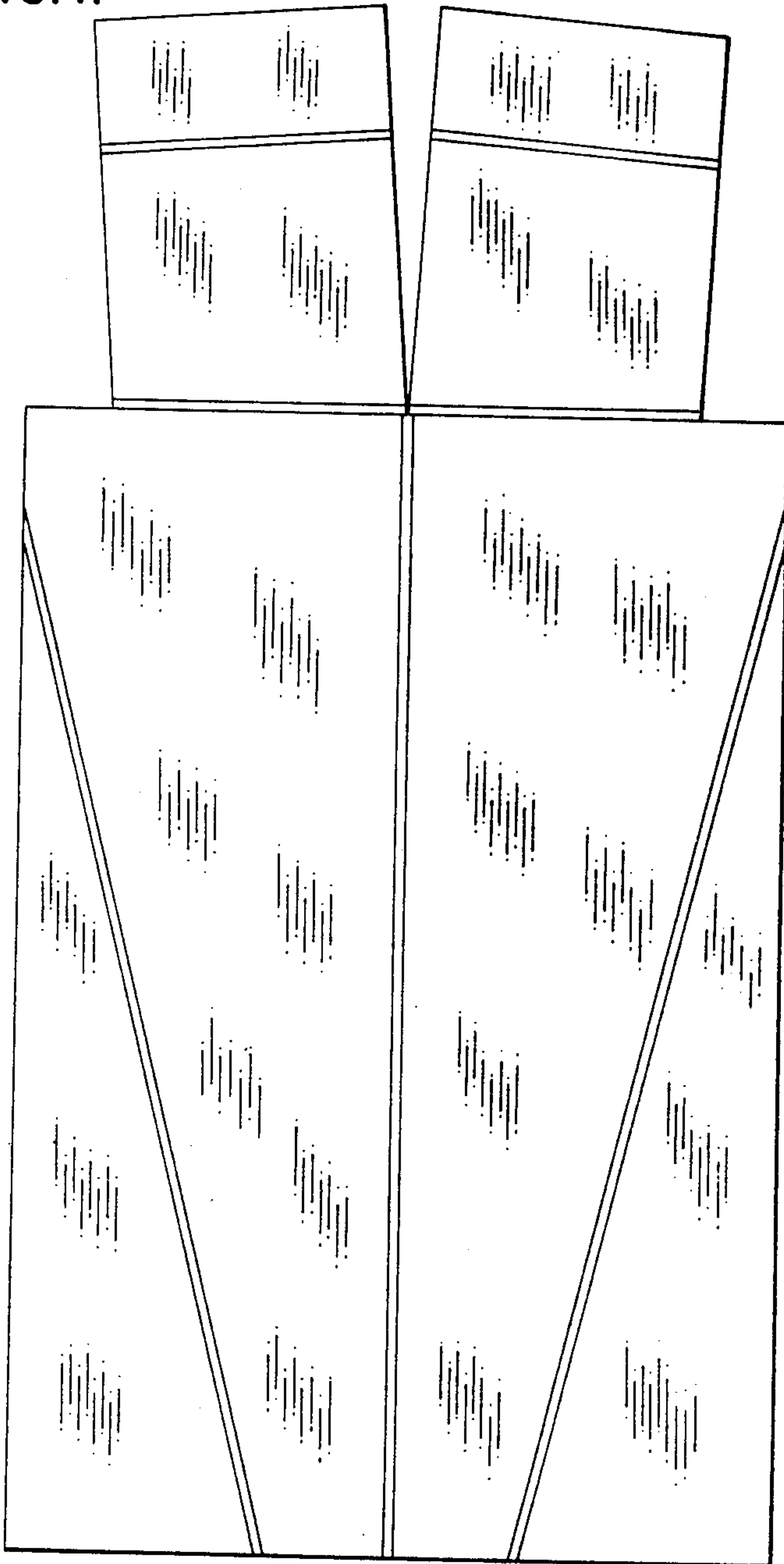

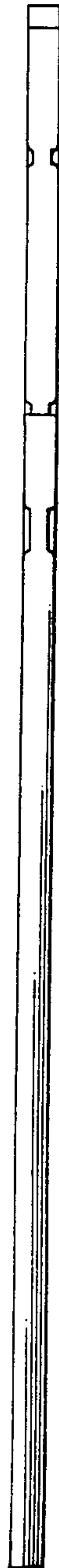

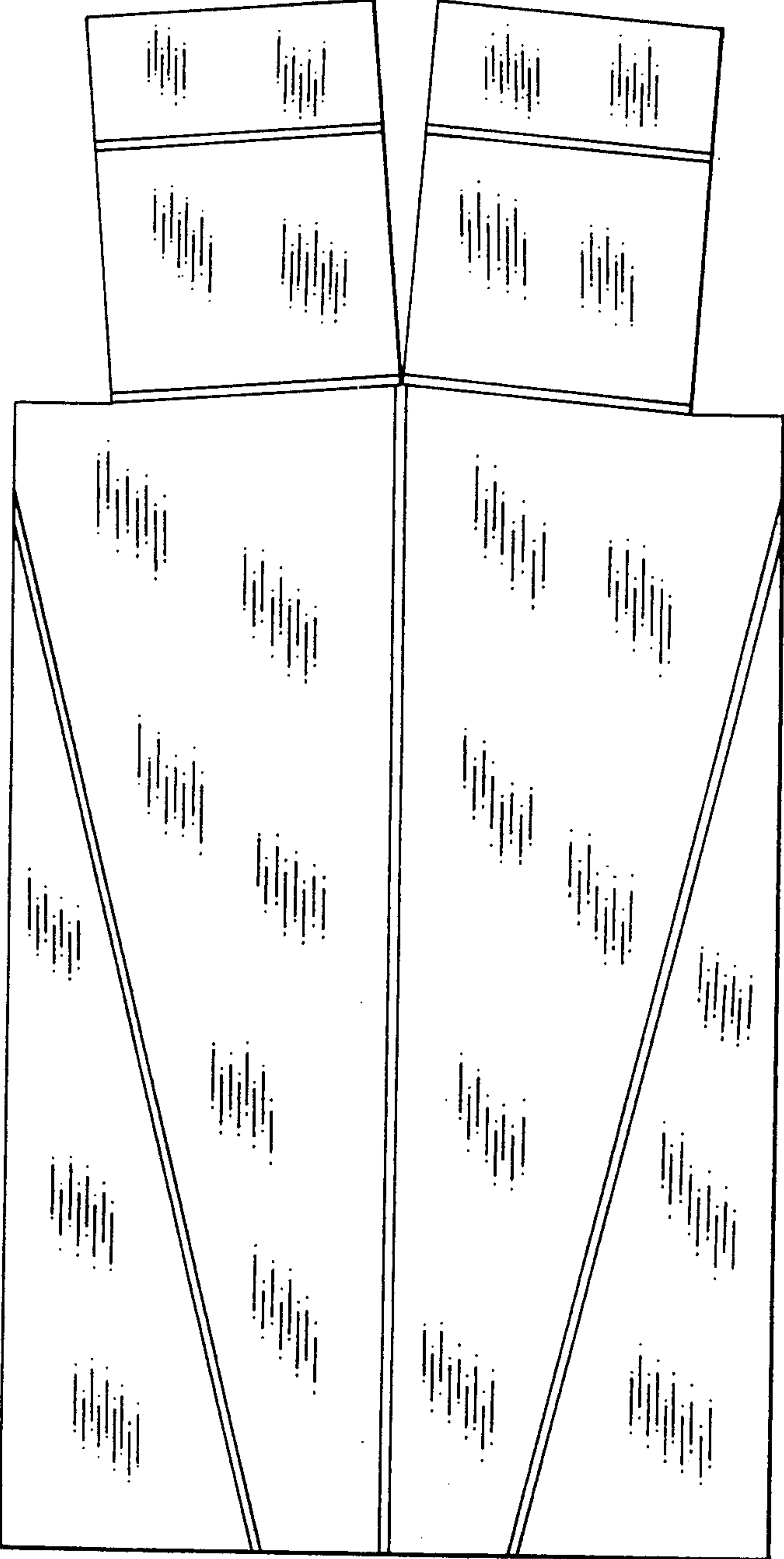
