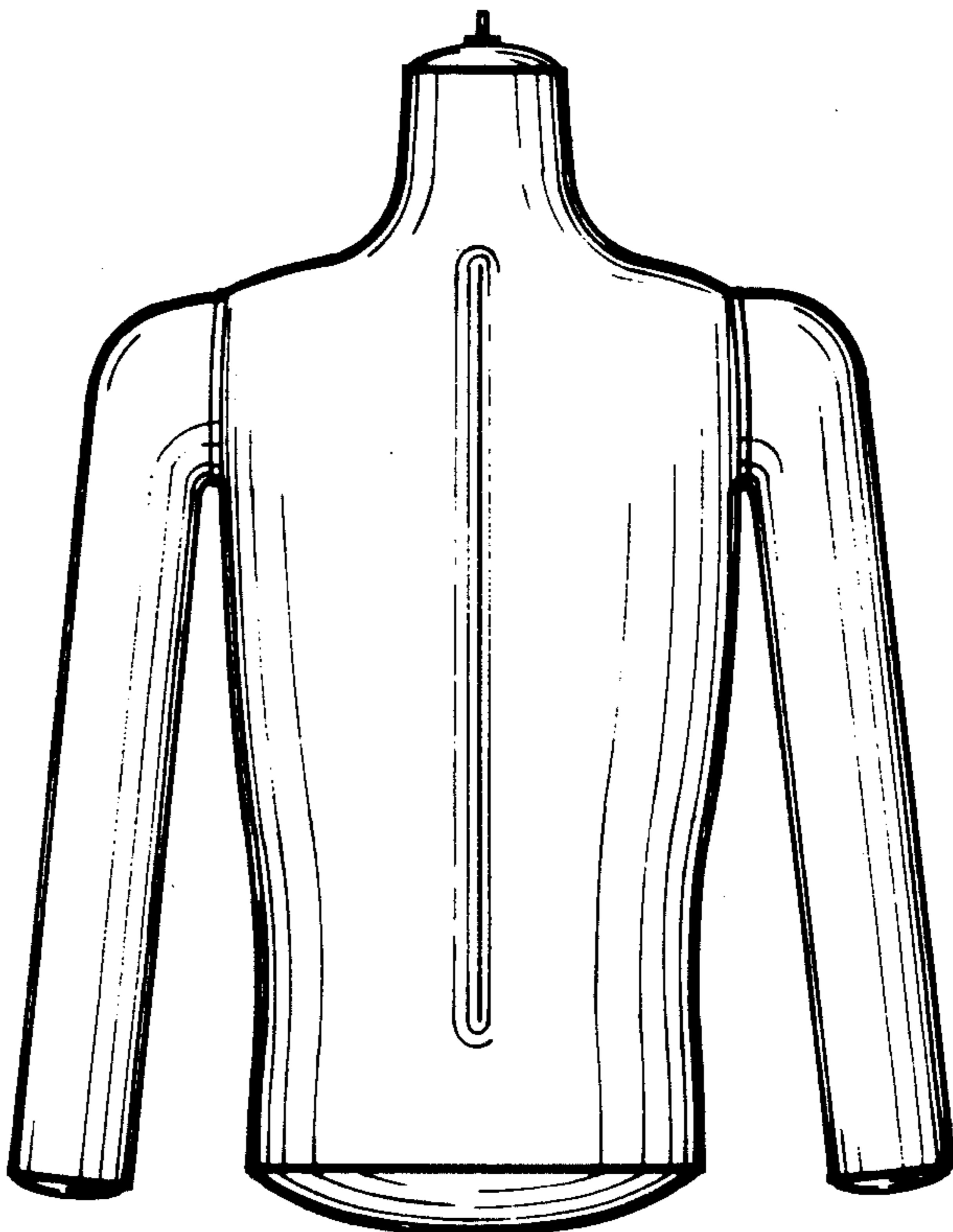
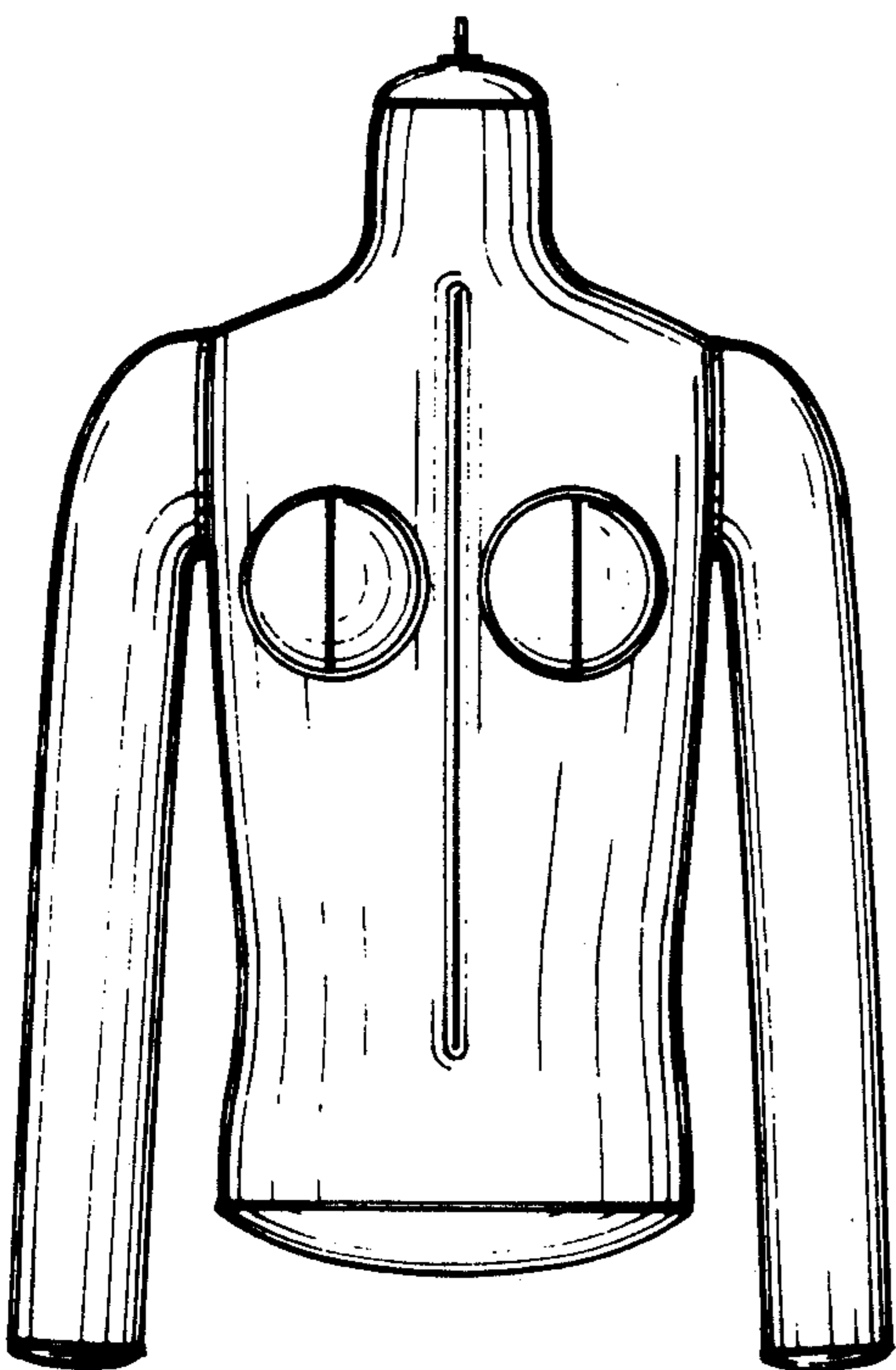

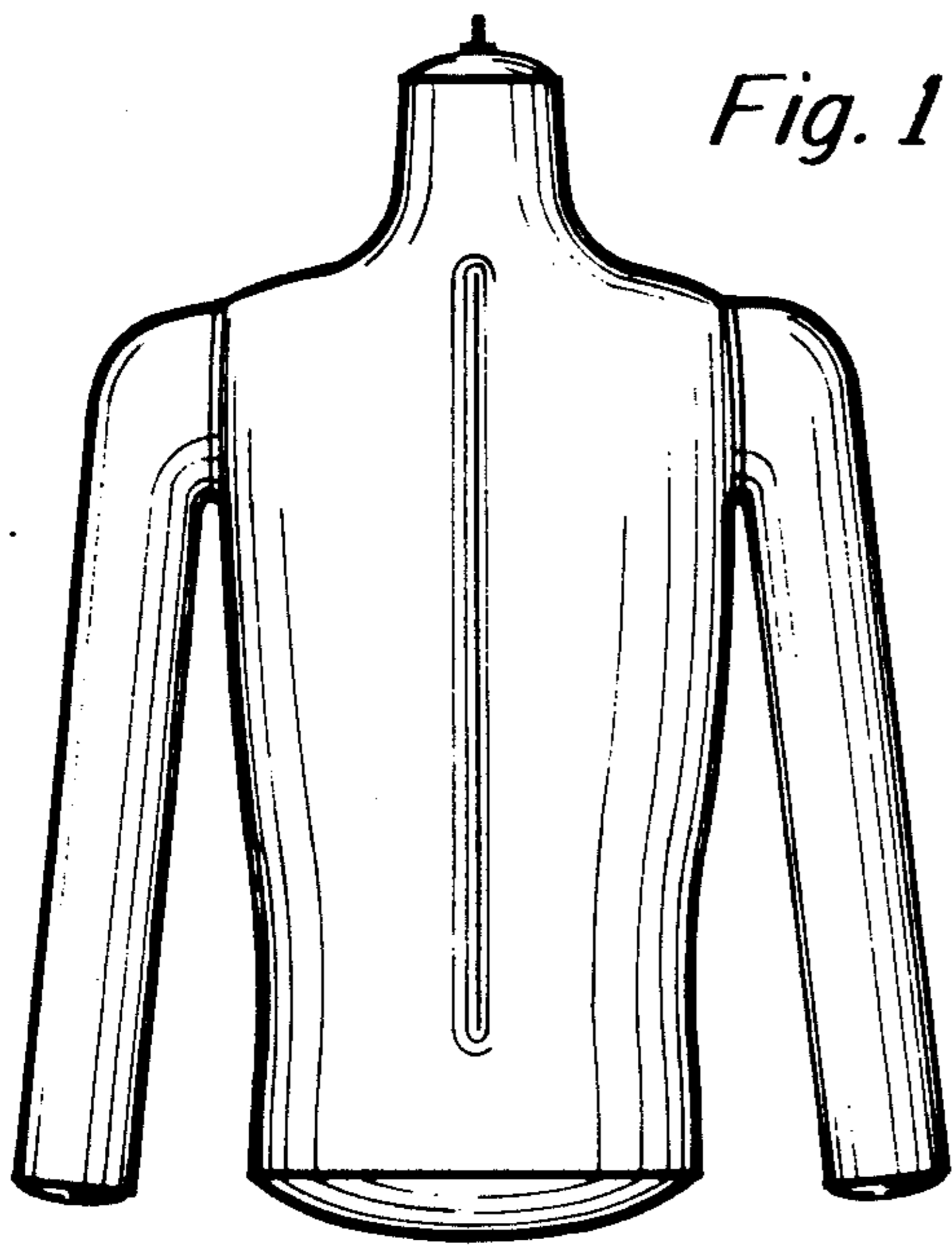
[57] CLAIM

The ornamental design for an inflatable display form, as shown and described.

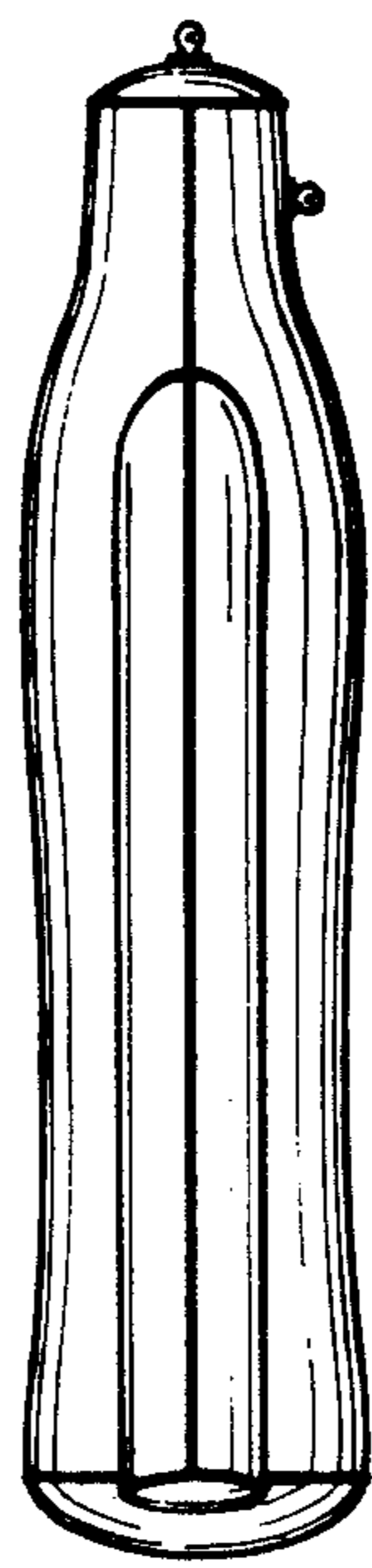
DESCRIPTION

FIG. 1 is a front elevational view of an inflatable display form, showing my new design;  
FIG. 2 is a side elevational view, the opposite side being a mirror image thereof;

FIG. 20 is a bottom plan view thereof.

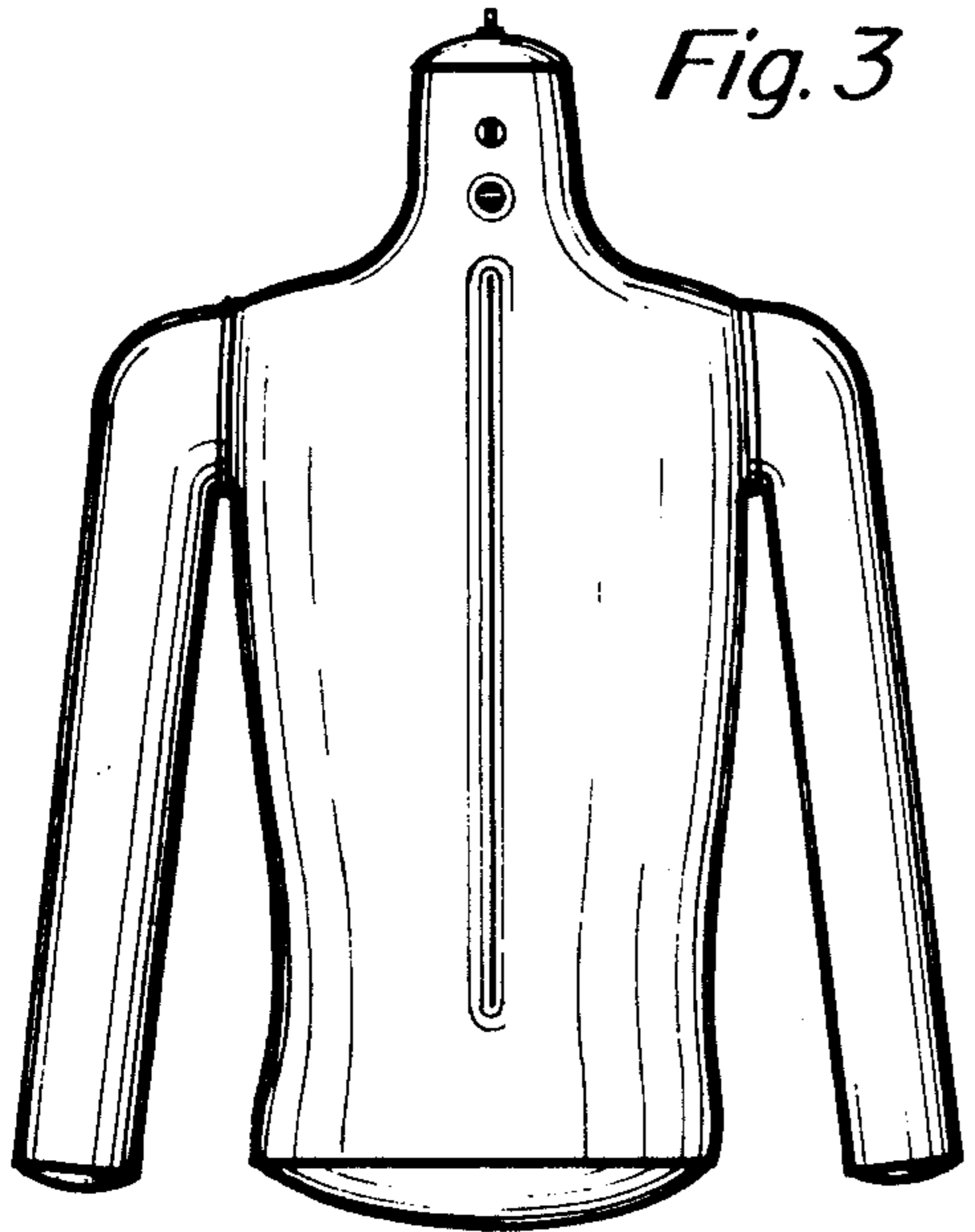




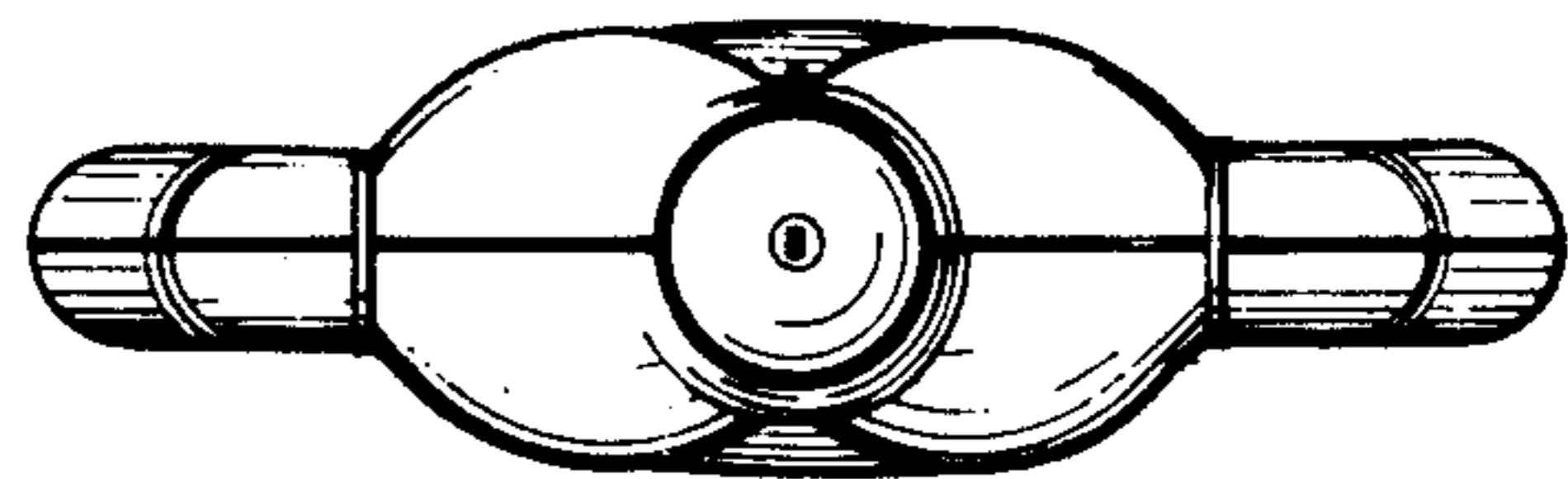

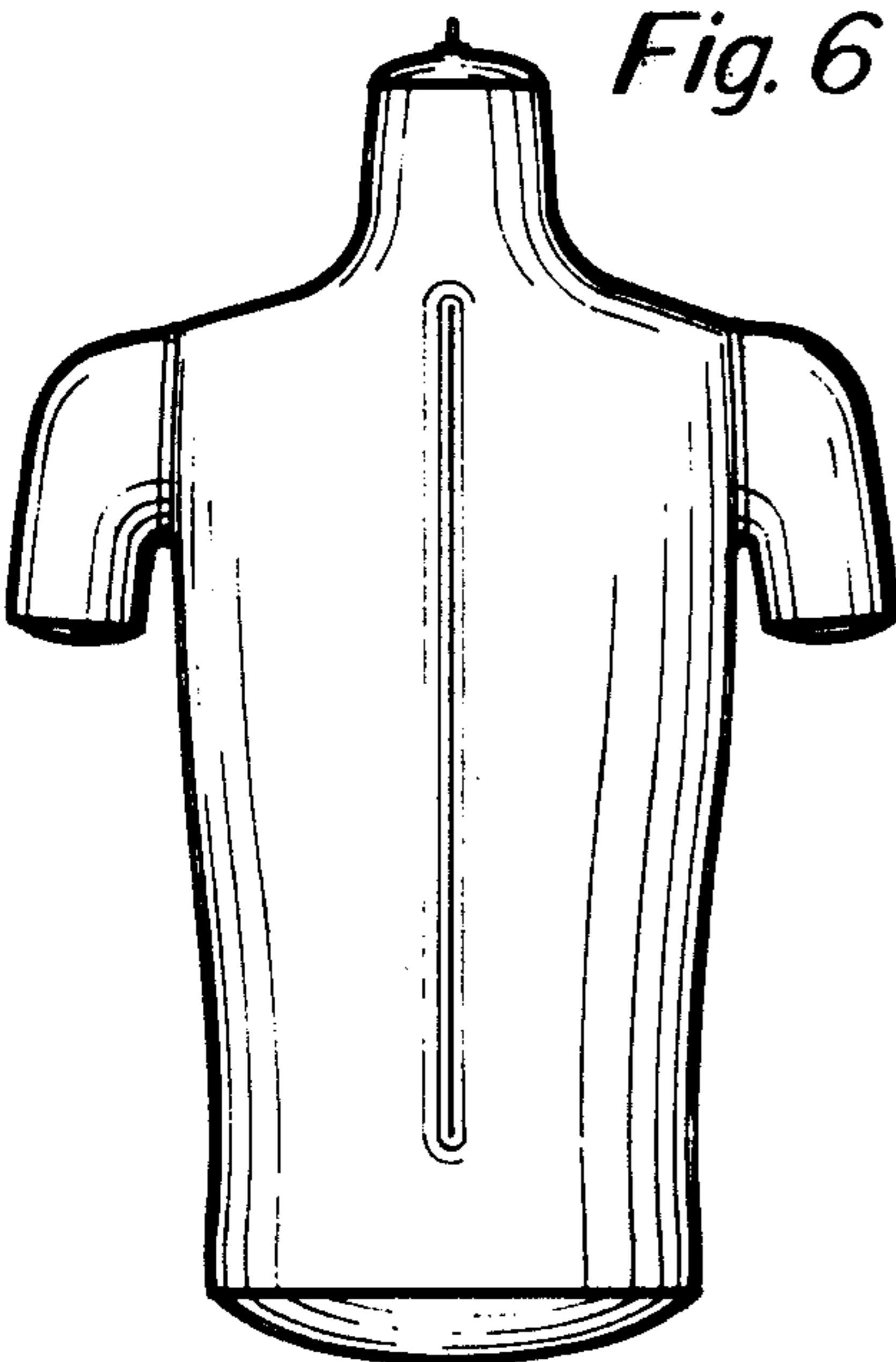

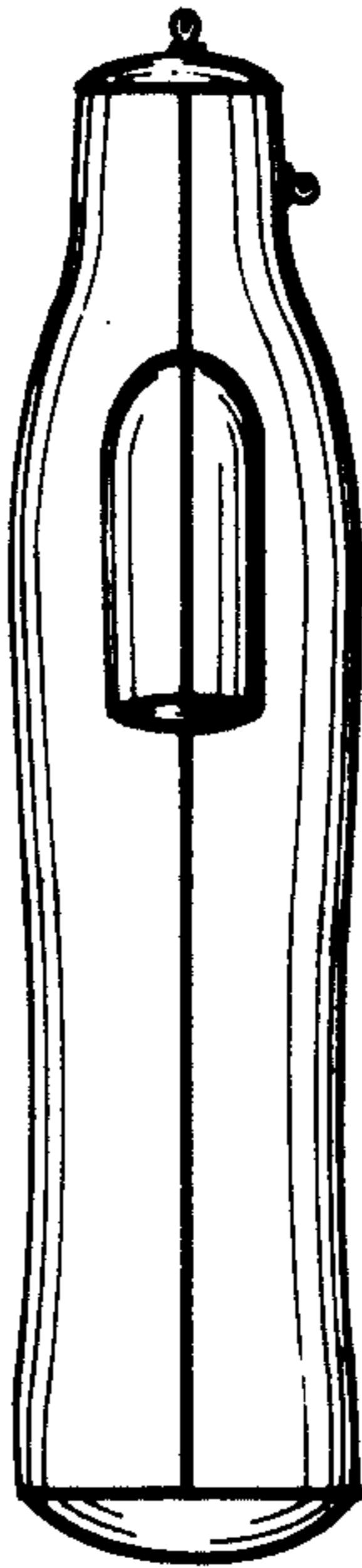

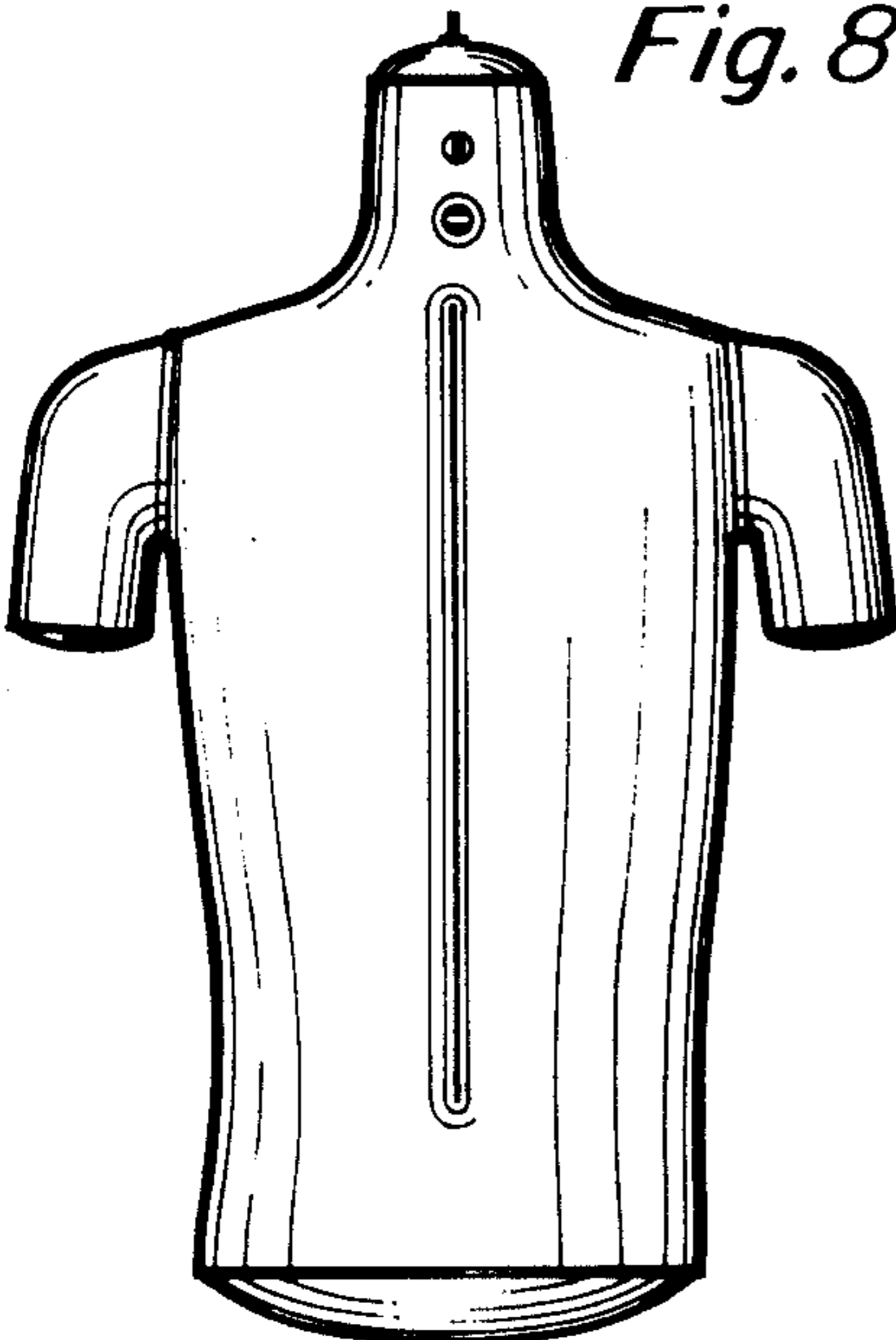

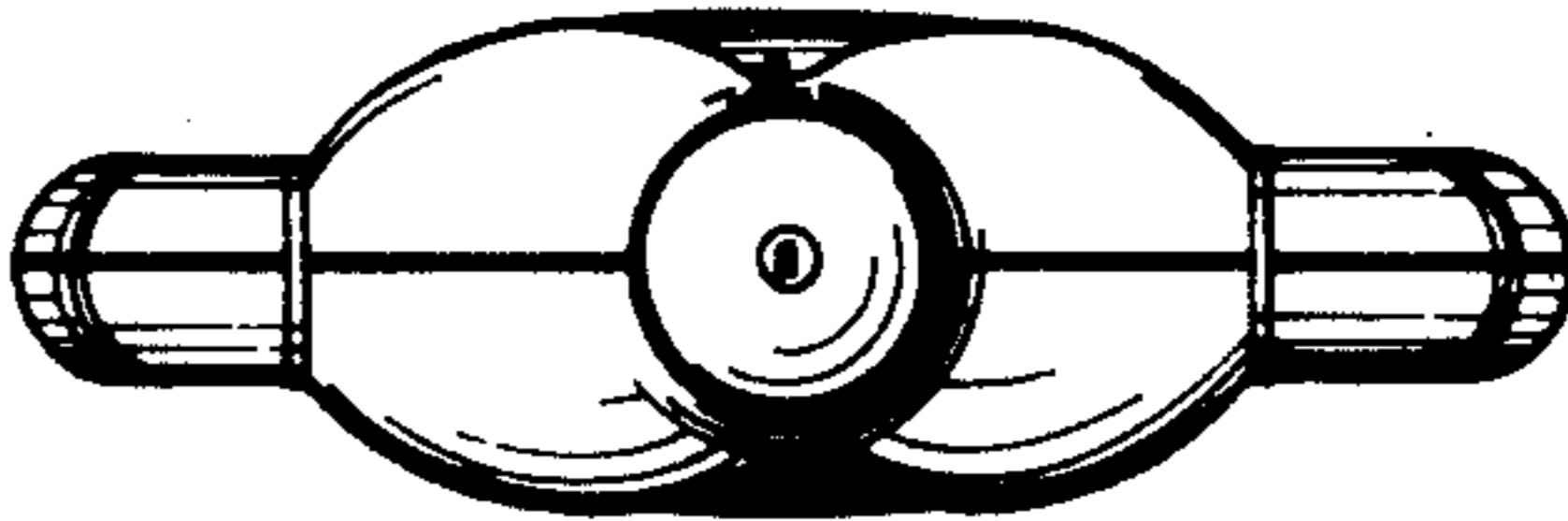
