[57] CLAIM

The ornamental design for a bathroom support fixture, substantially as shown and described.

DESCRIPTION

FIG. 1 is a reduced perspective view of a bathroom support fixture showing our new design embodied in a soap holder;

FIG. 2 is a top view of FIG. 1;

FIG. 3 is a front view of FIG. 1;

FIG. 4 is a side view taken from the left of FIG. 1;

FIG. 5 is a bottom view of FIG. 1;

FIG. 6 is a sectional view taken on line 6-6 of FIG. 2;

FIG. 7 is a fragmentary sectional view taken on line 7-7 of FIG. 3;

FIG. 8 is a top view of a bathroom support fixture embodied in a combined tumbler and toothbrush holder;

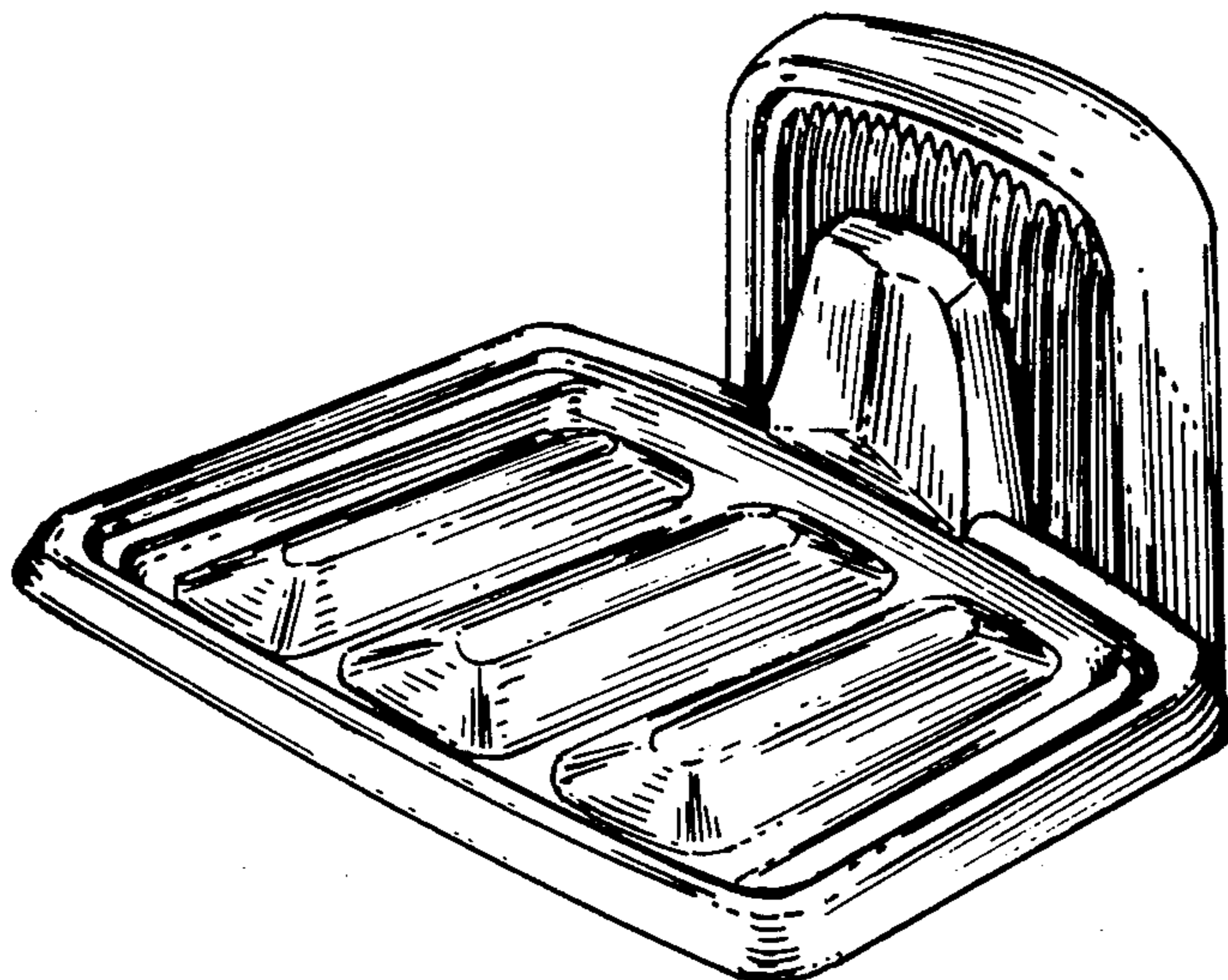
FIG. 9 is a front view of FIG. 8;

FIG. 10 is a bottom view of FIG. 8;

FIG. 11 is a side view taken from the left of FIG. 9;

FIG. 13 is an enlarged fragmentary sectional view taken on line 13-13 of FIG. 9.



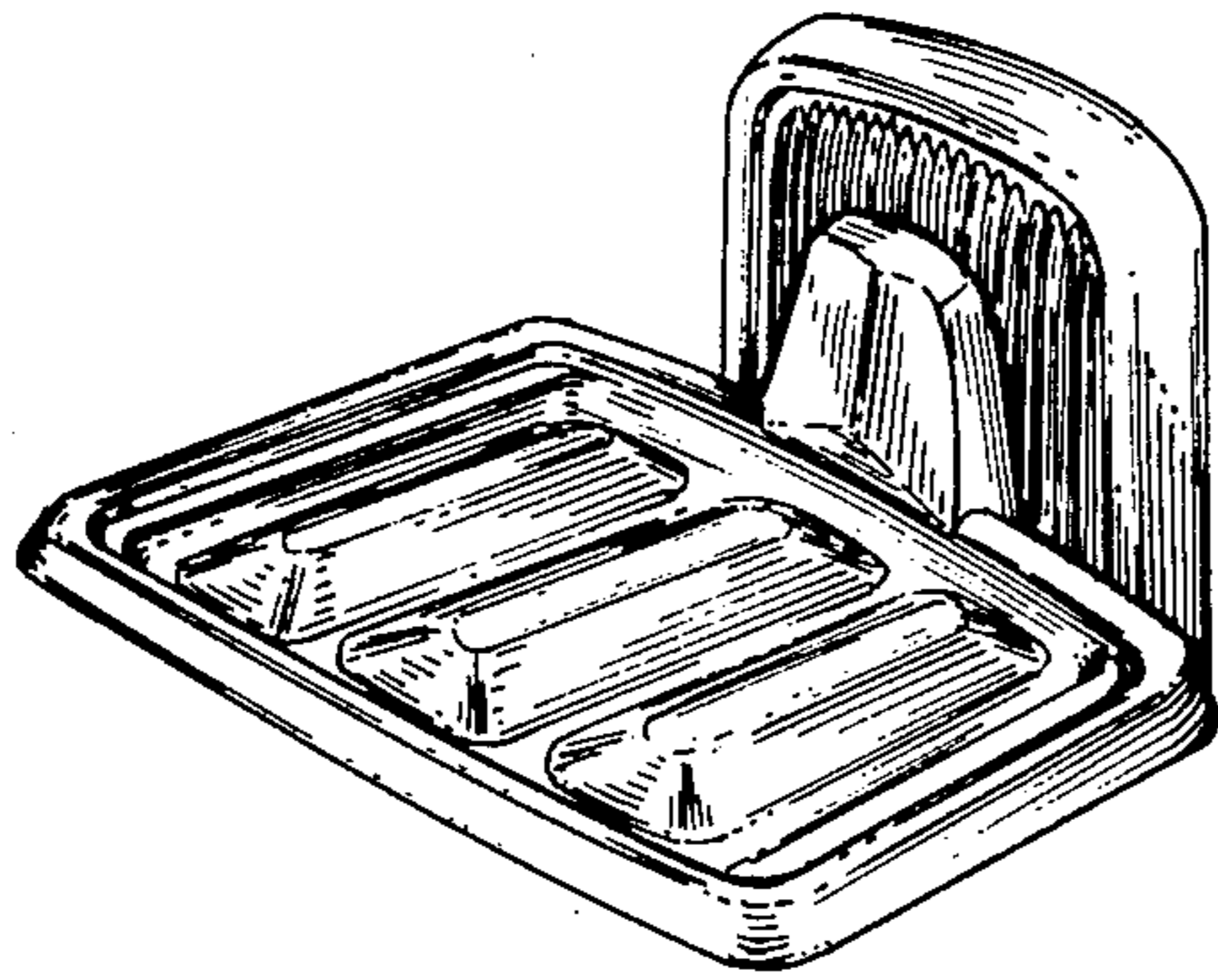

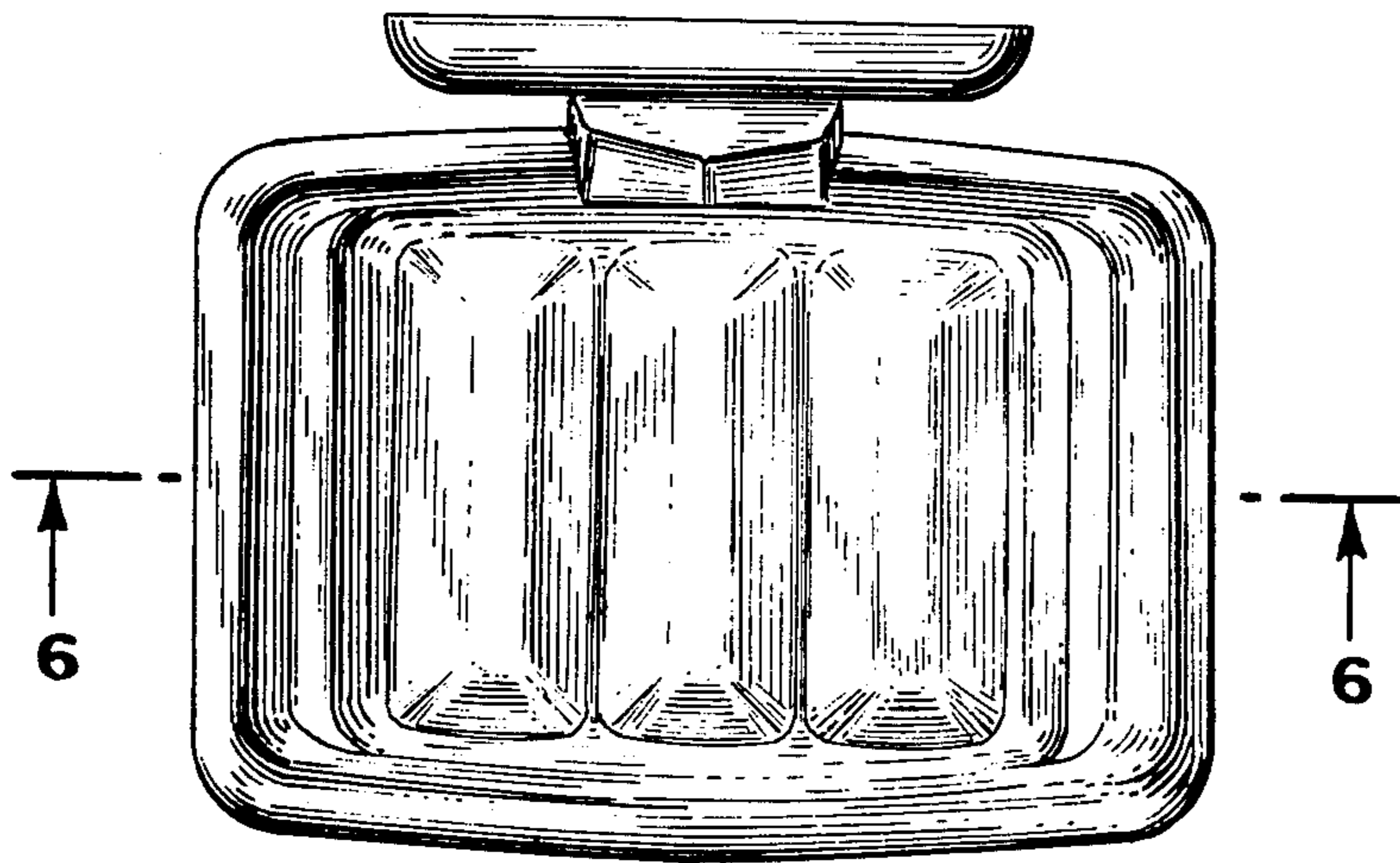

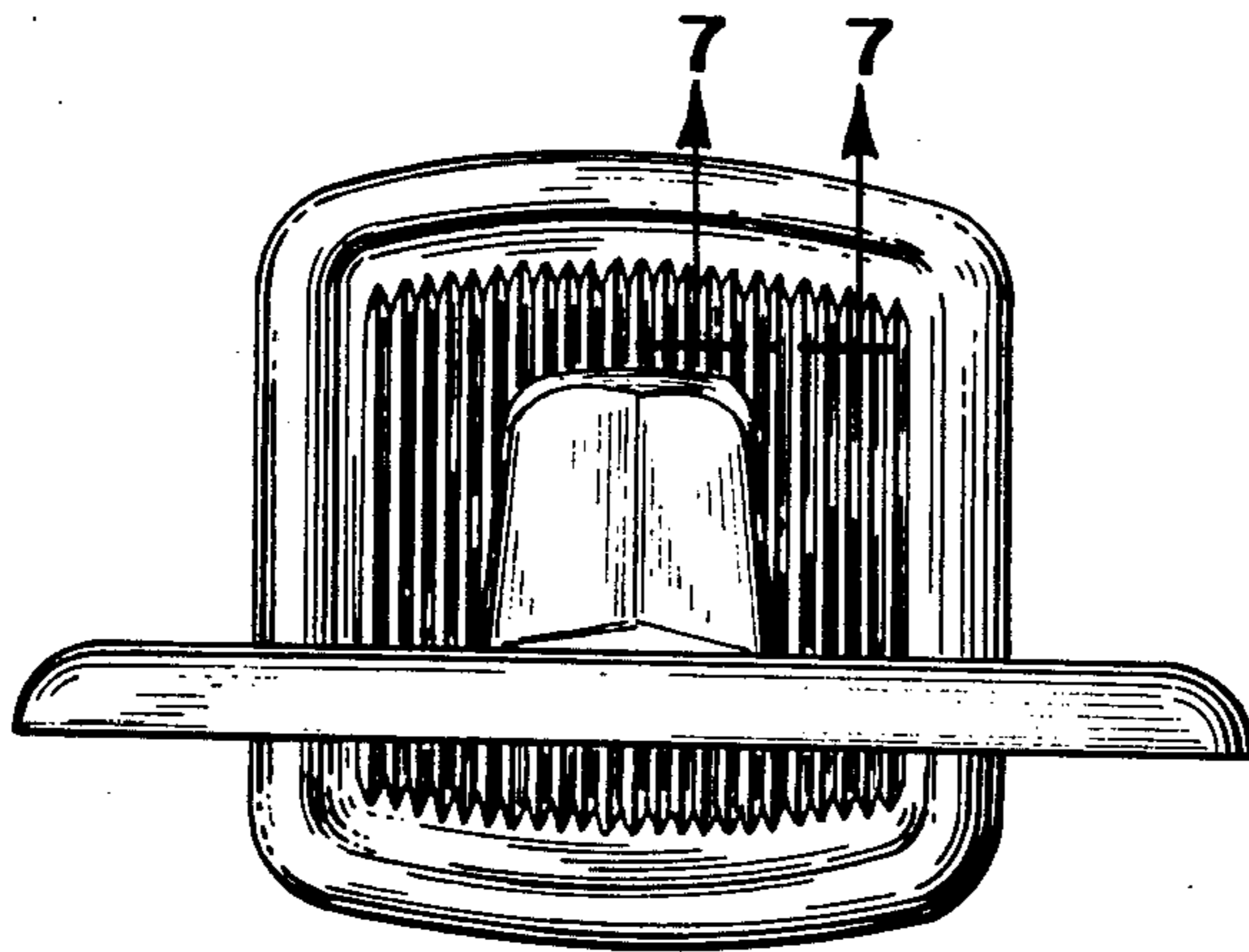

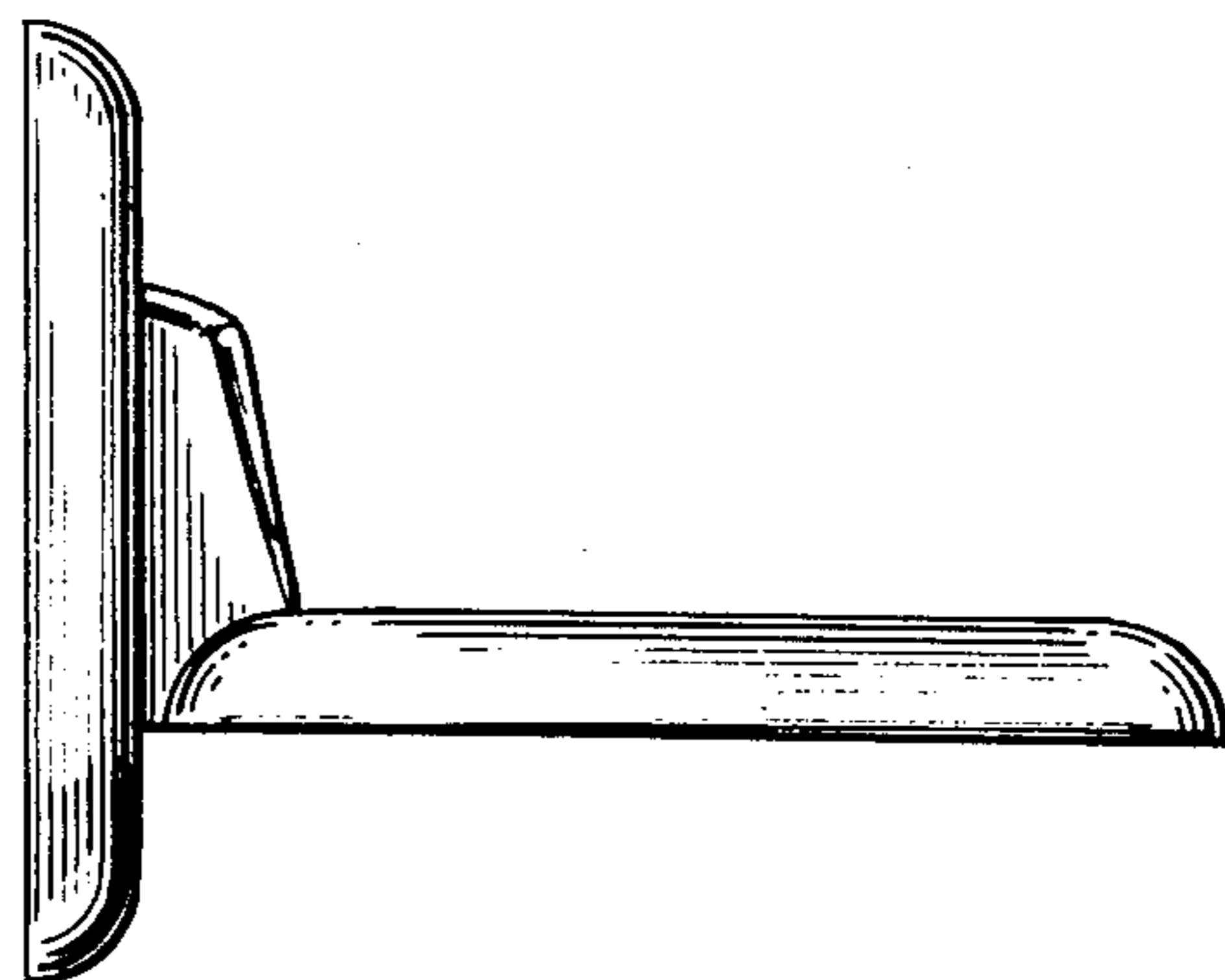

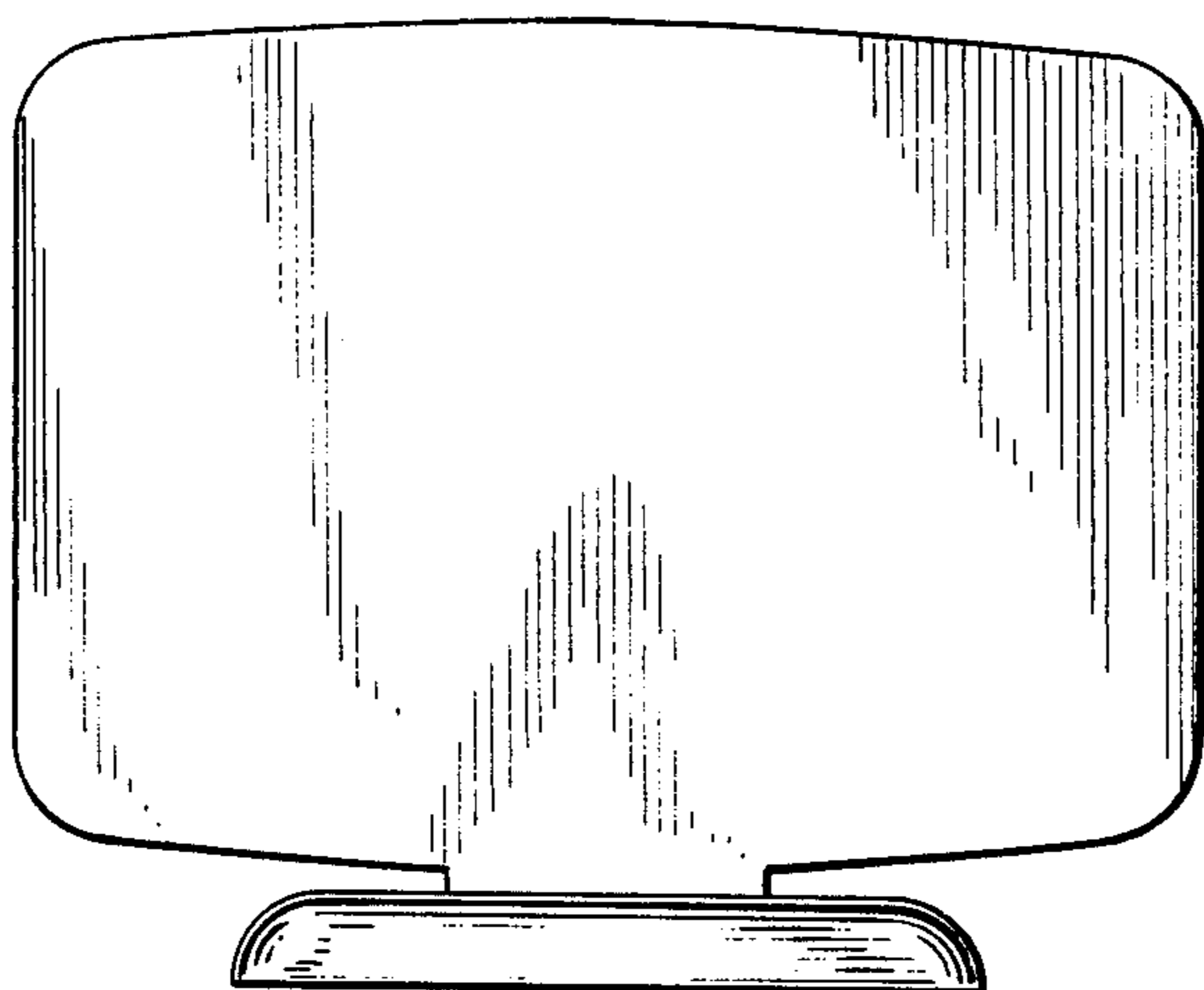

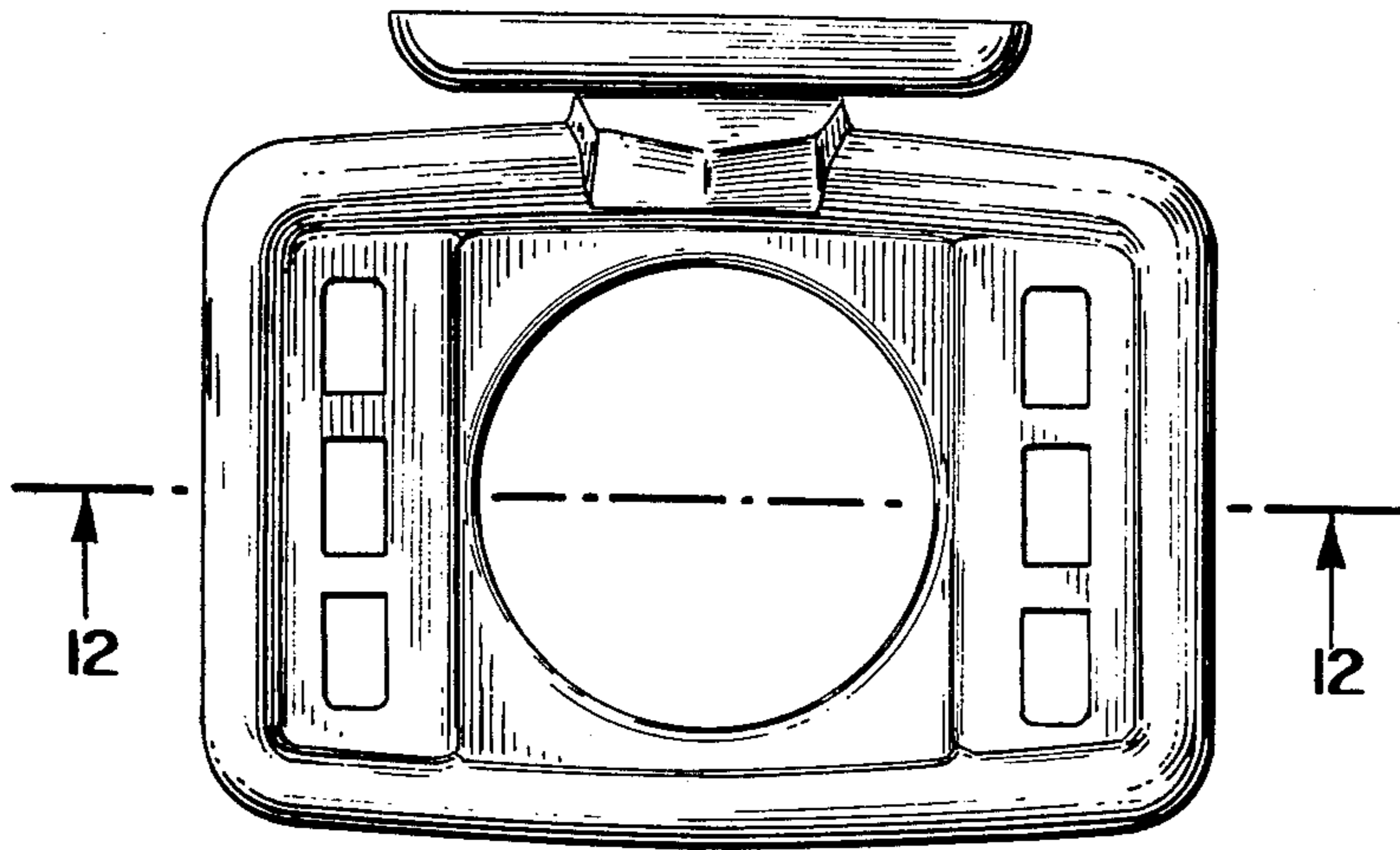

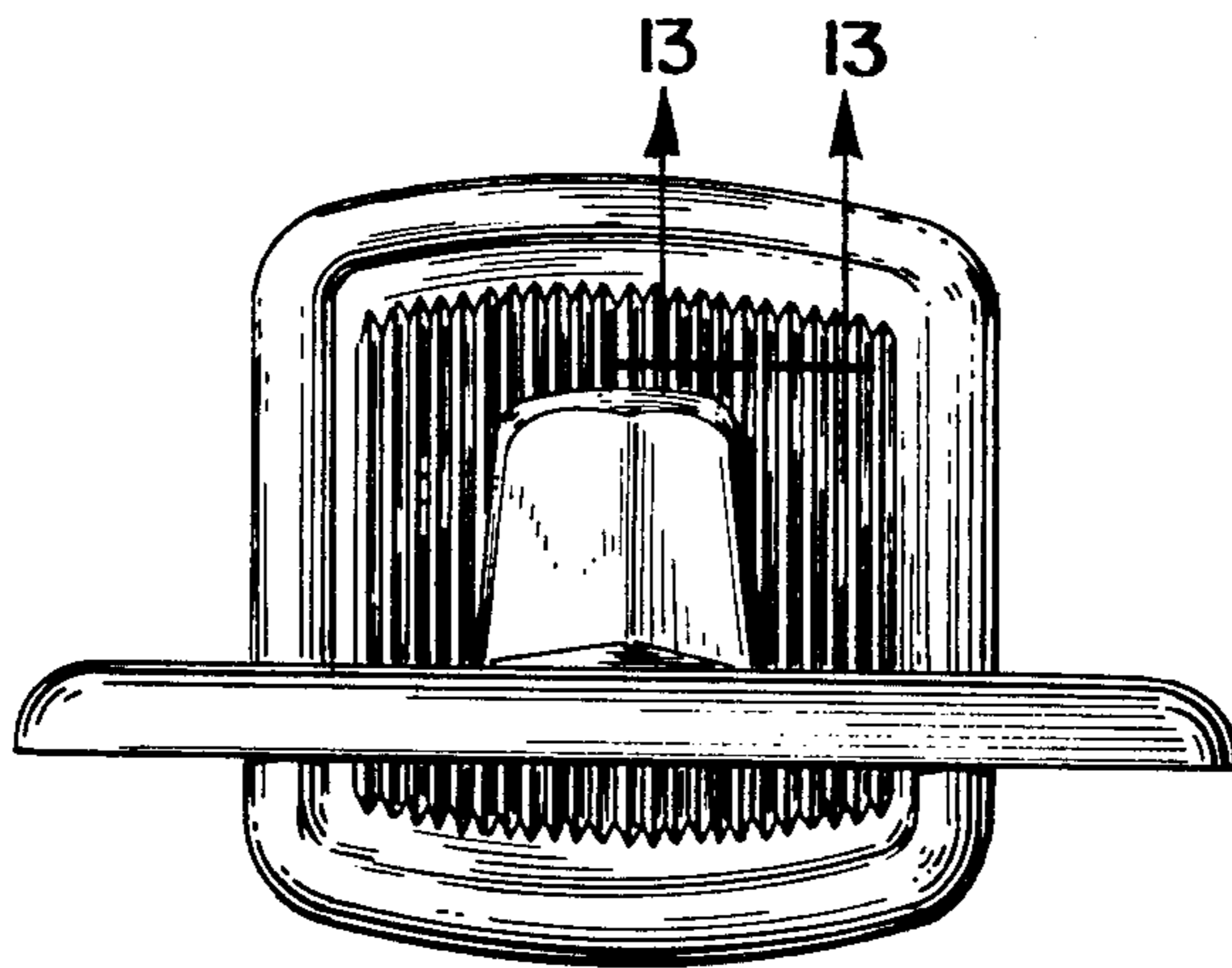

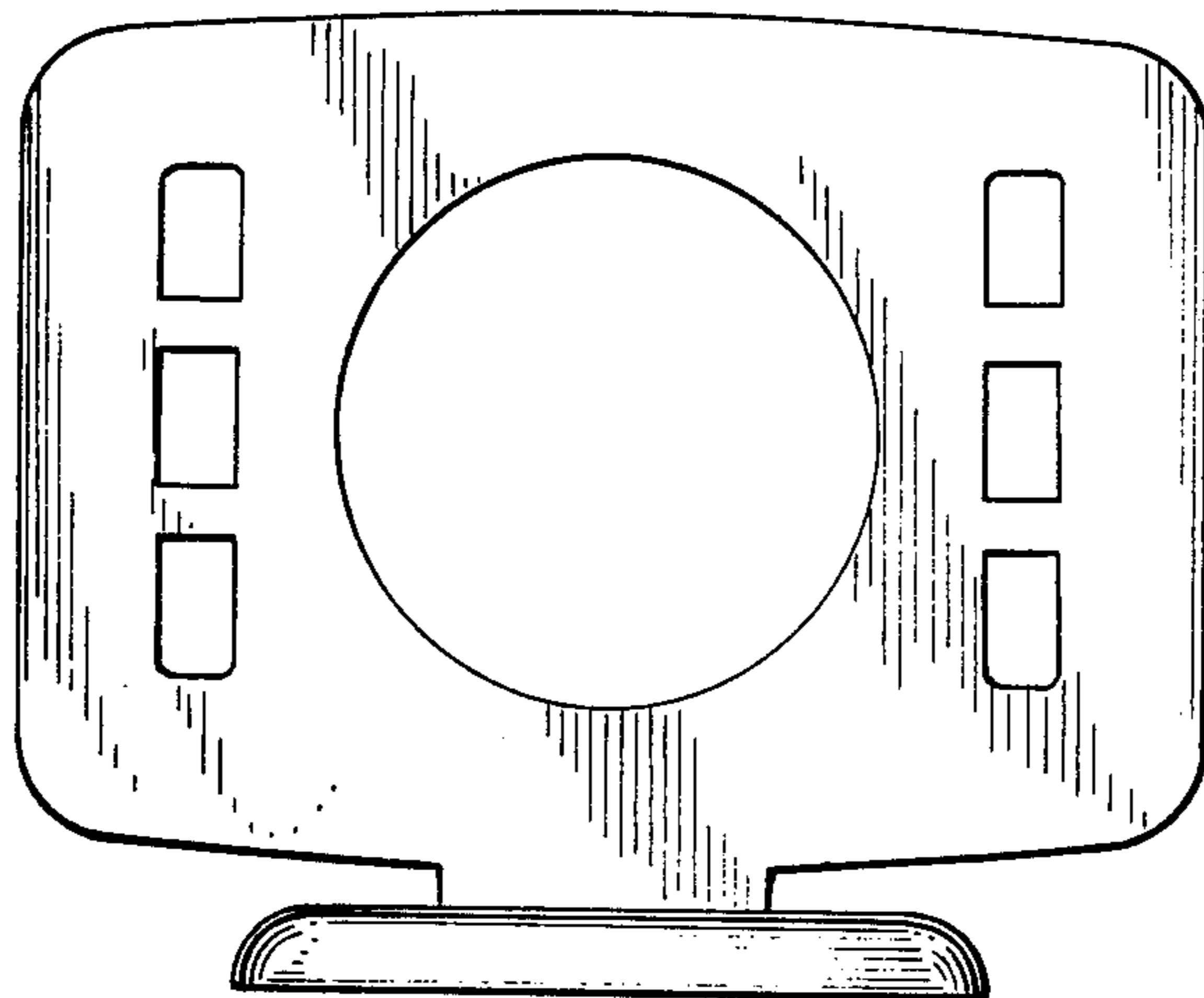

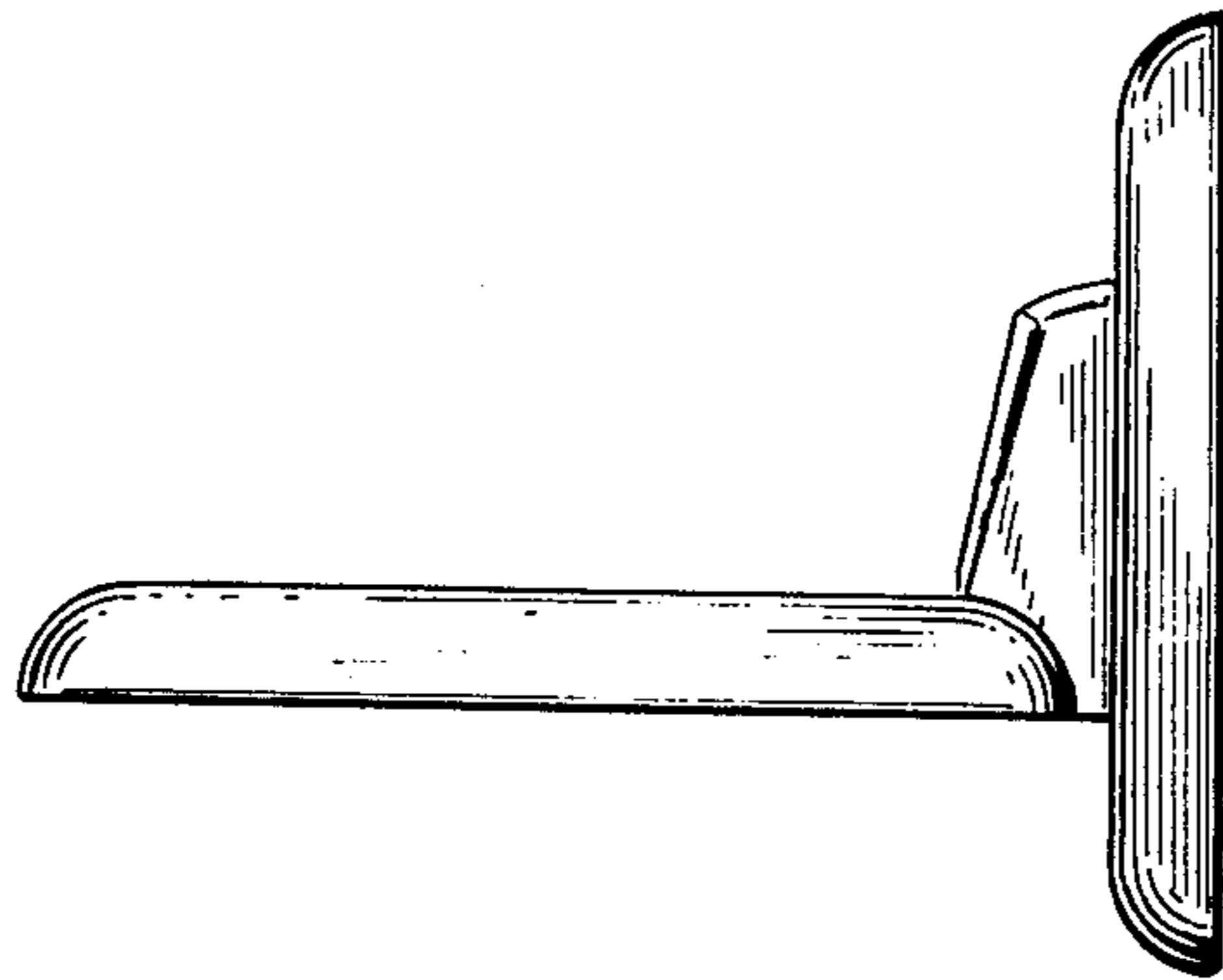
