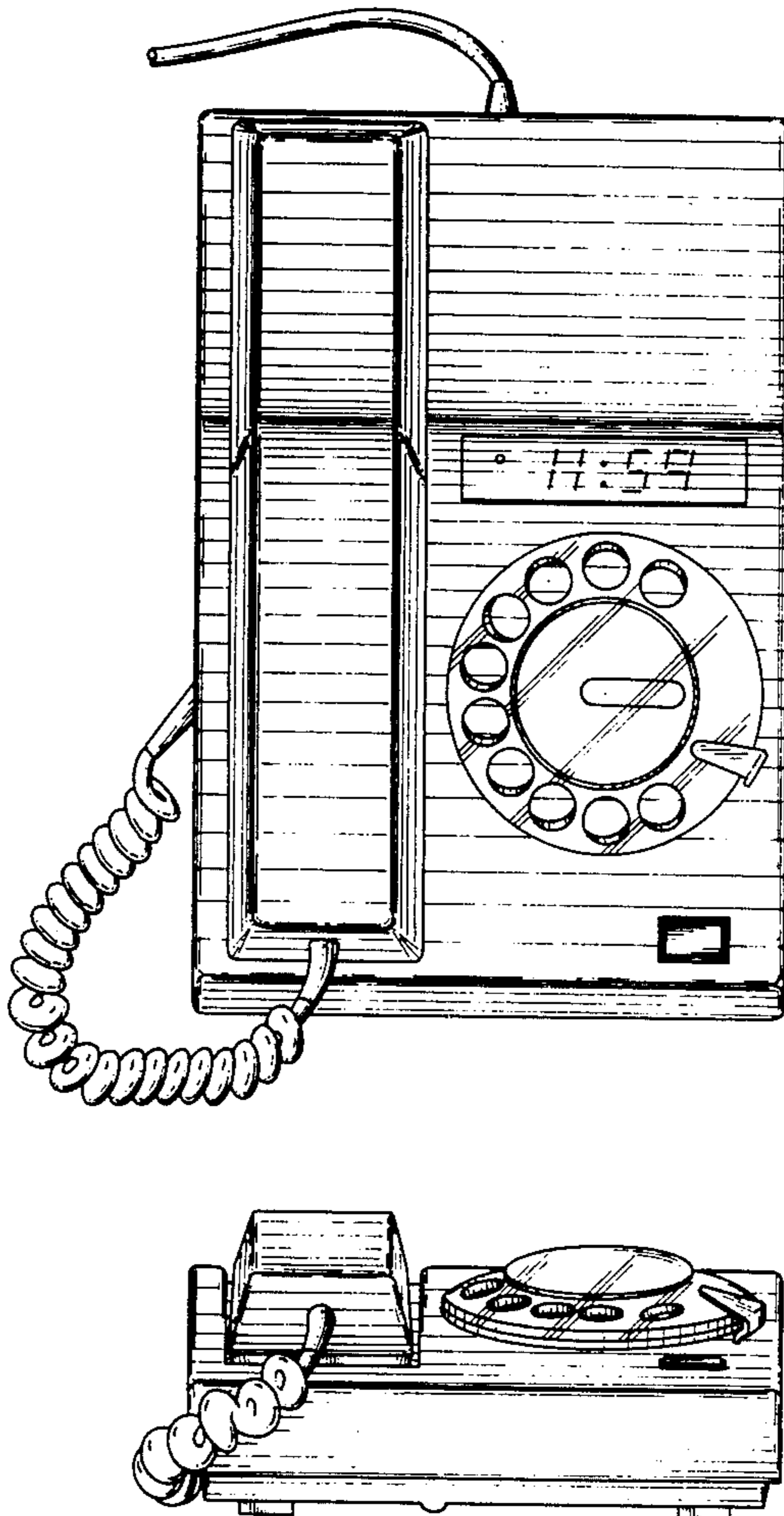

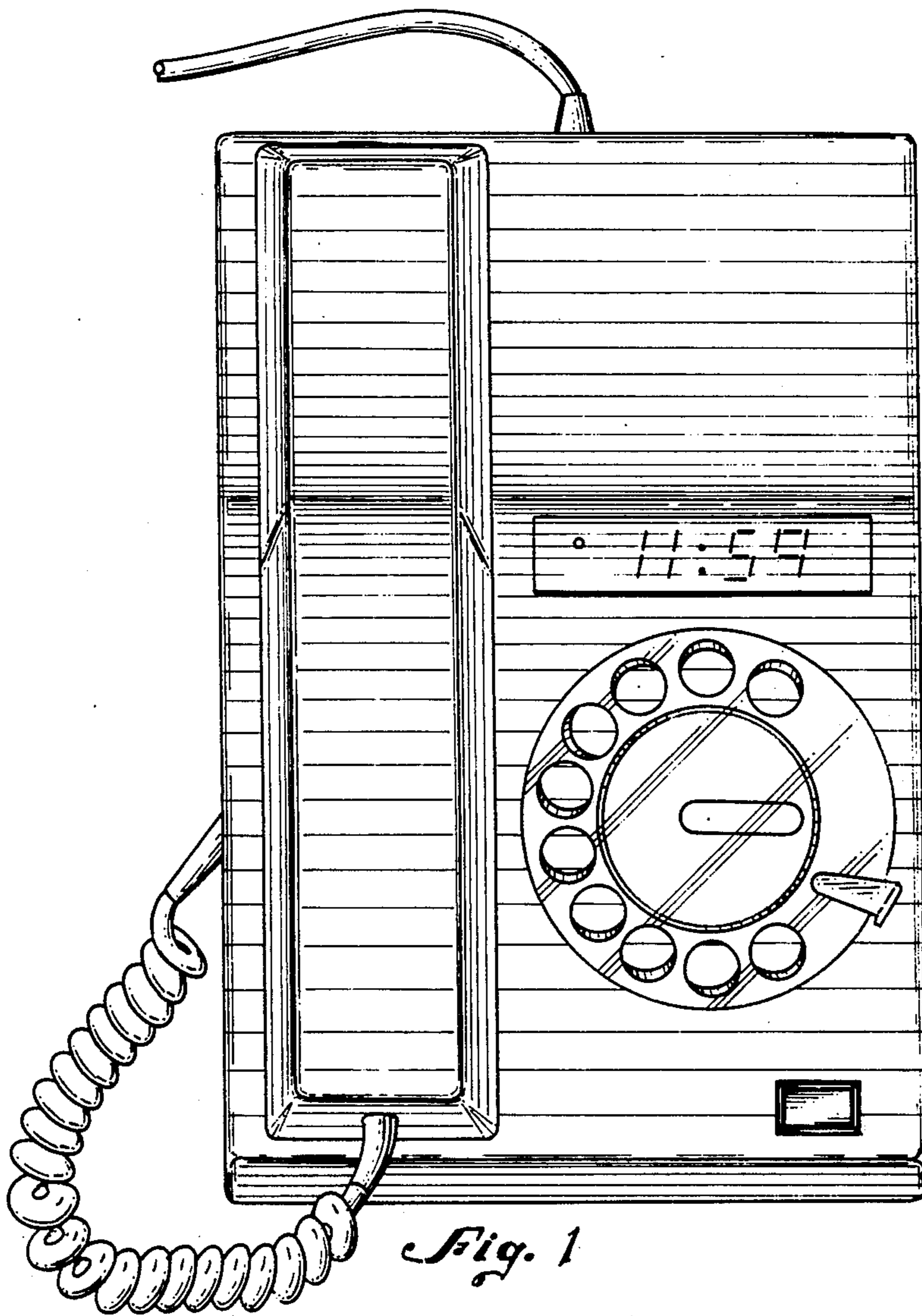
[57] CLAIM

The ornamental design for combination telephone instrument, substantially as shown and described.

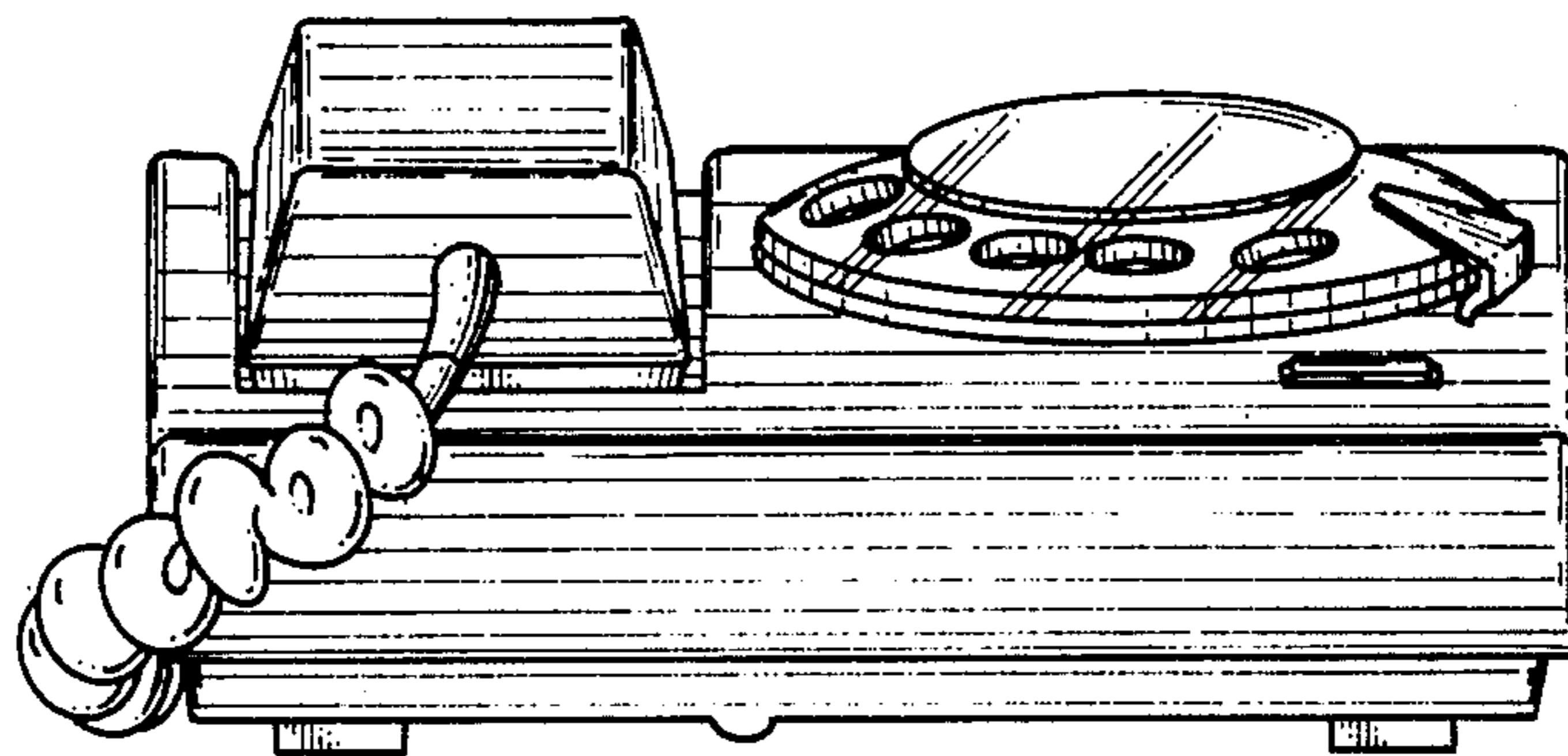
DESCRIPTION

FIG. 1 is a top plan view of a combination telephone instrument depicted in the form of a combination telephone and timer showing our new design; FIG. 2 is a front elevation thereof; FIG. 3 is a rear elevation thereof; FIG. 4 is a left side elevation thereof; FIG. 5 is a right side elevation thereof; FIG. 6 is a top plan view of a modified embodiment of the telephone instrument depicted in the form of a combination telephone and radio; FIG. 7 is a front elevation thereof; FIG. 8 is a rear elevation thereof; FIG. 9 is a left side elevation thereof; FIG. 10 is a right side elevation thereof; FIG. 11 is a top plan view of a further modified embodiment of the telephone instrument depicted in the form of a combination telephone and alarm clock; FIG. 12 is a front elevation thereof; FIG. 13 is a rear elevation thereof; FIG. 14 is a left side elevation thereof; and FIG. 15 is a right side elevation thereof.

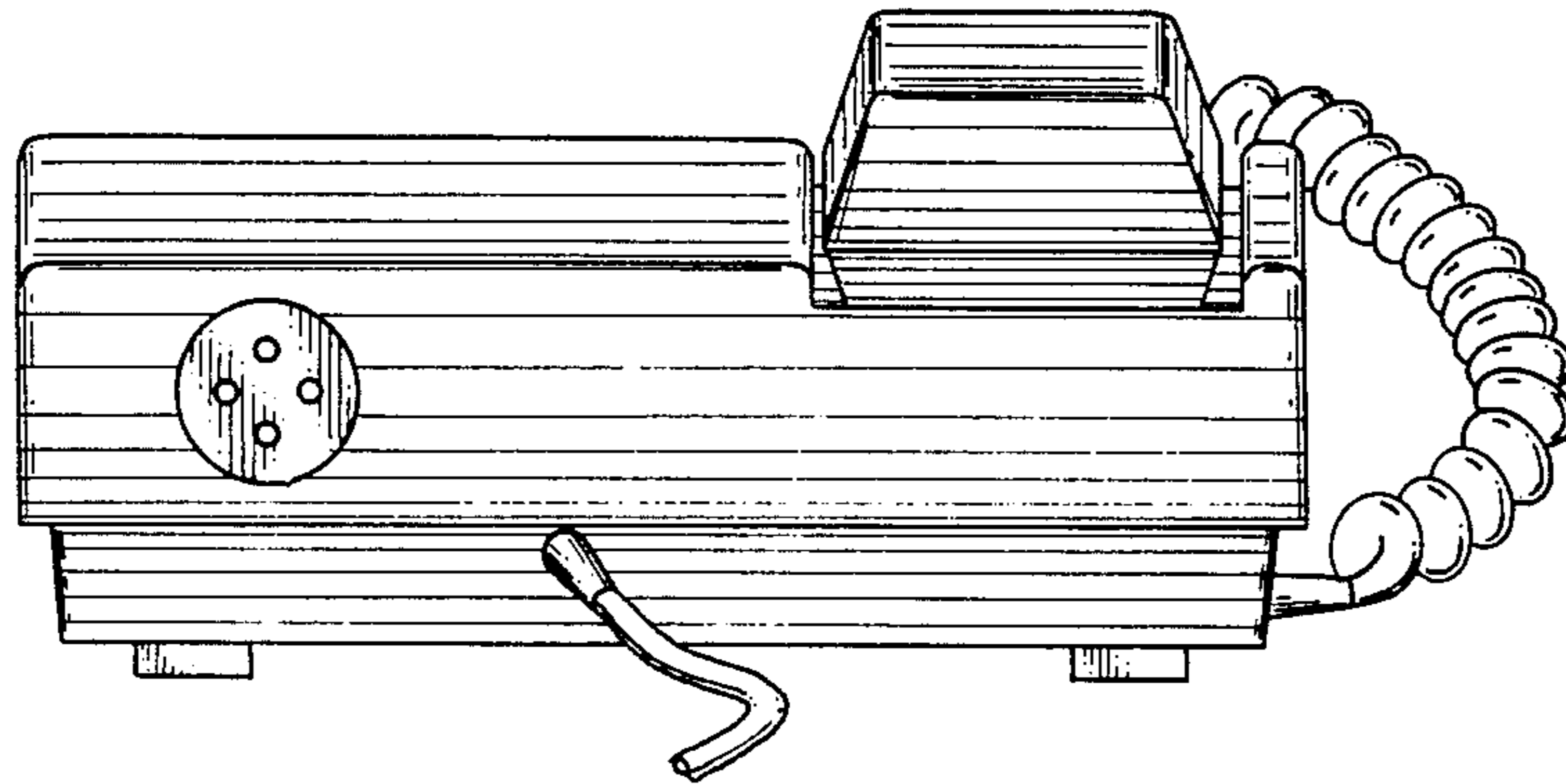




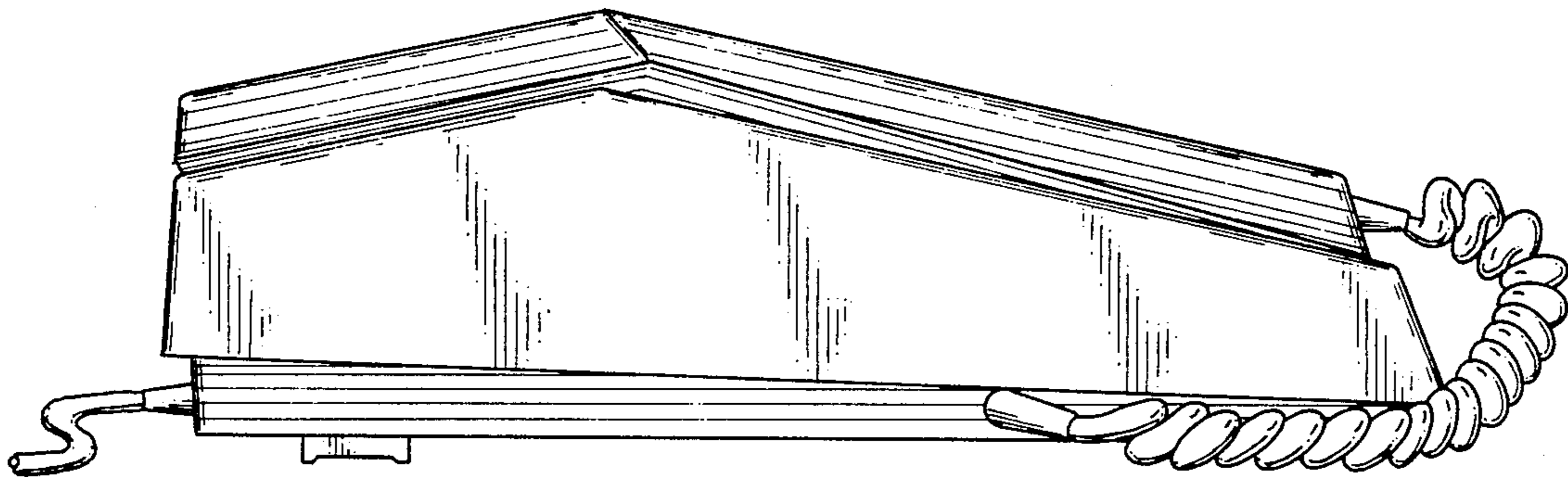

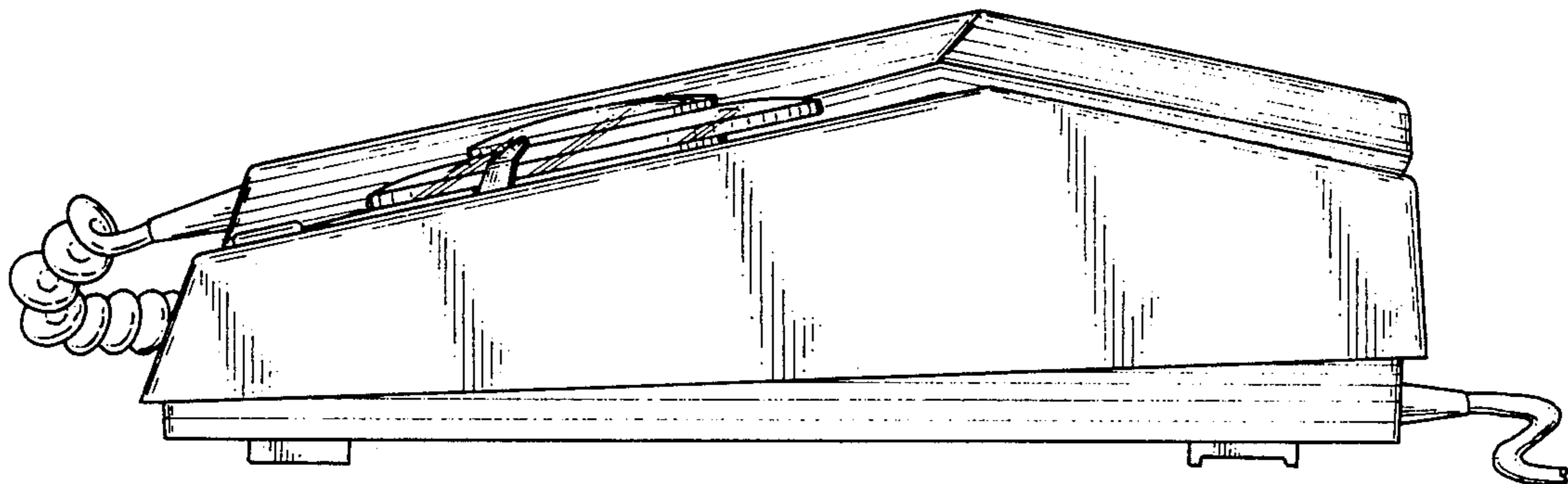

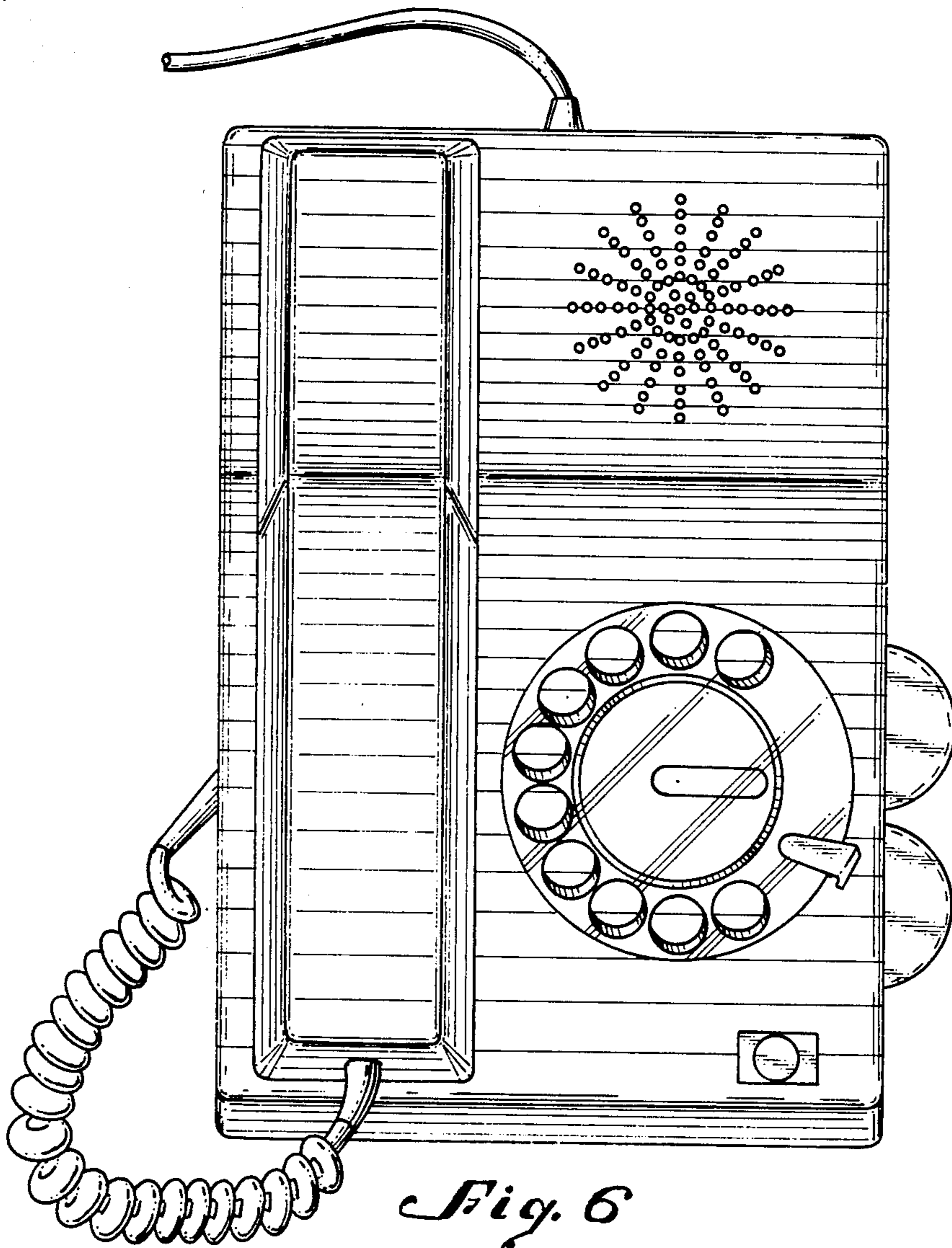

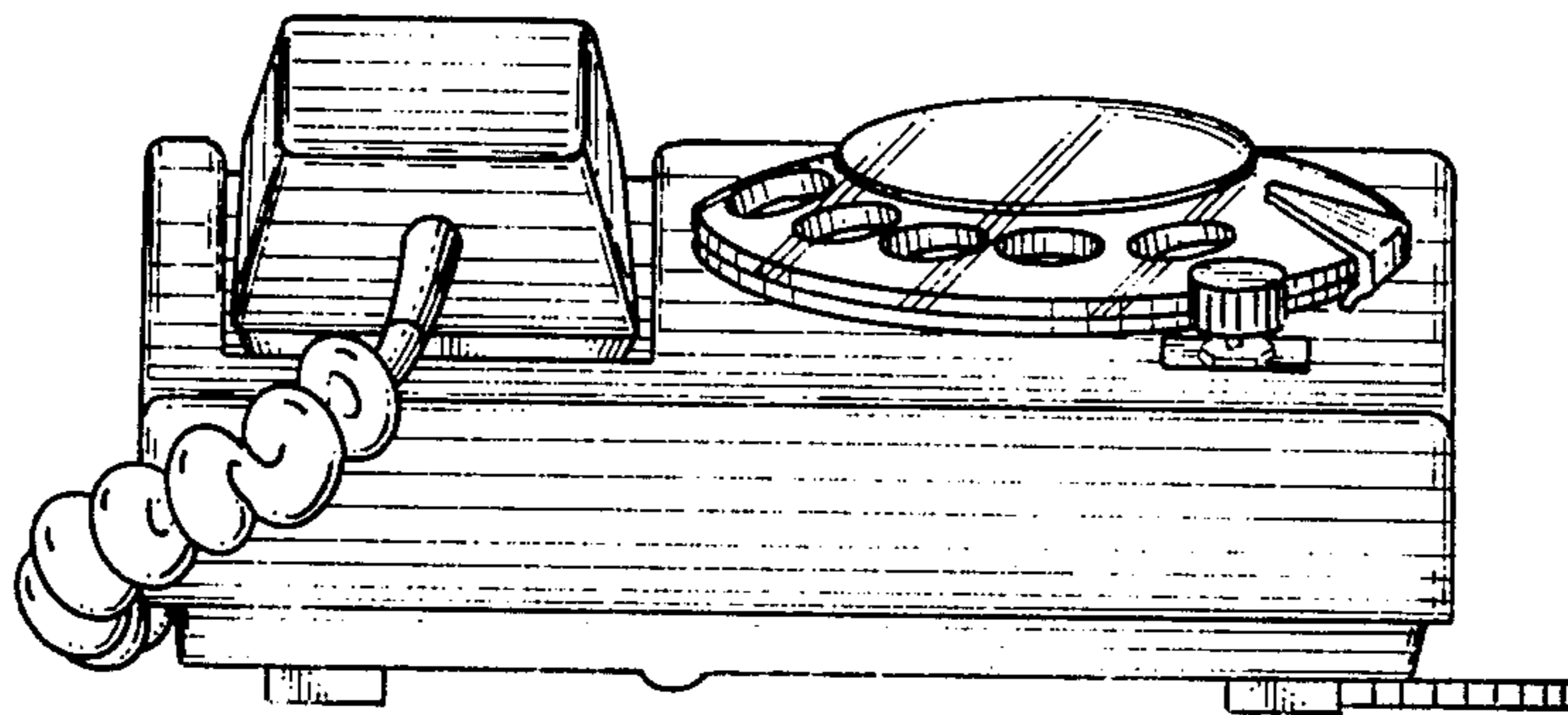

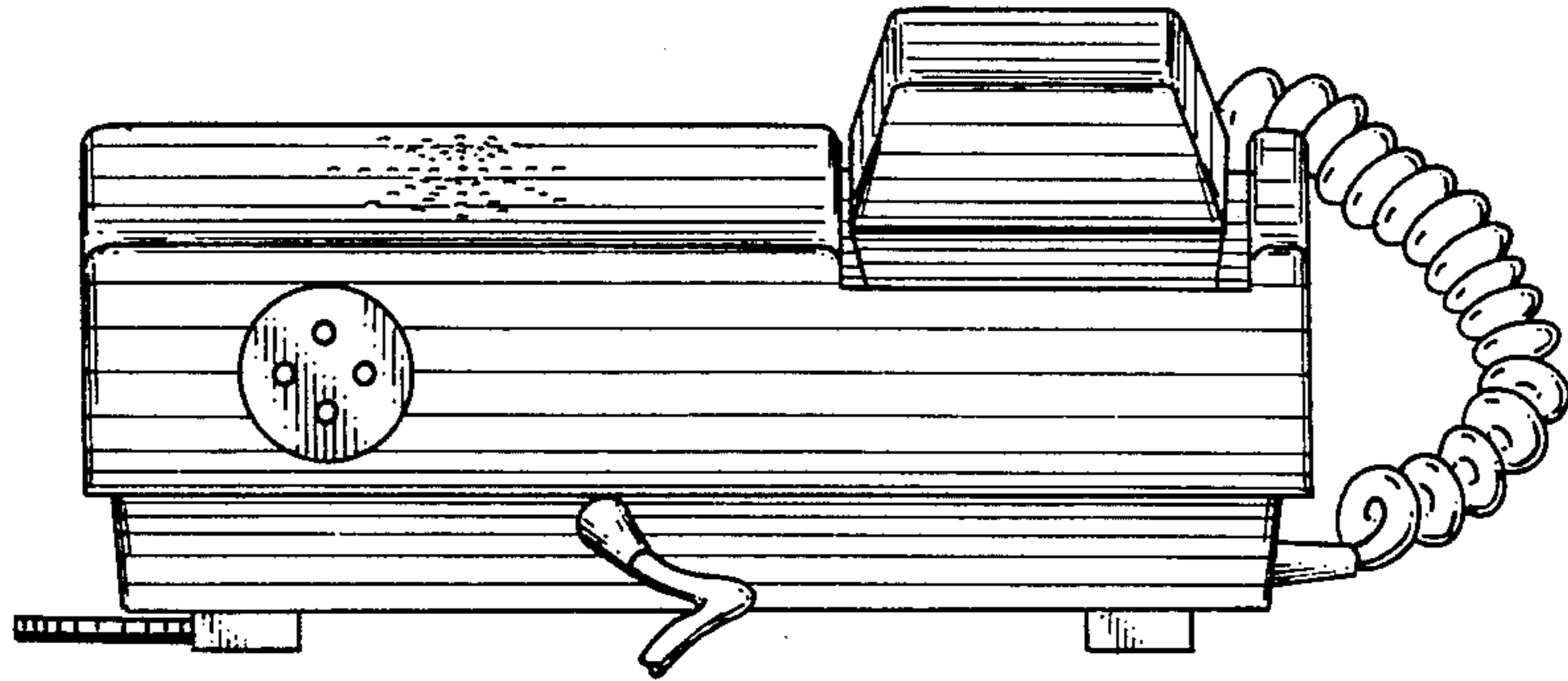

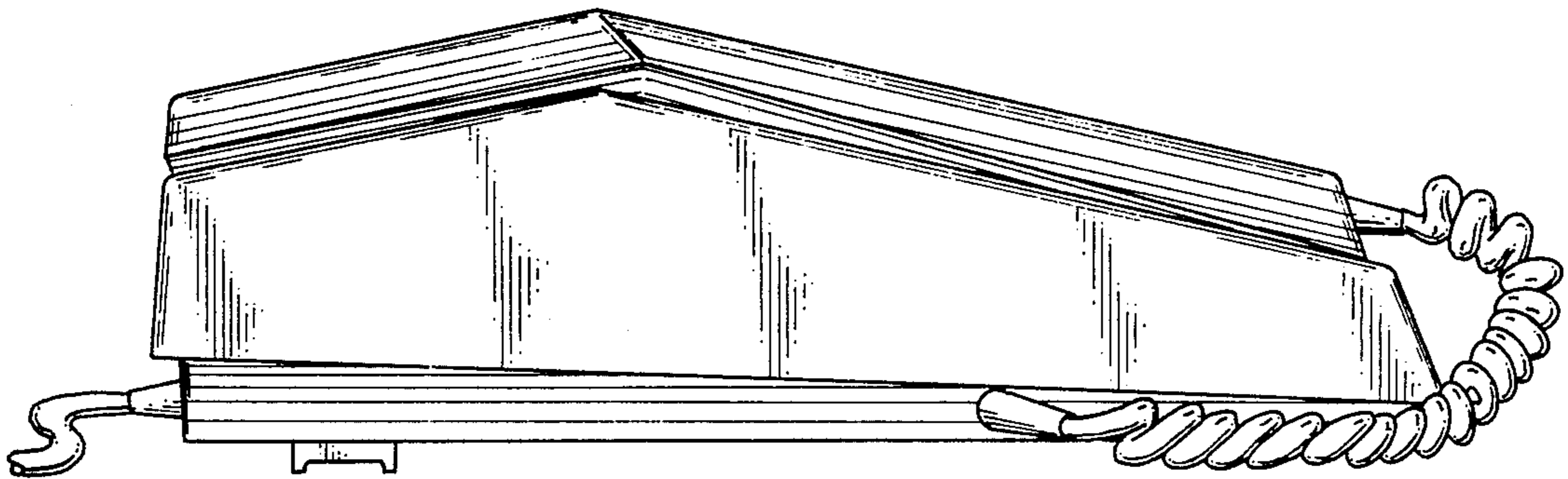

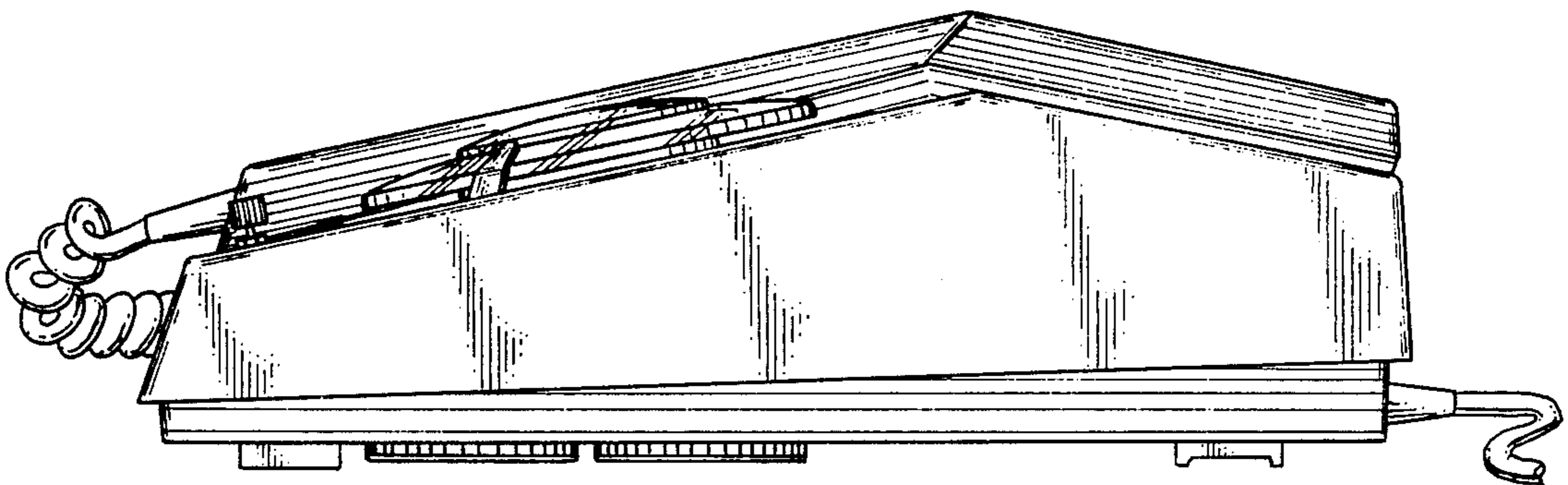

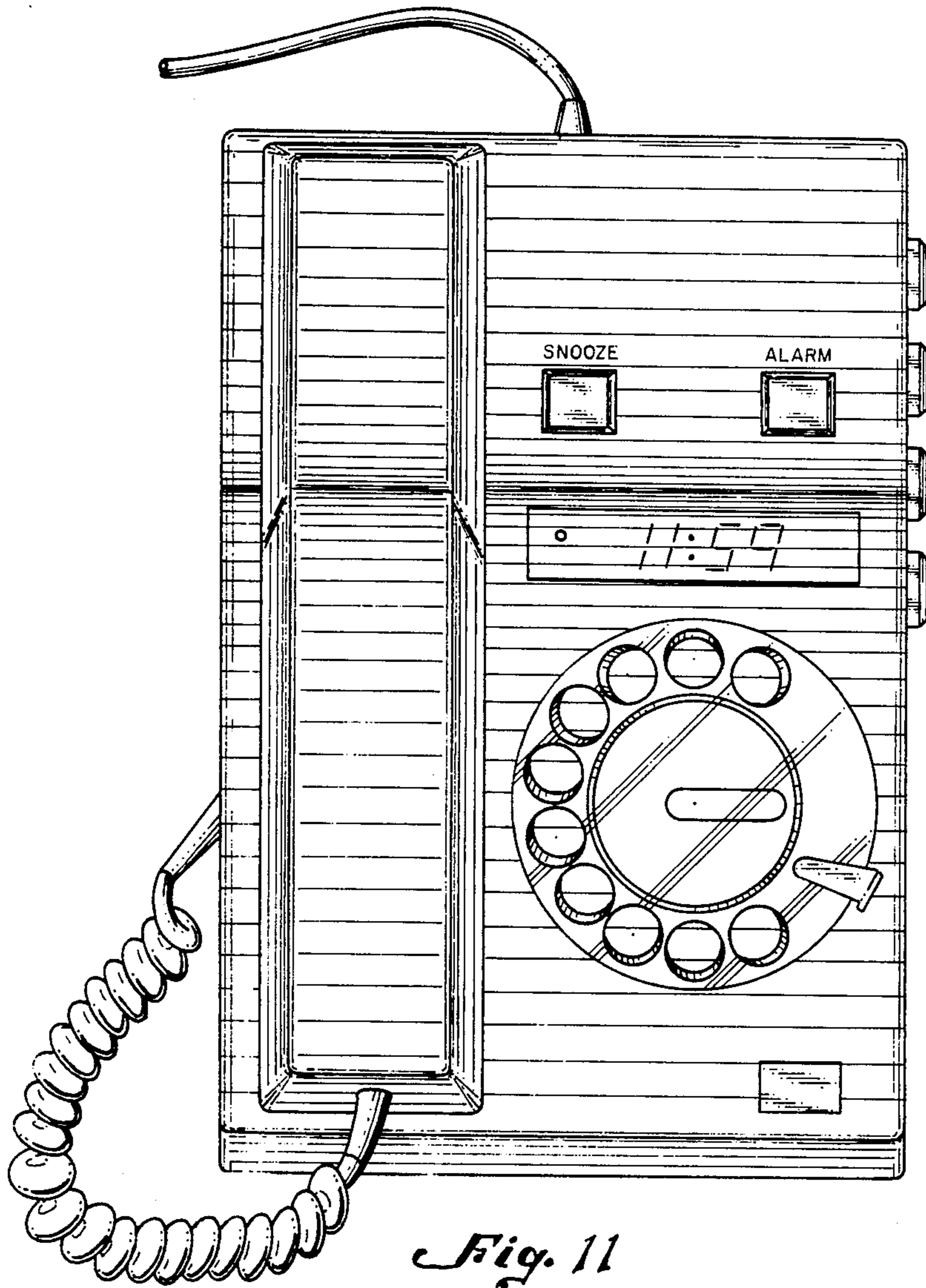

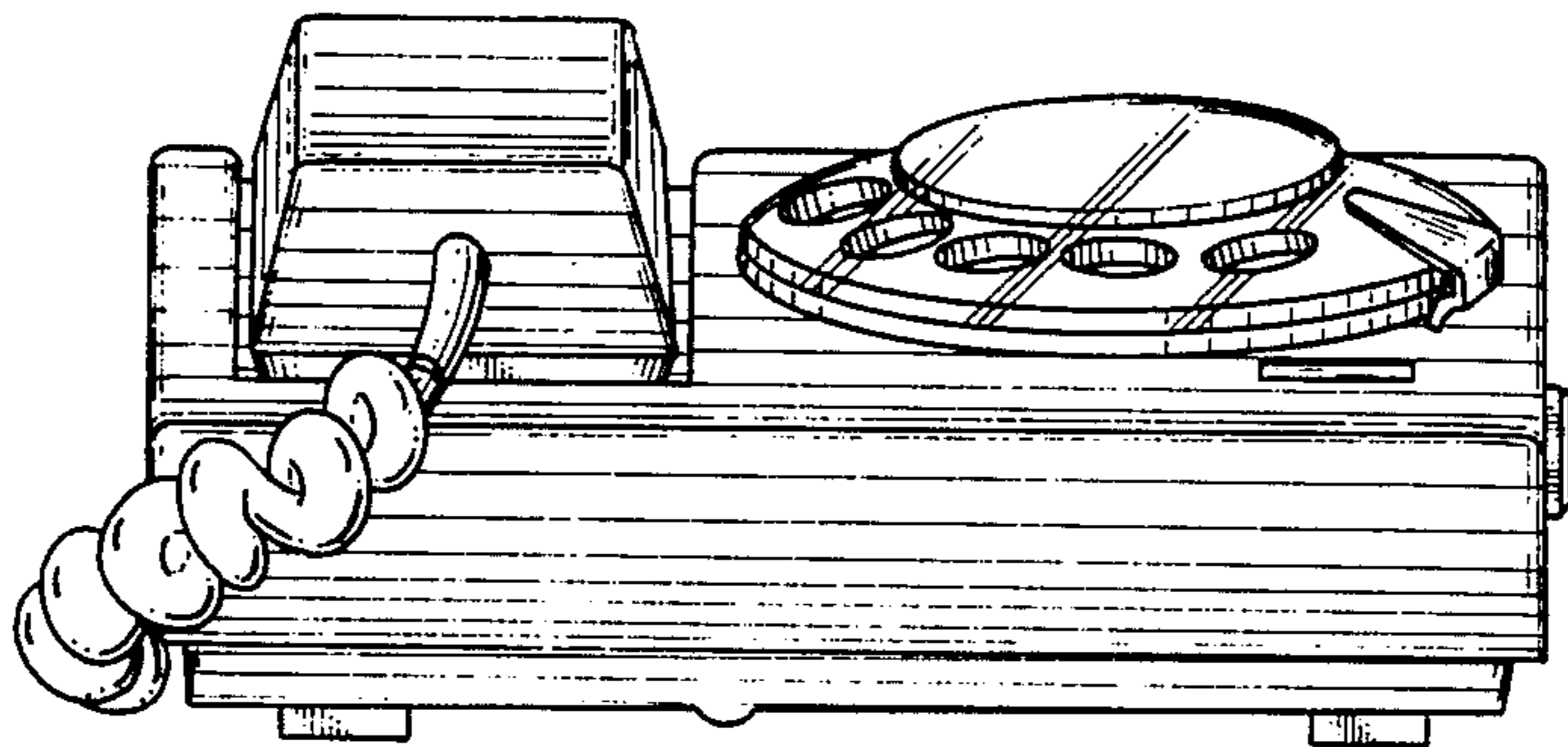

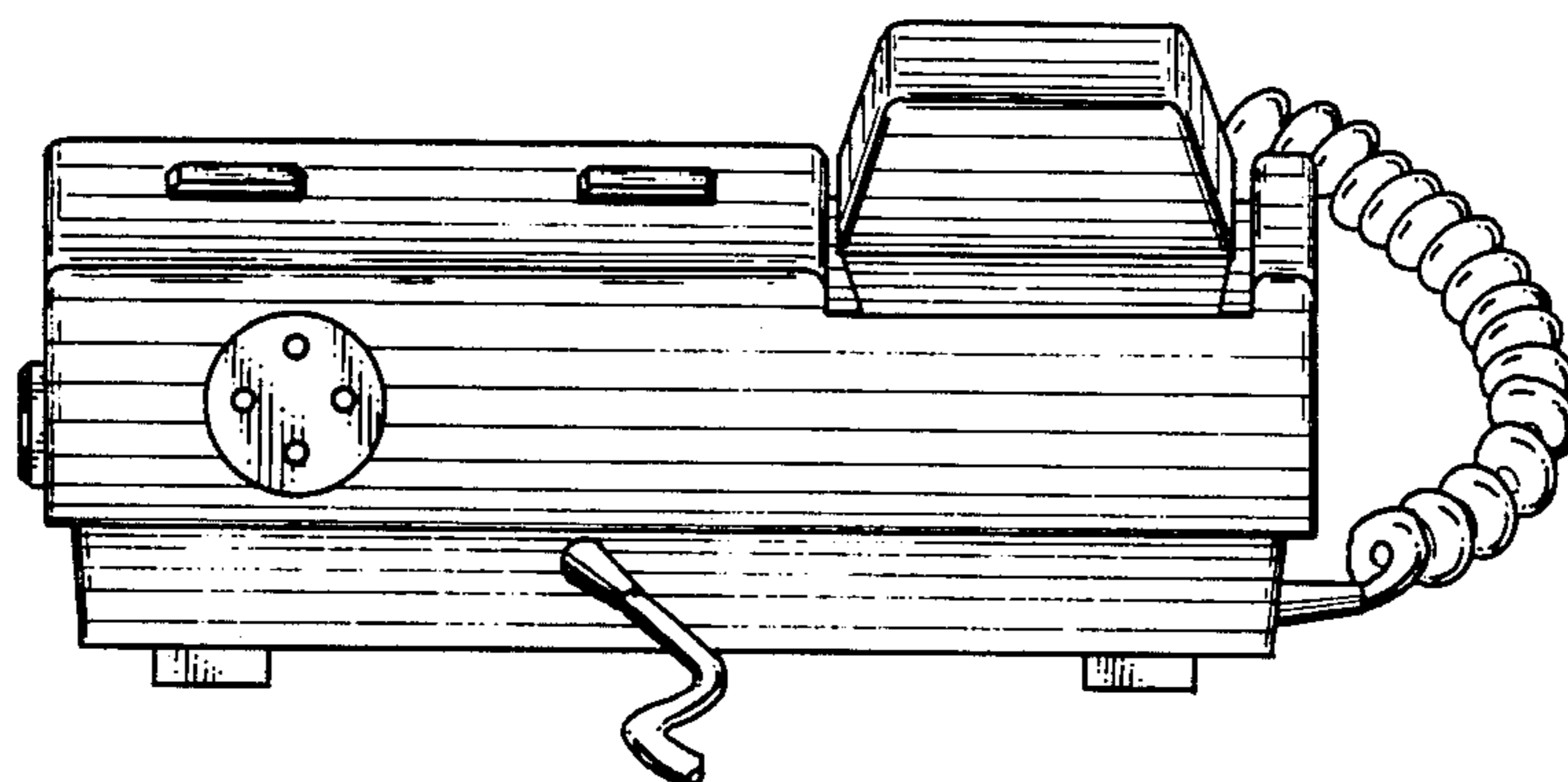

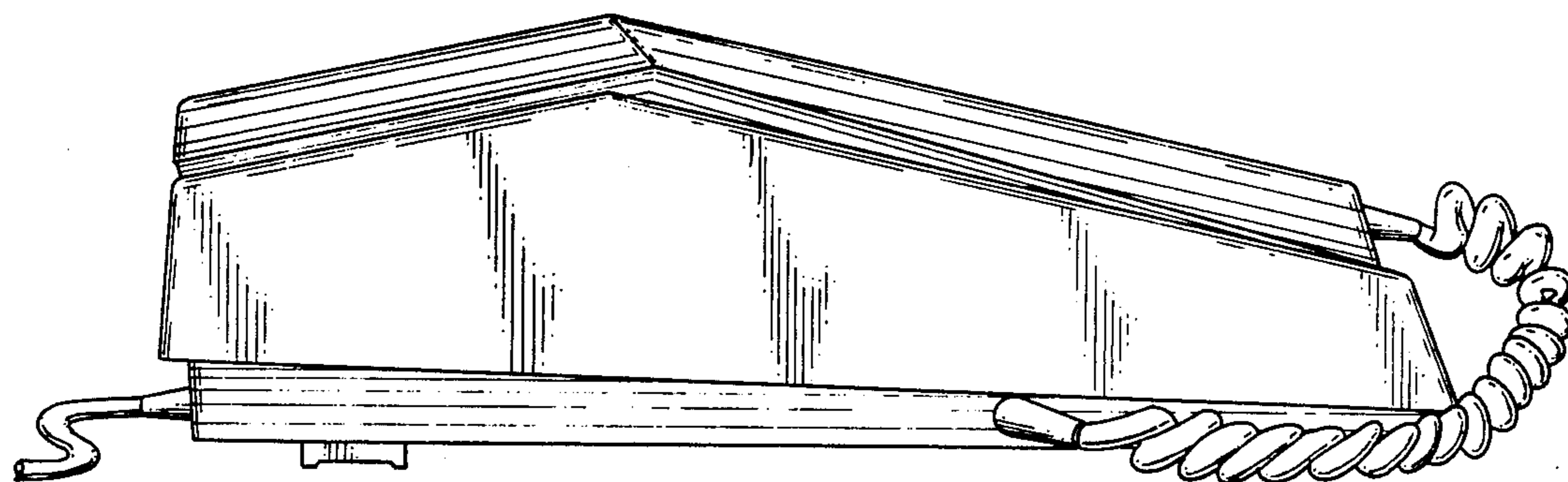

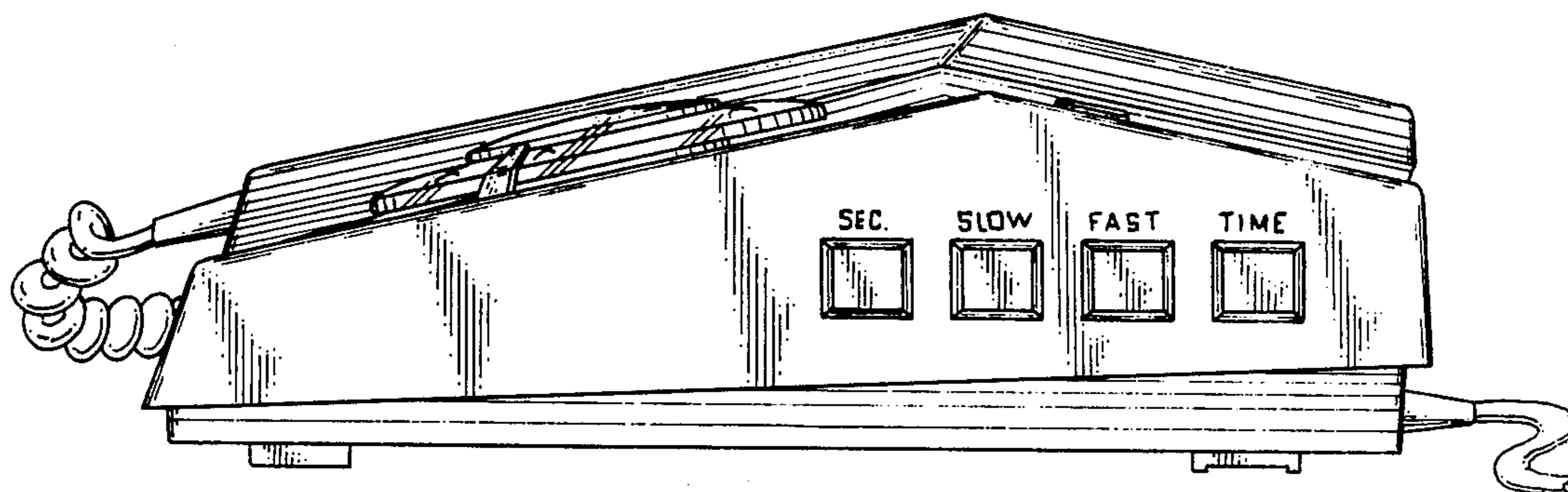
