[57] **CLAIM**

The ornamental design for a panel for partitions or the like, as shown and described.

DESCRIPTION

FIG. 1 is a reduced front elevational view of a panel for partitions or the like showing my new design, the rear being flat and unornamented;

FIG. 2 is a reduced front elevational view of a second embodiment of the design of FIG. 1, the only difference being the reversal of the pattern;

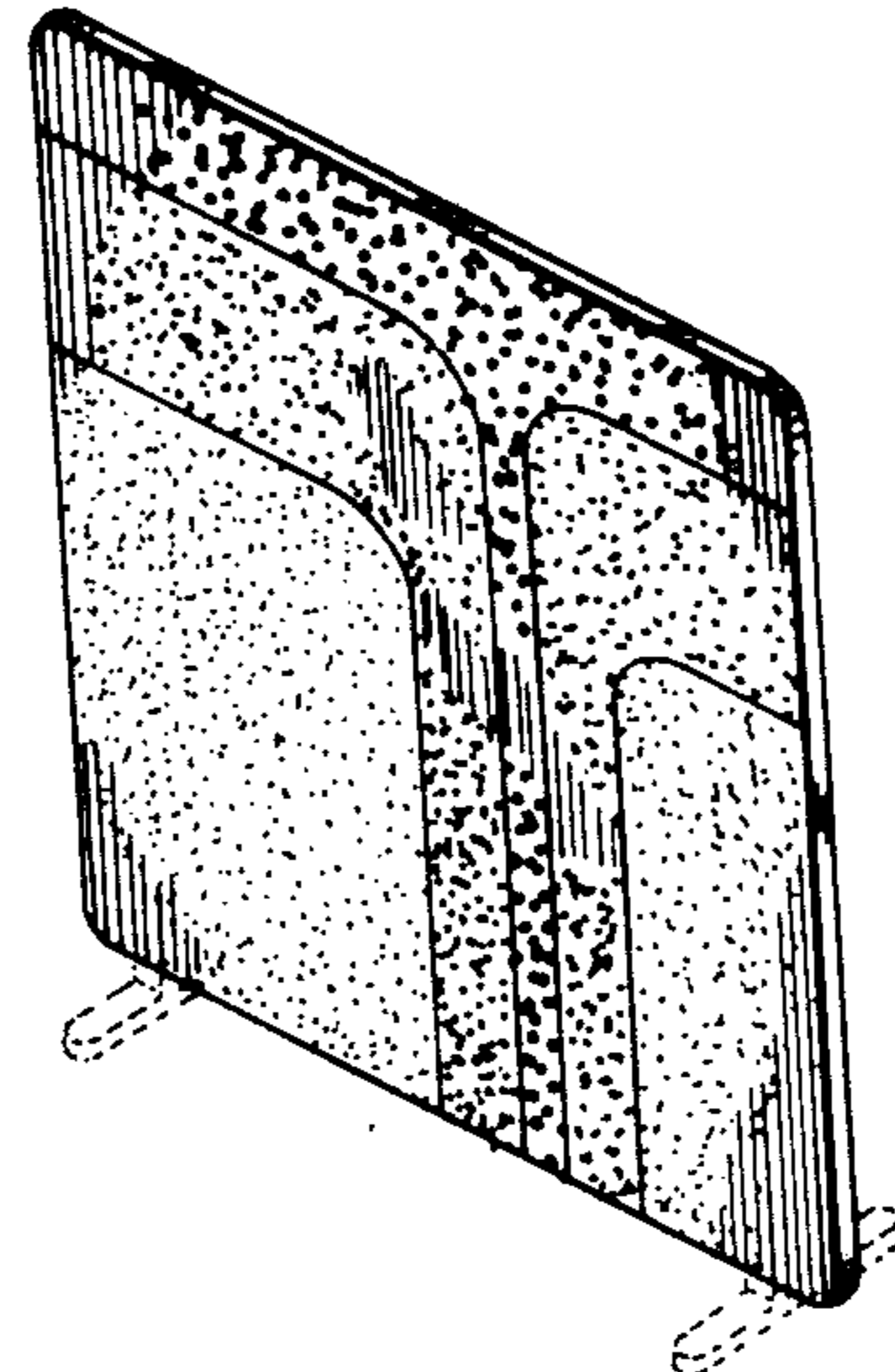
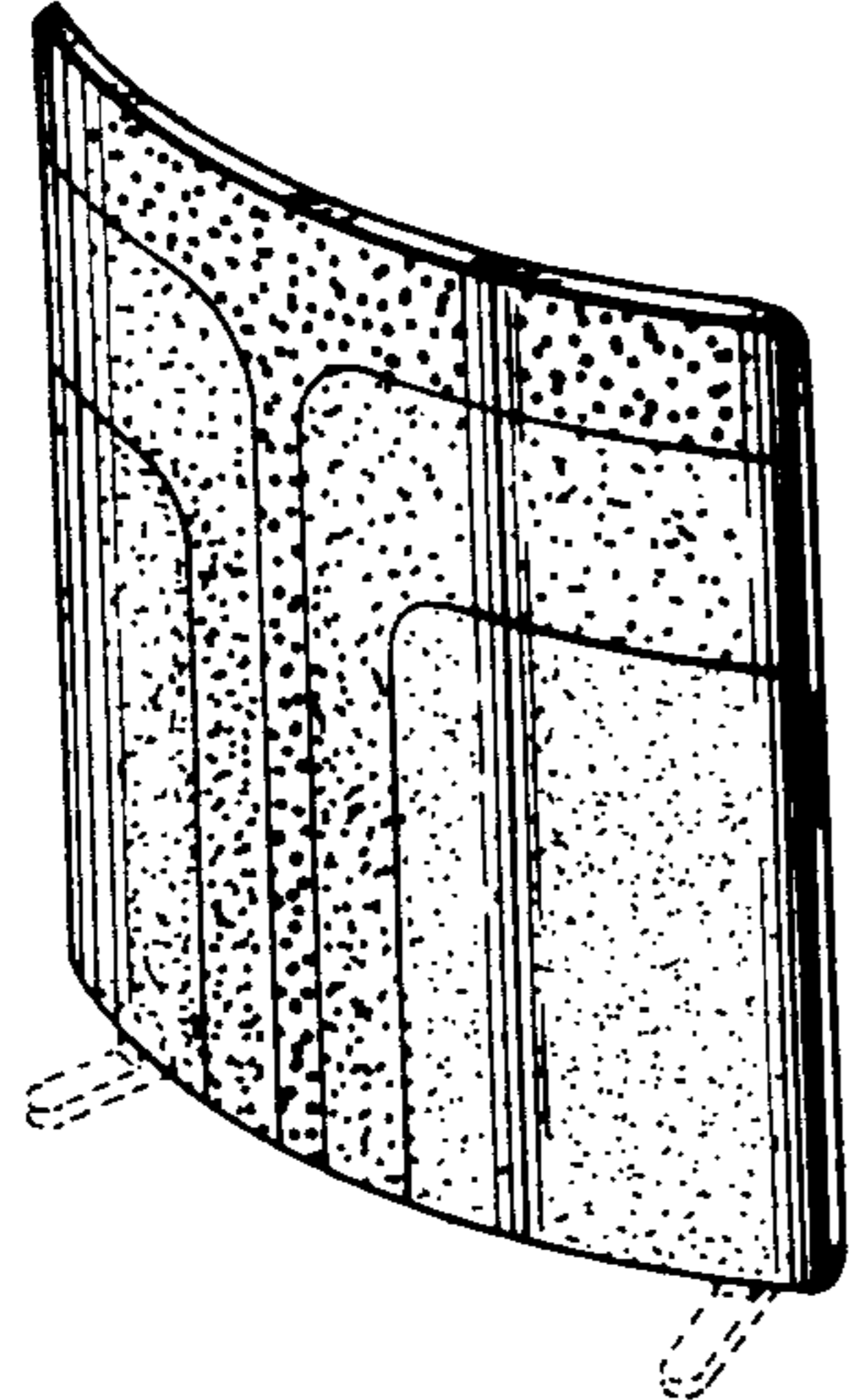
FIG. 3 is a perspective view of the third, fourth, and fifth embodiments of the design of FIG. 1 wherein the design of the rear is plain, as shown in FIG. 1, as shown in FIG. 2, respectively;

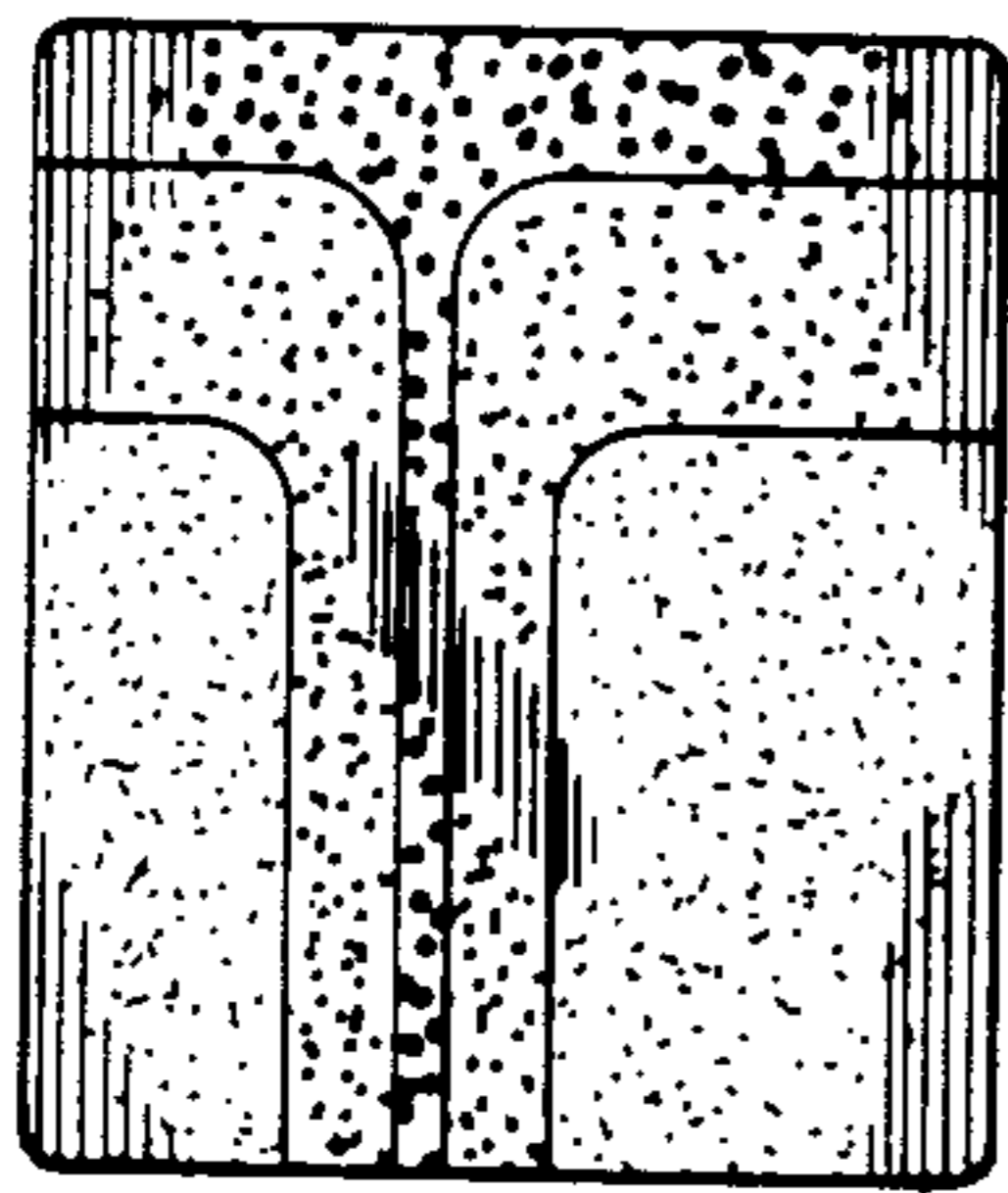
FIG. 4 is a reduced side elevational view taken from the right of FIG. 3;

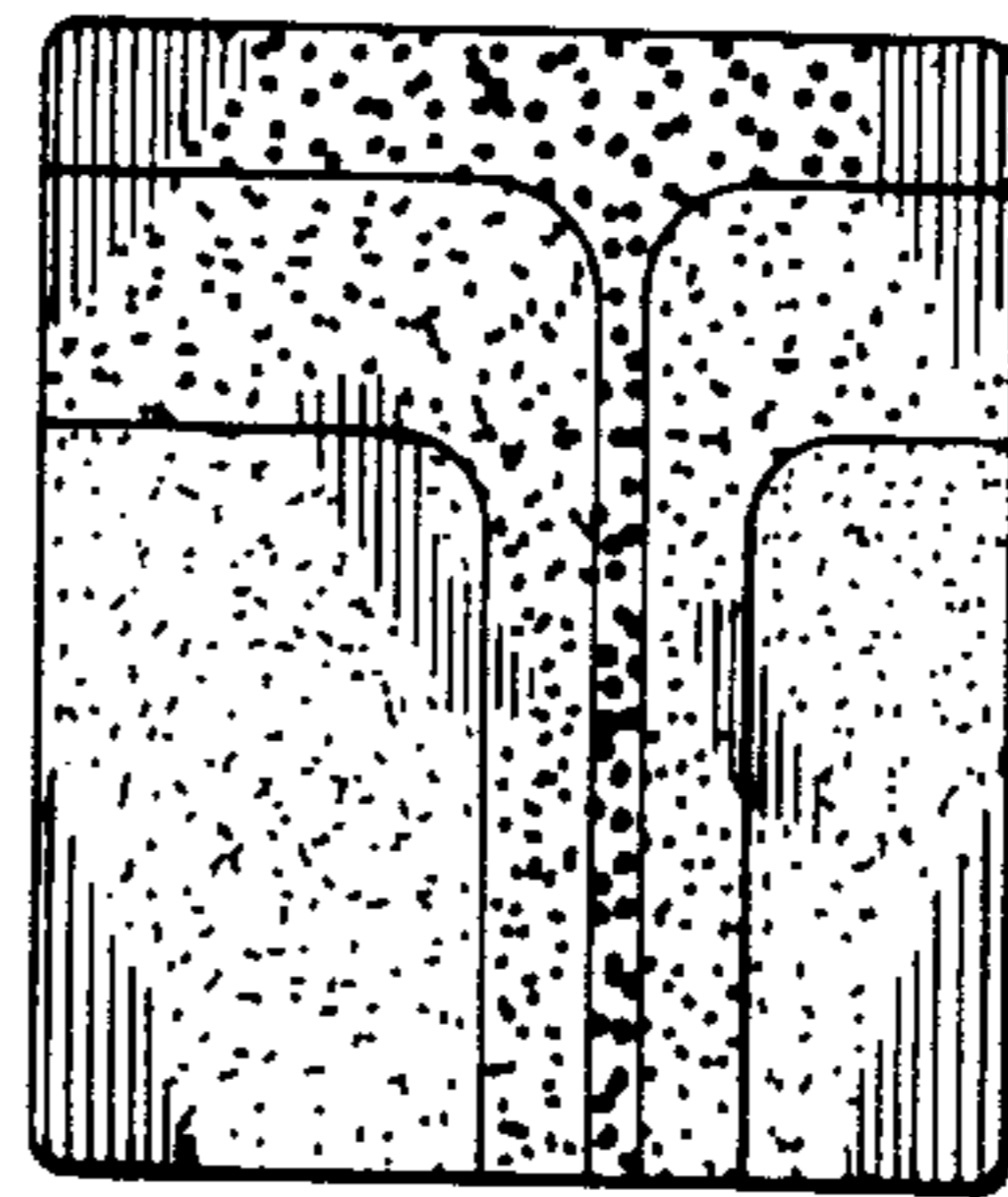

The broken line disclosure of the pedestal feet in FIGS. 3, 4, 5, and 6 is for illustrative purposes only.

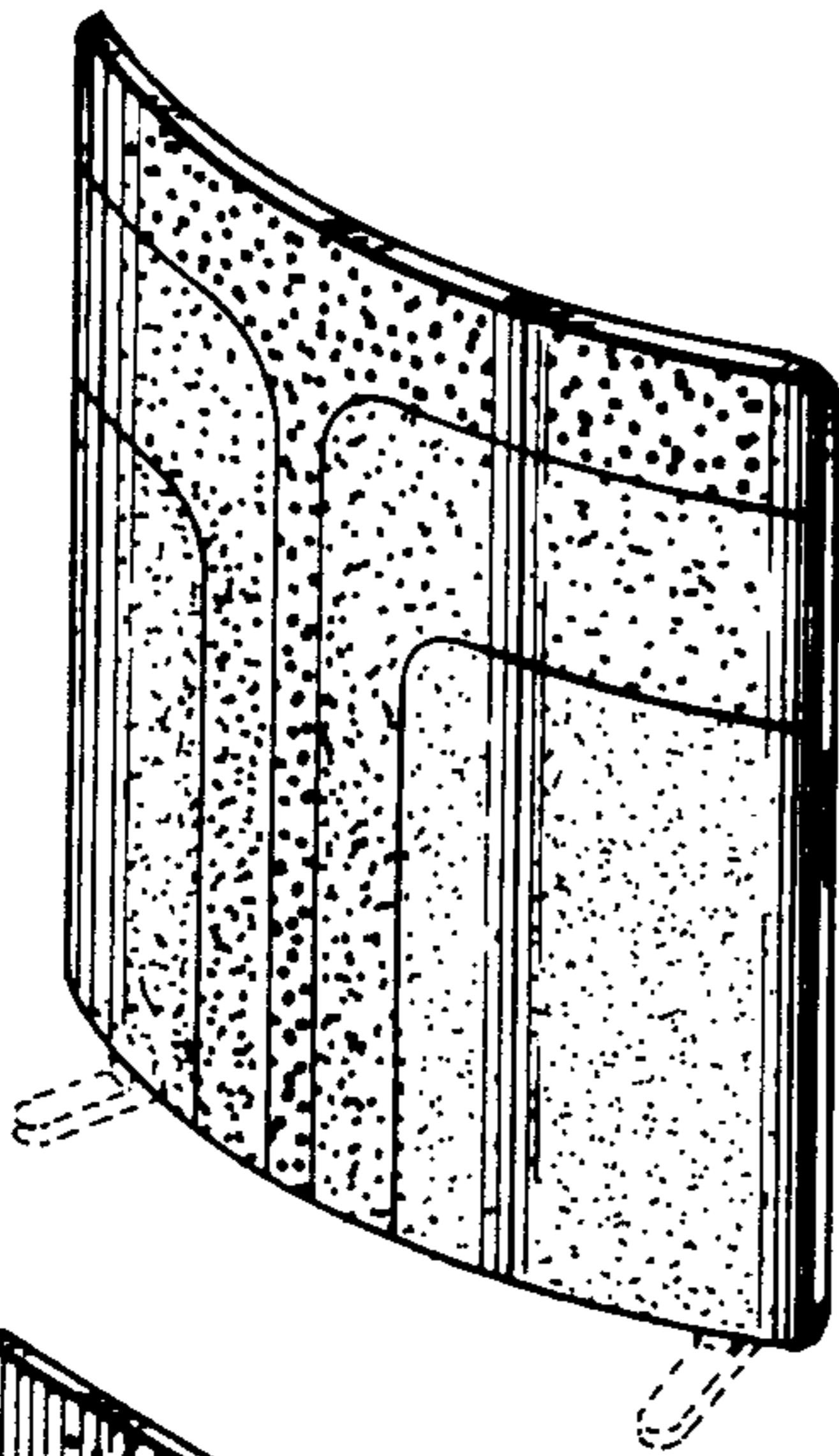




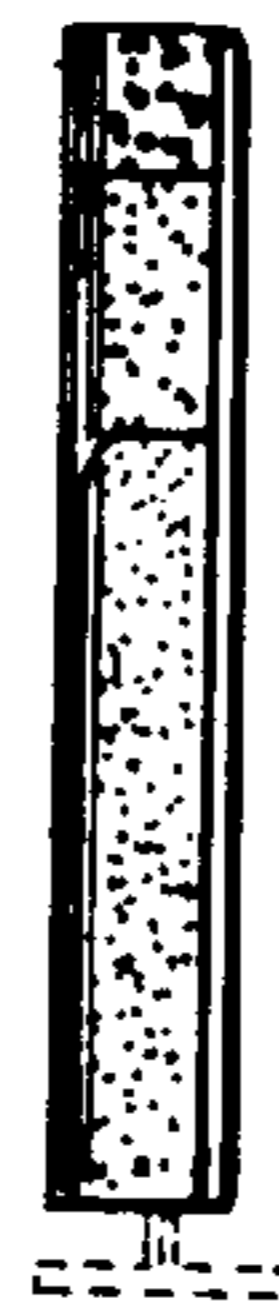

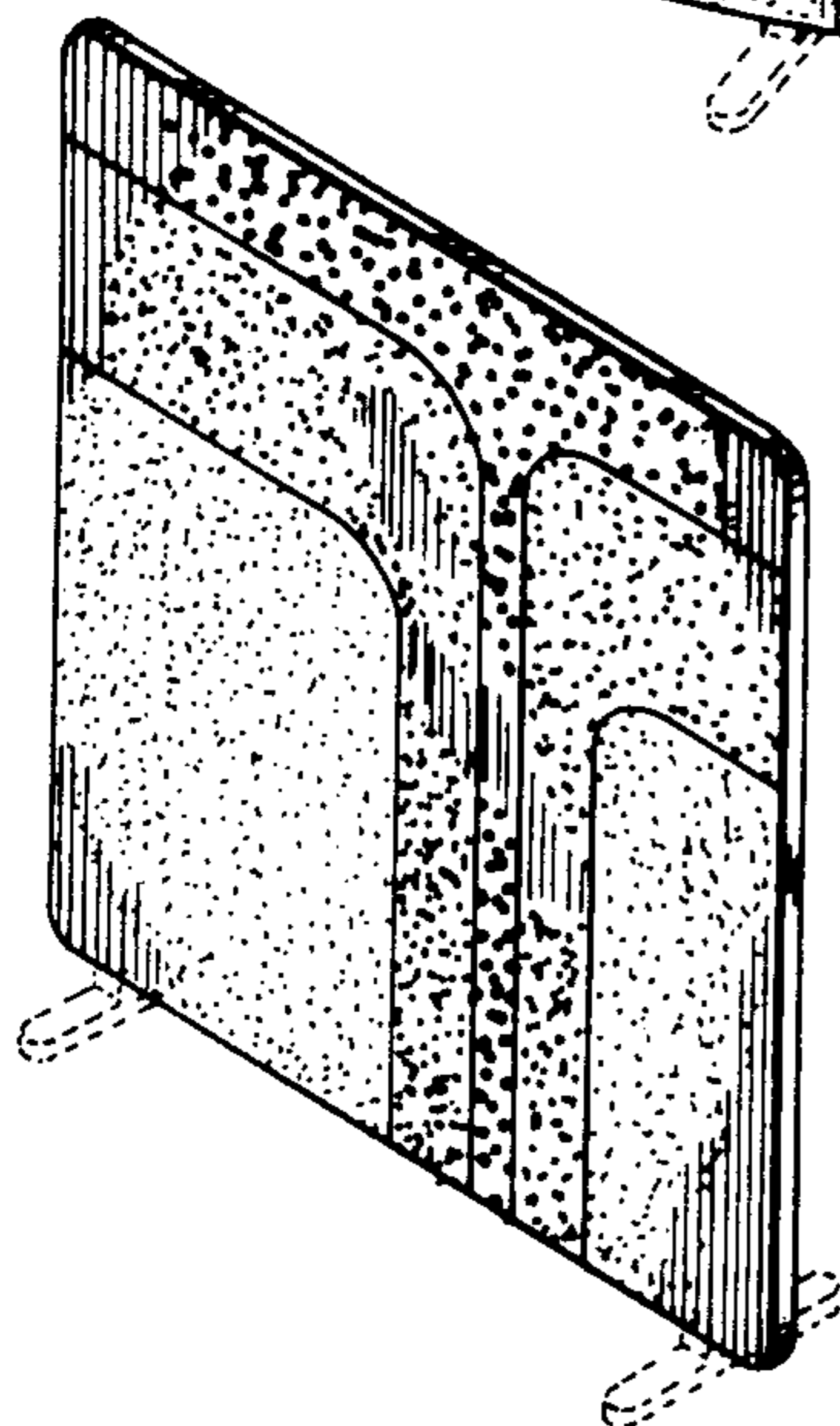

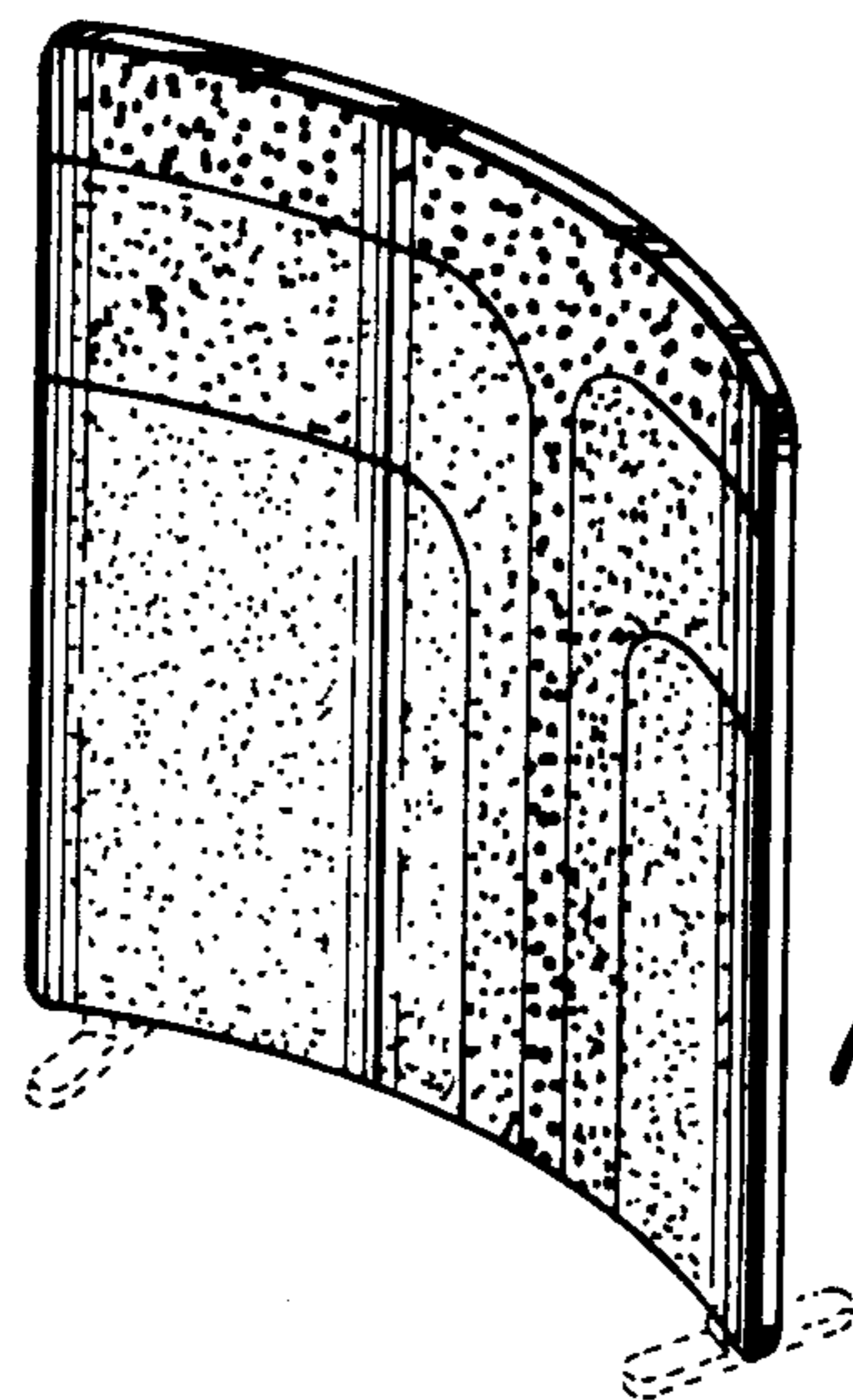

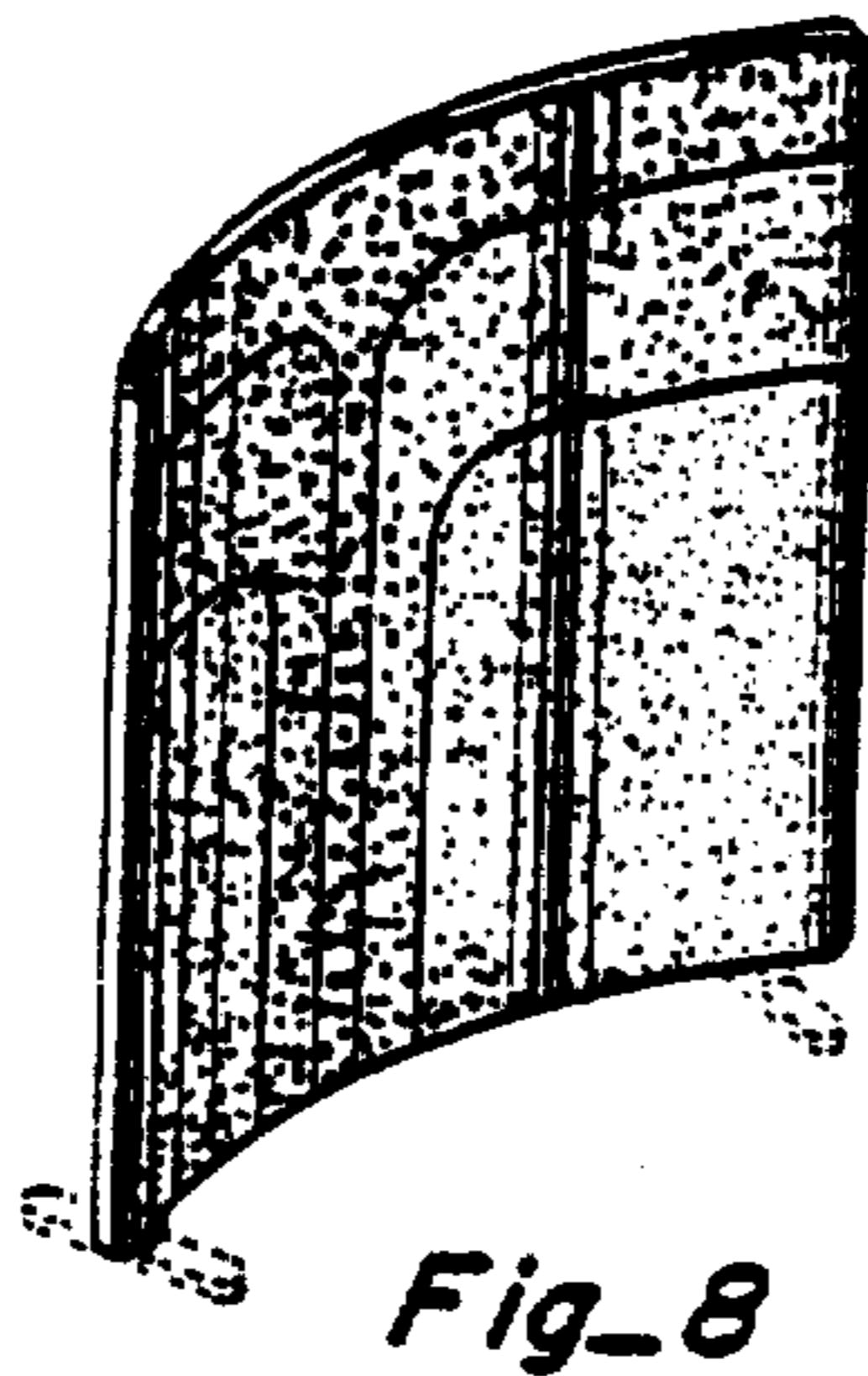
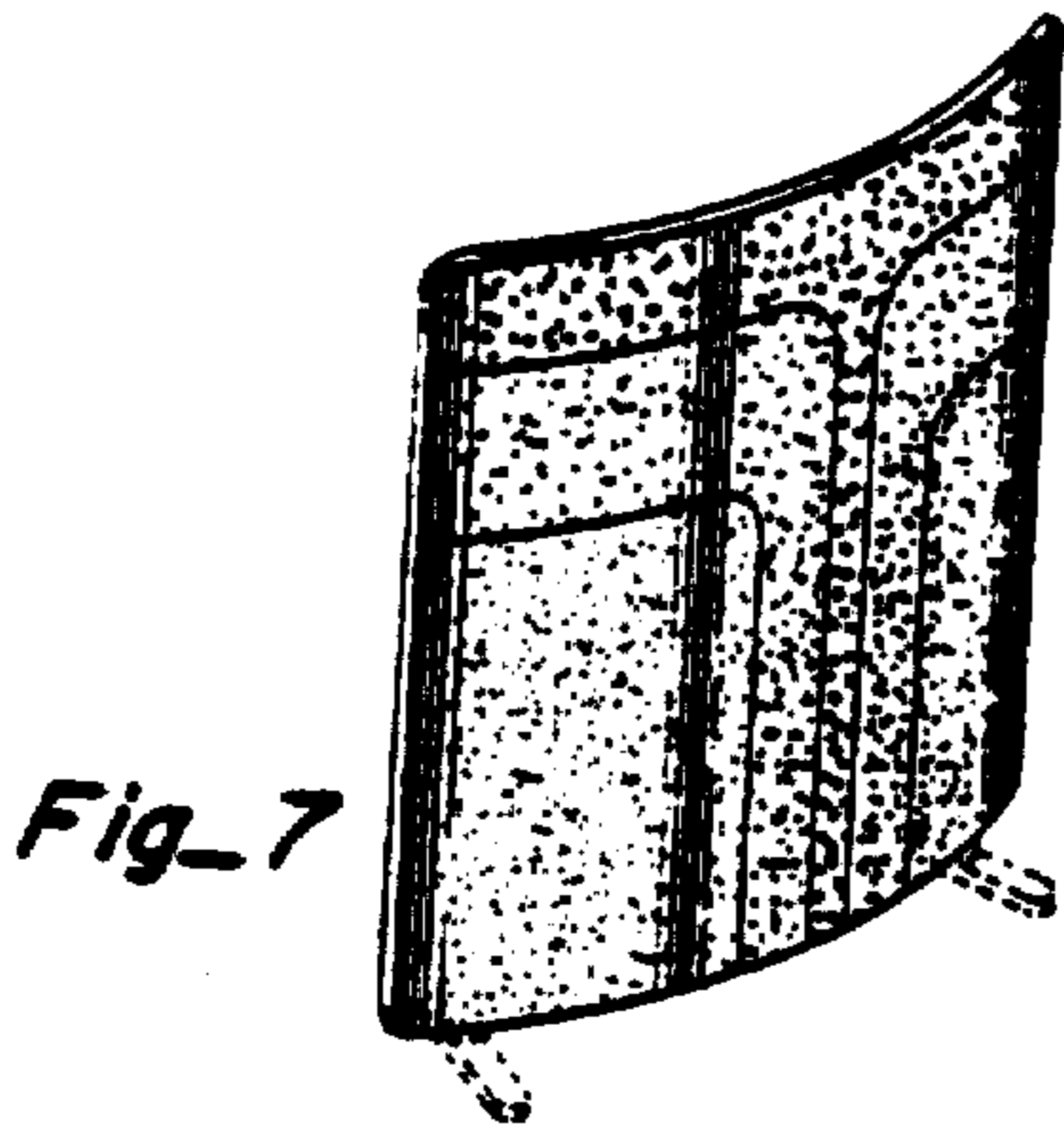
