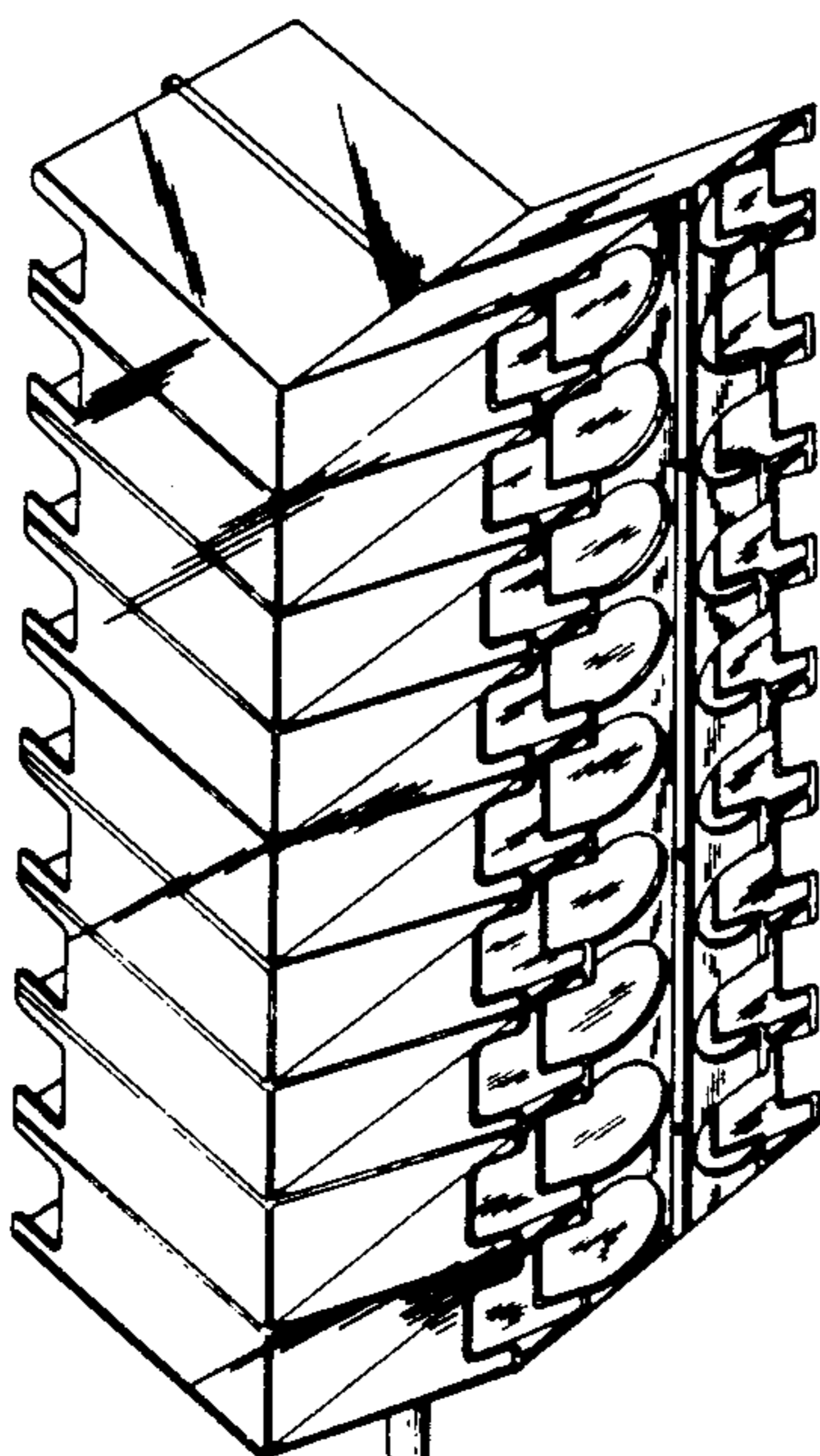

[57] **CLAIM**

The ornamental design for an eyeglass display rack, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an eyeglass display rack showing my new design, the rear being identical; FIG. 2 is an end elevational view thereof; FIG. 3 is a top plan view thereof; and FIG. 4 is a bottom plan thereof.



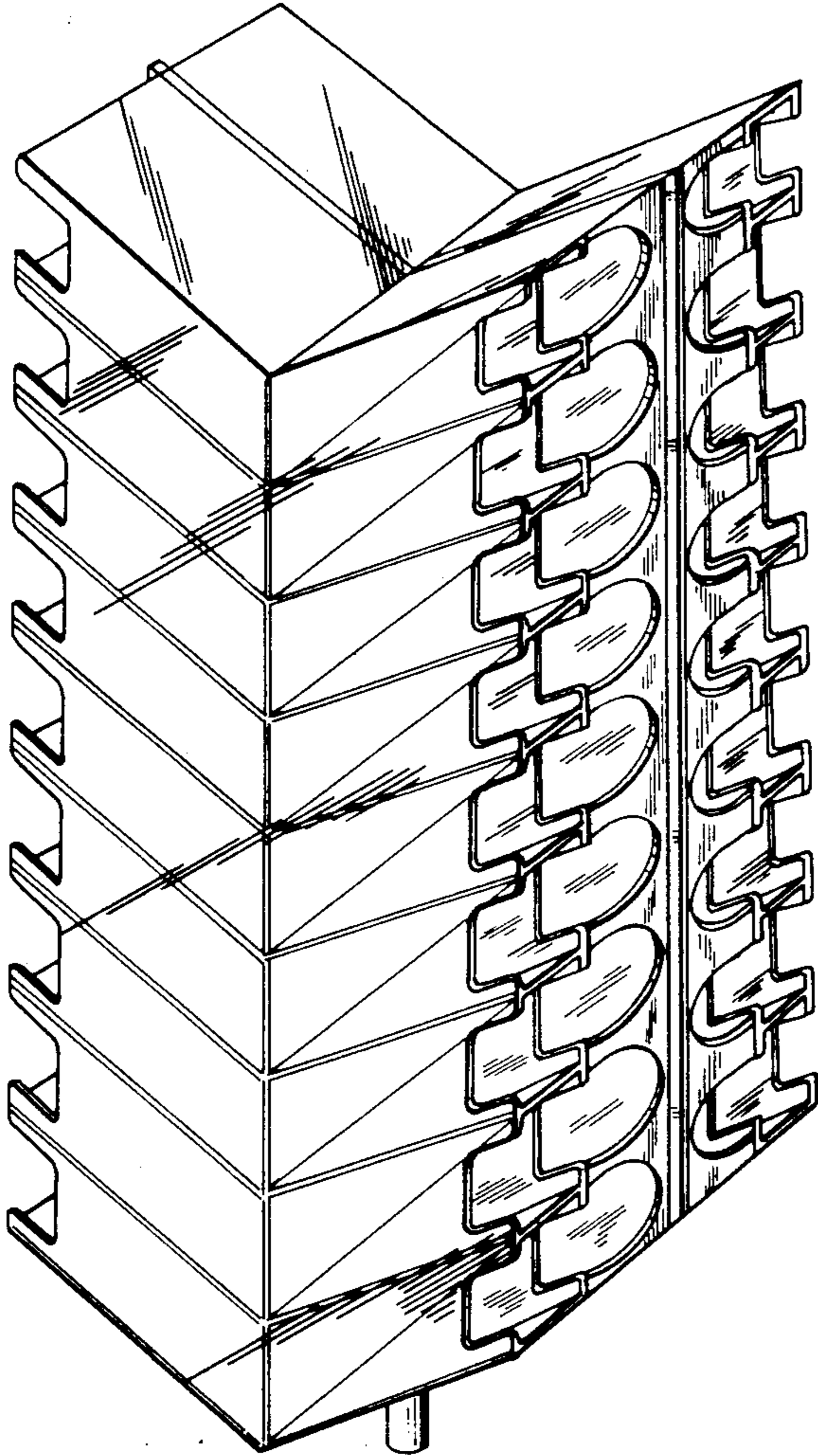

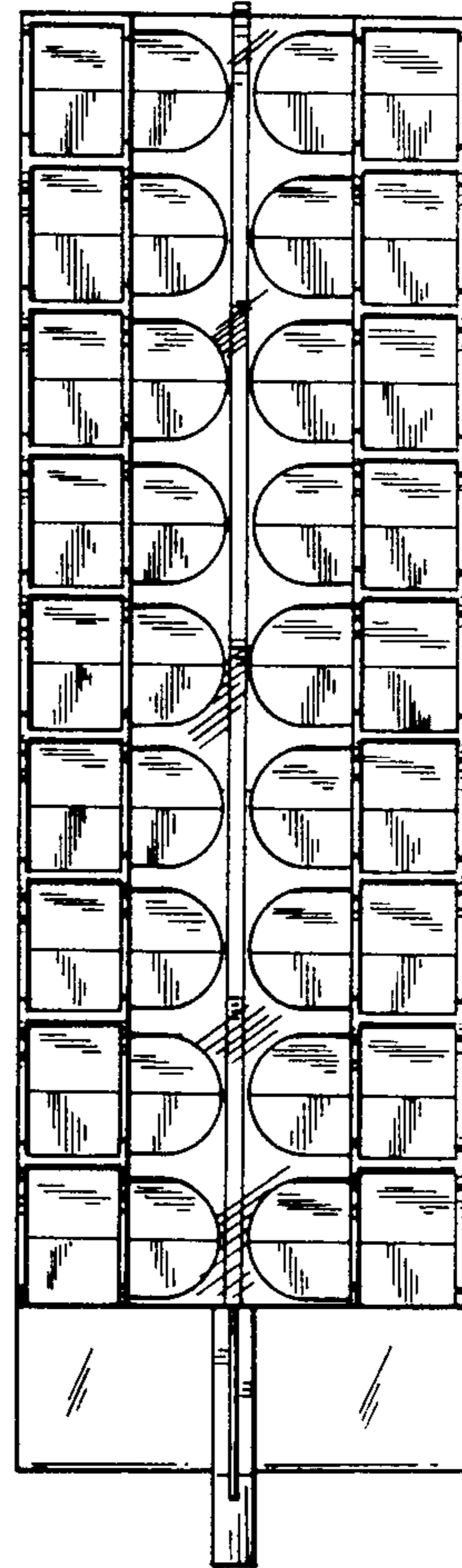

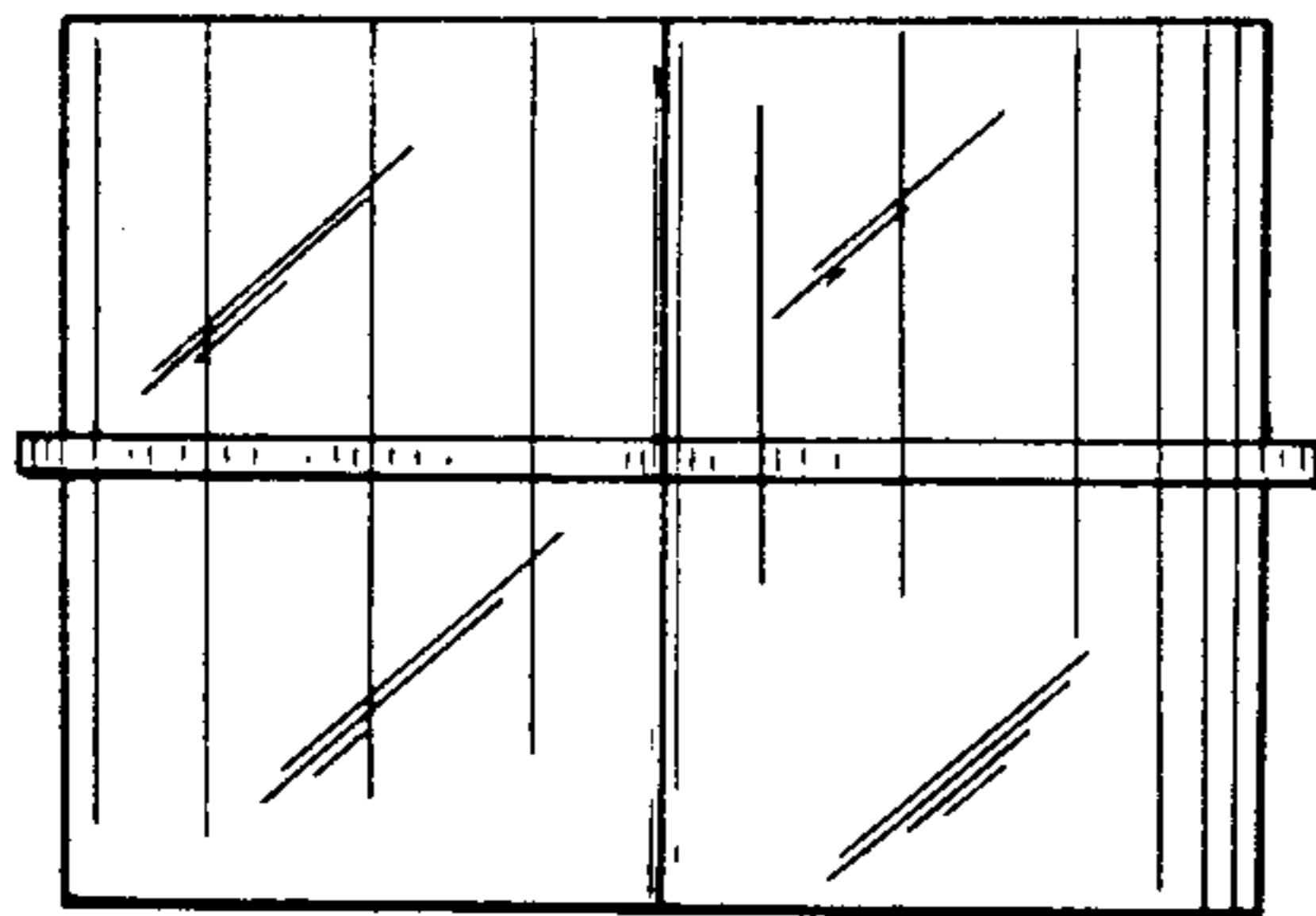

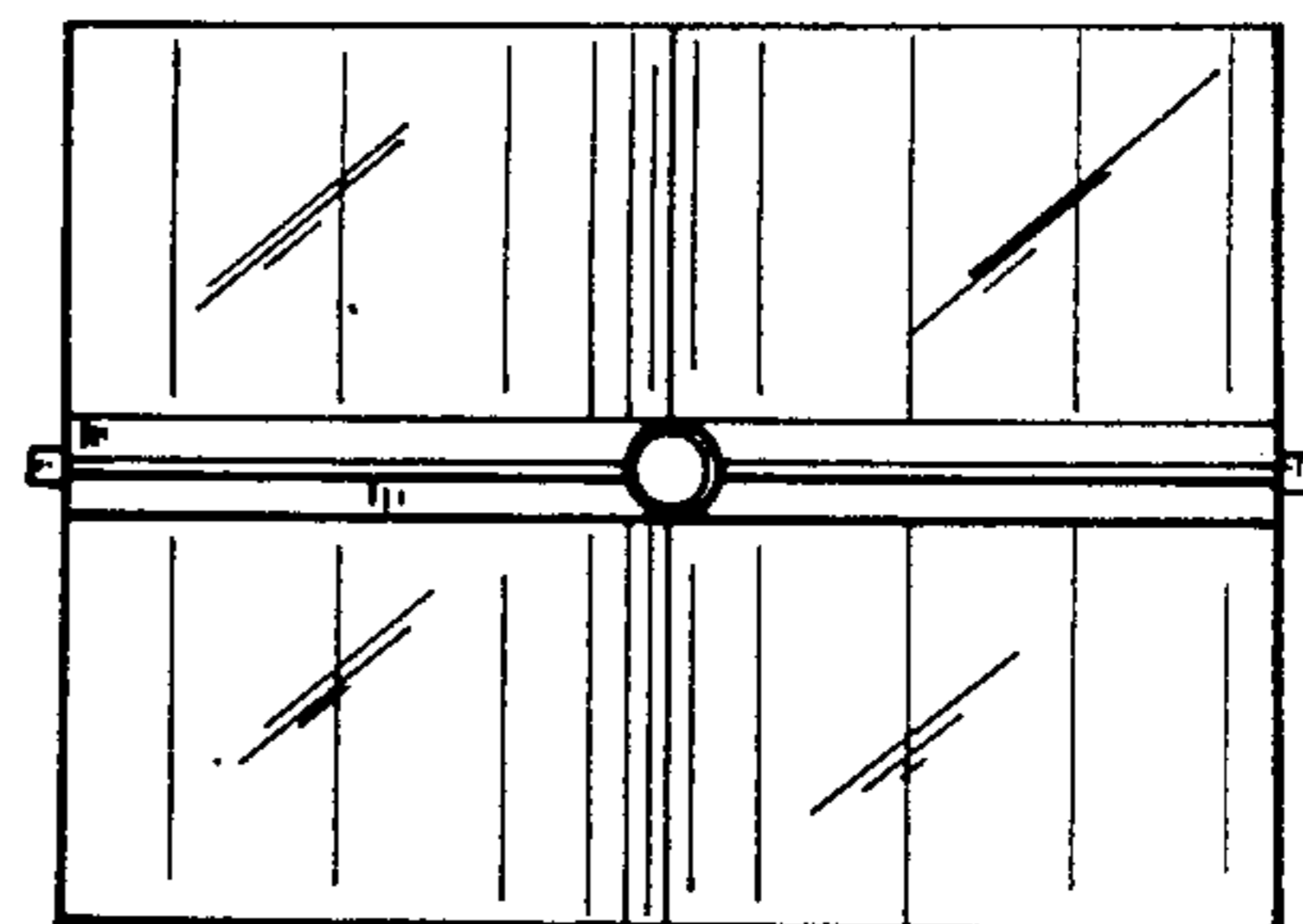
