[57] CLAIM

The ornamental design for a manicure kit, as shown and described.

DESCRIPTION

FIG. 1 is a right front perspective view of a manicure kit showing my new design in closed condition; FIG. 2 is a top plan view of FIG. 1 in the closed condition; FIG. 3 is a bottom plan view of FIG. 1 in the closed condition; FIG. 4 is a left side elevational view of FIG. 1 in the closed condition; FIG. 5 is a front elevational view of FIG. 1 in the closed condition; FIG. 6 is a rear elevational view of FIG. 1 in the closed condition; FIG. 7 is a right front perspective view of the manicure kit of FIG. 1 in an open position; FIG. 8 is a left front perspective view of the manicure kit in an exploded condition with parts thereof removed; FIG. 9 is a left rear perspective view of the bottom of the intermediate pivotal flap; FIG. 10 is a left rear perspective view of the bottom of the lower tray; FIG. 11 is a right front perspective view of a manicure kit showing a modified form of my new design. Six photographs of my manicure kit according to corresponding Figs. of the drawing are made part of this application.

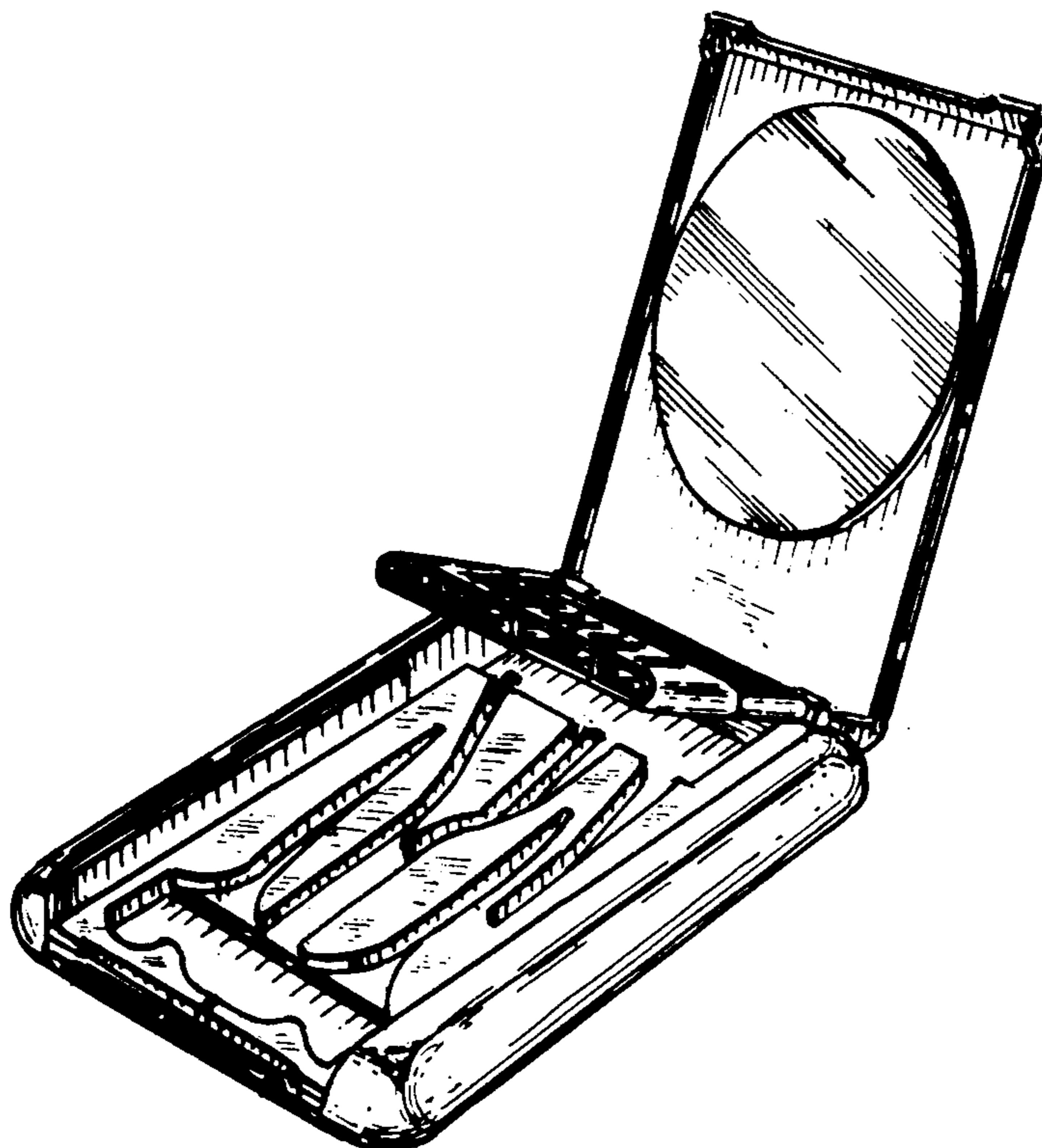

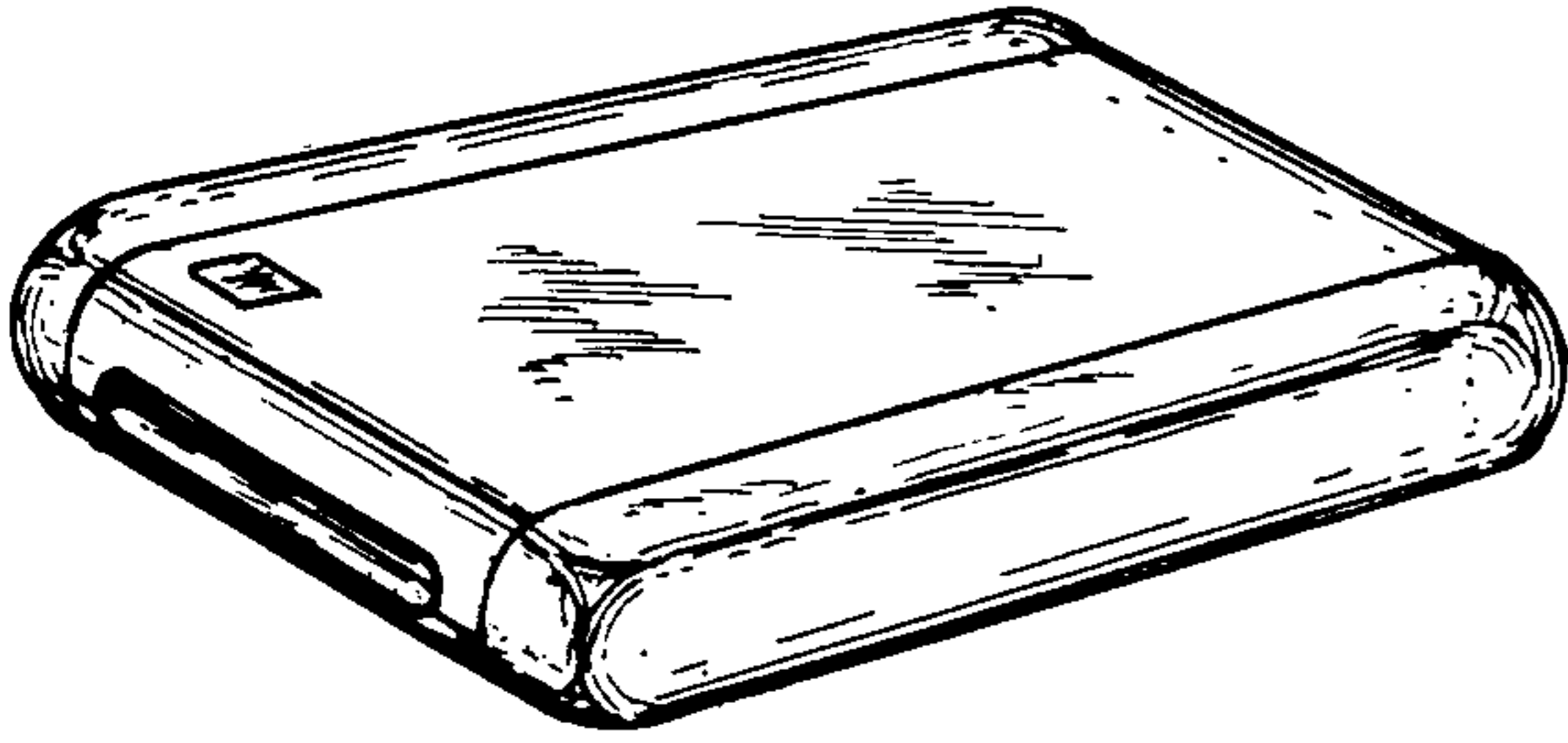

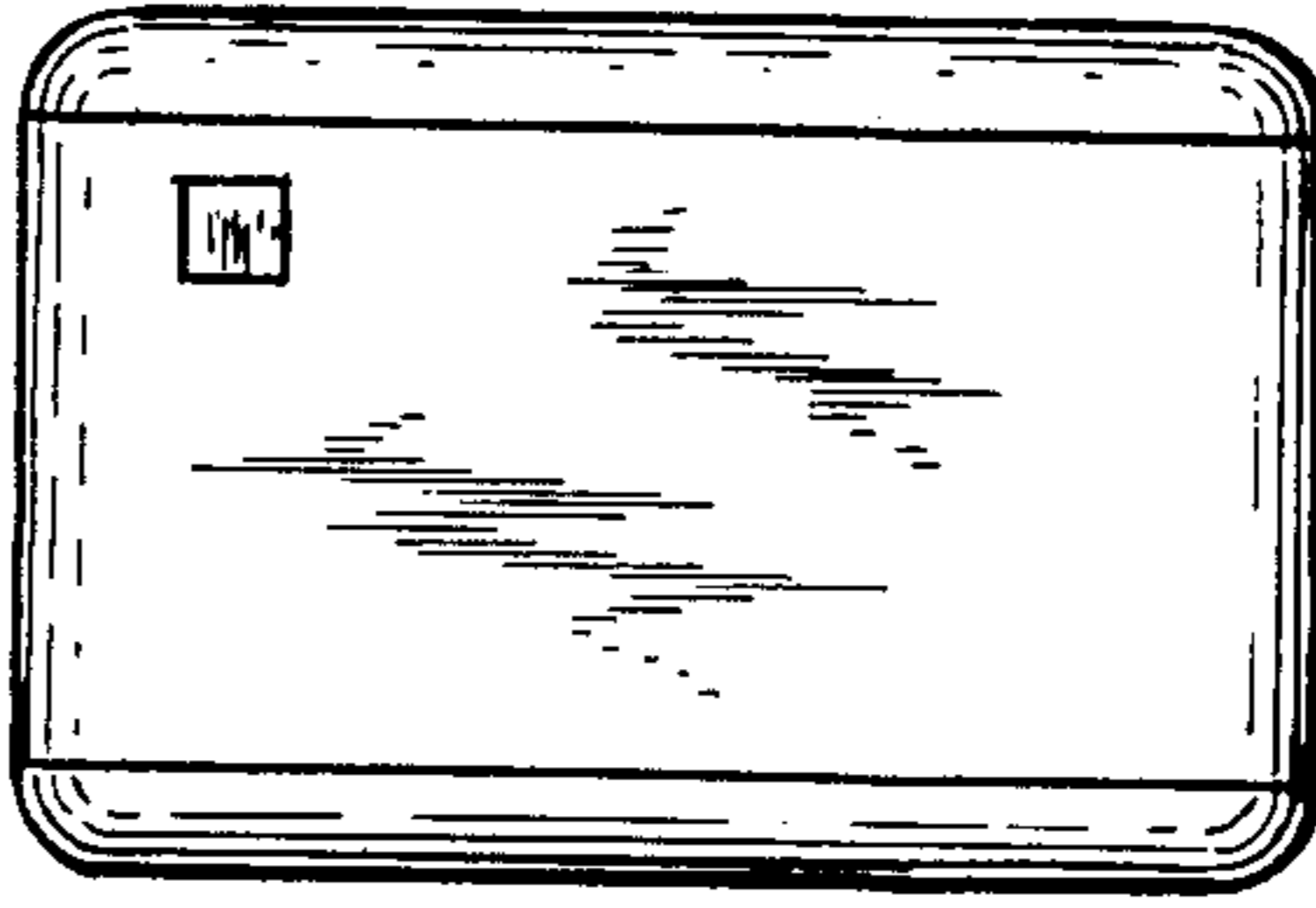

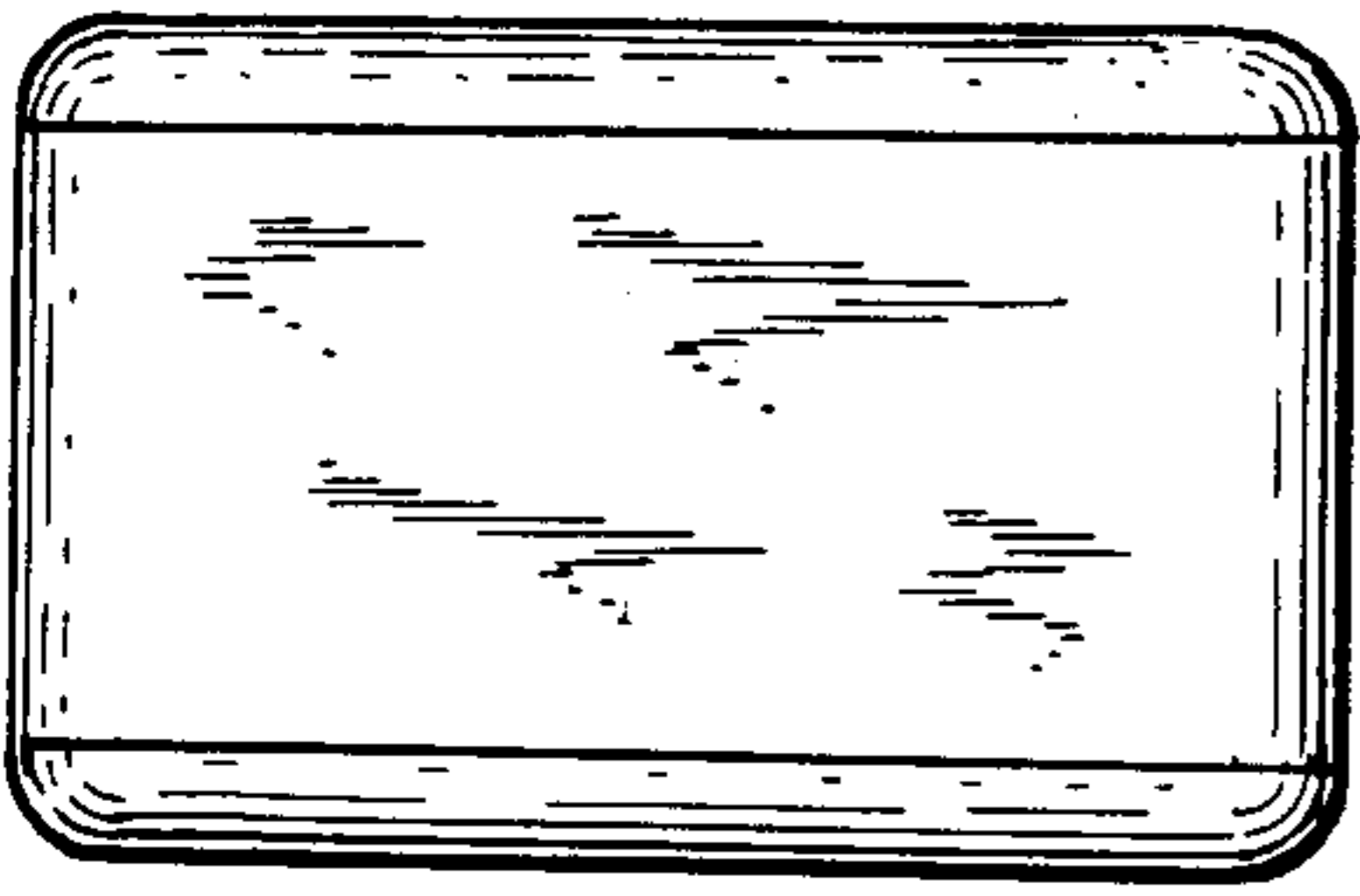

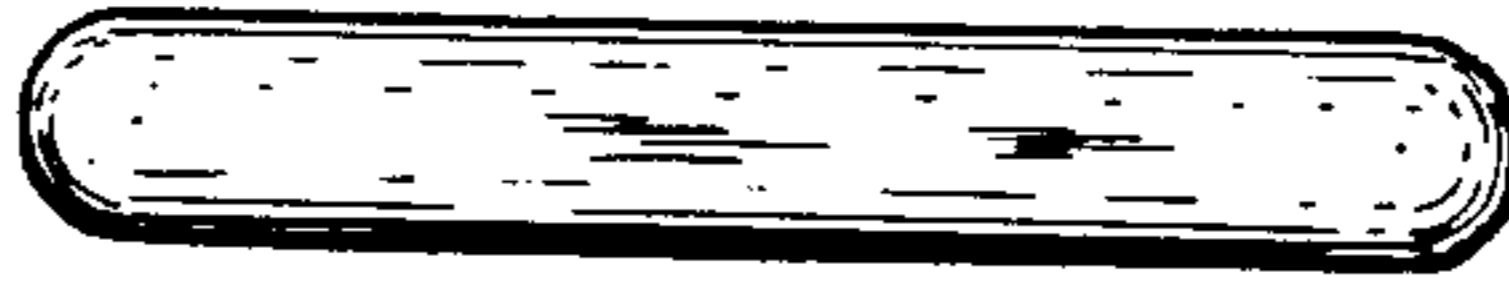

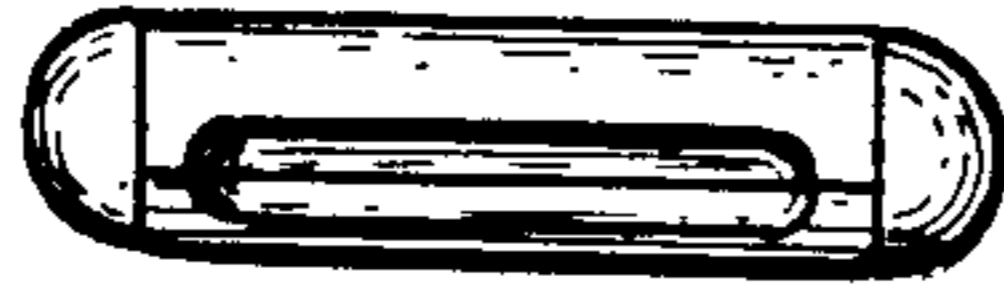

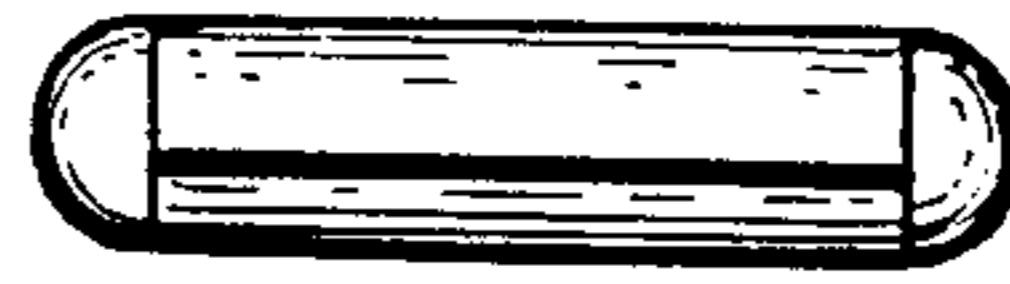

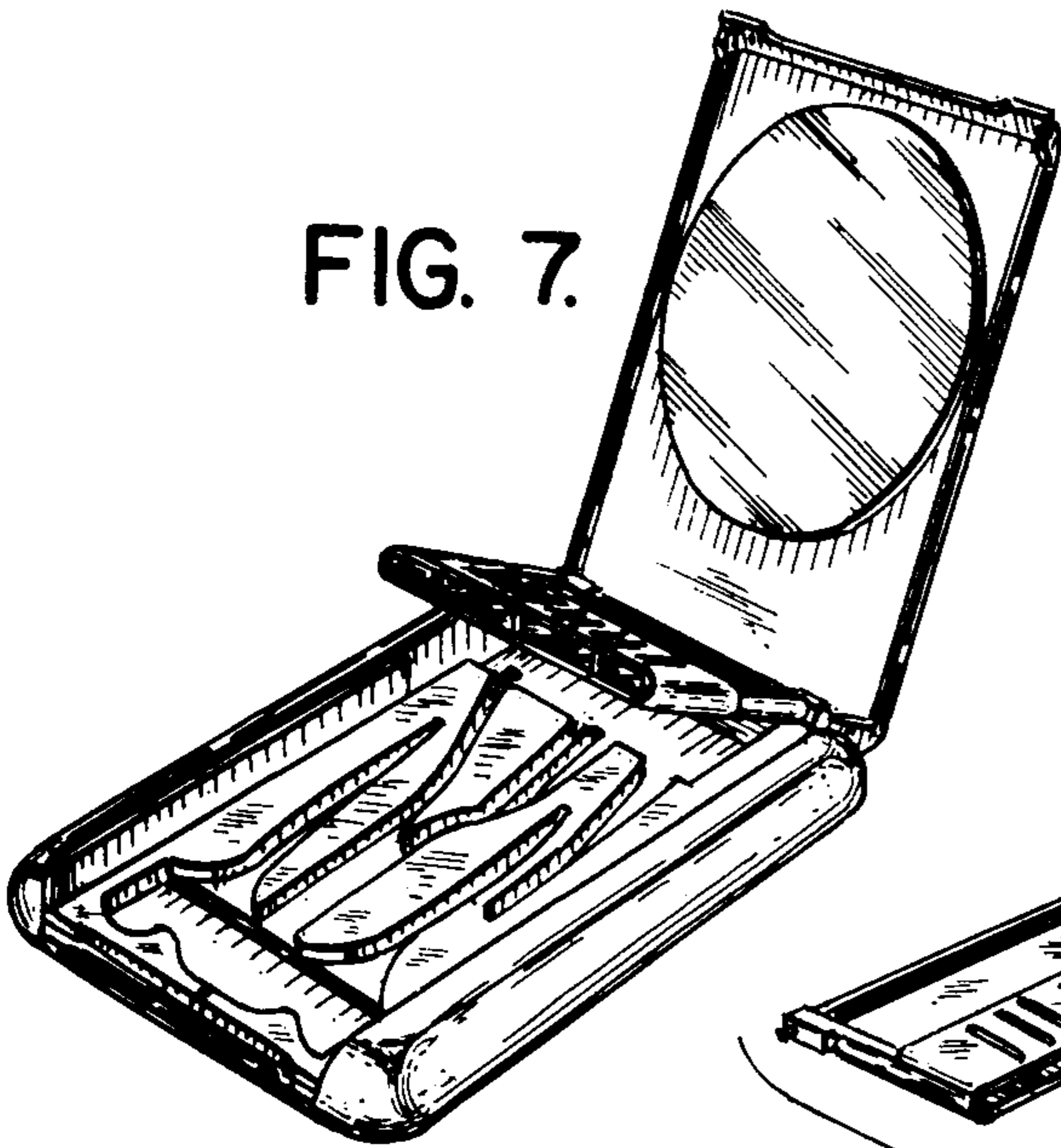

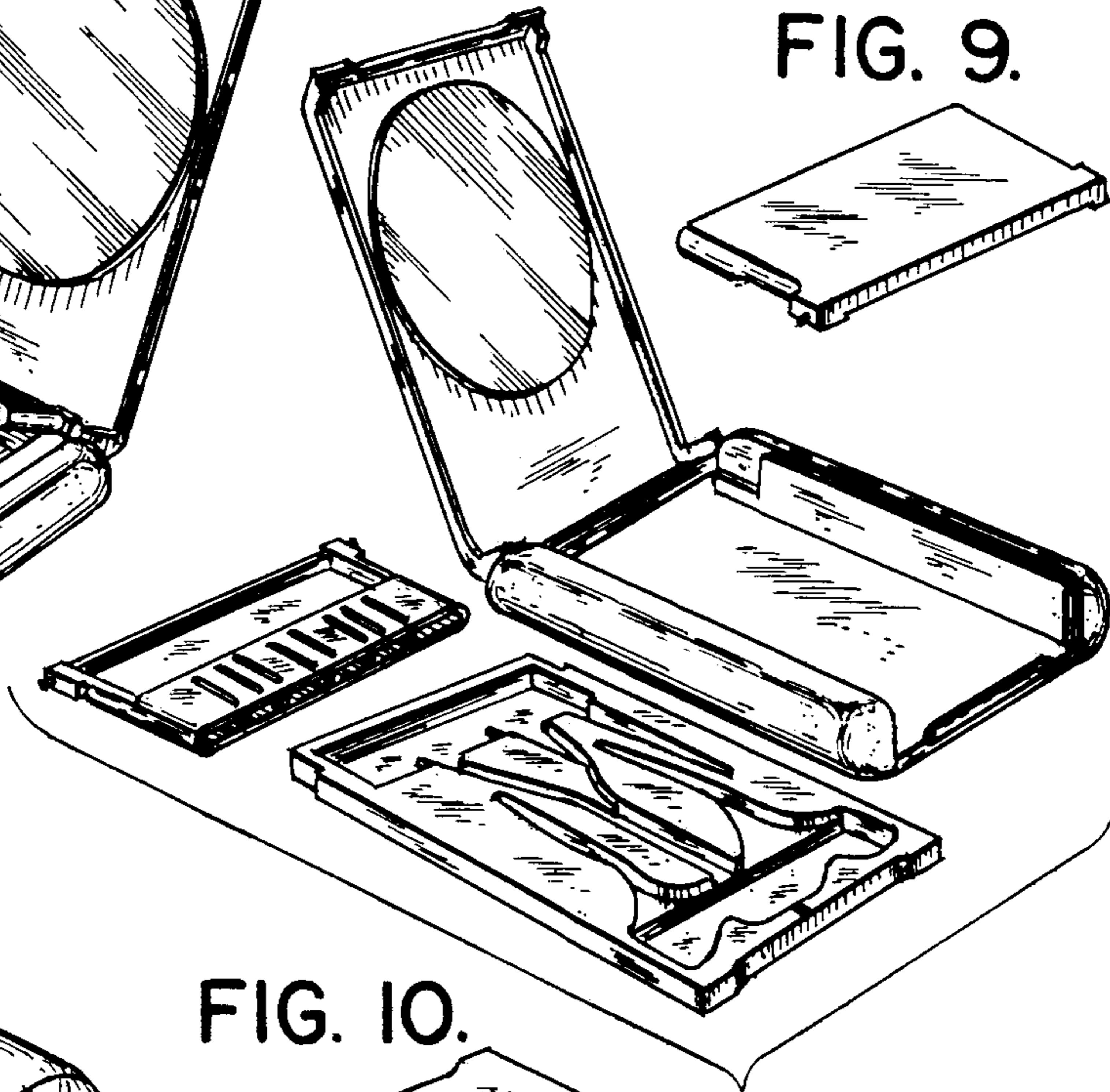

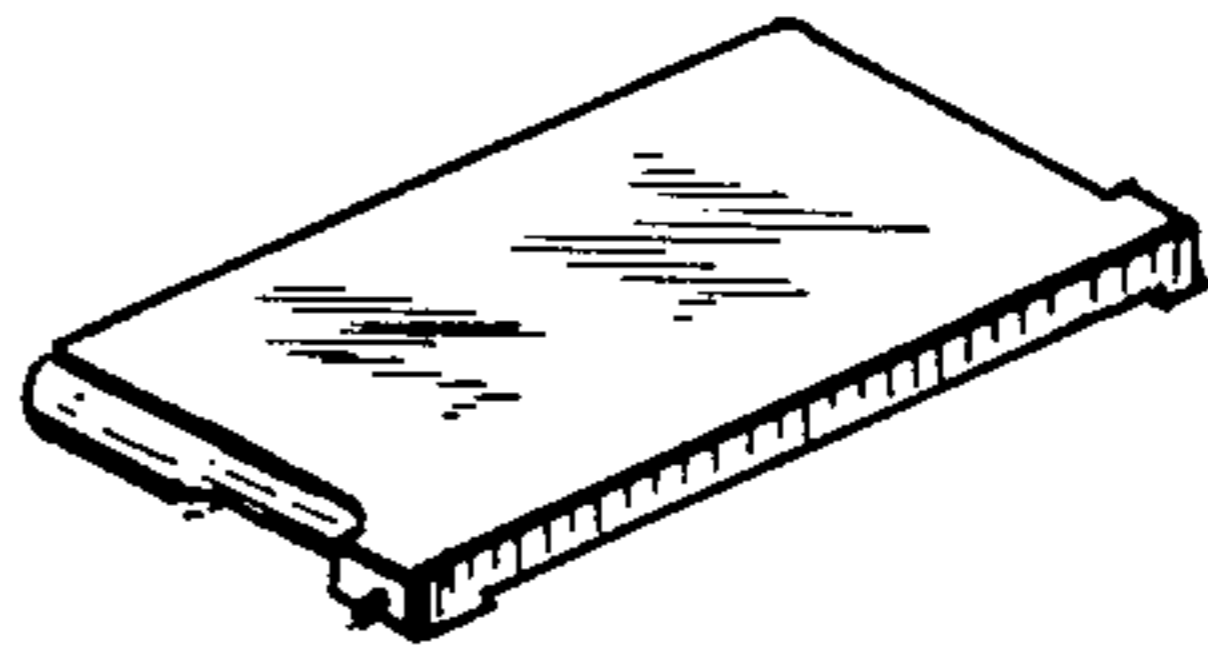

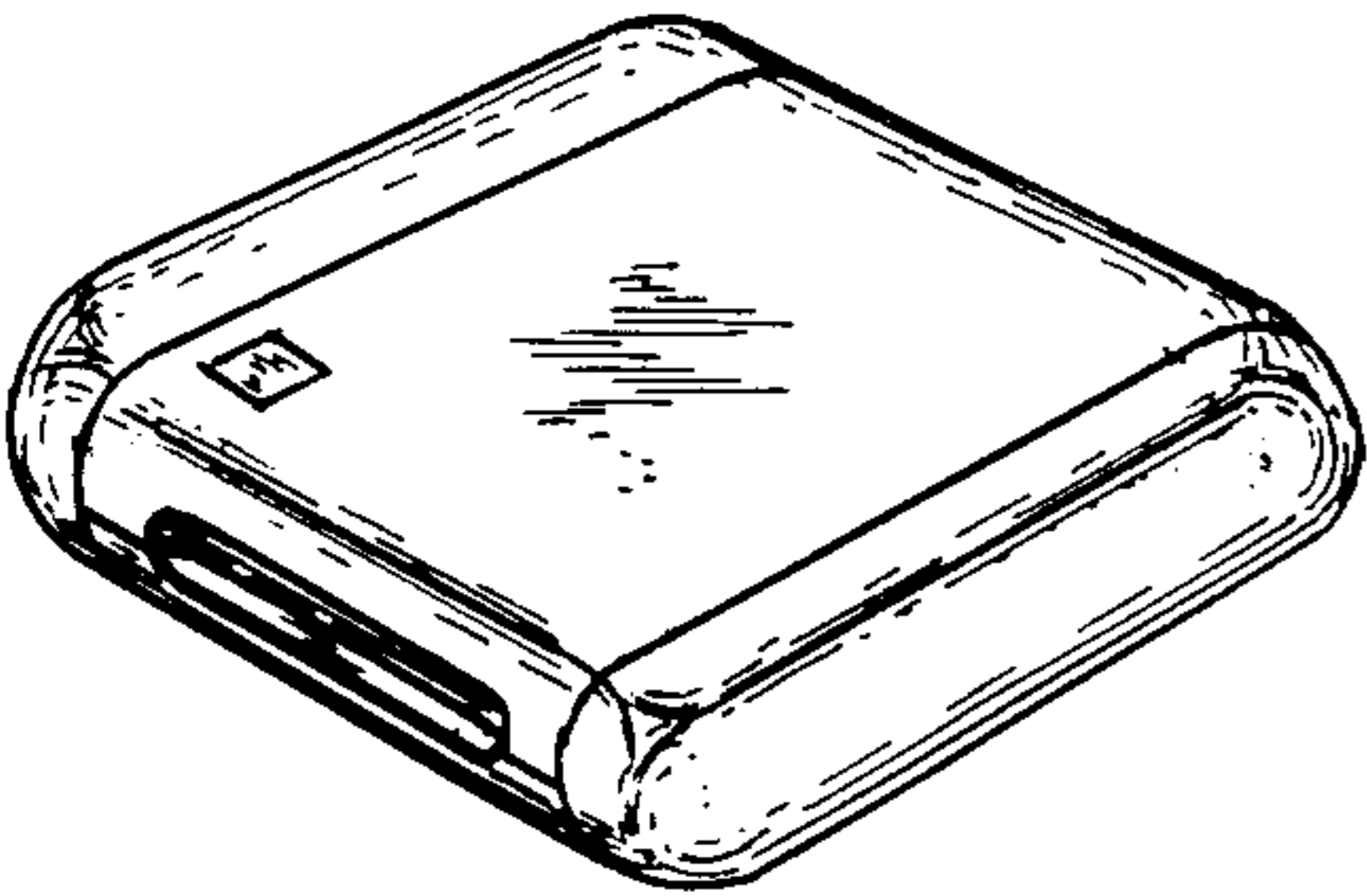
