## **DESCRIPTION**


FIG. 1 is a top plan view of the combined solar heat collector and cover for swimming pools showing my new design;

FIG. 2 is a typical edge view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a fragmentary vertical cross-sectional view taken in the plane indicated by the line 4-4 in FIG. 1; FIG. 5 is a fragmentary vertical cross-sectional view taken in the plane indicated by the line 5-5 in FIG. 1; FIG. 6 is a fragmentary vertical cross-sectional view taken in the plane indicated by the line 6-6 in FIG. 1; FIG. 7 is a fragmentary vertical cross-sectional view taken in the plane indicated by the line 7—7 in FIG. 1; FIG. 8 is a fragmentary vertical cross-sectional view taken in the plane indicated by the line 8-8 in FIG. 1; FIG. 9 is a fragmentary vertical cross-sectional view taken in the plane indicated by the line 9—9 in FIG. 1; FIG. 10 is a fragmentary vertical cross-sectional view taken in the plane indicated by the line 10-10 in FIG. **1**; and

FIG. 11 is a fragmentary vertical cross-sectional view taken in the plane indicated by the line 11—11 in FIG.






