FIG. 9 is an enlarged side elevational view taken from the right of FIG. 6;

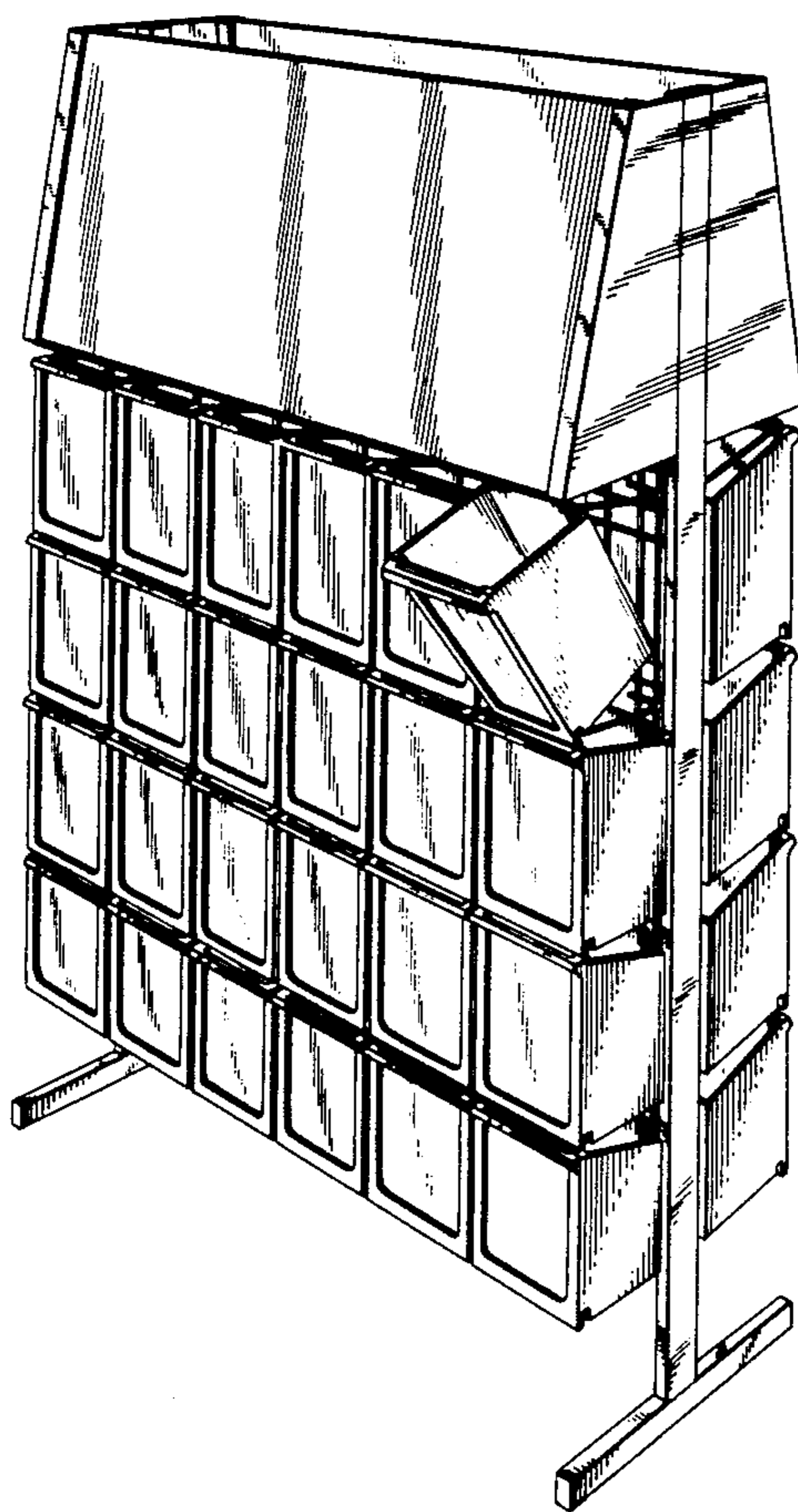
FIG. 10 is an enlarged rear elevational view of FIG. 6; and,

FIG. 11 is an enlarged bottom plan view of FIG. 6.

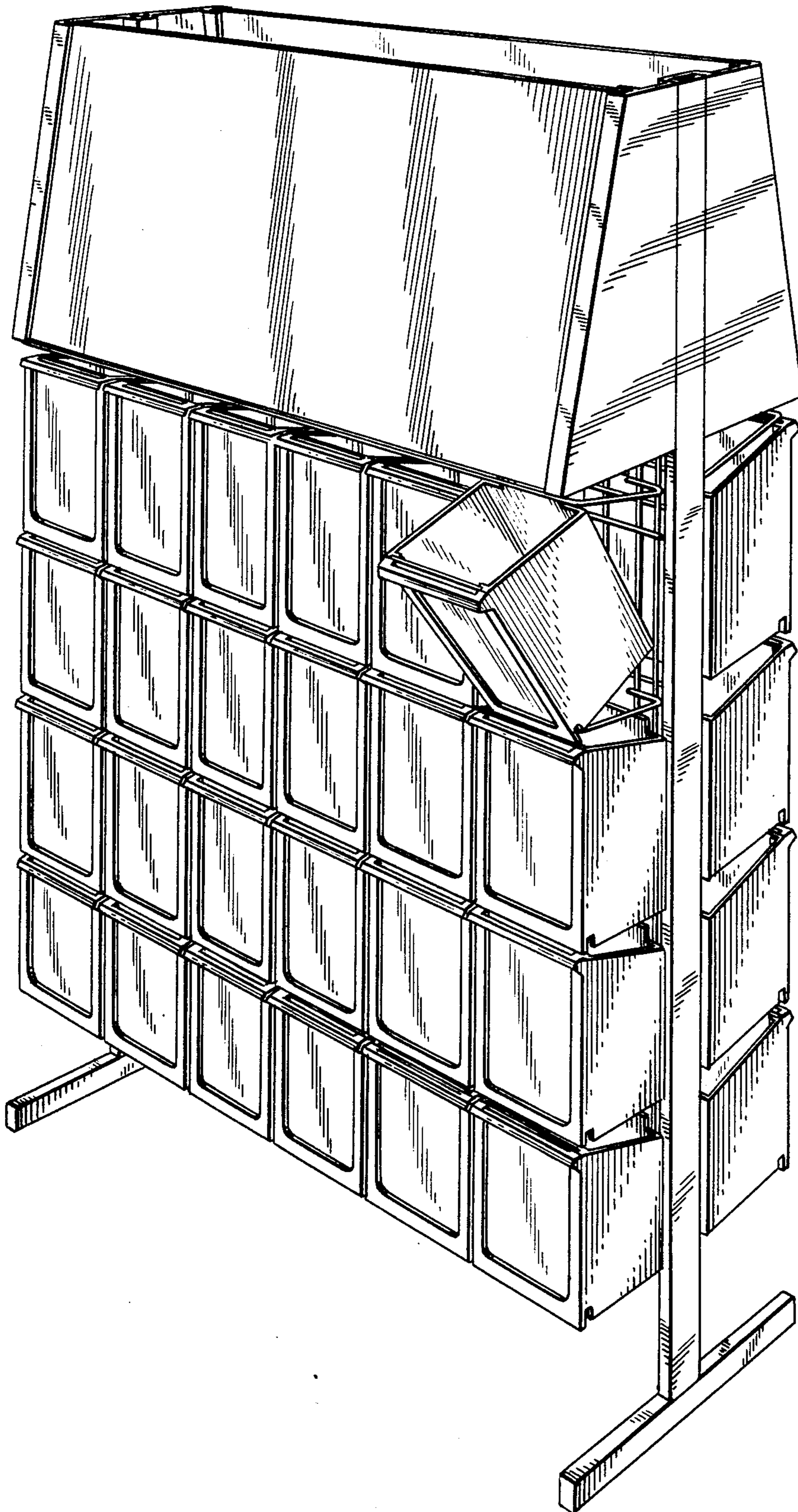

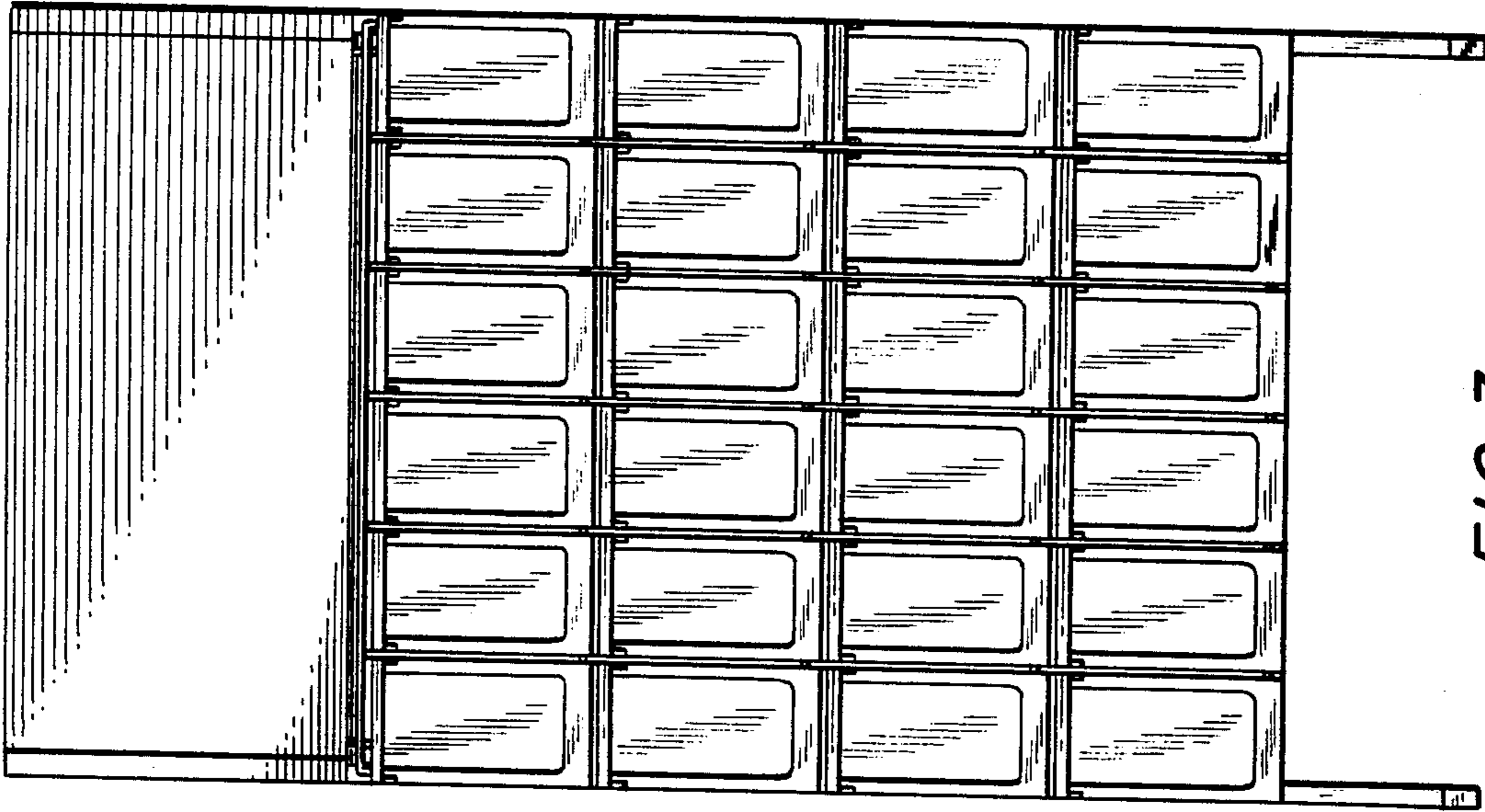

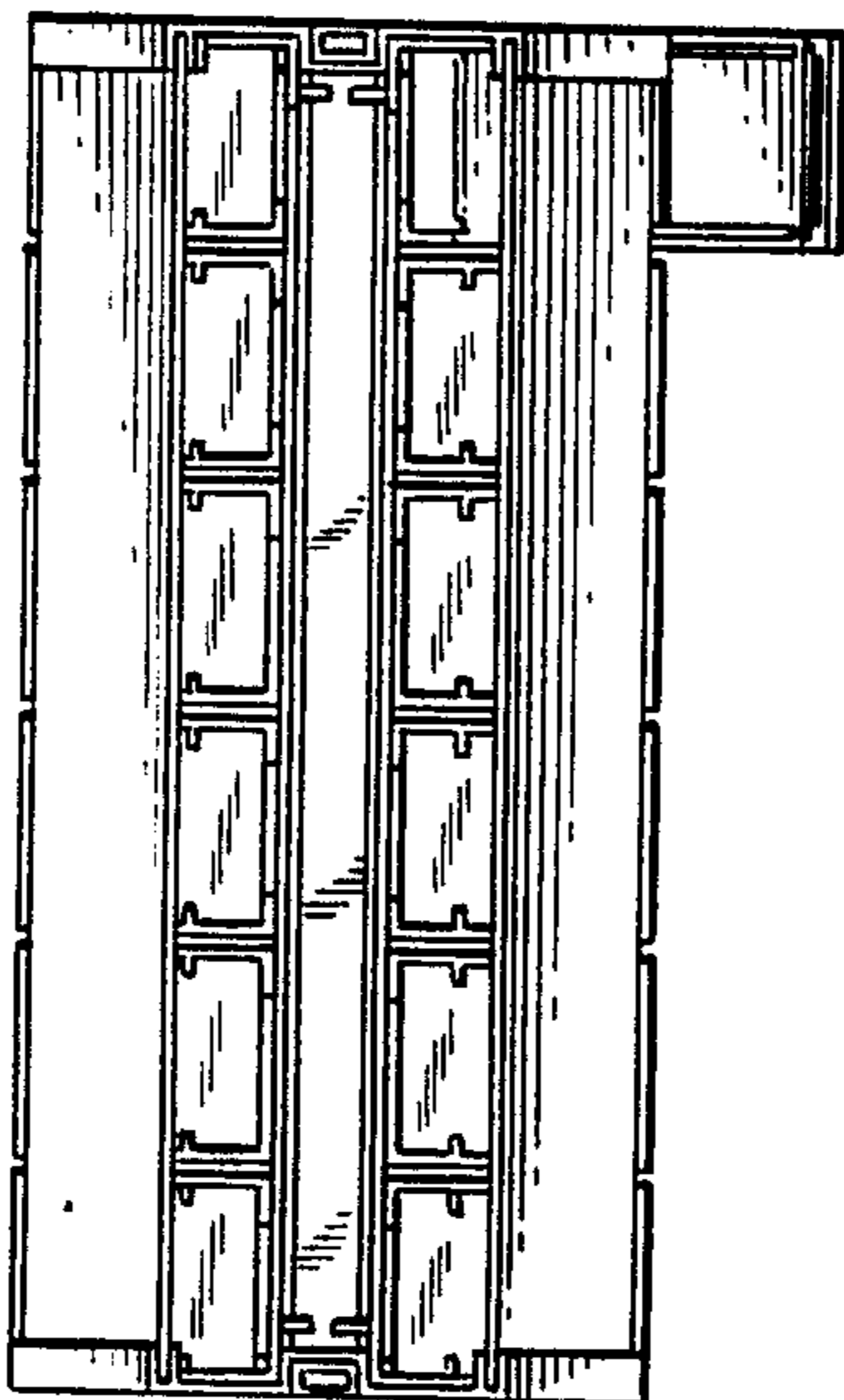

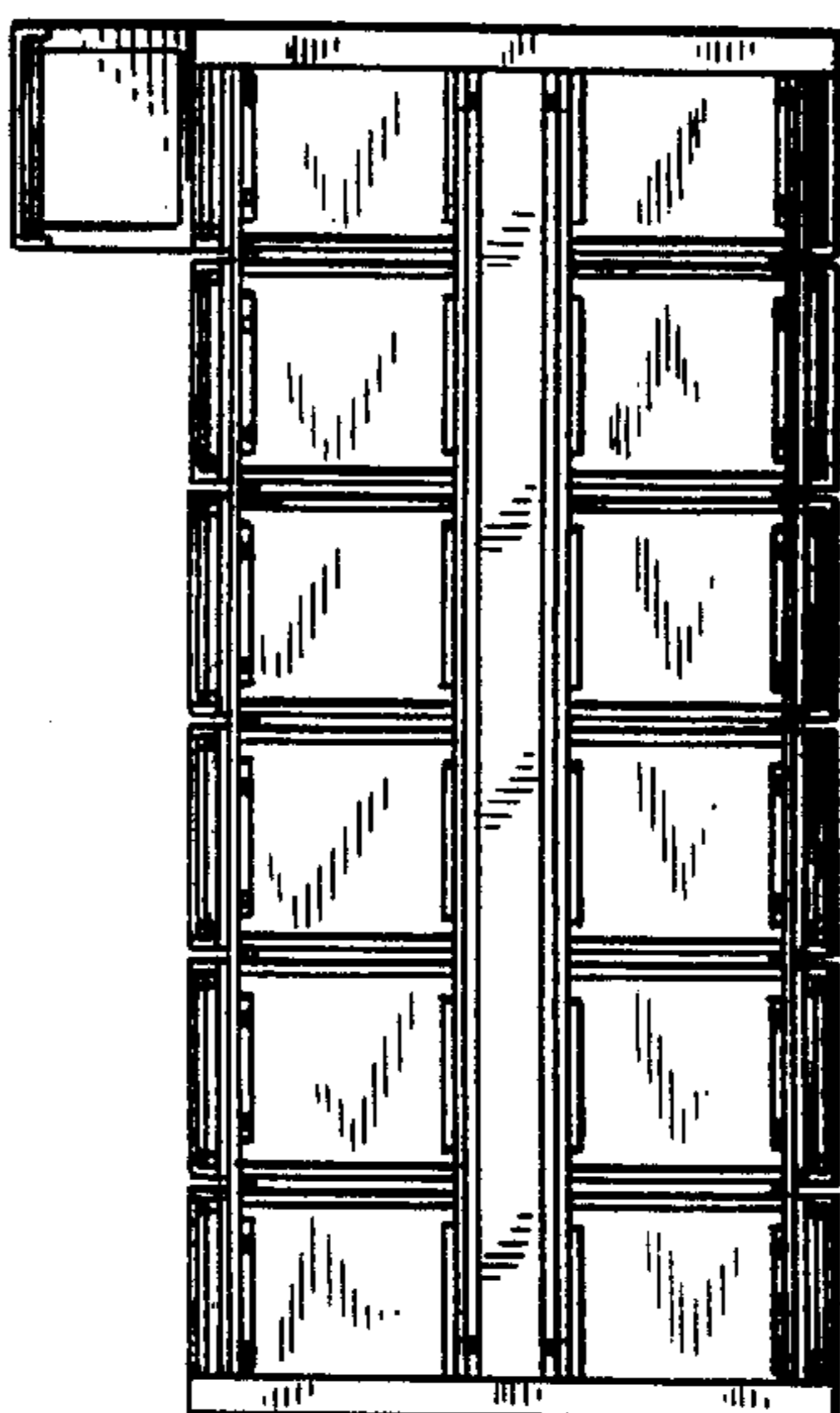
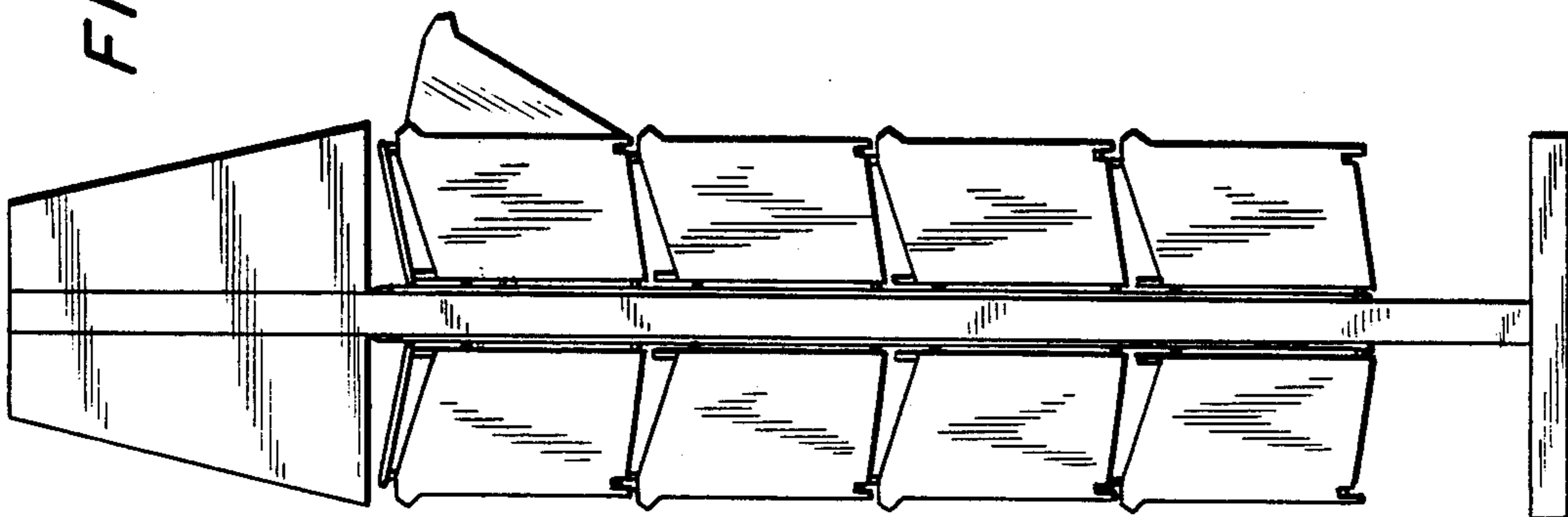

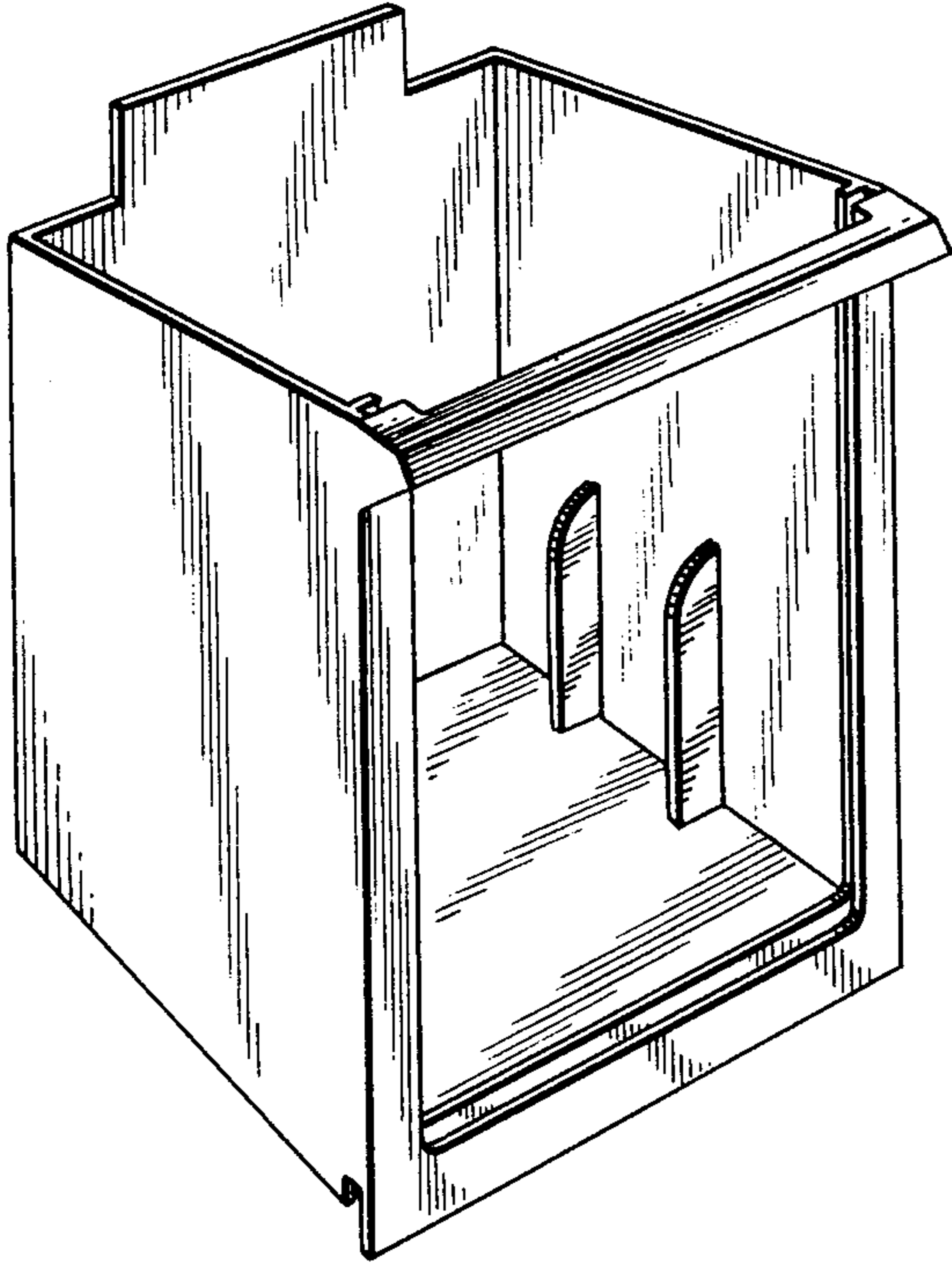
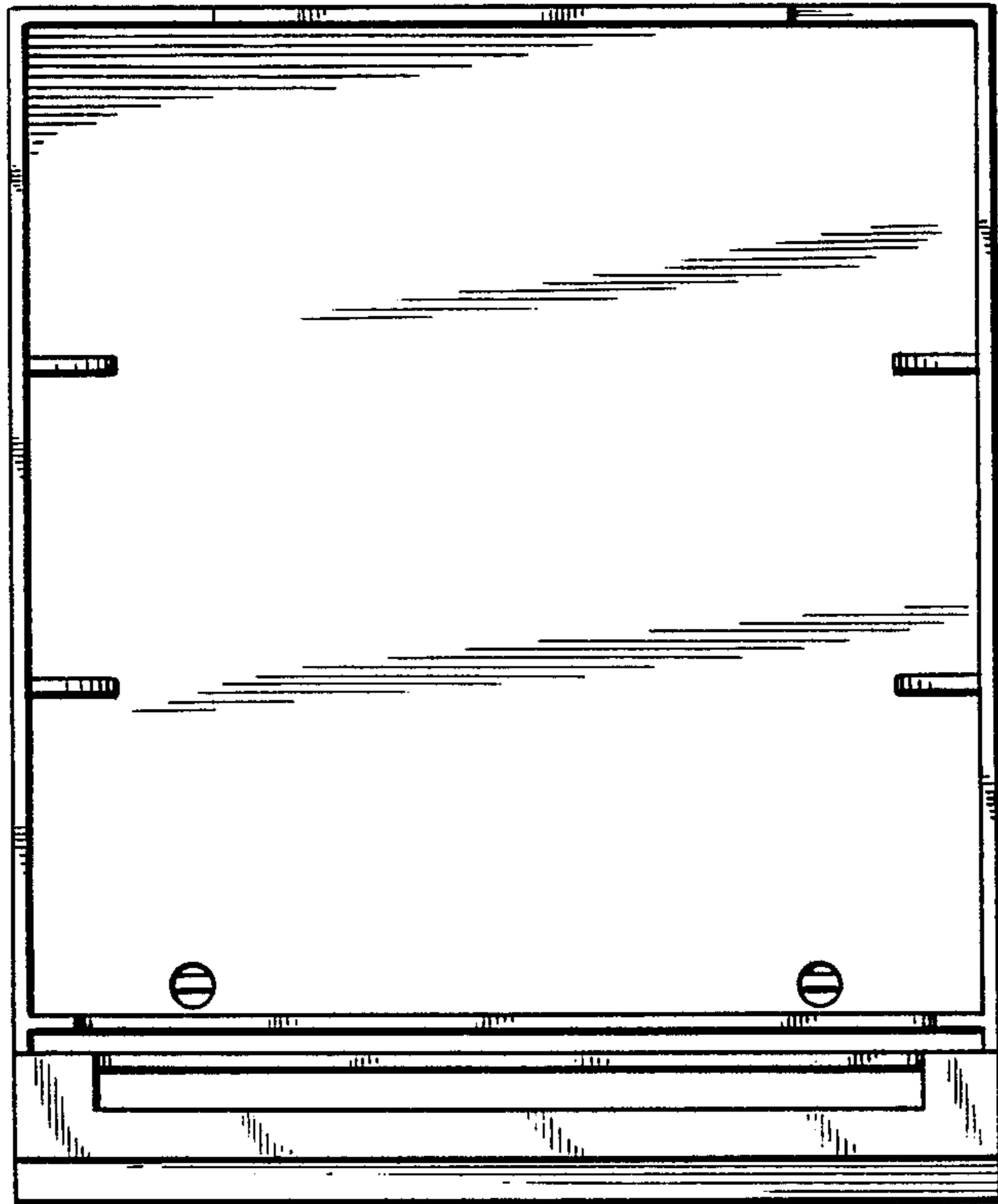

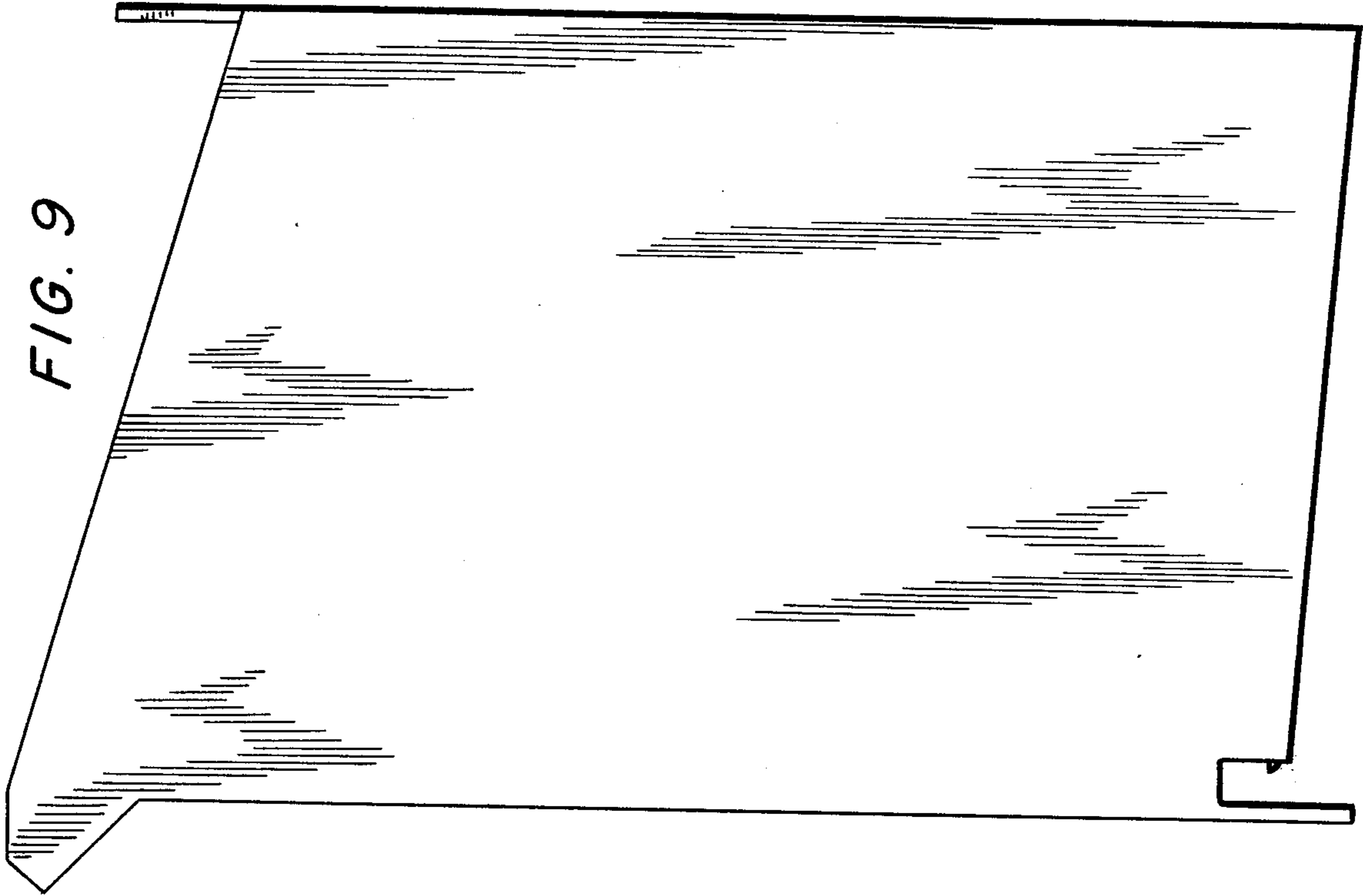

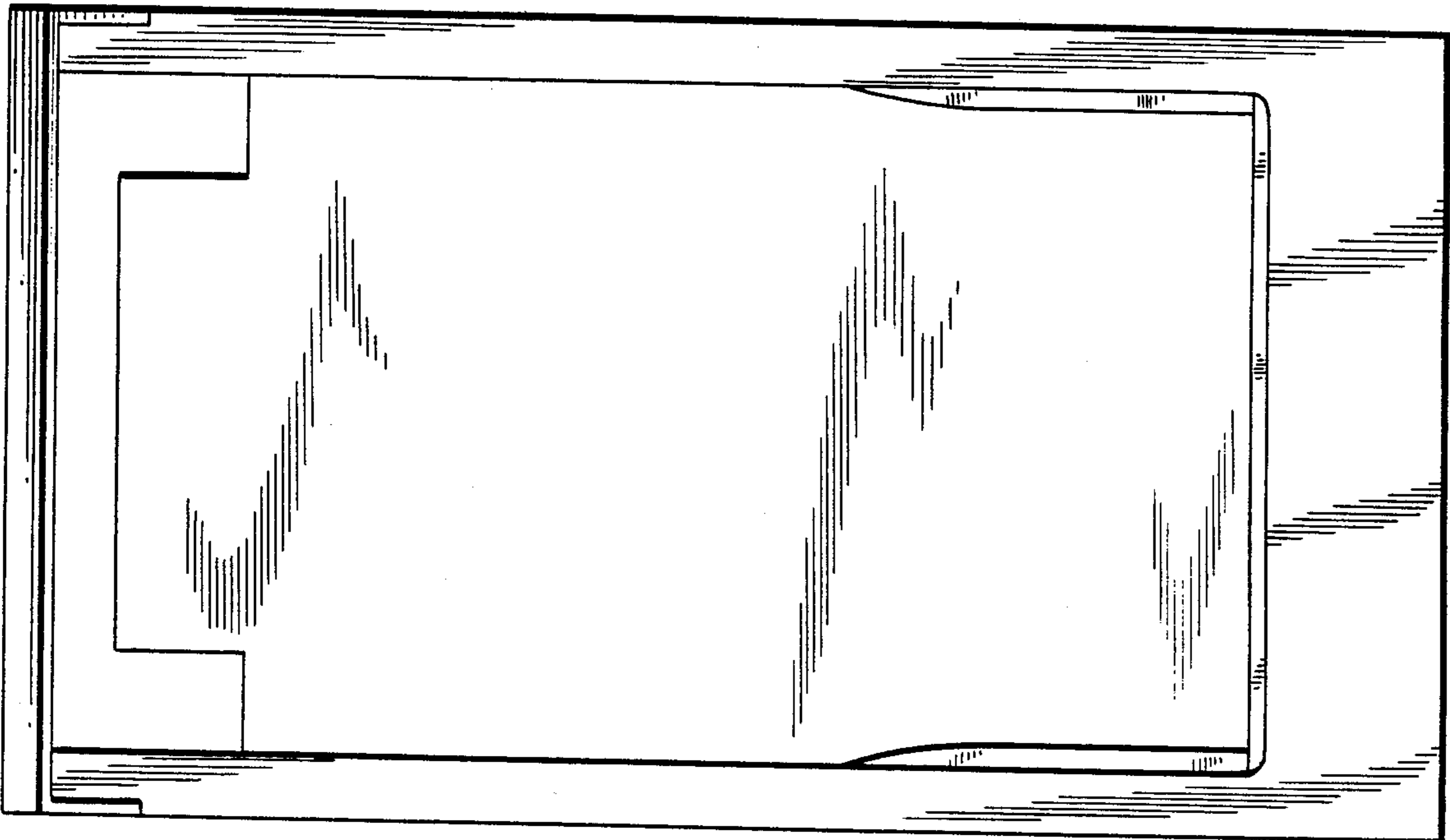

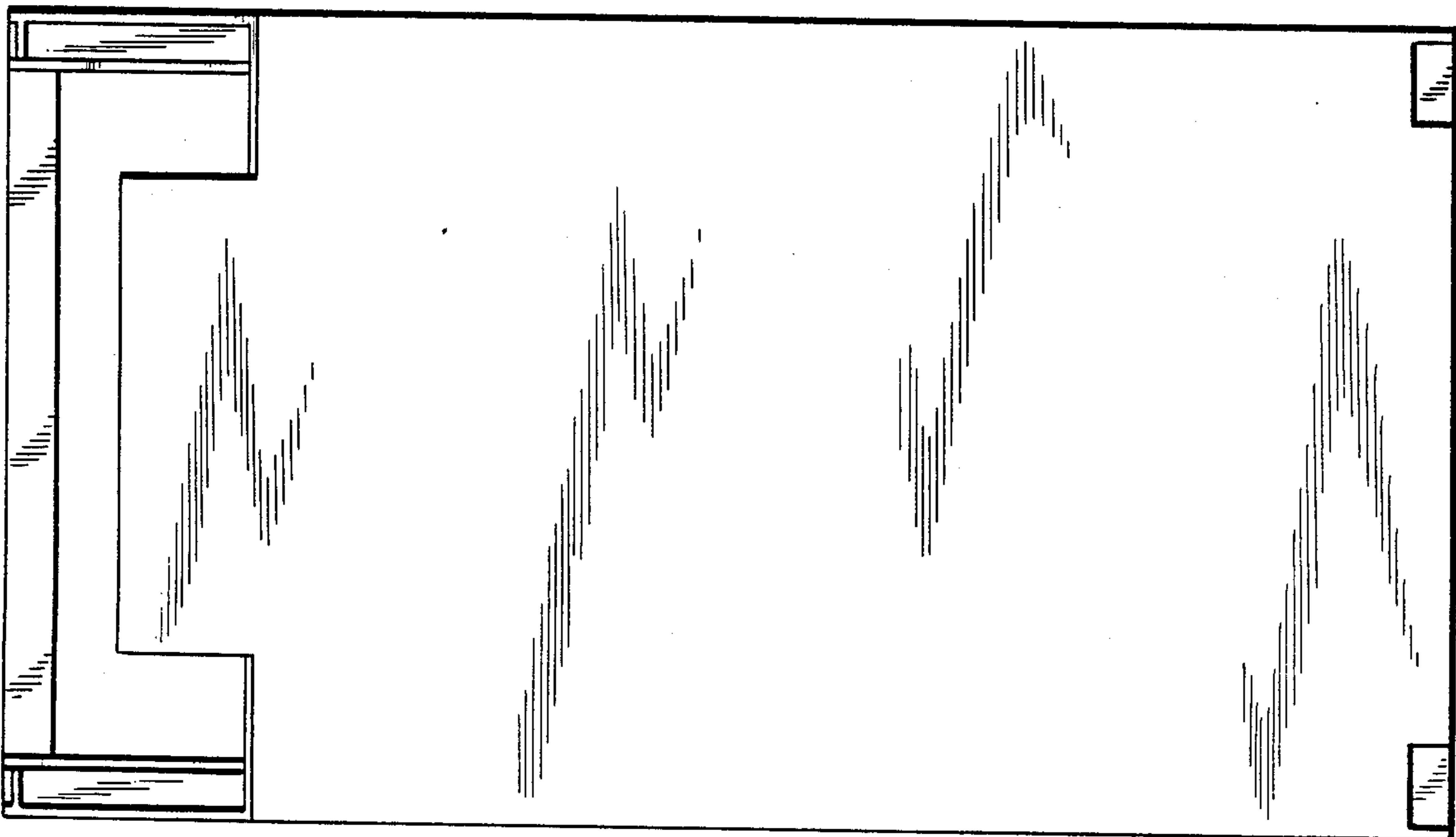
