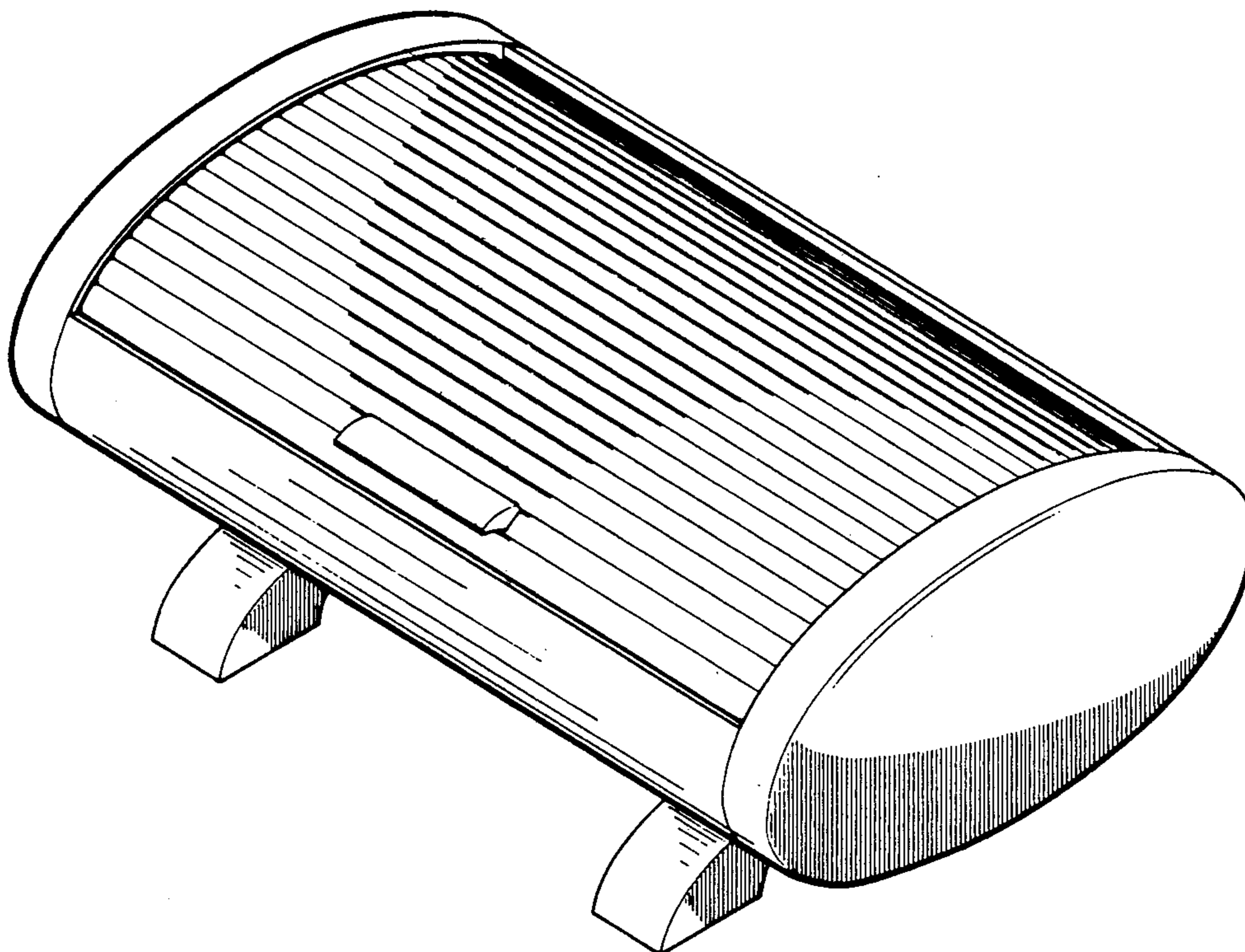

- FIG. 6 is a left side elevational view, the opposite side being a mirror image thereof.



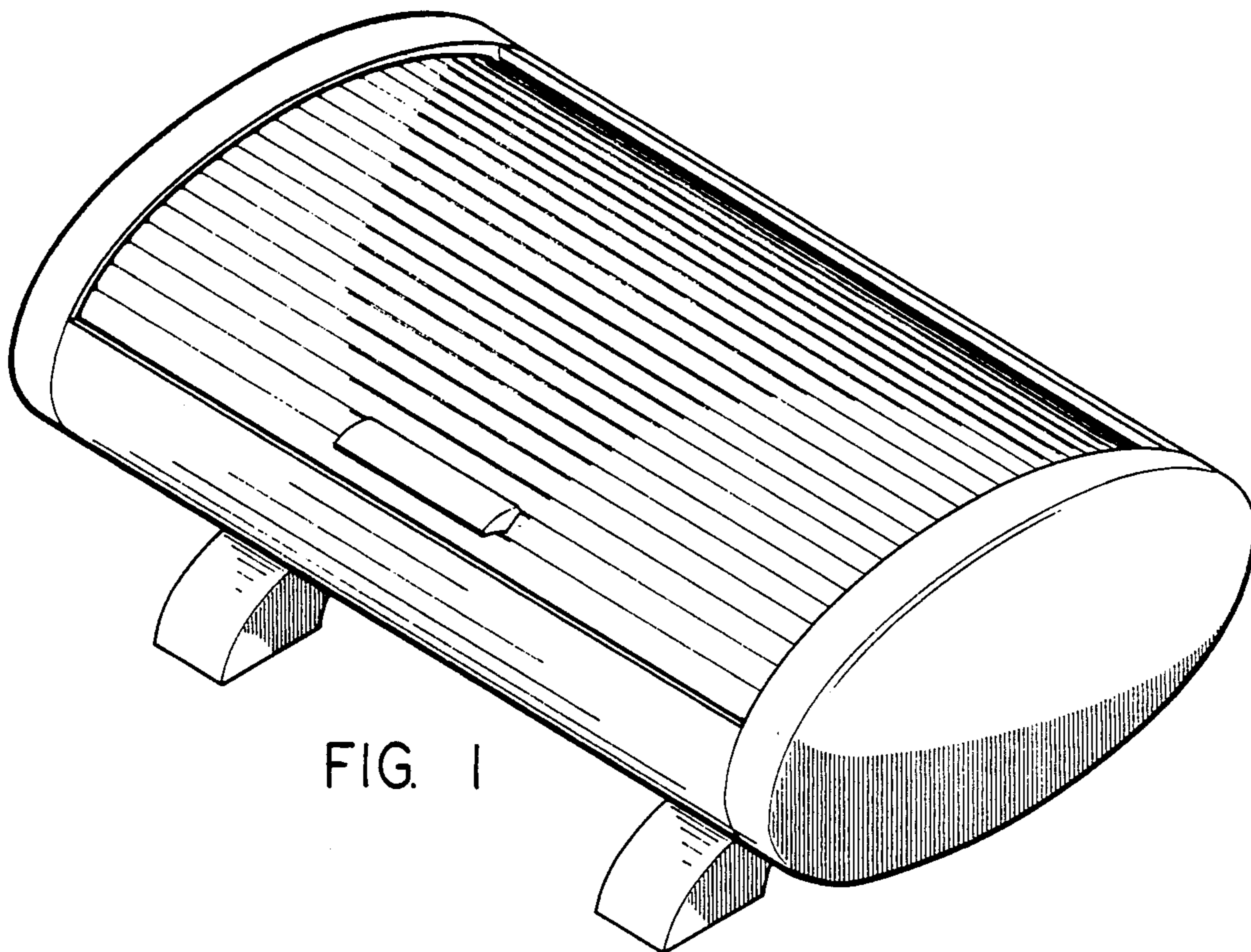

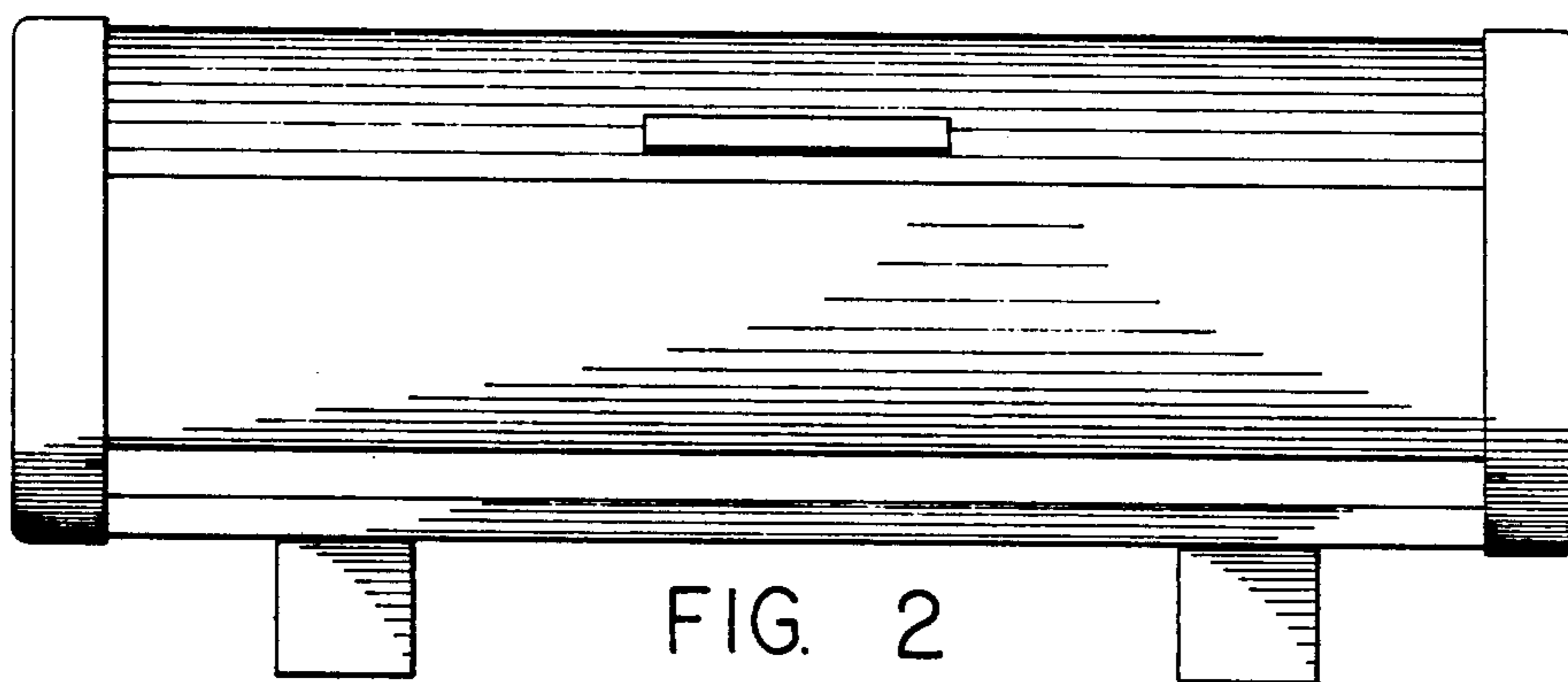

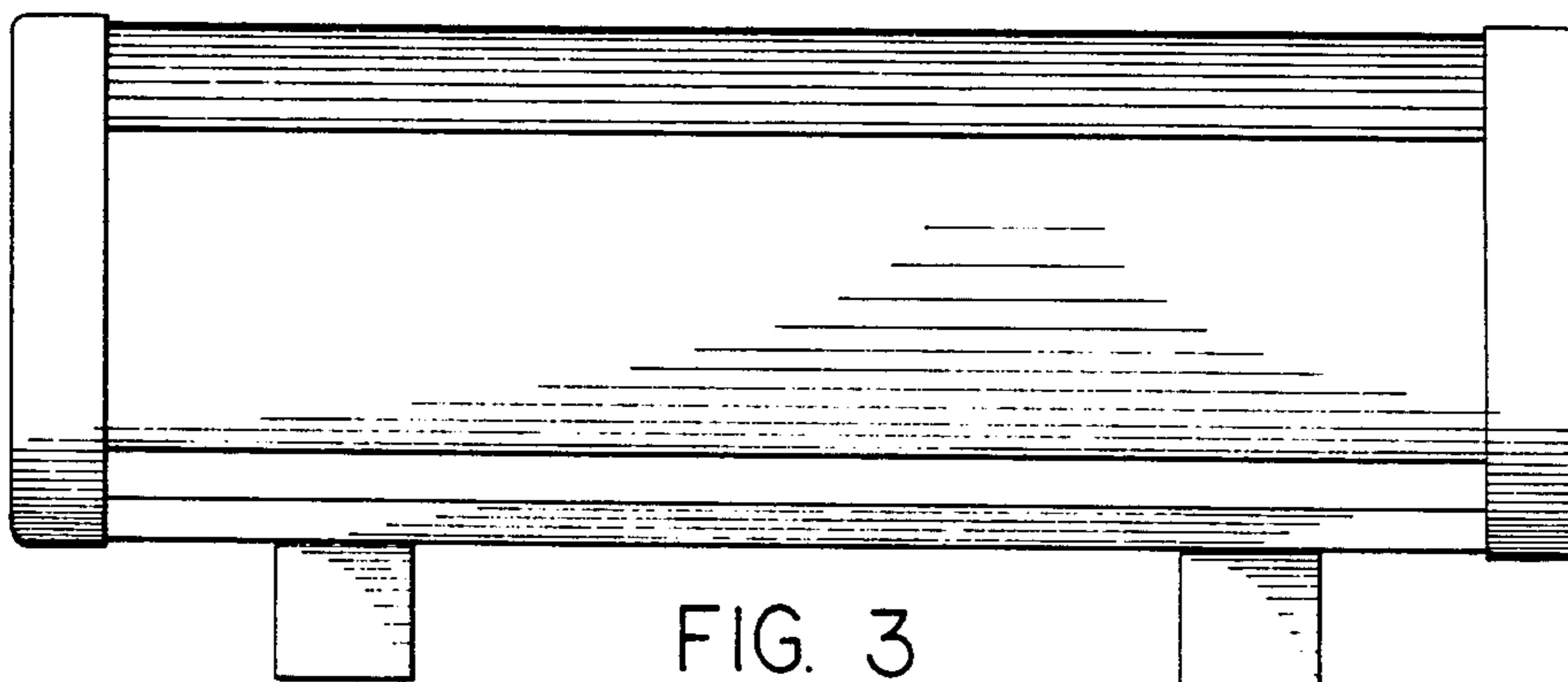

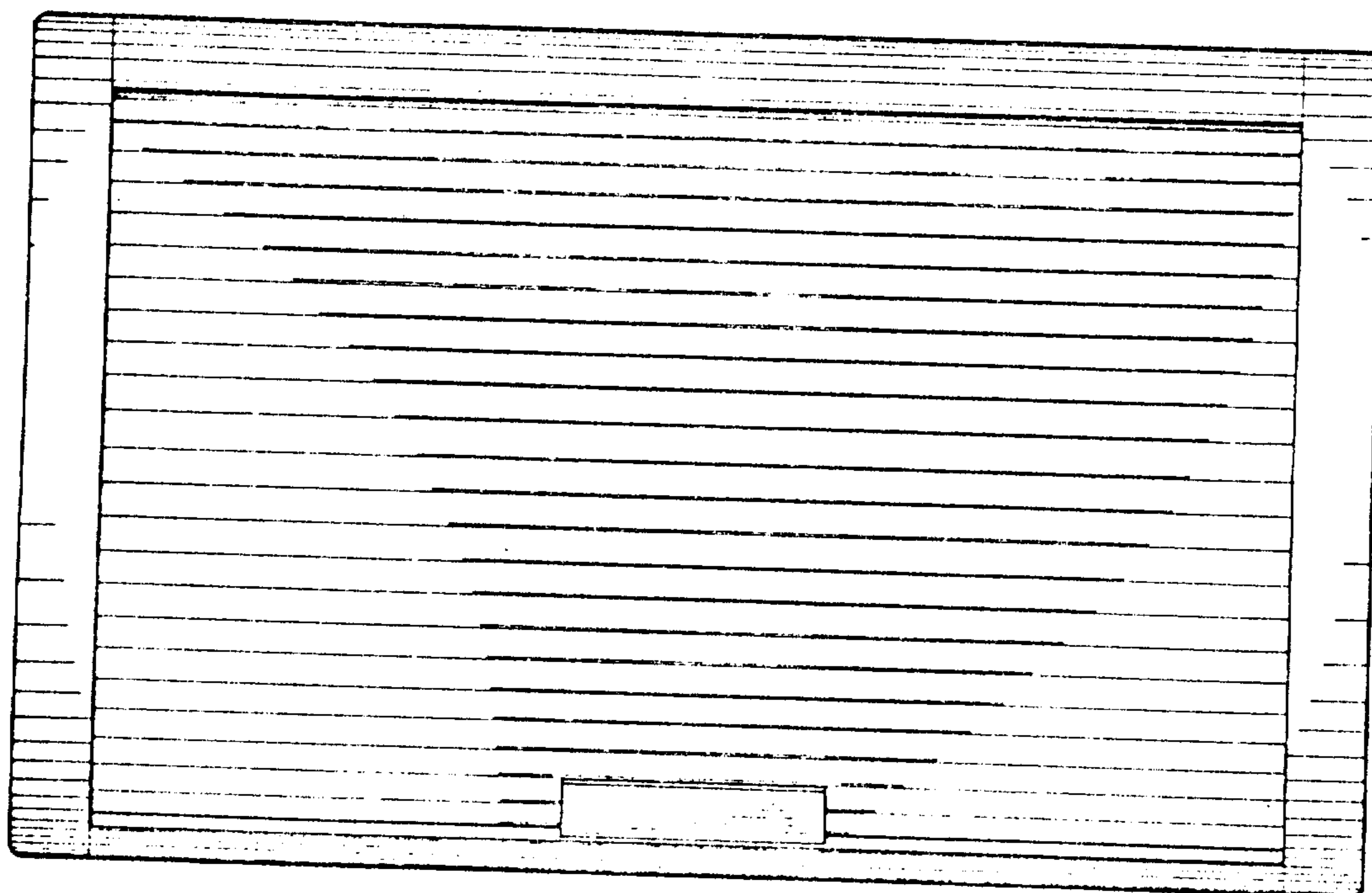

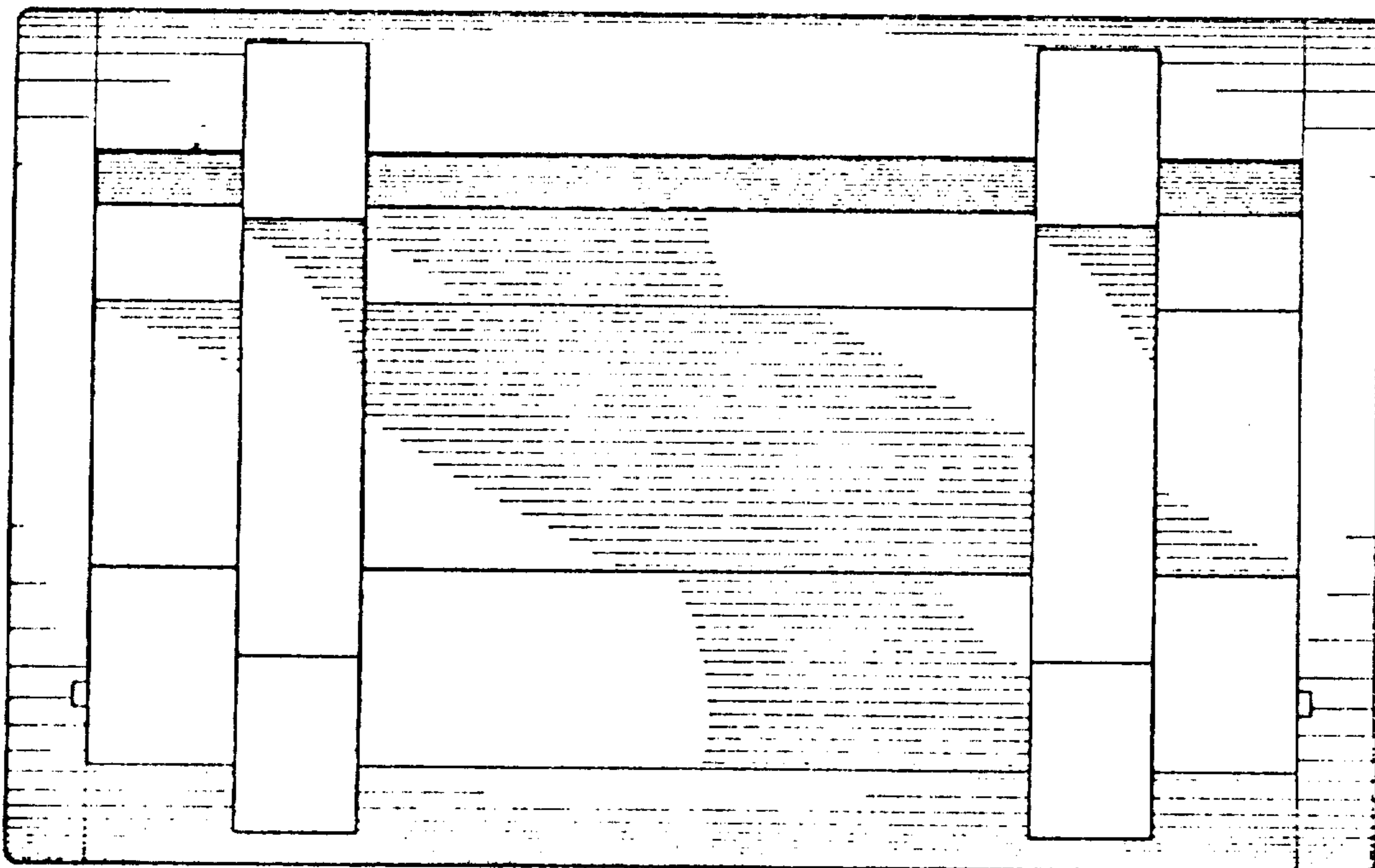
