[57] CLAIM

The ornamental design for a combined automobile cartridge player and radio receiver or the like, substantially as shown.

DESCRIPTION

FIG. 1 is a front perspective view of a combined automobile cartridge player and radio receiver or the like showing our new design;

FIG. 8 is a right side elevational view.

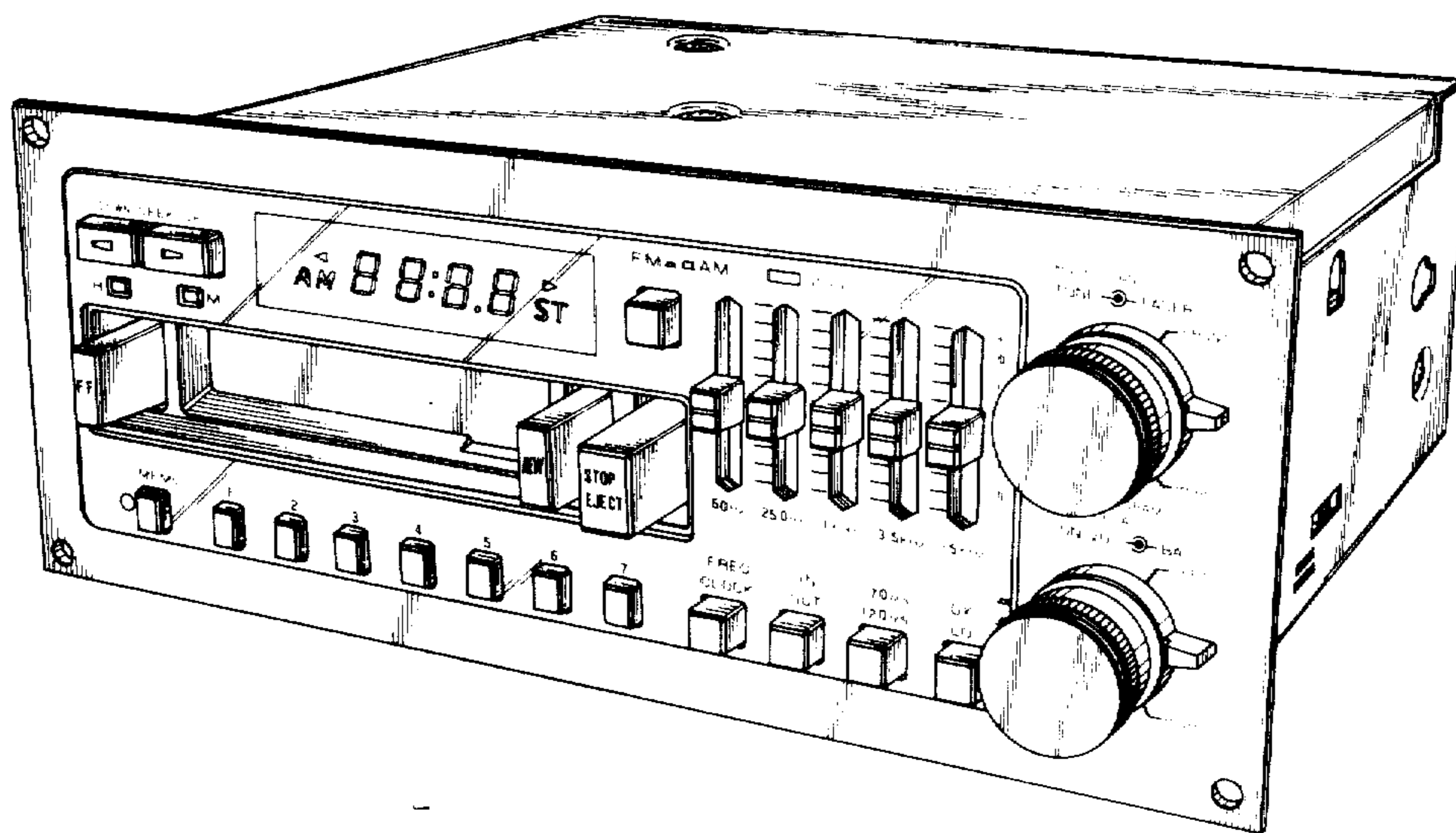

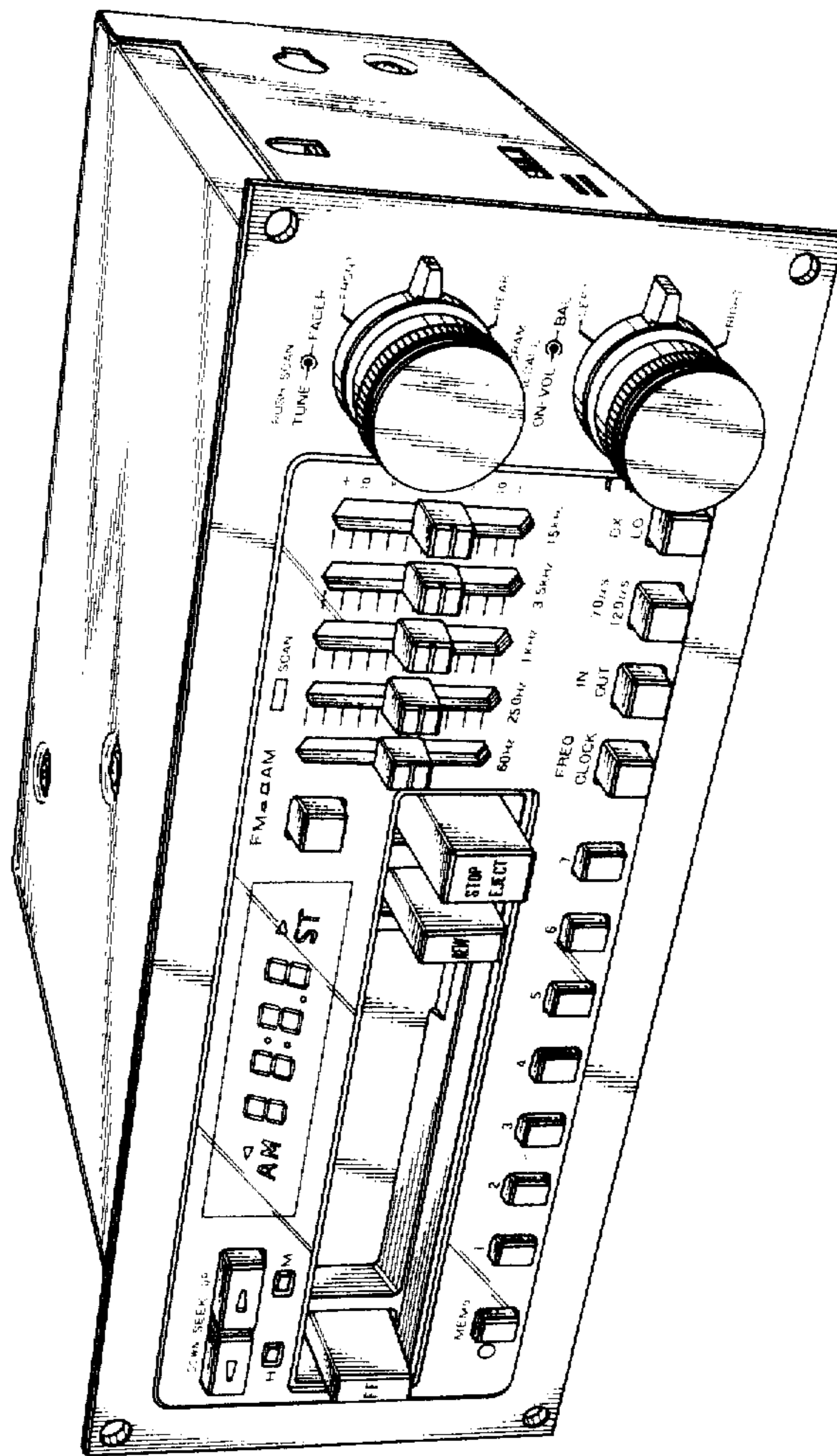

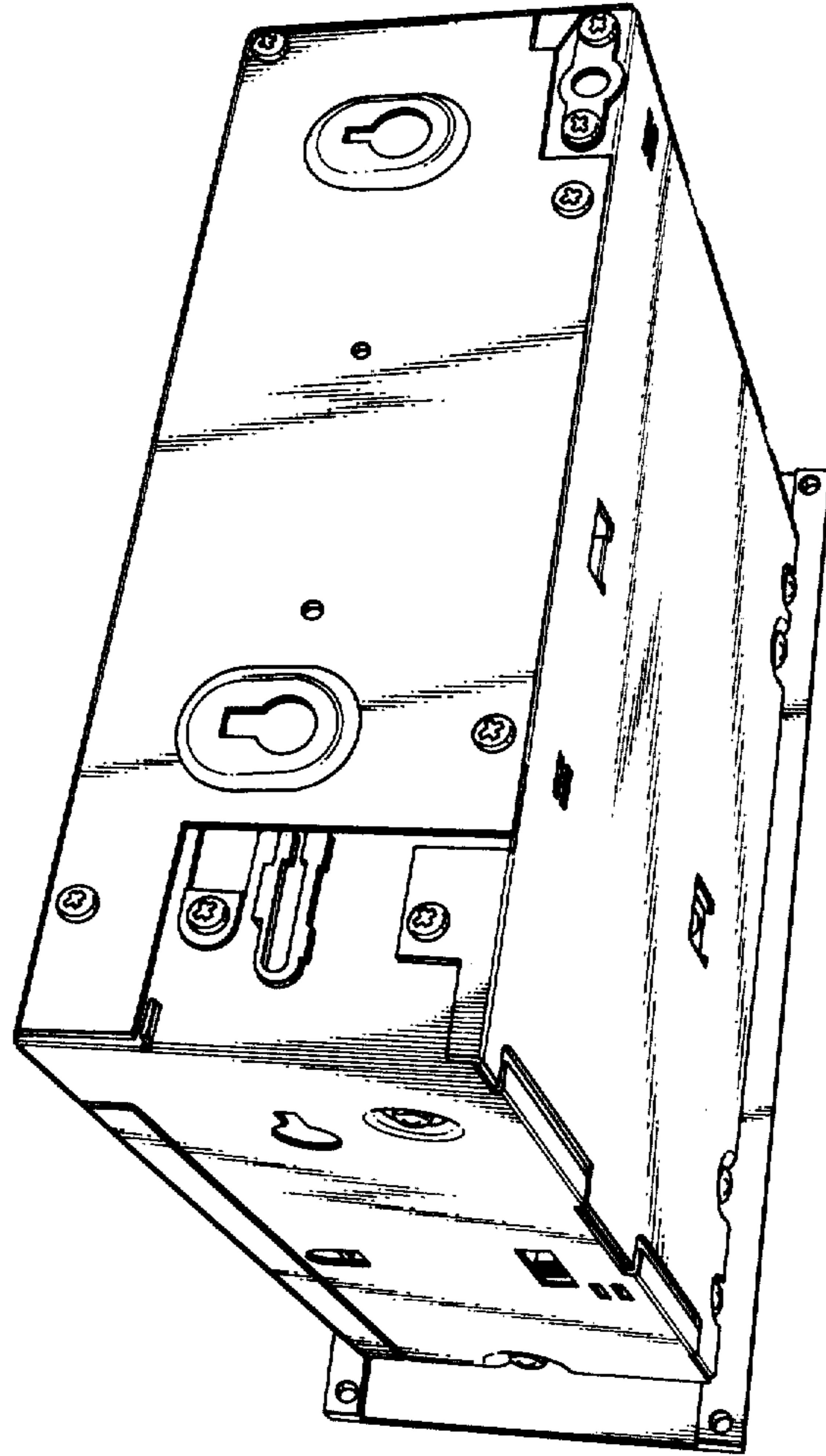

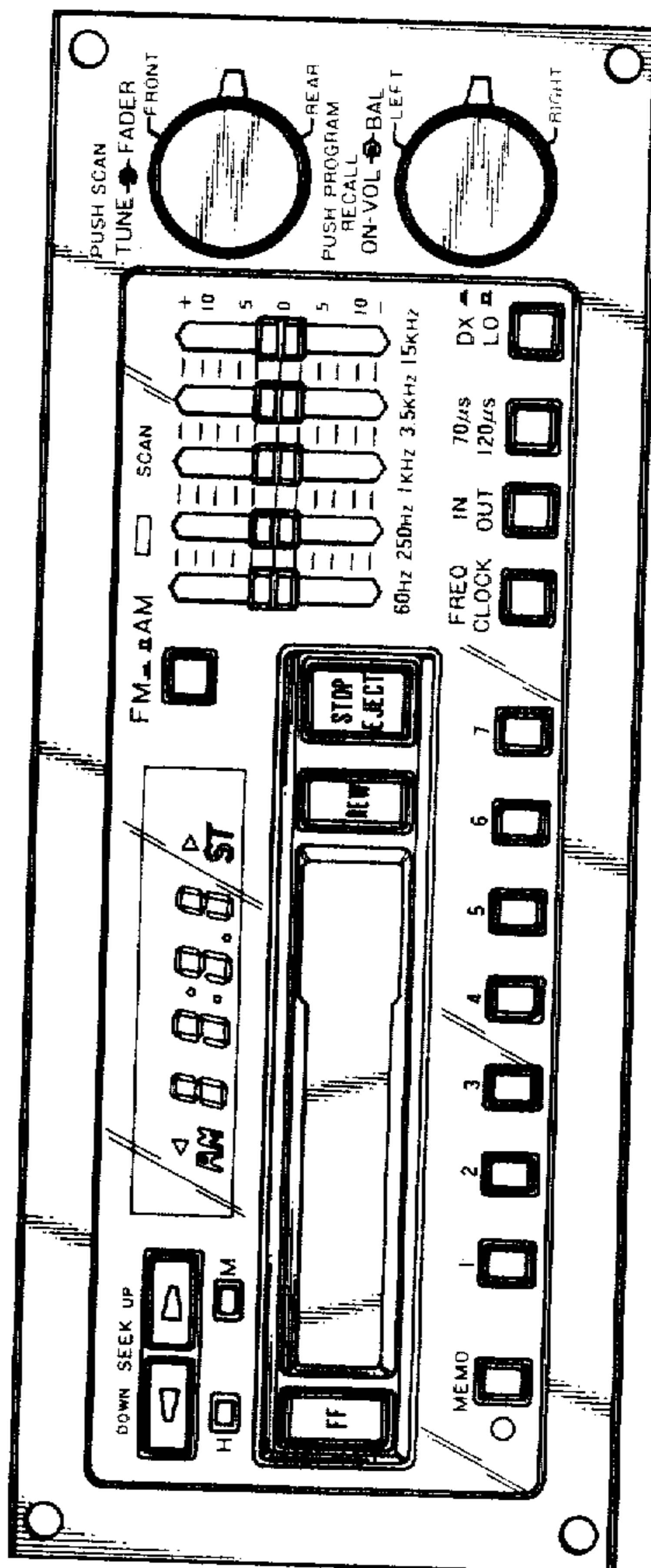

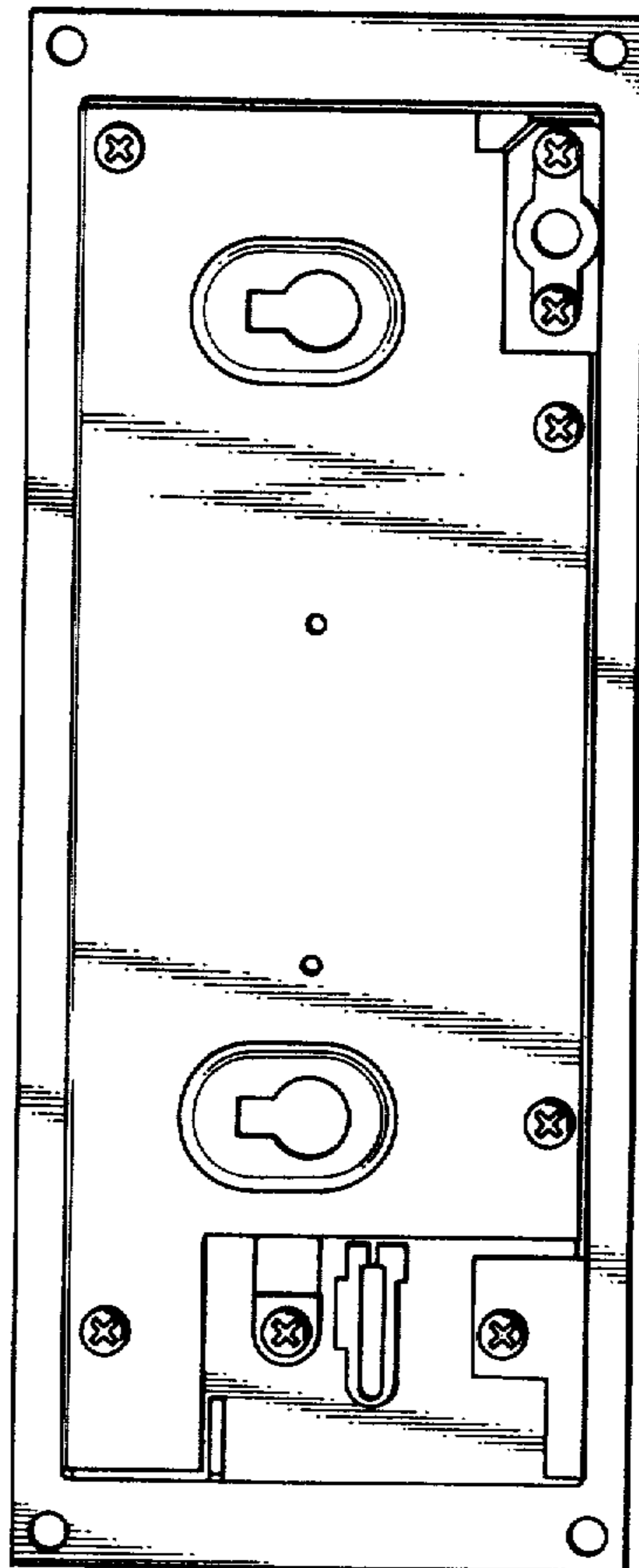

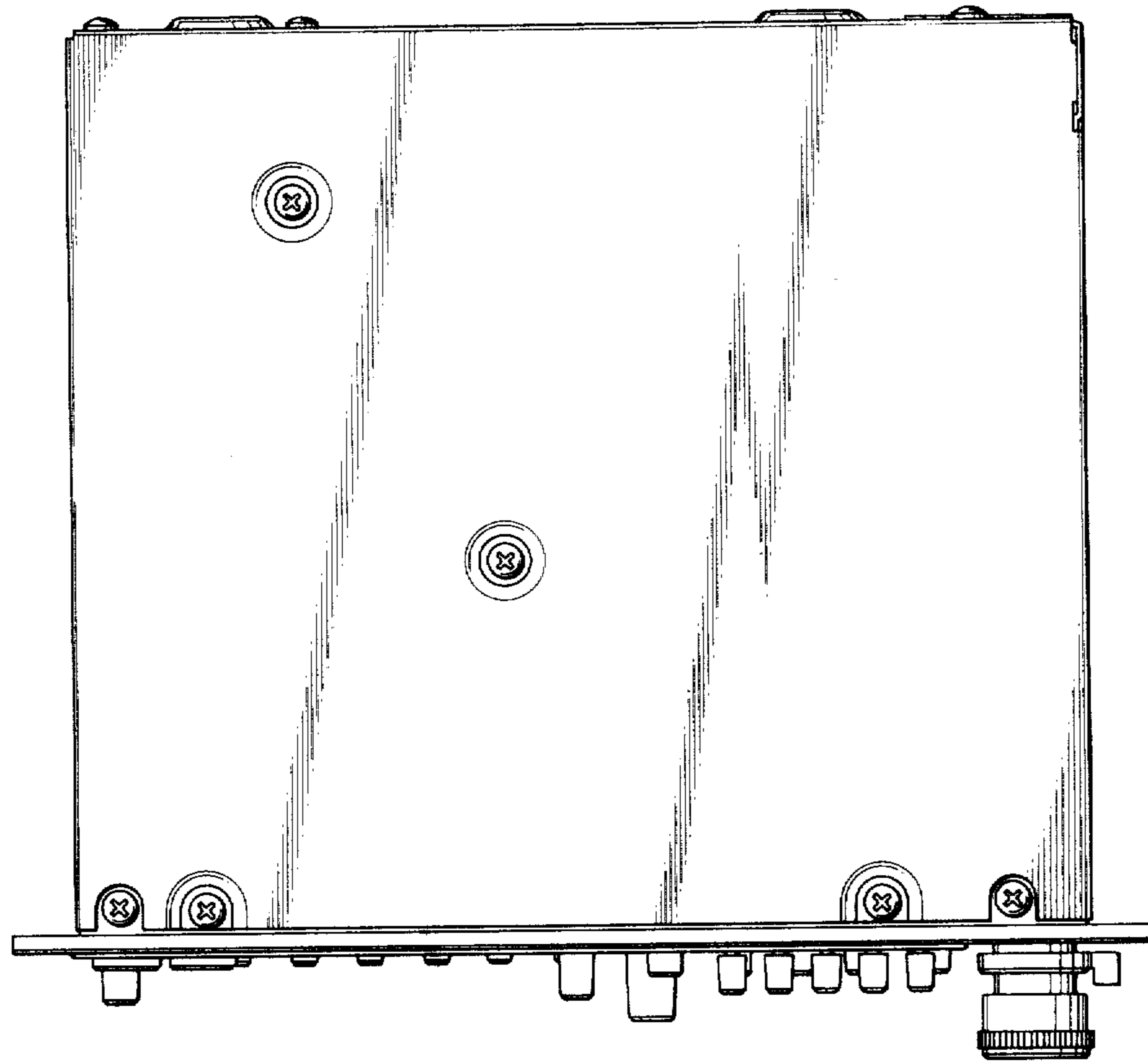

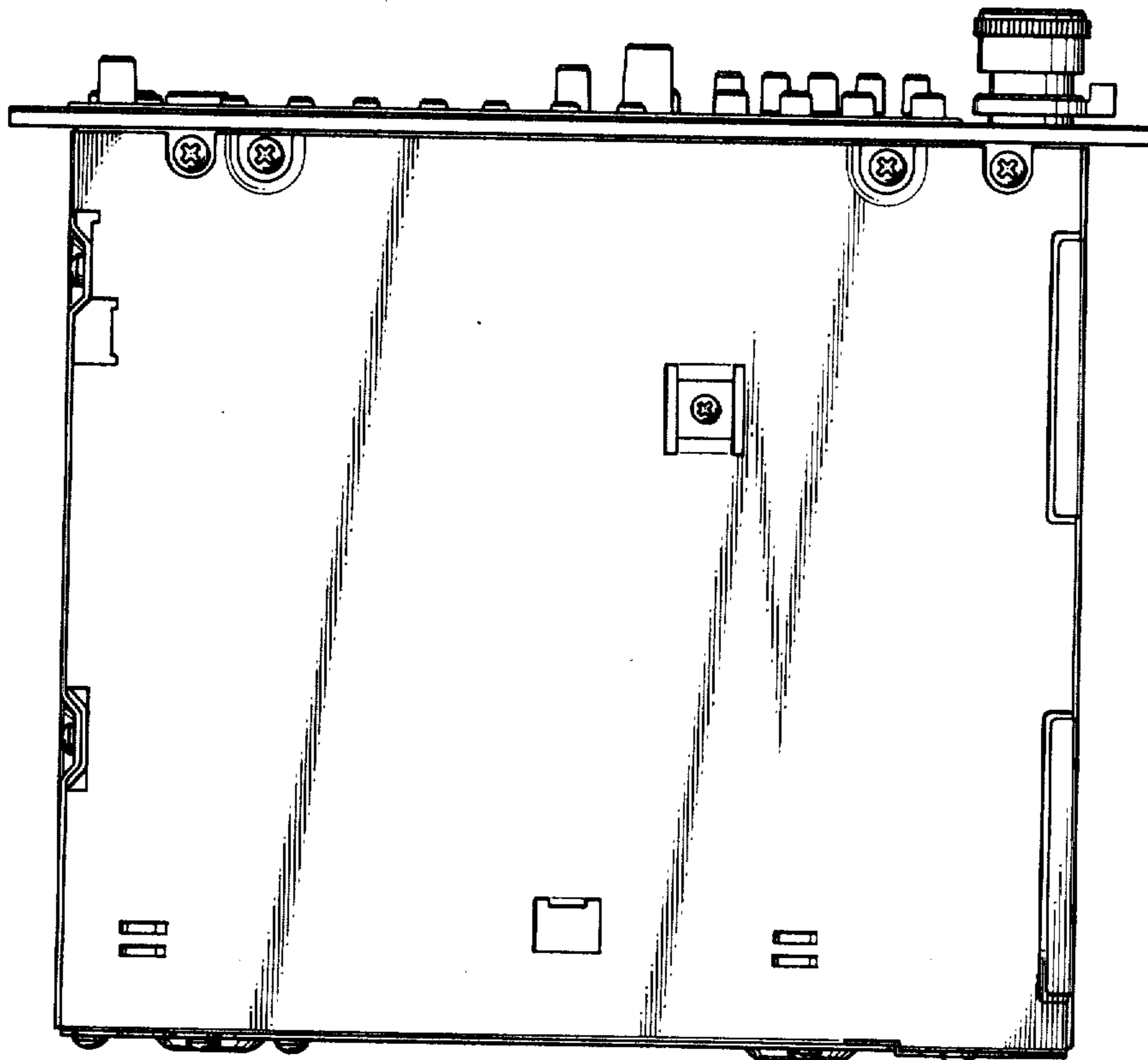

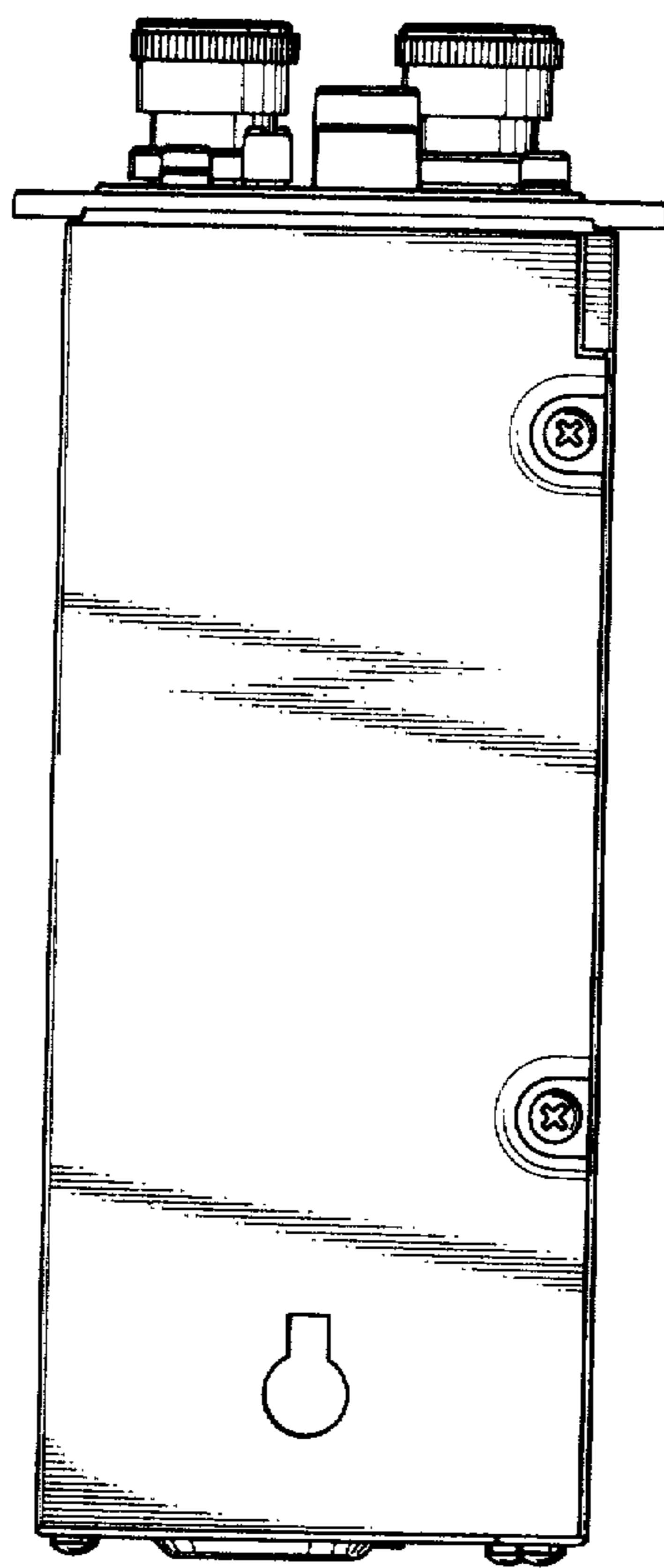
