The ornamental design for an insulated carrier for food or the like, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front, left corner perspective view of an insulated carrier for food or the like showing our new design;

FIG. 7 is a bottom plan view thereof.

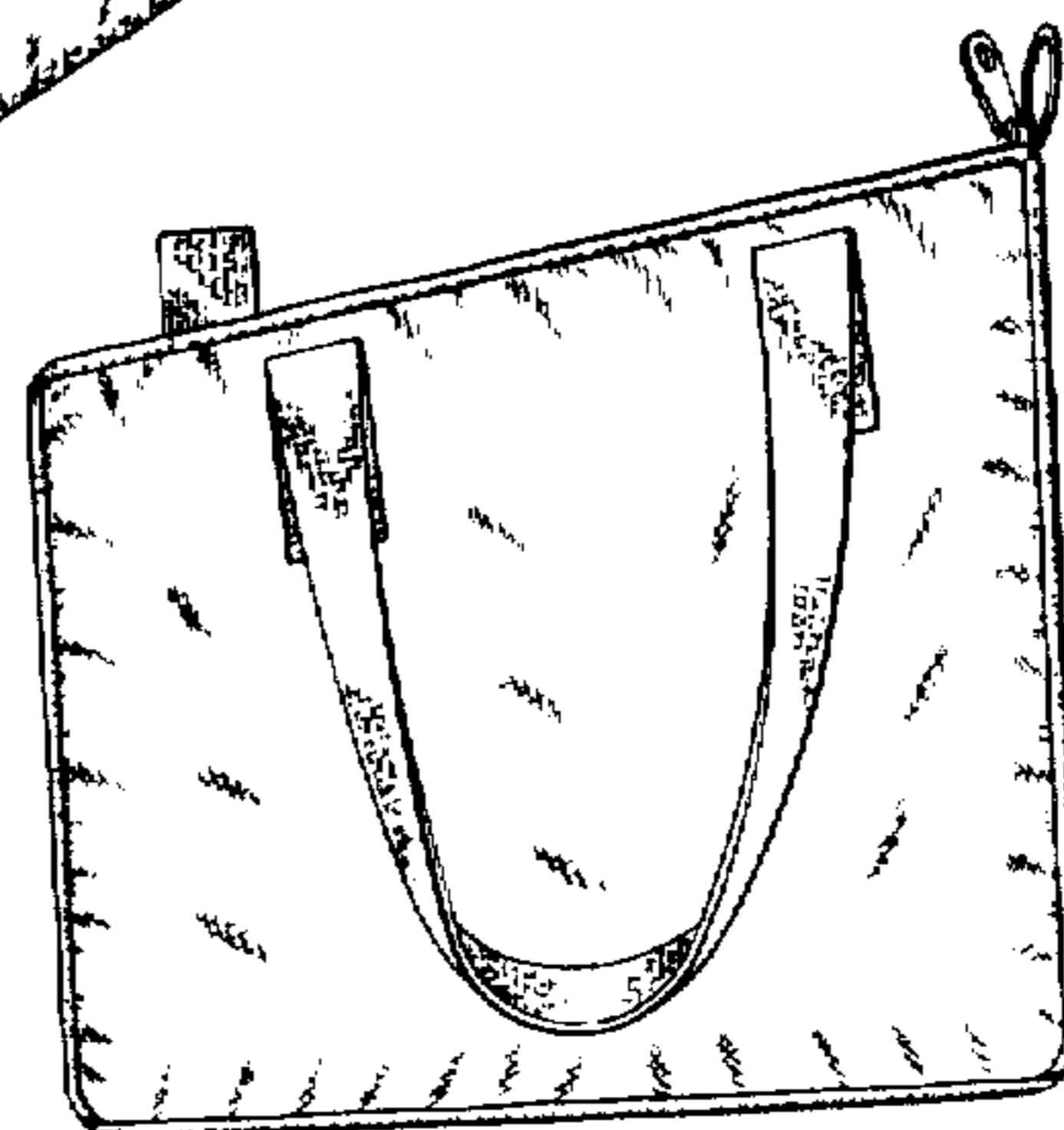
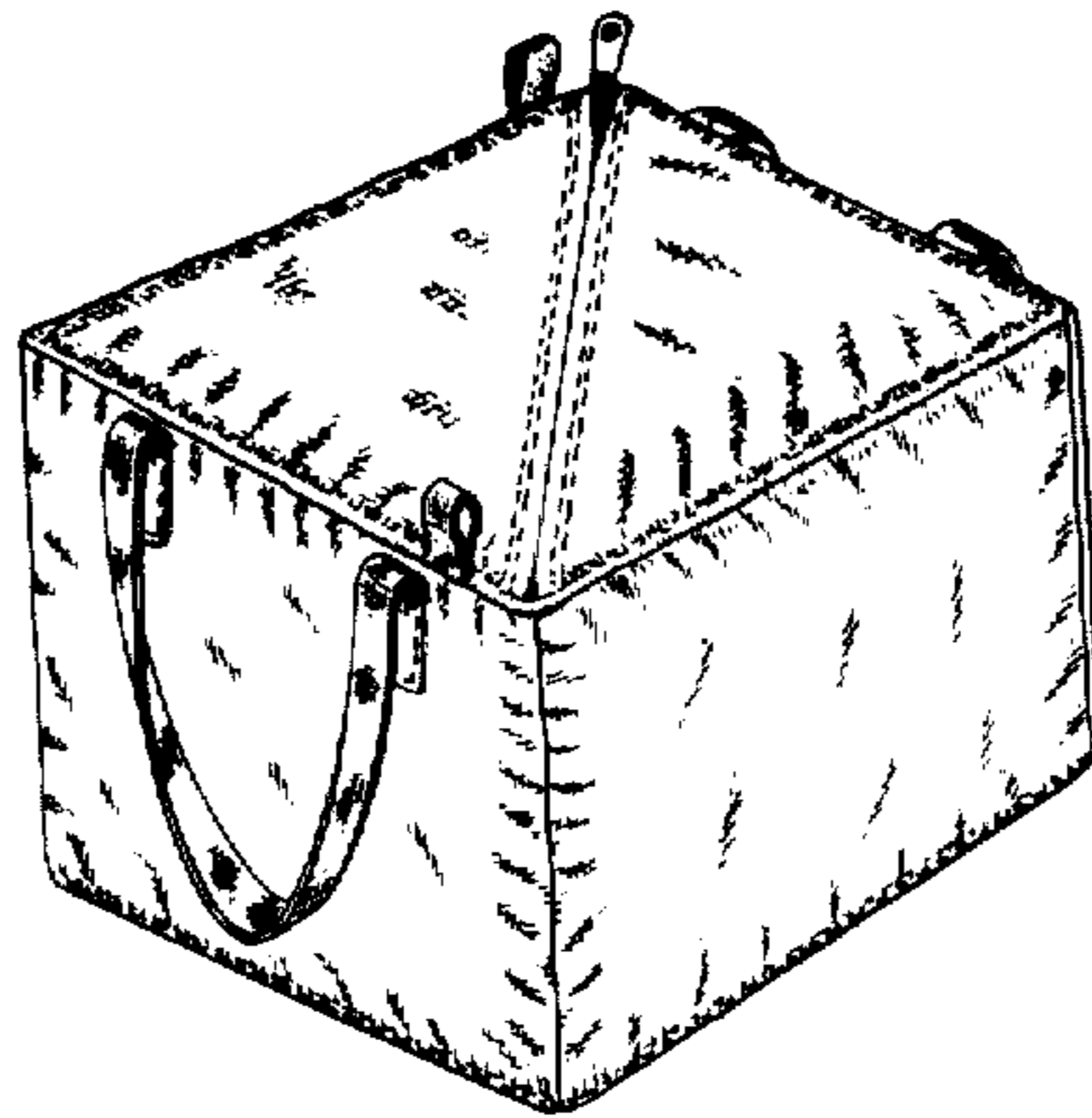

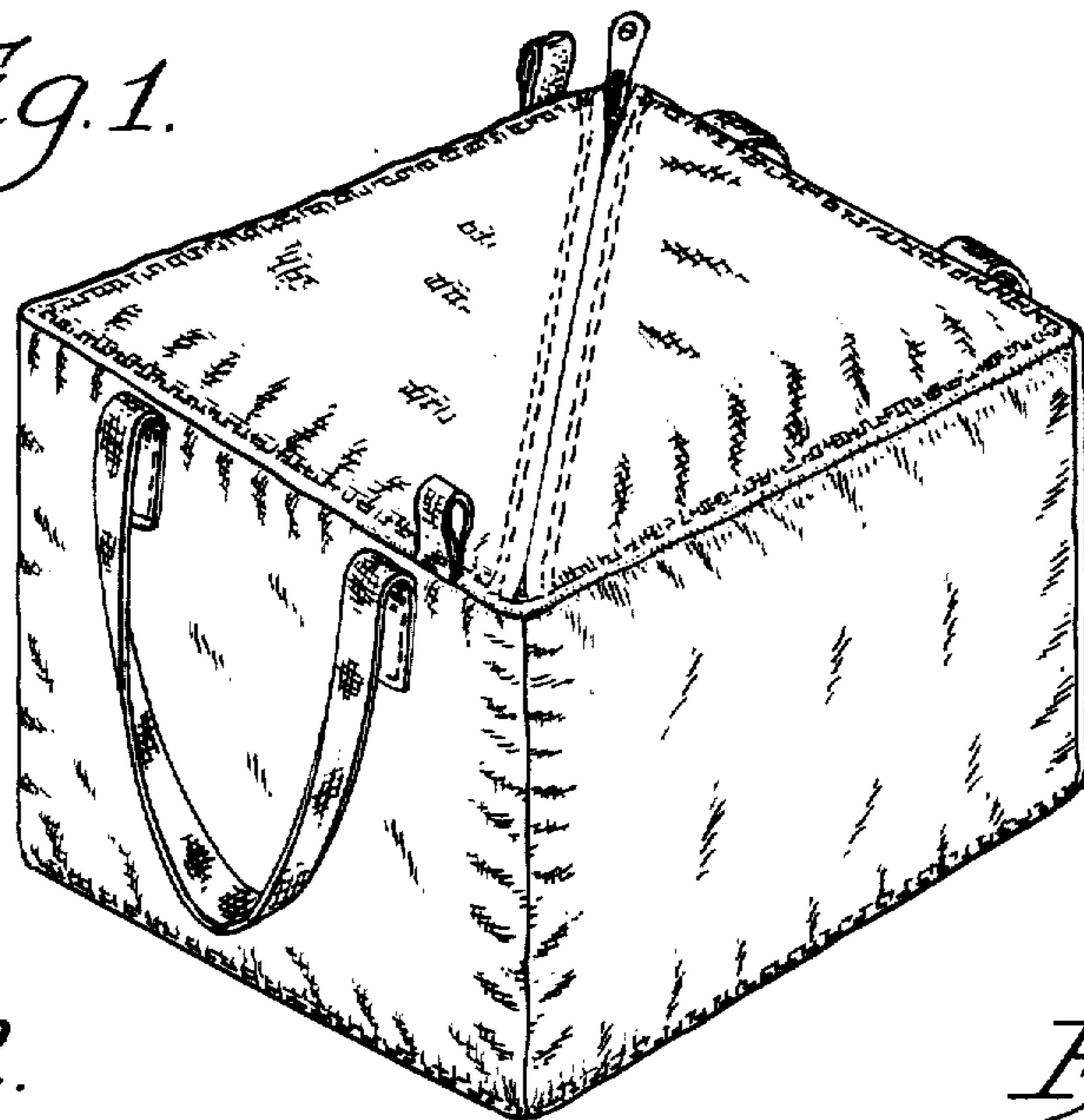

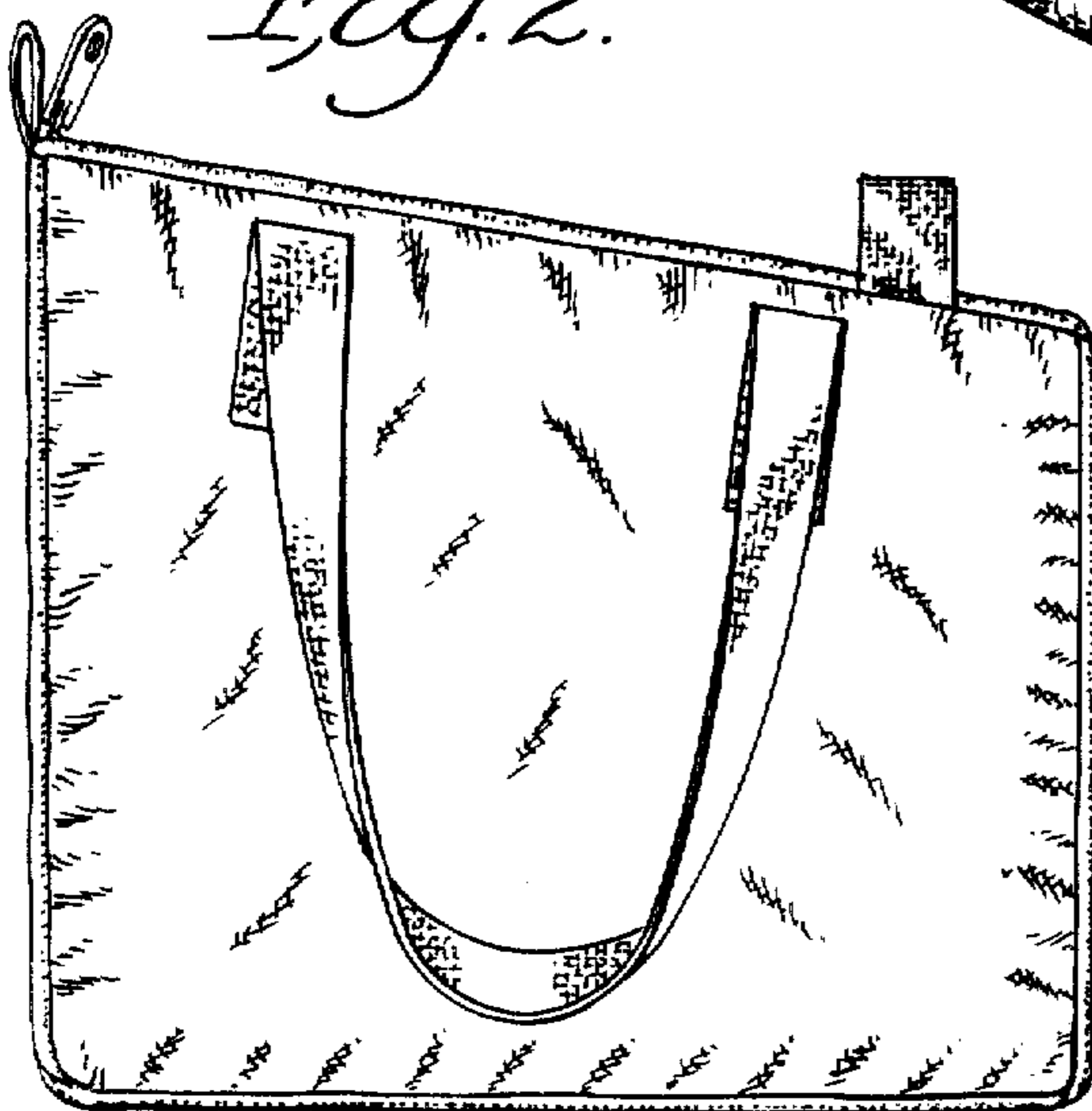

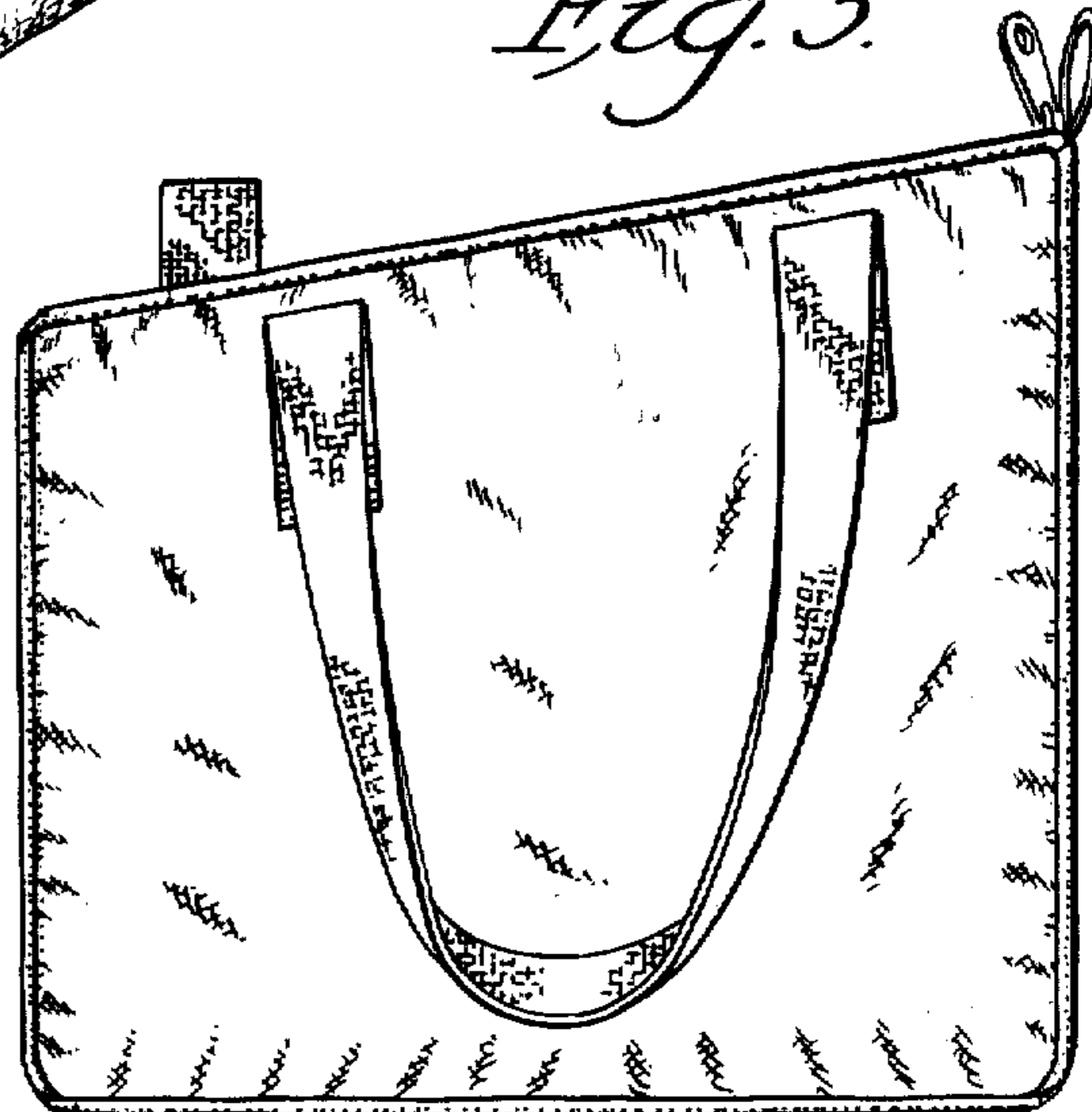

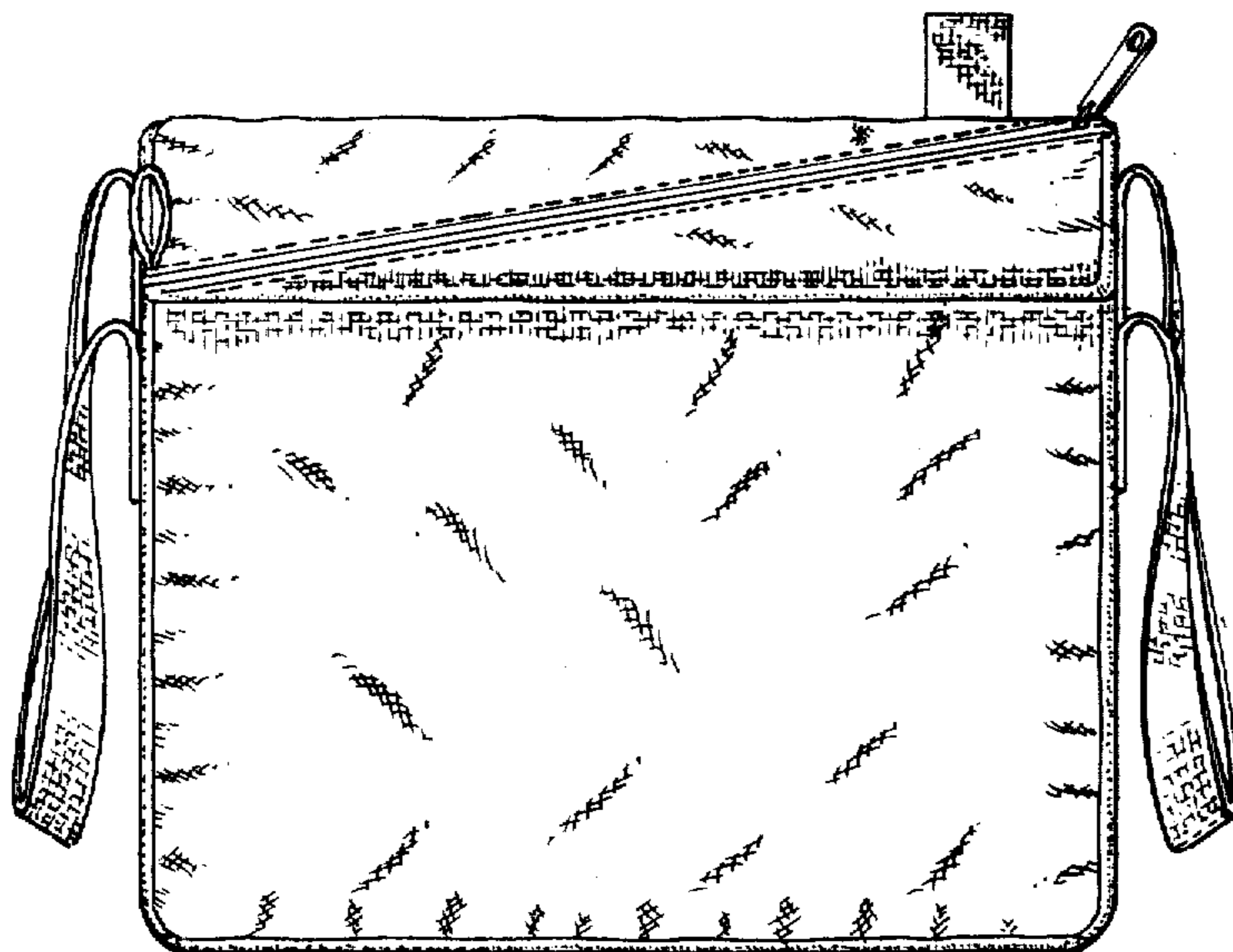

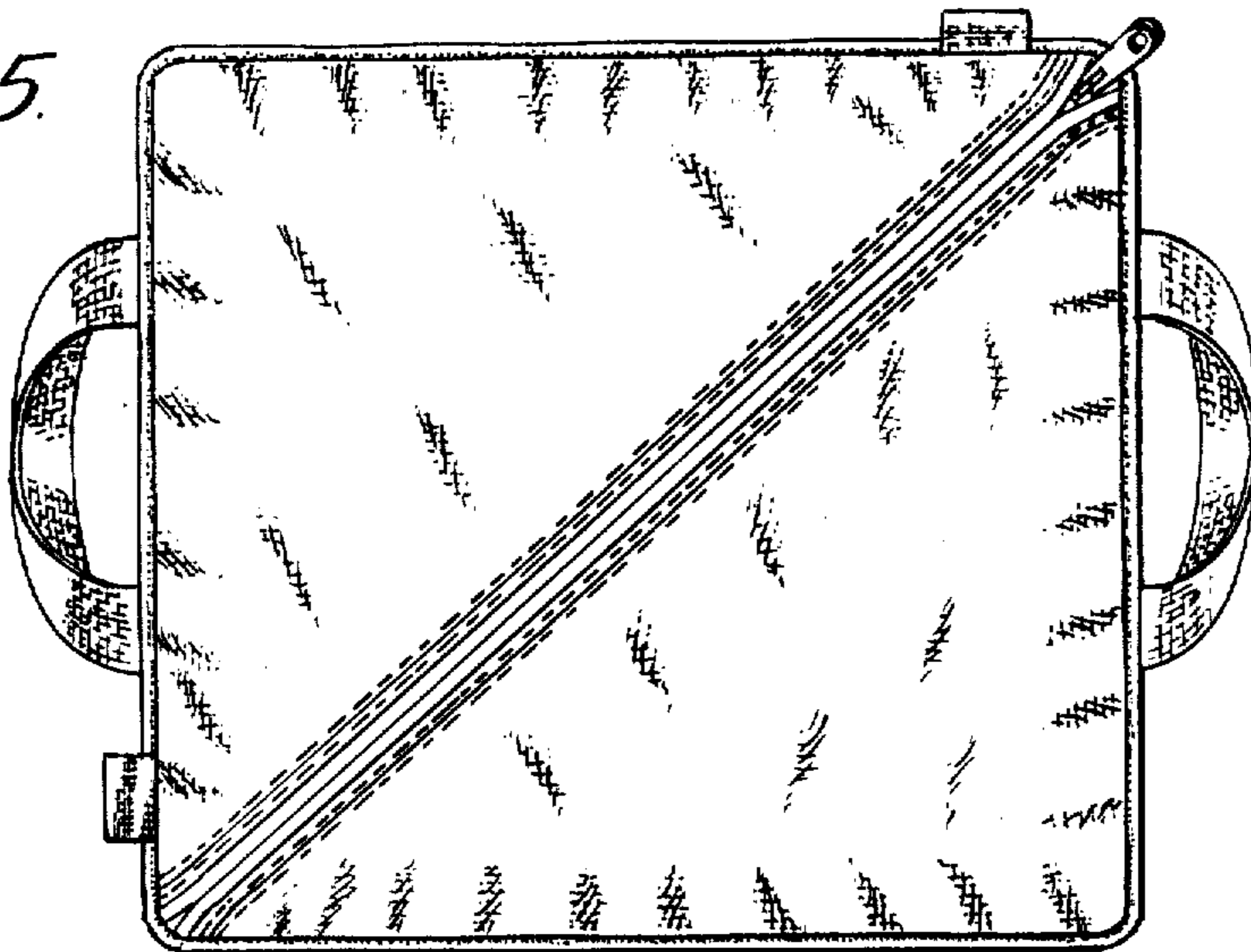

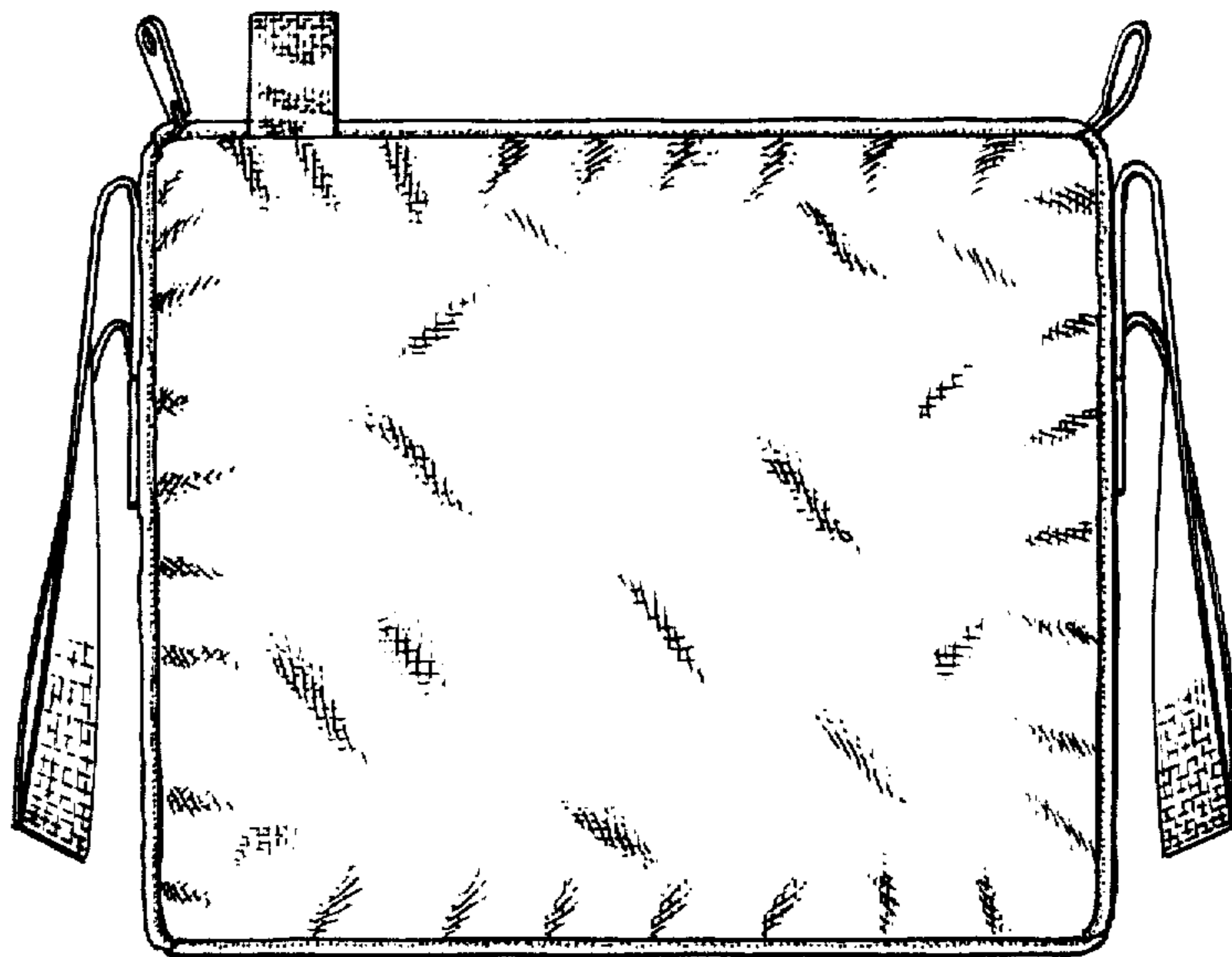
