The ornamental design for an athletic shoe with pocket, as shown and described.

**DESCRIPTION**

FIG. 1 is a right side elevational view of an athletic shoe with pocket showing my new design;  
 FIG. 2 is a top and right side perspective view thereof;  
 FIG. 3 is a right side elevational view of a second embodiment of my new design of FIGS. 1 and 2;  
 FIG. 4 is a front and top perspective view of FIG. 3;  
 FIG. 5 is a right side elevational view of a third embodiment of my new design of FIGS. 1 and 2;  
 FIG. 6 is a right side elevational view of a fourth embodiment of my new design of FIGS. 1 and 2.



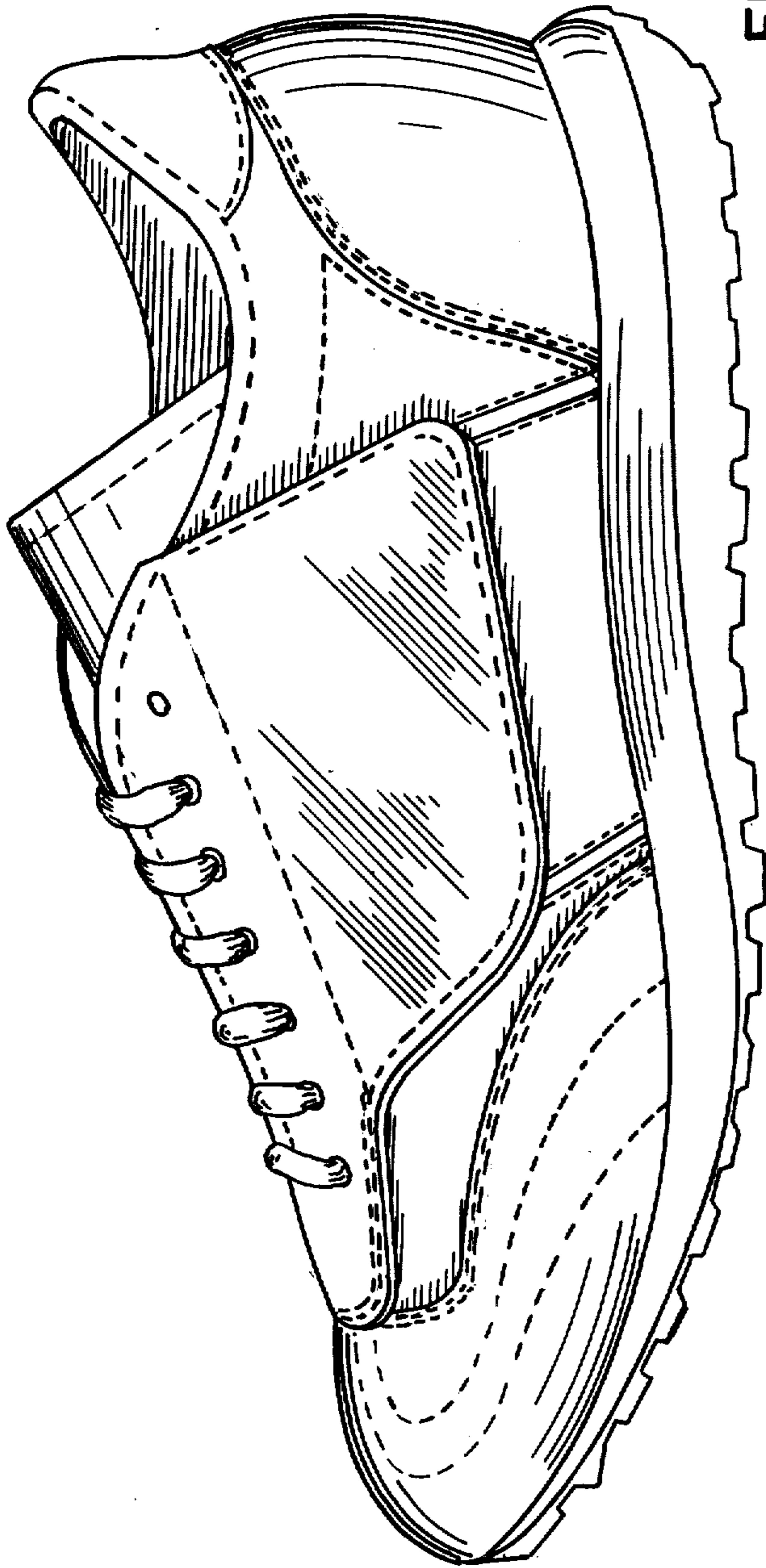

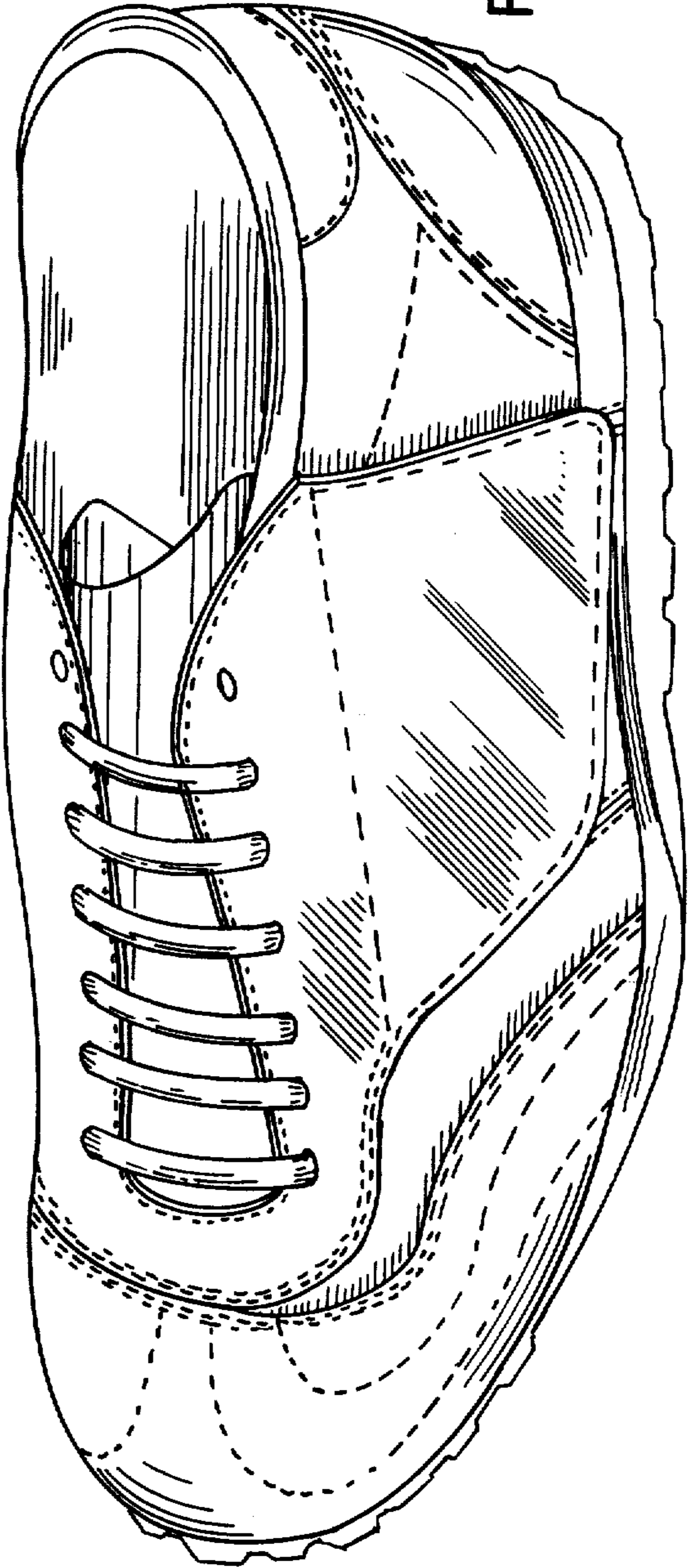

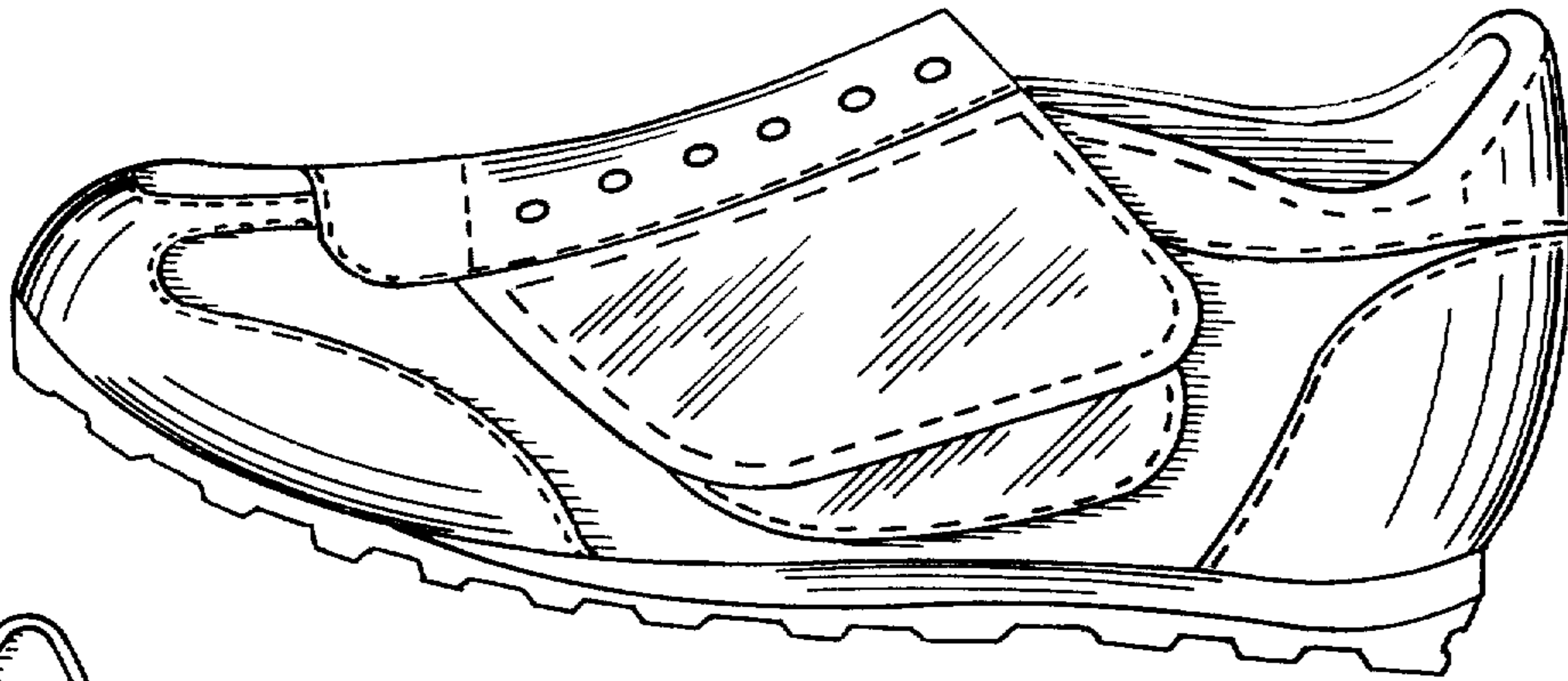

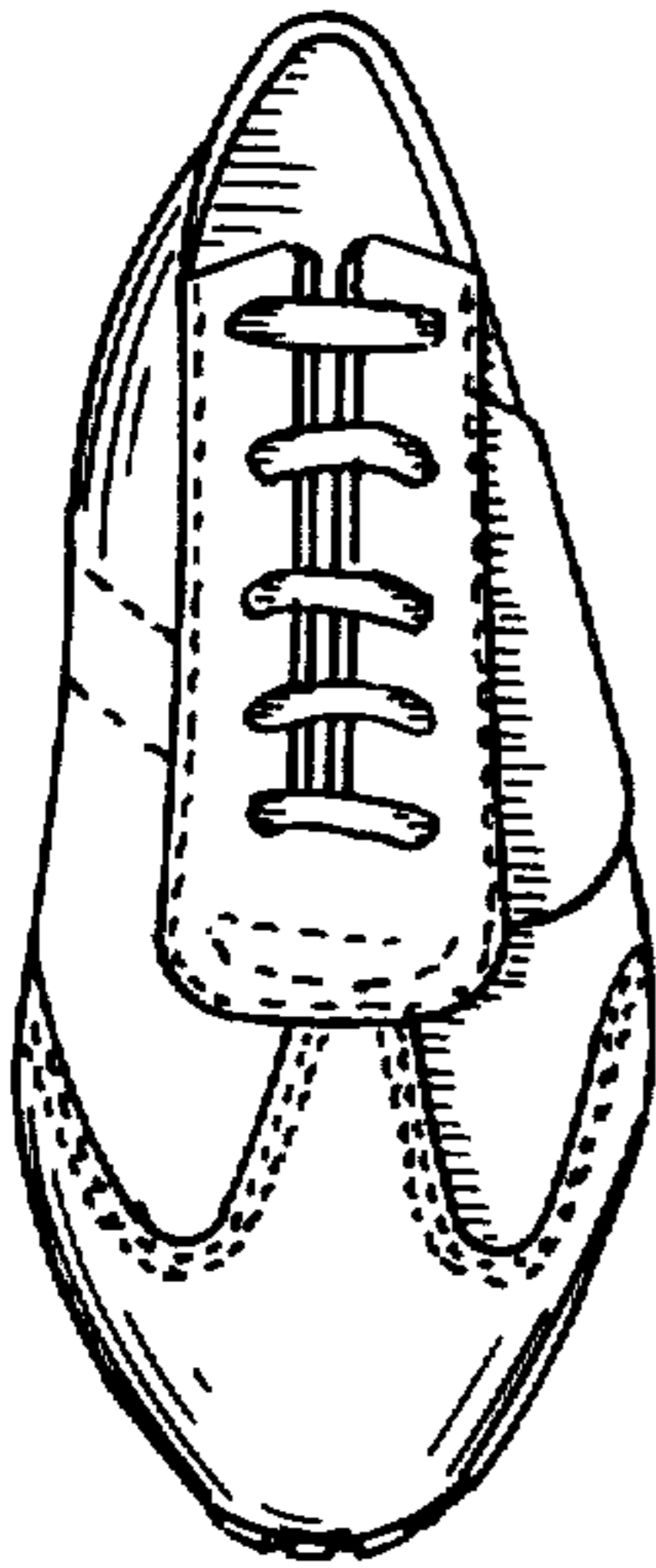

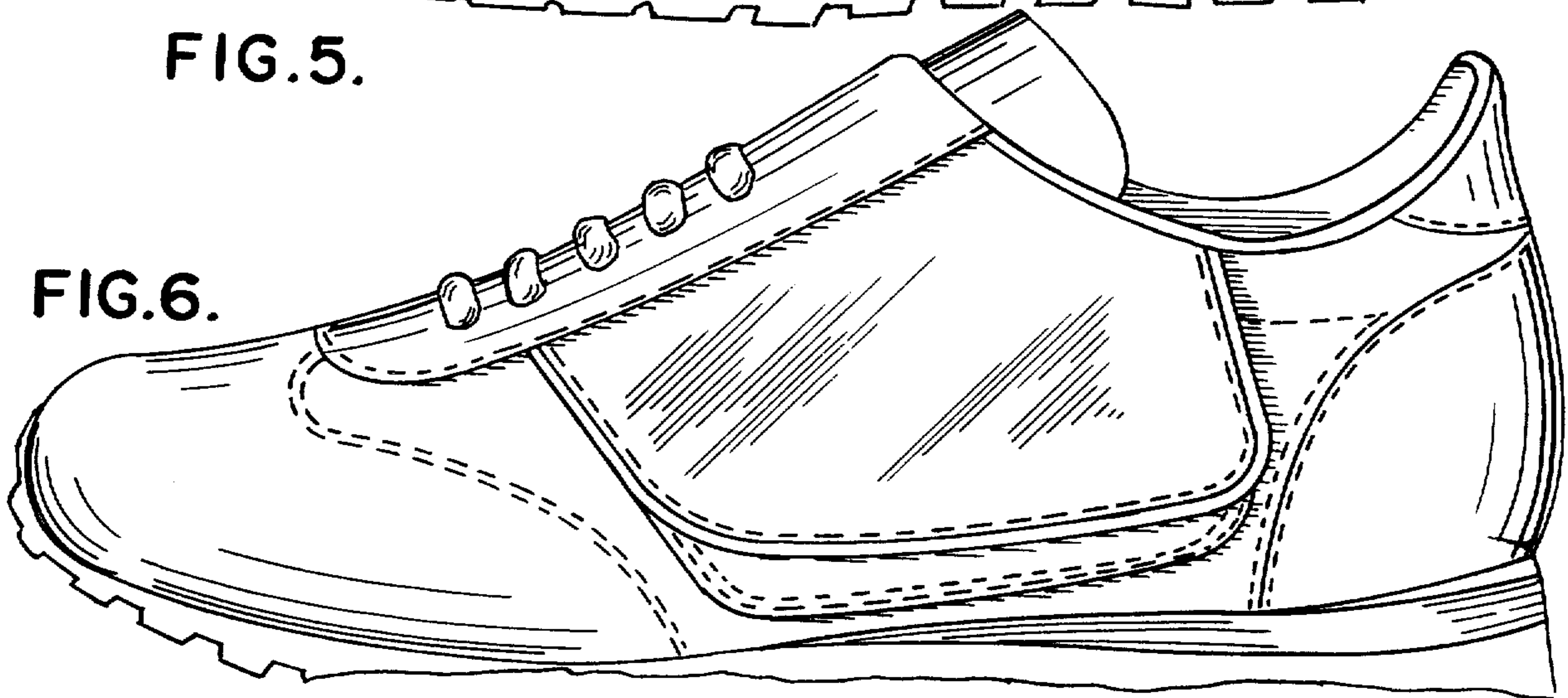
