the ornamental design for a wrist watch or the like, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a wrist watch showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a left side elevational view thereof; and
FIG. 8 is a top plan view of a second embodiment of my new design of FIGS. 1-6;
FIG. 9 is a top plan view of a third embodiment of my new design of FIGS. 1-6;
FIG. 10 is a top plan view of a fourth embodiment of my new design of FIGS. 1-6;
FIG. 11 is a top plan view of a fifth embodiment of my new design of FIGS. 1-6;
FIG. 12 is a top plan view of a sixth embodiment of my new design of FIGS. 1-6;
FIG. 13 is a top plan view of a seventh embodiment of my new design of FIGS. 1-6;
FIG. 14 is a top plan view of an eighth embodiment of my new design of FIGS. 1-6;
FIG. 15 is a top plan view of a ninth embodiment of my new design of FIGS. 1-6.
The bottom plan views of the second through ninth embodiments are identical to FIG. 3.

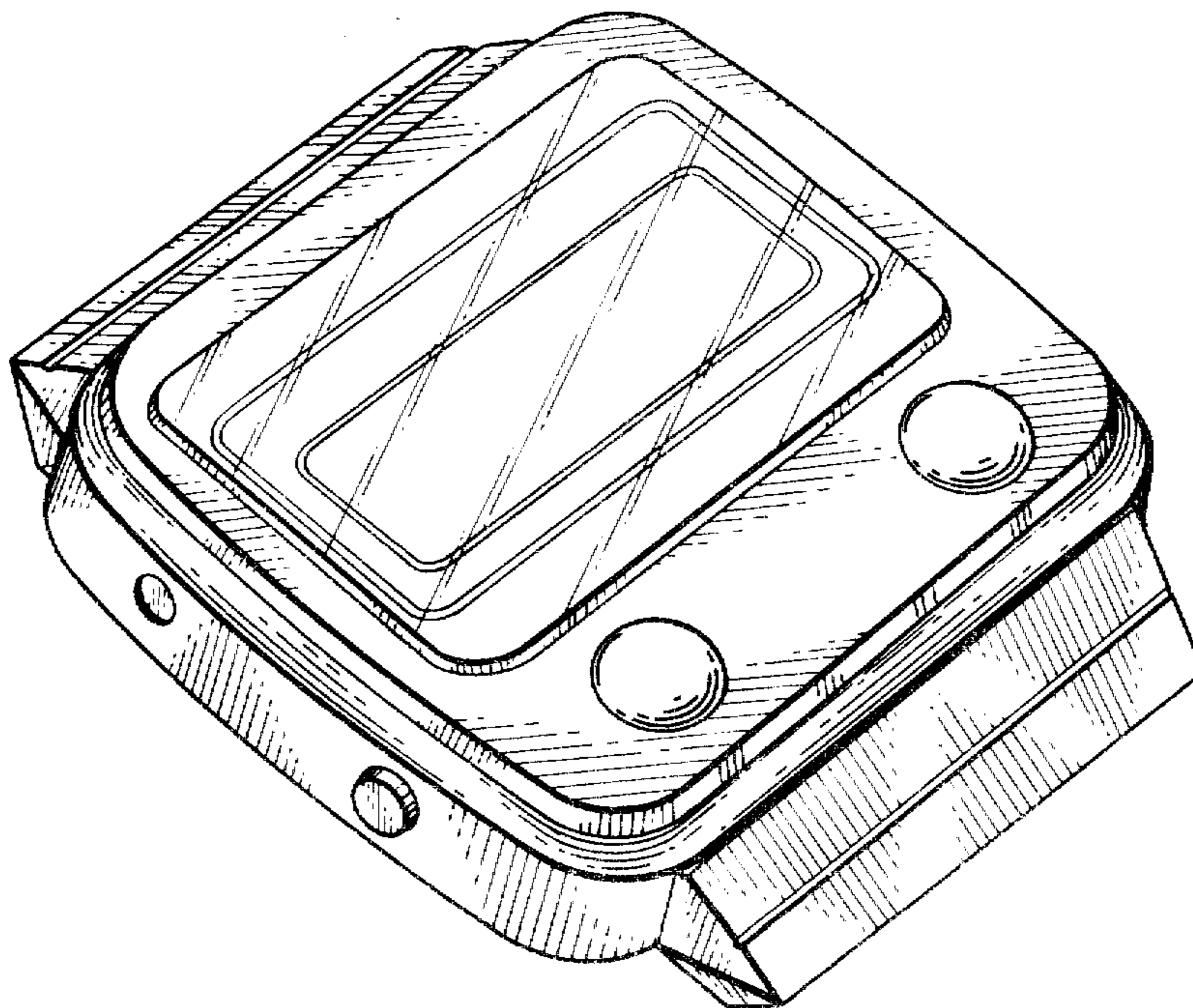

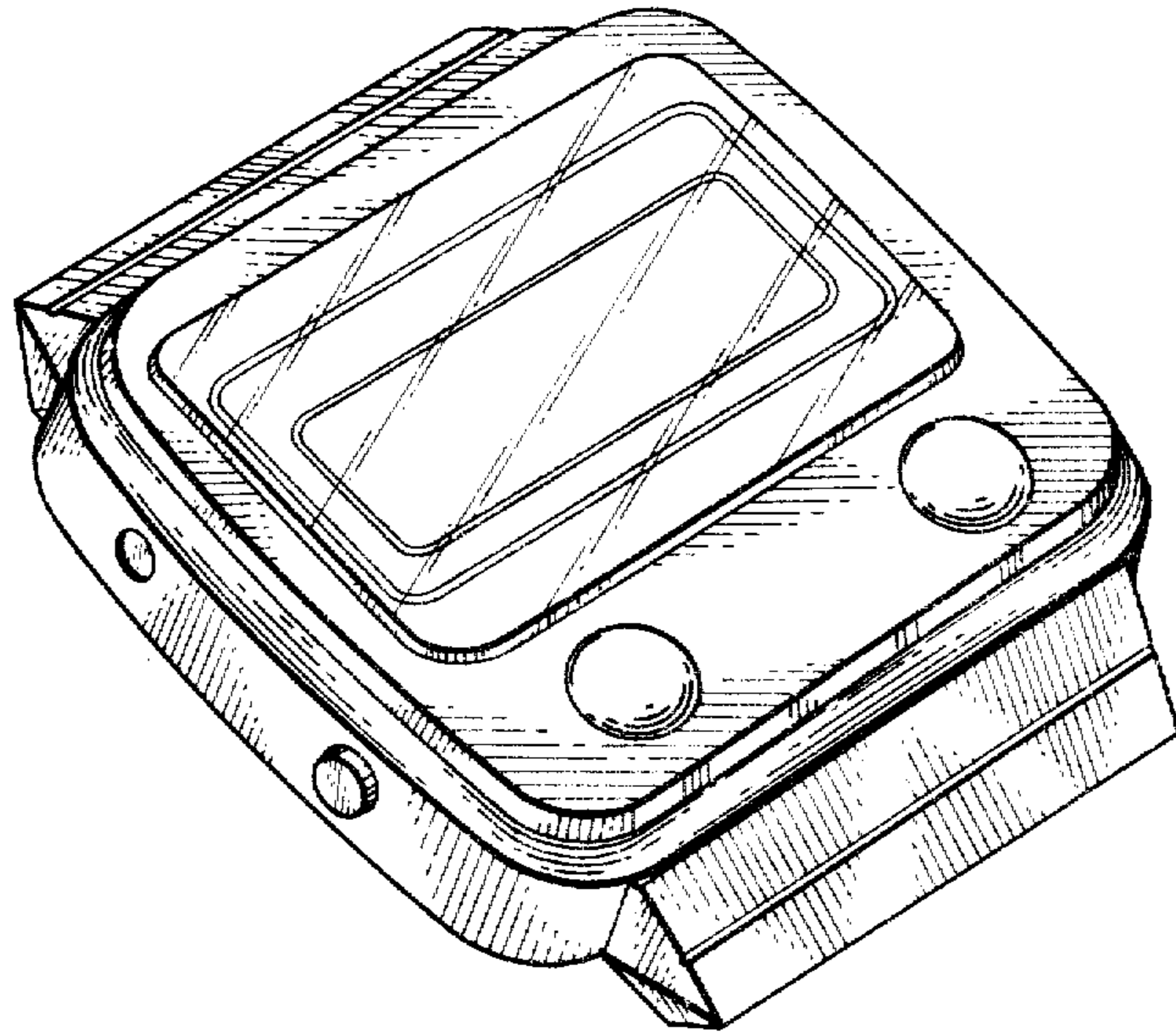

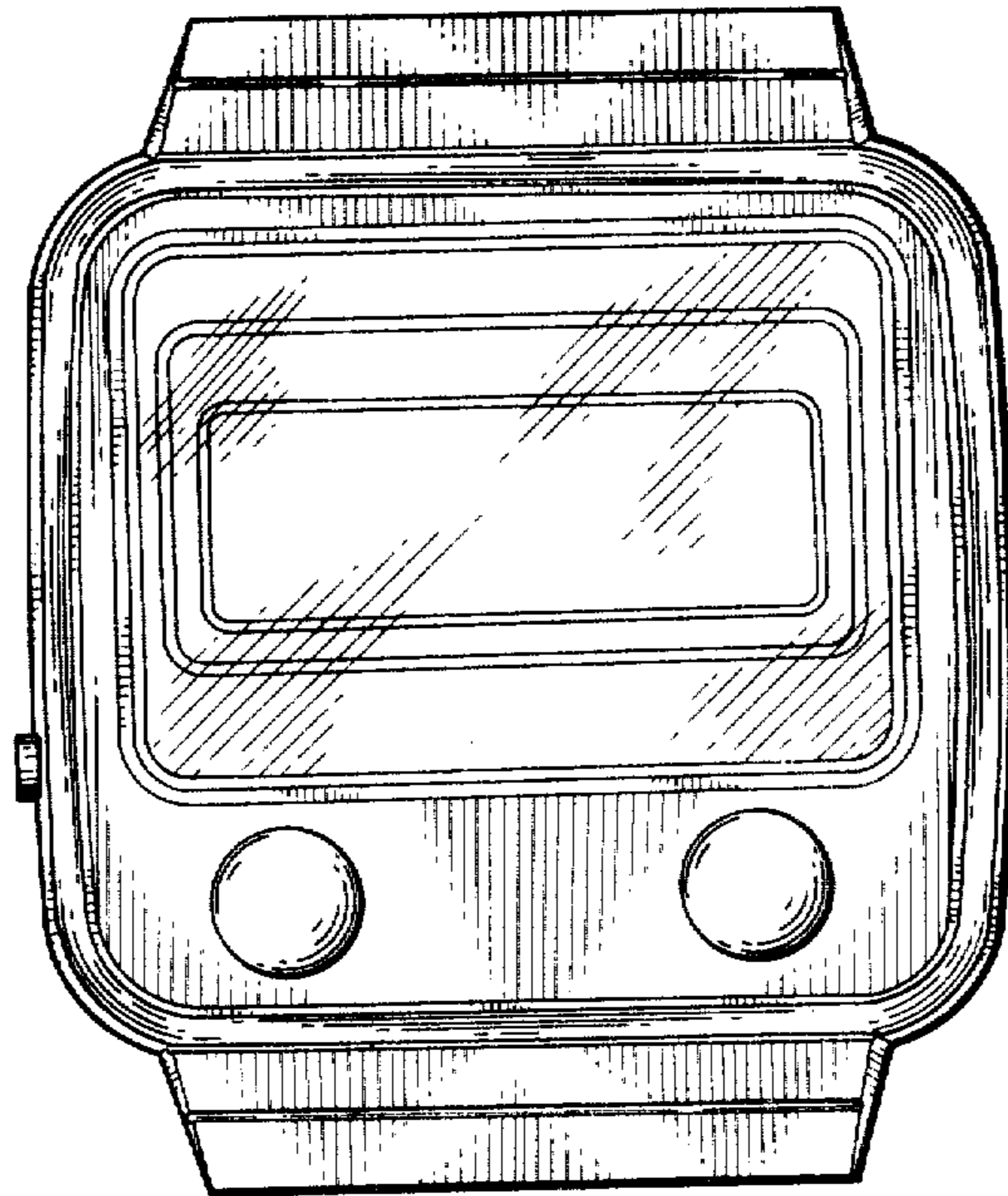

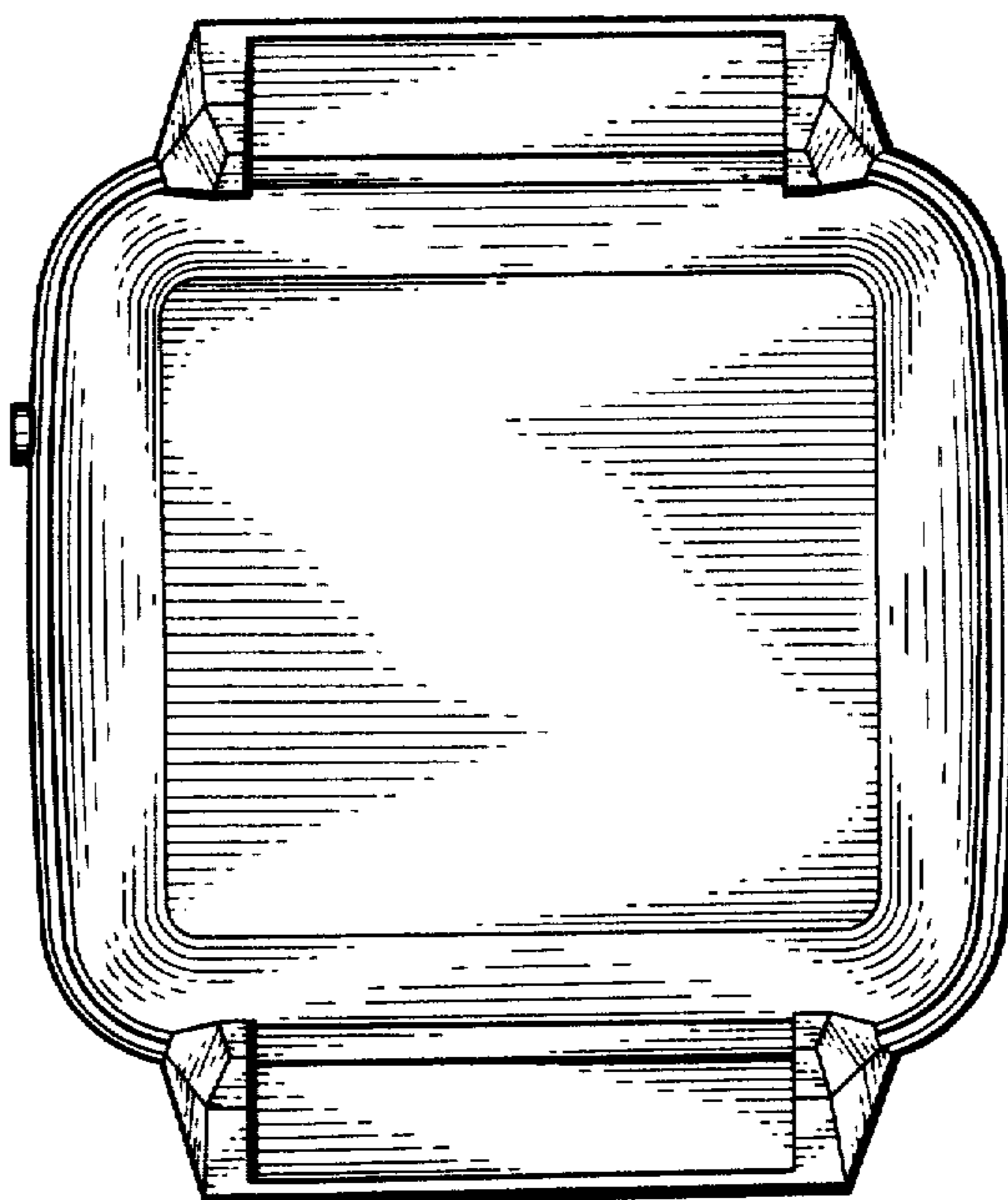

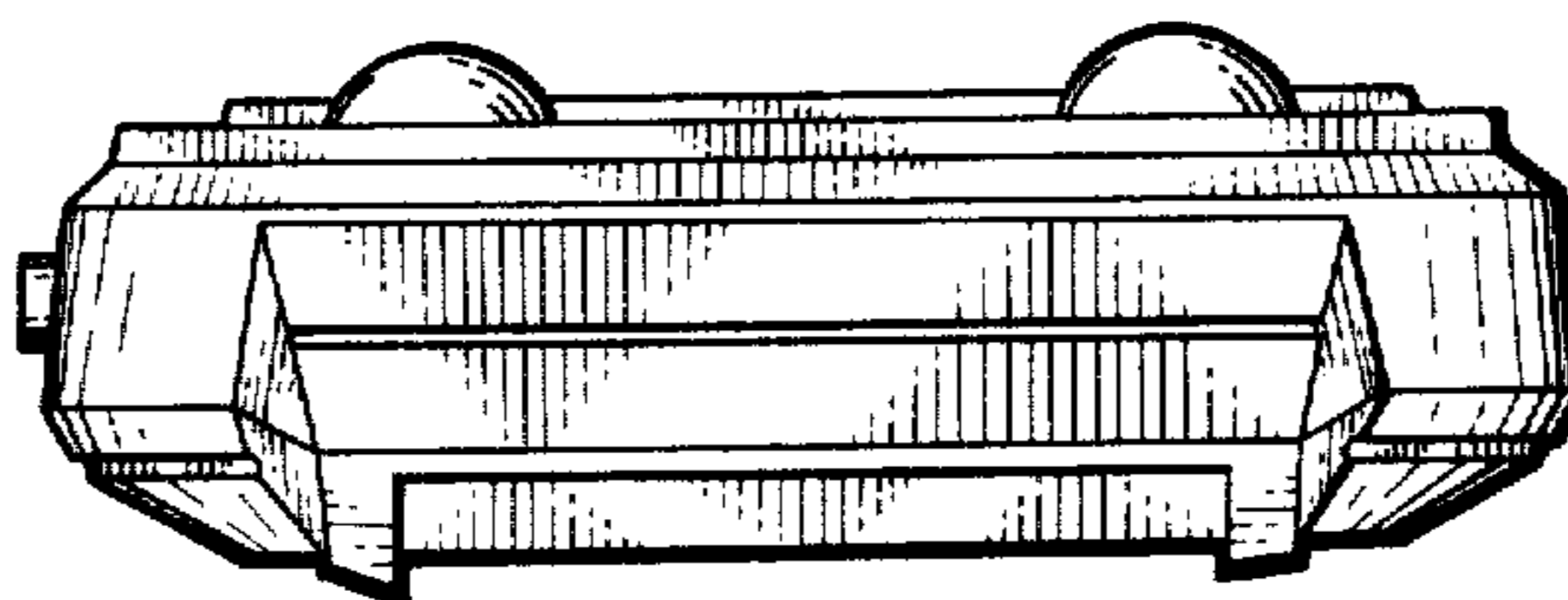

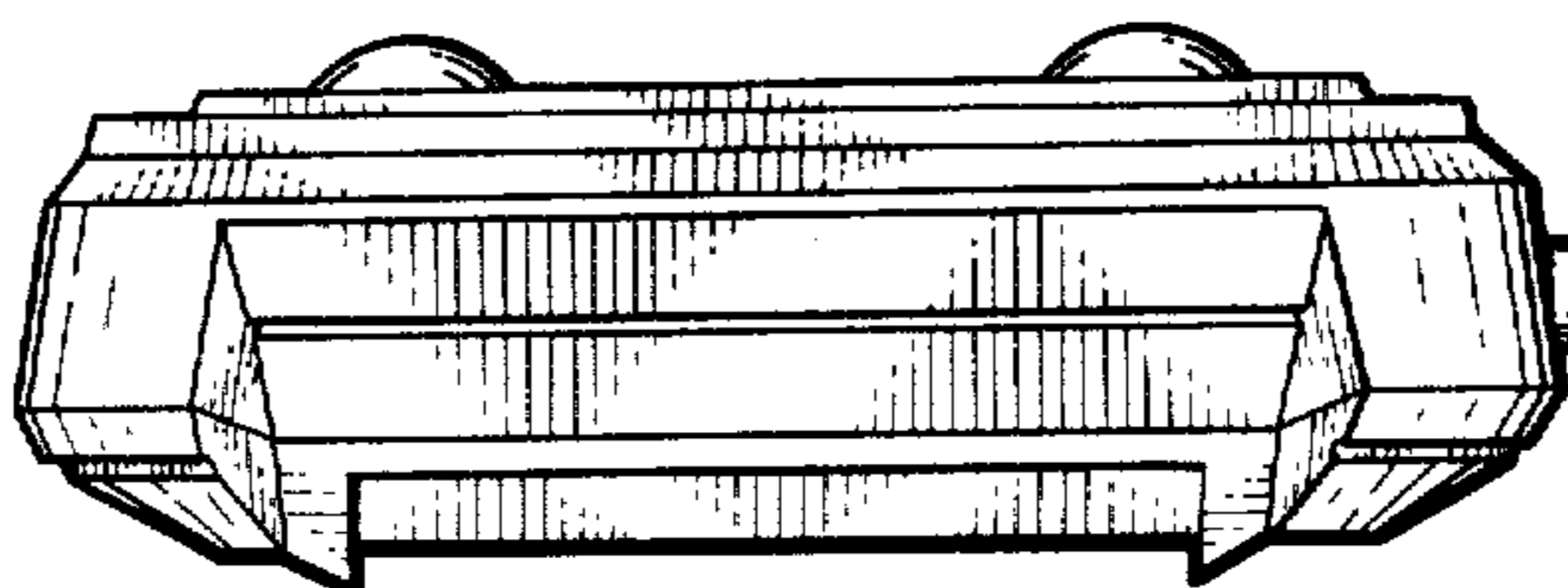

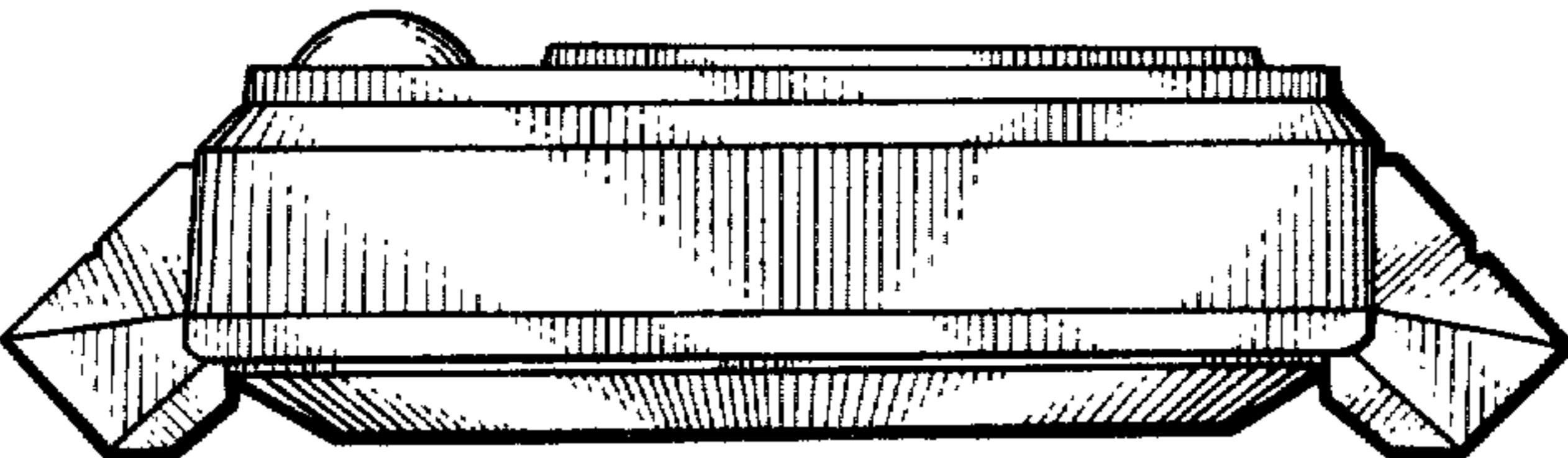

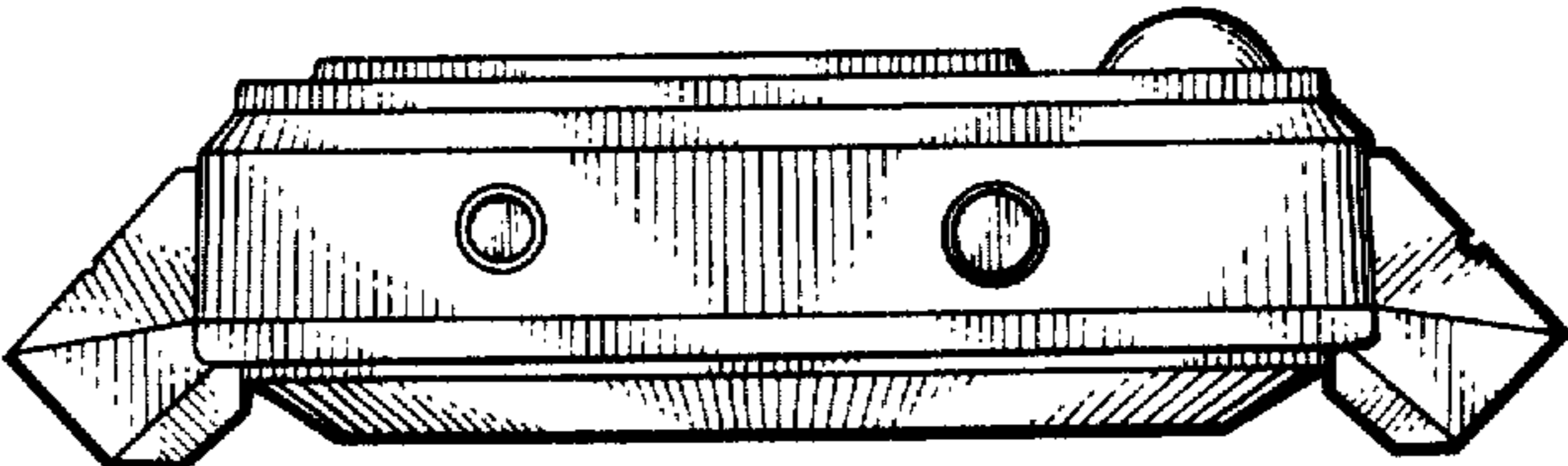

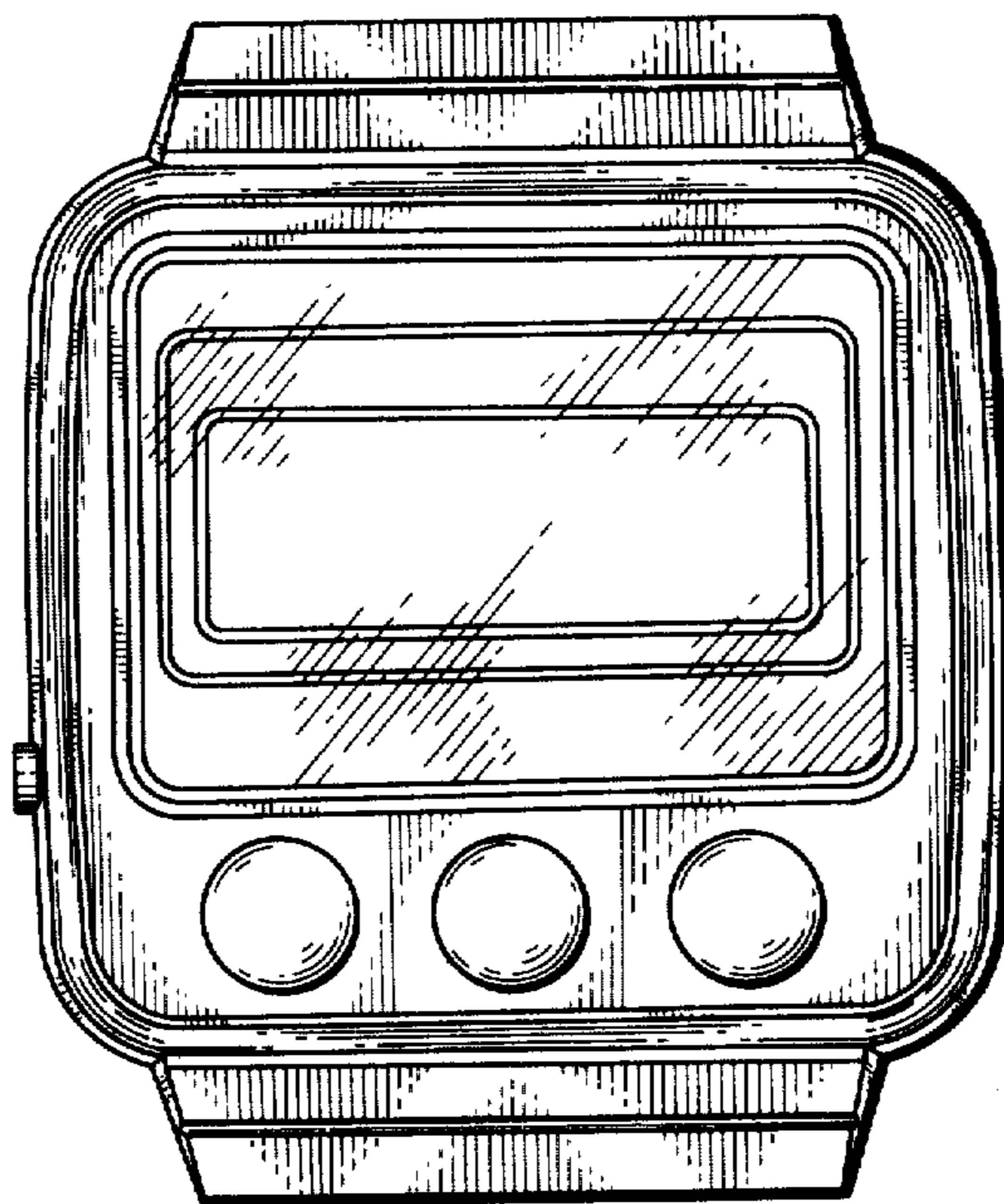

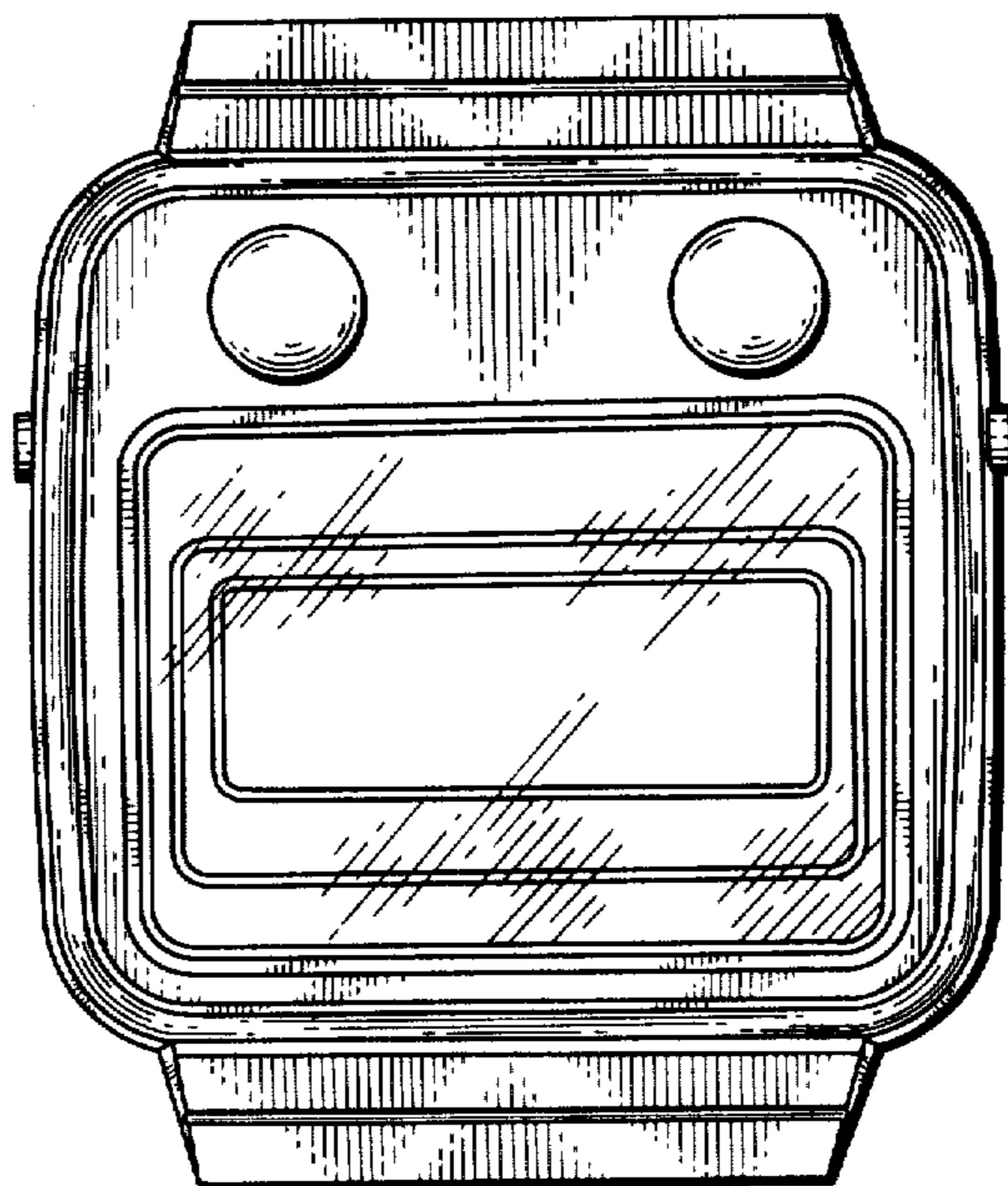

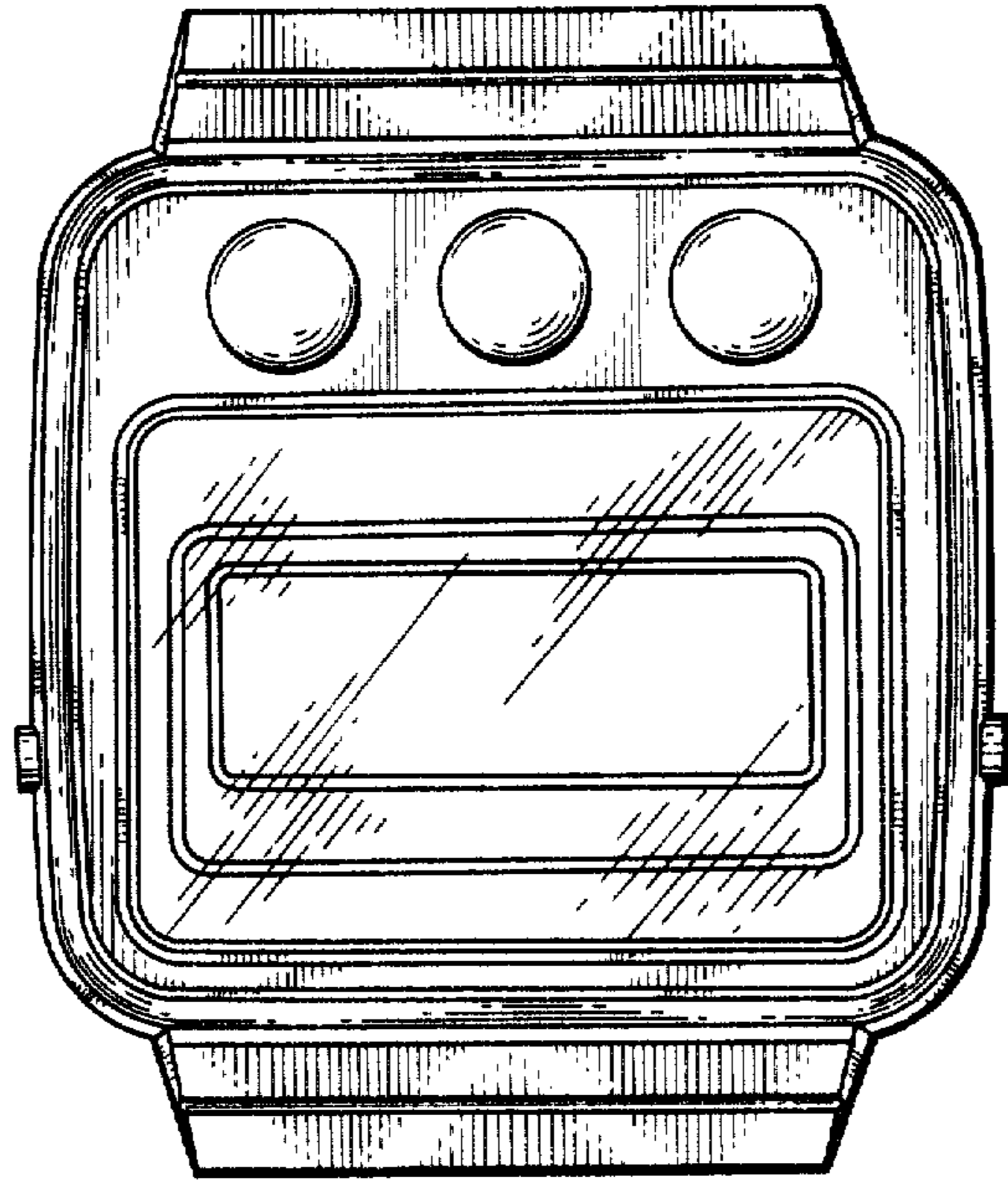

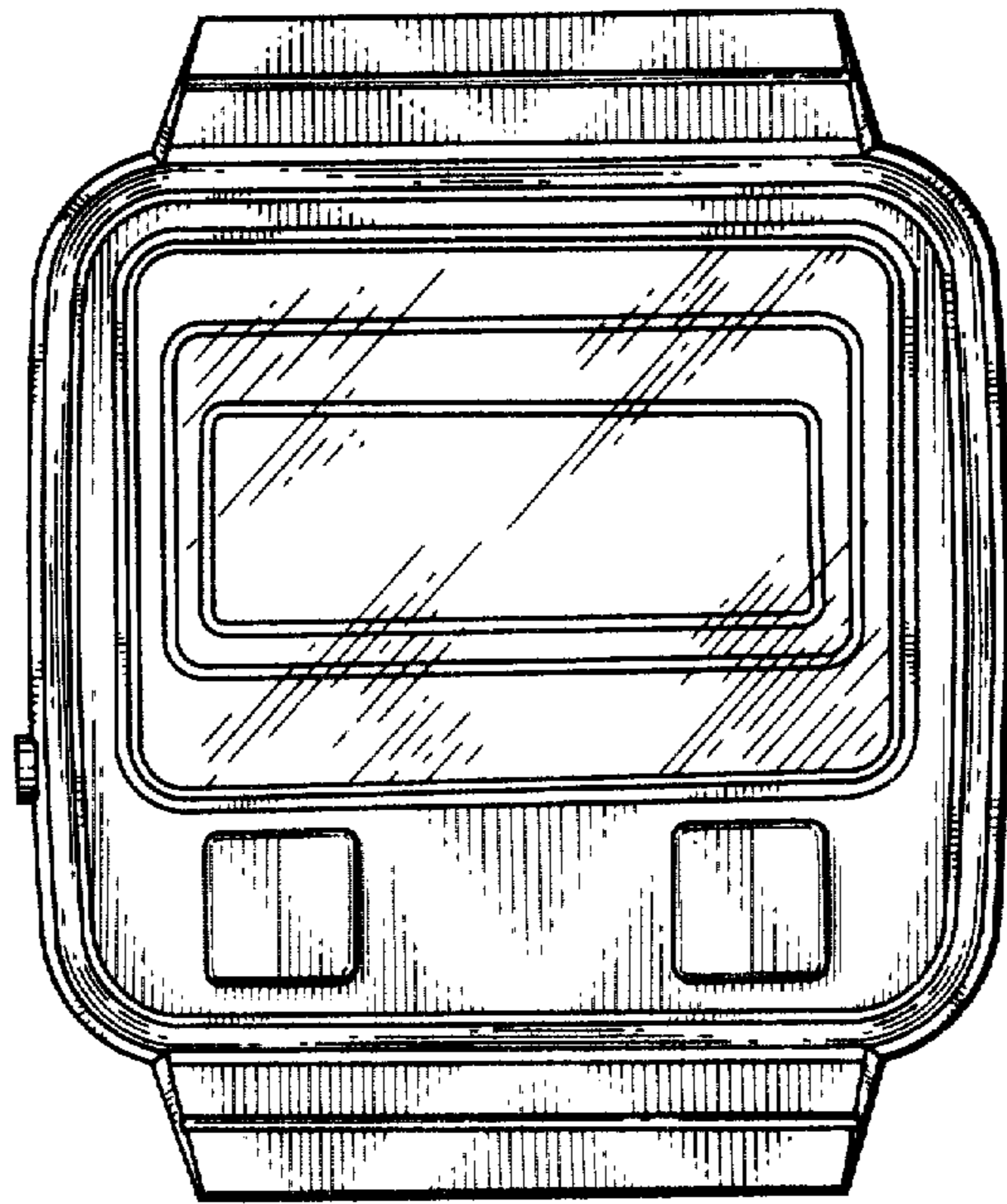

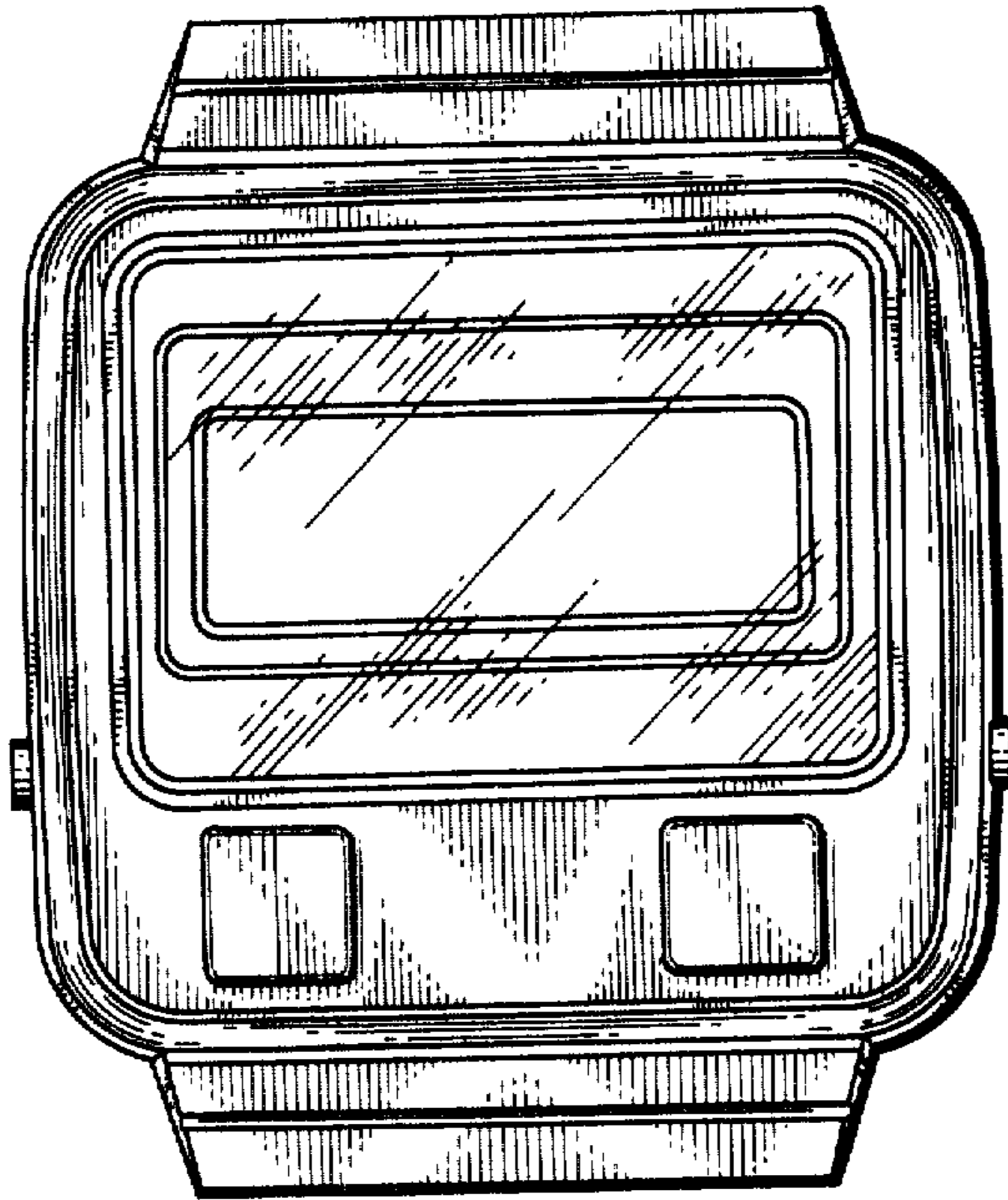

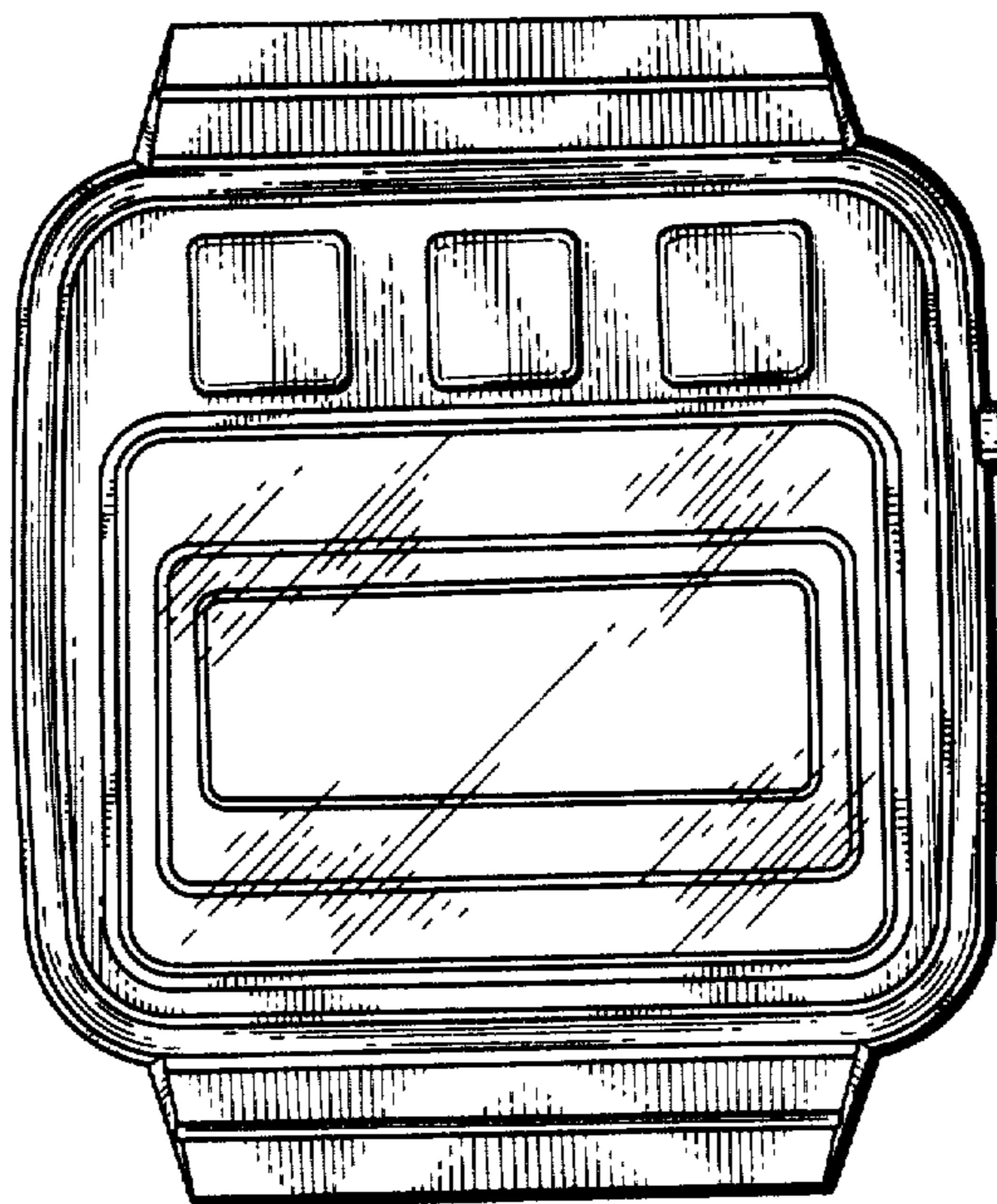

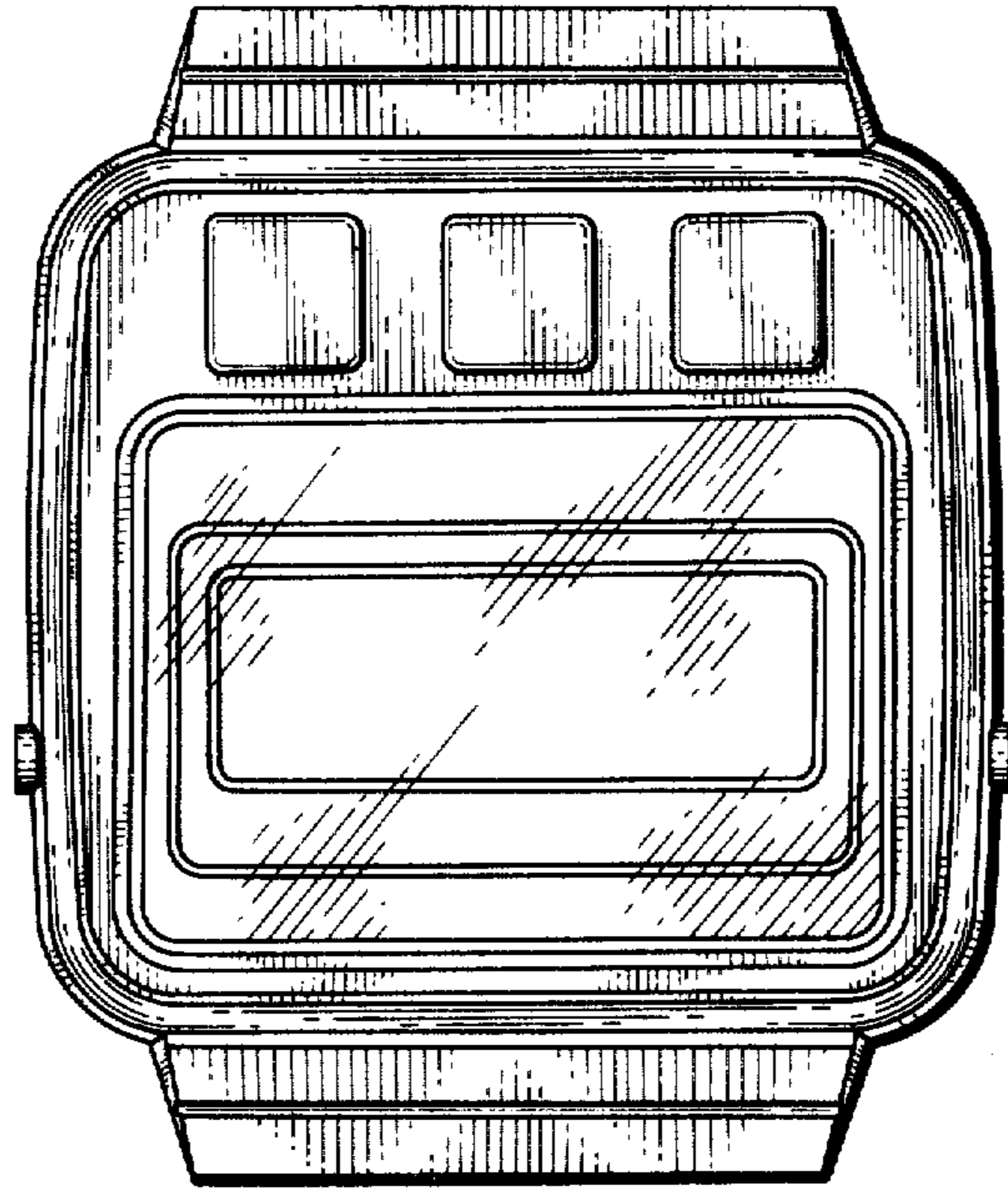
