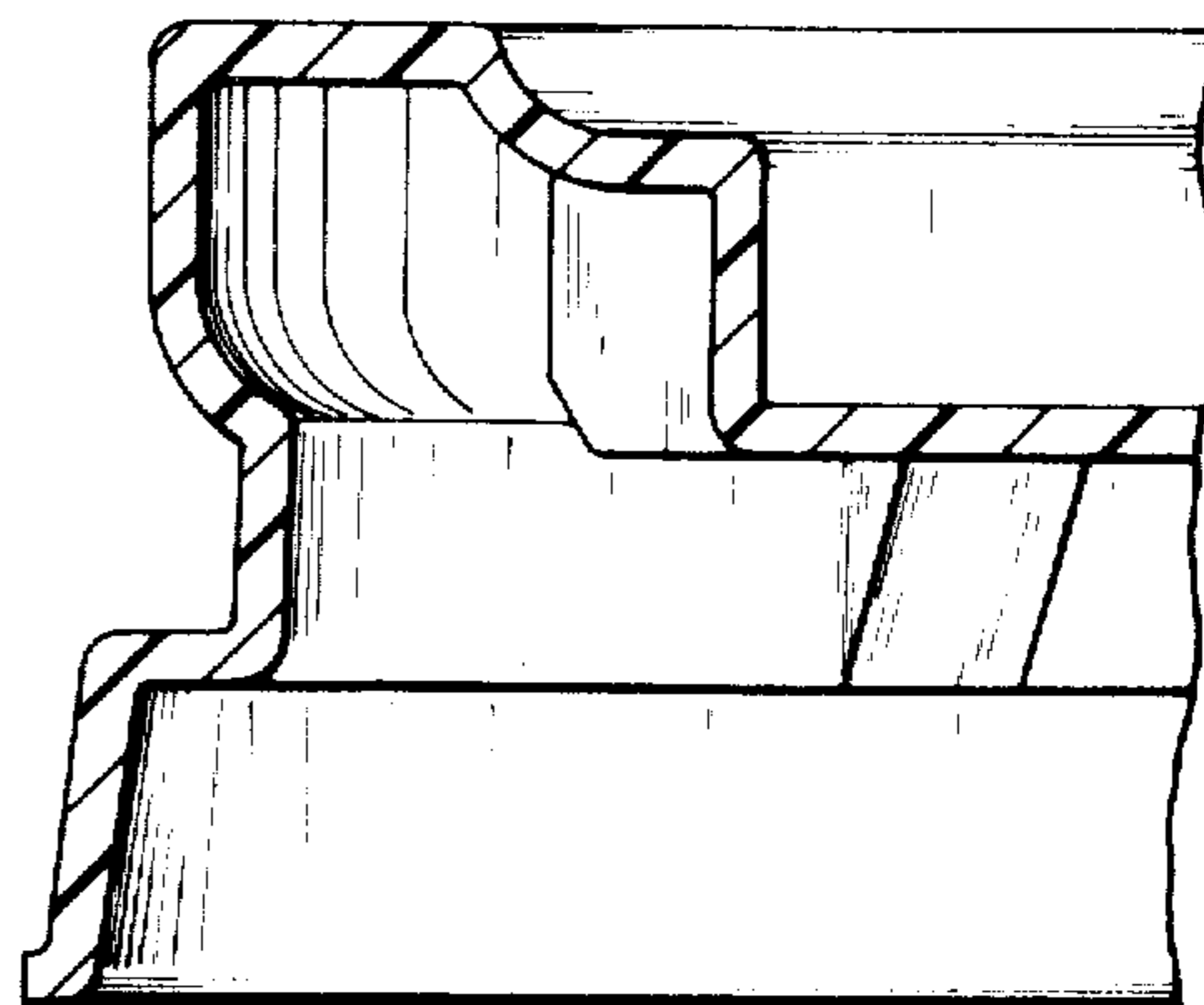
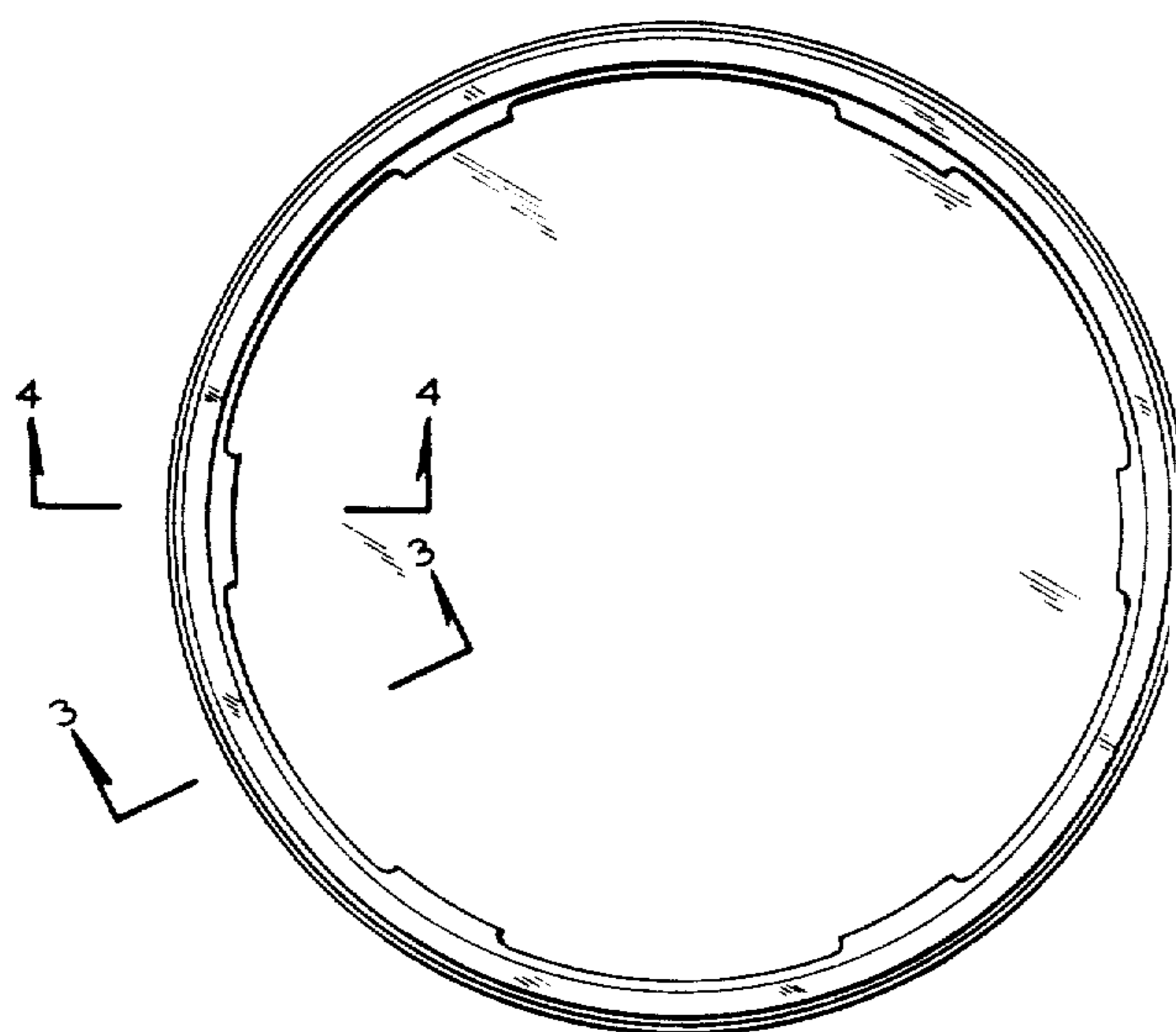

The ornamental design for a closure or similar article, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a closure or similar article showing my new design;  
 FIG. 2 is a side elevational view thereof;  
 FIG. 3 is an enlarged fragmentary sectional view taken along line 3—3 of FIG. 1; and  
 FIG. 4 is an enlarged fragmentary sectional view taken on the line 4—4 in FIG. 1.



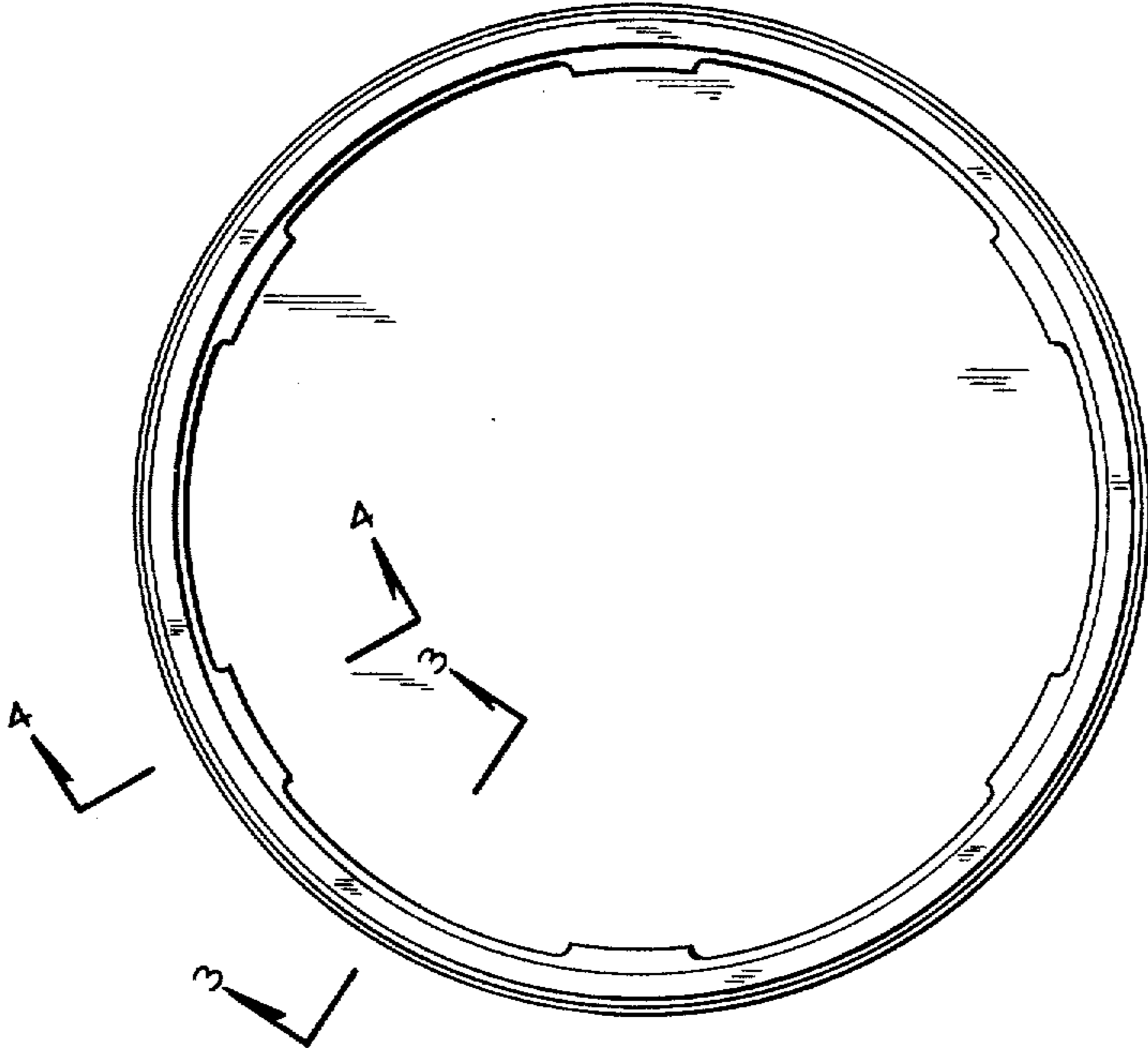

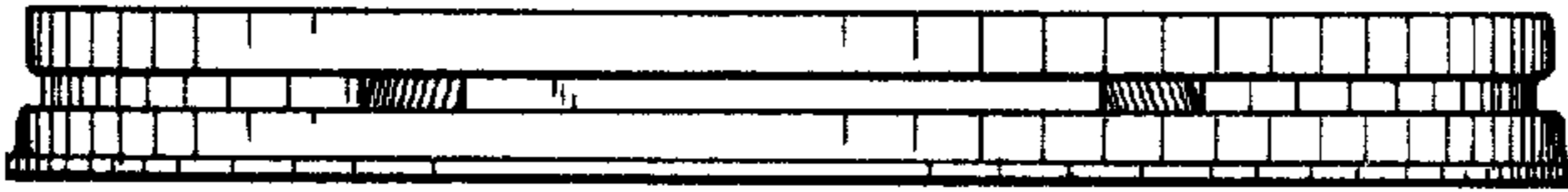

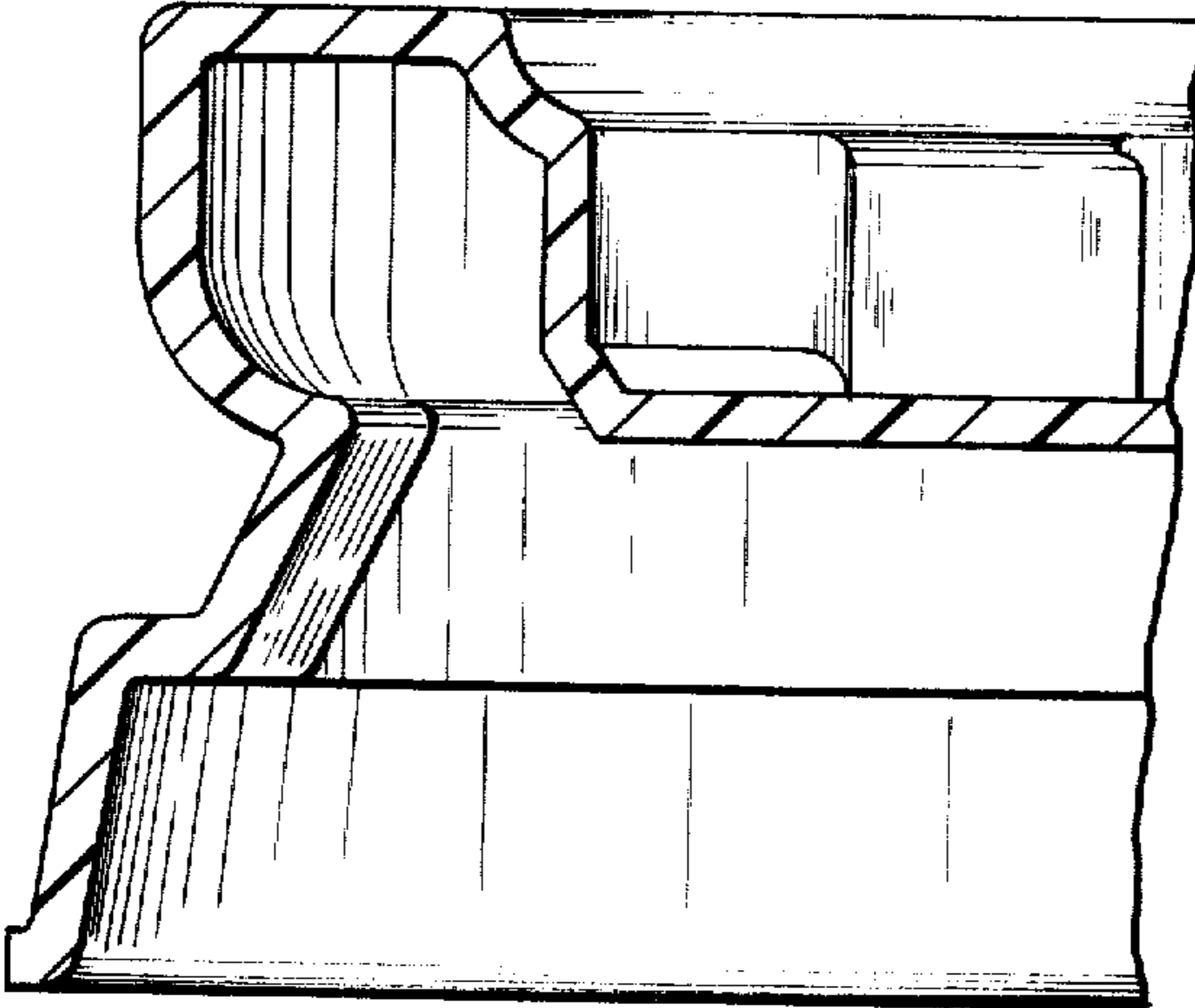

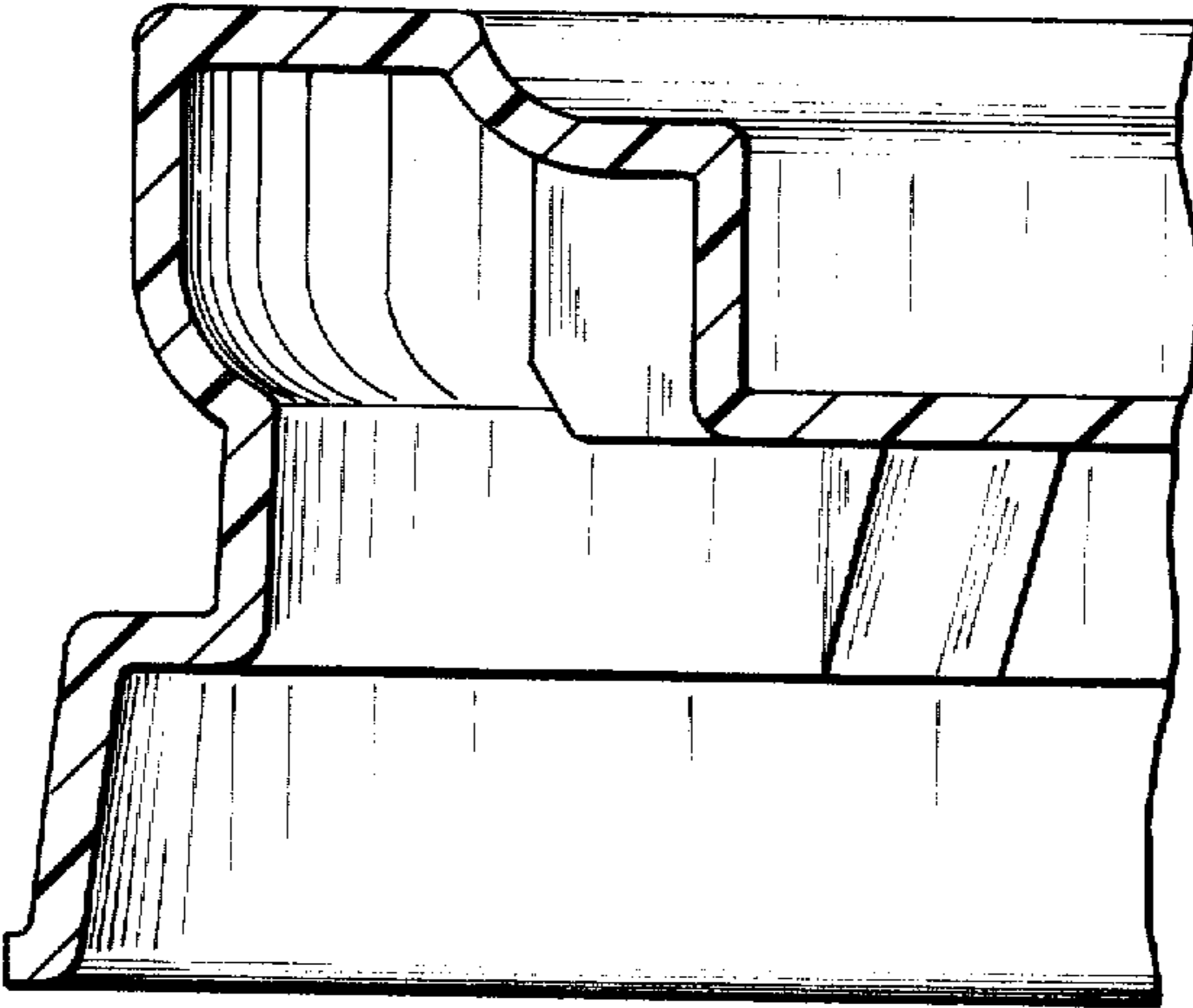
