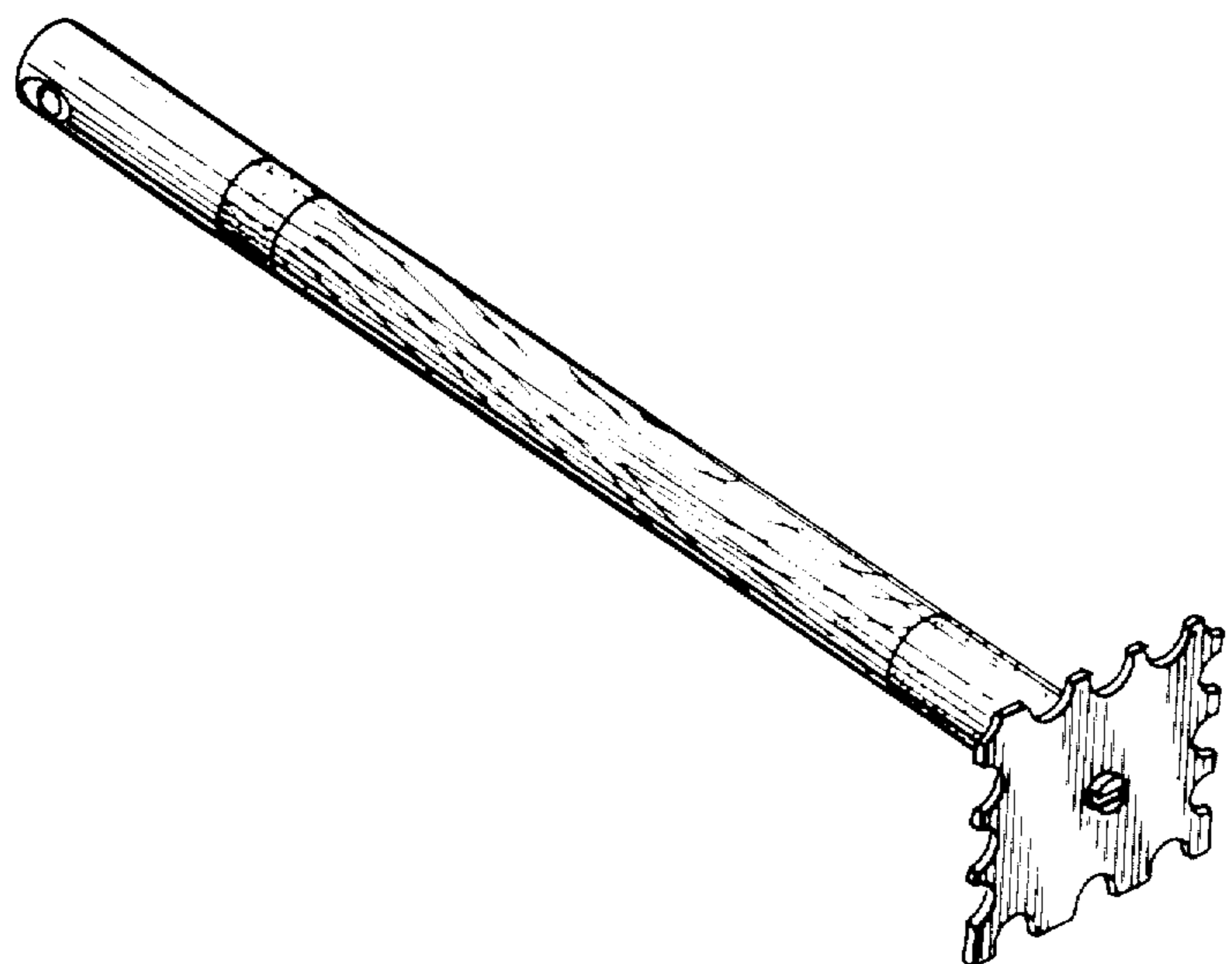

The ornamental design for a barbeque grill cleaner, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a barbeque grill cleaner, showing my new design;
 FIG. 2 is an enlarged right end elevational view thereof;
 FIG. 3 is an enlarged left end elevational view thereof;
 FIG. 4 is an elevational view taken from the top of FIG. 2;
 FIG. 5 is an elevational view taken from the bottom of FIG. 2;
 FIG. 6 is an elevational view taken from the right of FIG. 2;
 FIG. 7 is an elevational view taken from the left of FIG. 2;
 FIG. 8 is a perspective view of a second embodiment of a barbecue grill cleaner;
 FIG. 9 is an enlarged right end elevational view thereof;
 FIG. 10 is an enlarged left end elevational view thereof;
 FIG. 11 is an elevational view taken from the top of FIG. 9;
 FIG. 12 is an elevational view taken from the bottom of FIG. 9;
 FIG. 13 is an elevational view taken from the right side of FIG. 9;
 FIG. 14 is an elevational view taken from the left side of FIG. 9.



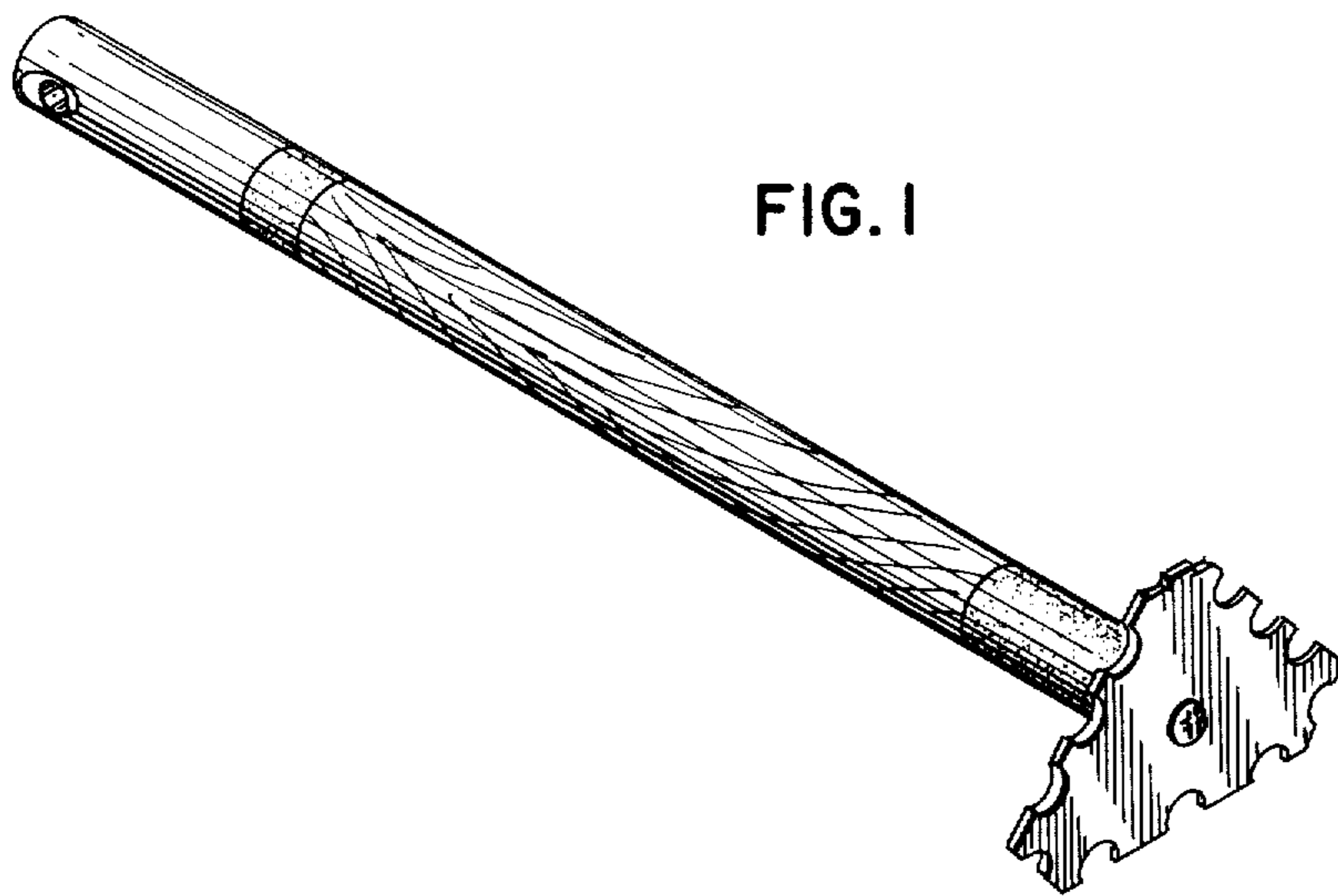

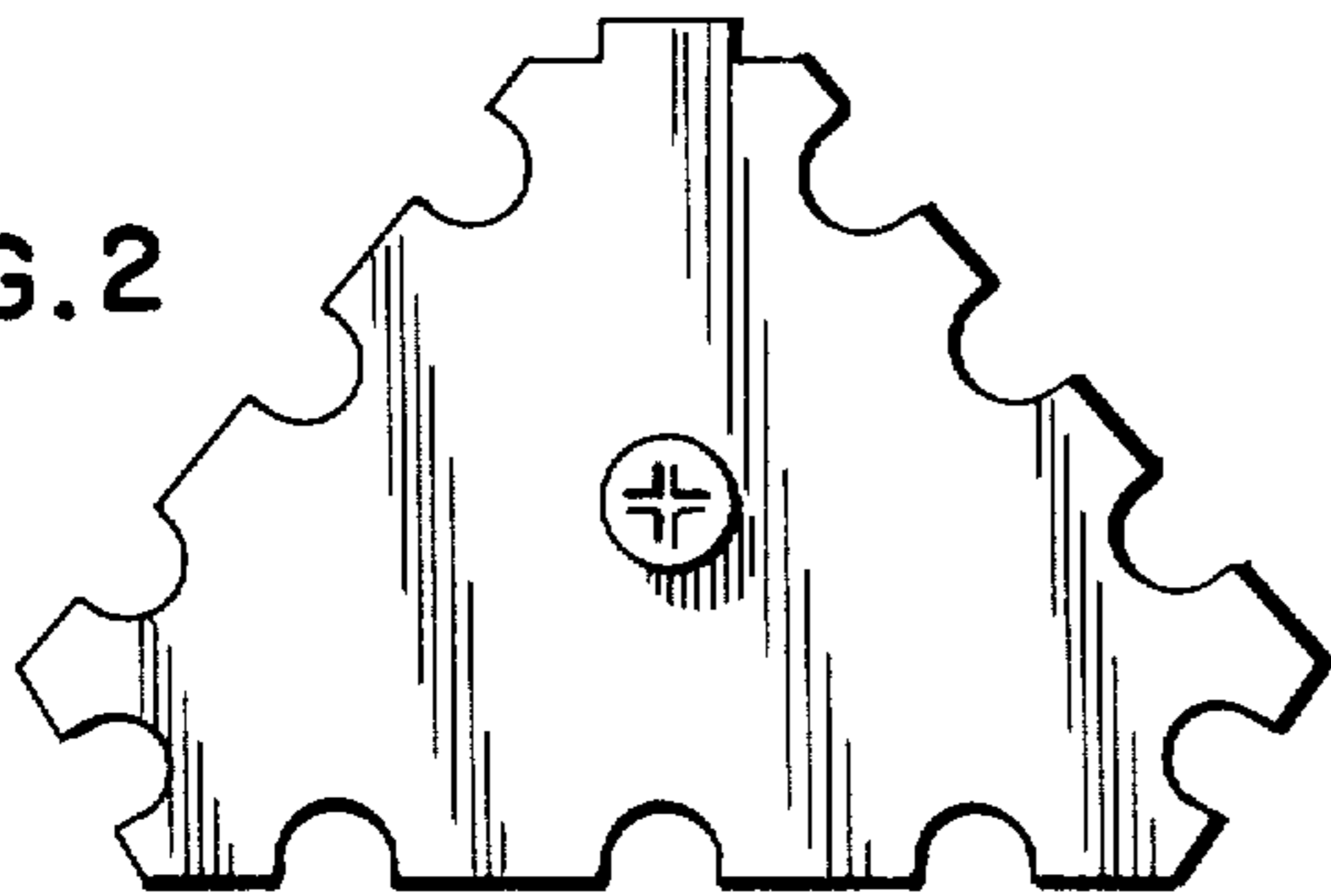

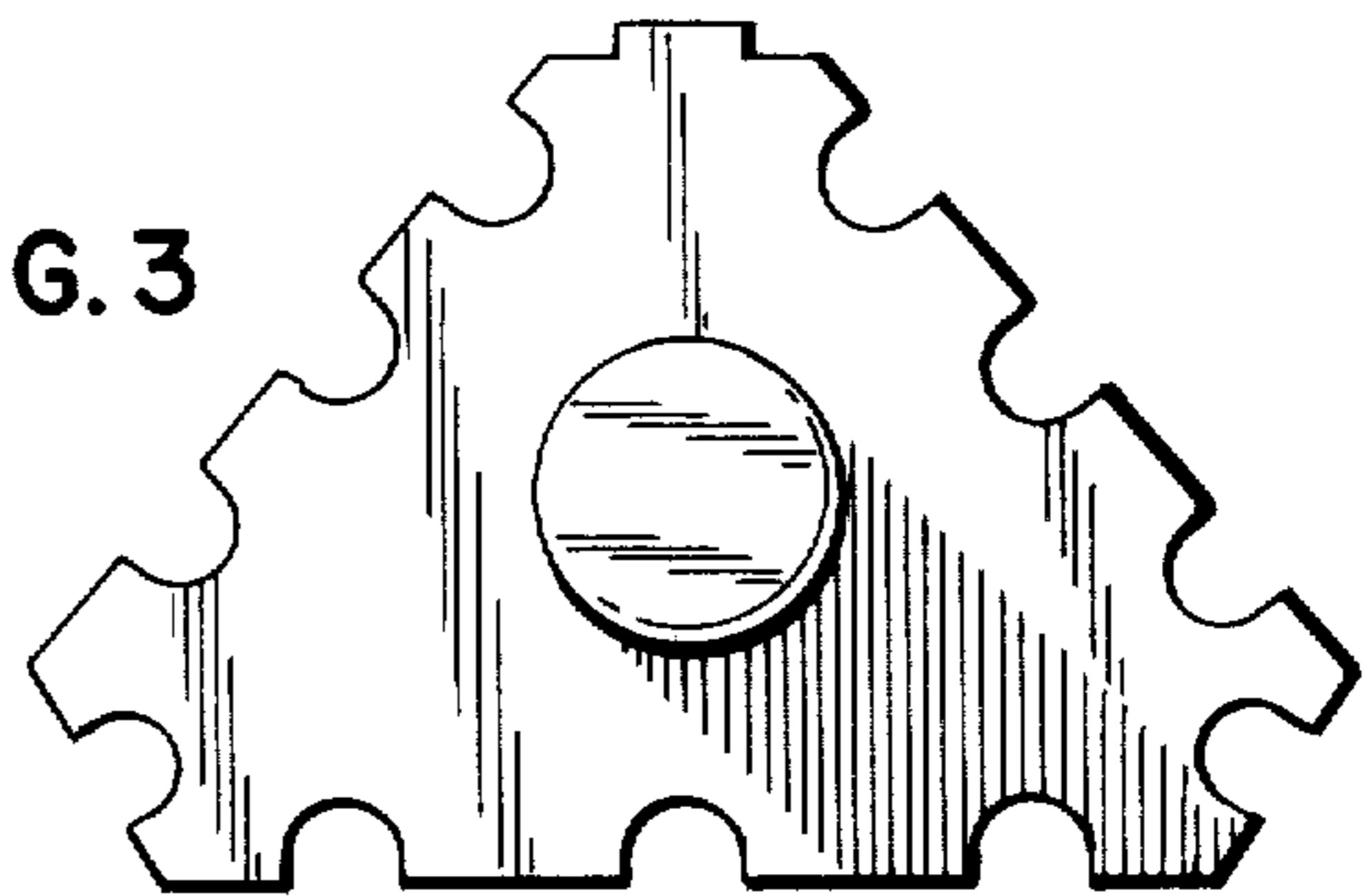

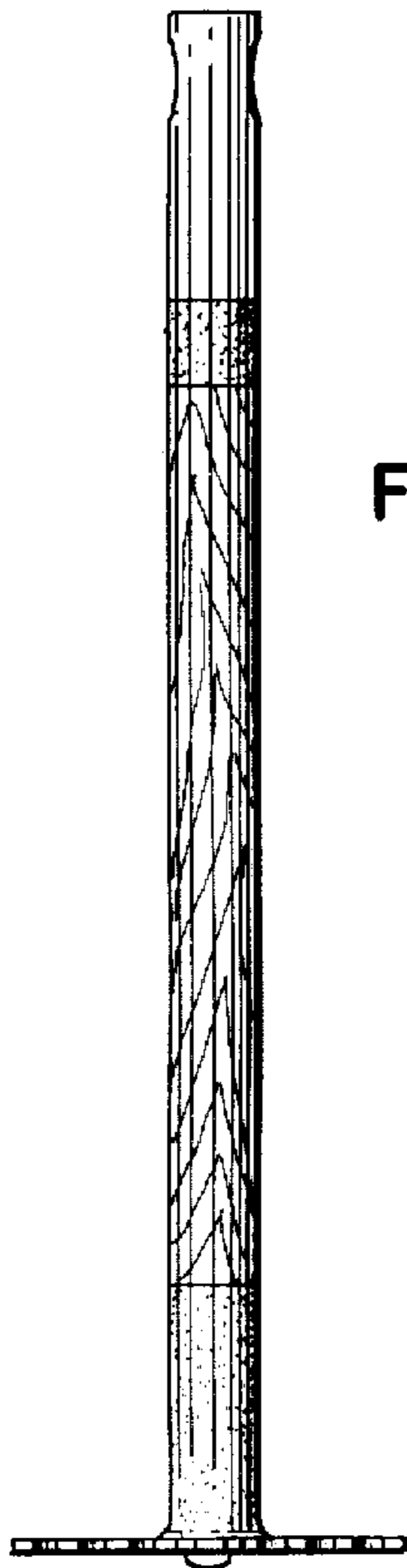

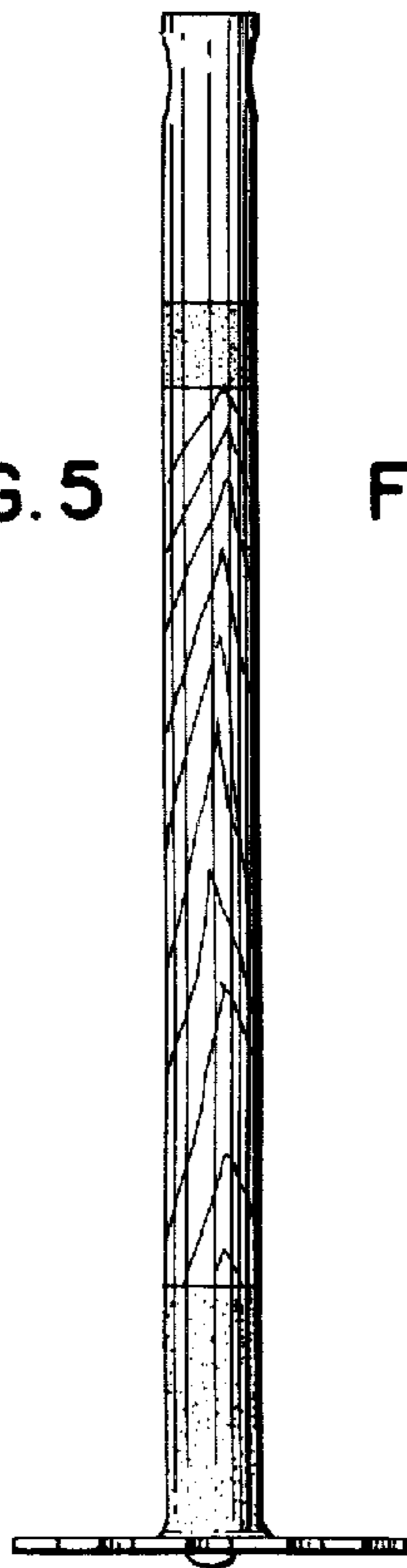

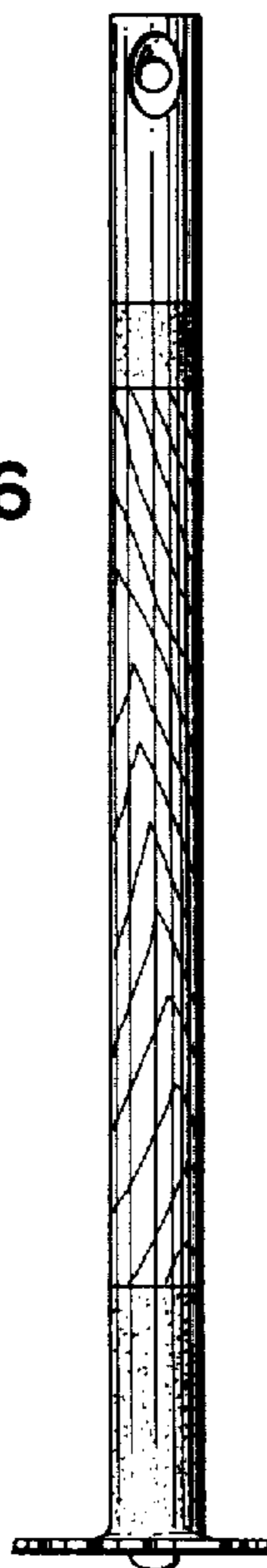
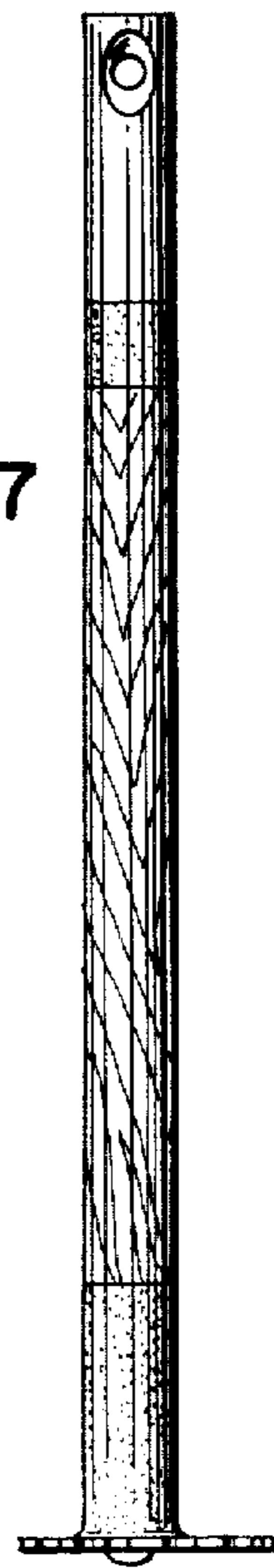

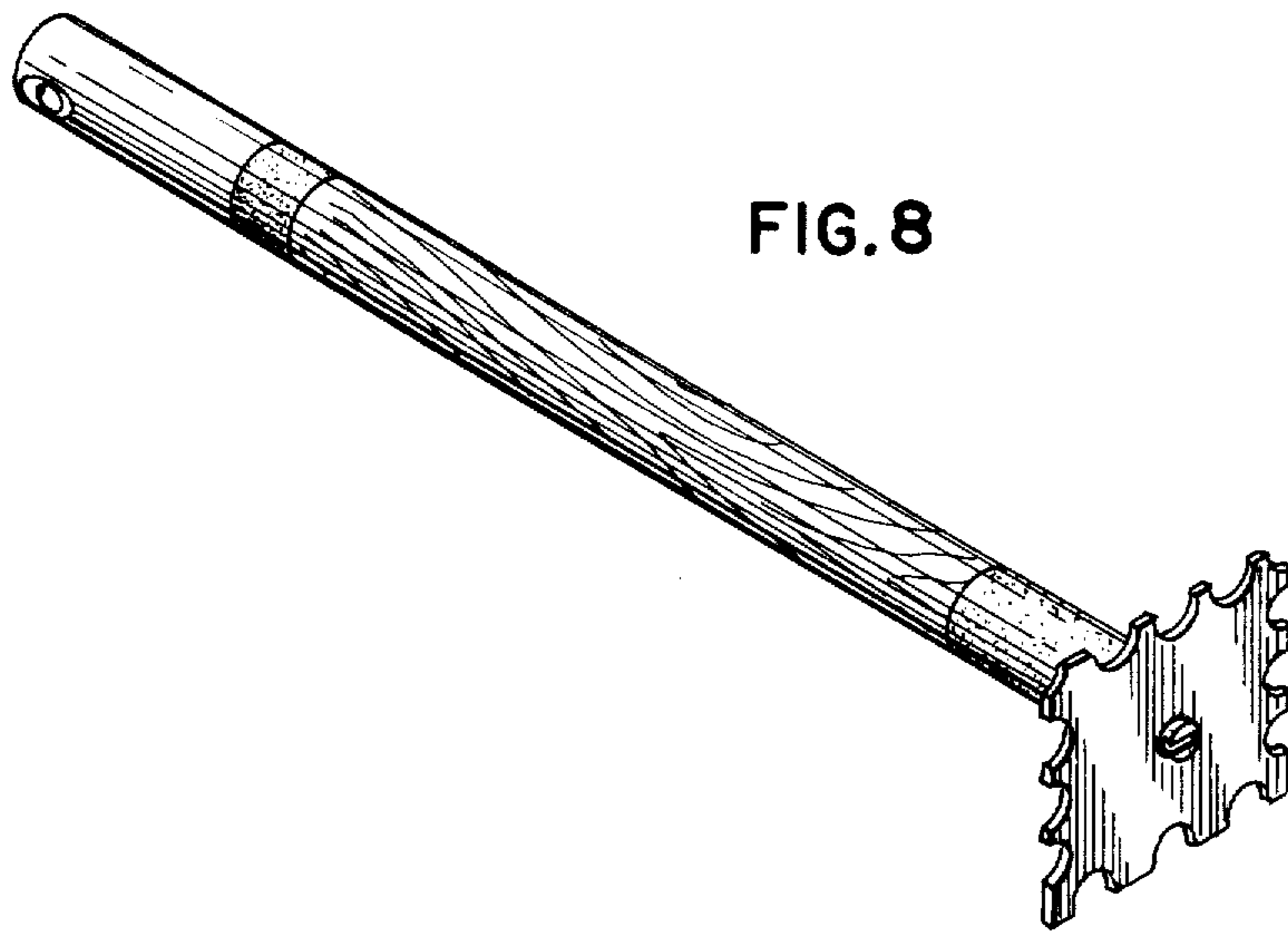

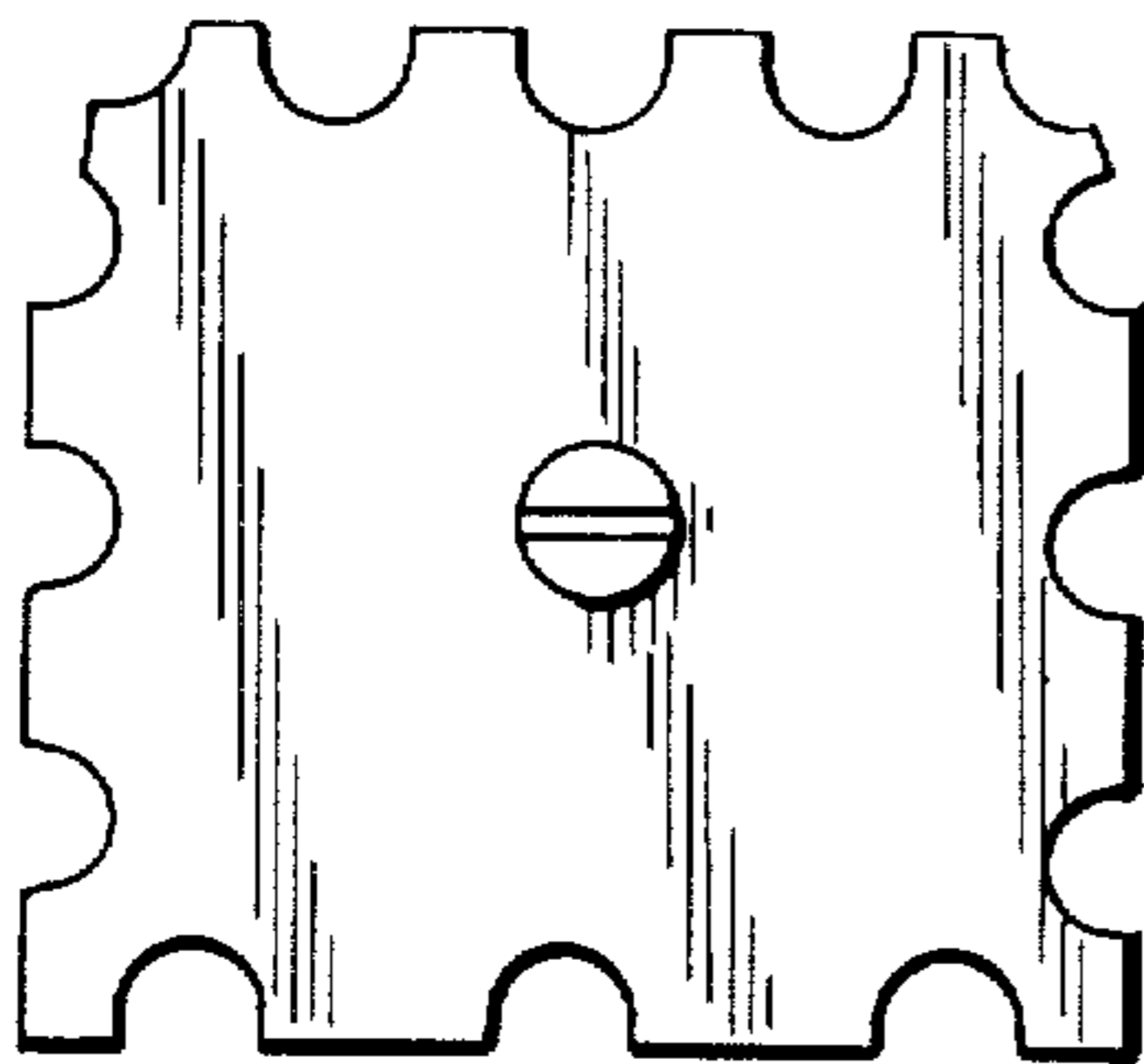

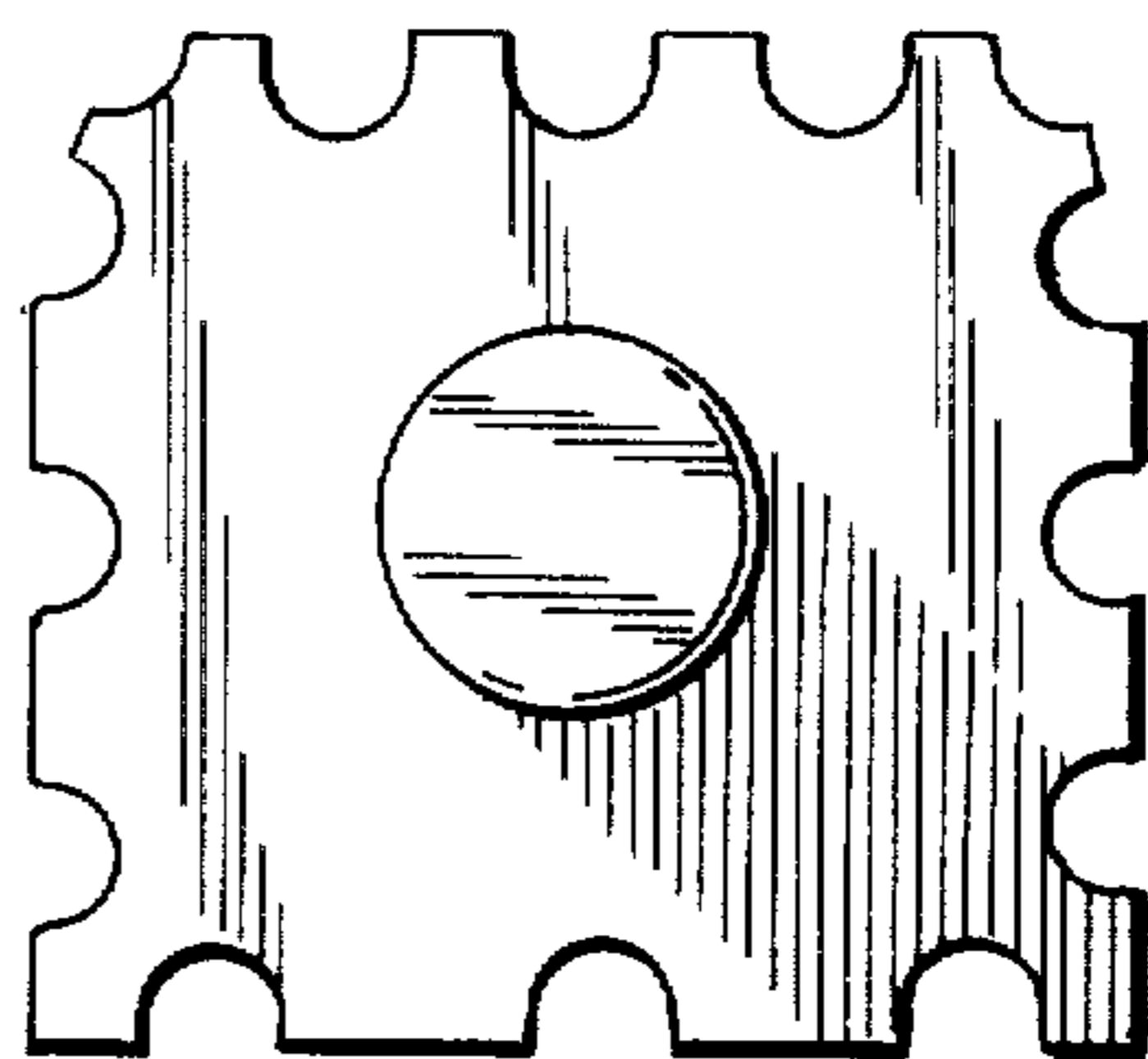

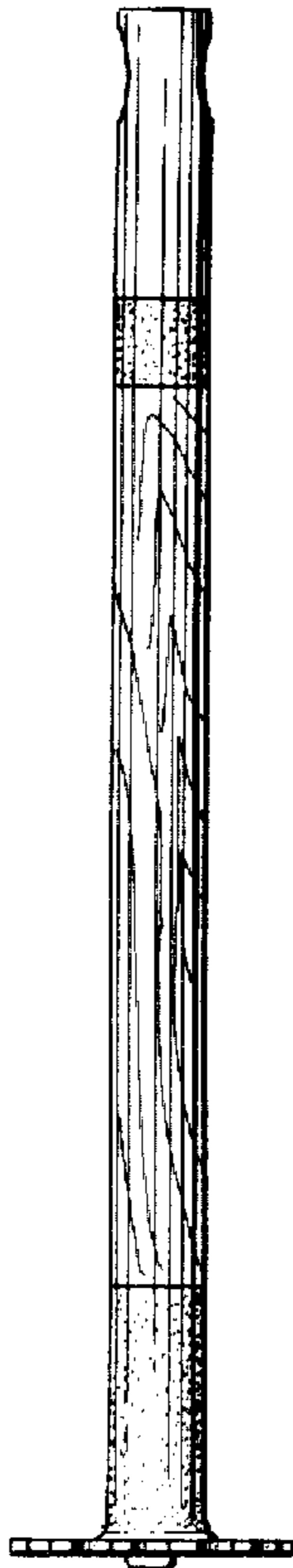

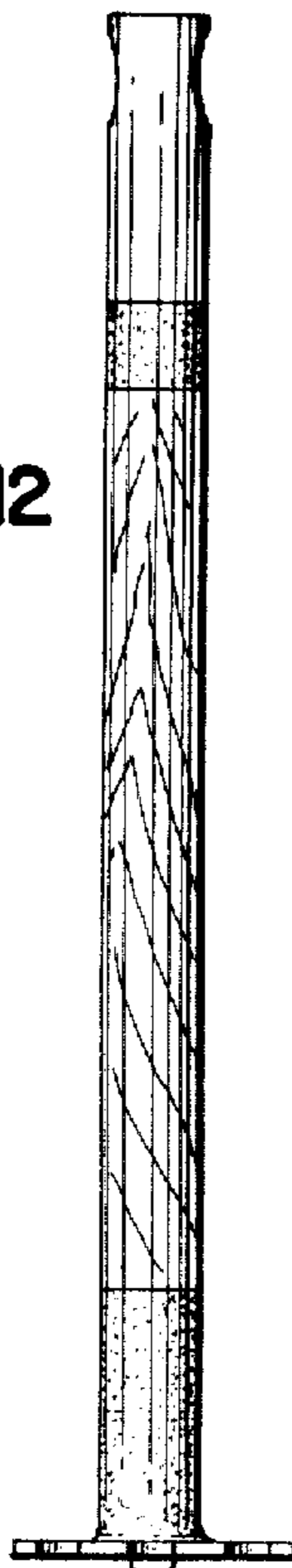

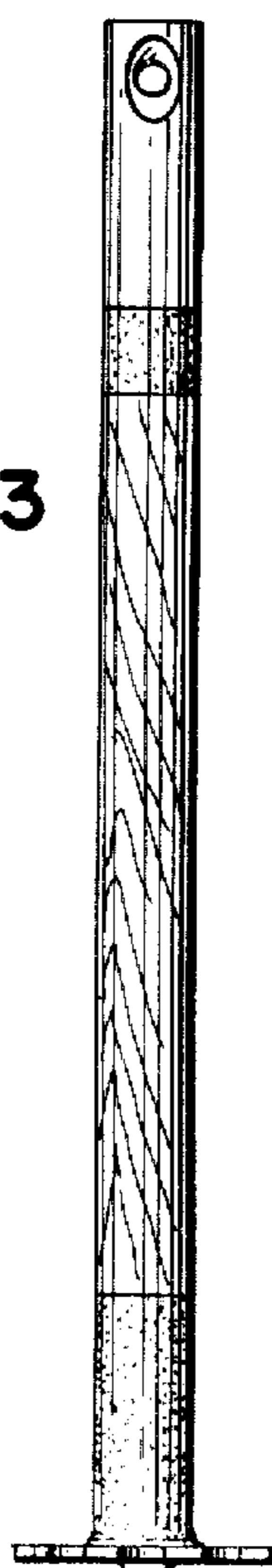
