[57] **CLAIM**

The ornamental design for a sewing machine foot pedal, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a sewing machine foot pedal showing my new design; FIG. 2 is a right side elevational view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a front elevational view thereof; FIG. 6 is a top-plan view thereof; and FIG. 7 is a bottom-plan view thereof.

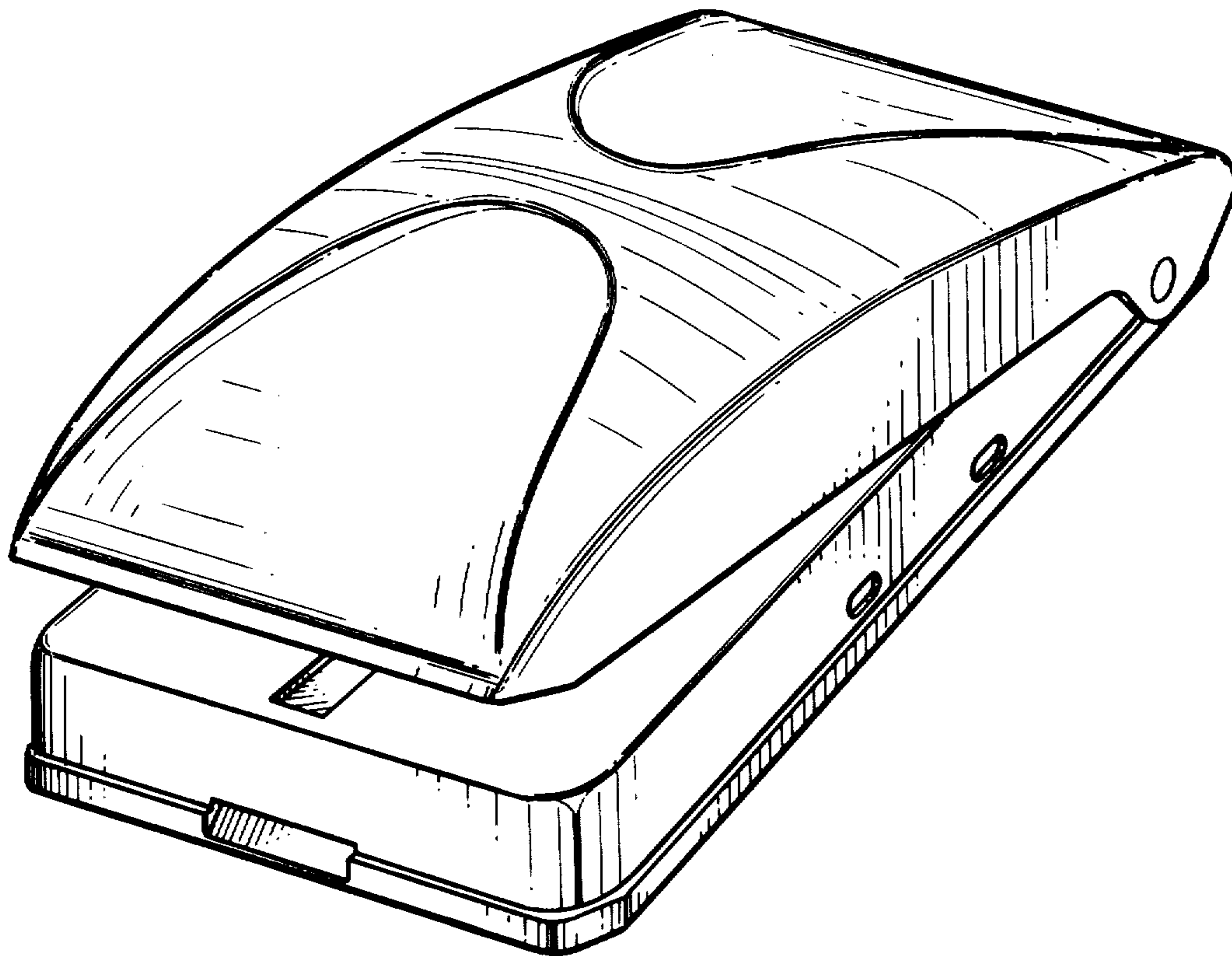

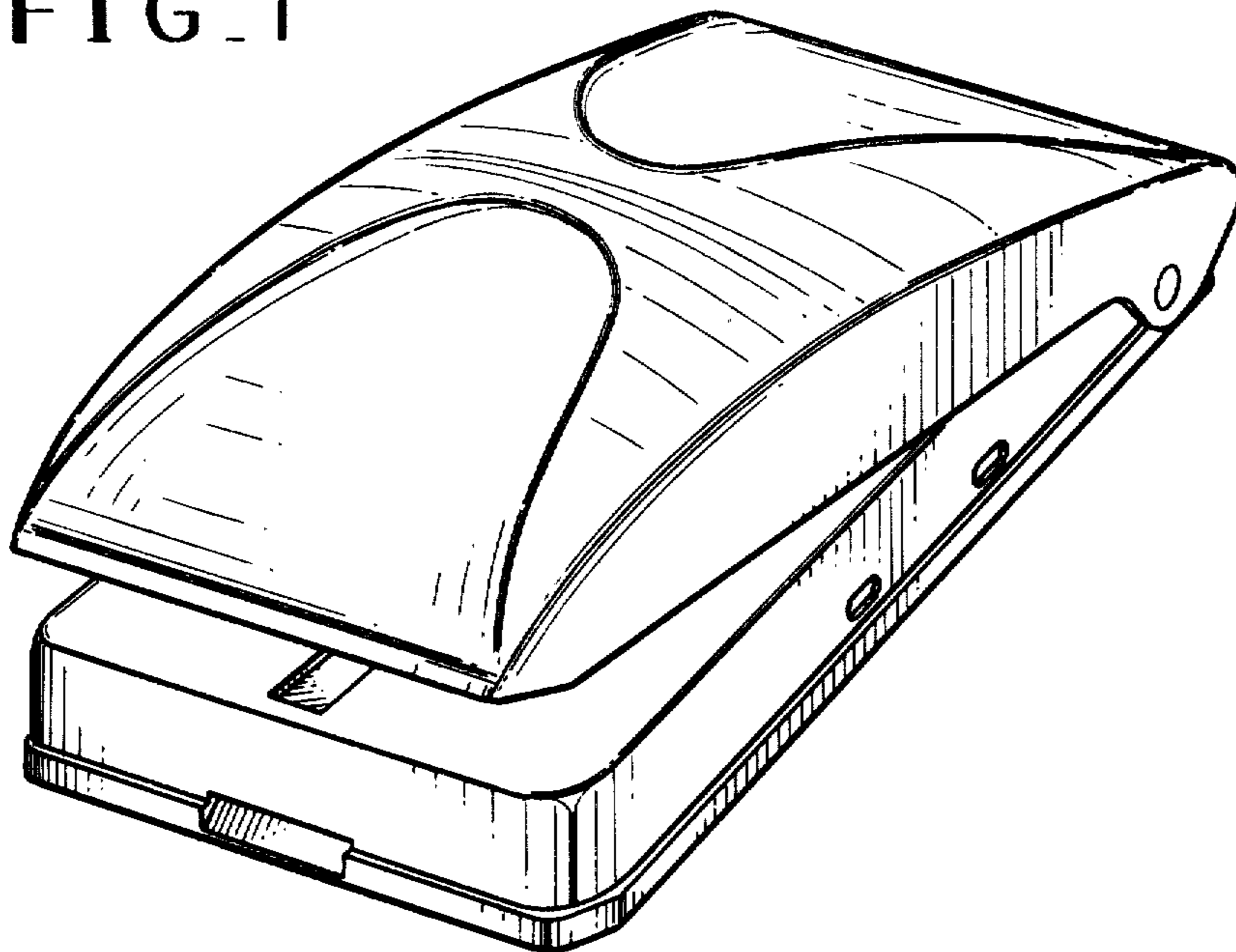

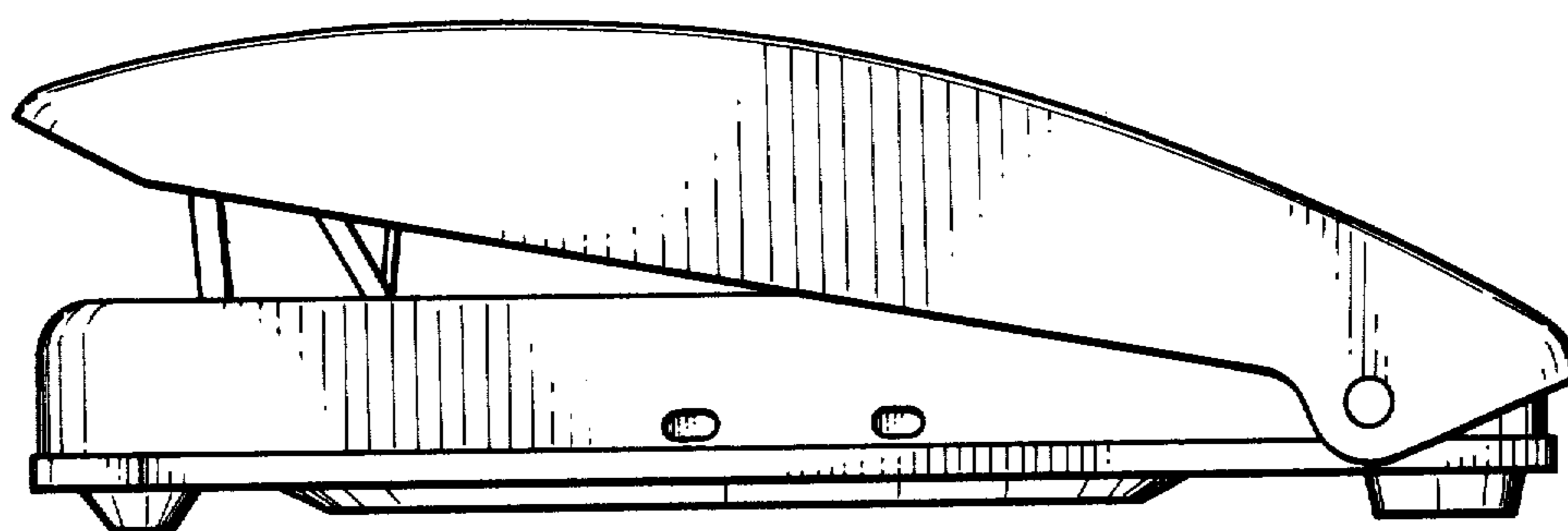

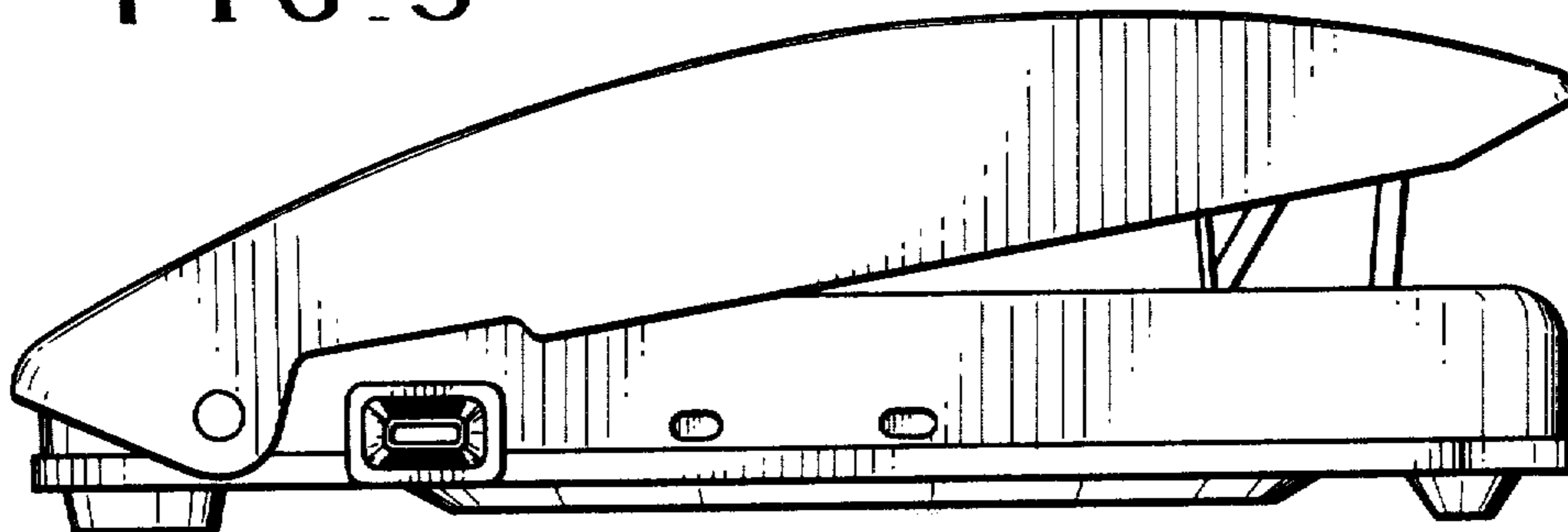

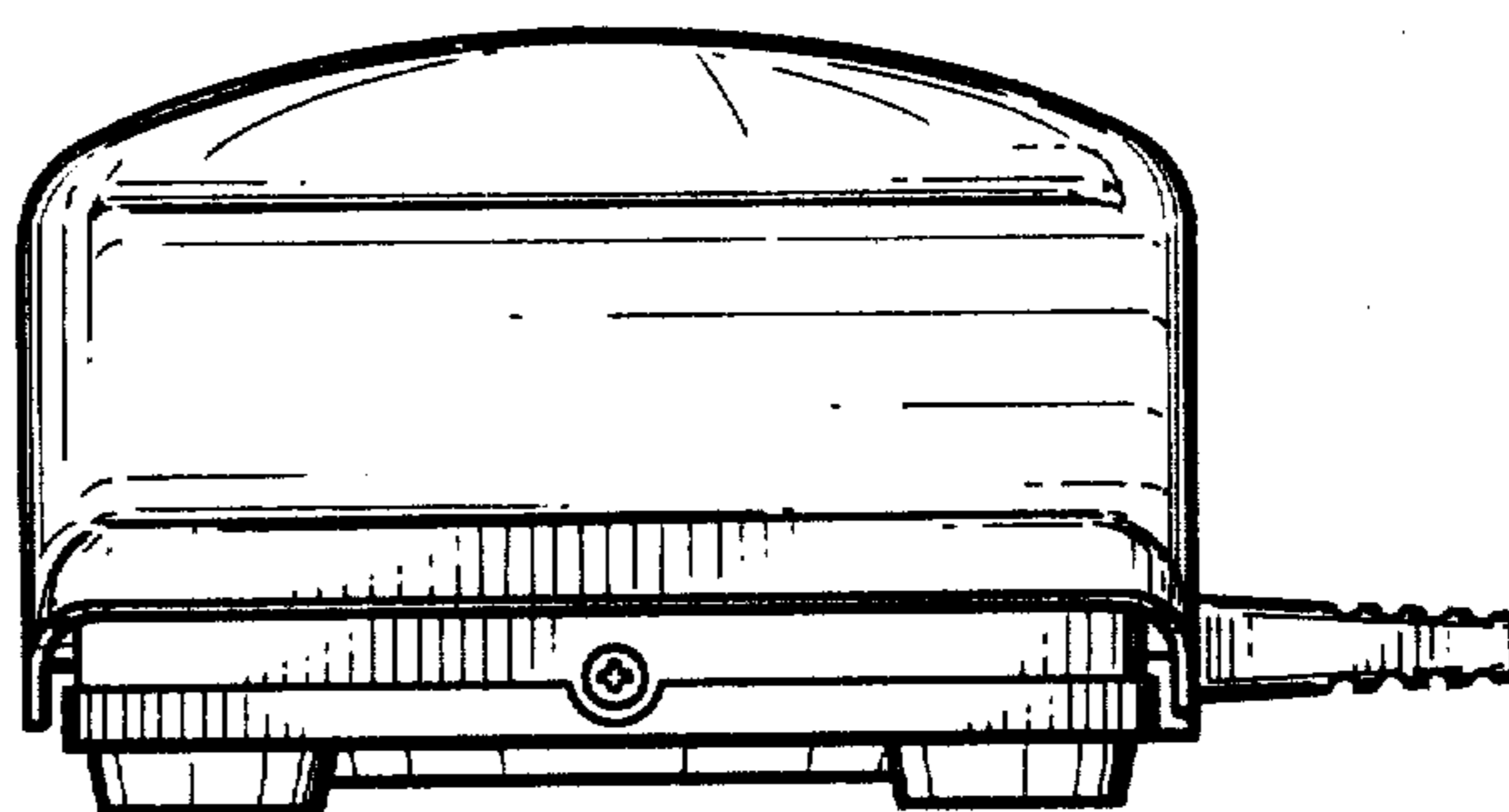

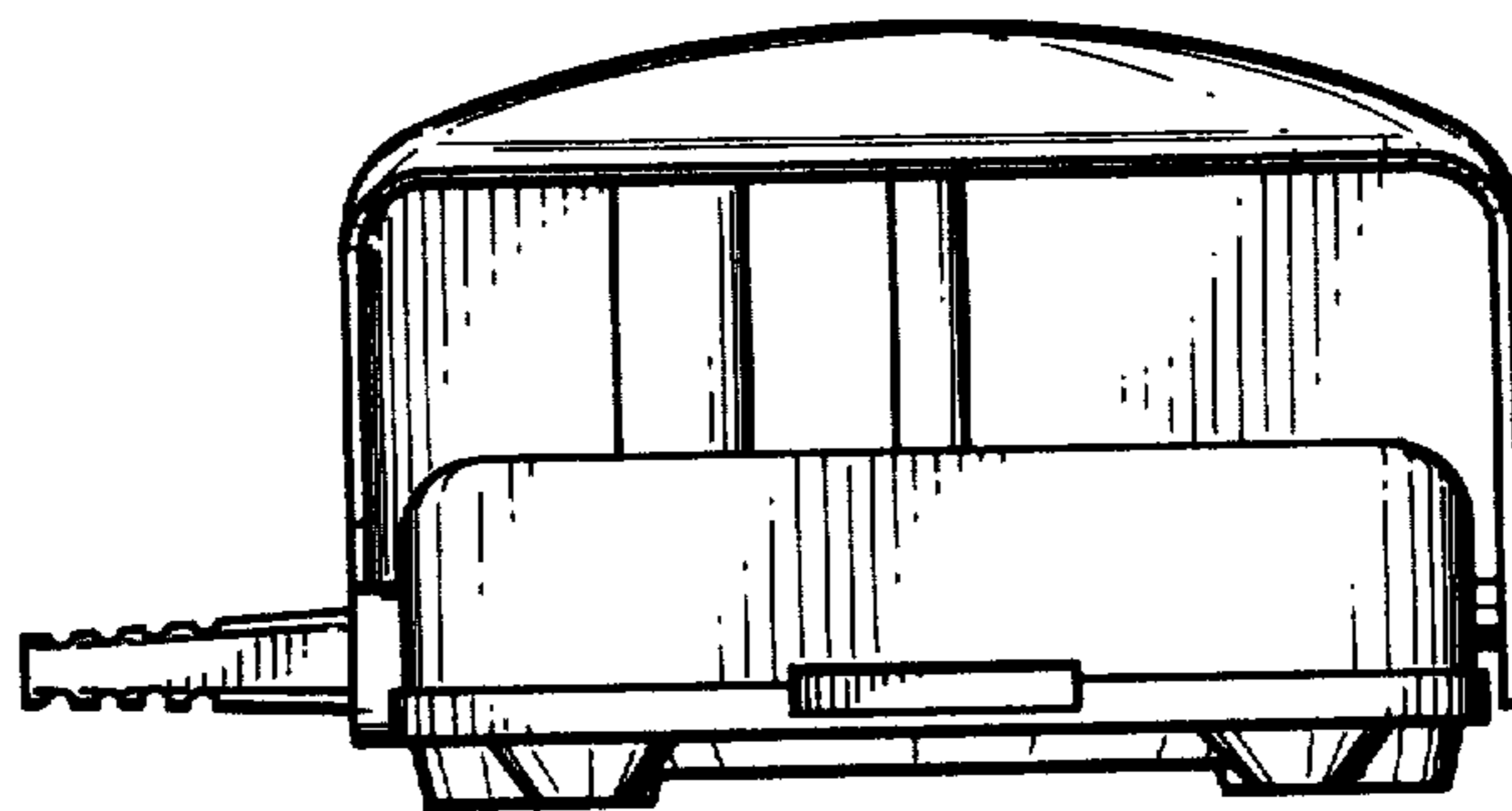

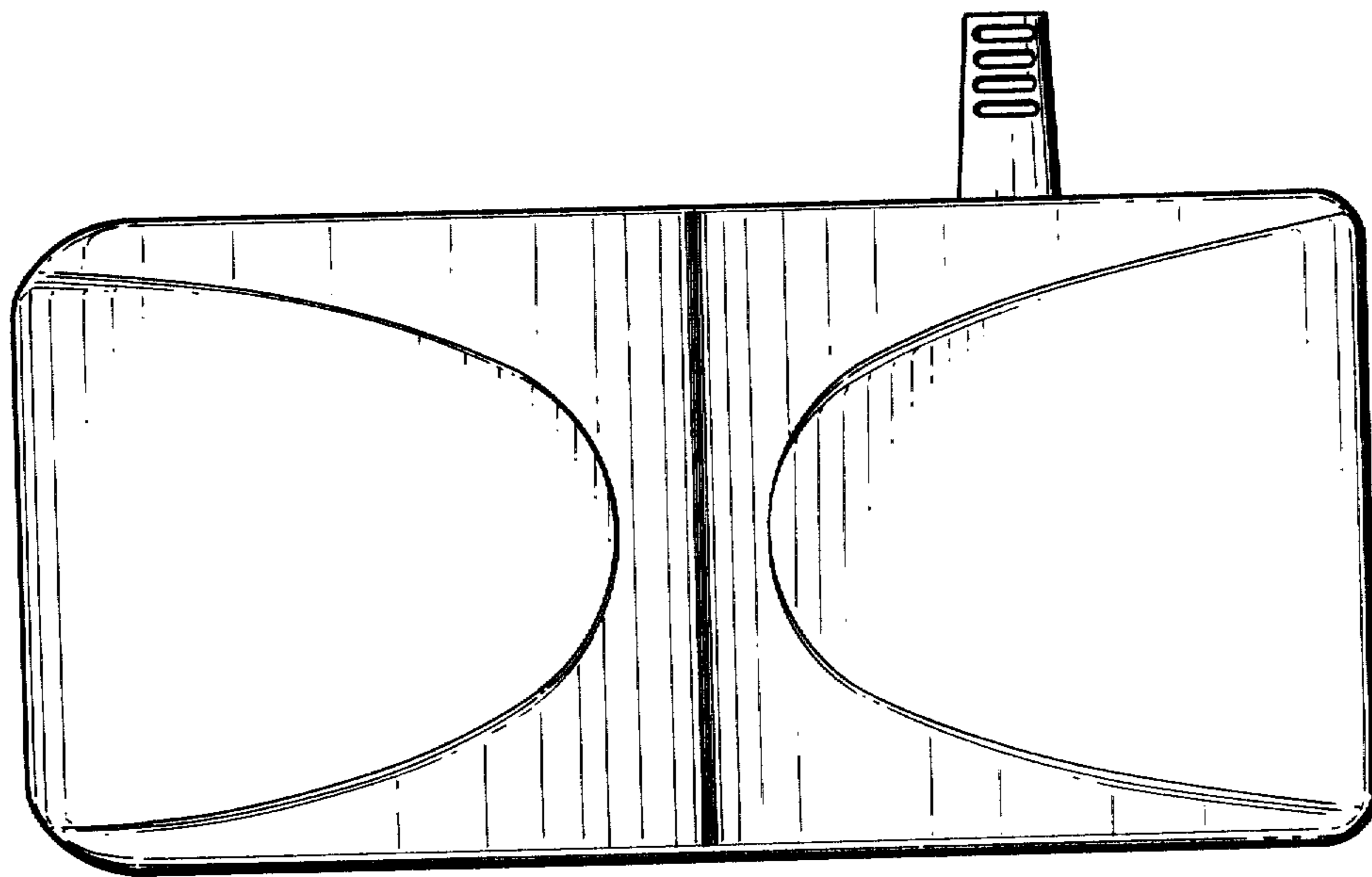
