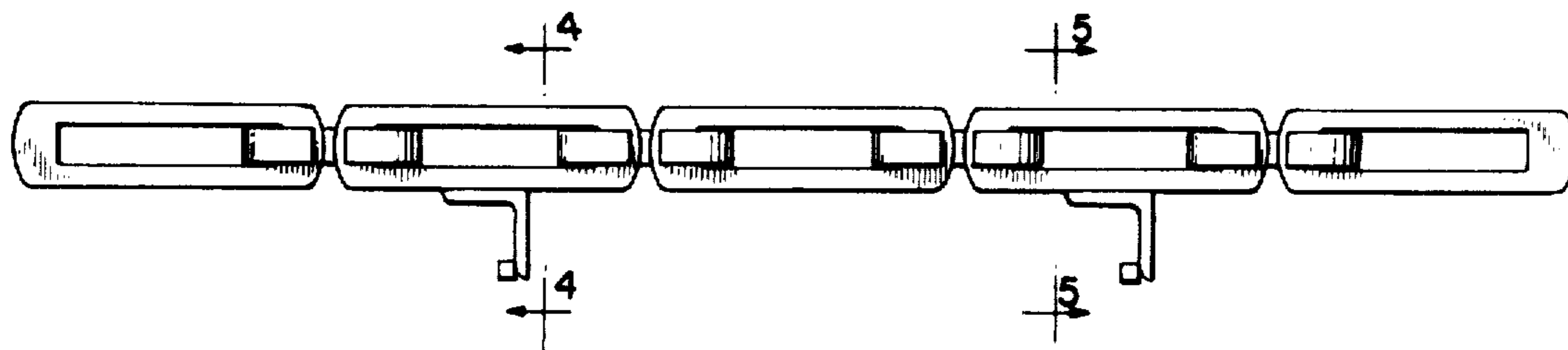
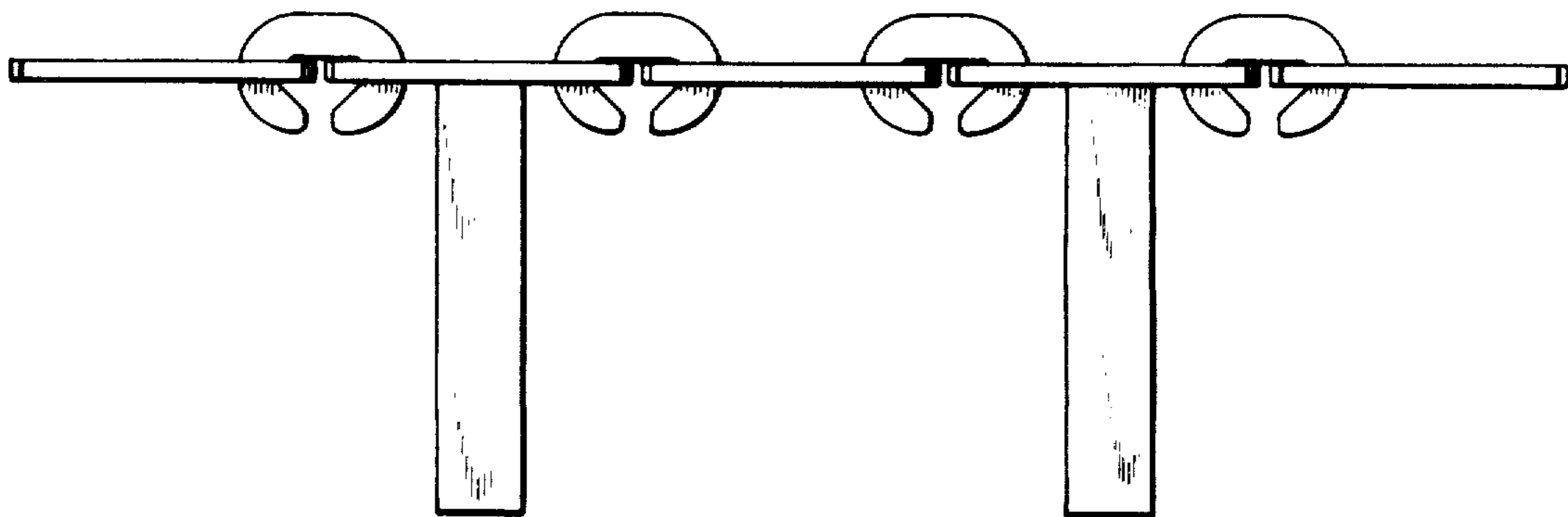

[57] CLAIM

The ornamental design for a chain for waste removal conveyor for a barn, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a chain for waste removal conveyor for a barn showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a cross sectional view taken on line 4-4 of FIG. 2; and FIG. 5 is a cross sectional view taken on line 5-5 of FIG. 2. It is to be understood that the chain is of indeterminate length and is repeated indefinitely, as indicated.



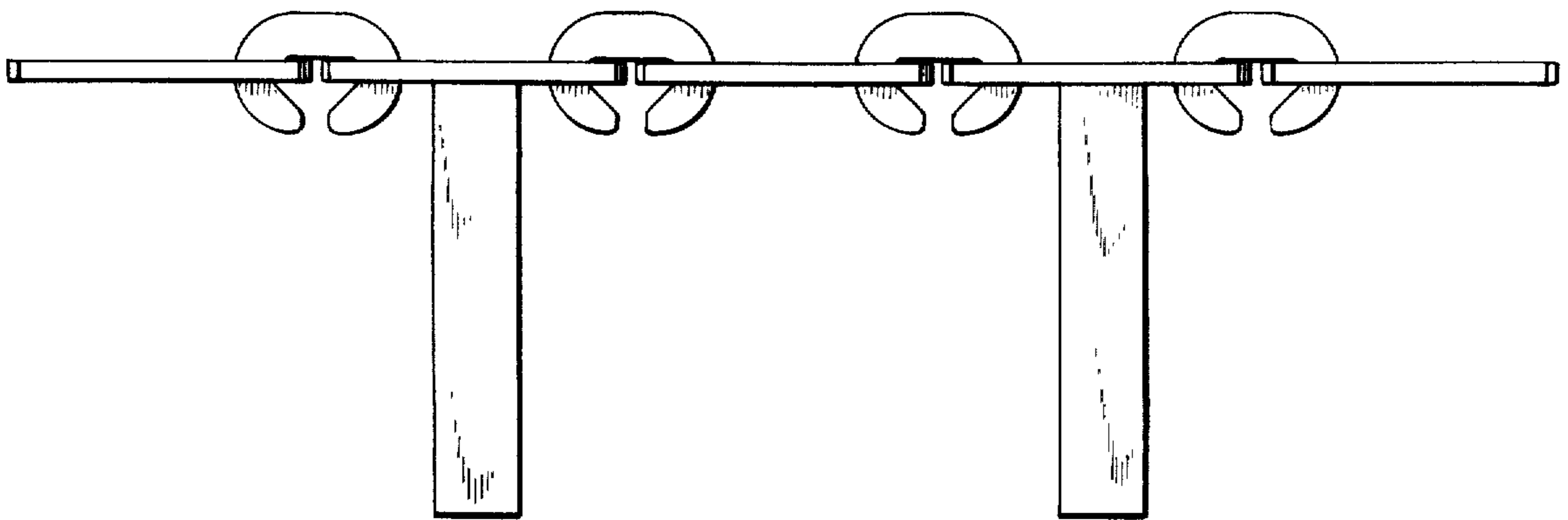

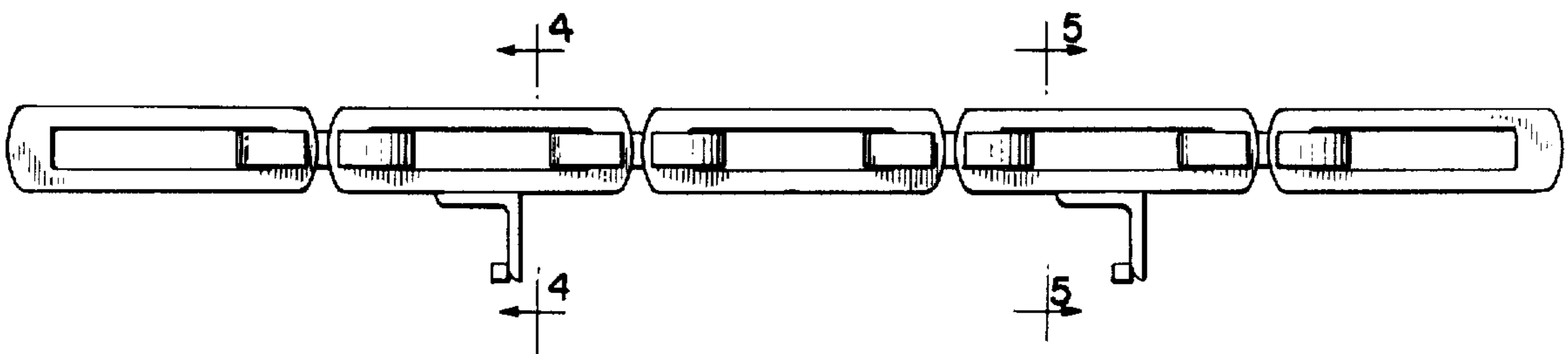

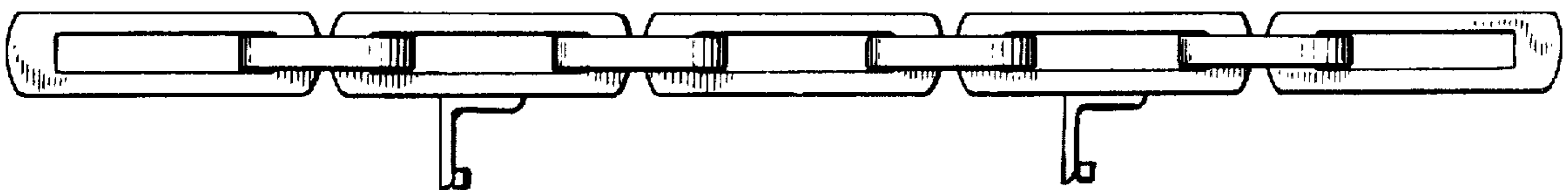

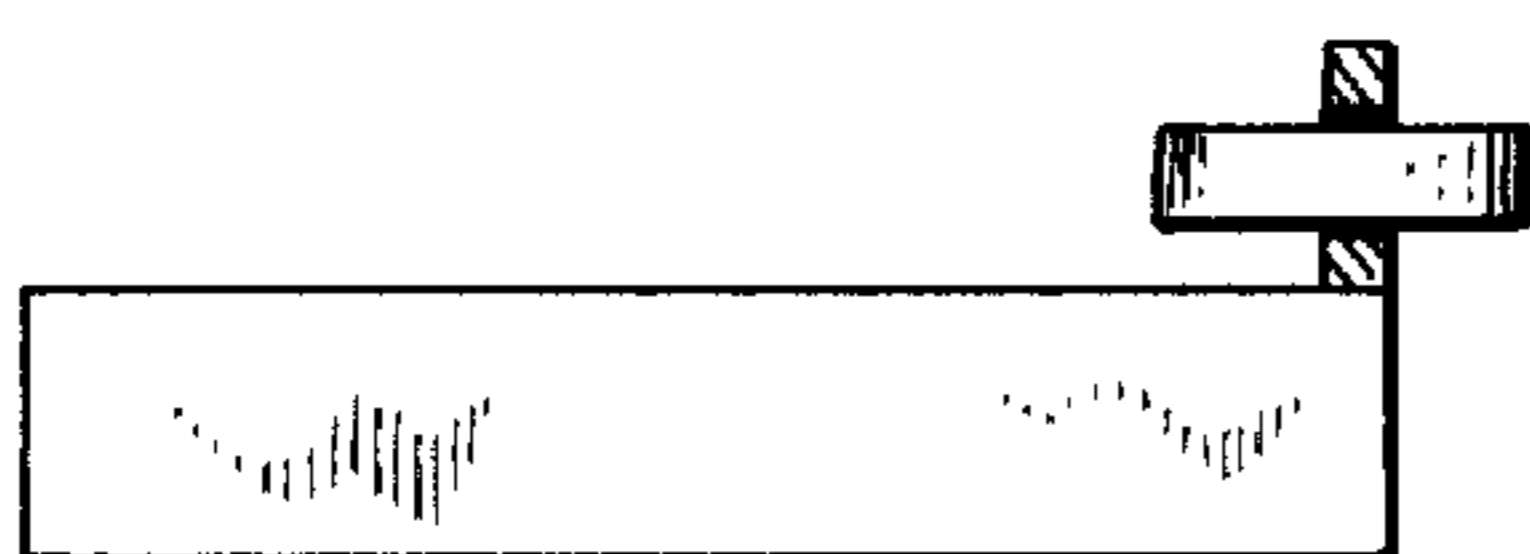

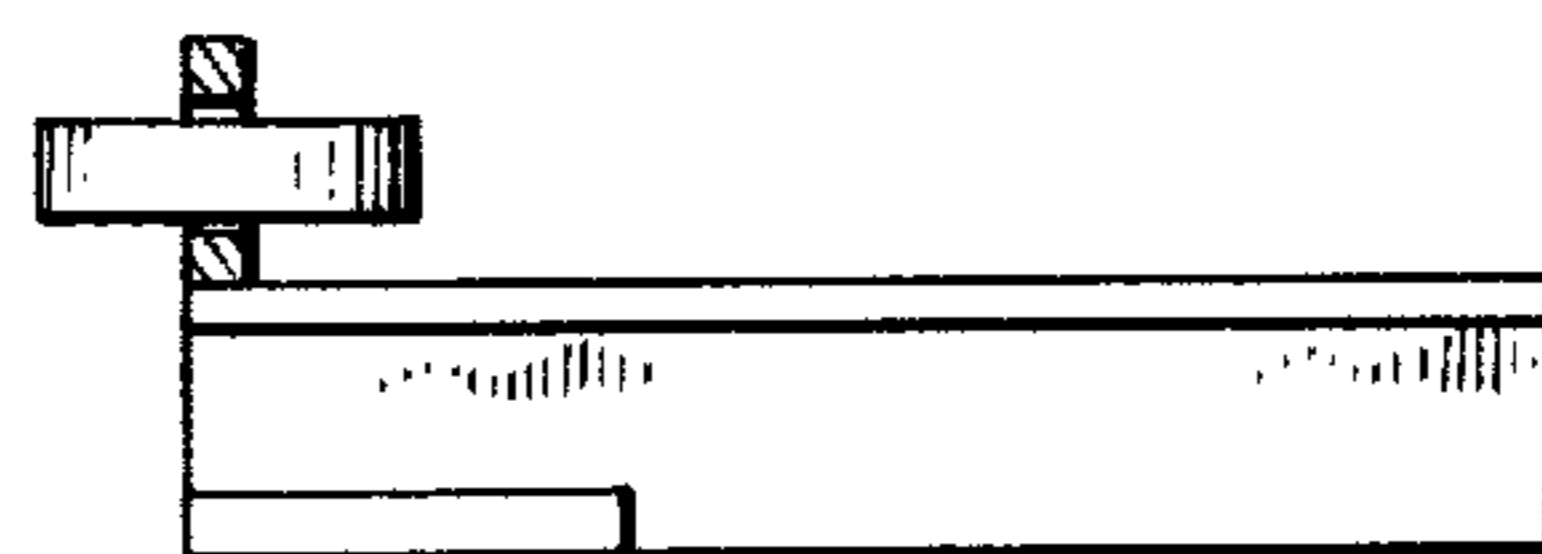
