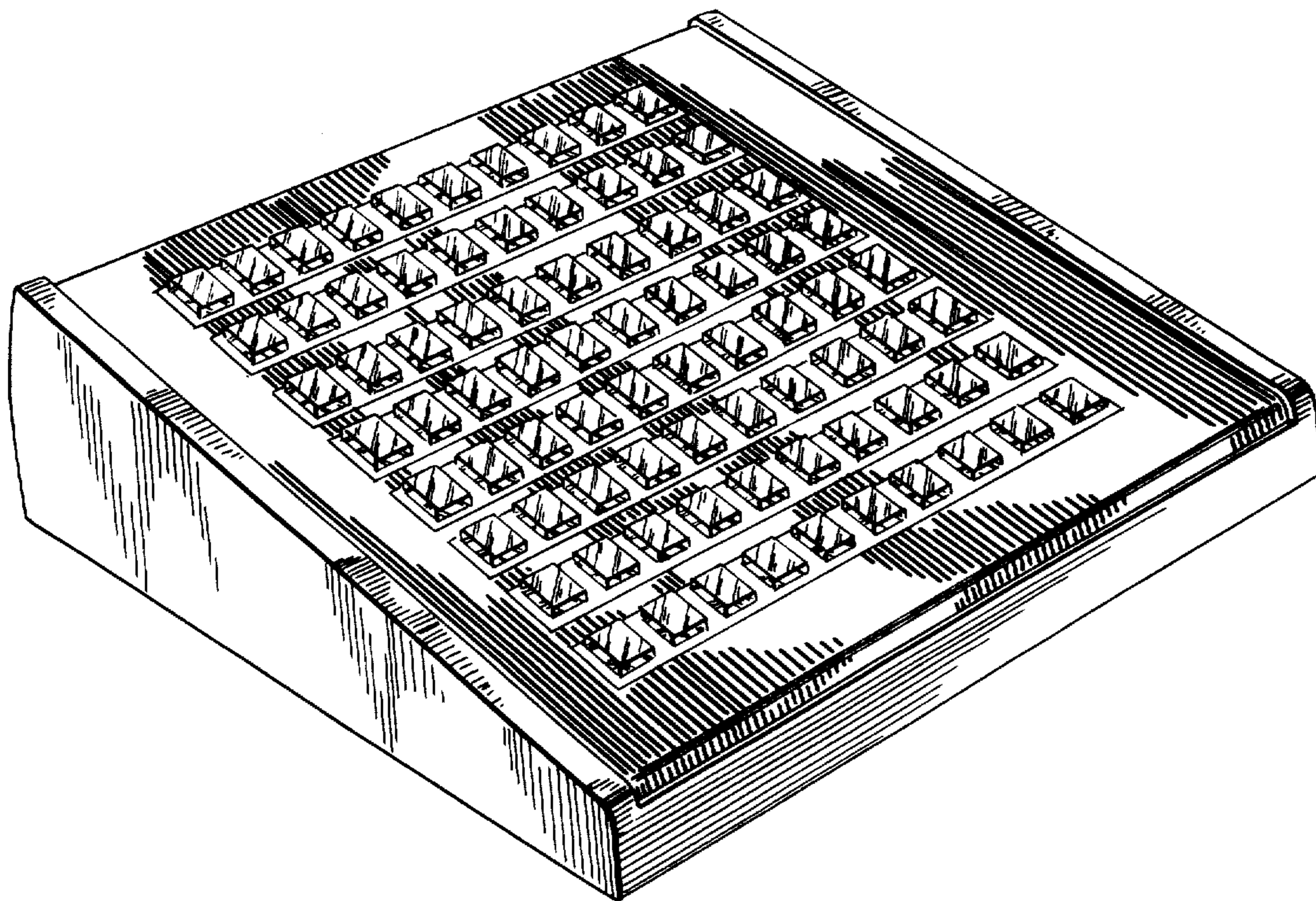

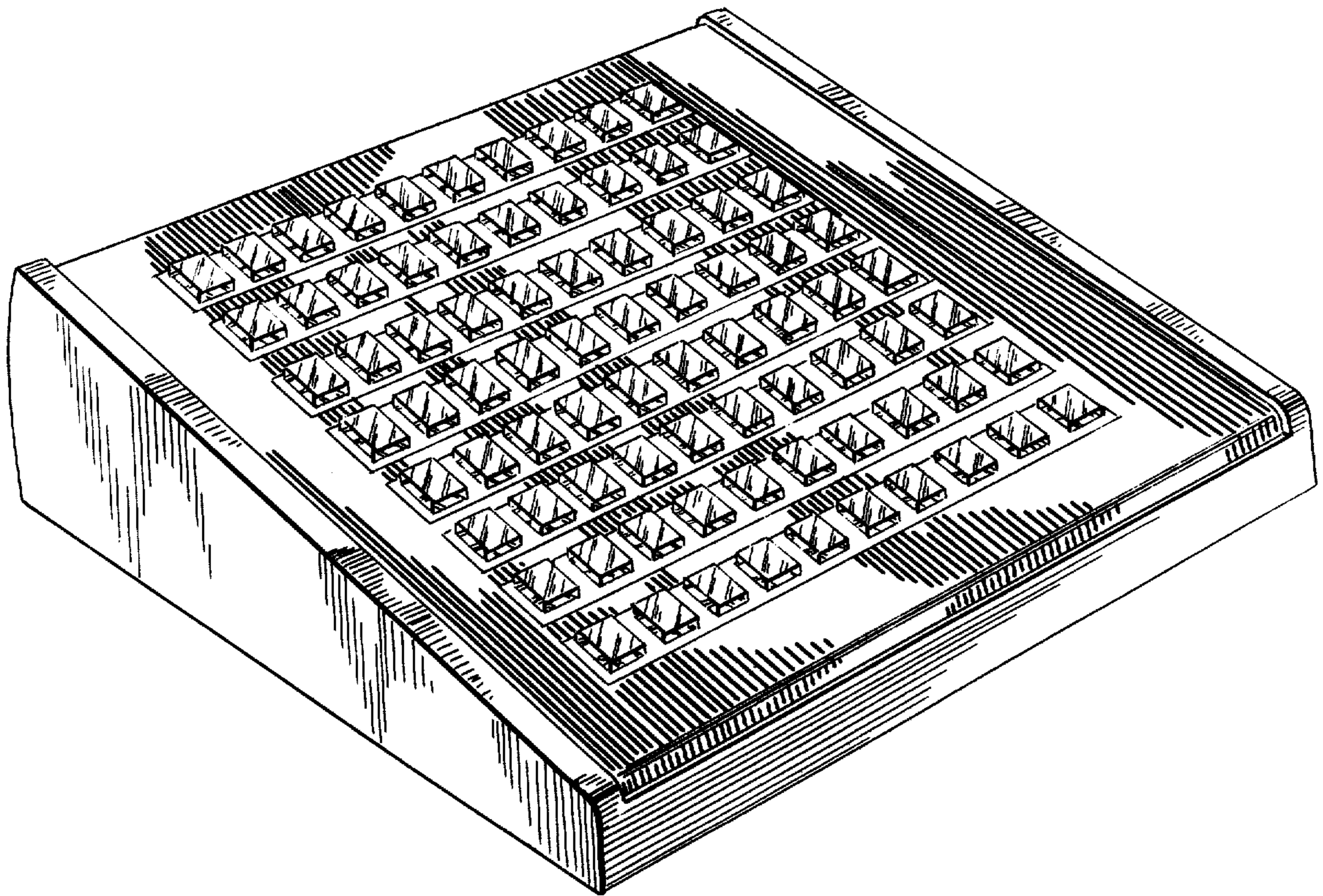
The ornamental design for a direct station selection console, substantially as shown and described.

DESCRIPTION

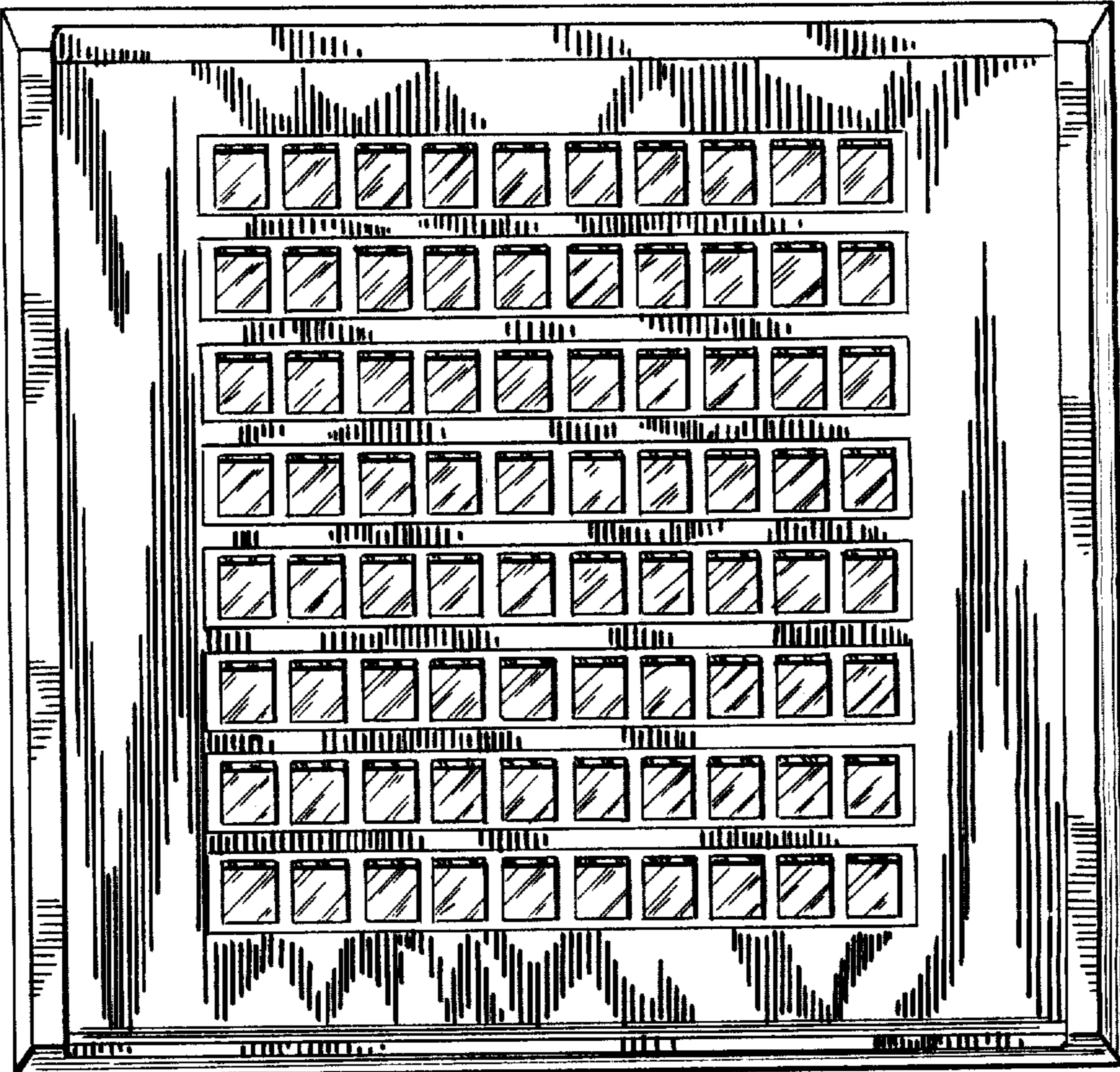
FIG. 1 is a front isometric view of a direct station selection console showing our new design;  
FIG. 2 is a plan view of the top of the direct station selection console of FIG. 1;  
FIG. 3 is a front elevation of the direct station selection console of FIG. 1;  
FIG. 4 is a front isometric view of a second modified embodiment of the direct station selection console illustrated in FIG. 1;  
FIG. 5 is a plan view of the top of the direct station selection console of FIG. 4;  
FIG. 6 is a front elevation of the direct station selection console of FIG. 4;  
FIG. 7 is a right side elevation of the direct station selection console of FIGS. 1-3 and the direct station selection console of FIGS. 4-6;  
FIG. 8 is a left side elevation of the direct station selection console of FIGS. 1-3 and the direct station selection console of FIGS. 4-6;  
FIG. 9 is a rear elevation of the direct station selection console of FIGS. 1-3 and the direct station selection console of FIGS. 4-6; and  
FIG. 10 is a bottom plan view of the direct station selection console of FIGS. 1-3 and the direct station selection console of FIGS. 4-6.



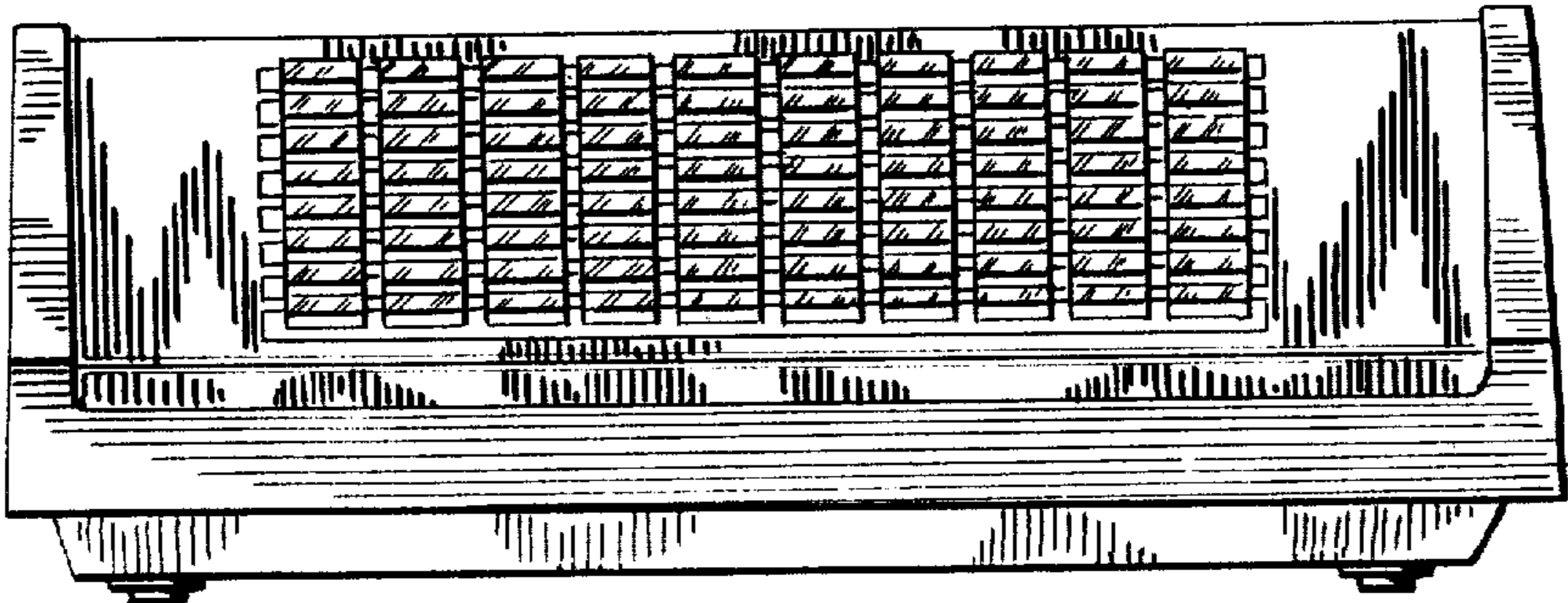

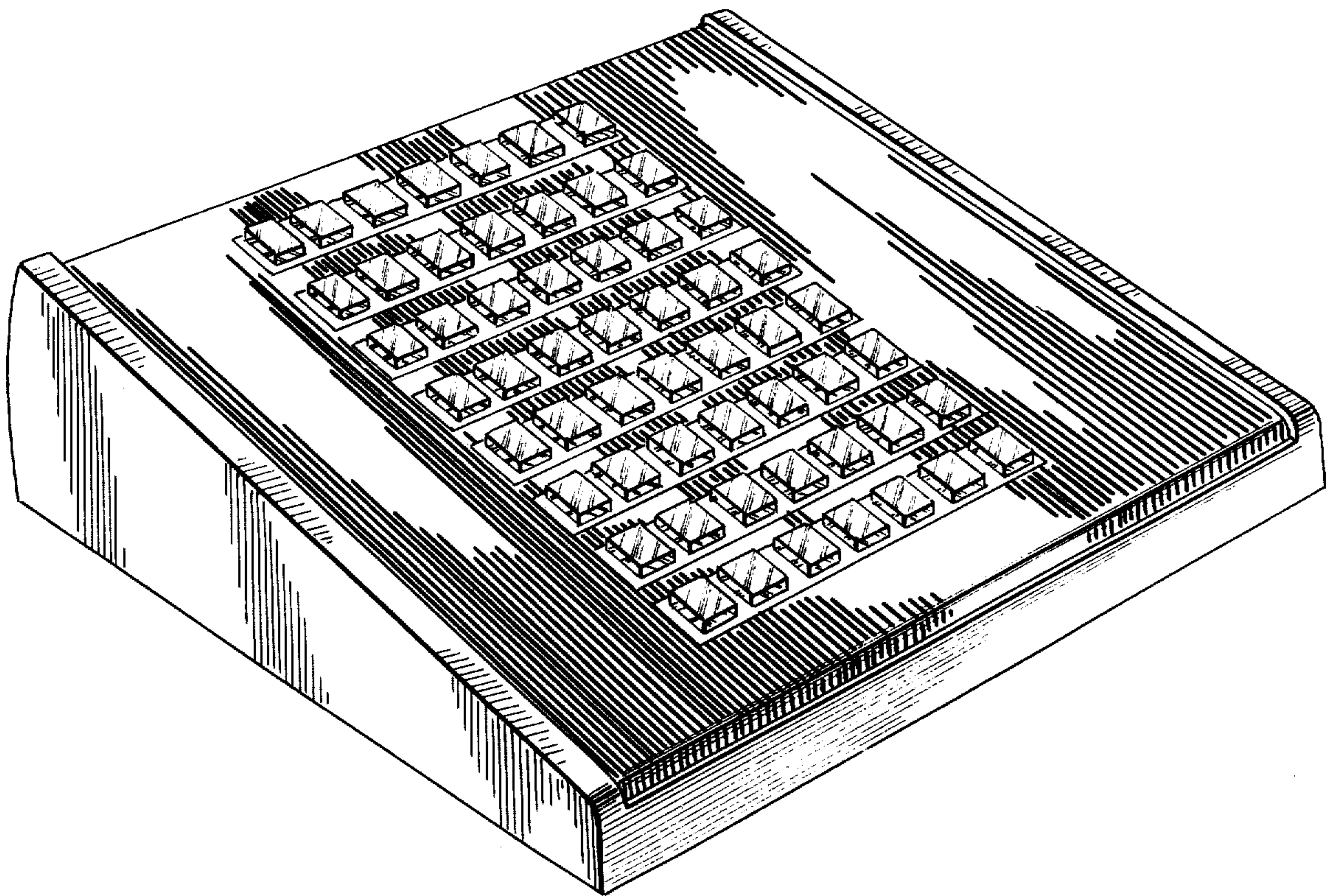

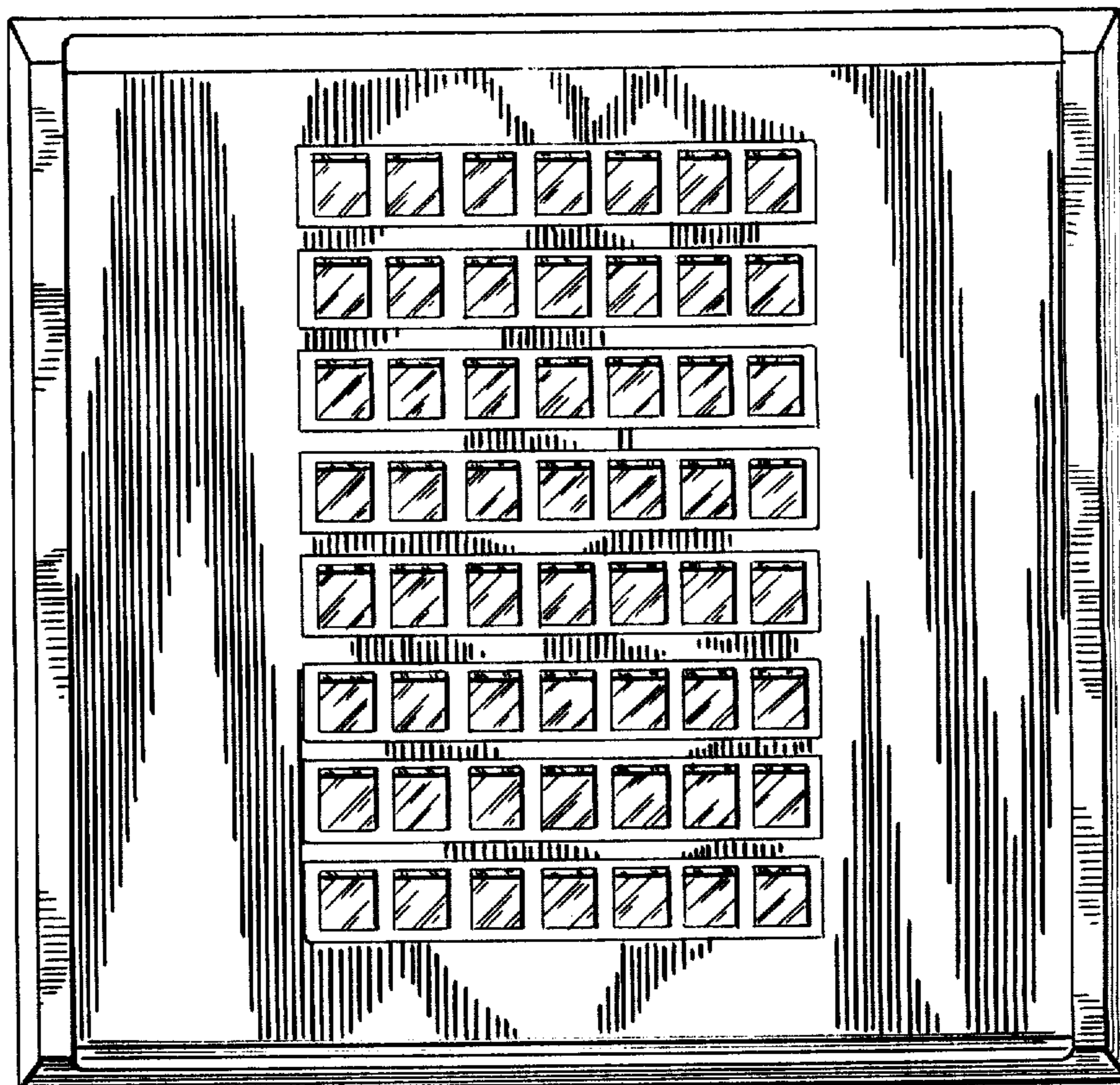

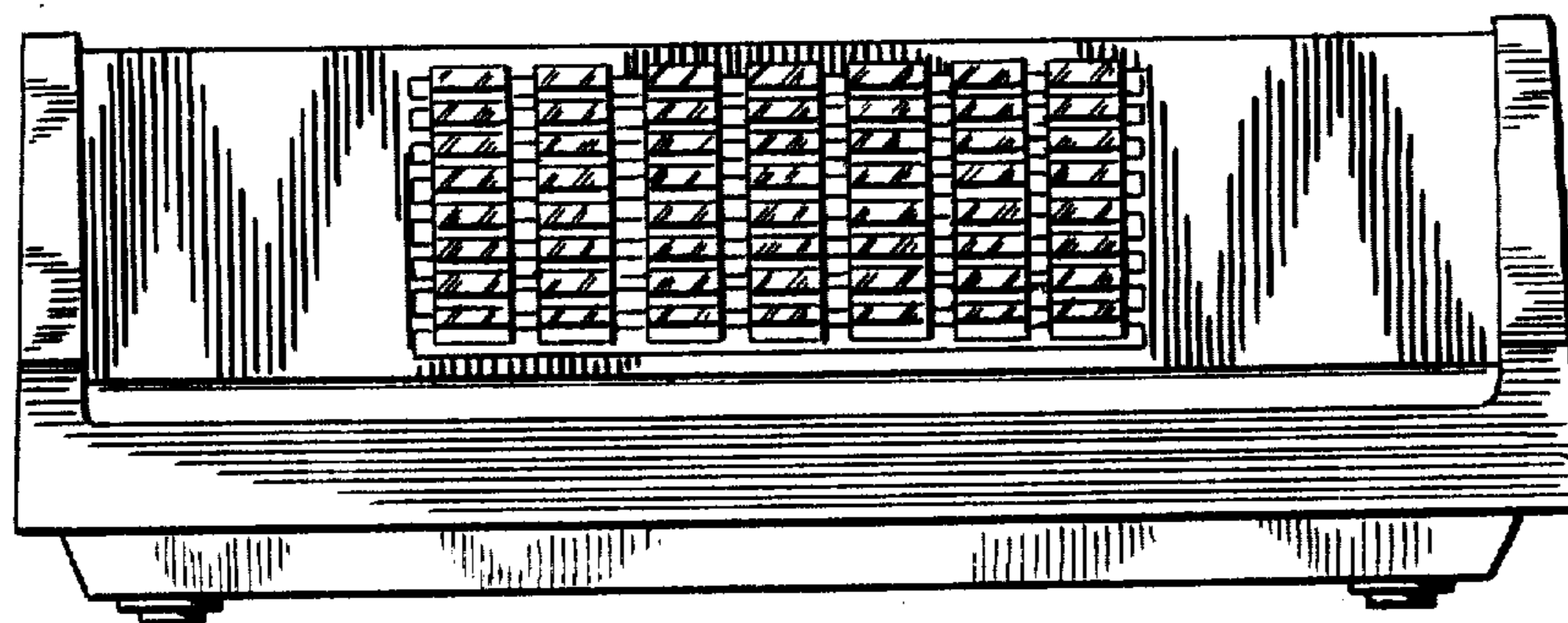

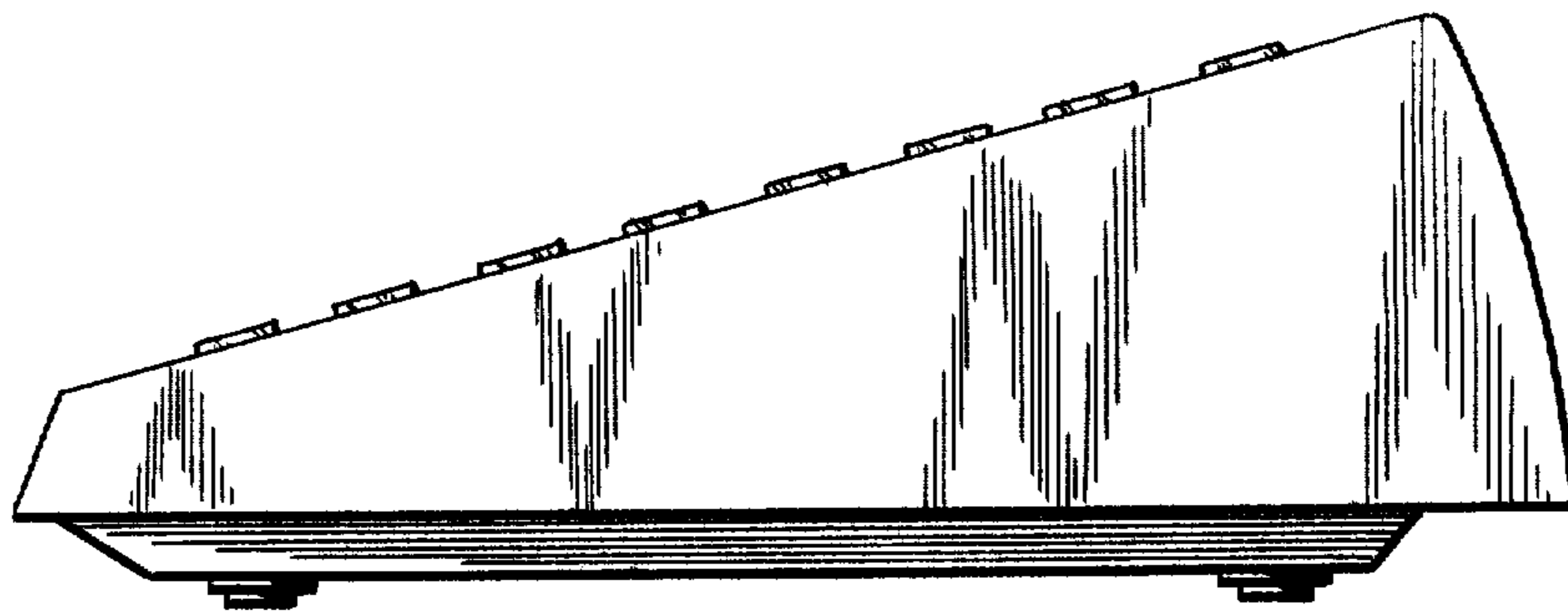

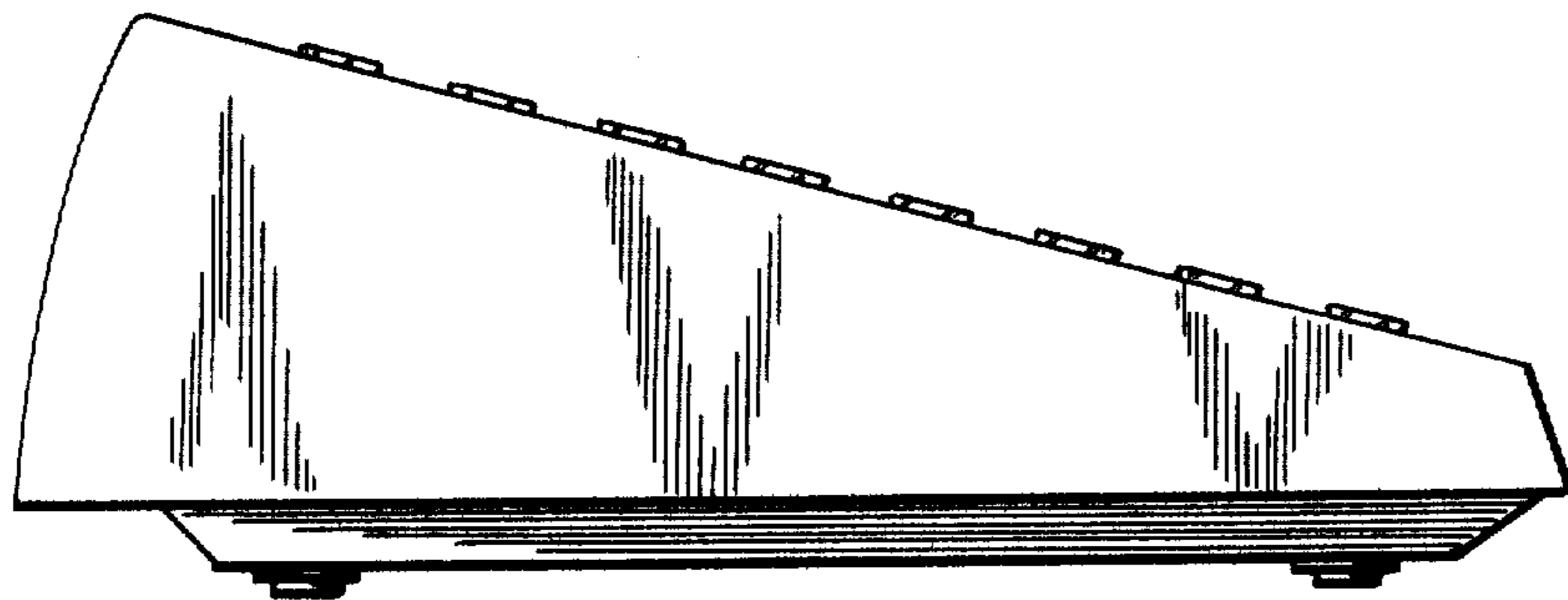

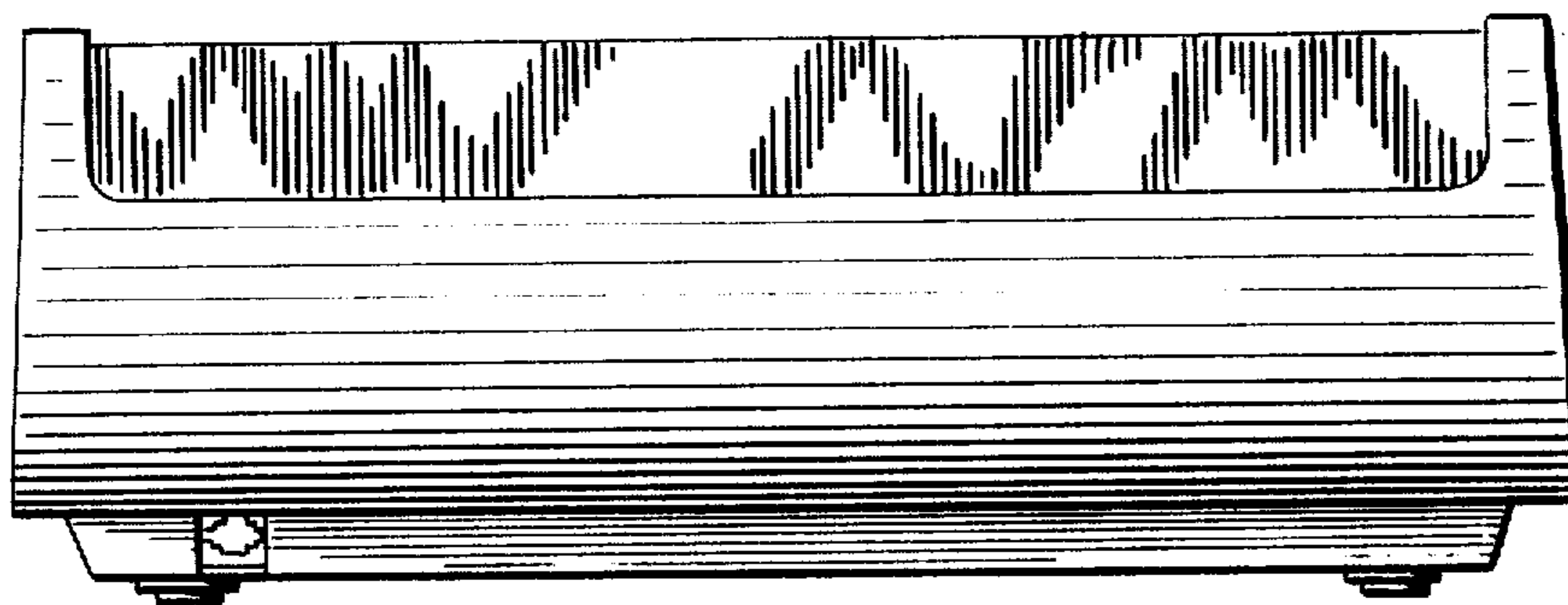
