 FIG. 7 is a front and top perspective view.

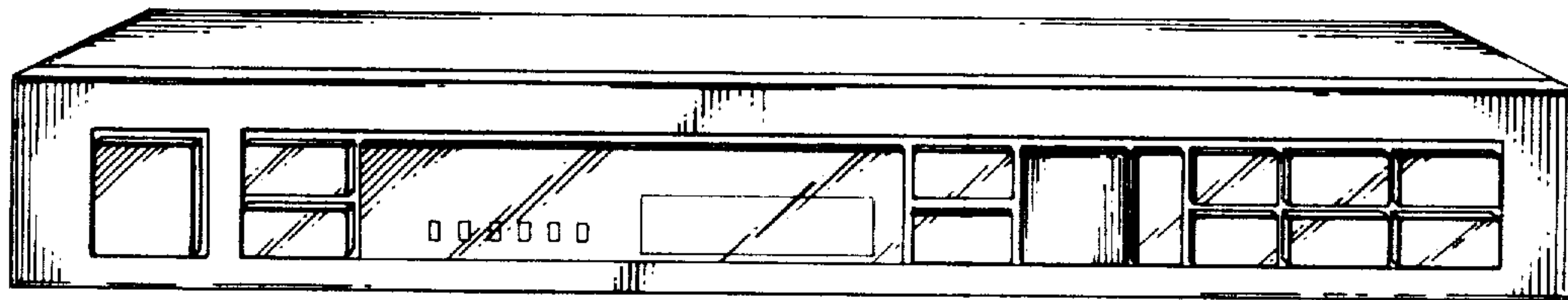

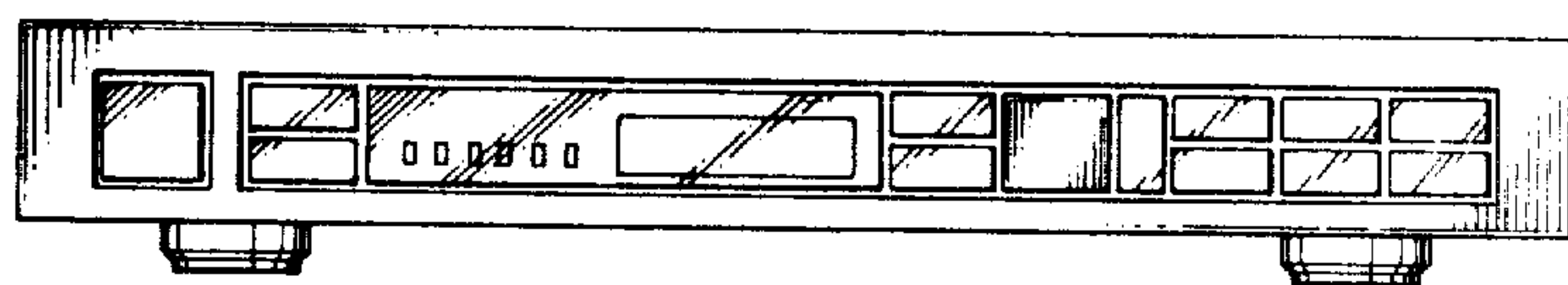

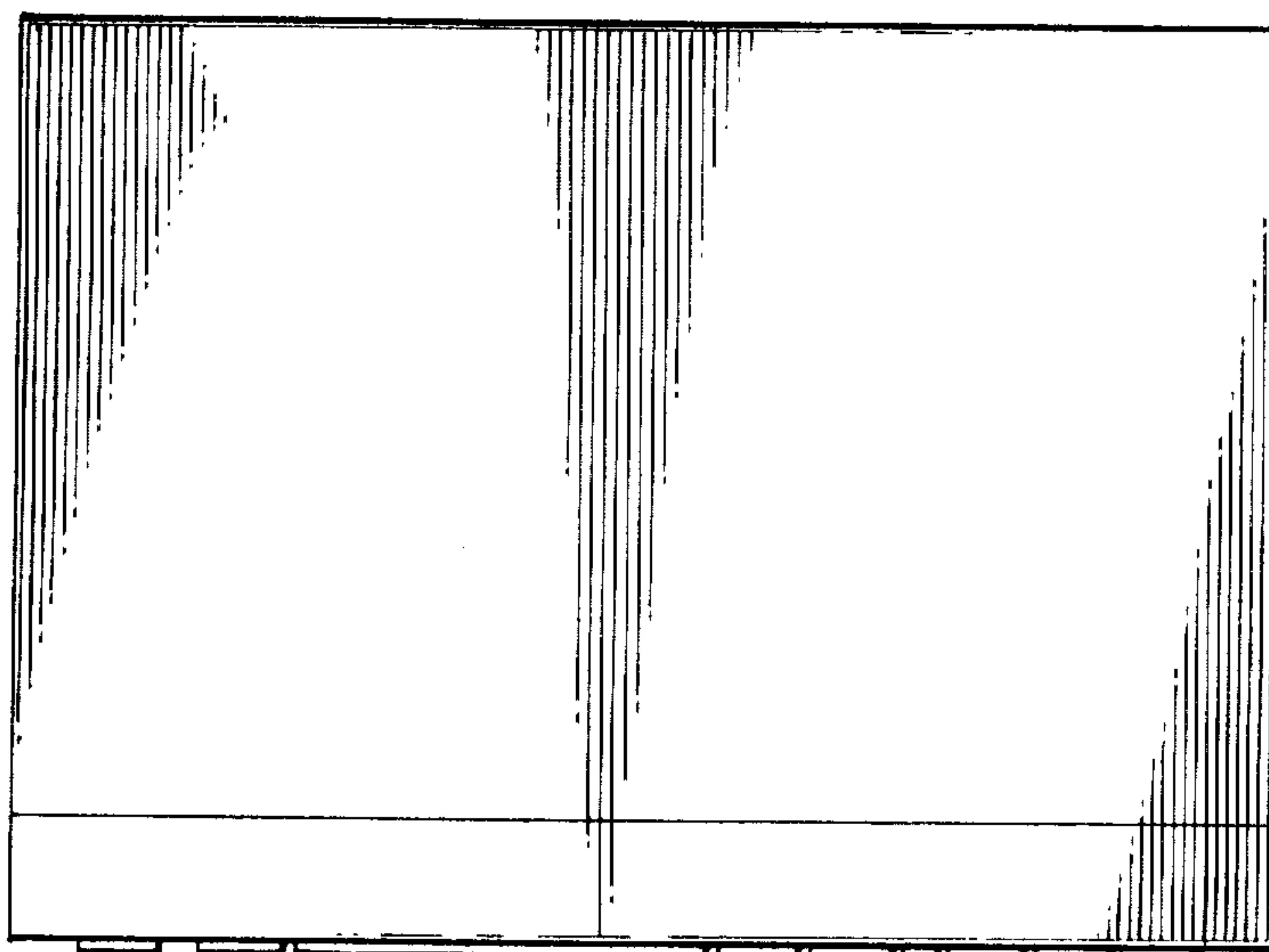

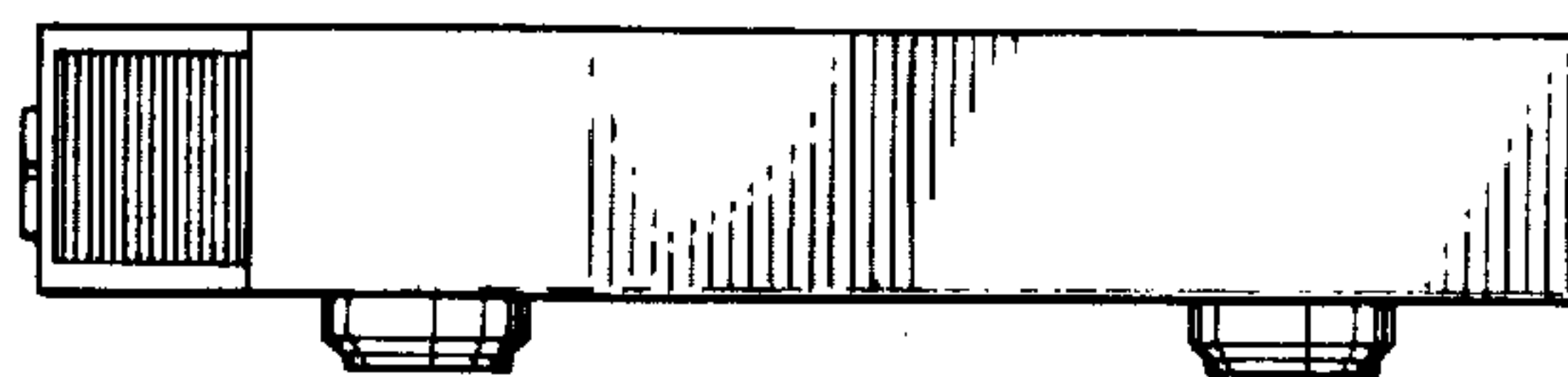

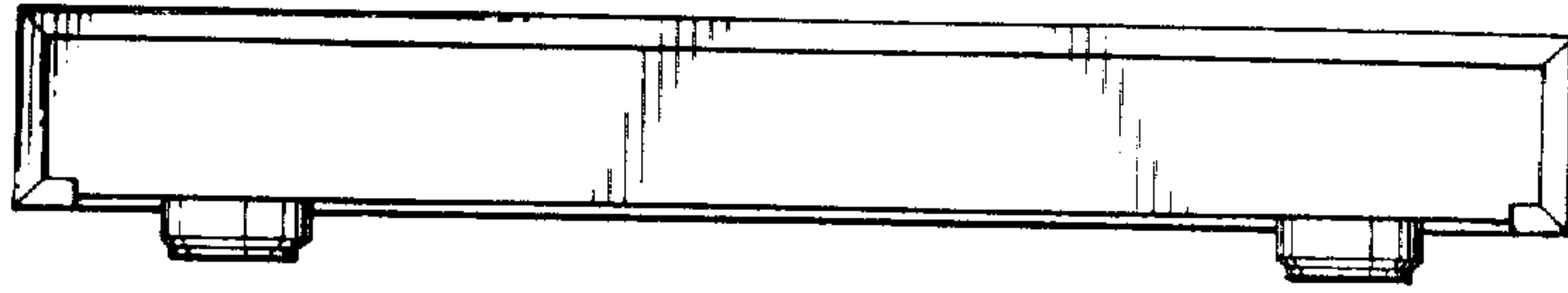

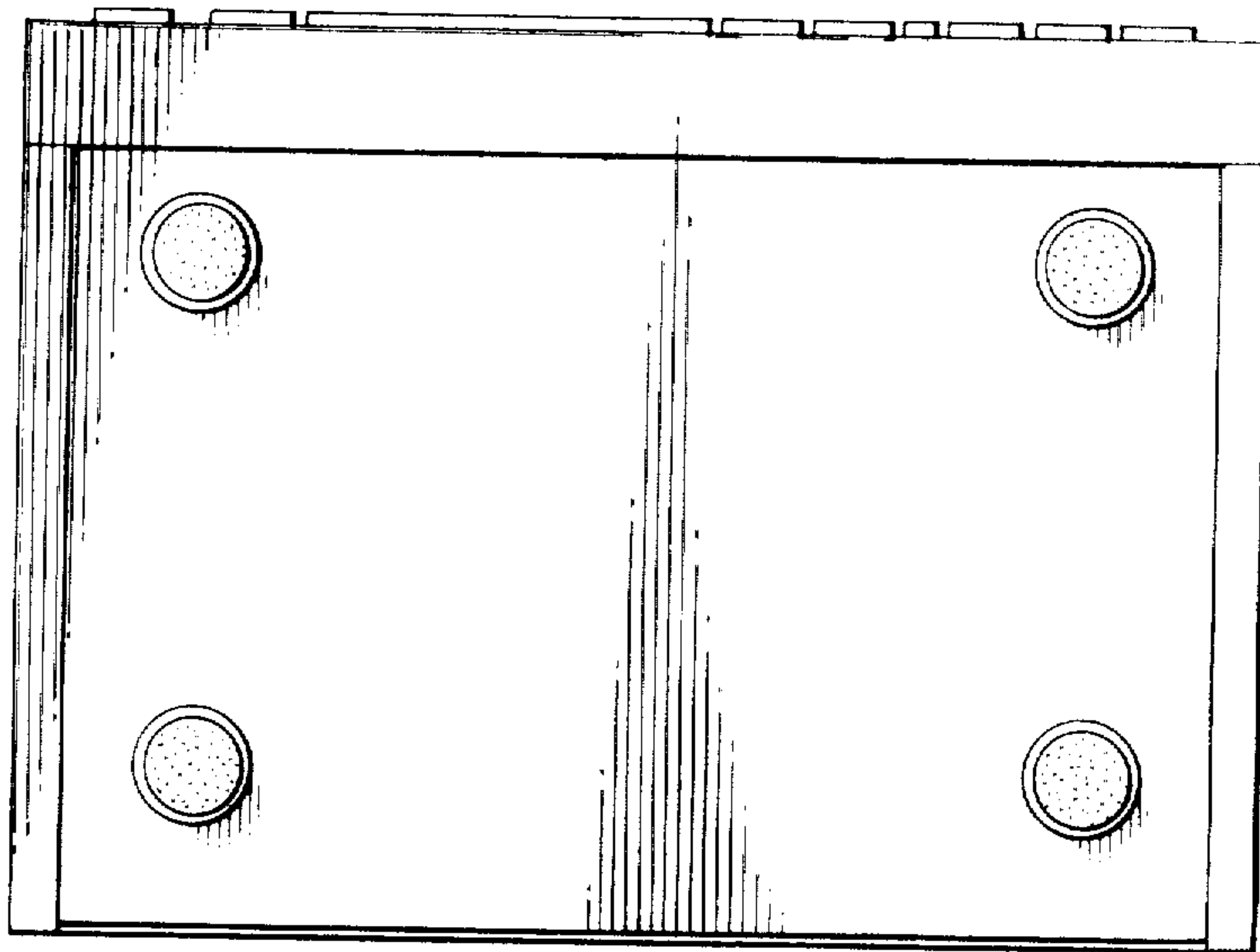
