[57] CLAIM

The ornamental design for a combined support surface and pedestal for a lavatory, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a combined support surface and pedestal for a lavatory showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a right side elevational view thereof, the left side being a mirror image of the right side shown;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a front elevational view of the support surface portion thereof;

FIG. 7 is a top plan view of FIG. 6;

FIG. 8 is a right side elevational view of FIG. 6, the left side being a mirror image of the right side shown;

FIG. 9 is a rear elevational view of FIG. 6;

FIG. 10 is a bottom plan view of FIG. 6;

FIG. 11 is a front elevational view of the pedestal portion thereof;

FIG. 12 is a right side elevational view of FIG. 11, the left side being a mirror image of the right side shown;

FIG. 13 is a rear elevational view of FIG. 11;

FIG. 14 is a top plan view of FIG. 11; and

FIG. 15 is a bottom plan view of FIG. 11.

The broken line representation of a lavatory in FIGS. 2 and 7 are for purposes of illustration only.

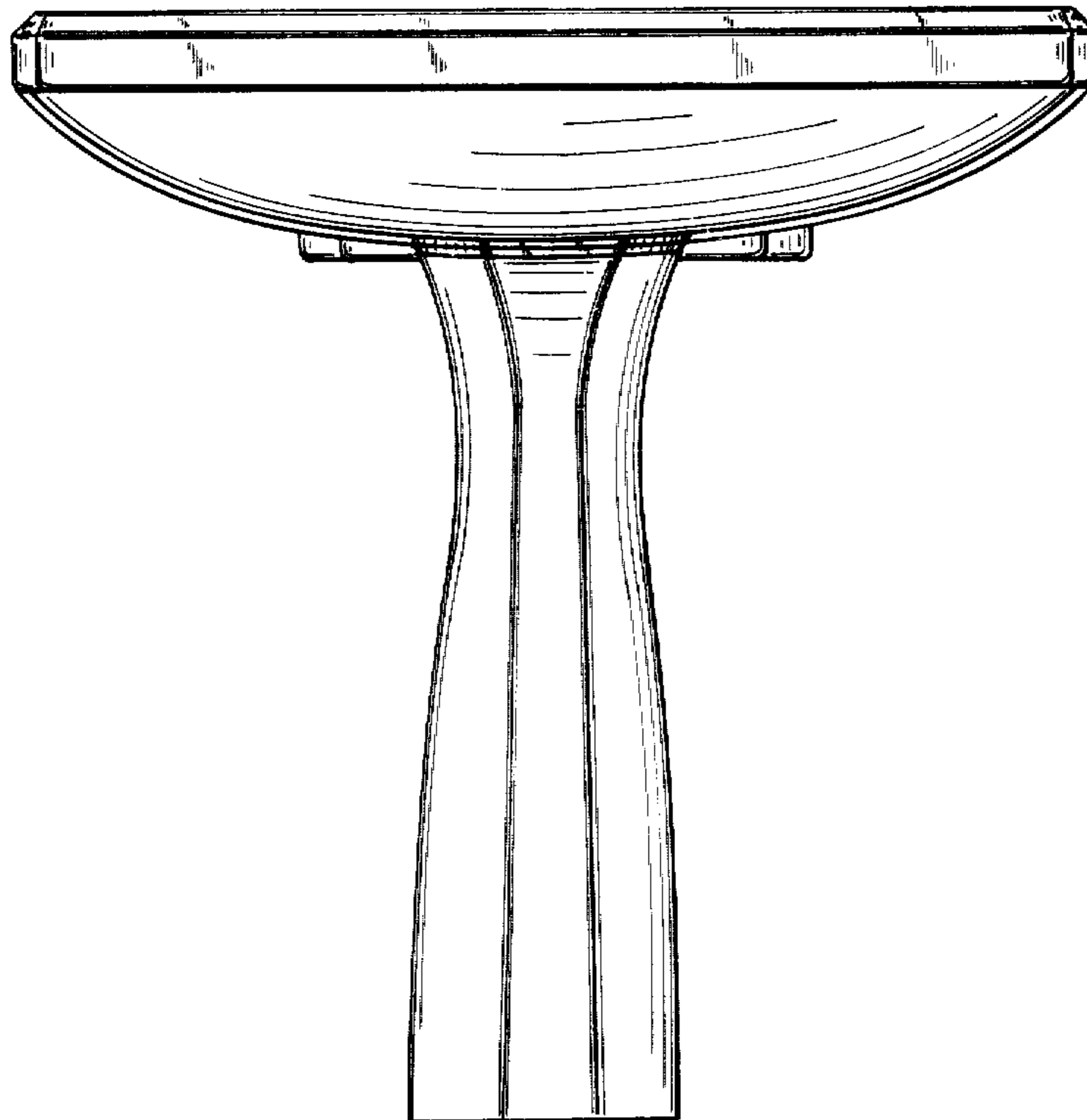

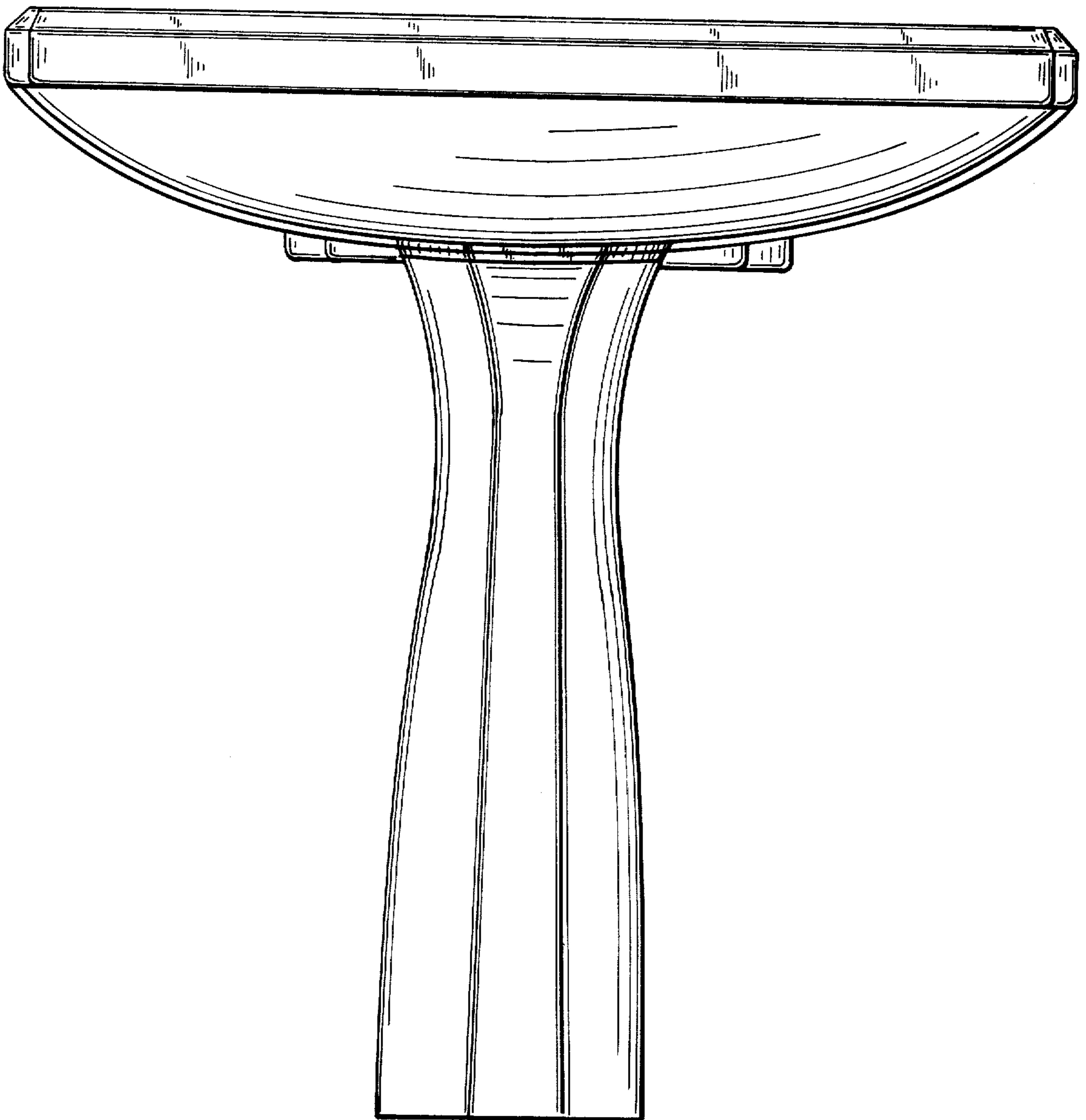
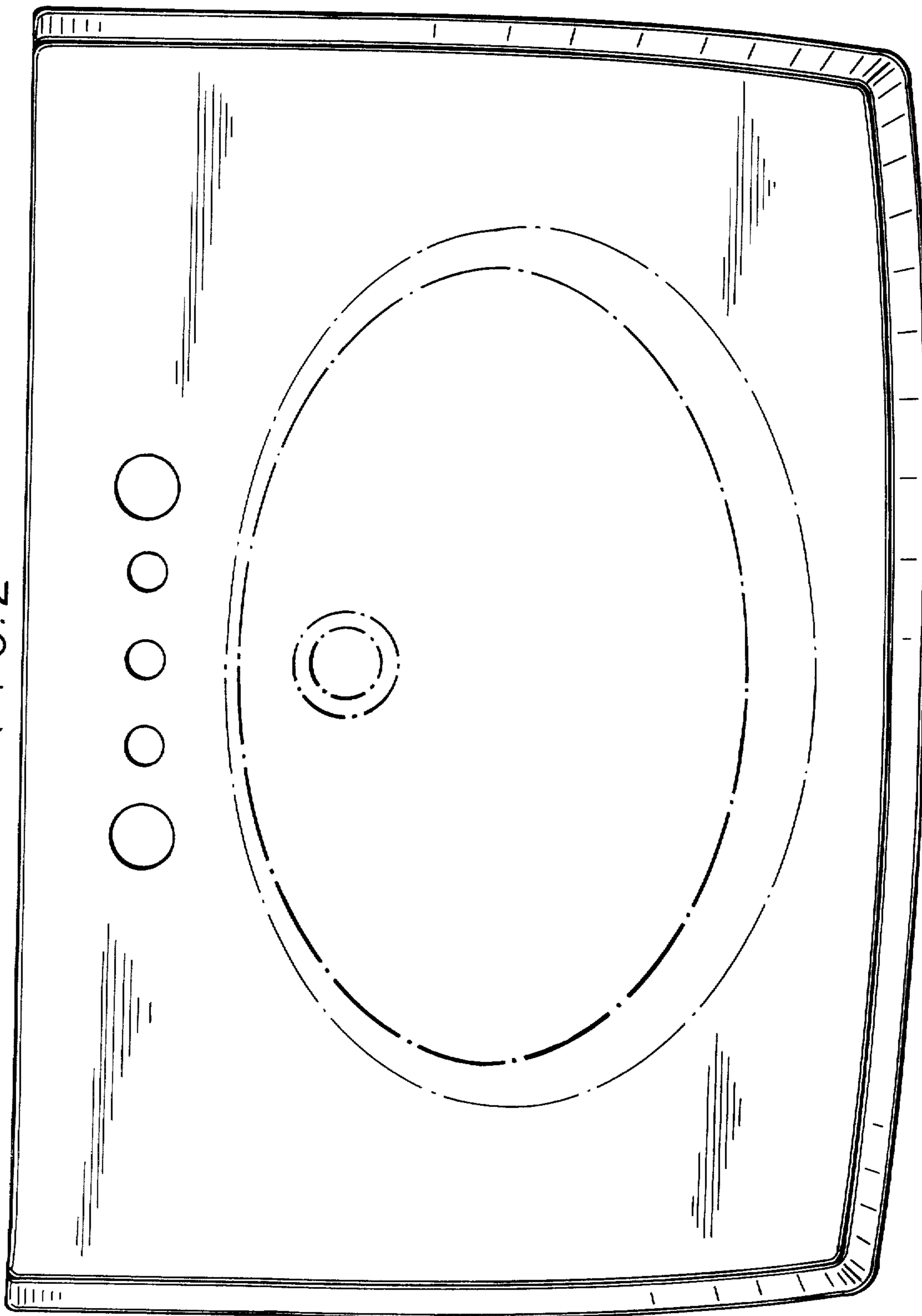

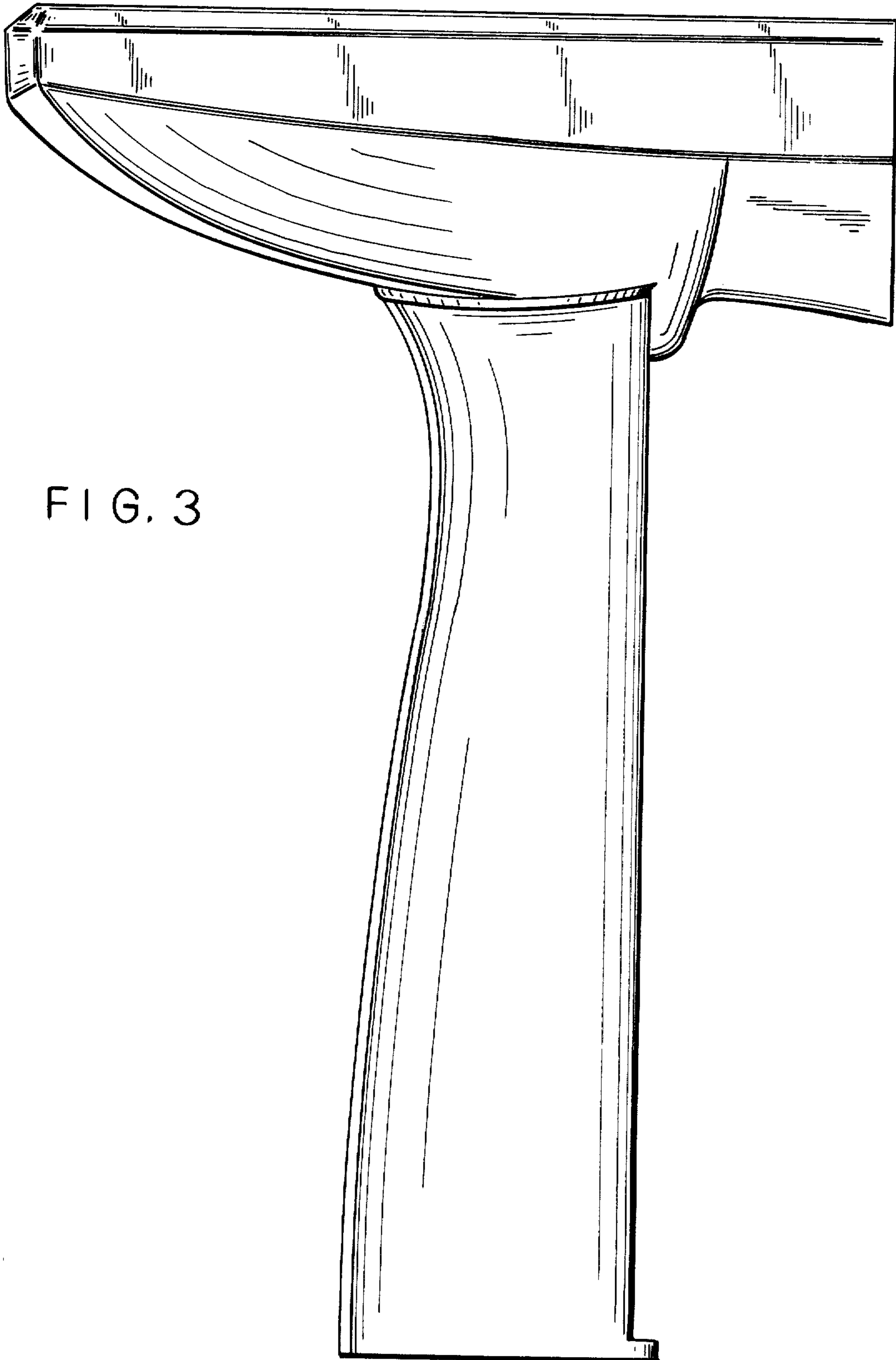

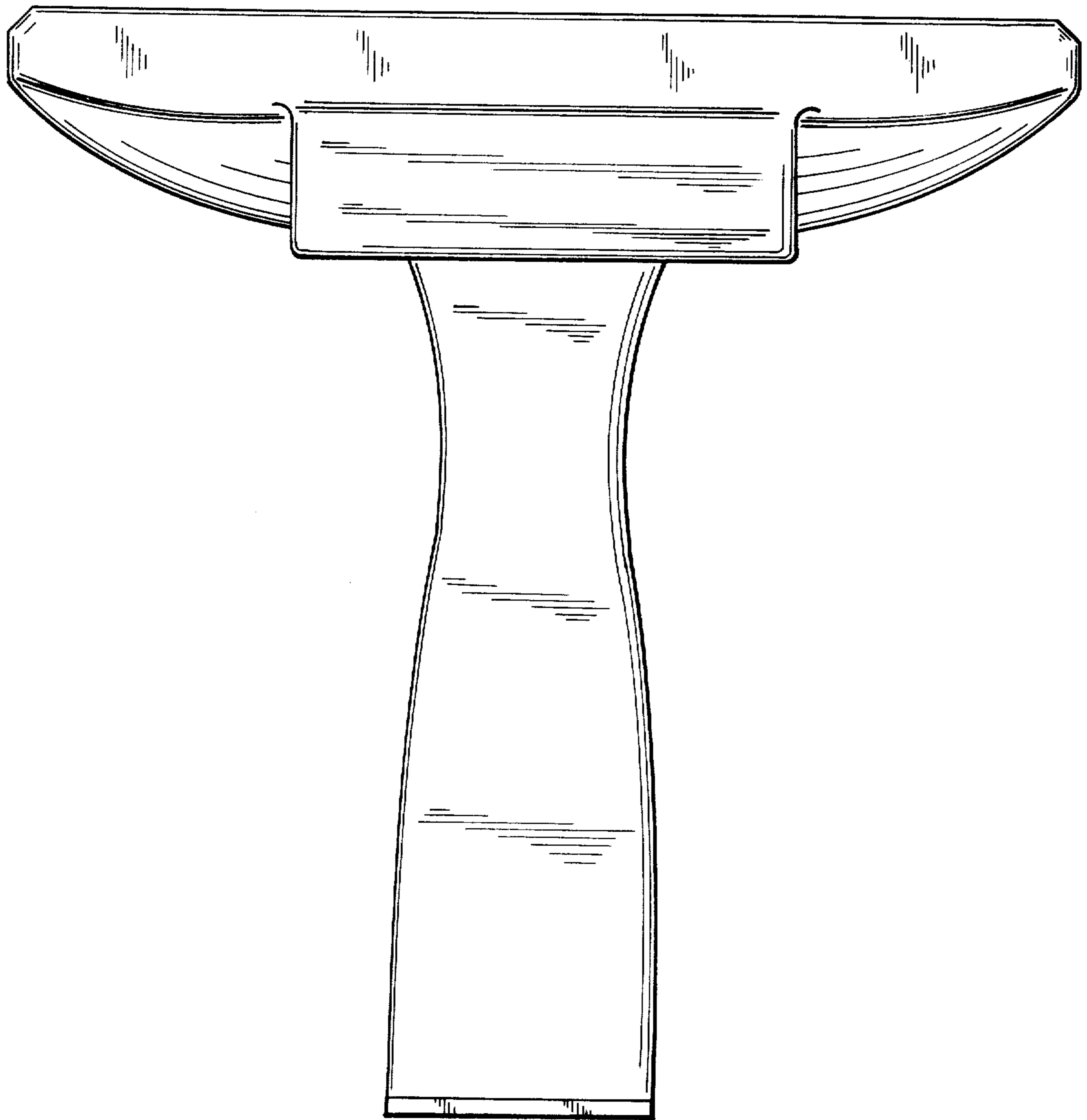

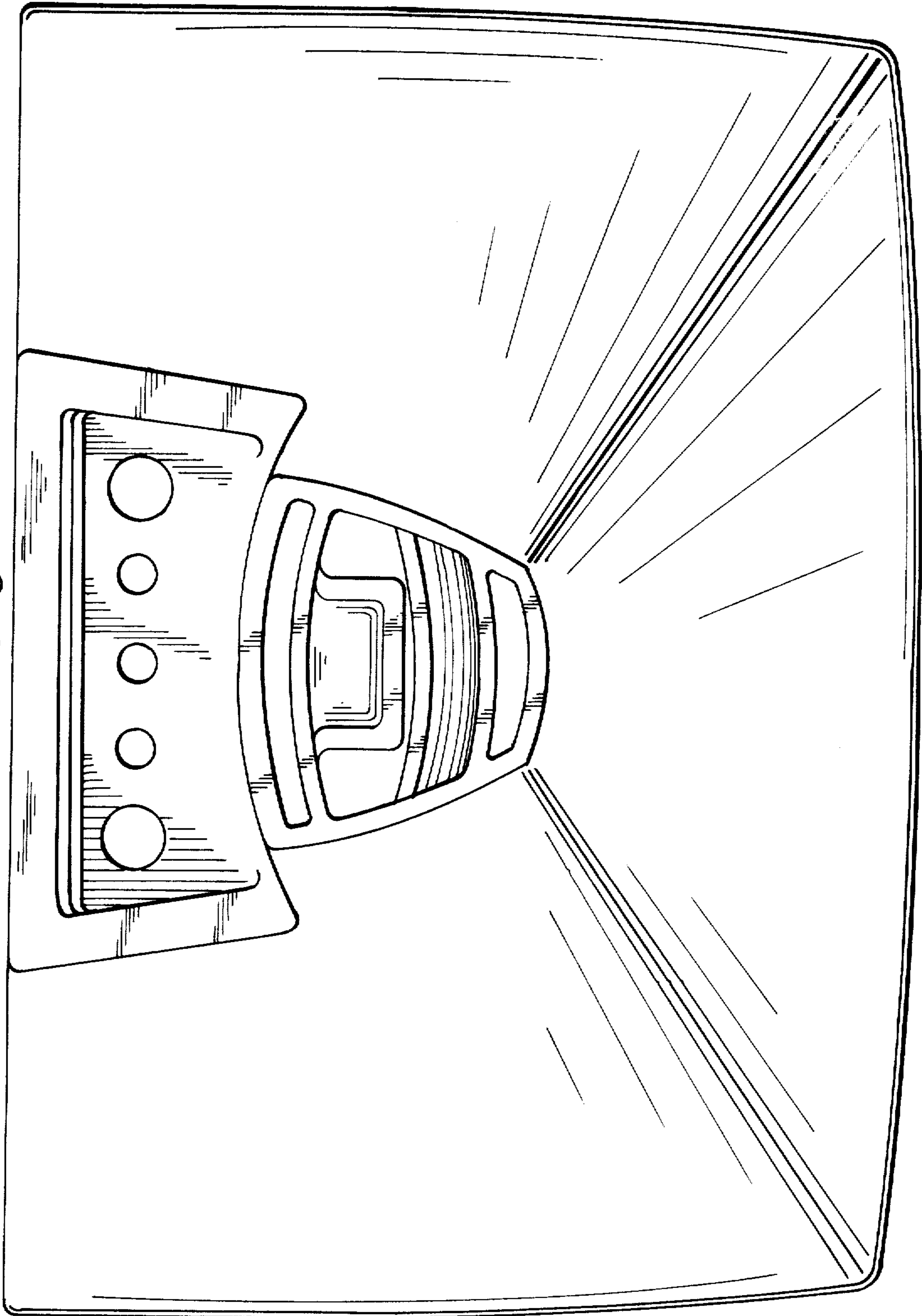

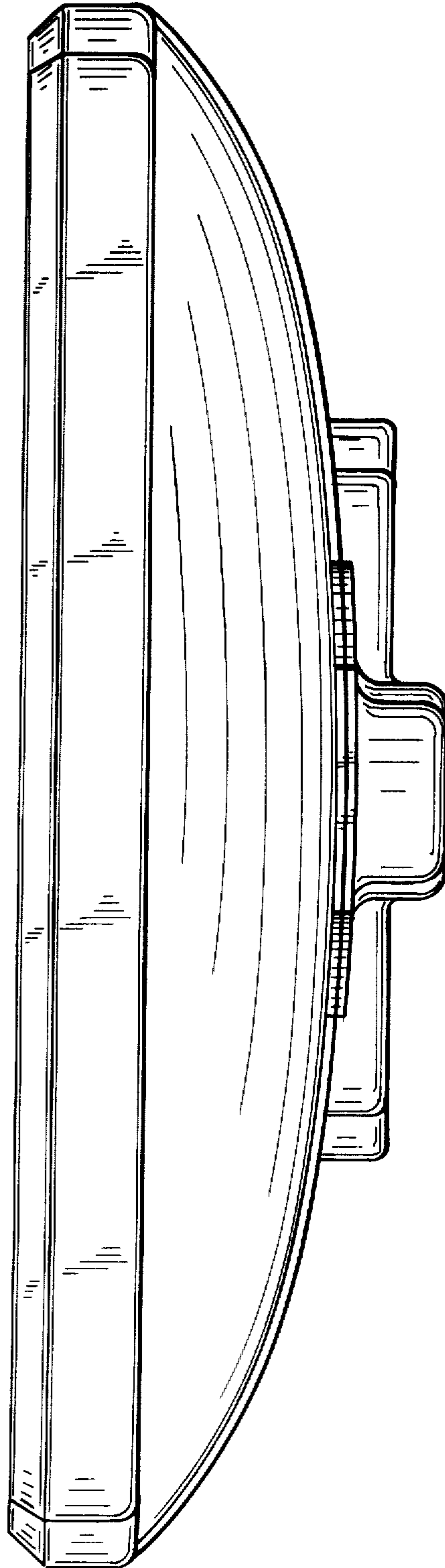

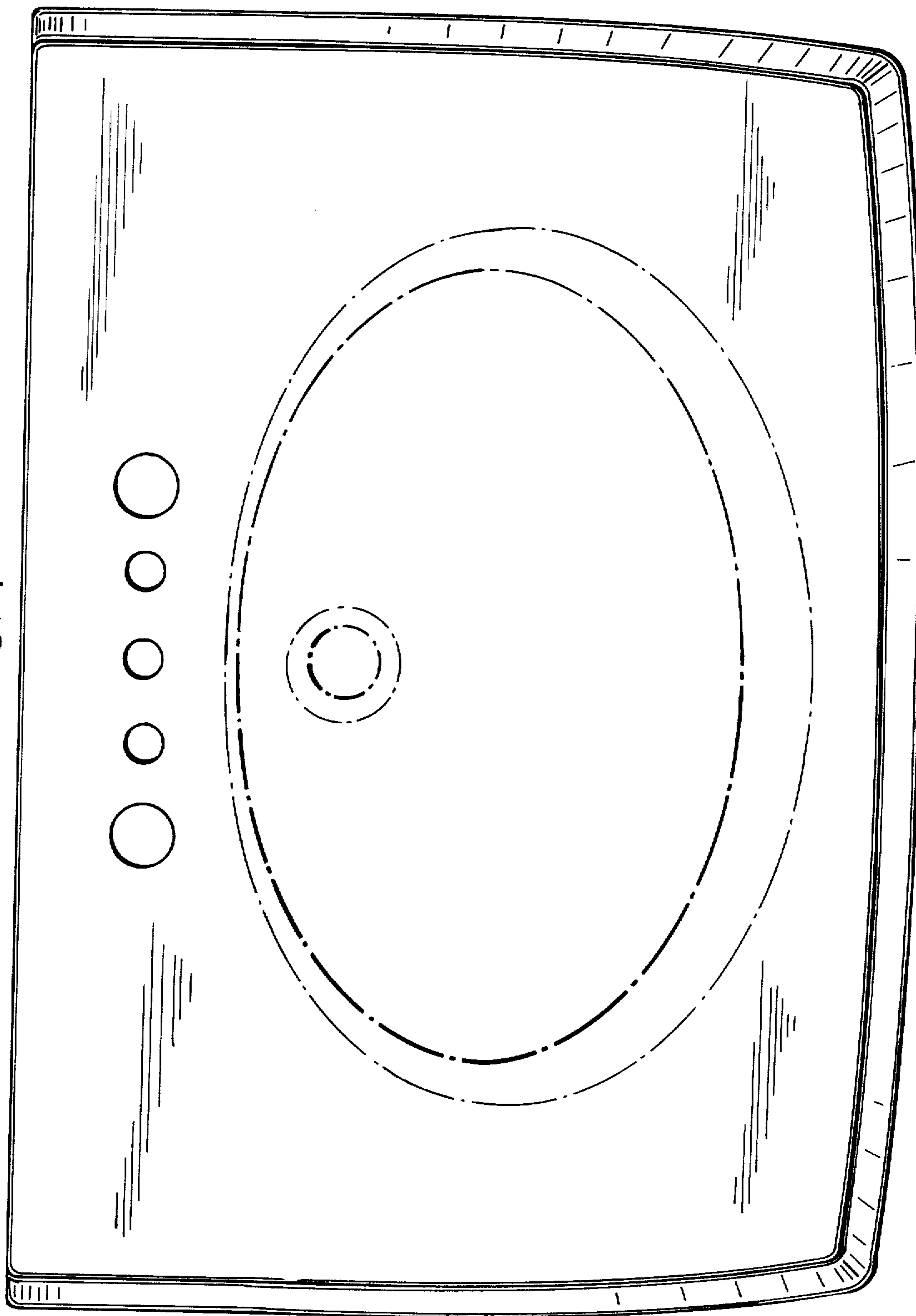

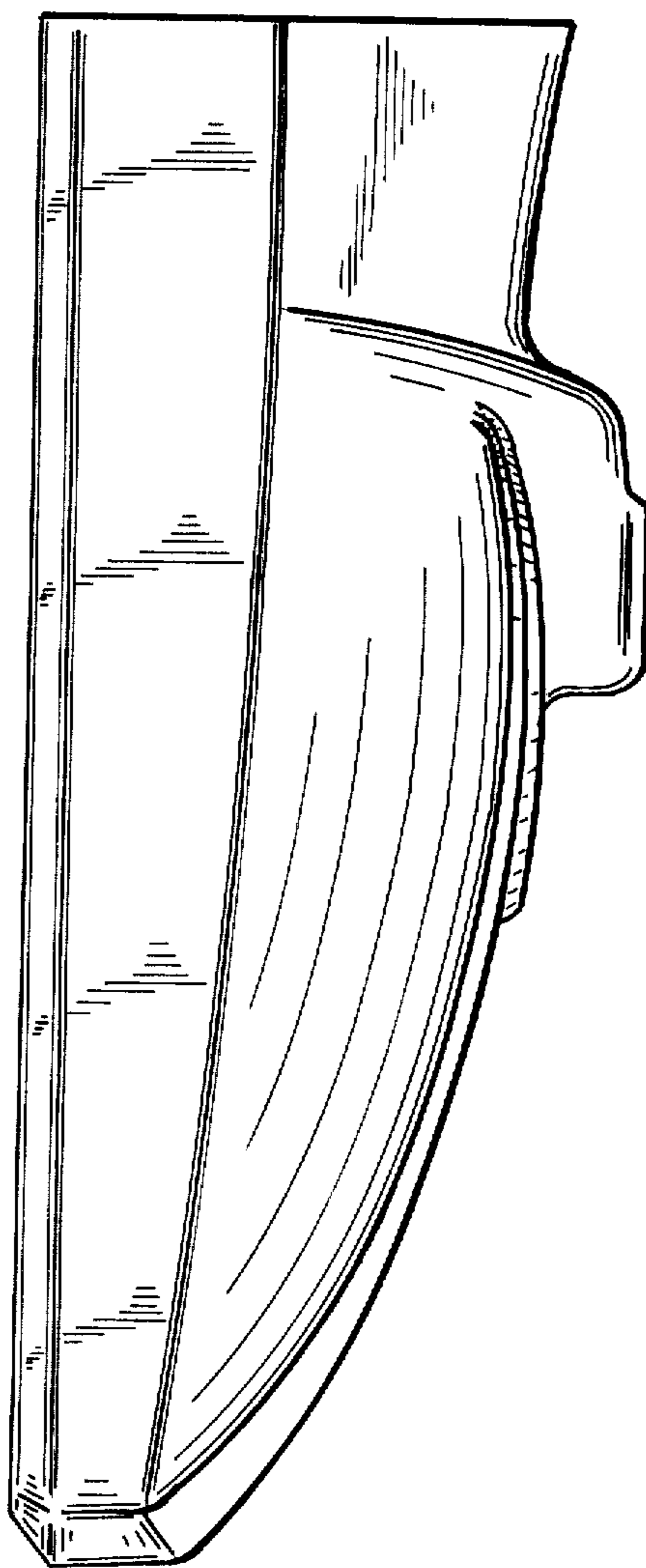

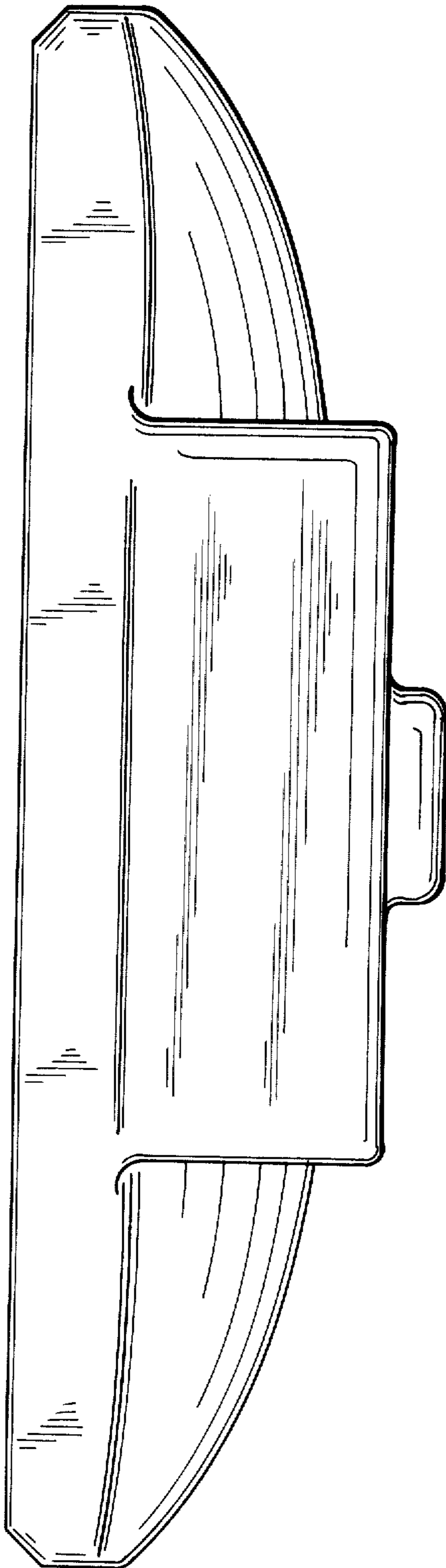

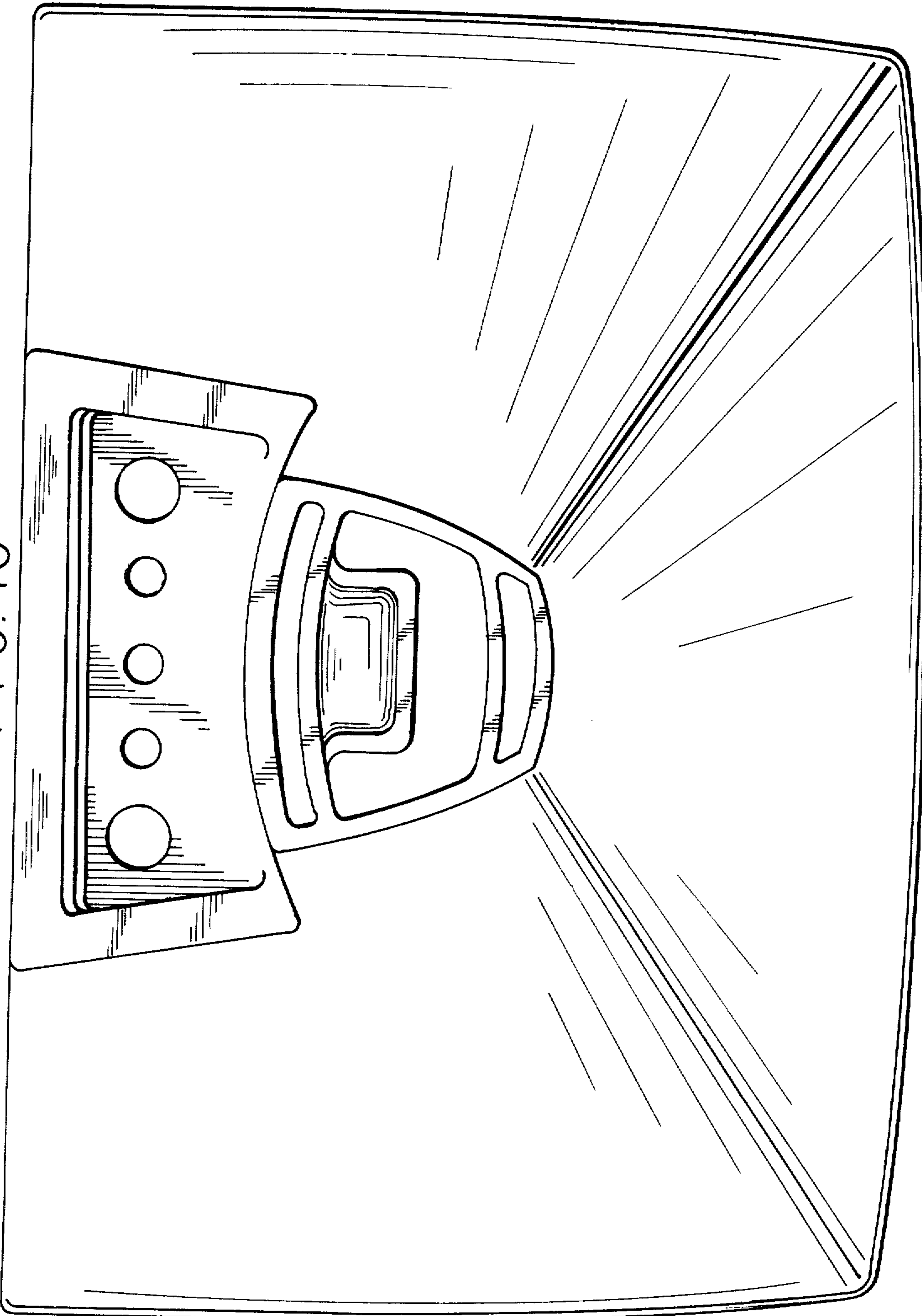

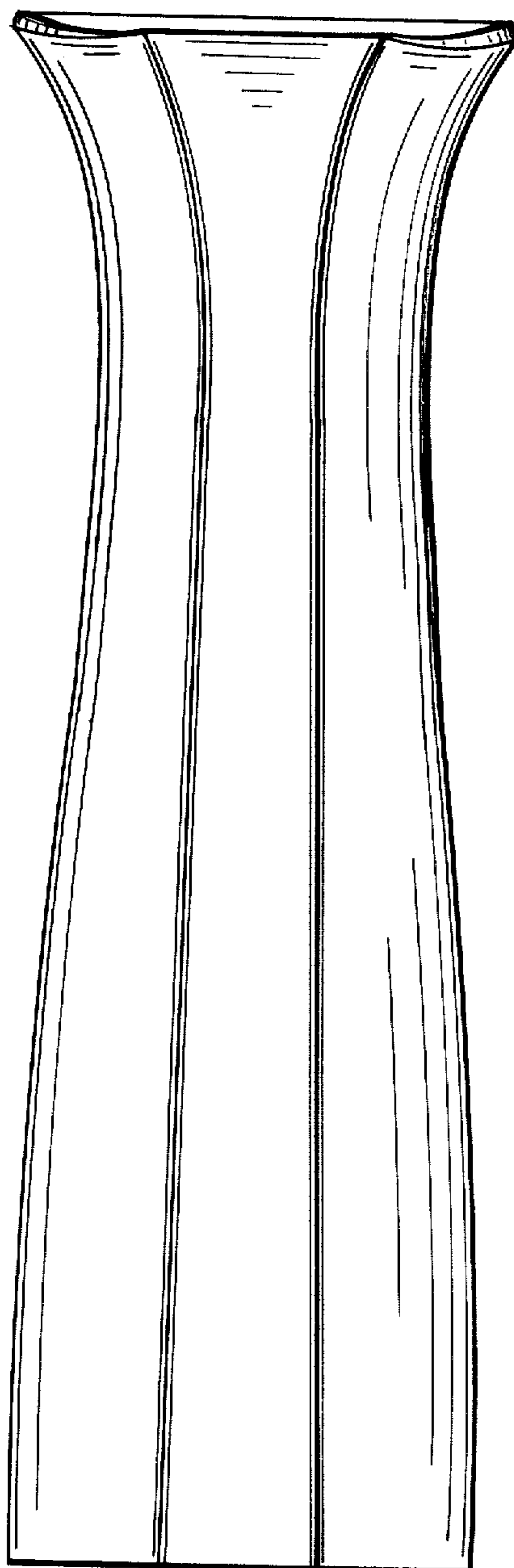

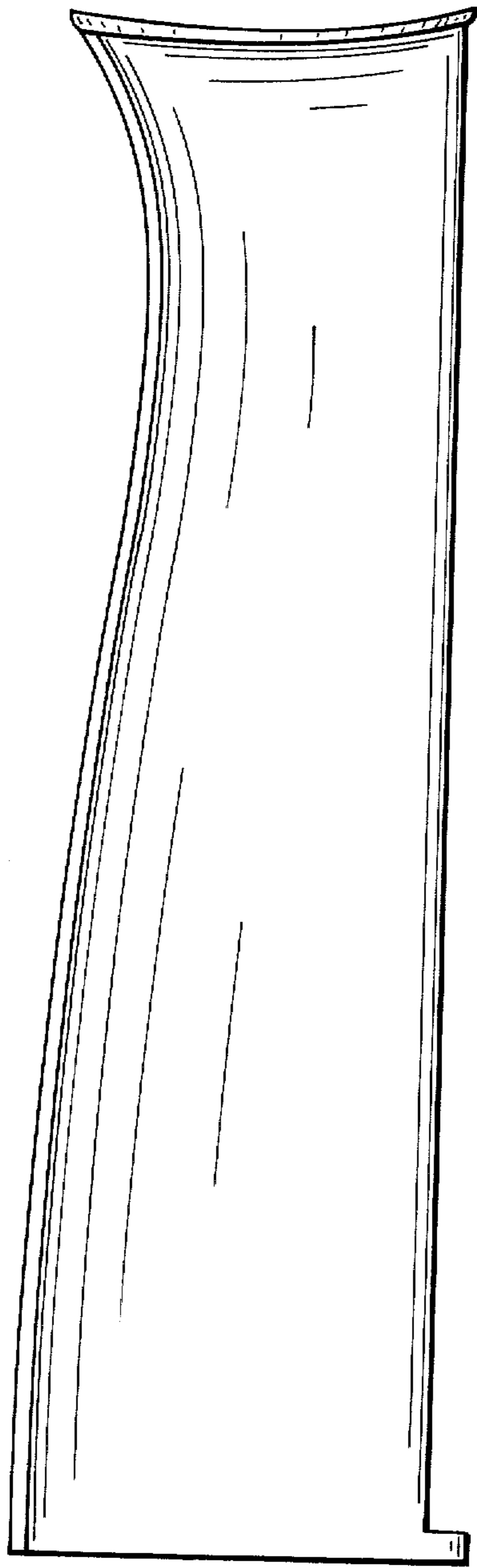

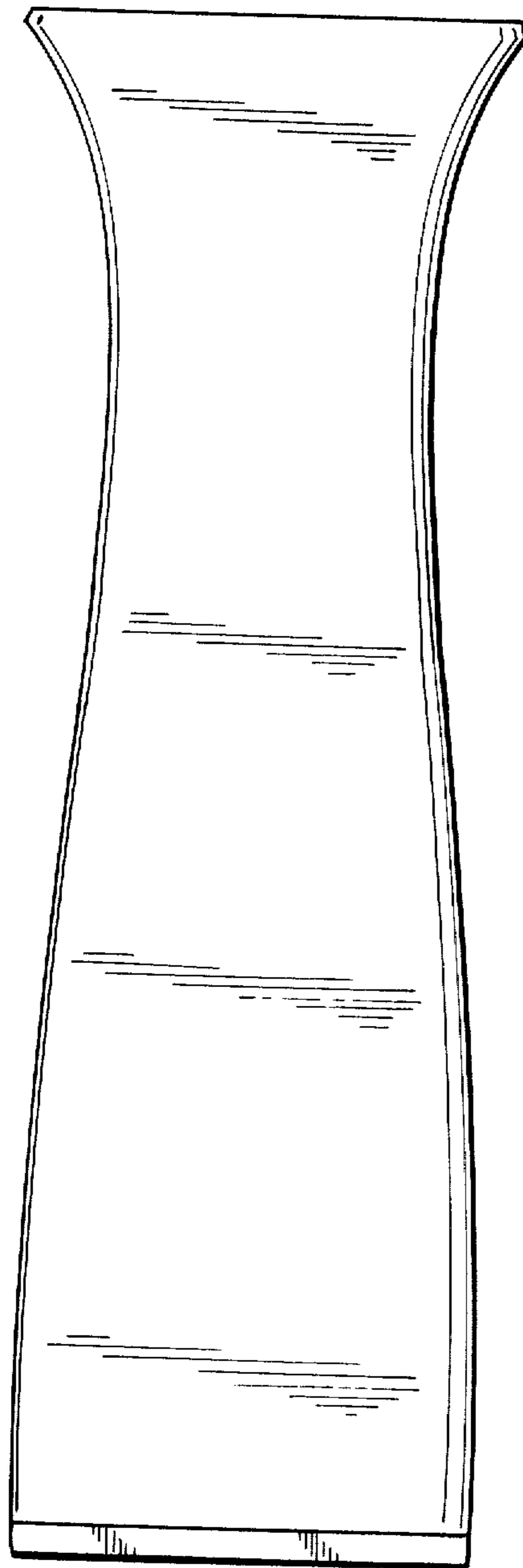

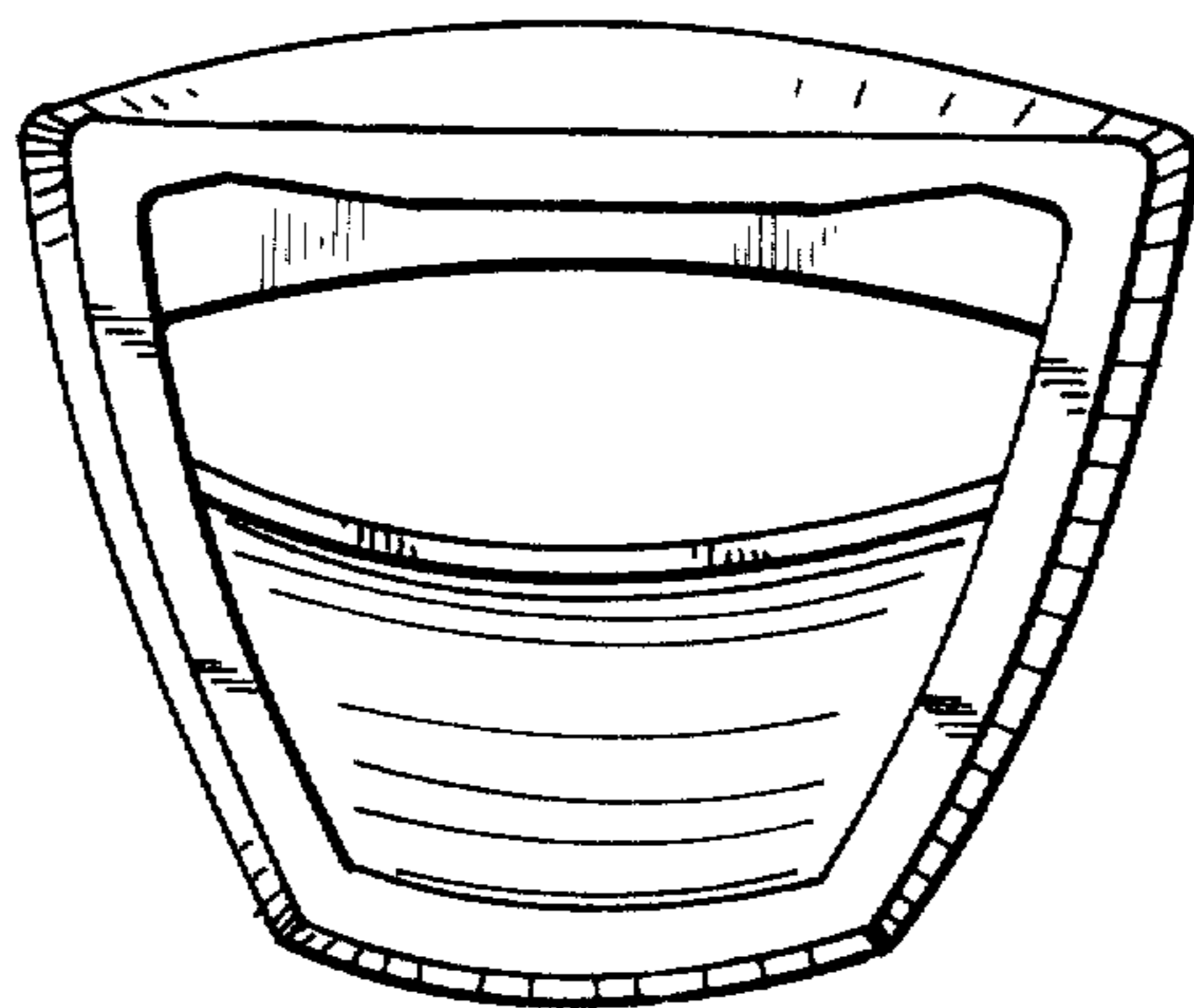
