The ornamental design for a fuel dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a fuel dispenser showing our new design;

FIG. 2 is a top plan view thereof, a portion of the hose being shown in broken lines for convenience of illustration;

FIG. 3 is a right side elevation view thereof;

FIG. 4 is a front elevation view of another embodiment of our new design of FIG. 1;

FIG. 5 is a top plan view thereof, a portion of the hose being shown in broken lines for convenience of illustration; and

FIG. 6 is a side elevation view common for both sides of FIG. 4 and the left side of FIG. 1;

FIG. 7 is a front elevation view of another embodiment of our new design of FIG. 1;

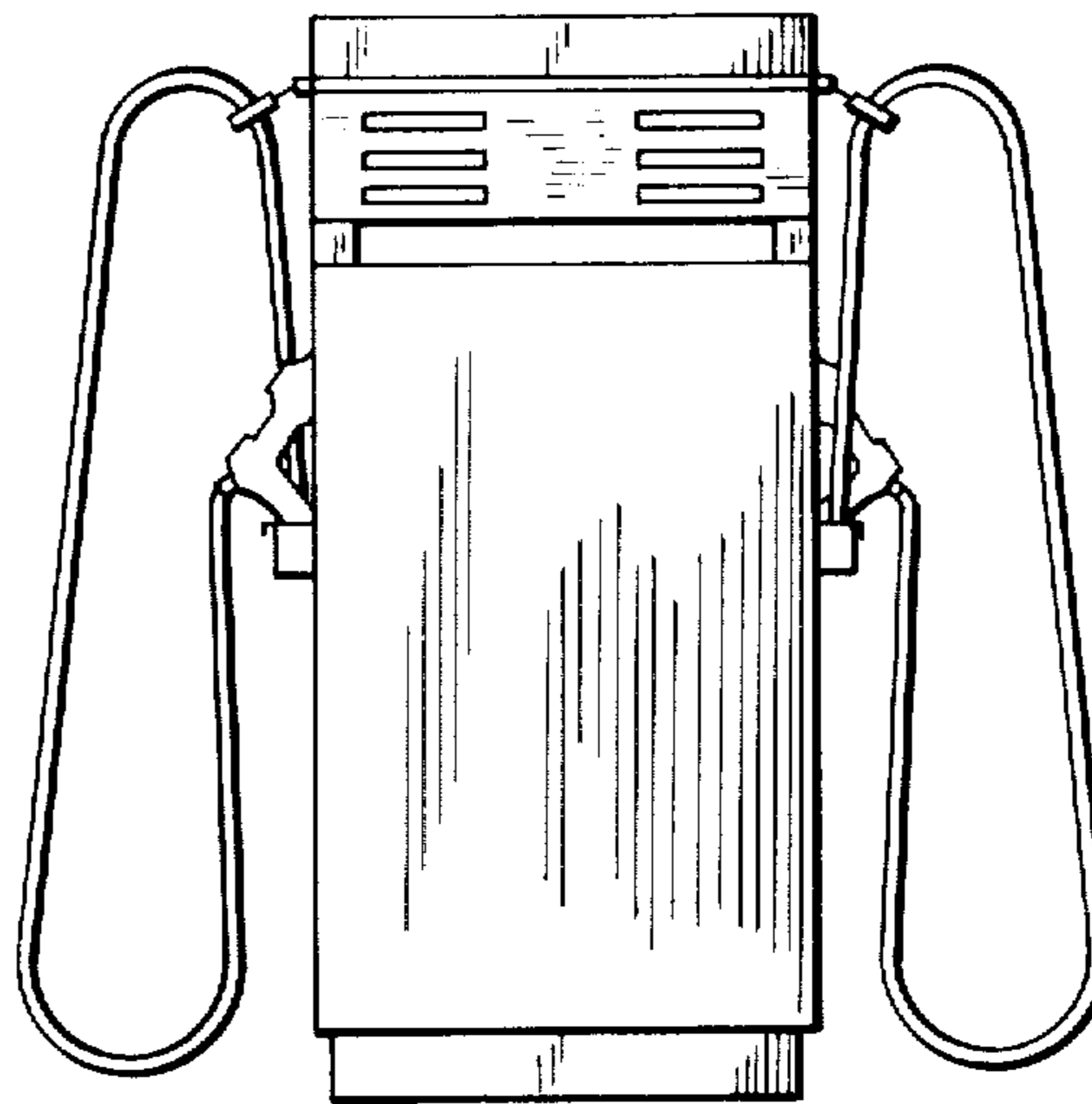
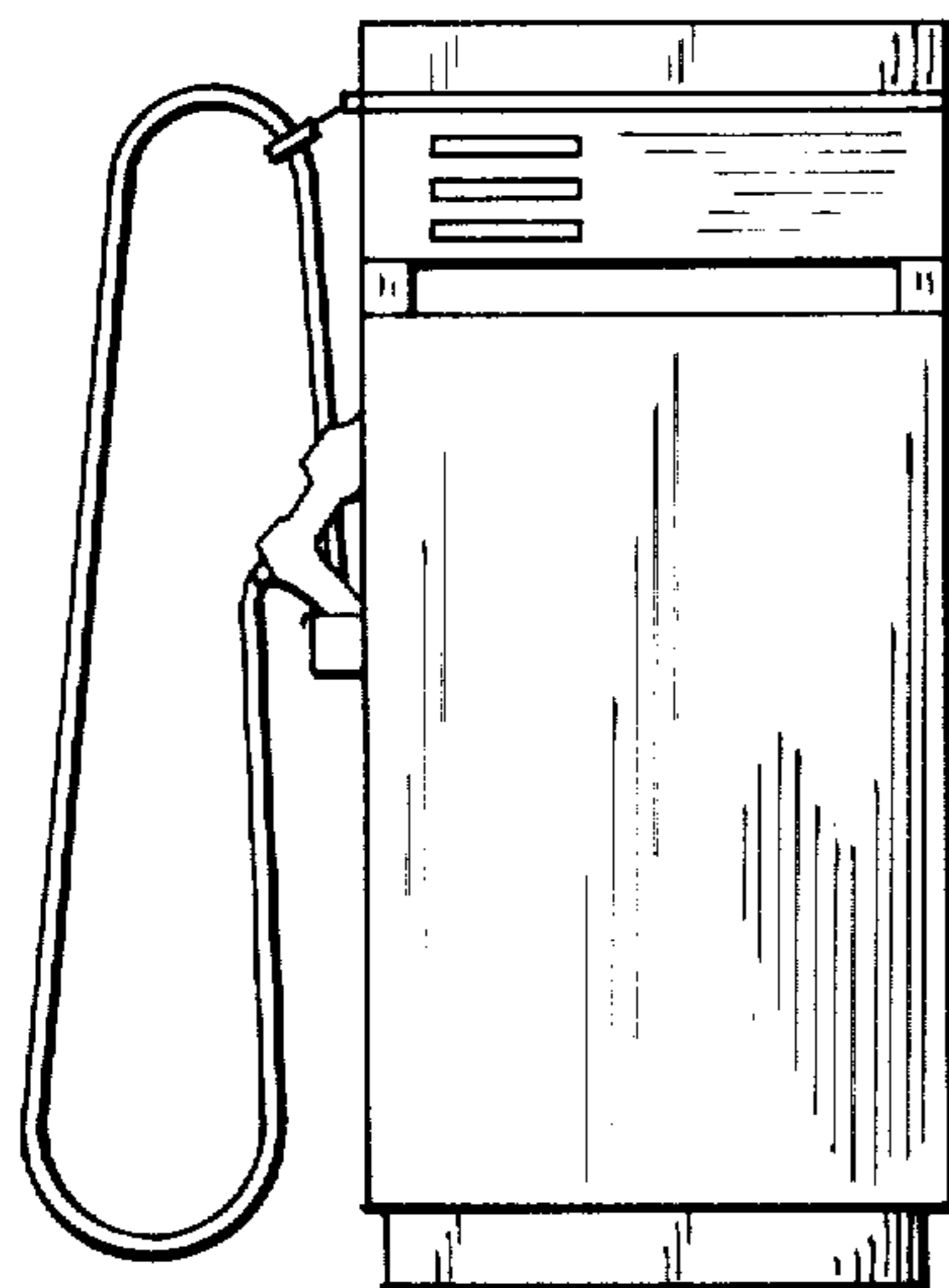
FIG. 8 is a top plan view thereof, a portion of the hose being shown in broken lines for convenience of illustration; and

FIG. 12 is a side elevation view common for both sides of FIG. 10 and the left side of FIG. 7;



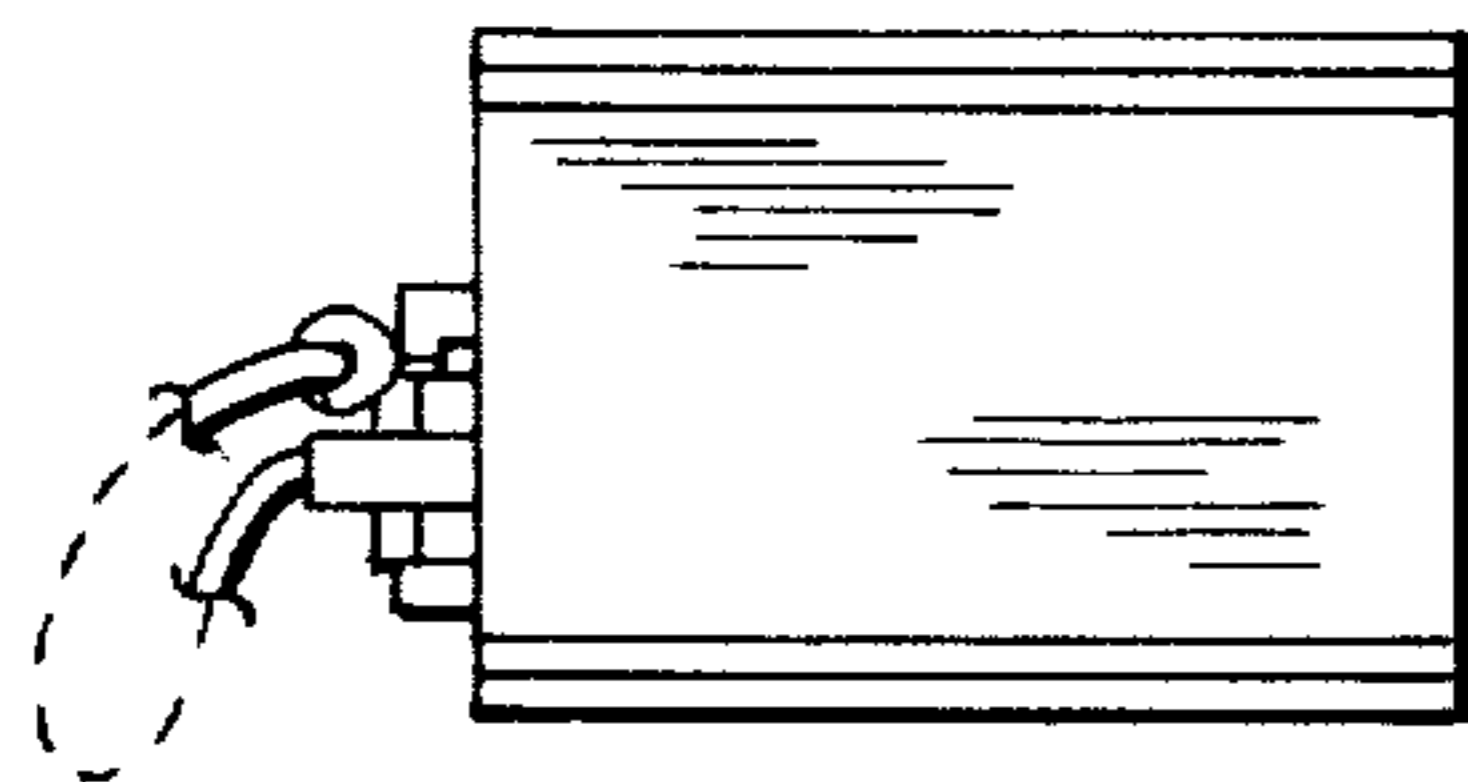

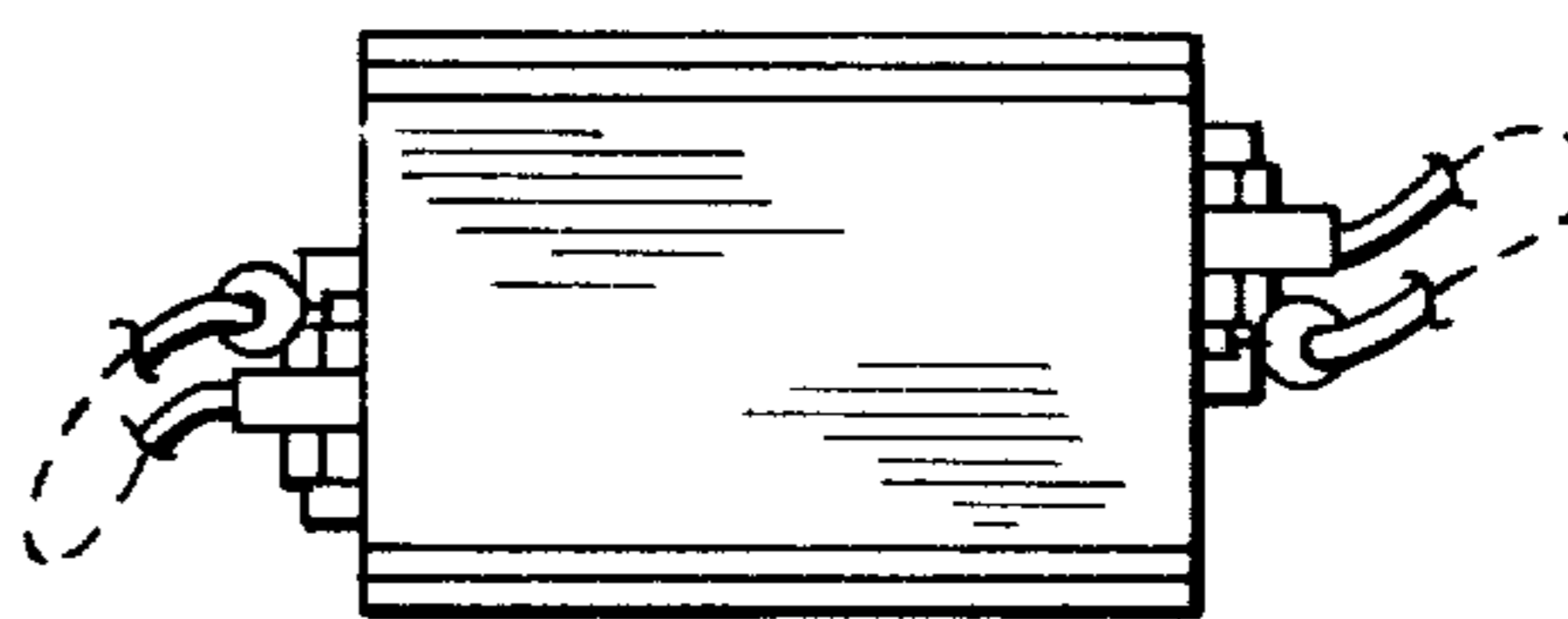

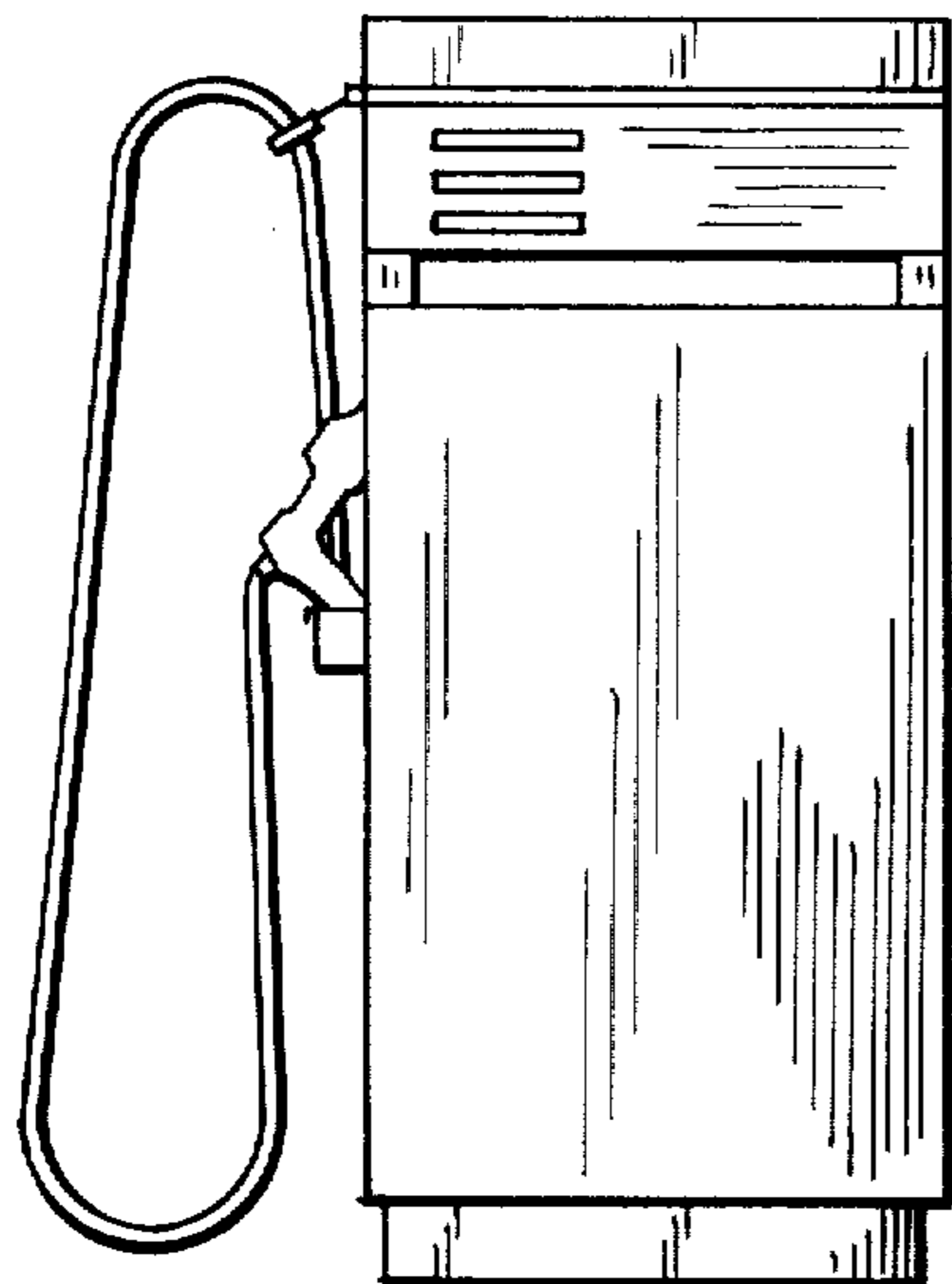

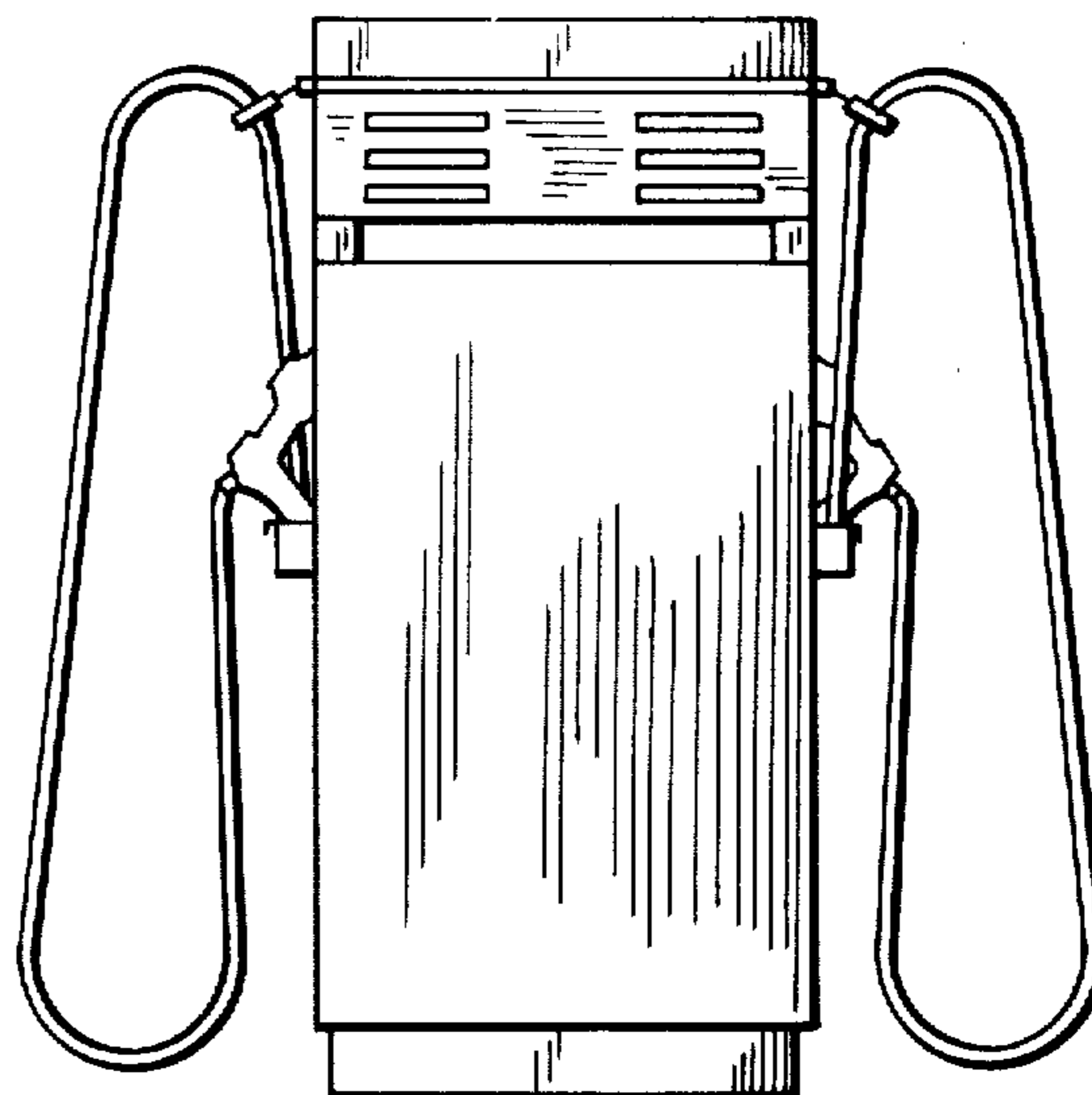

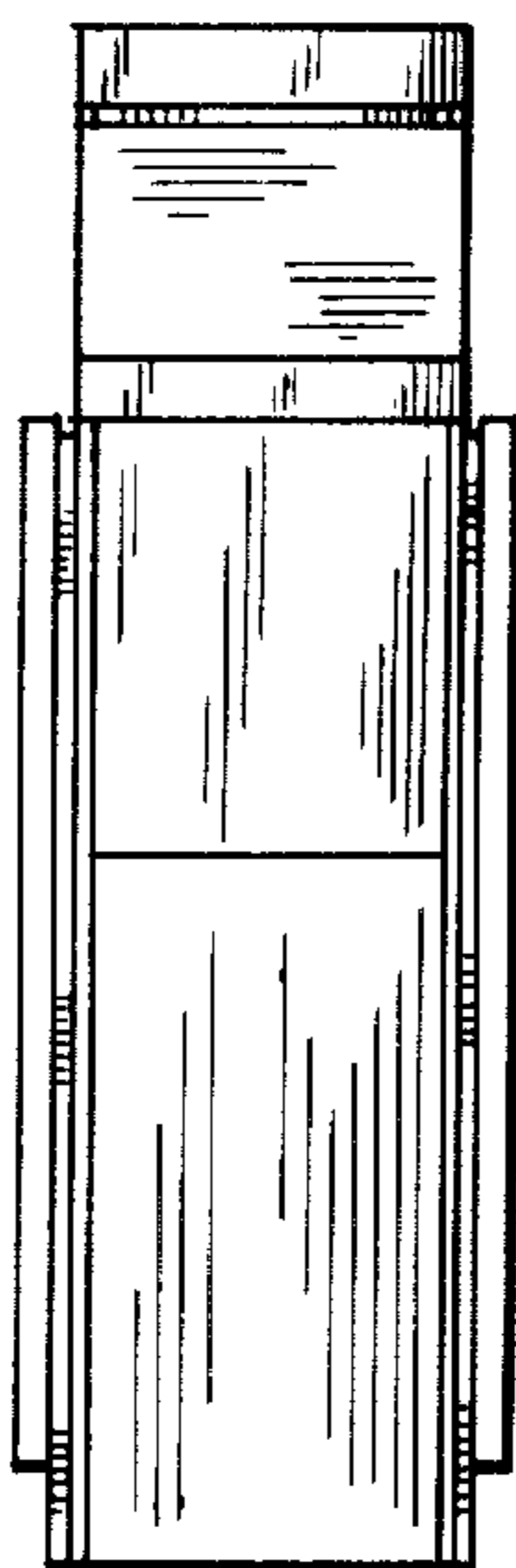

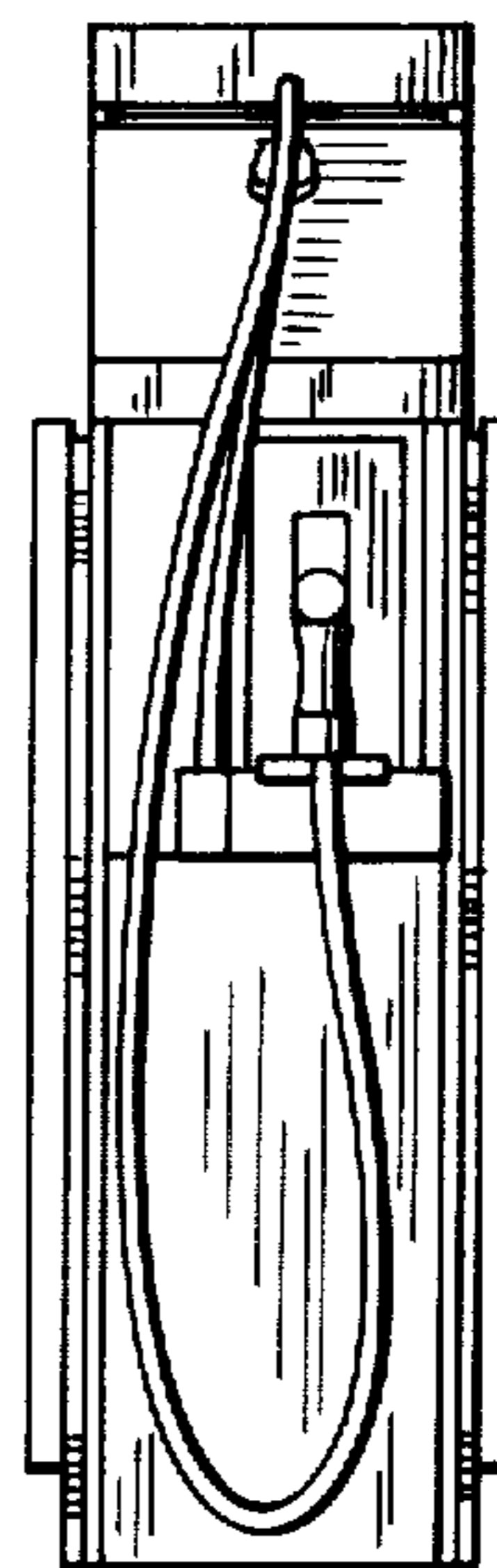

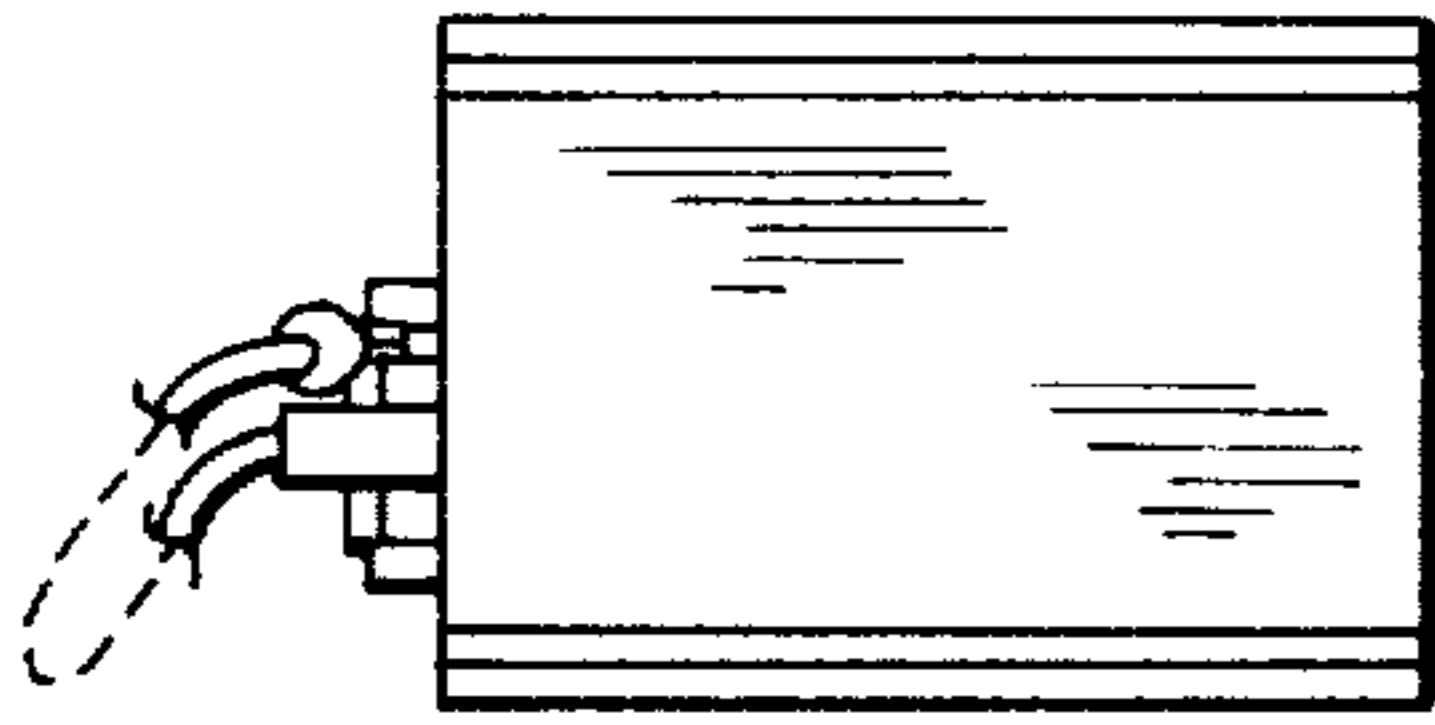

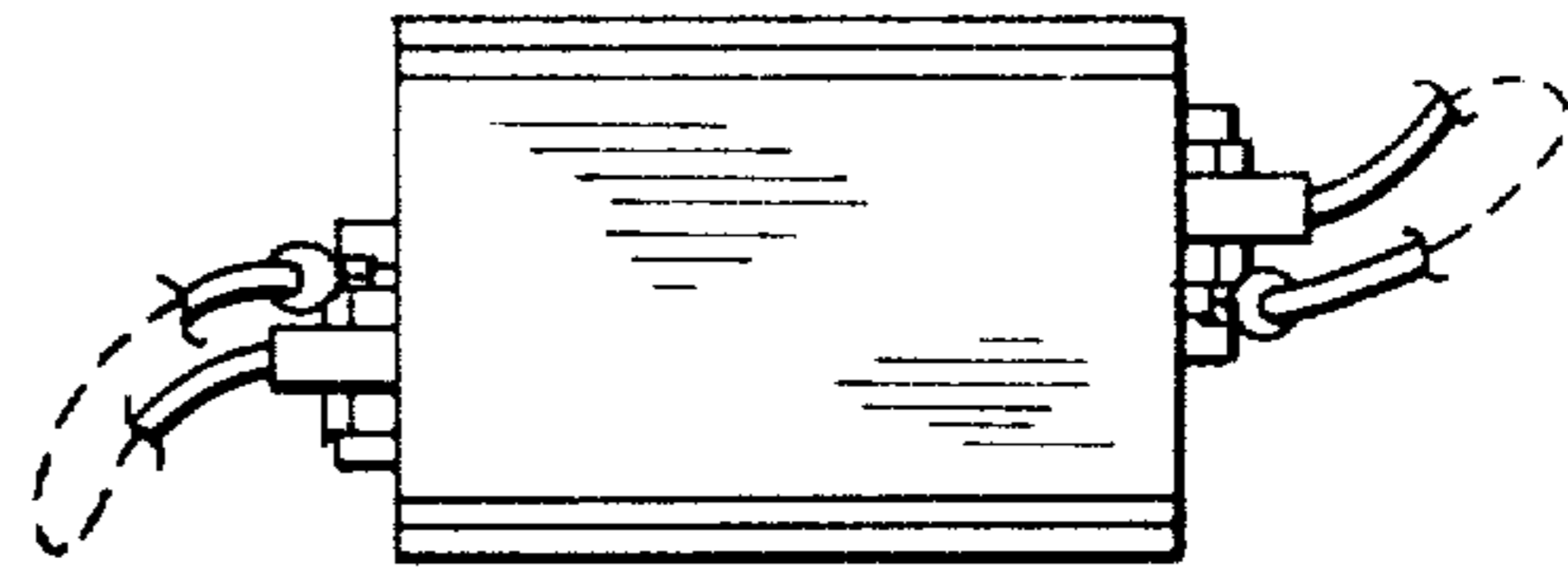

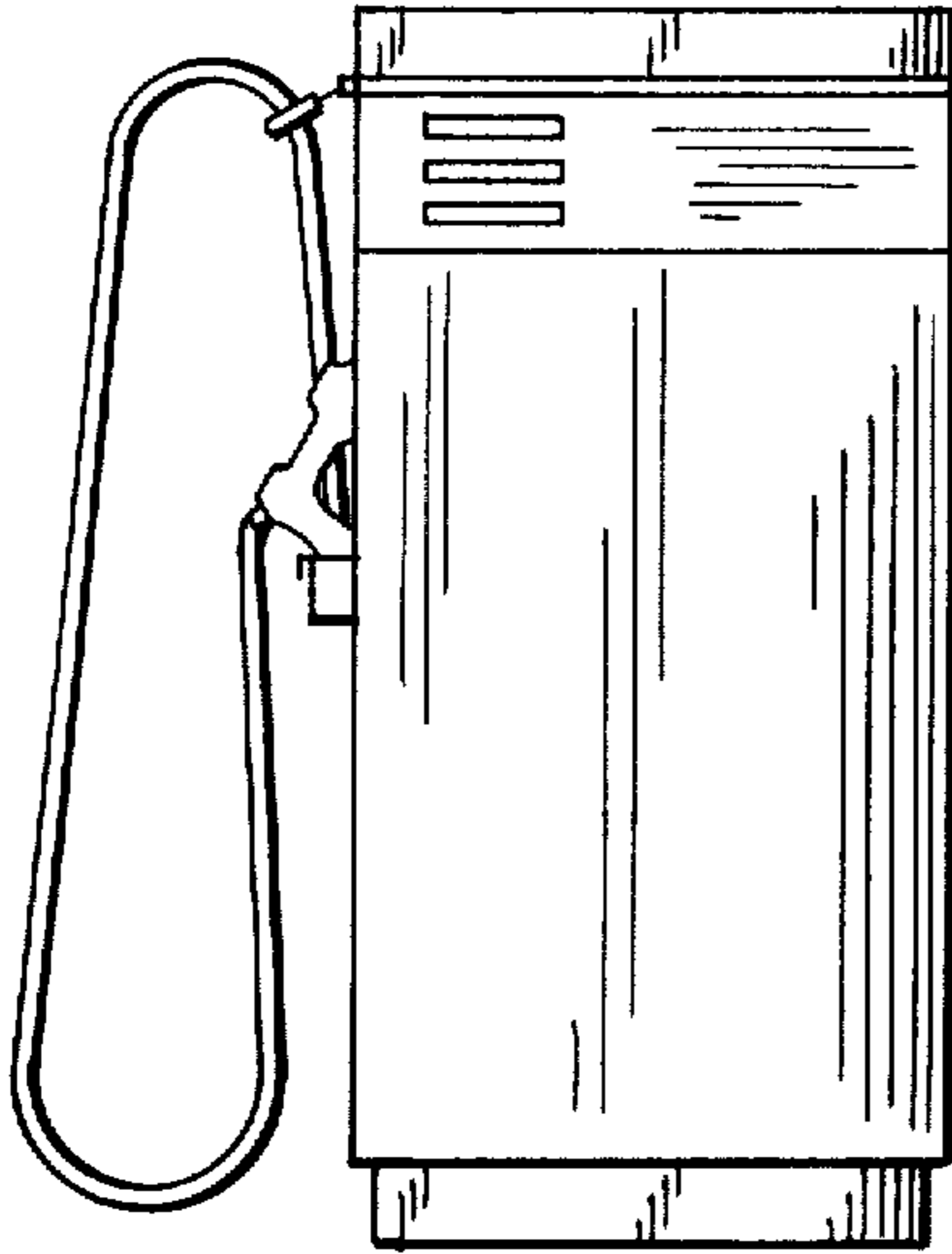

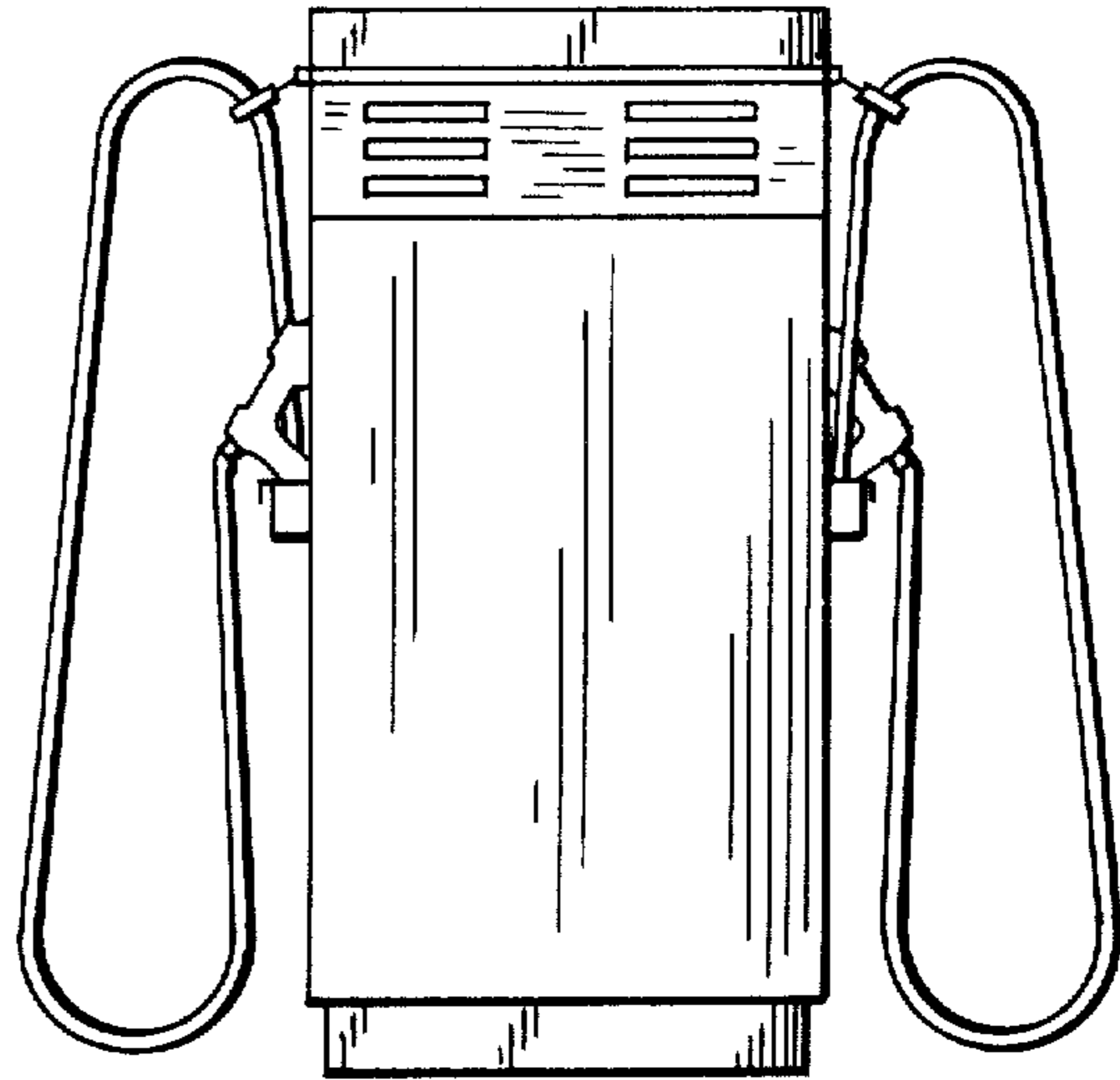

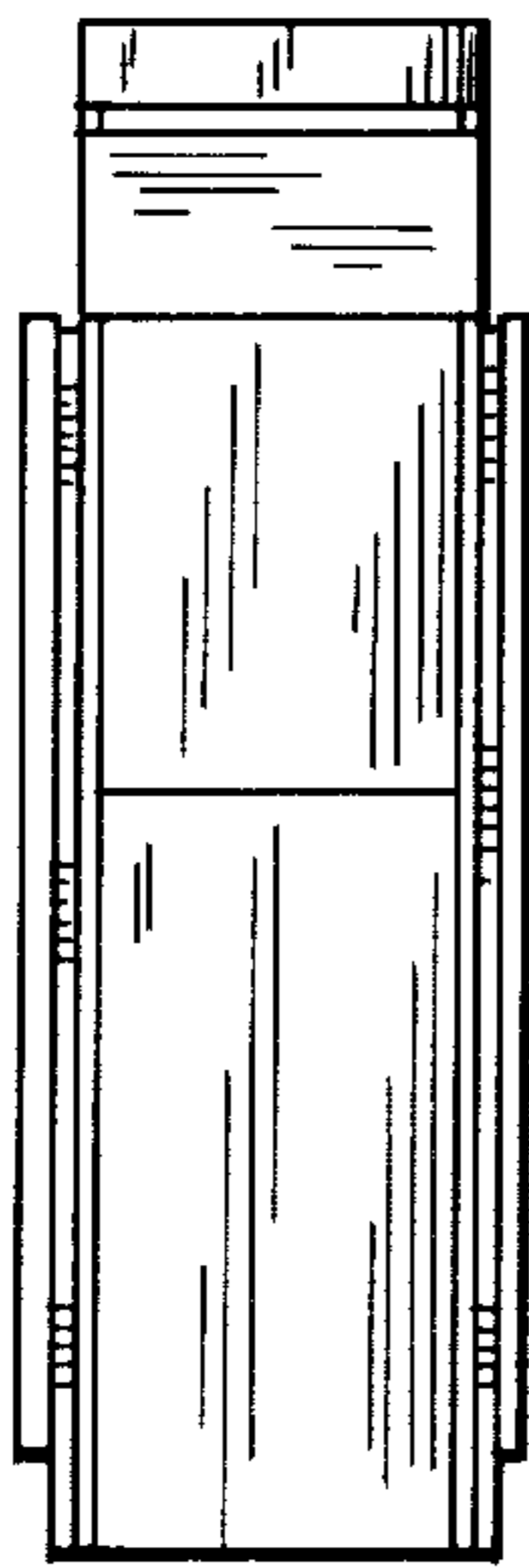

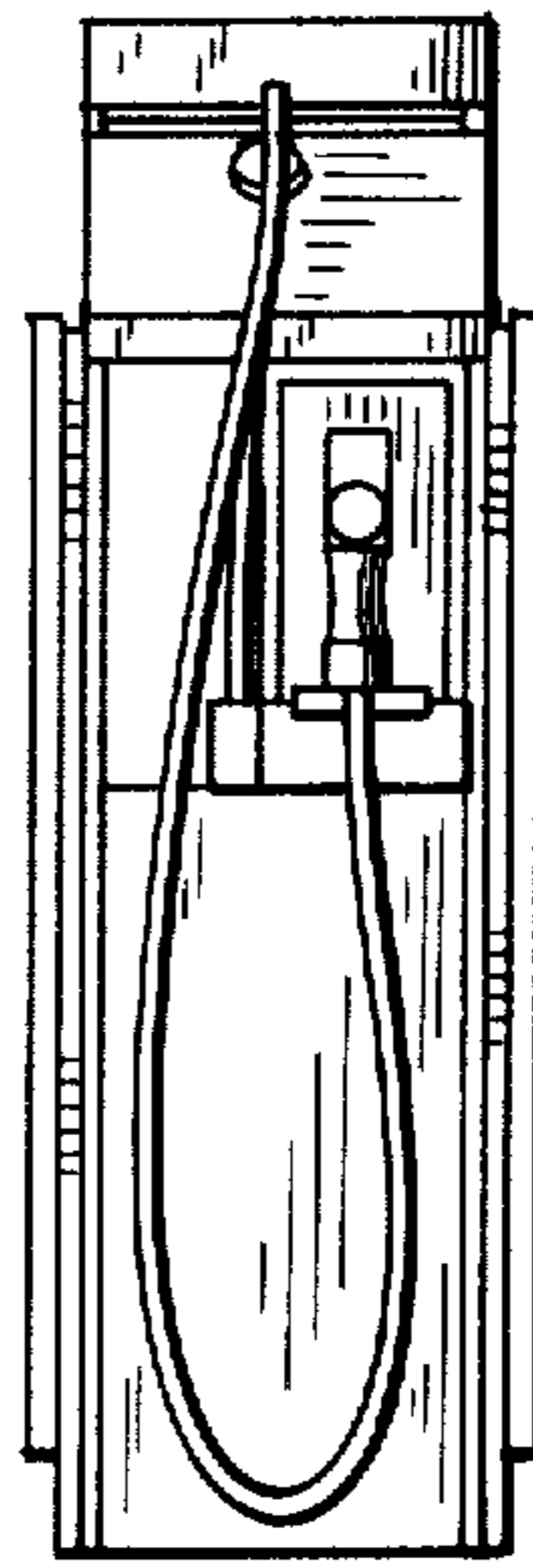
