[57] CLAIM

The ornamental design for a blood pressure measuring instrument or similar article, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first embodiment of our blood pressure measuring instrument or similar article showing our new design;

FIG. 2 is a side view thereof, viewed from the left side of FIG. 1;

FIG. 3 is a rear view thereof;

FIG. 4 is a side view, opposite to the side shown in FIG. 2;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a front view of a second embodiment of our blood pressure measuring instrument or similar article;

FIG. 8 is a side view thereof, viewed from the left side of FIG. 7;

FIG. 9 is a rear view thereof;

FIG. 10 is a side view, opposite to the side shown in FIG. 8;

FIG. 11 is a top plan view thereof; and

FIG. 12 is a bottom plan view thereof.

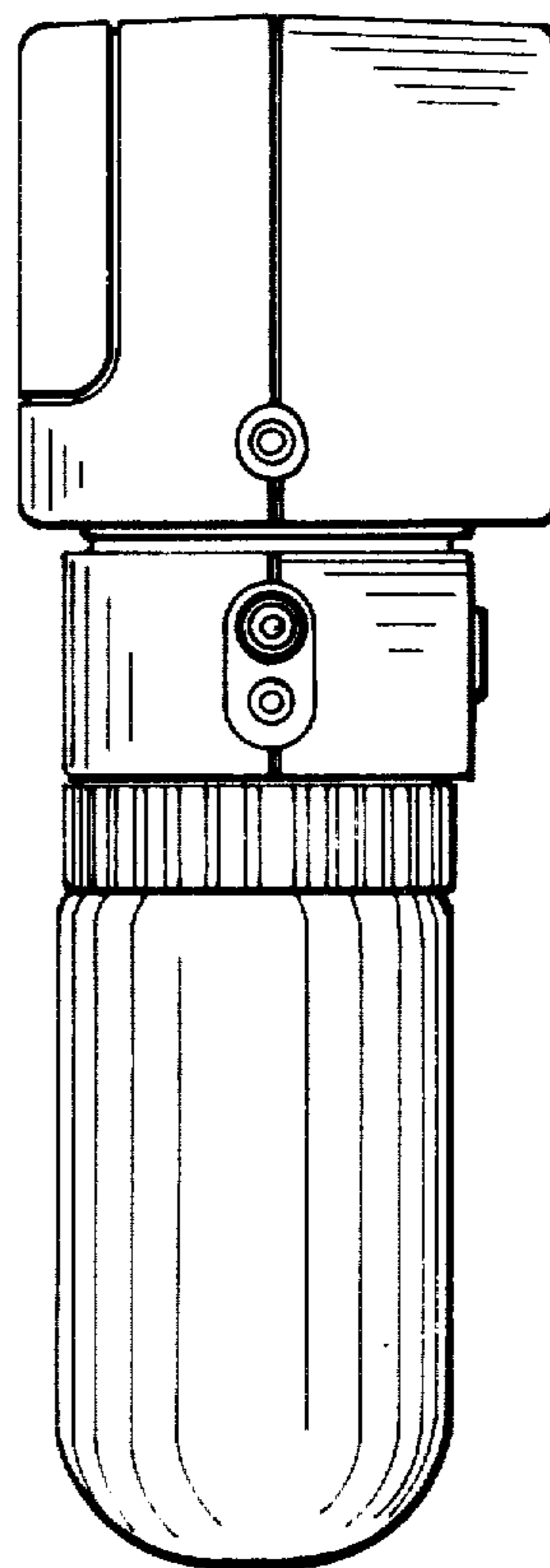
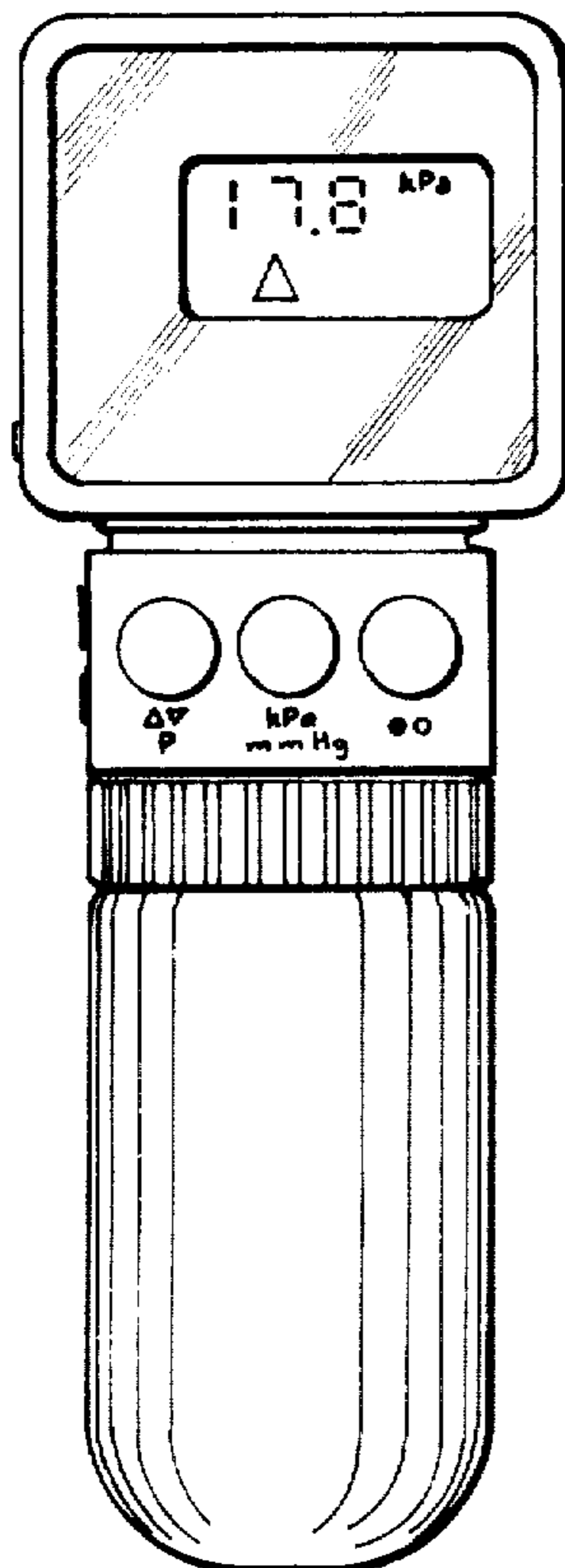

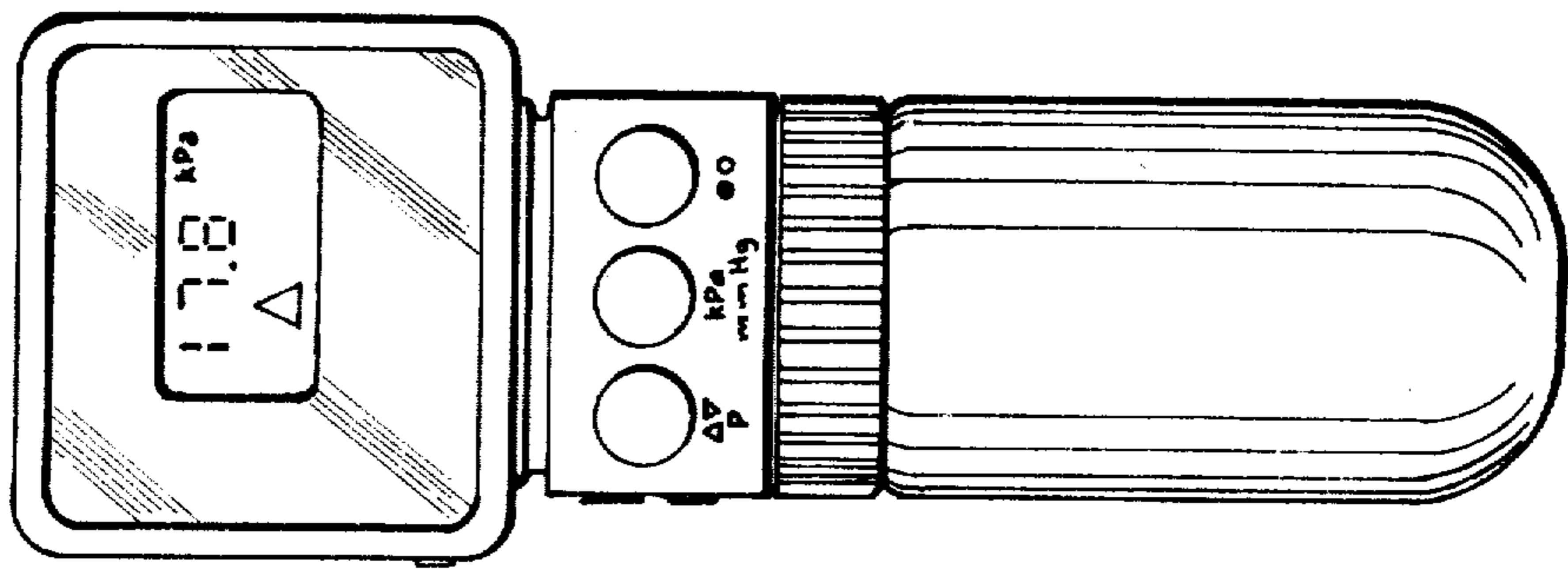

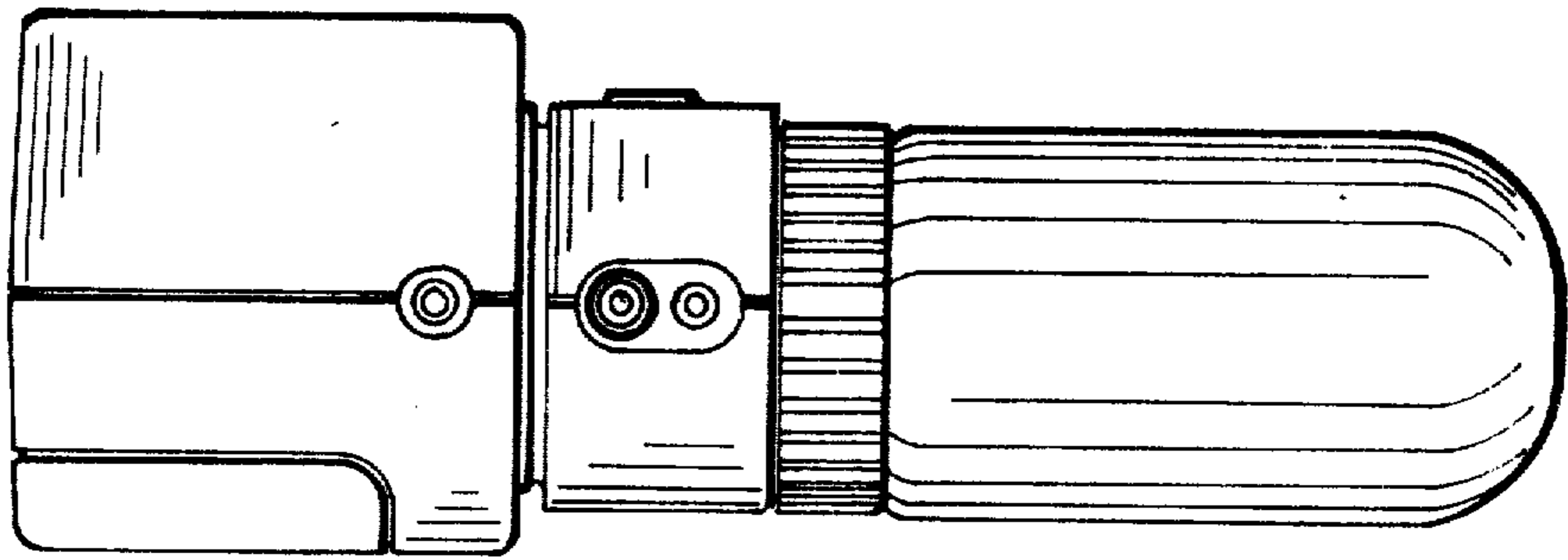
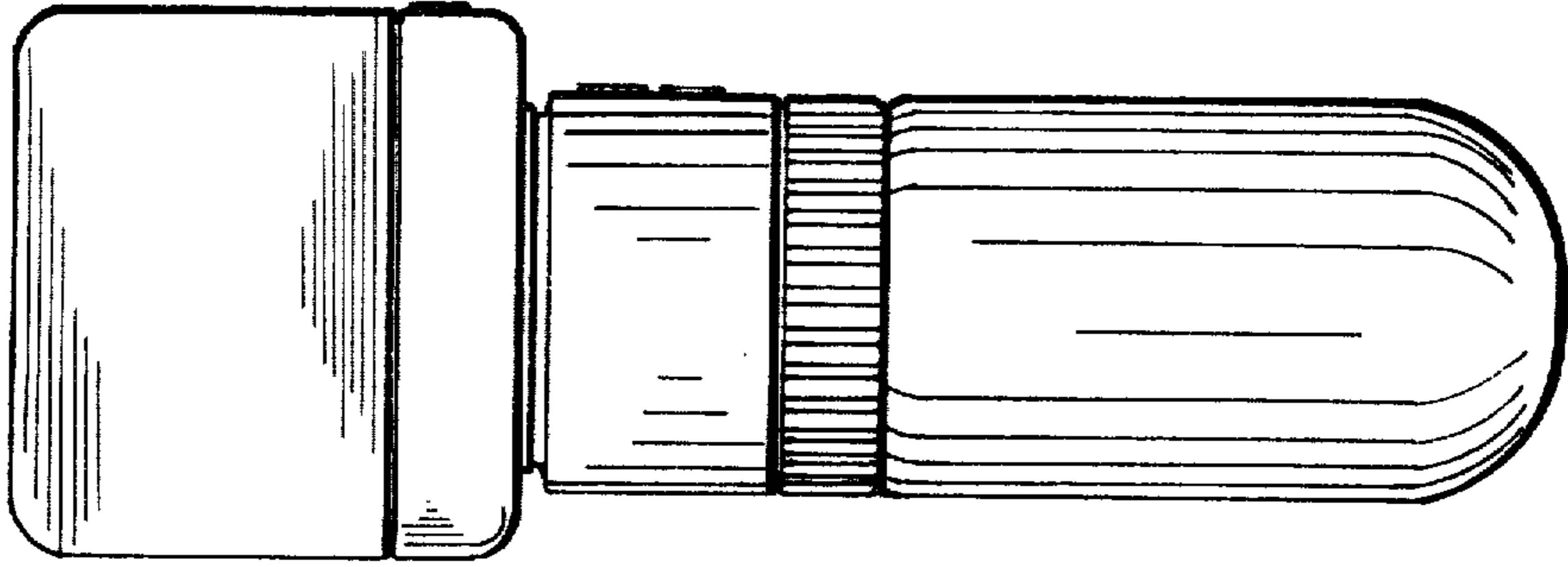

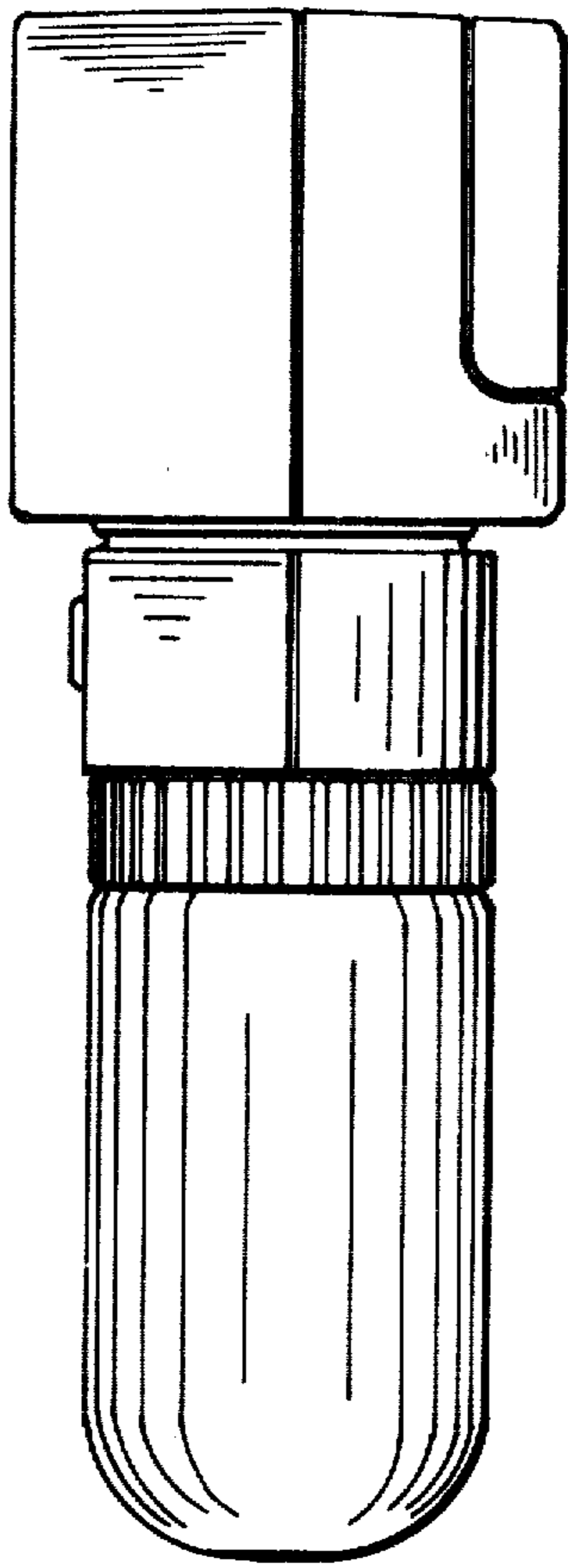

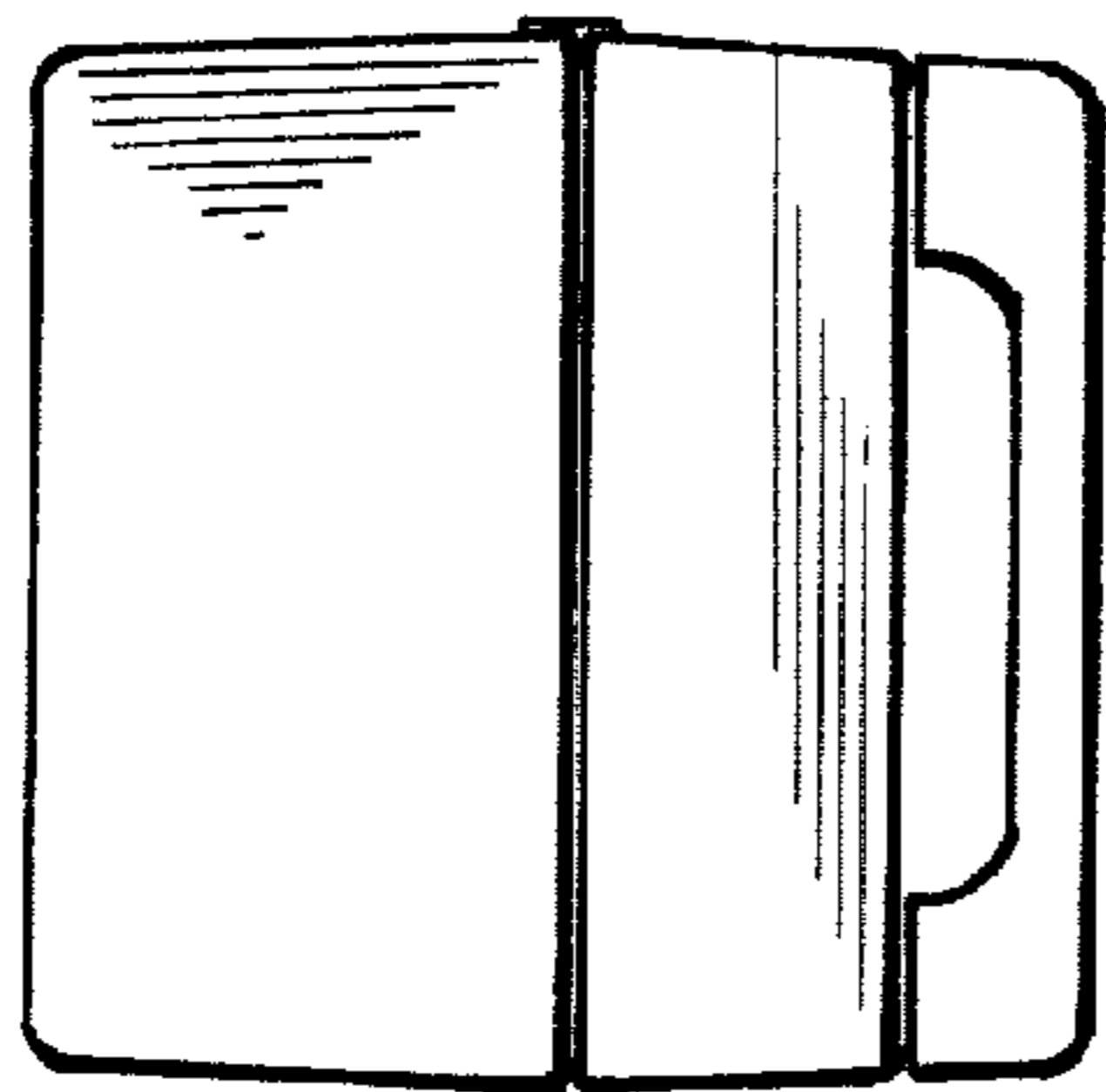

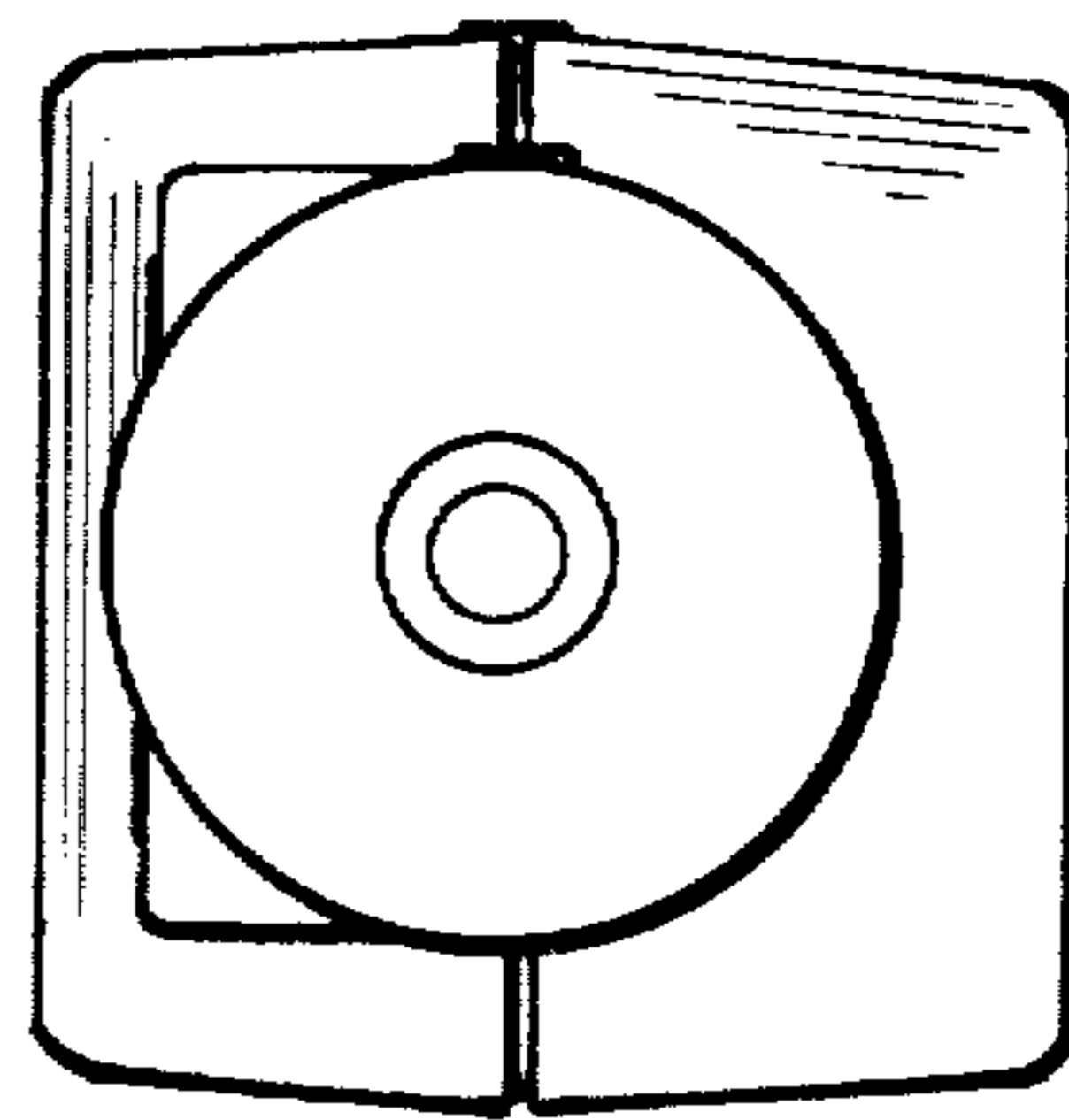

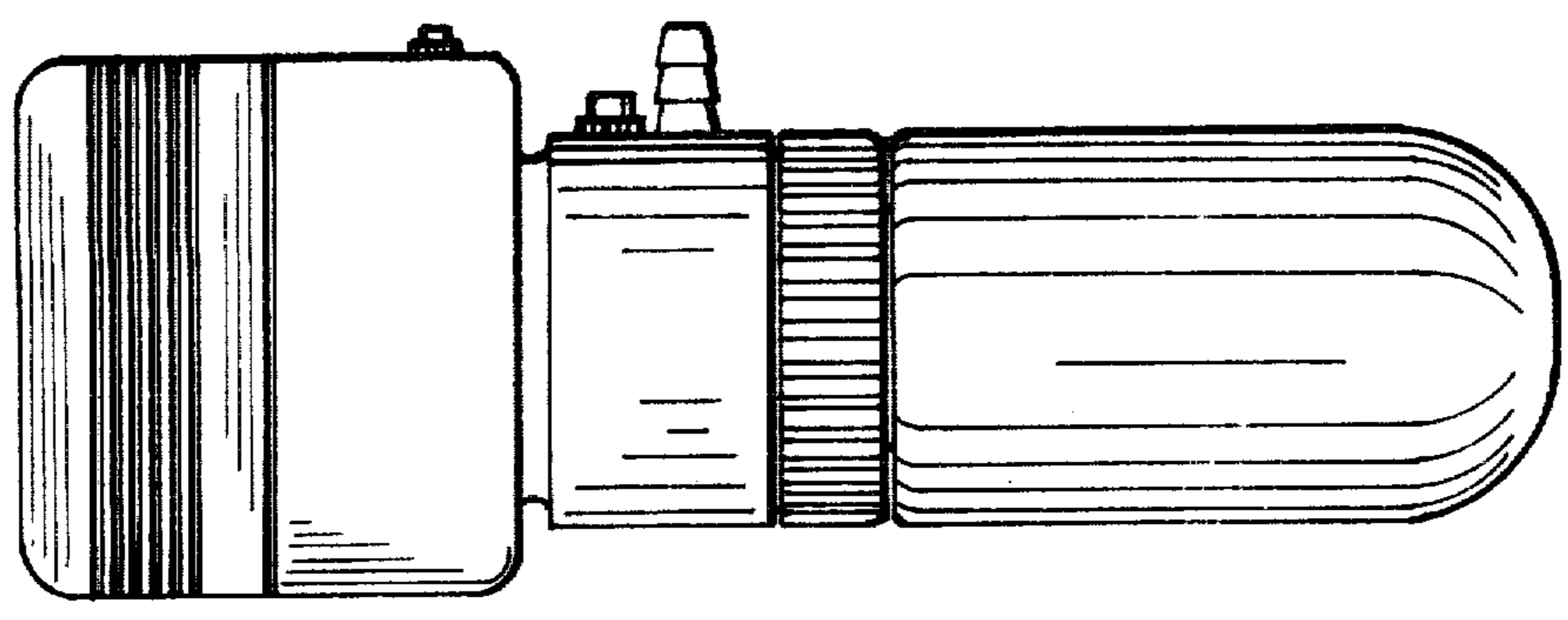

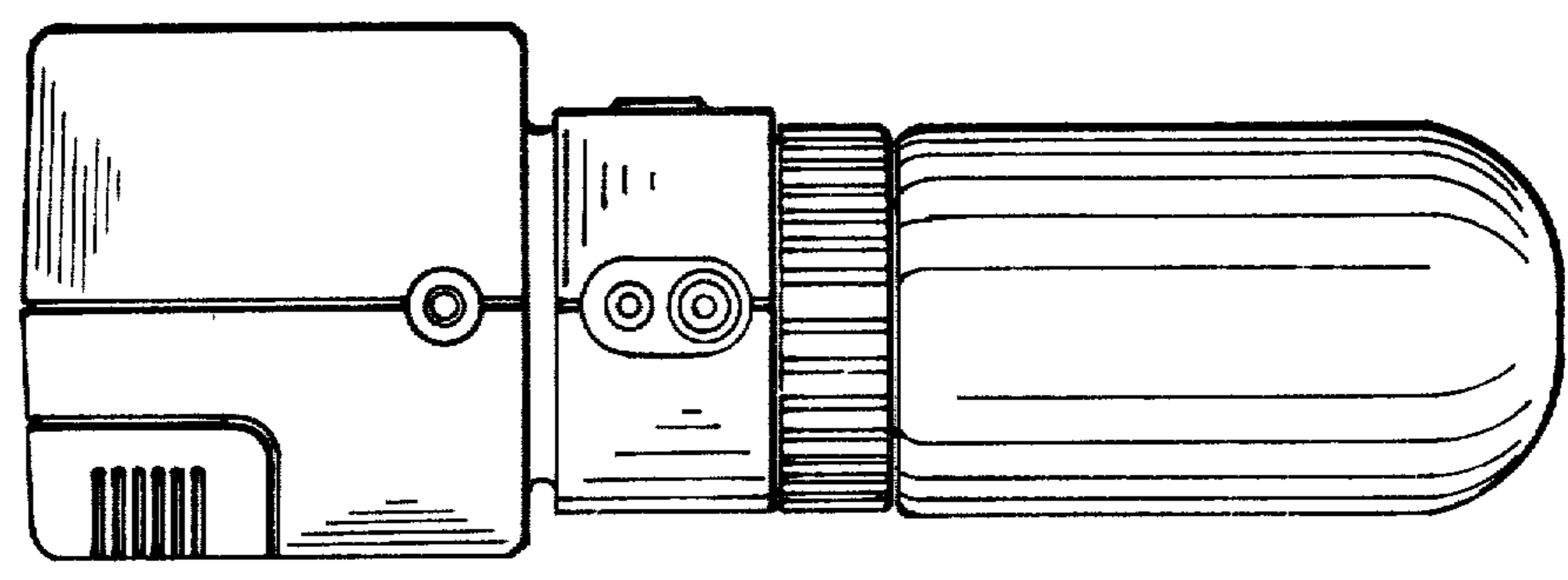
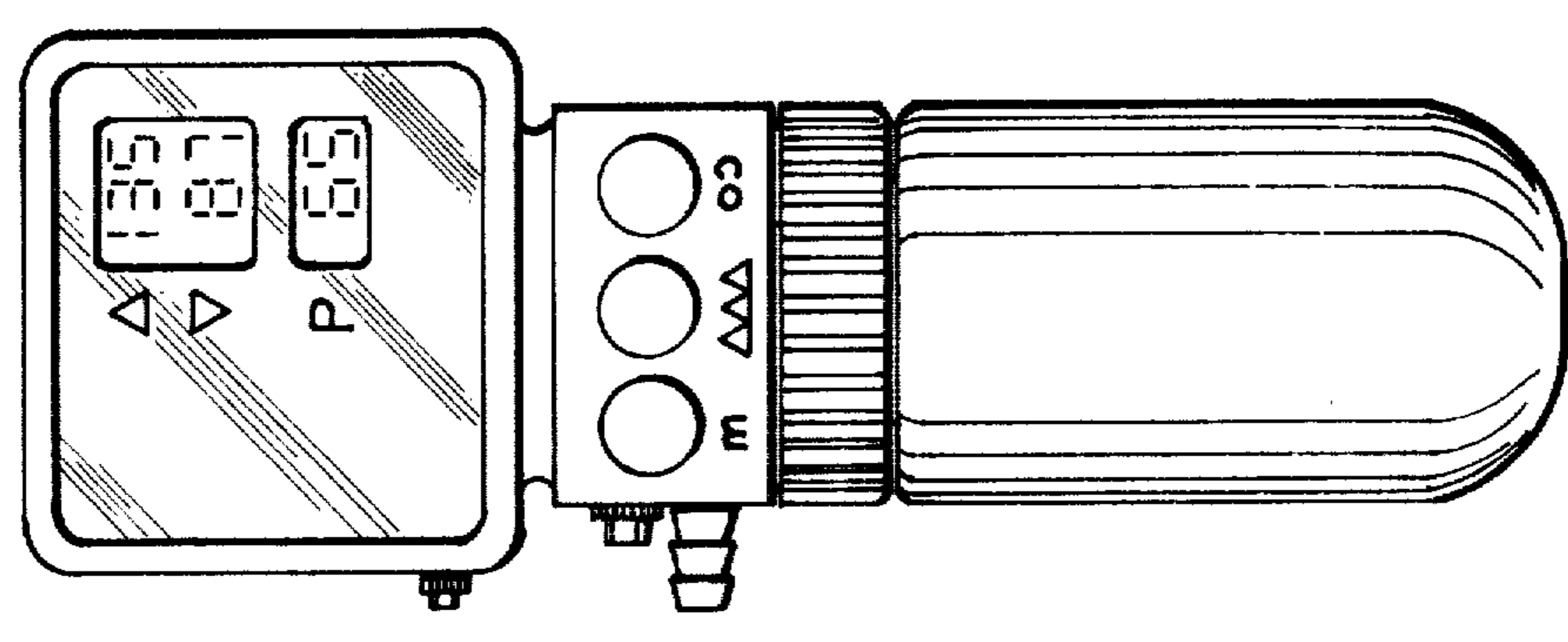

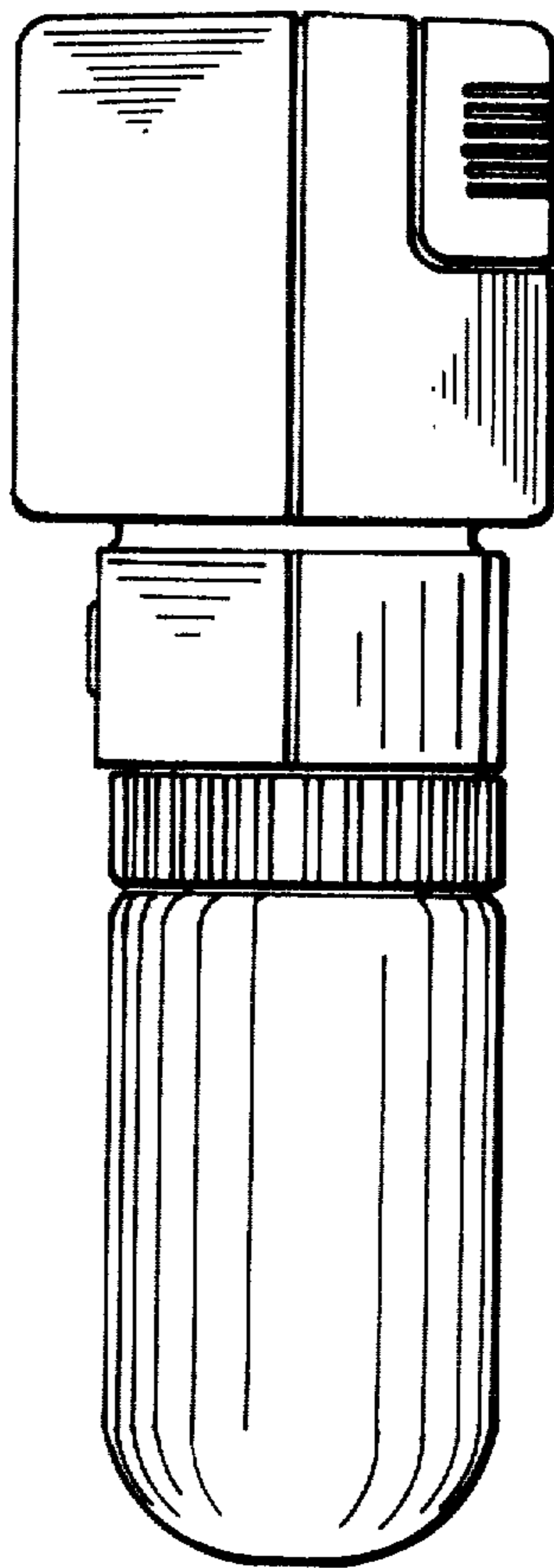

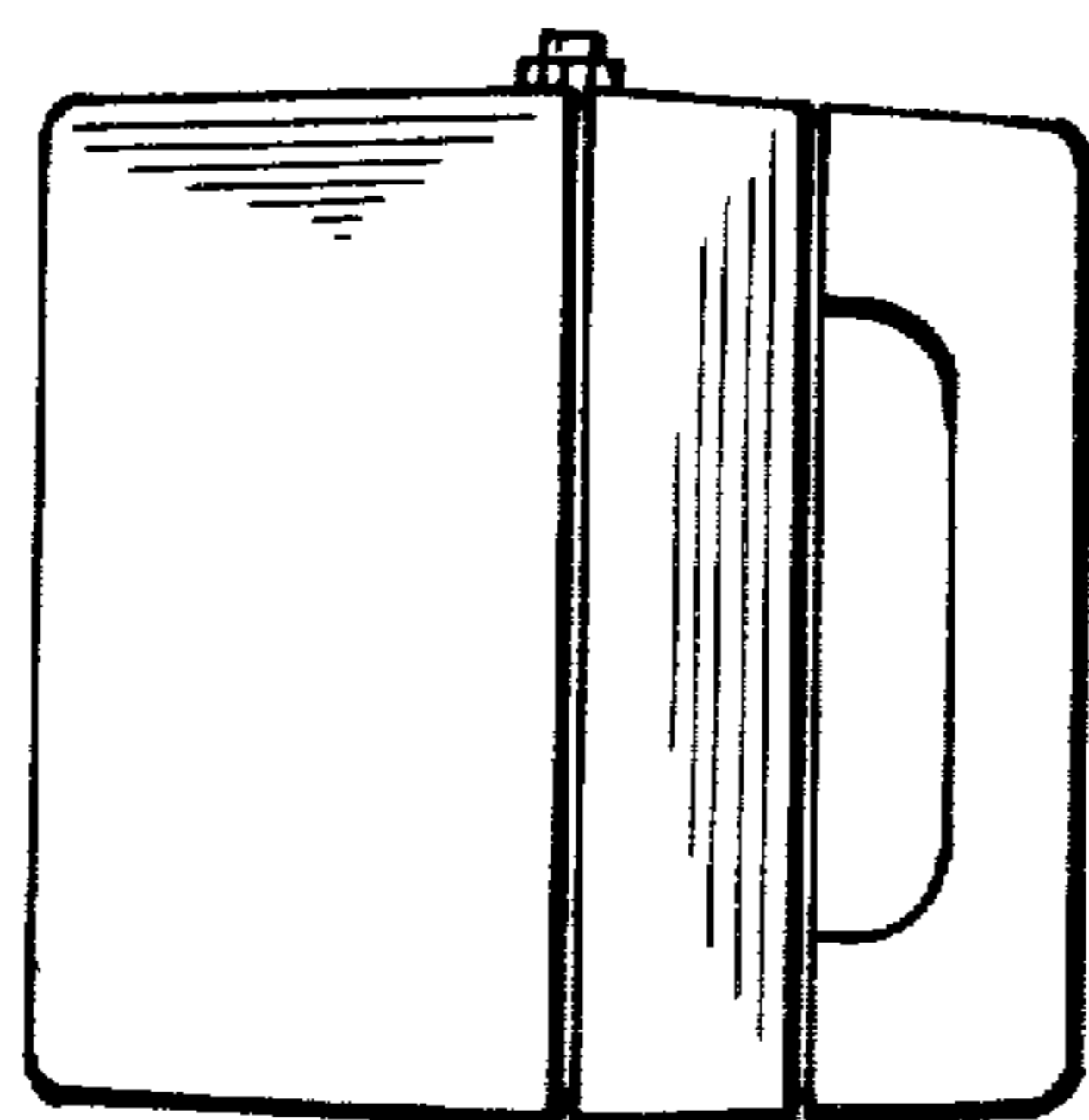

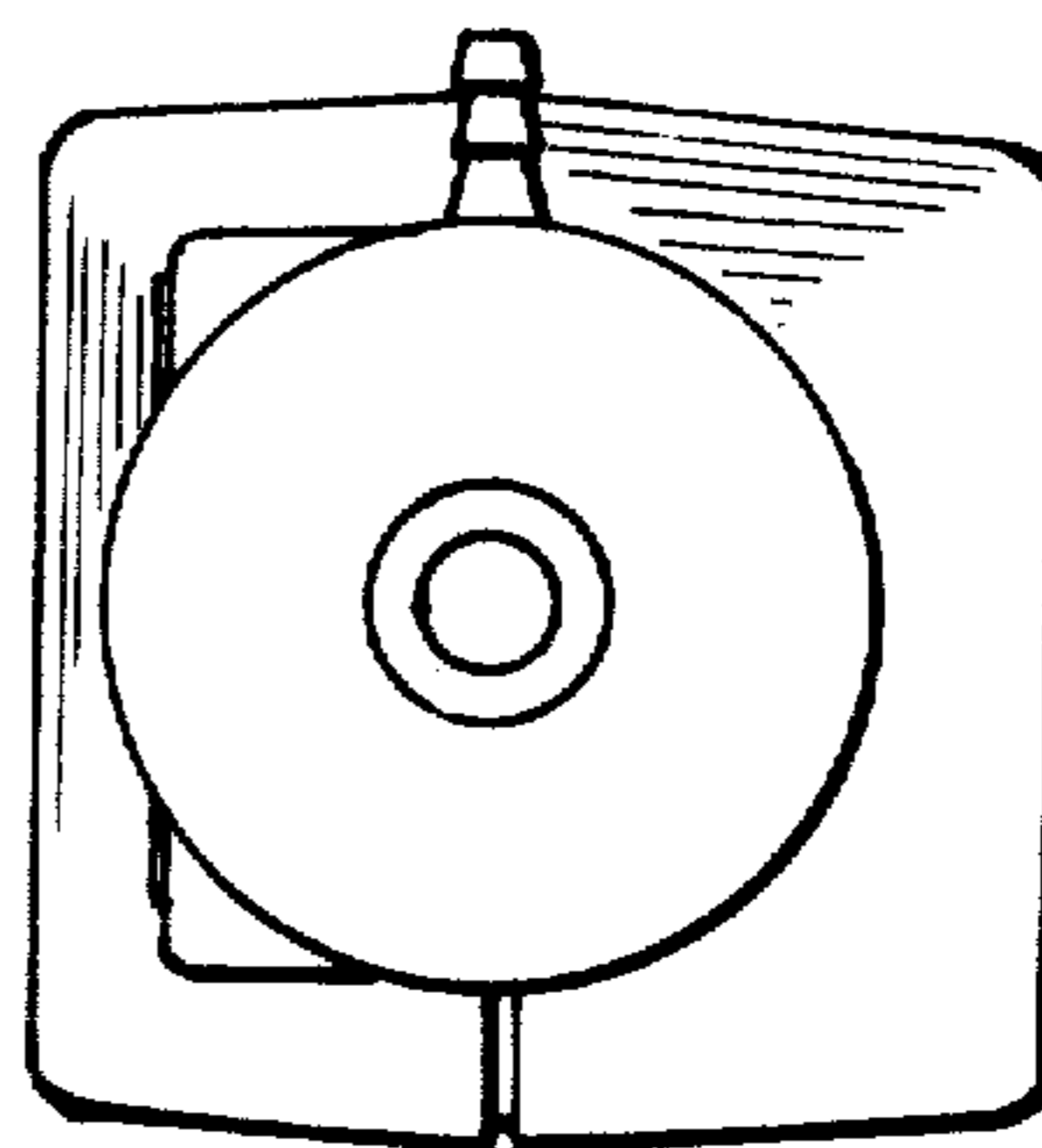
