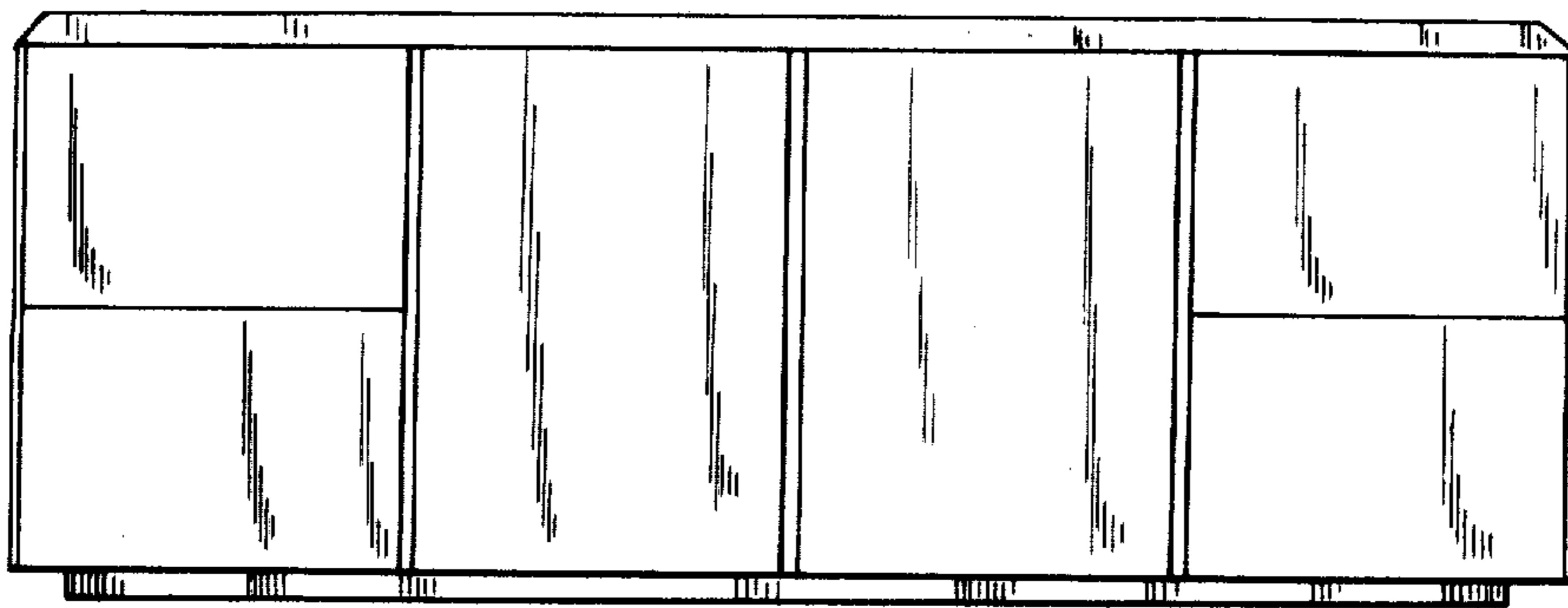

The ornamental design for a credenza or similar article, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a first embodiment of my invention, the article shown being a credenza or similar article;
FIG. 2 is a top plan view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a right side elevation thereof; and
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a front elevation view of a second embodiment of my invention, the article shown being a credenza or similar article;
FIG. 7 is a top plan view thereof;
FIG. 8 is a rear elevation view thereof;
FIG. 9 is a right side elevation view thereof;
FIG. 10 is a bottom plan view thereof; and
FIG. 11 is an enlarged detail sectional view taken line 11—11 of FIG. 9.



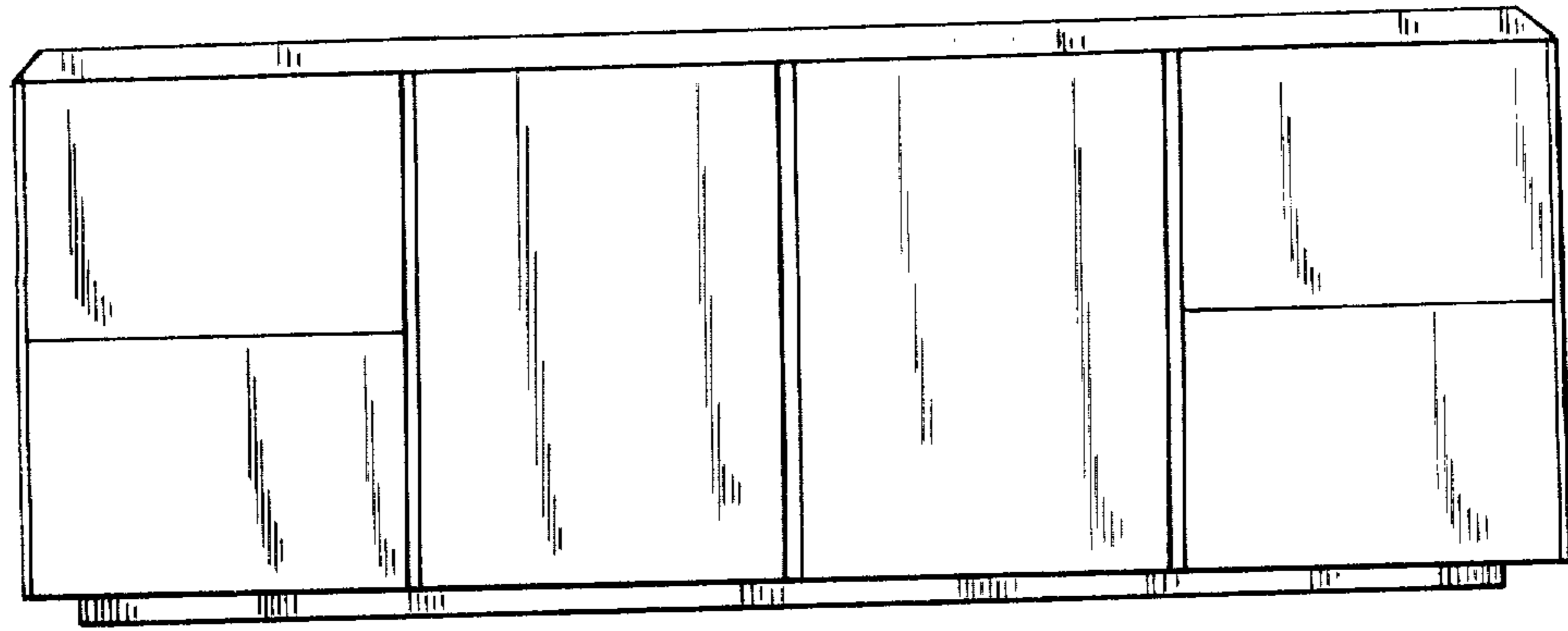

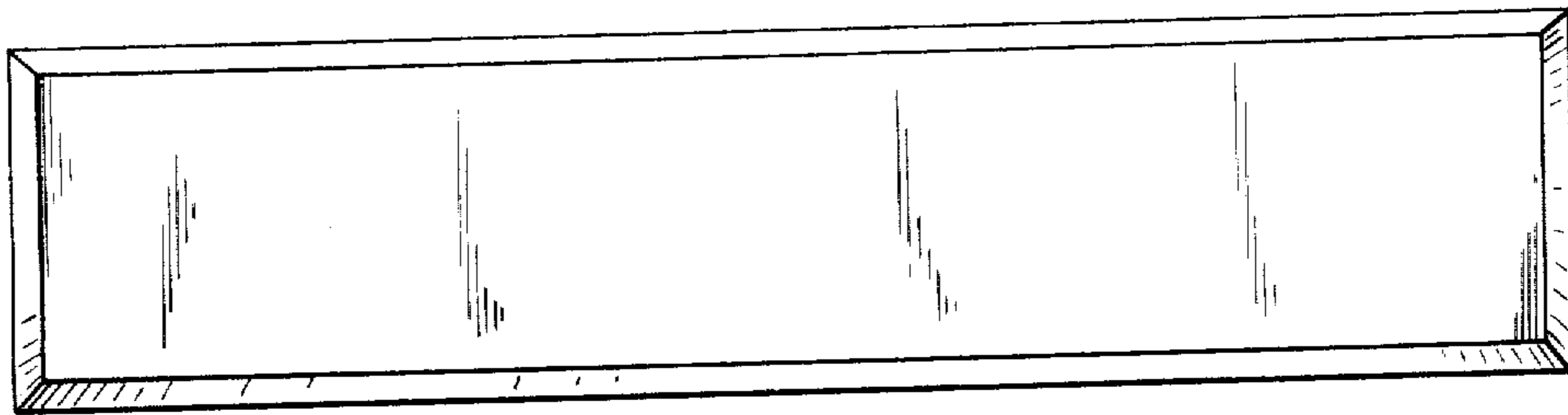

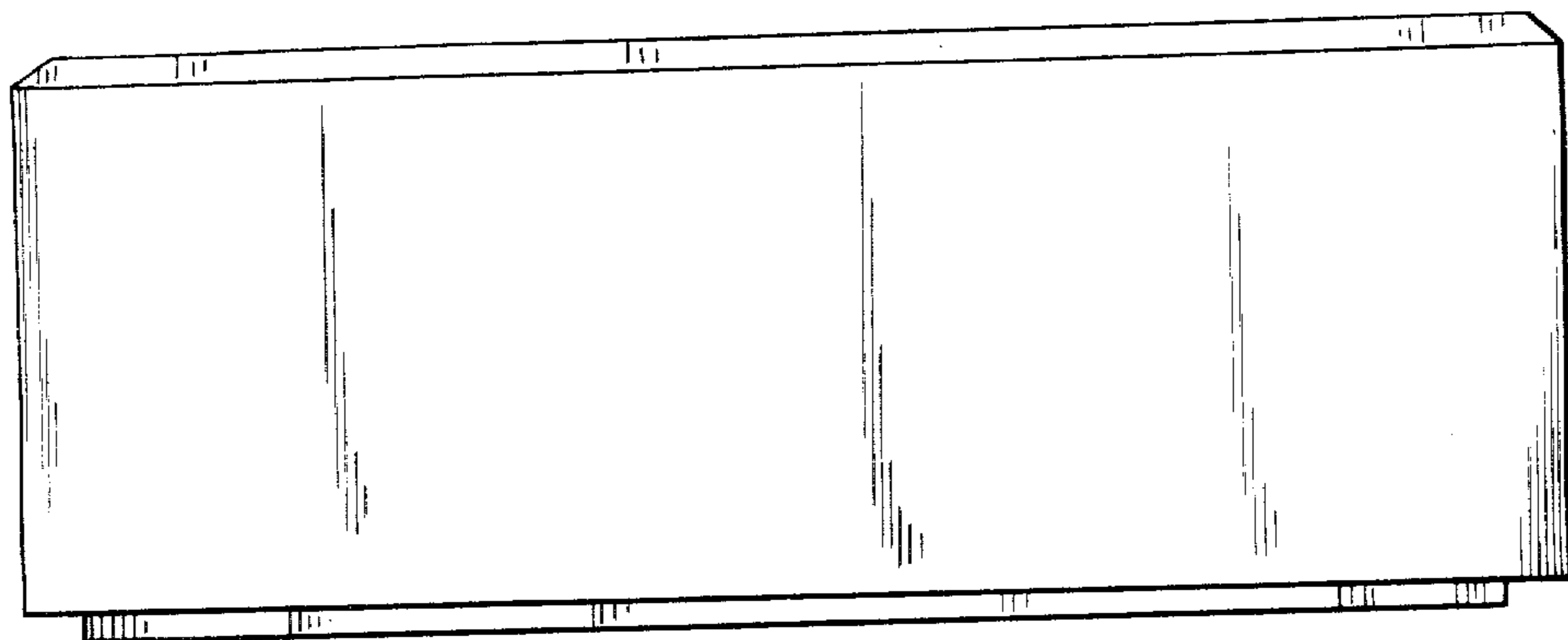

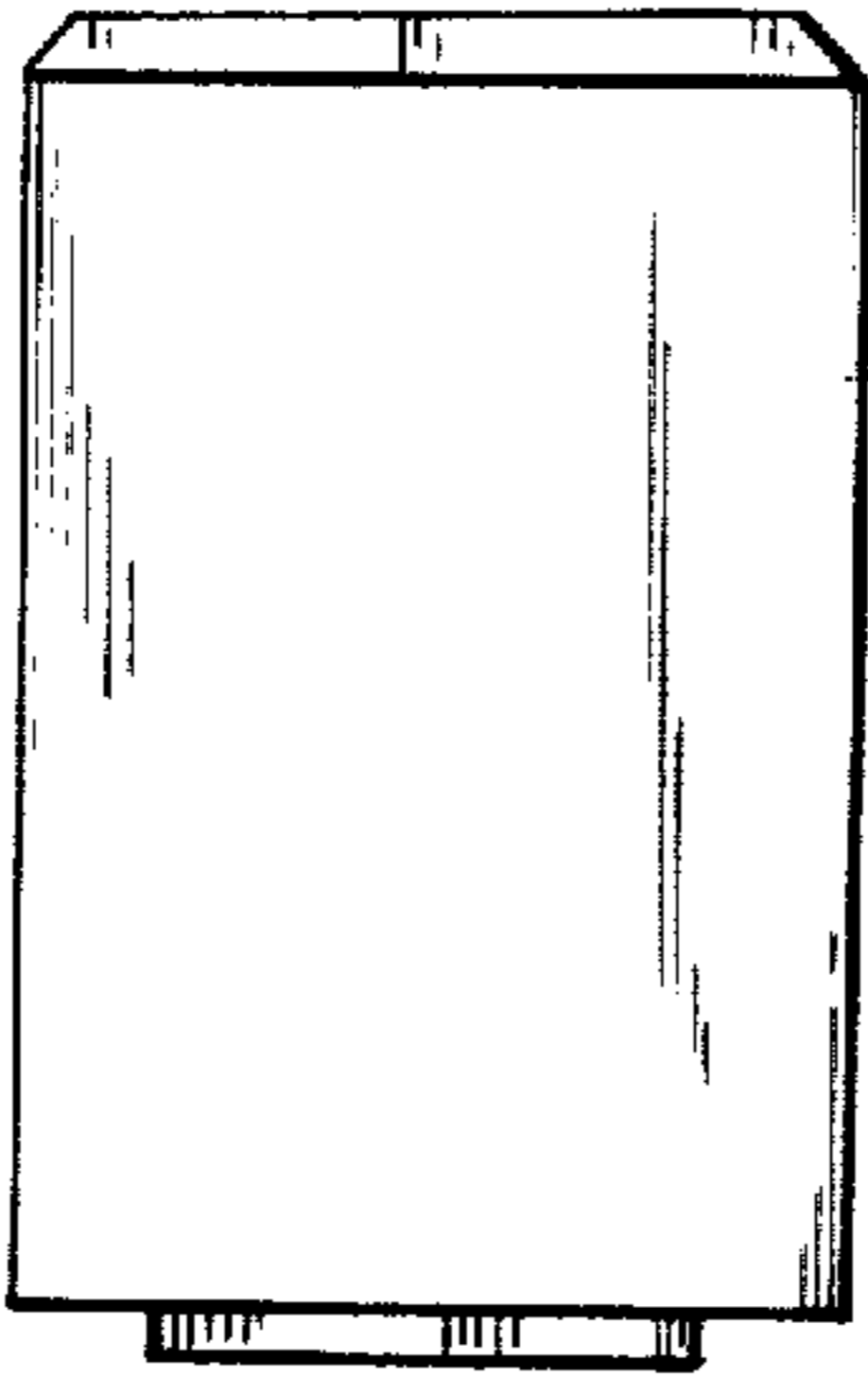

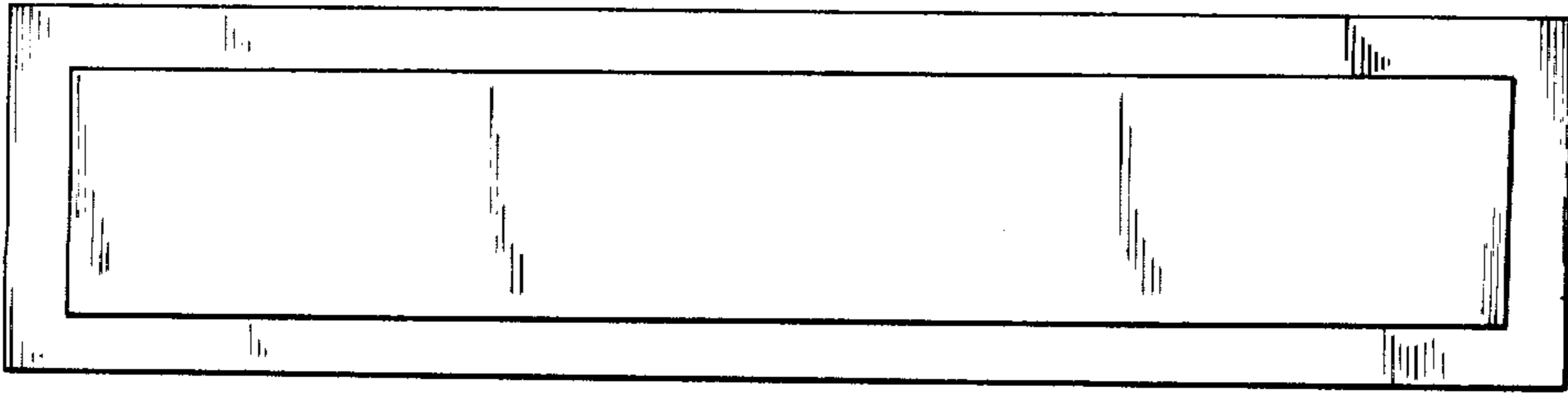

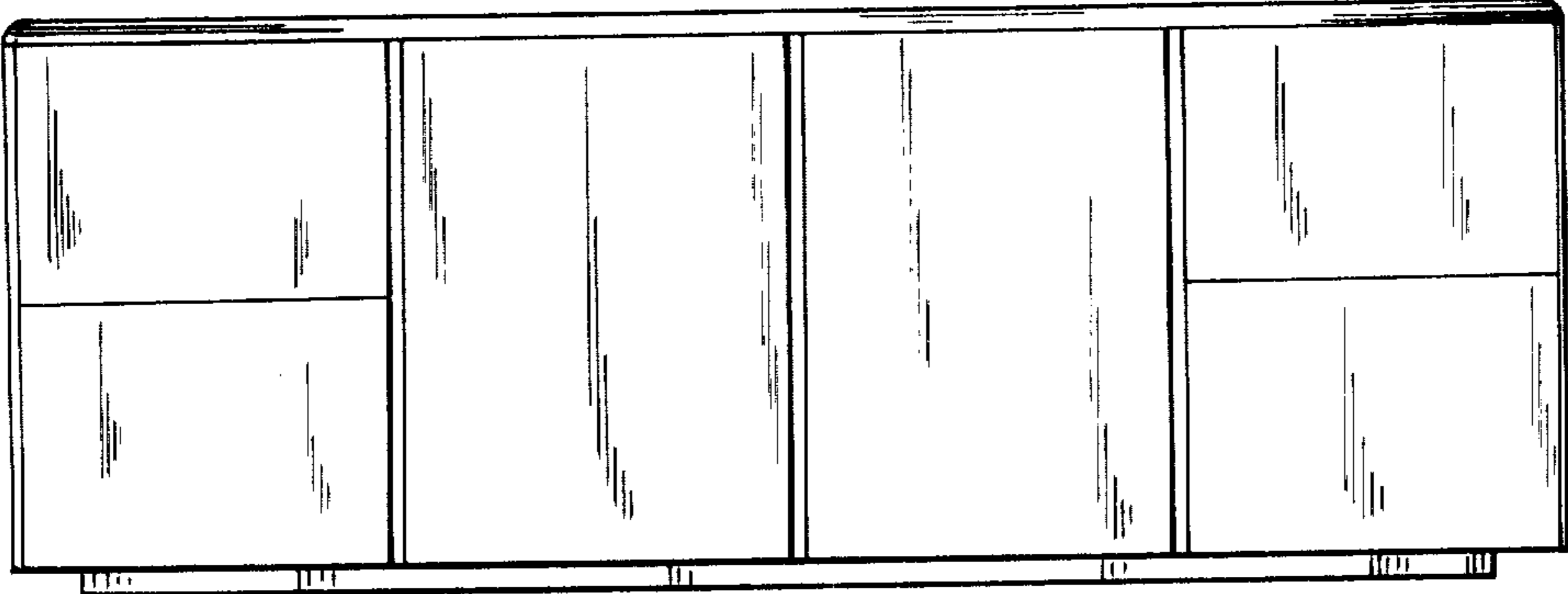

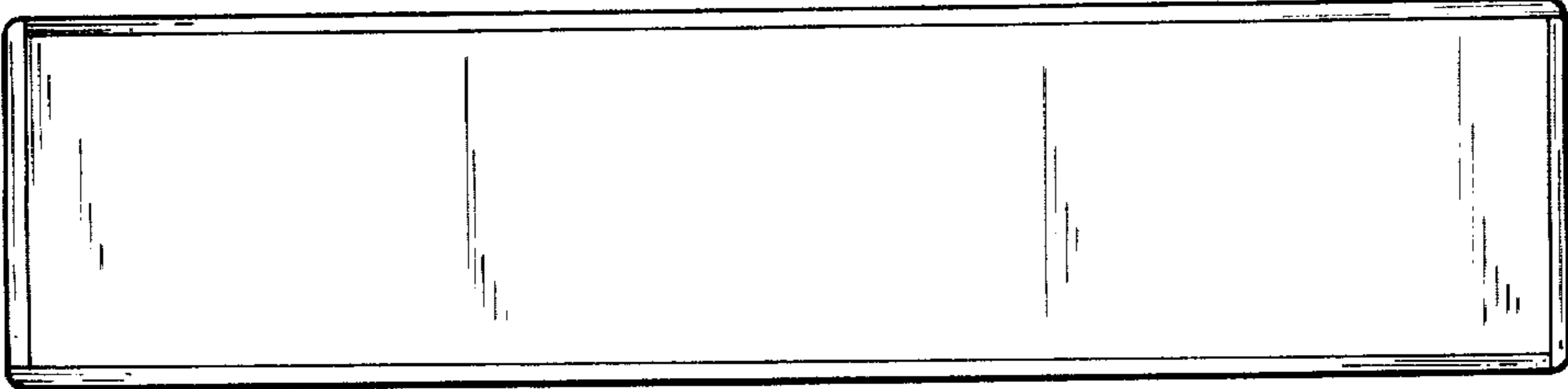

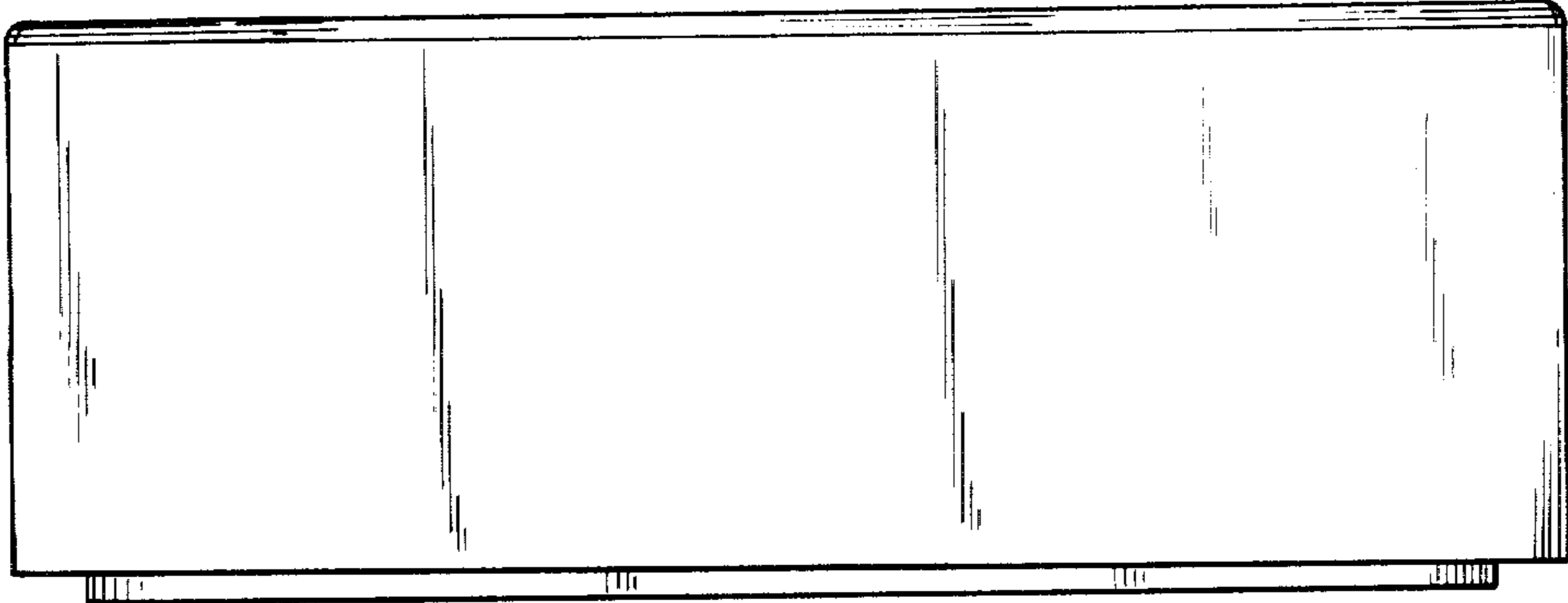

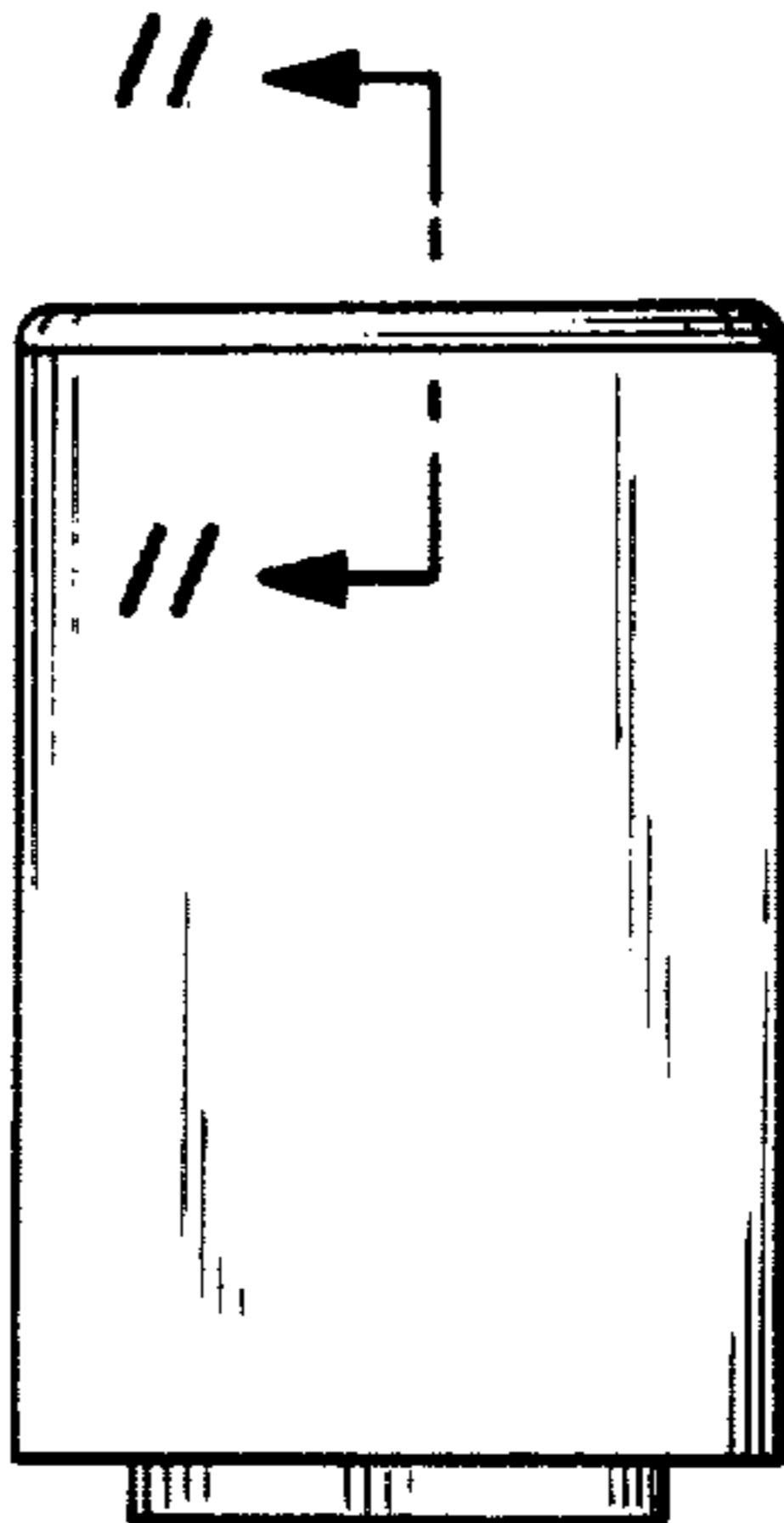

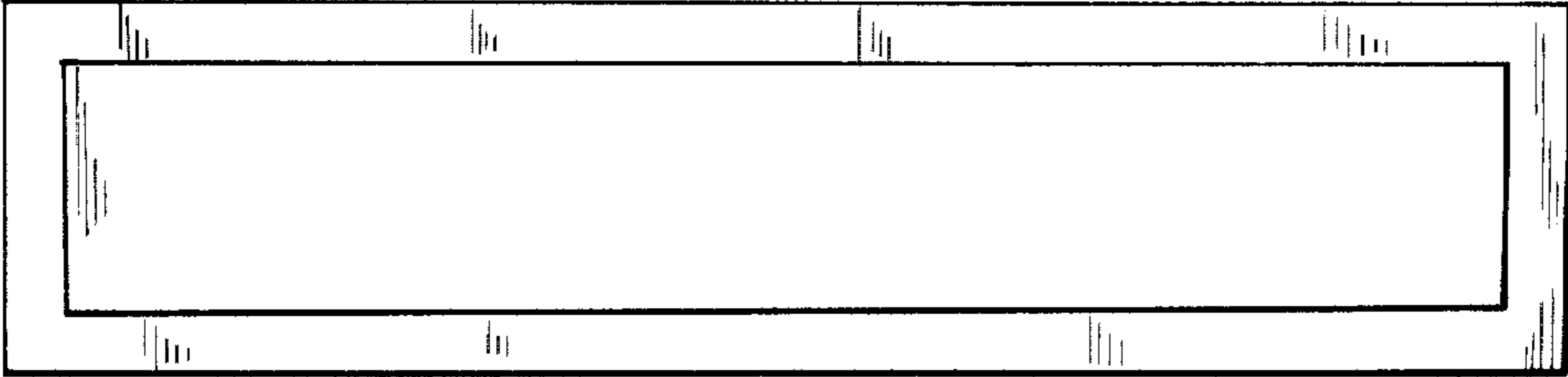

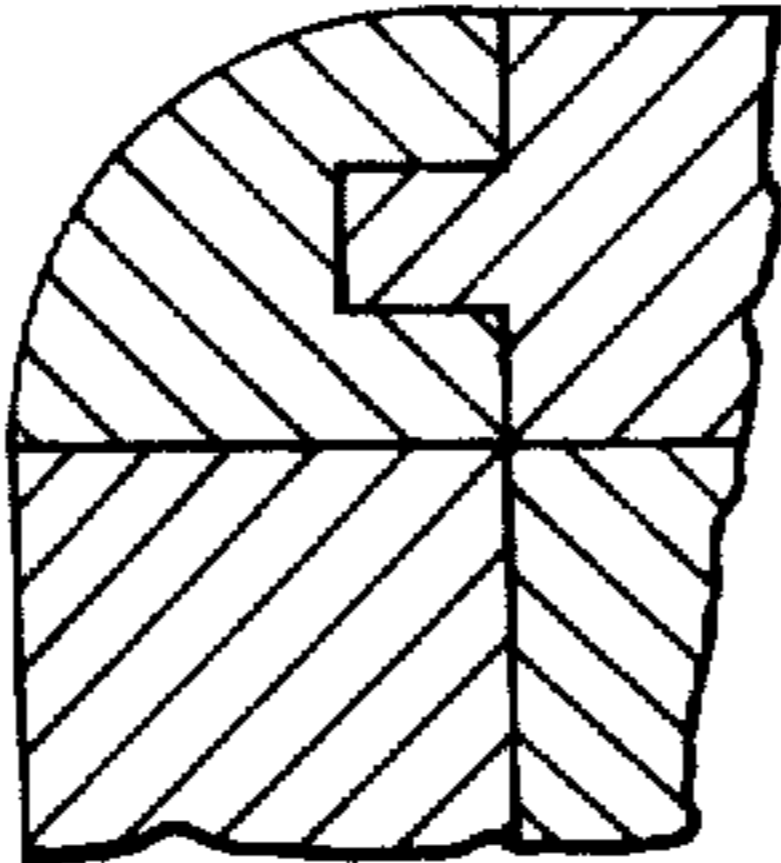
