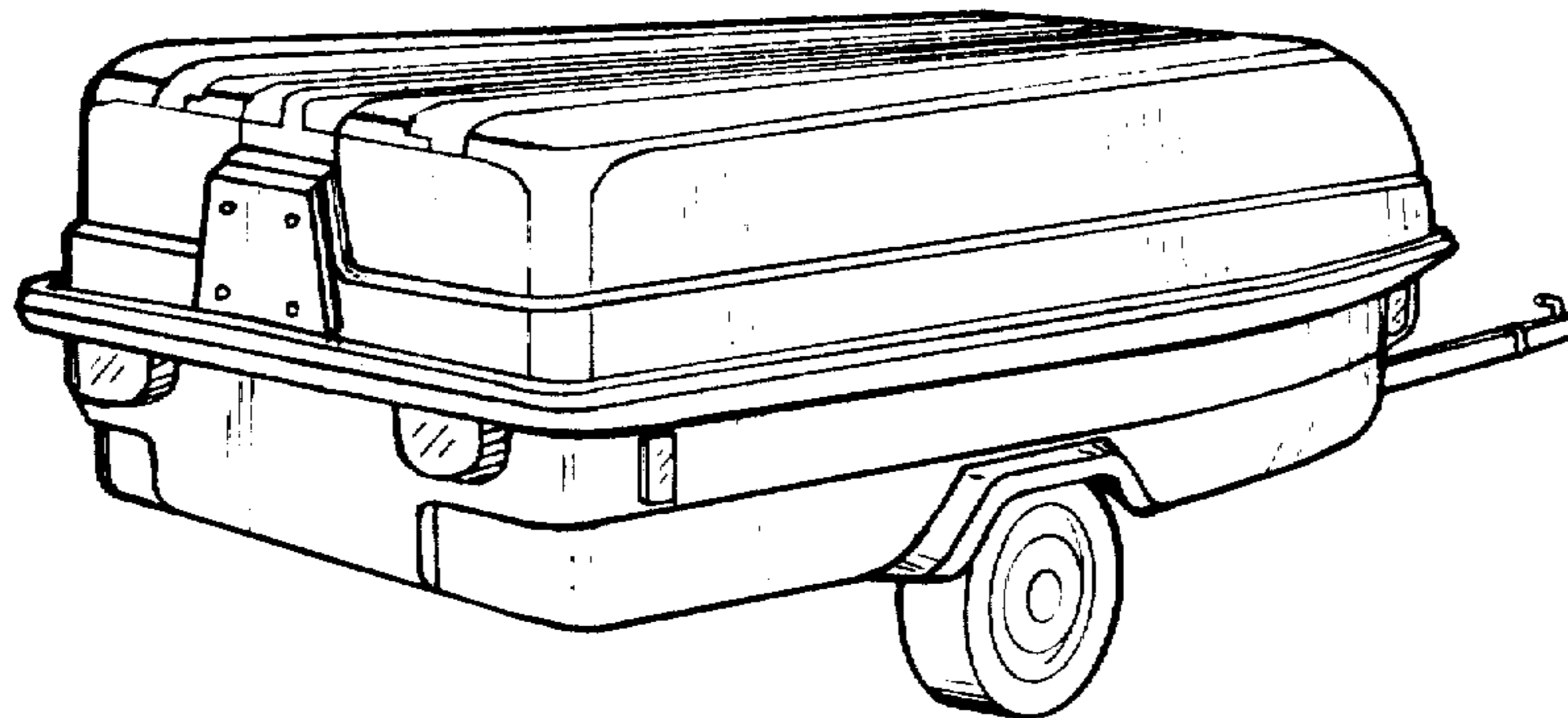

[57] CLAIM

The ornamental design for a combined boat, camper and utility trailer, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a combined boat, camper, and utility trailer embodying this invention; FIG. 2 is a top plan view thereof; FIG. 3 is a right side elevational view thereof, the left side being substantially a mirror image of the right side shown; FIG. 4 is an enlarged rear elevational view thereof; FIG. 5 is an enlarged front elevational view thereof; FIG. 6 is a perspective view thereof in open condition with the boat removed and the bed board and tent set up for use as a camper; FIG. 7 is a left side elevational view of FIG. 6; FIG. 8 is a rear elevational view of FIG. 6; FIG. 9 is a front elevational view of FIG. 6; FIG. 10 is a right side elevational view of FIG. 6; FIG. 11 is a top plan view of the boat of the invention turned upright; FIG. 12 is a bottom plan view of FIG. 11; FIG. 13 is an enlarged left side elevational view of FIG. 11; FIG. 14 is an enlarged rear elevational view of FIG. 11; FIG. 15 is an enlarged front elevational view of FIG. 11; FIG. 16 is a top plan view of the trailer of the invention with the boat and bed board and tent removed; FIG. 17 is a bottom plan view of FIG. 16; FIG. 18 is a right side elevational view of FIG. 16; FIG. 19 is an enlarged rear elevational view of FIG. 16; and FIG. 20 is an enlarged front elevational view of FIG. 16. The broken lines on the tent in FIGS. 6, 7, 8, 9 and 10 represent stitching.



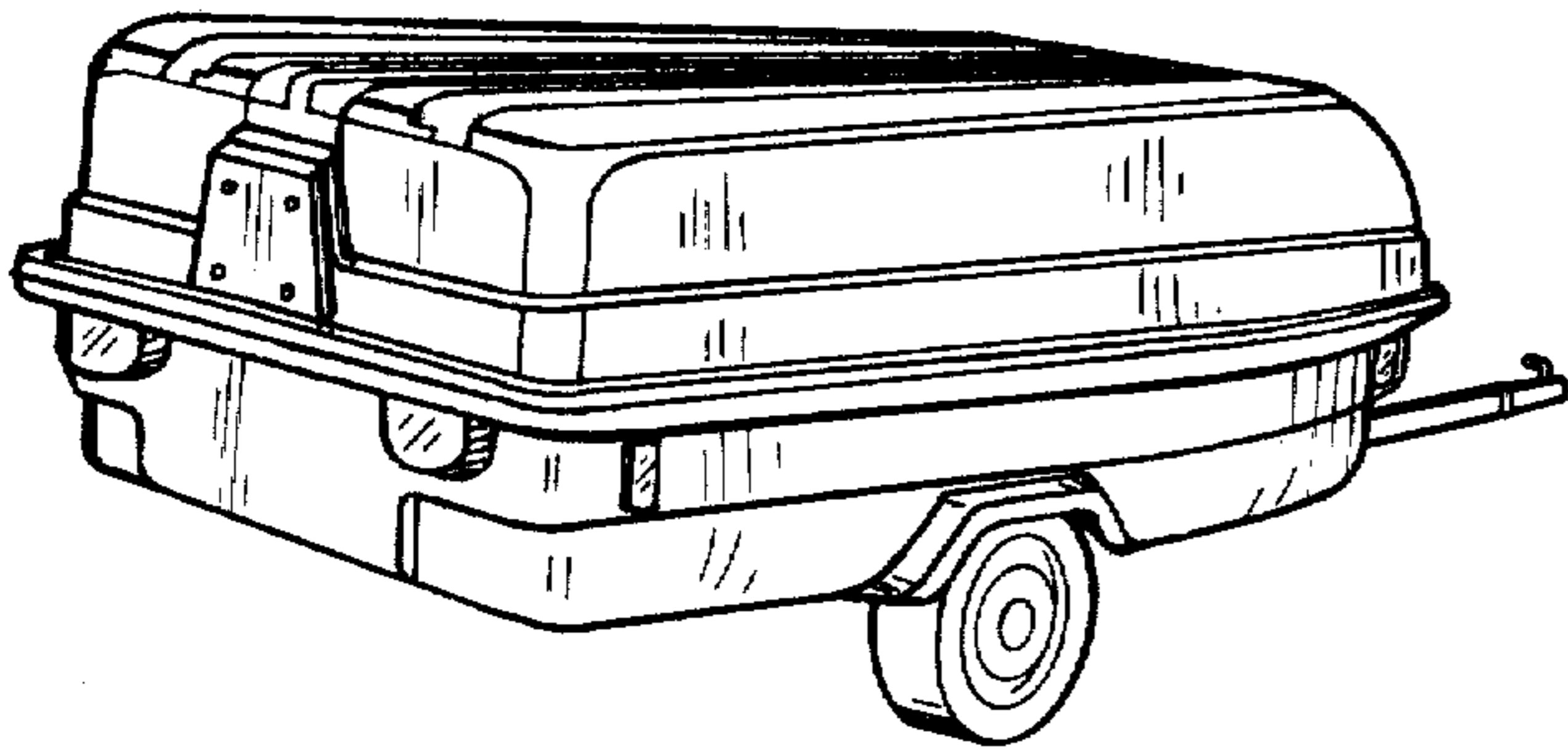

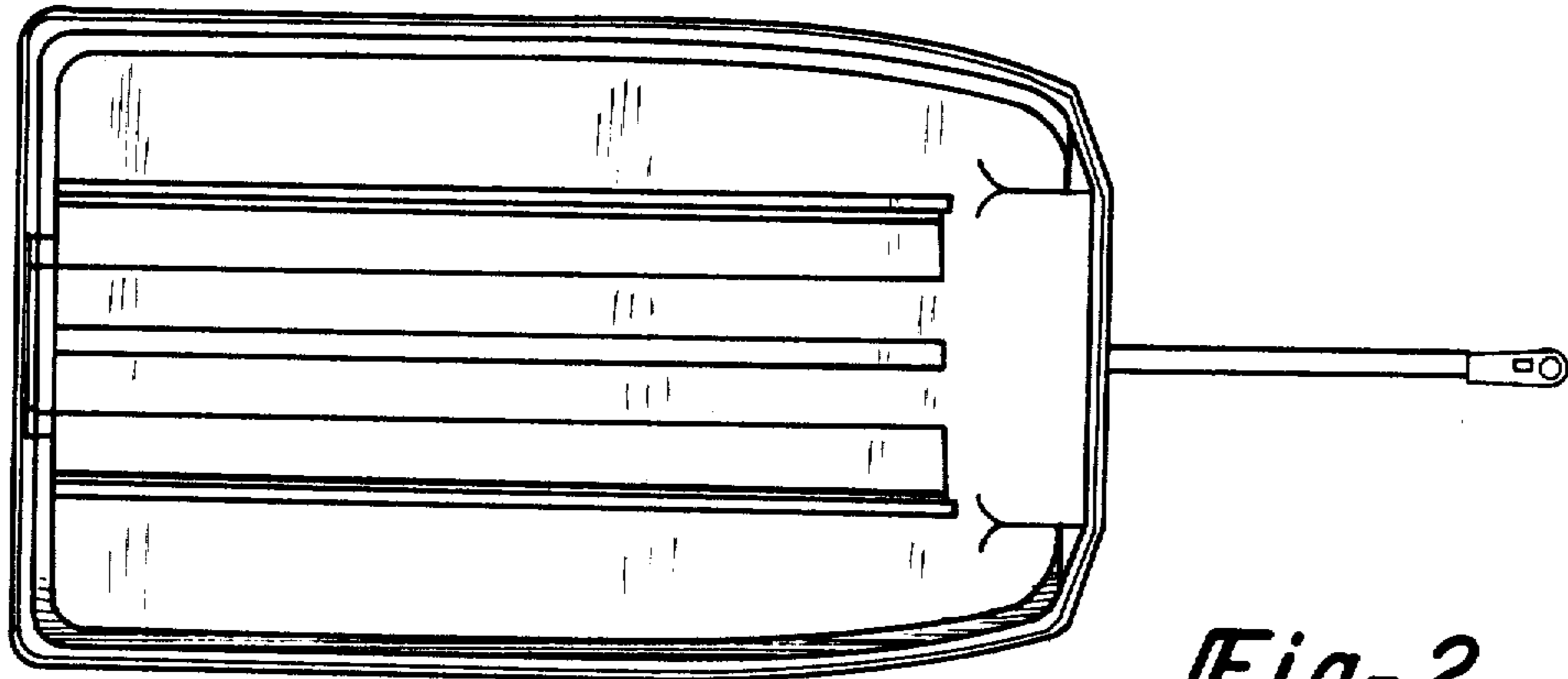

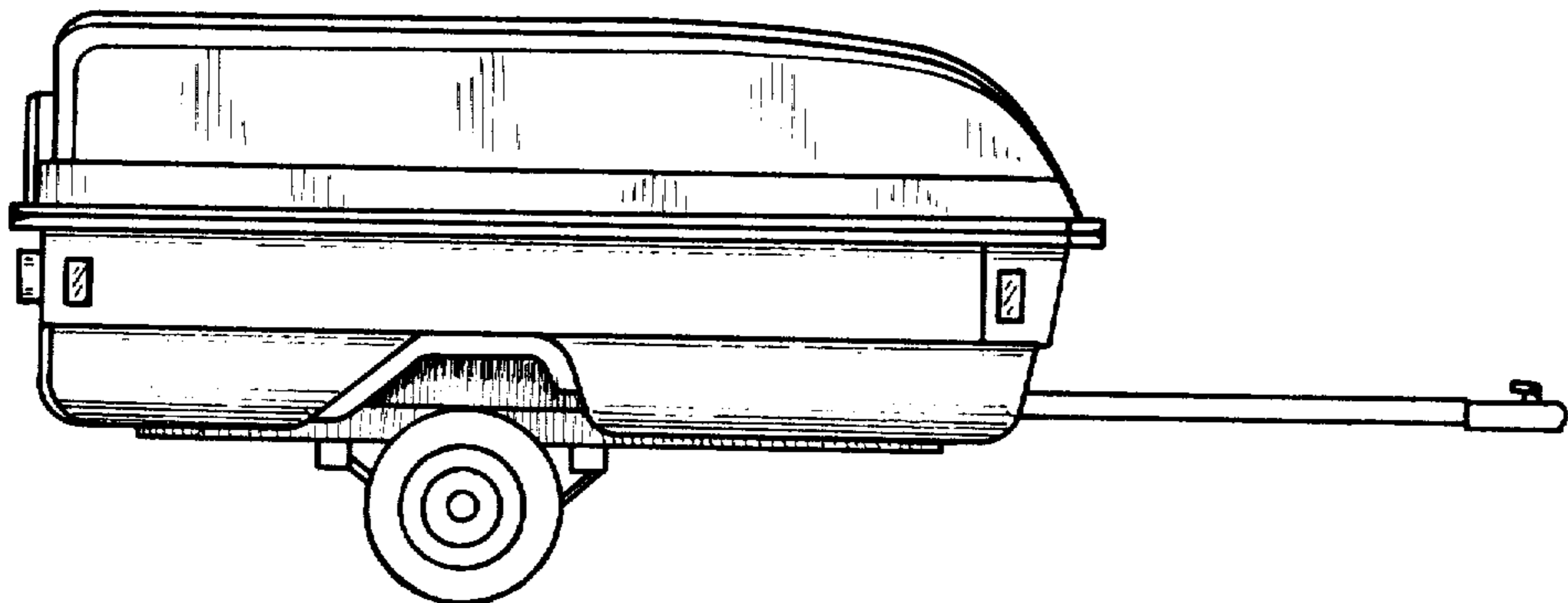

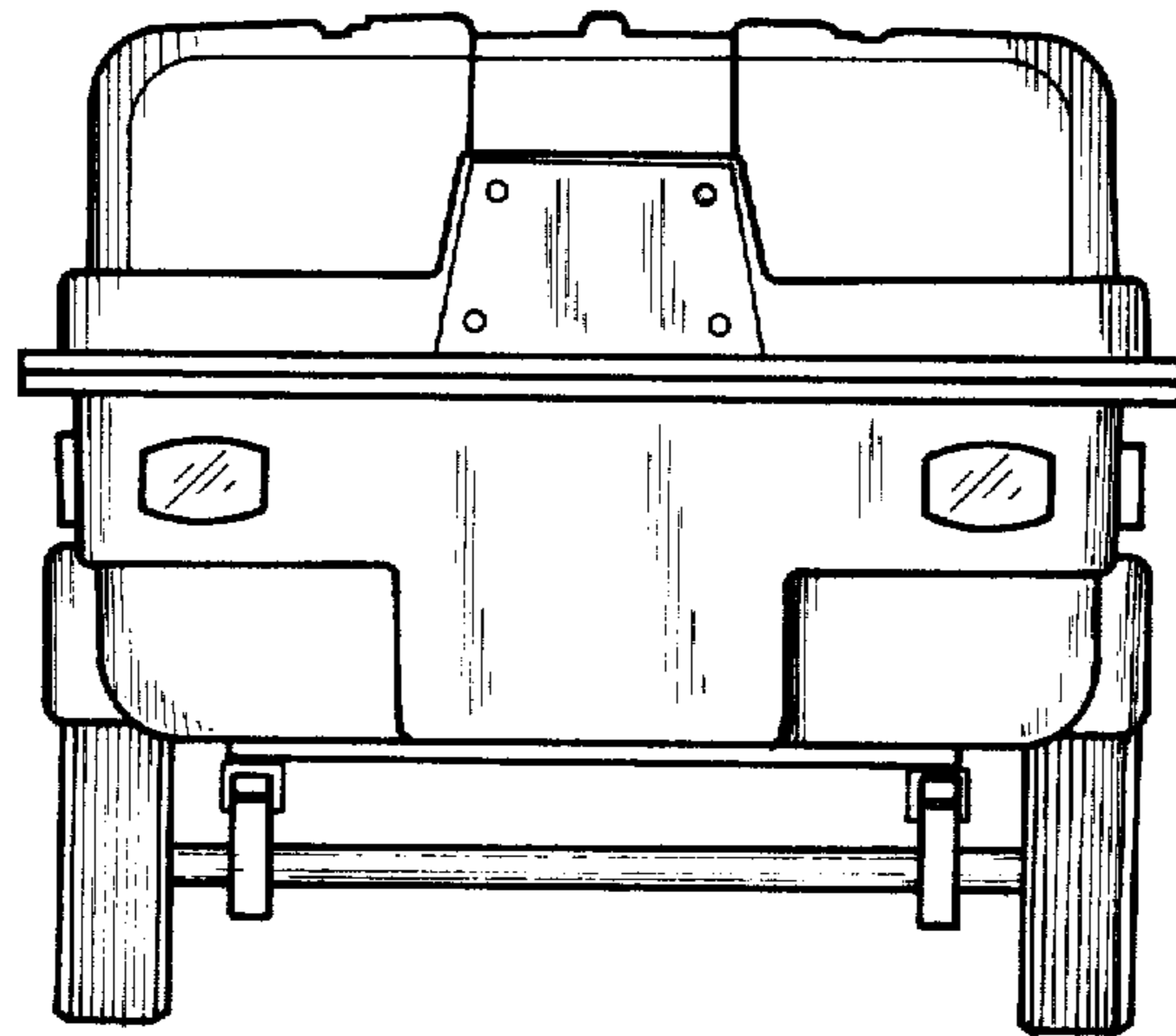

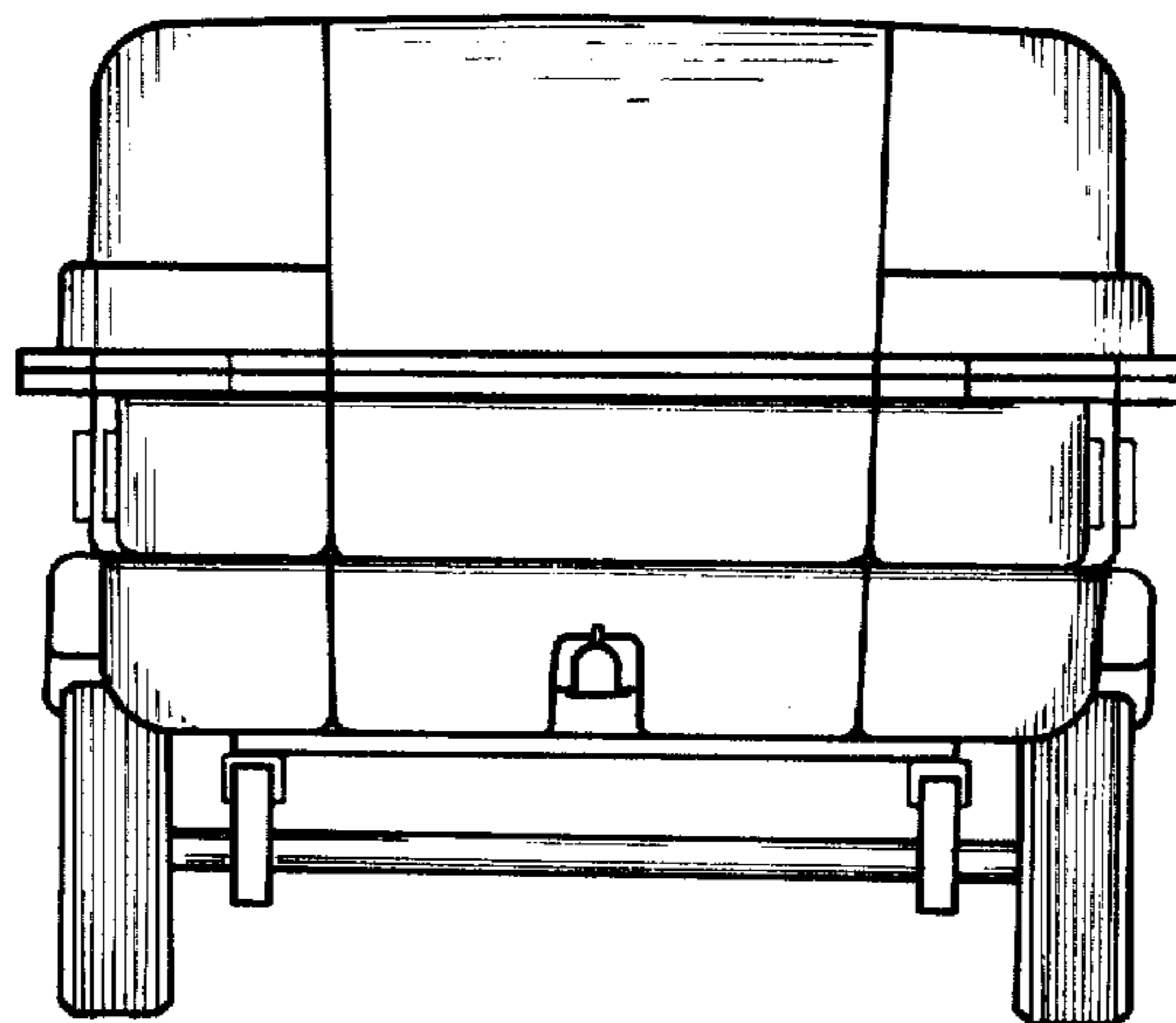

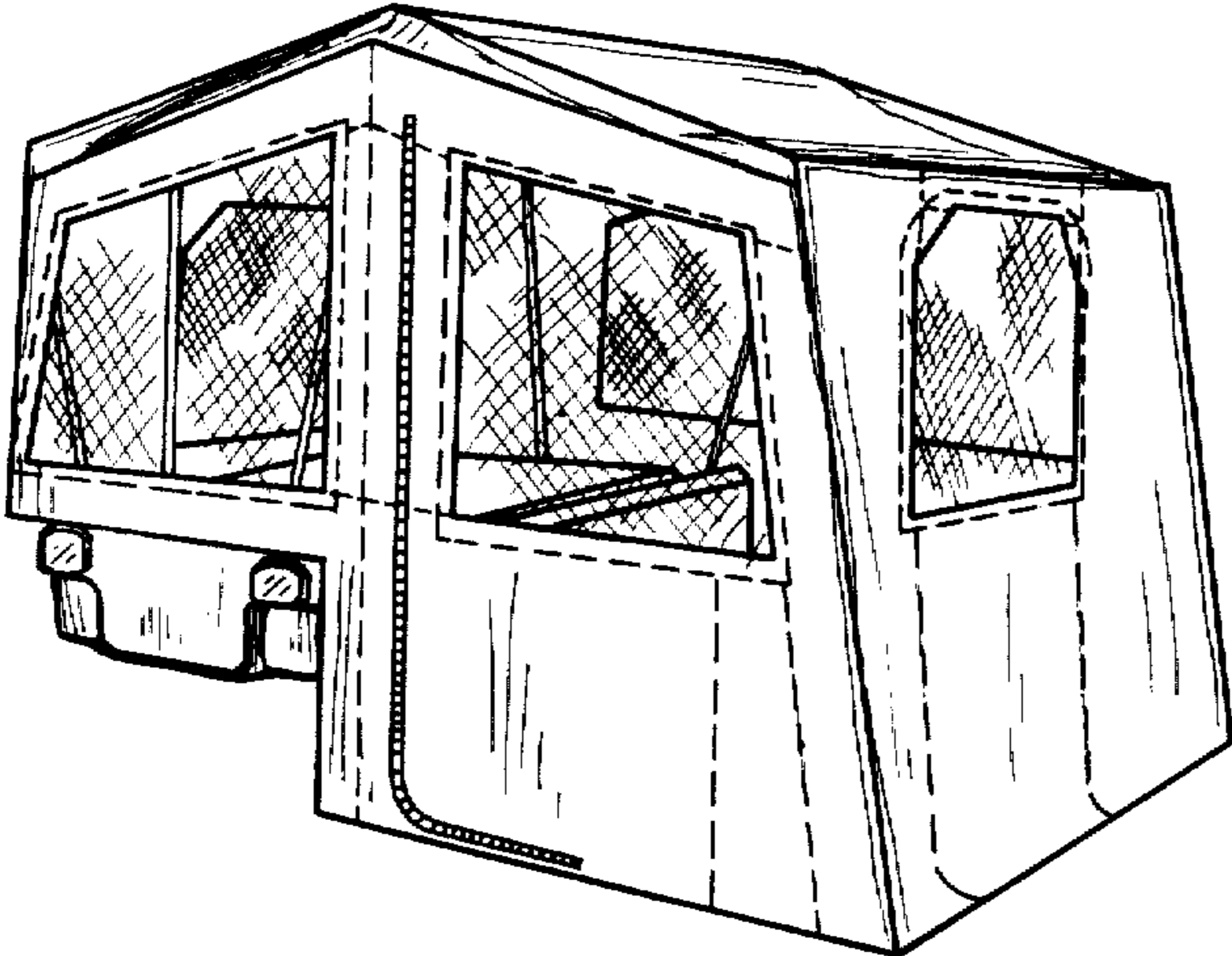

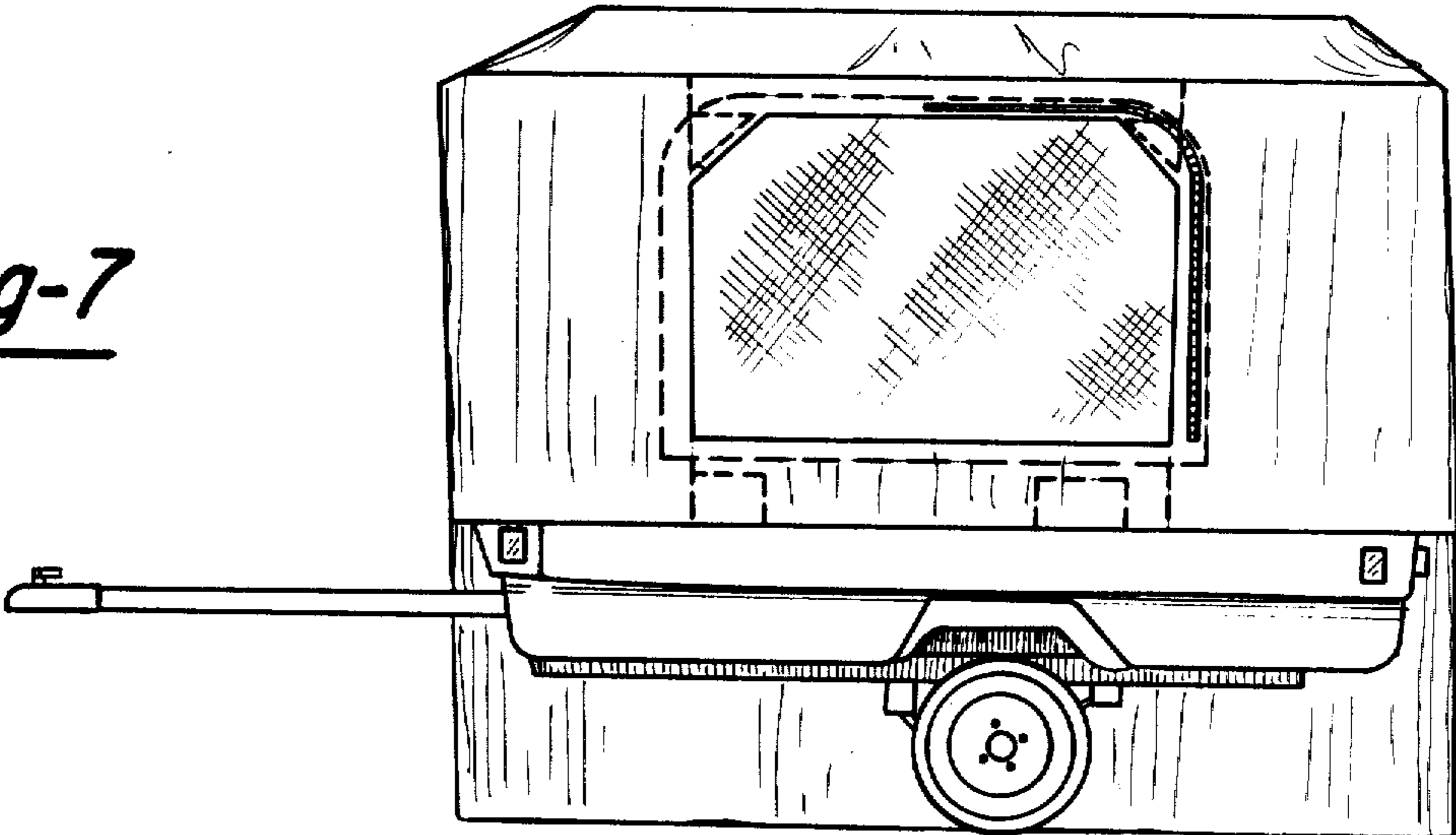

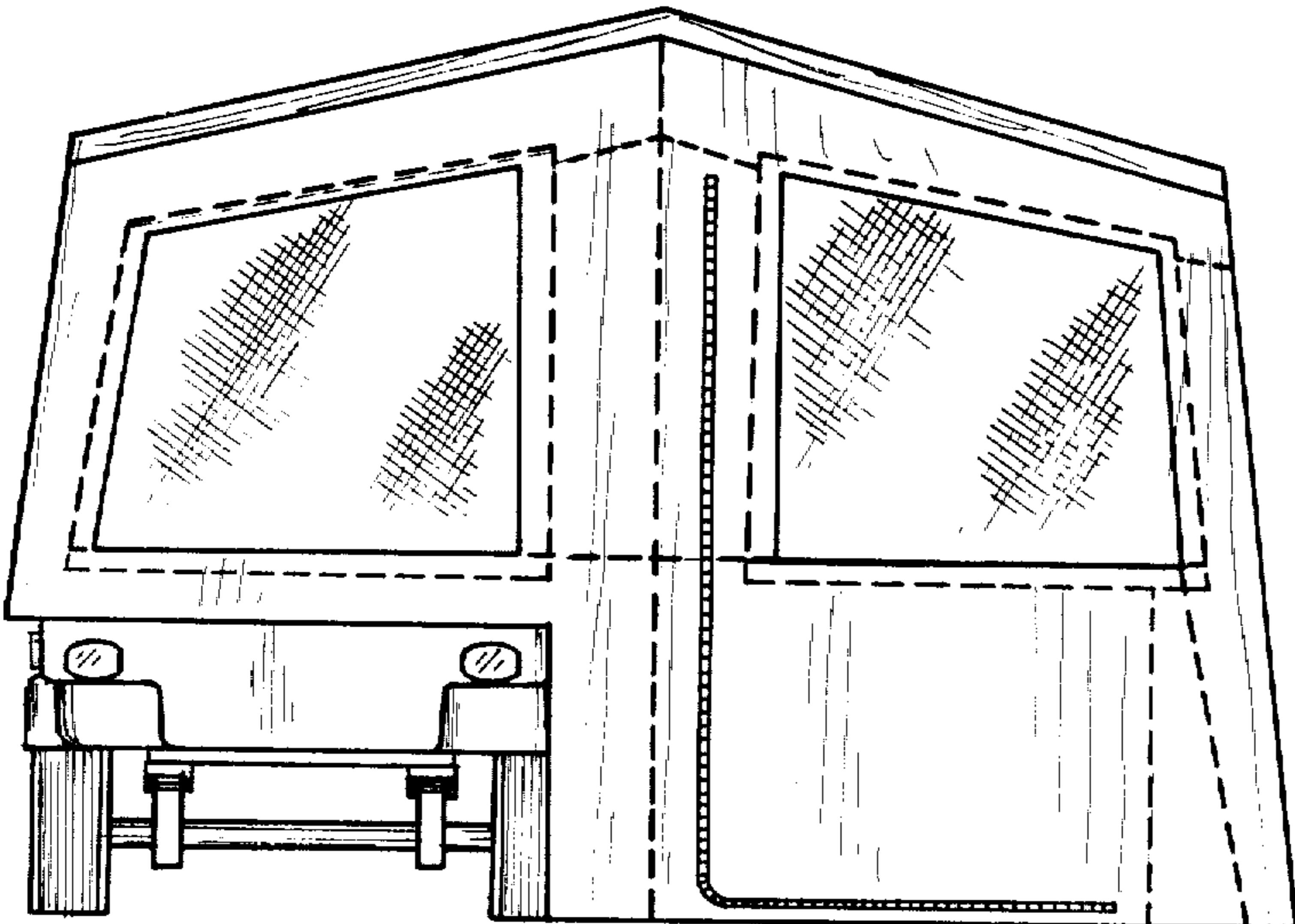

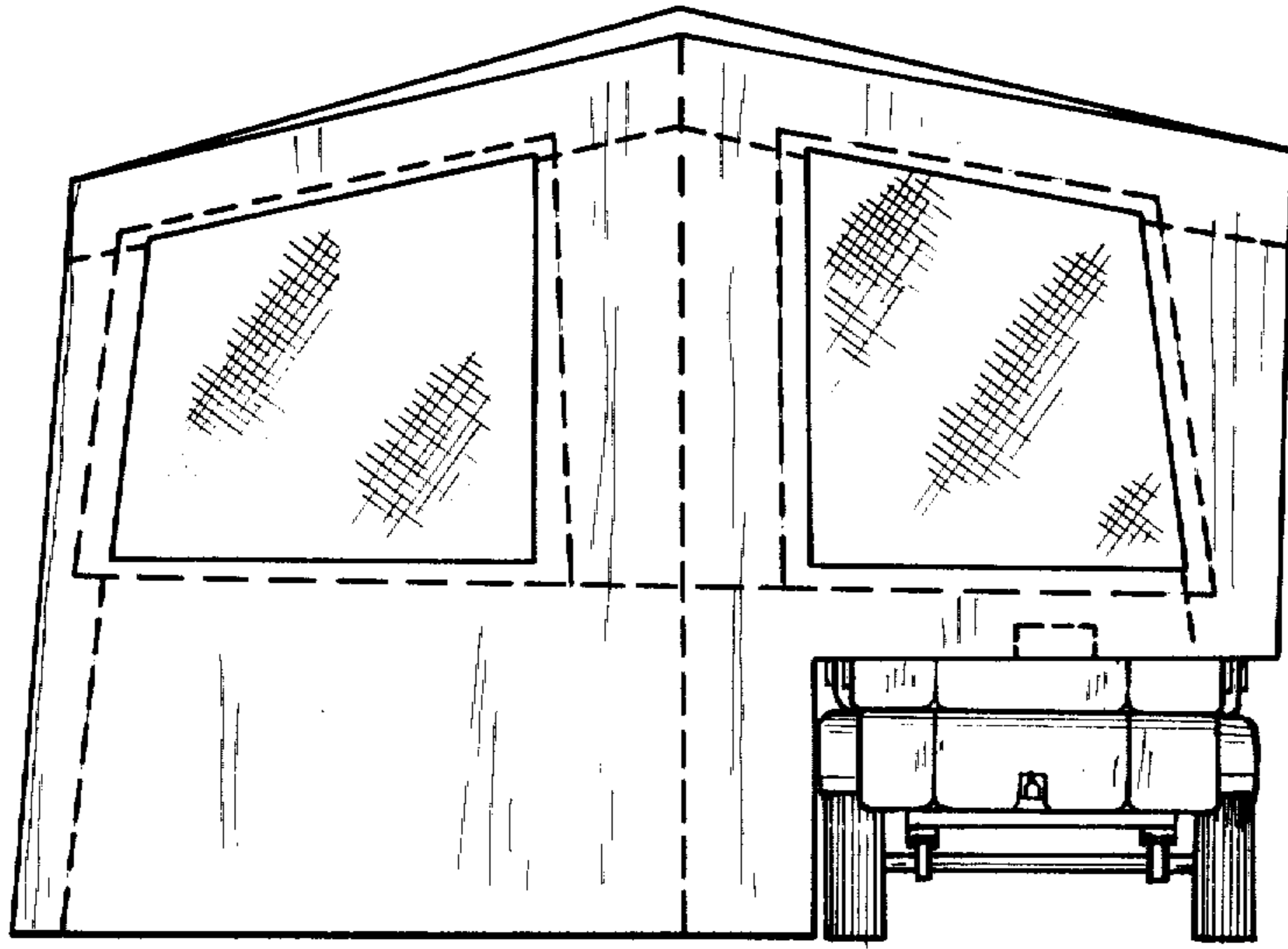

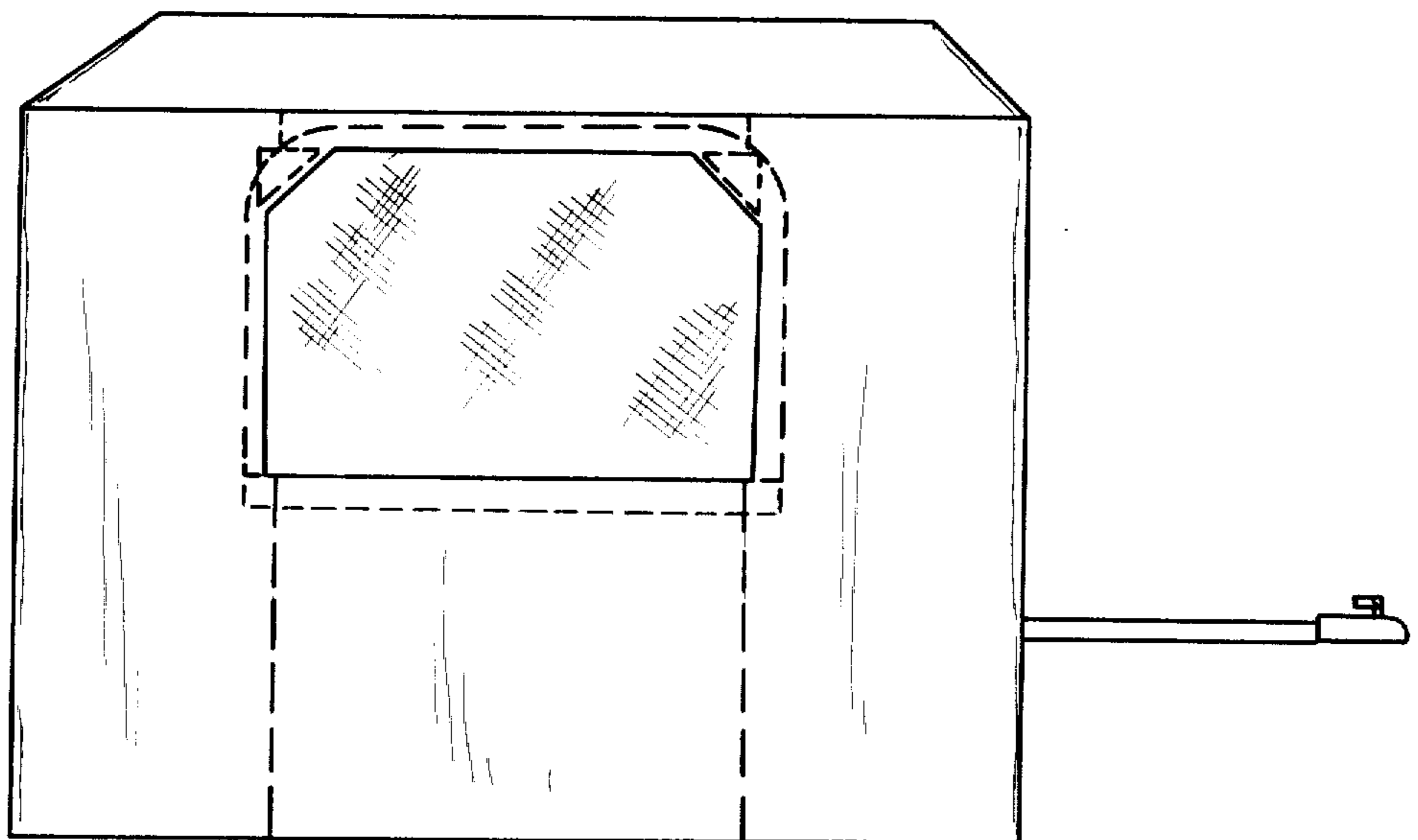

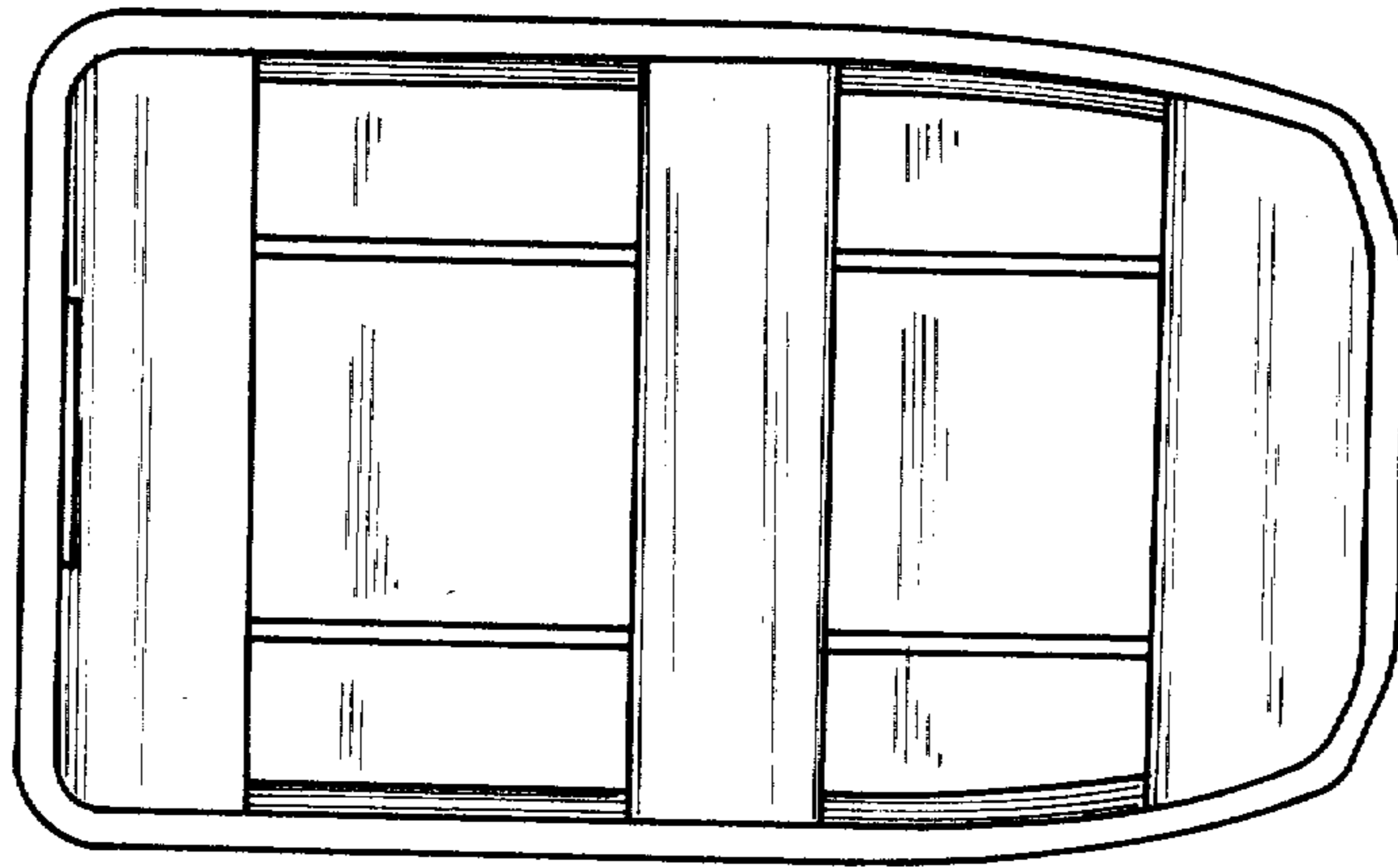

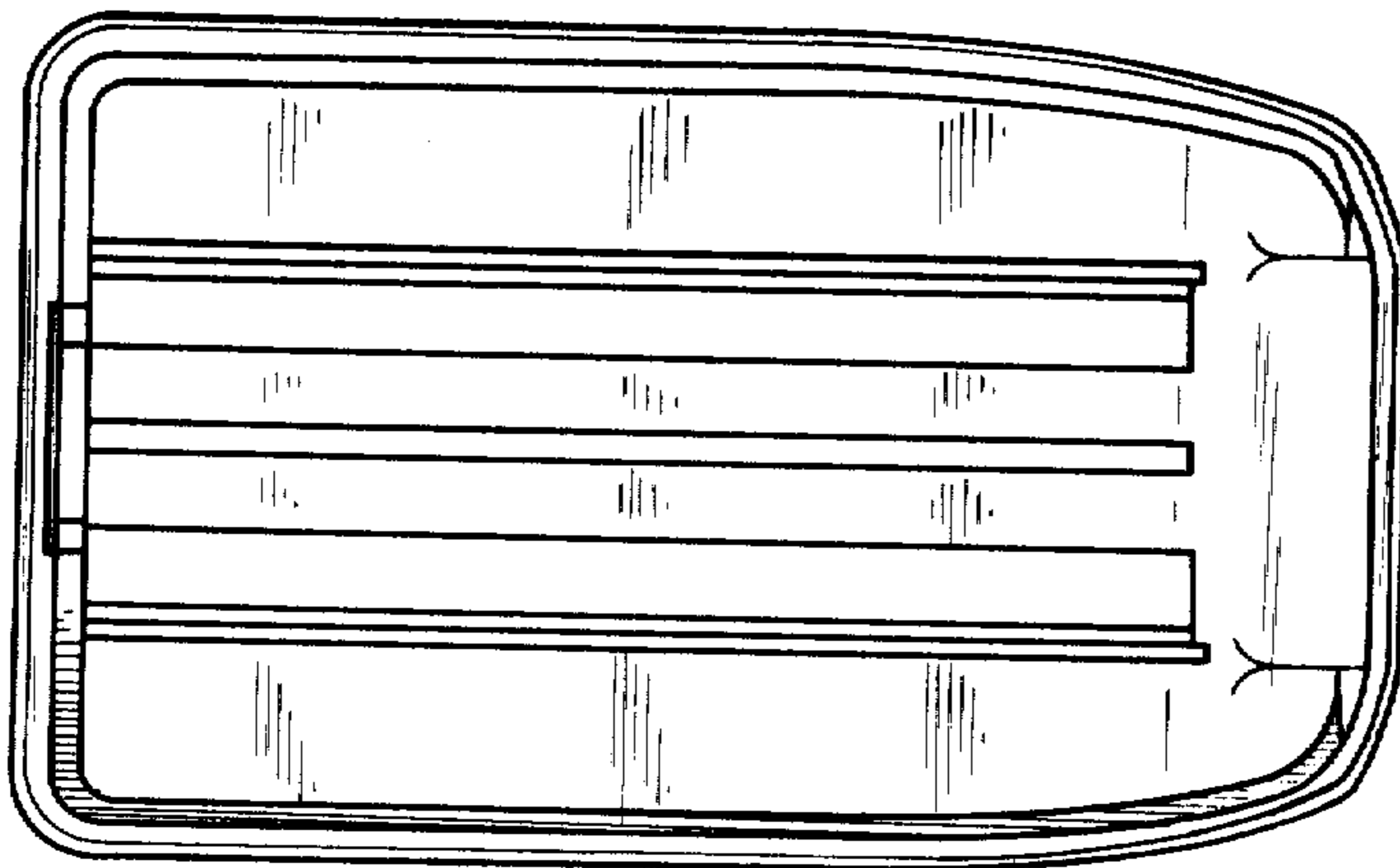

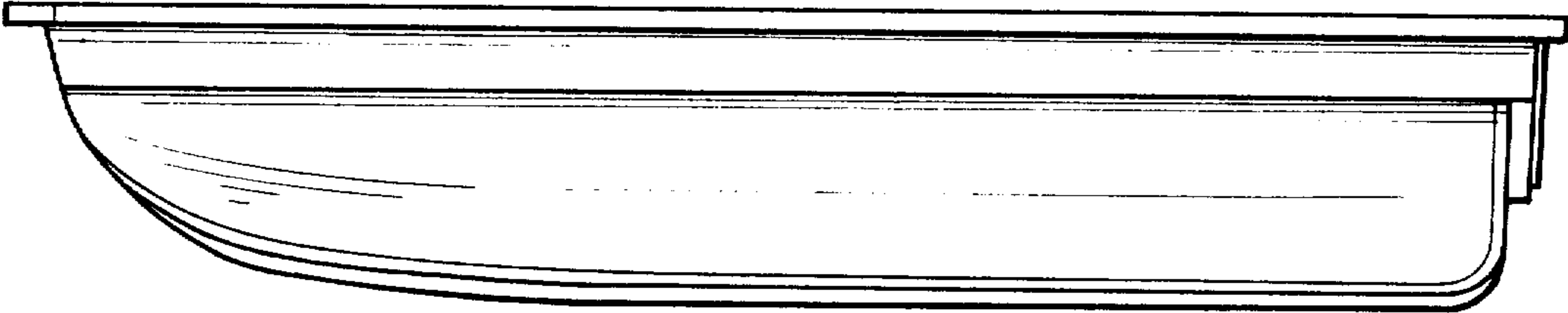

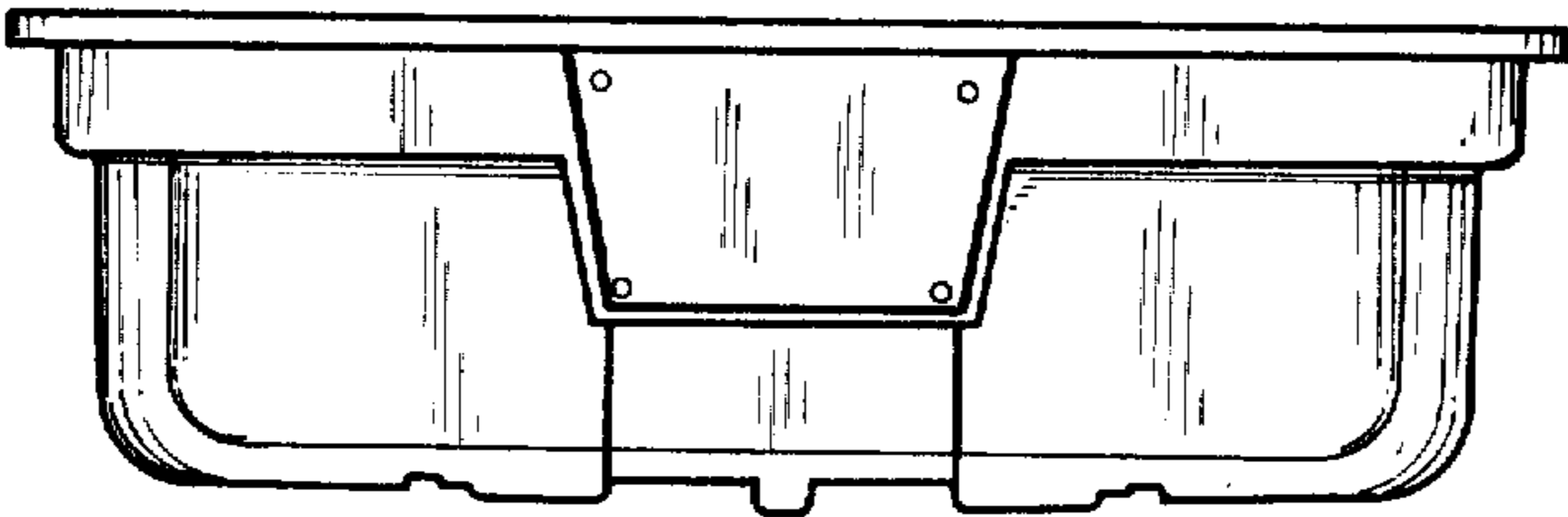

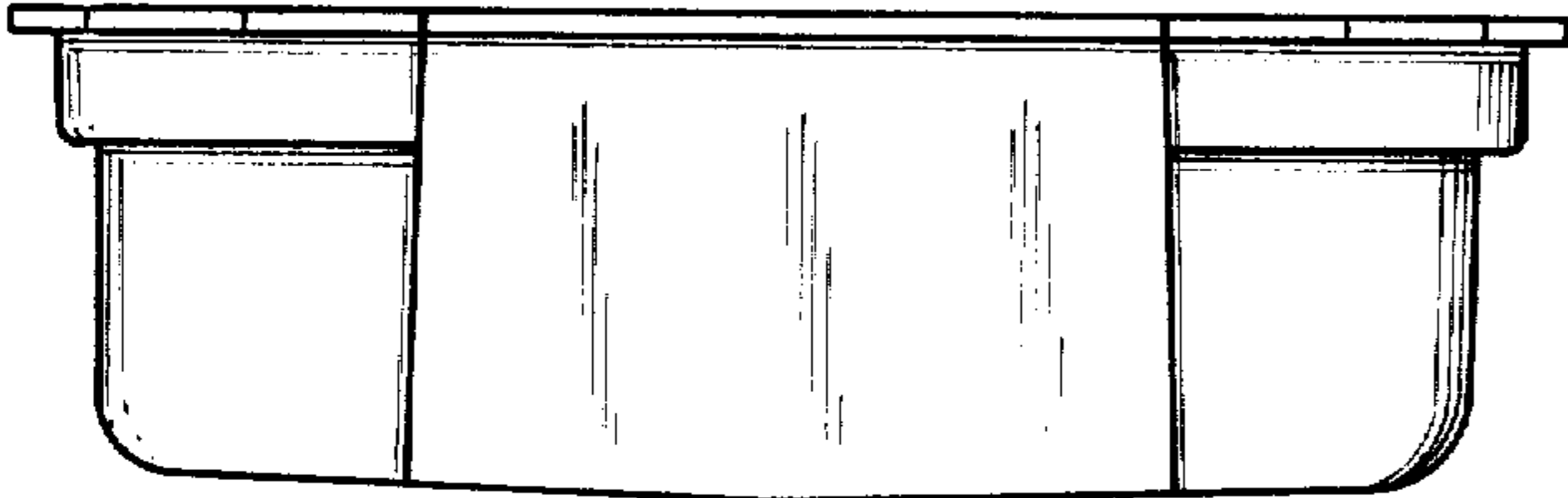

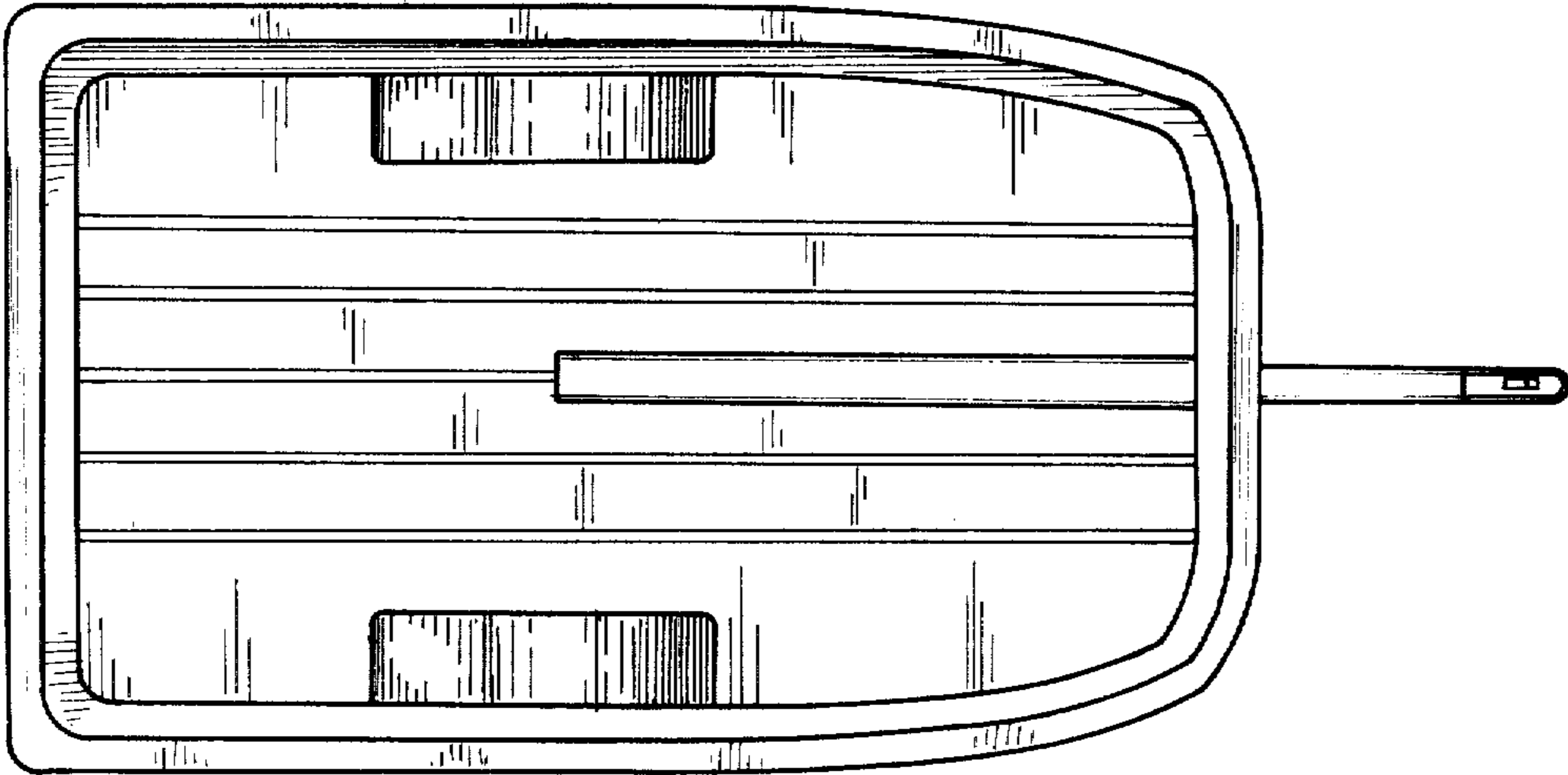

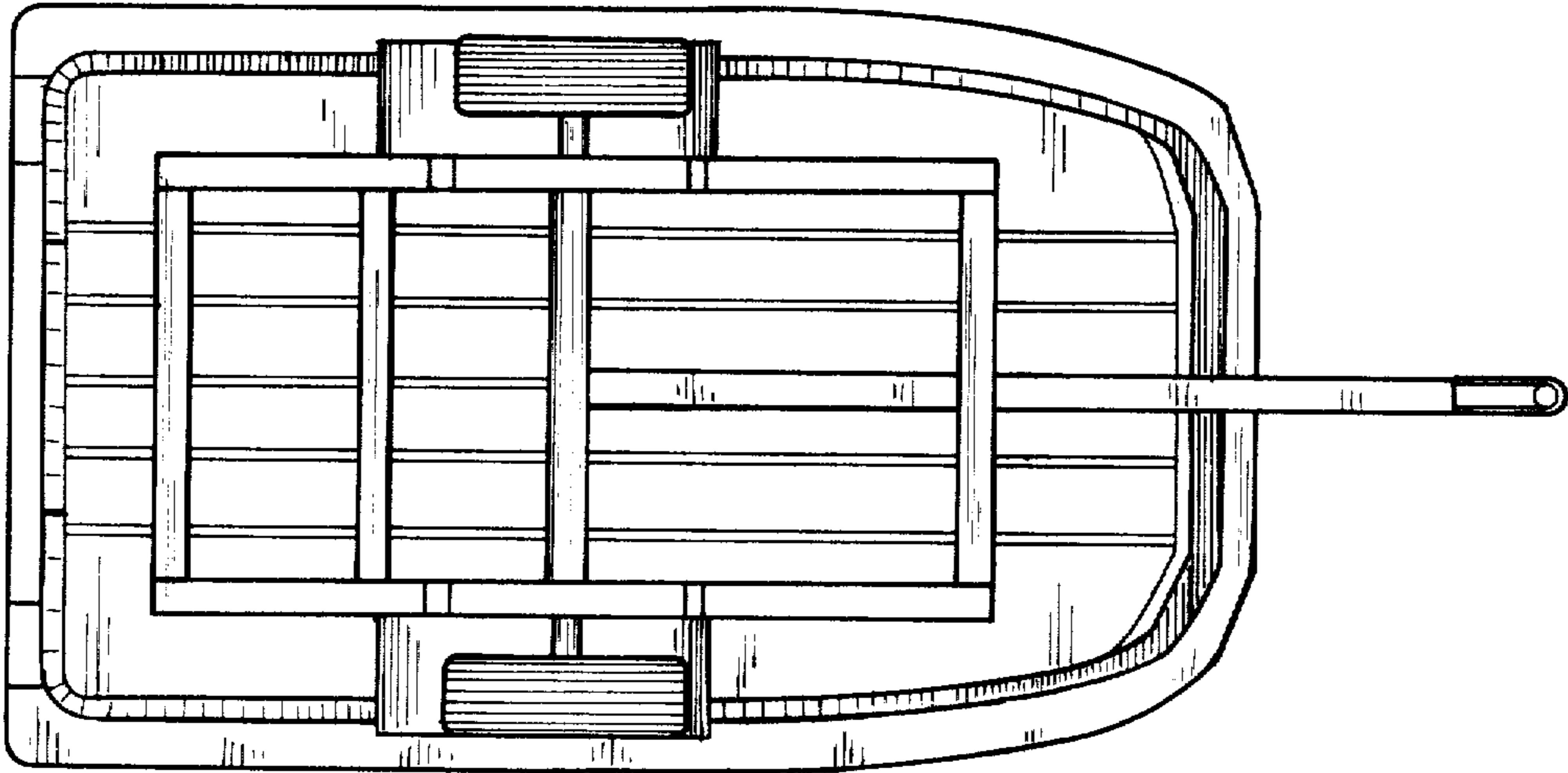

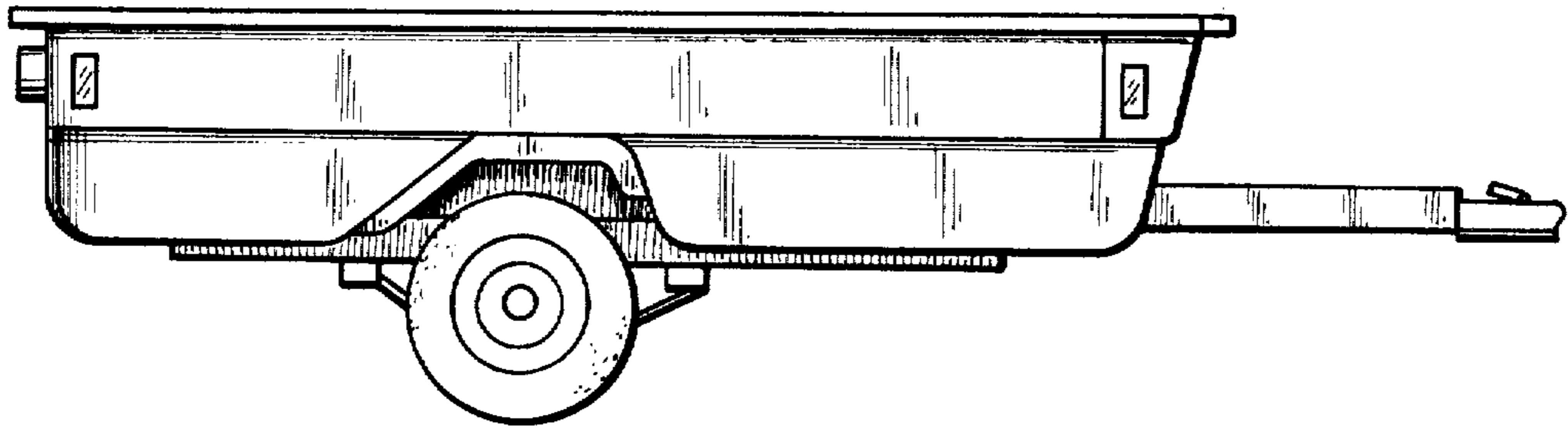

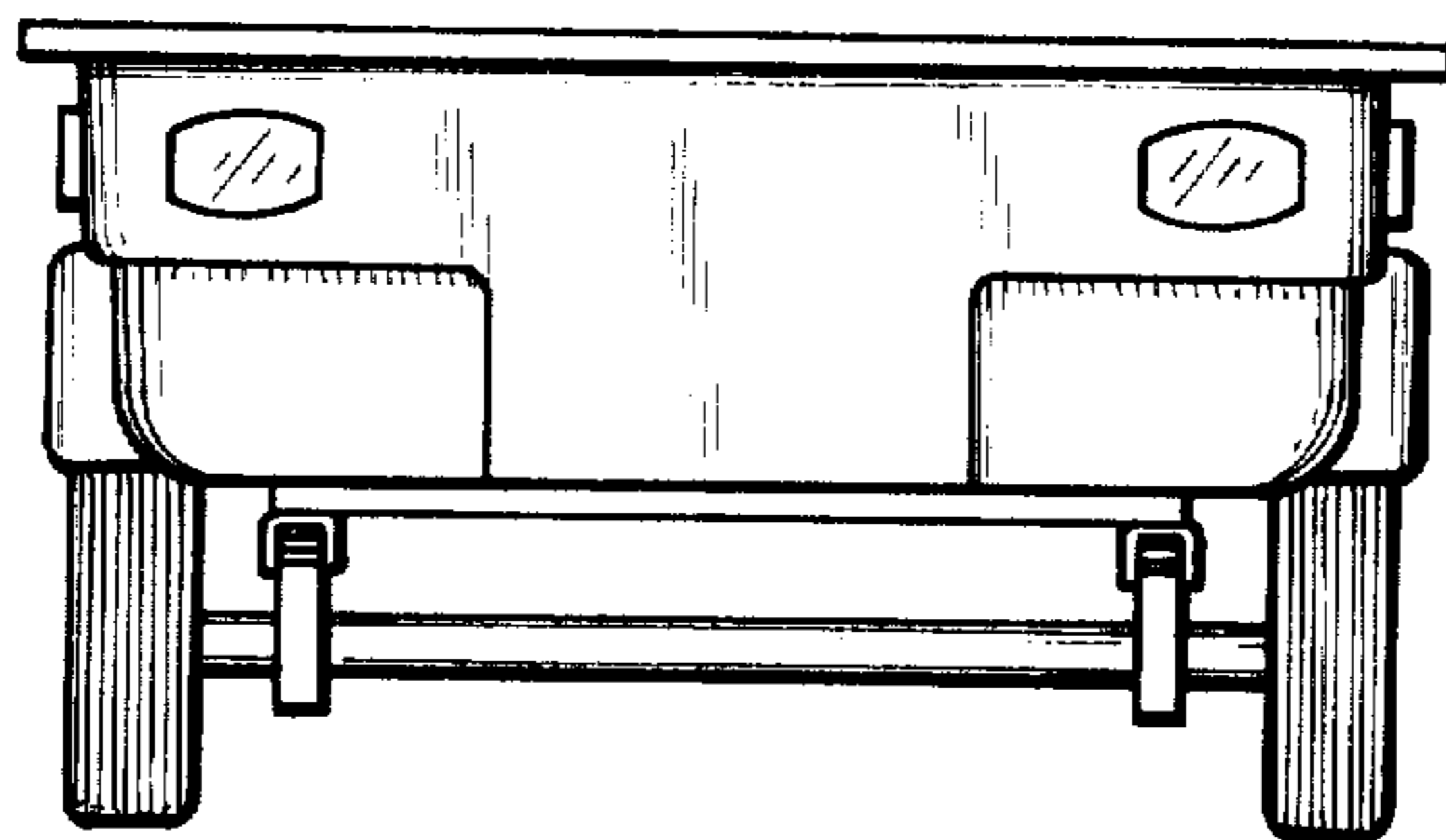

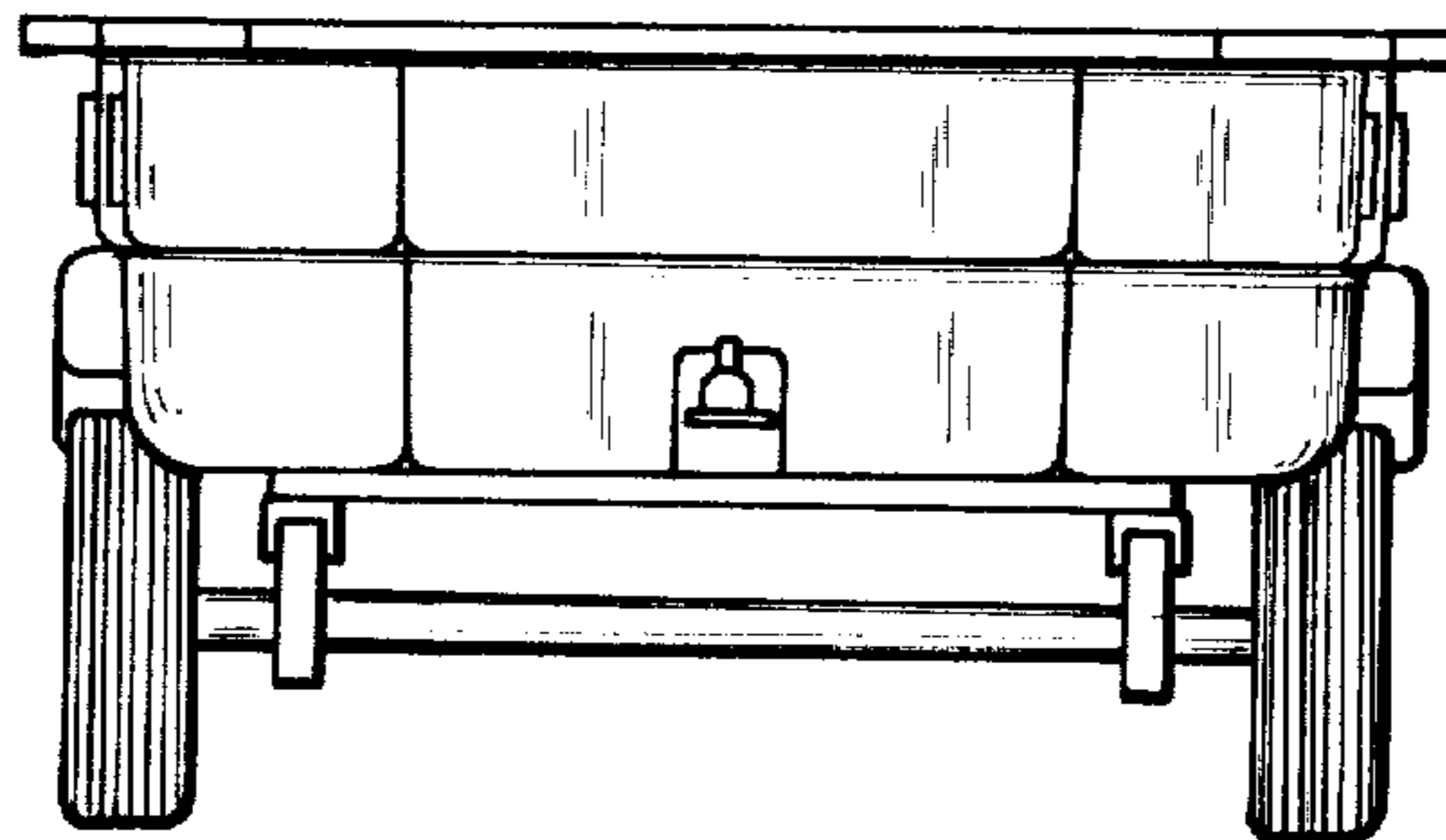
