The ornamental design for a shoe sole, as shown.

DESCRIPTION

FIG. 1 is a top plan view of a shoe sole showing my new design;

FIG. 2 is a left side elevational view thereof, the right side being a mirror image thereto;

FIG. 5 is a rear elevational view thereof;

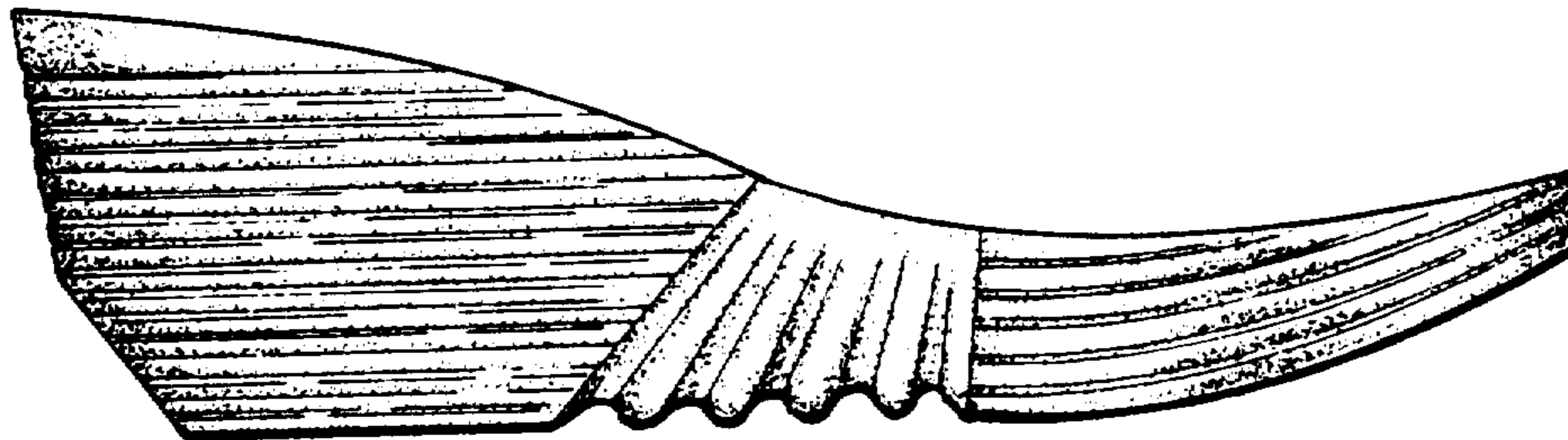
FIG. 6 is a top plan view of another embodiment of my new design of FIGS. 1-5;

FIG. 7 is a left side elevational view thereof, the right side being a mirror image thereto;

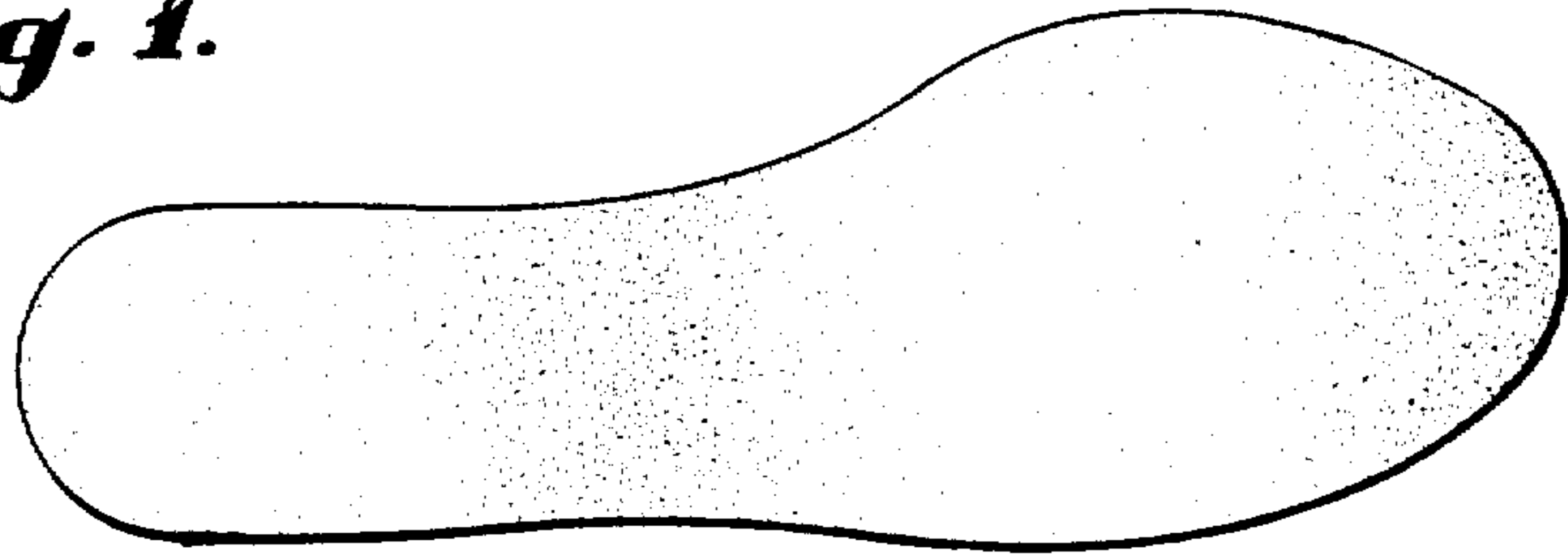
FIG. 8 is a bottom plan view thereof;

FIG. 9 is a front elevational view thereof;

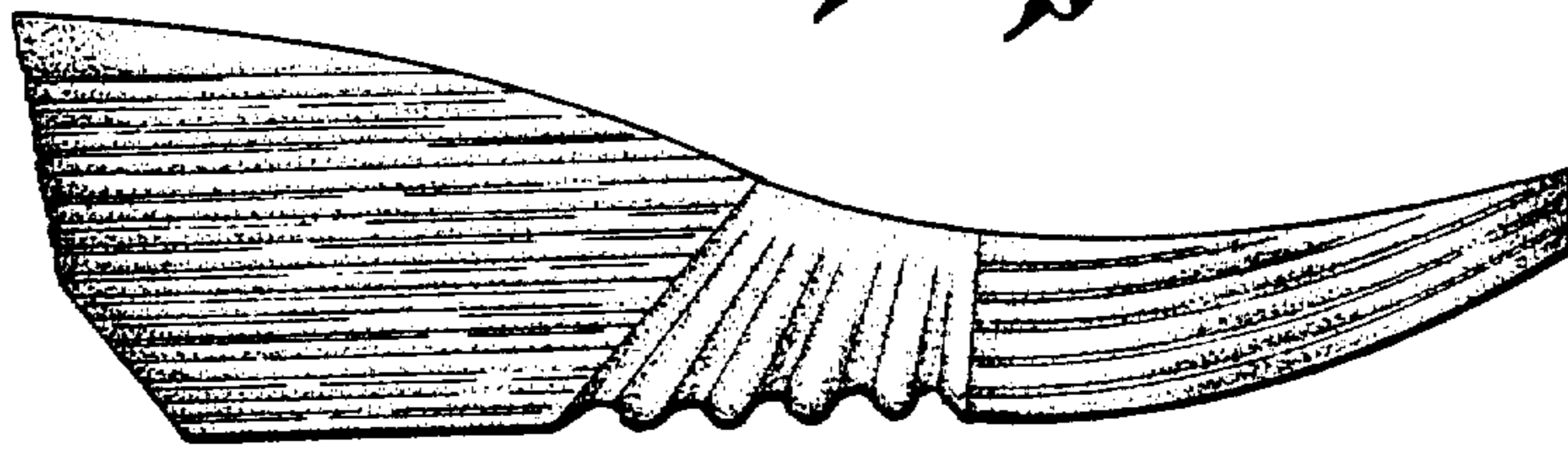
FIG. 10 is a rear elevational view thereof.



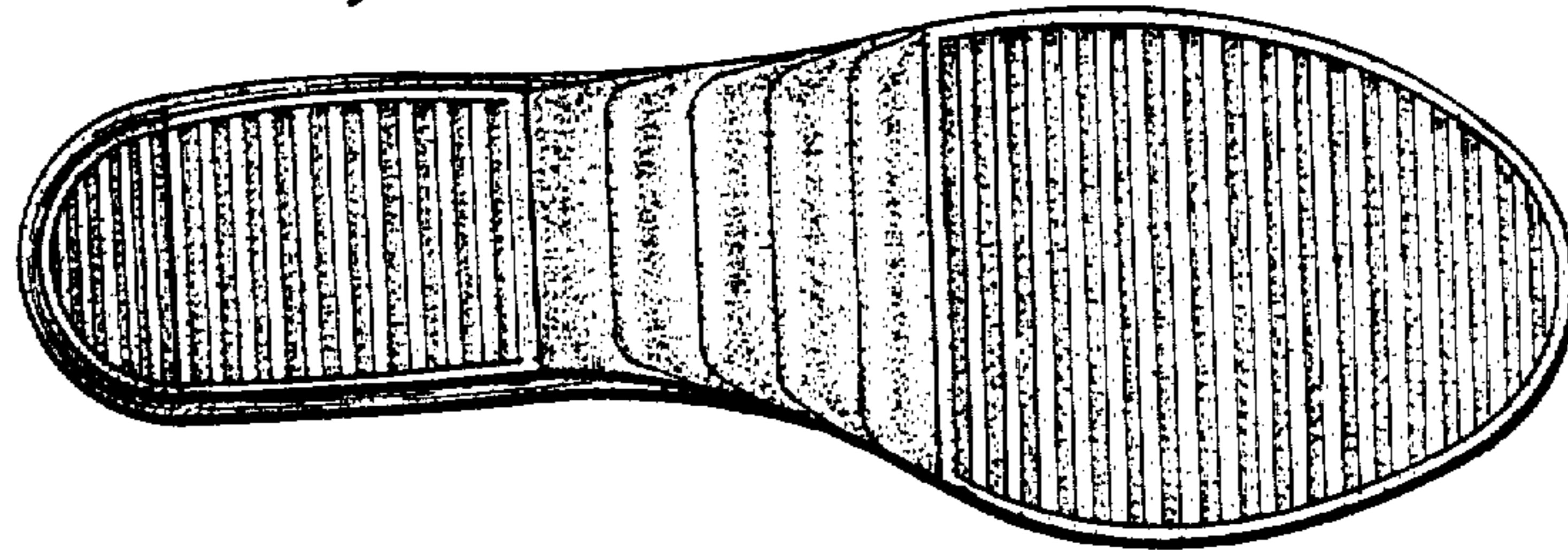

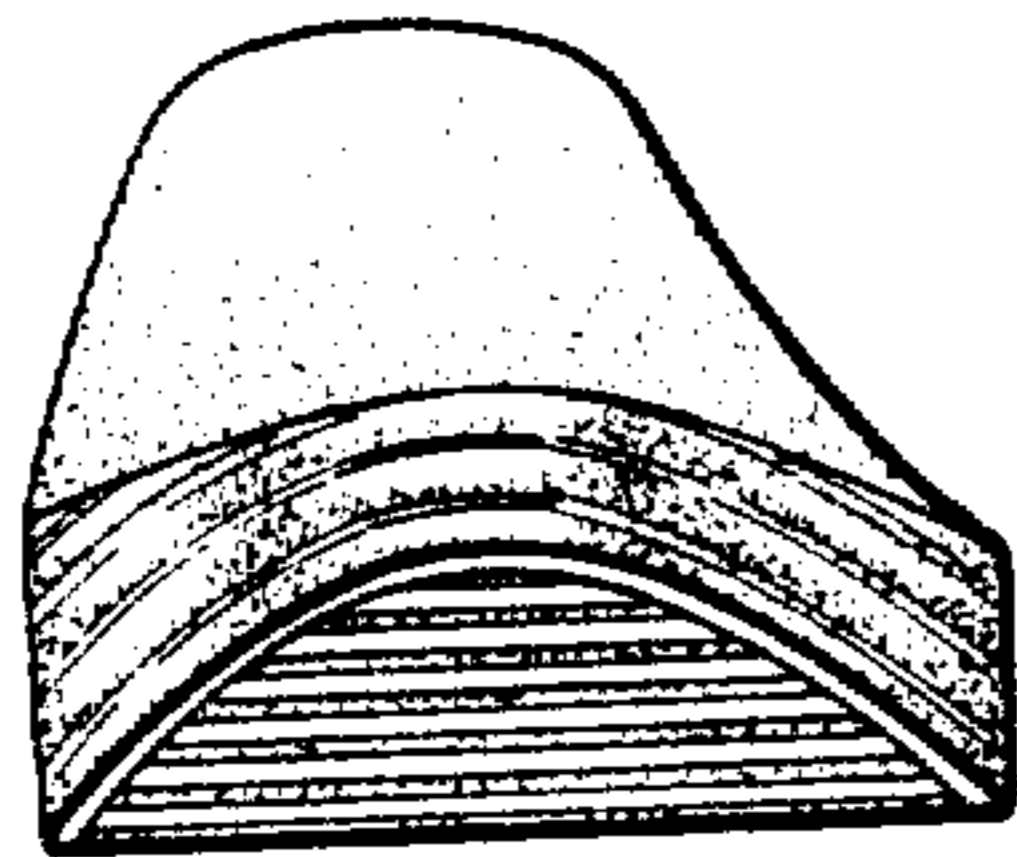

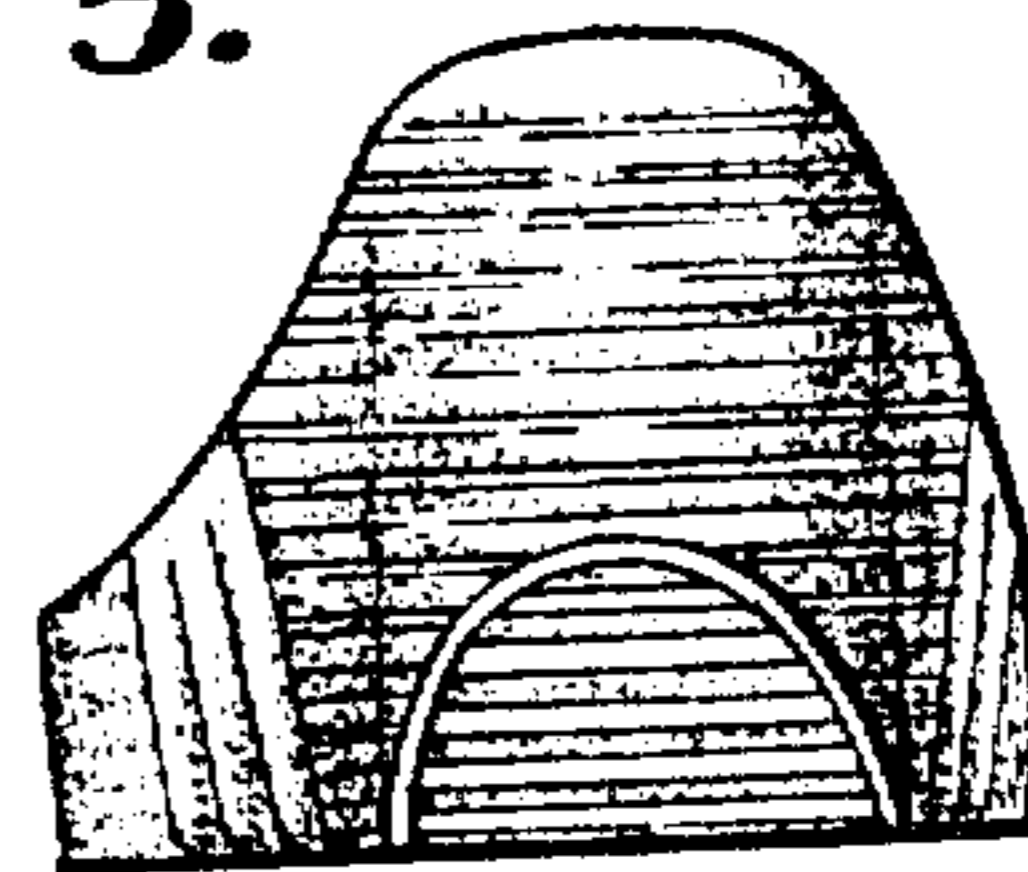

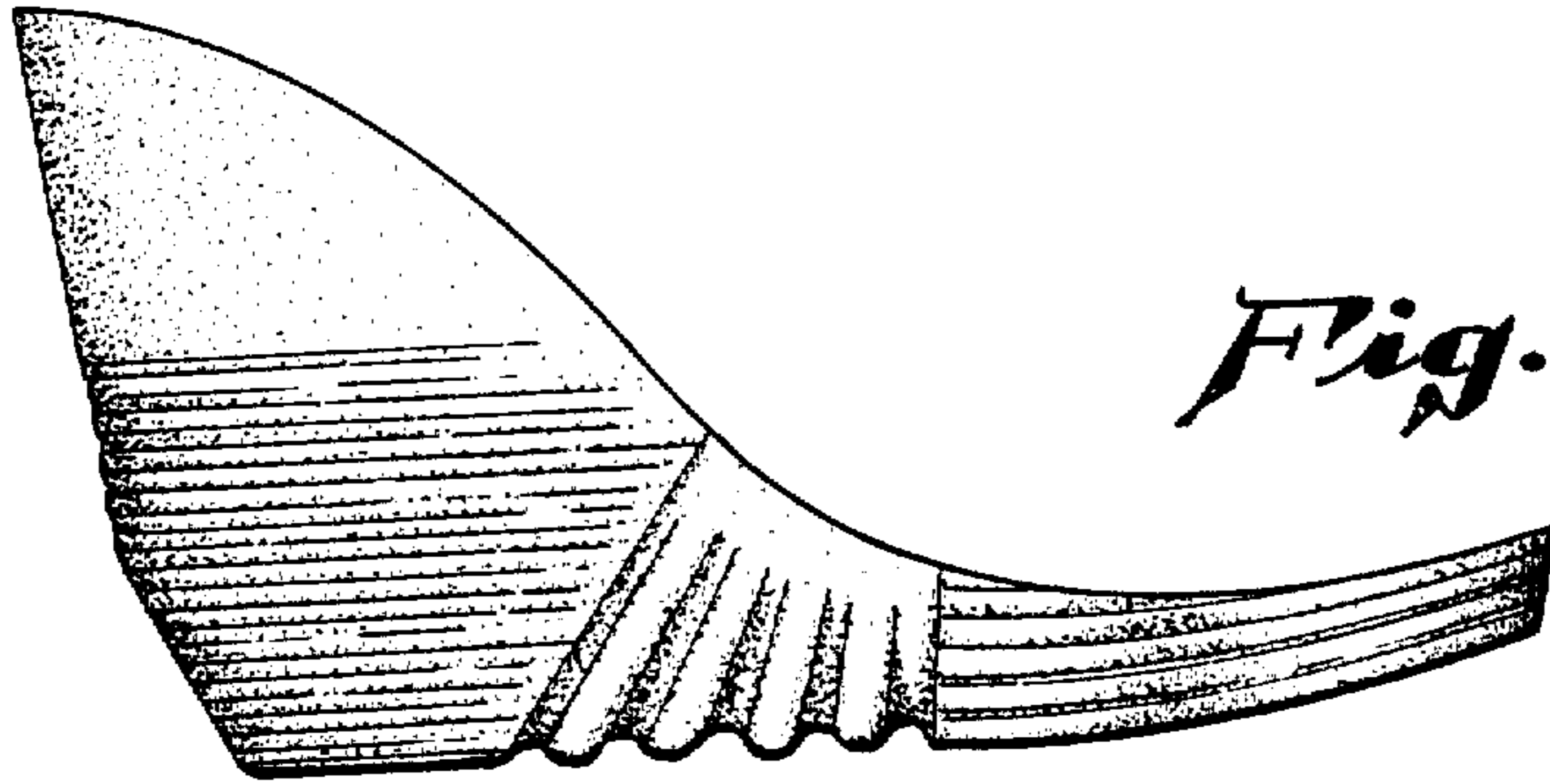
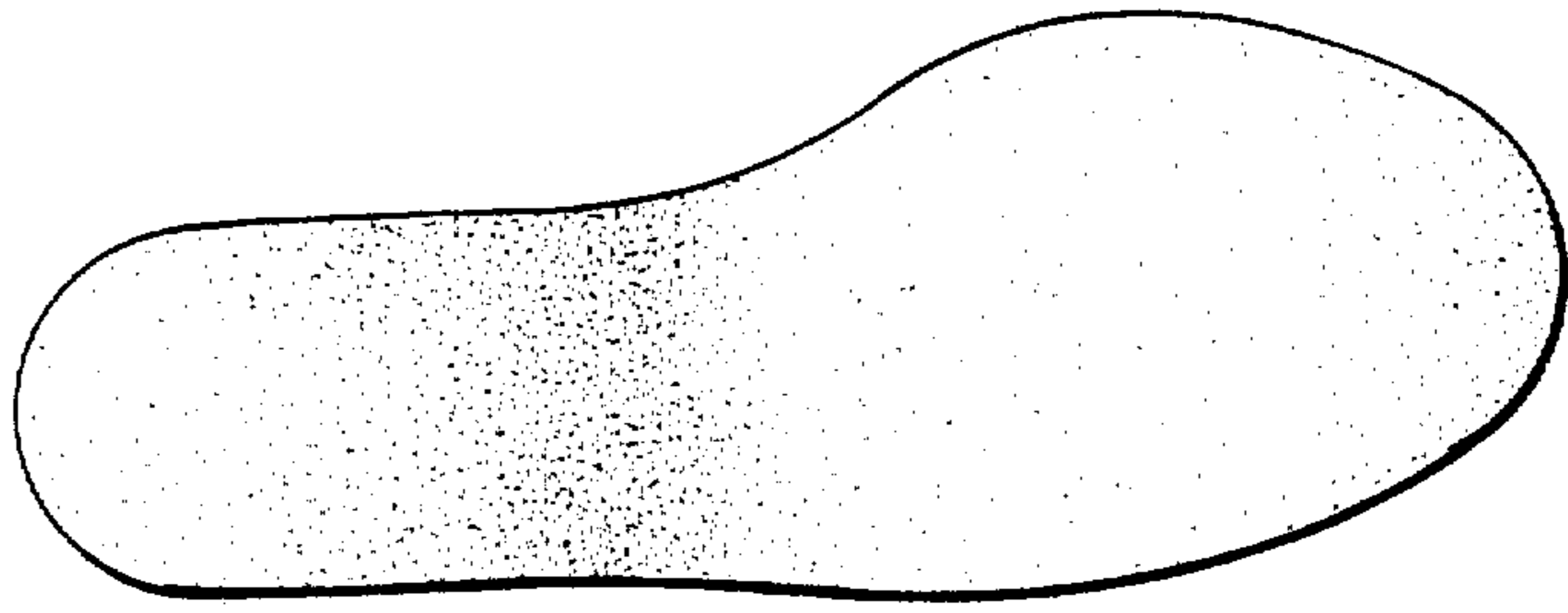

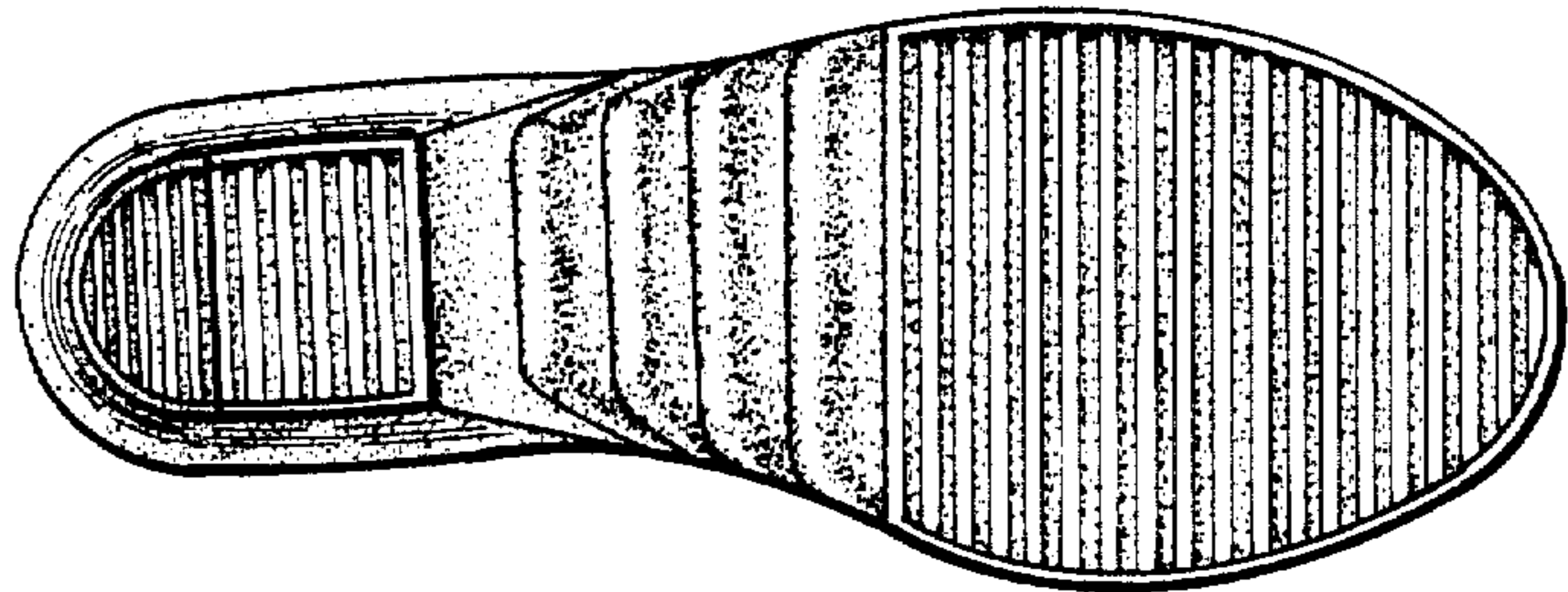

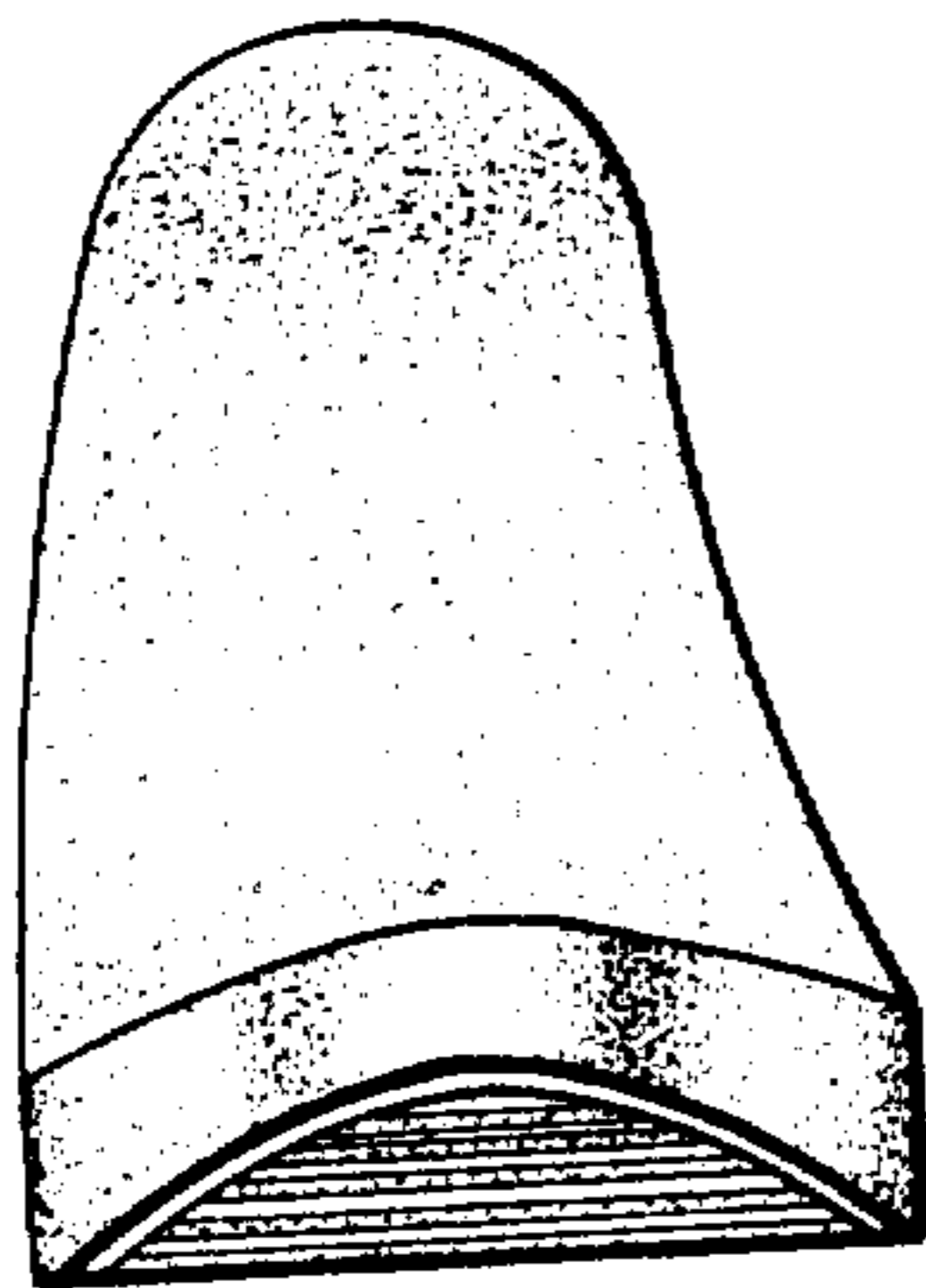
