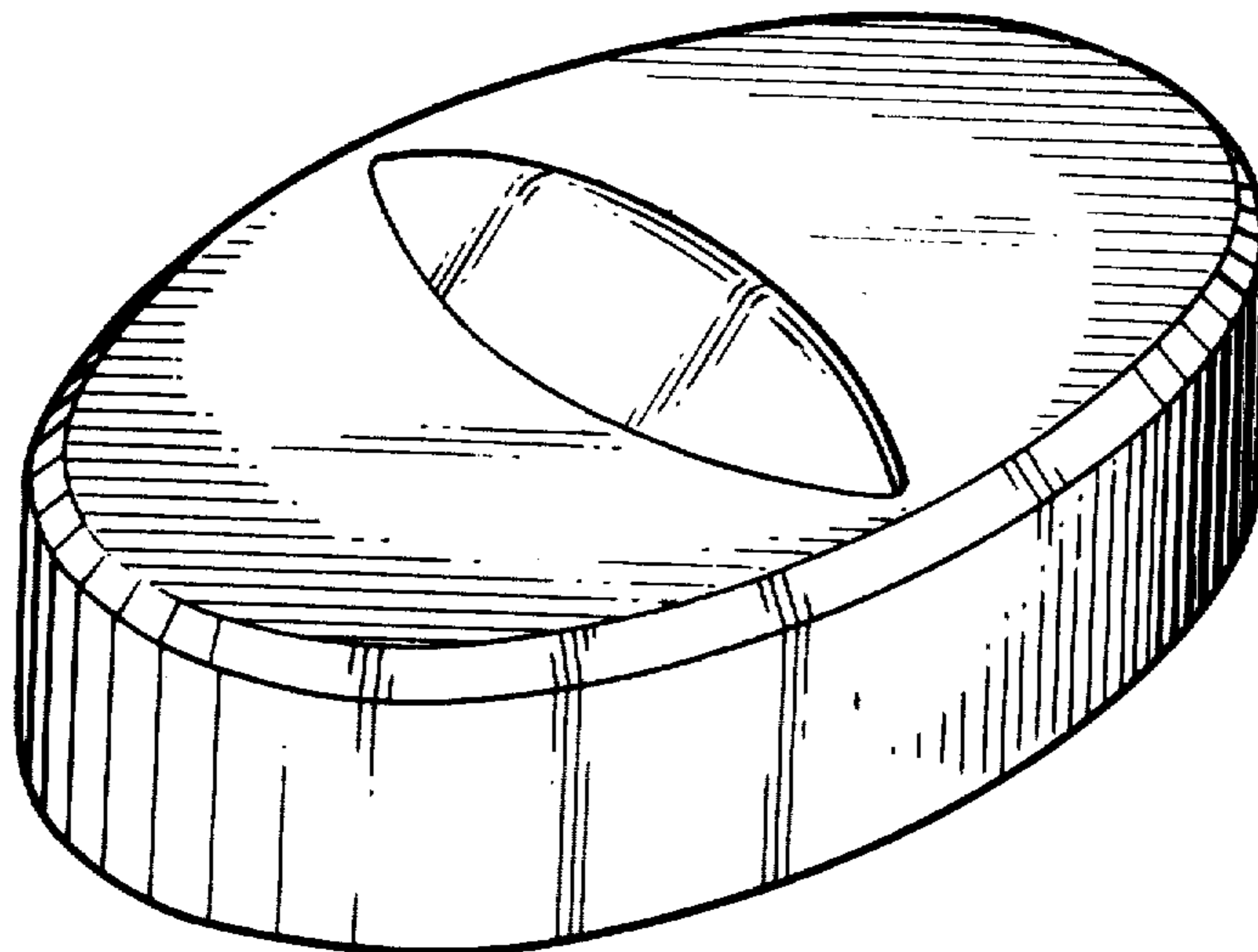

 FIG. 3 is a side elevation thereof, it being understood that the opposite side is identical to that shown.



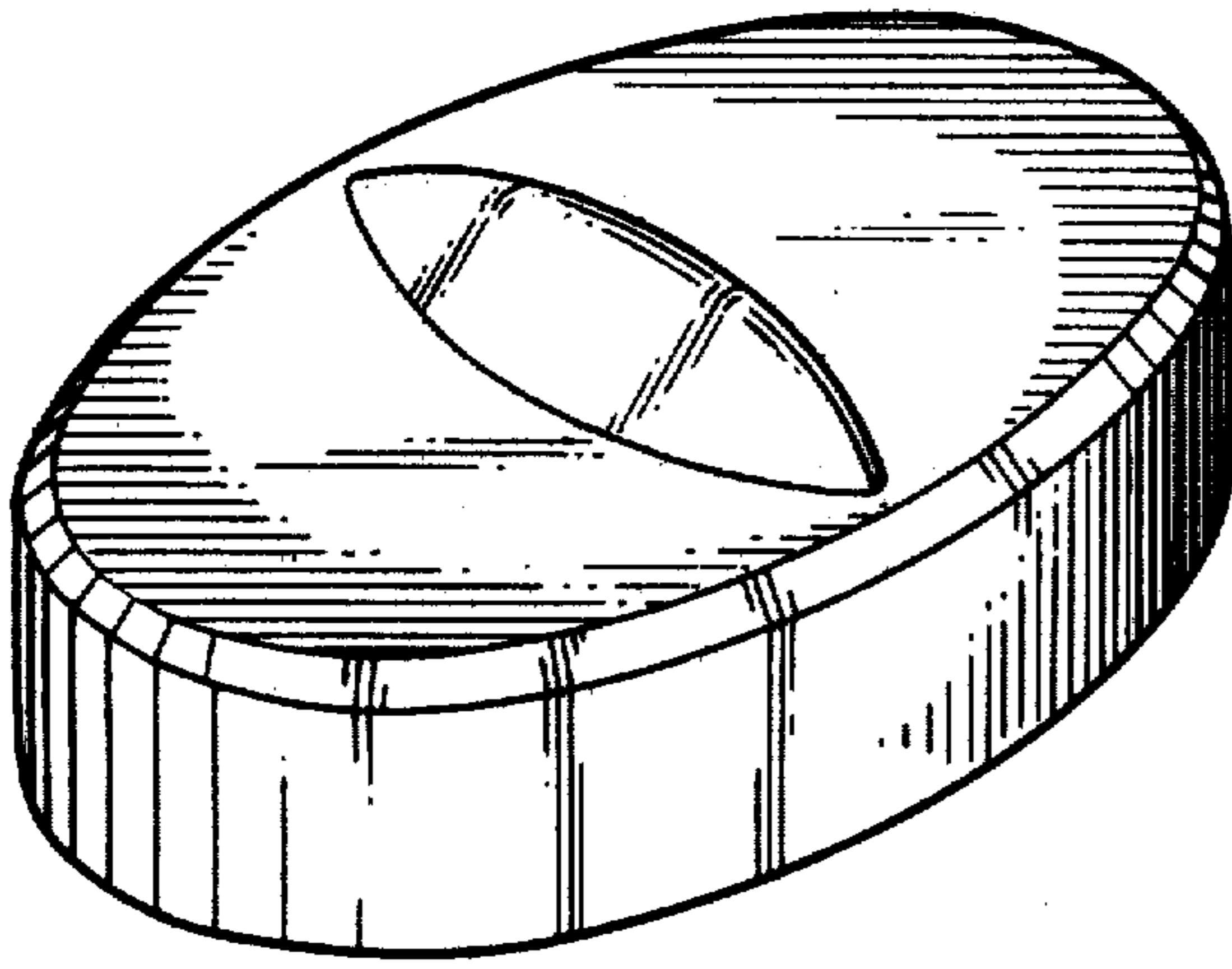

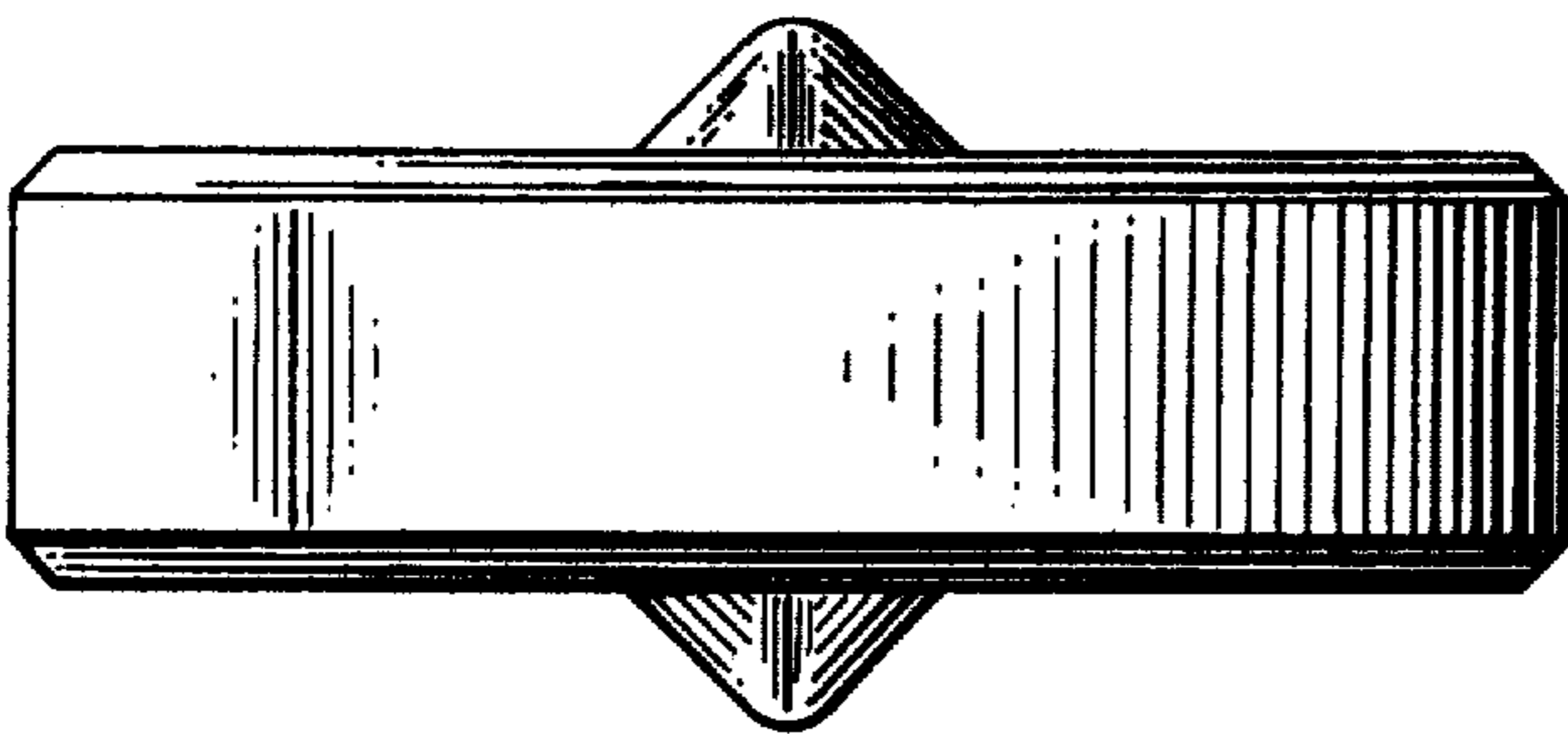
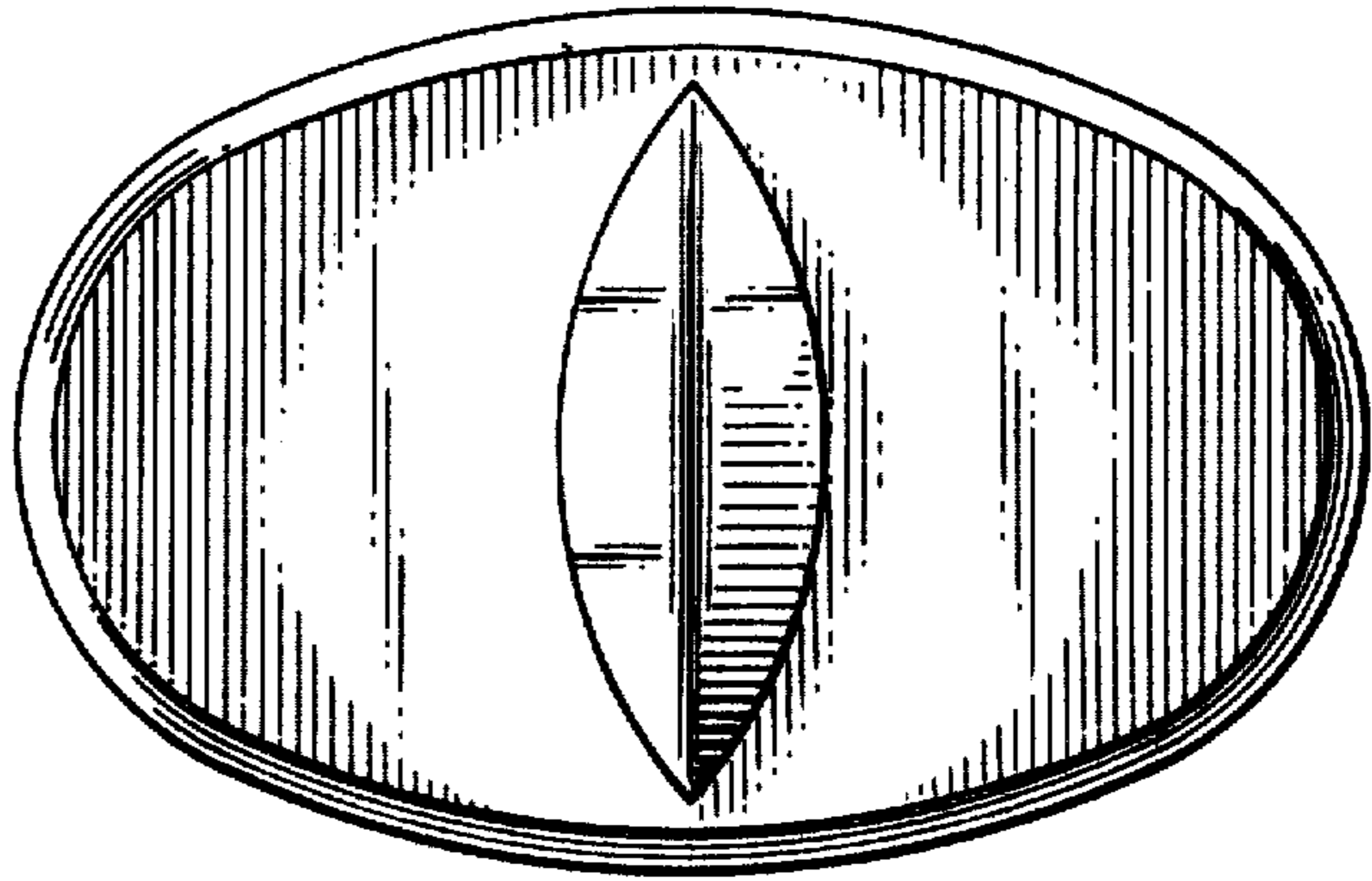
