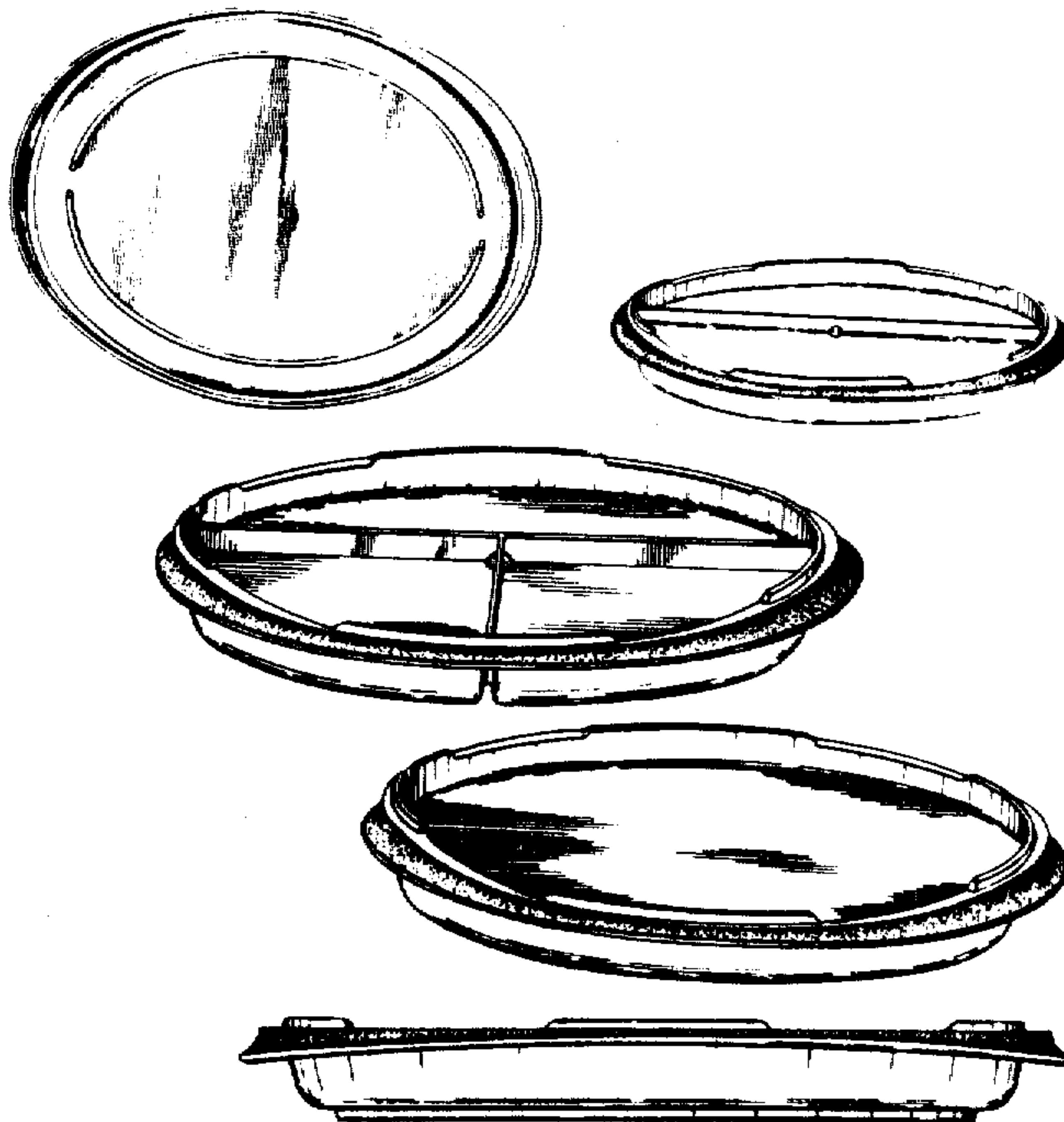

DESCRIPTION

FIG. 1 is a top front perspective view of a dish showing my new design;

 FIG. 12 is a bottom plan view of the dish shown in FIG. 8;
 FIG. 13 is a top front perspective view of another alternative embodiment of the dish;

 FIG. 18 is a bottom plan view of the dish shown in FIG. 13.



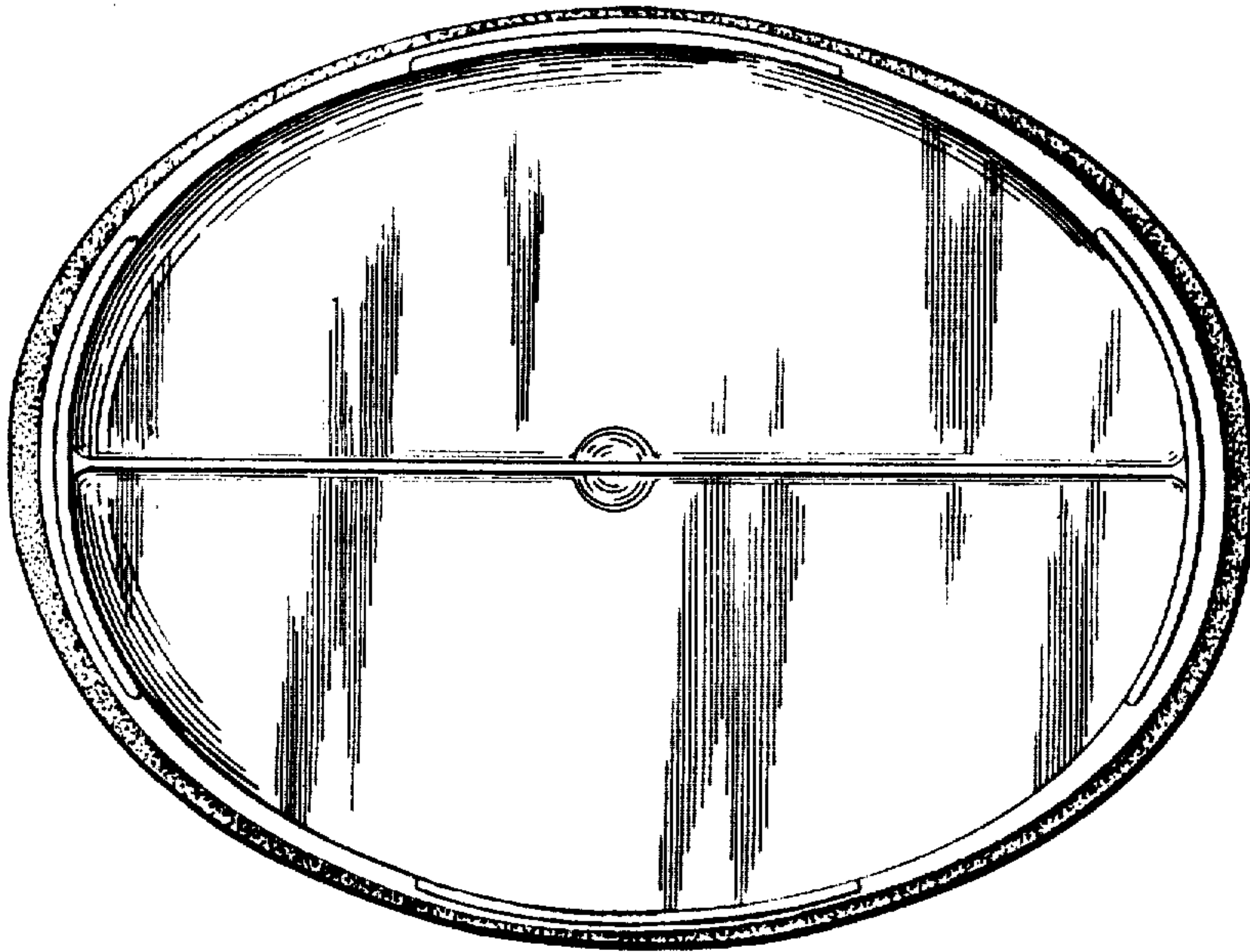

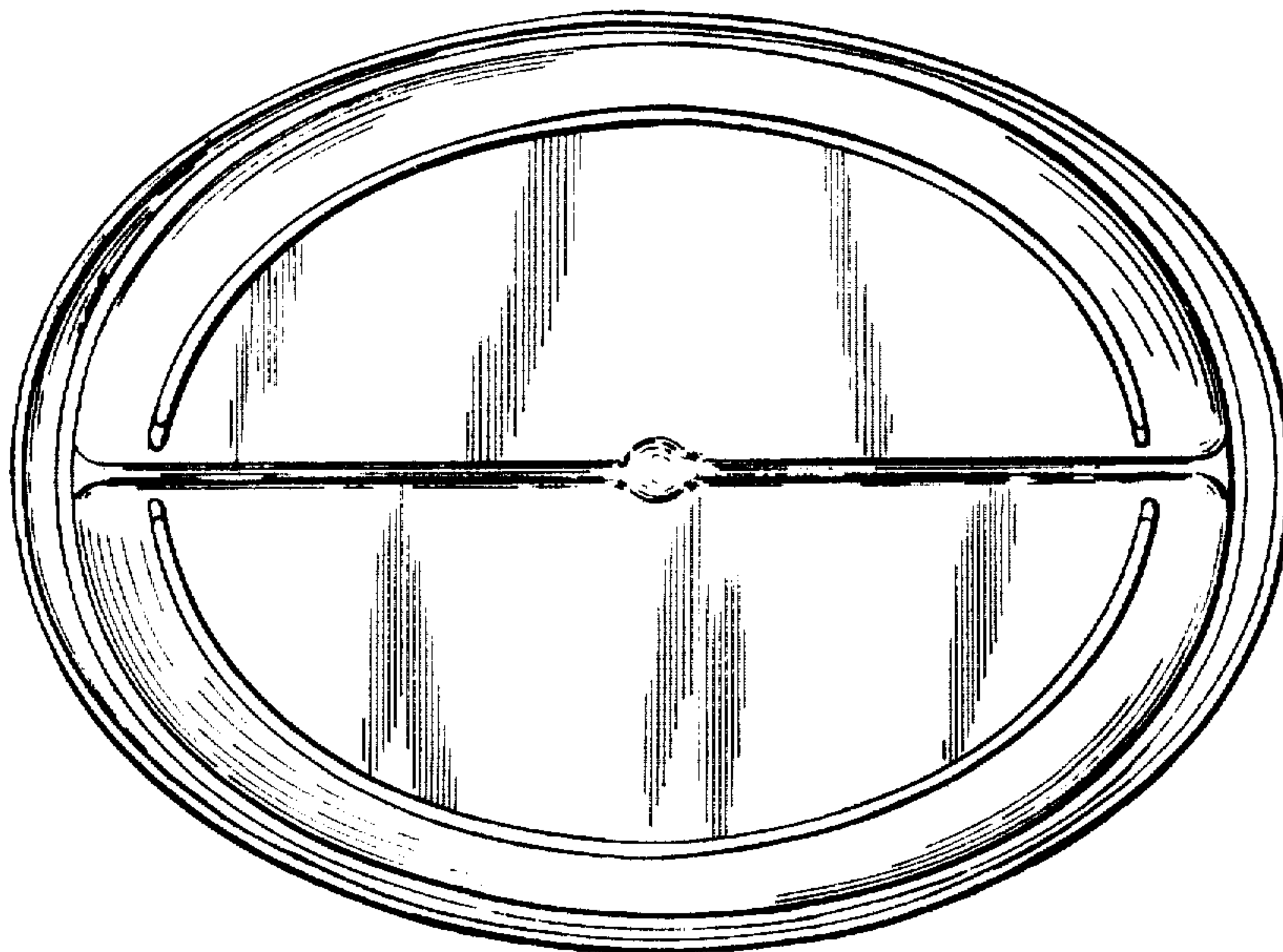
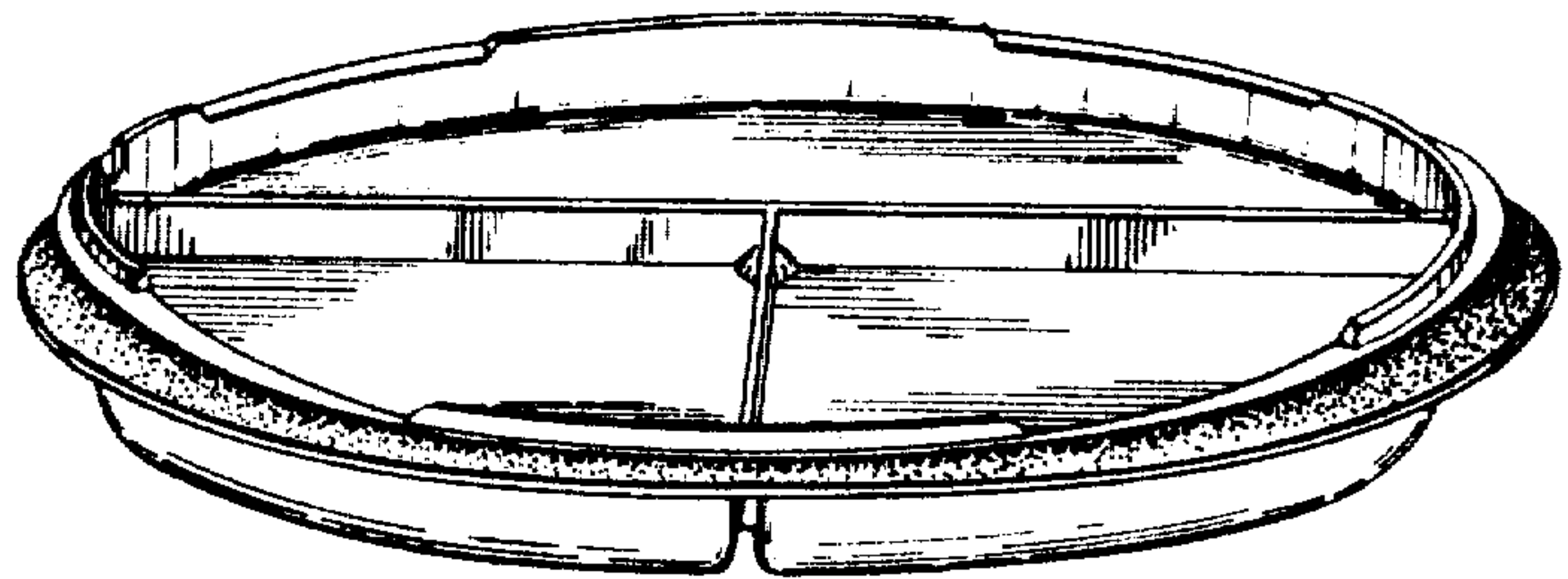

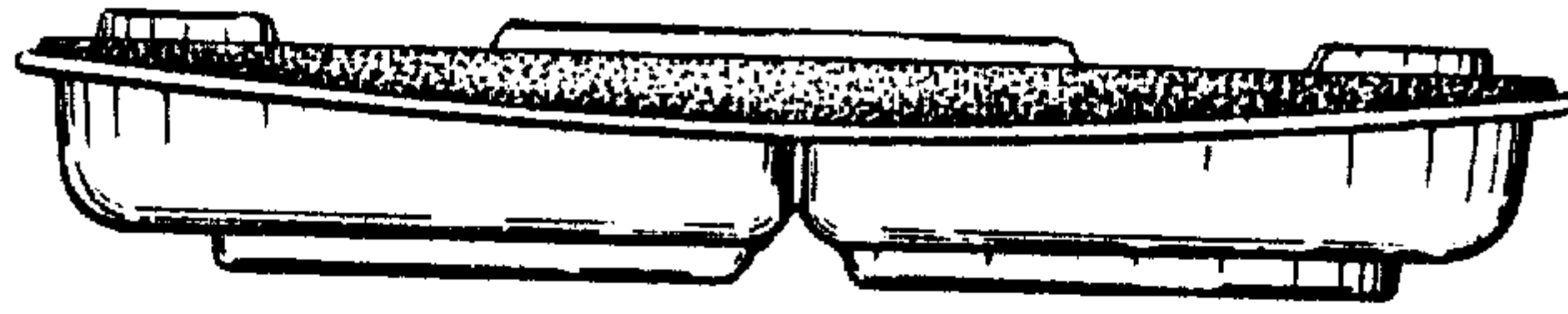

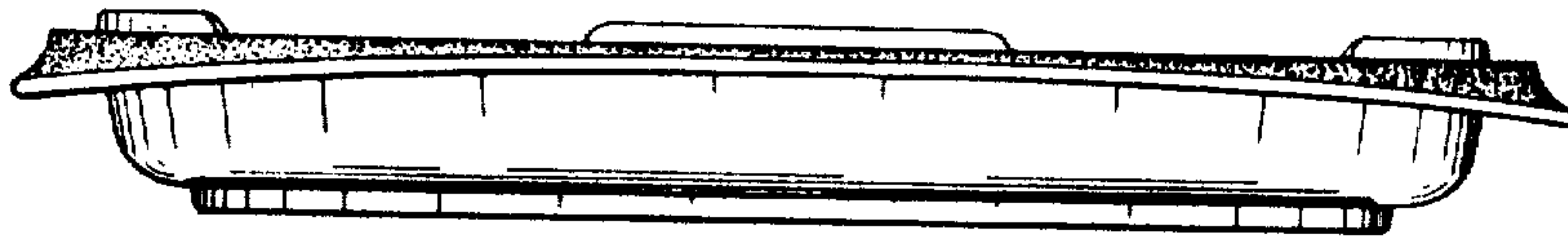

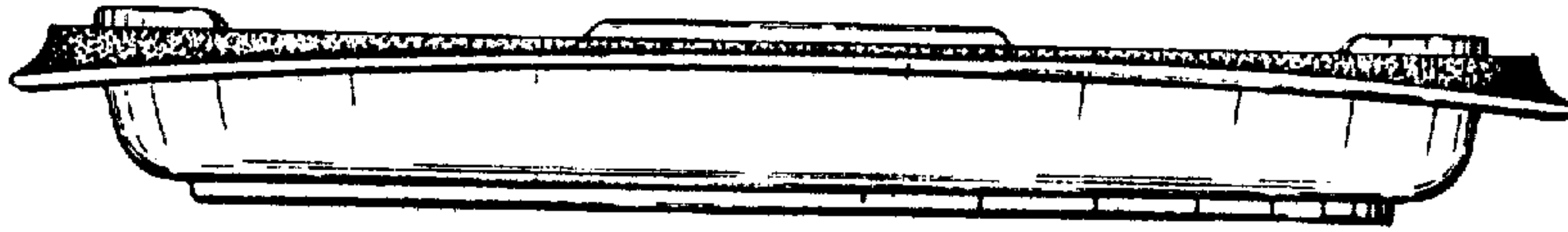

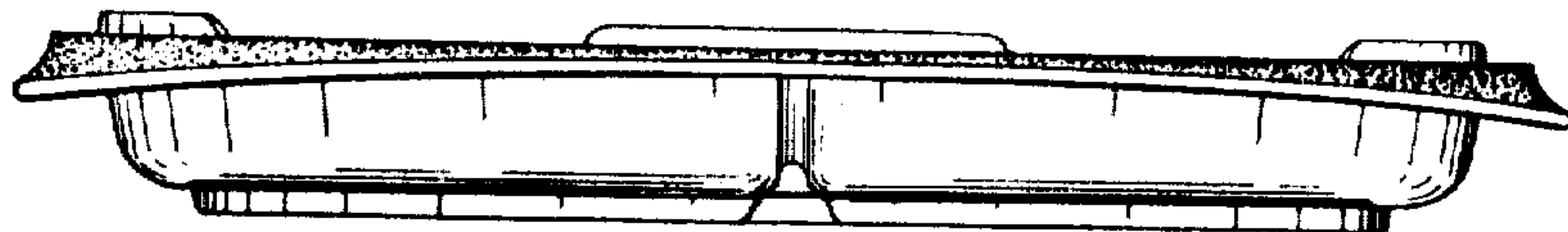

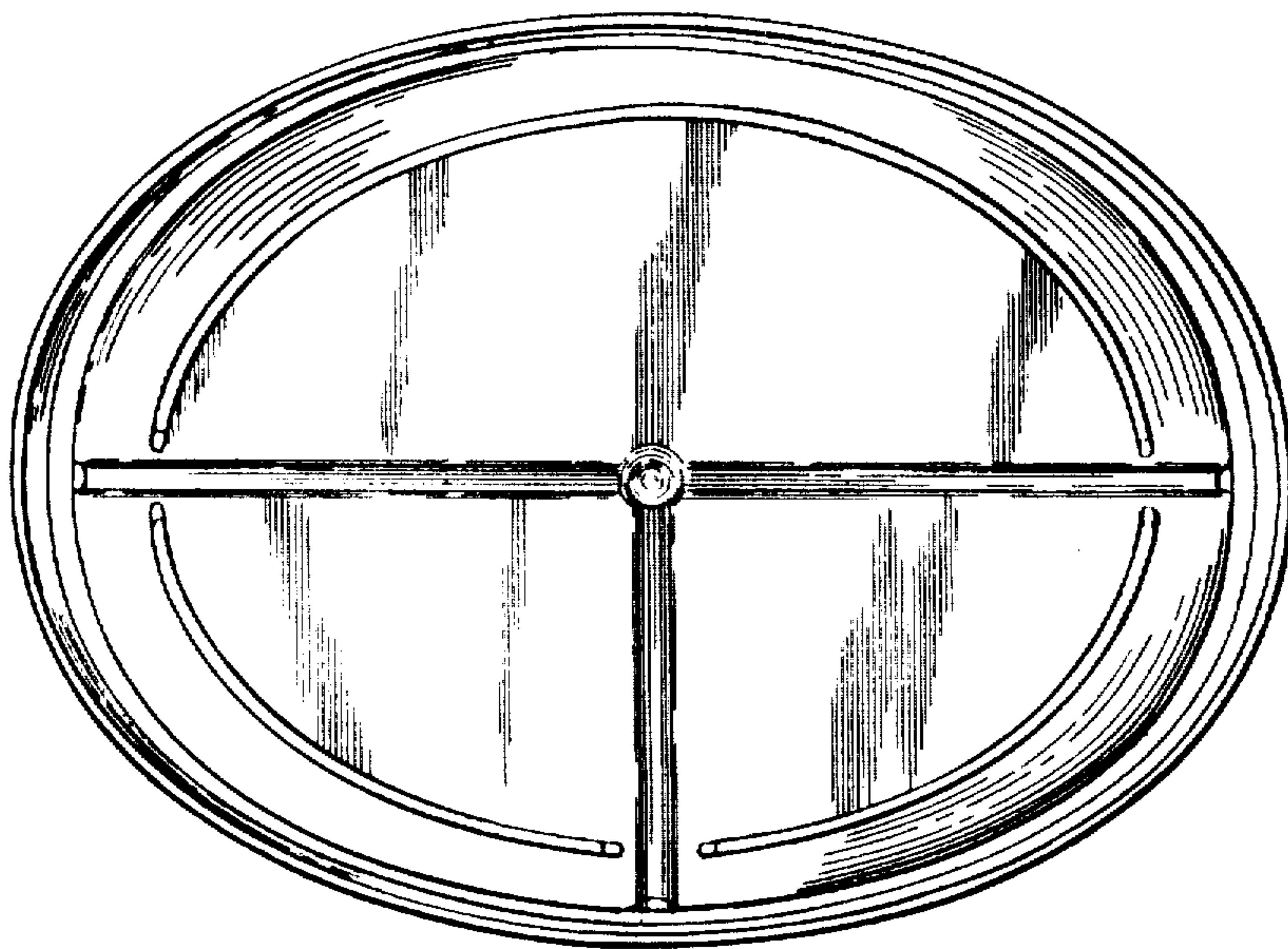

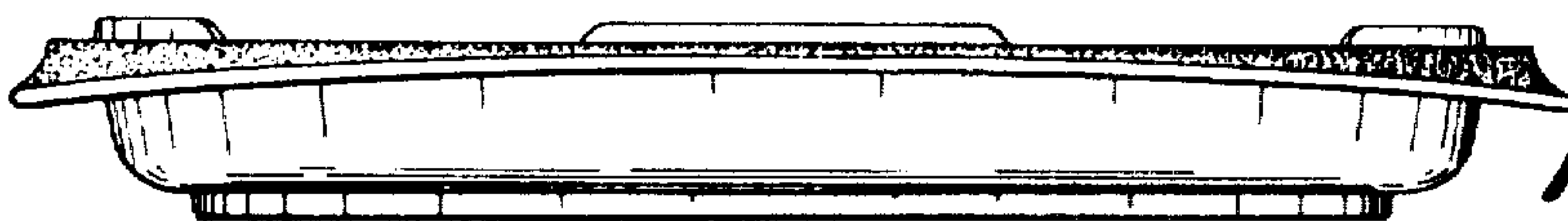
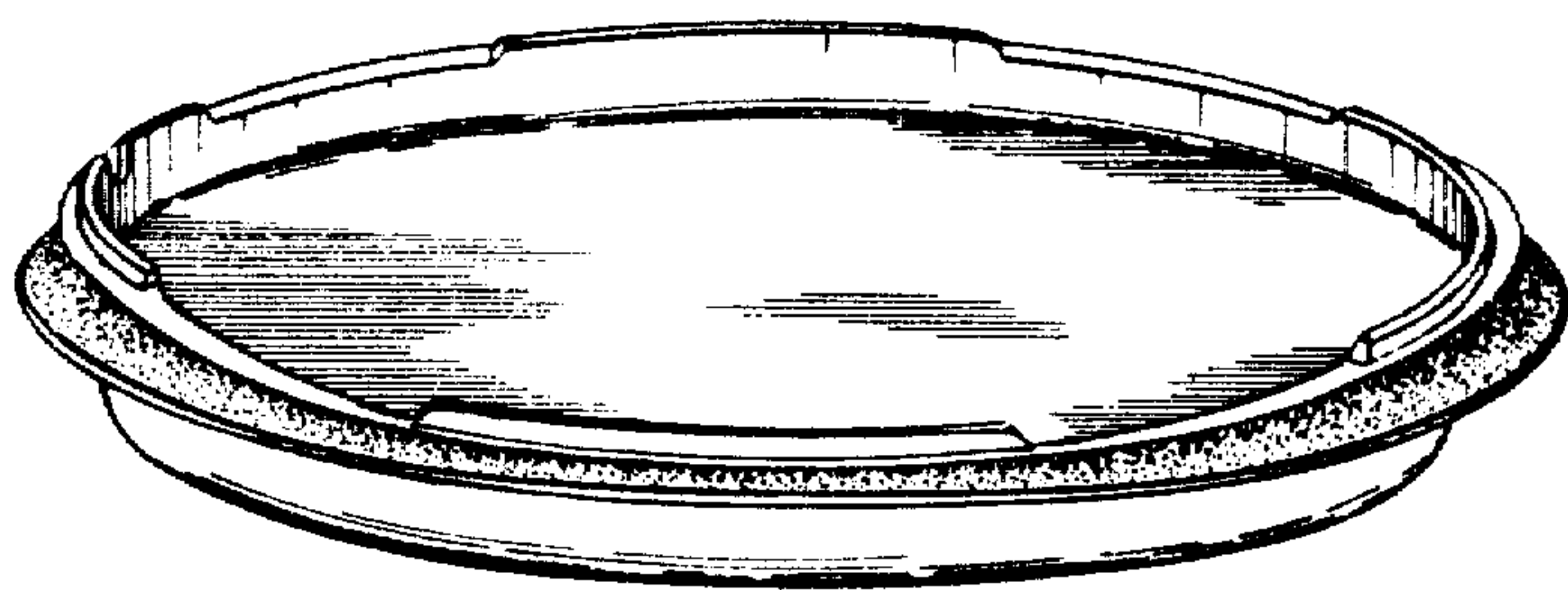

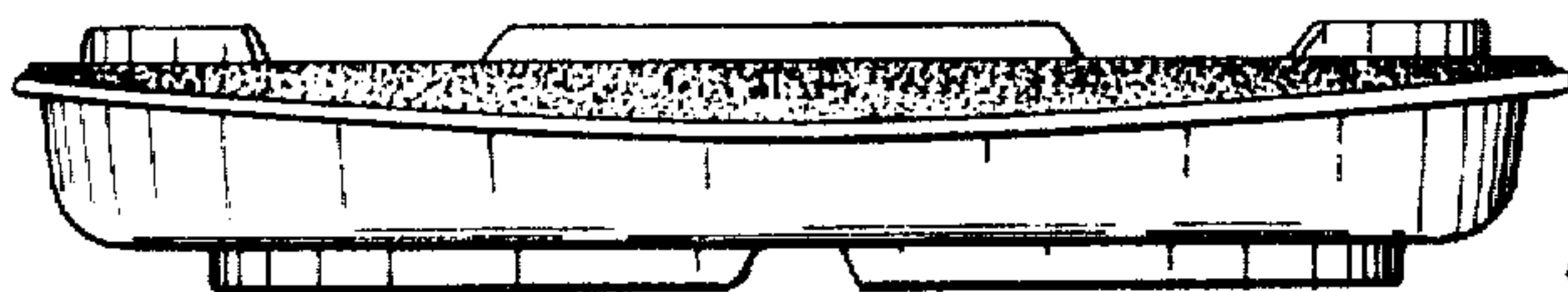
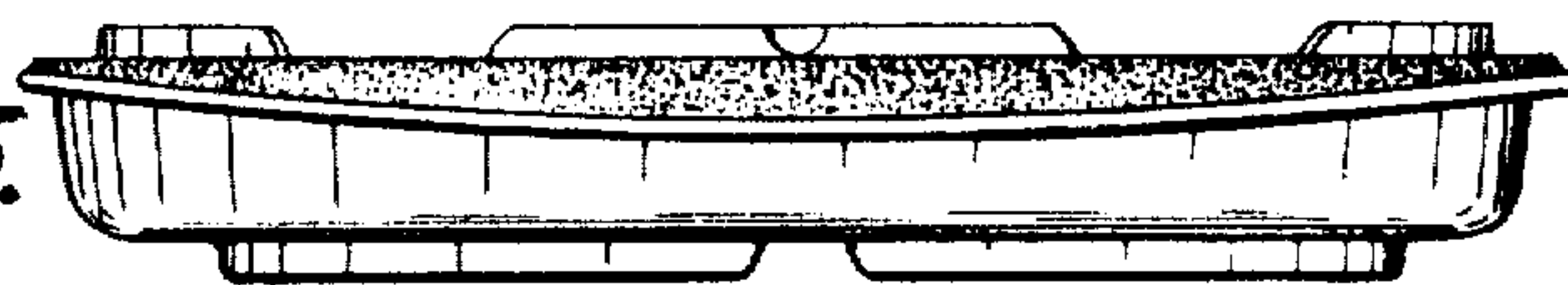

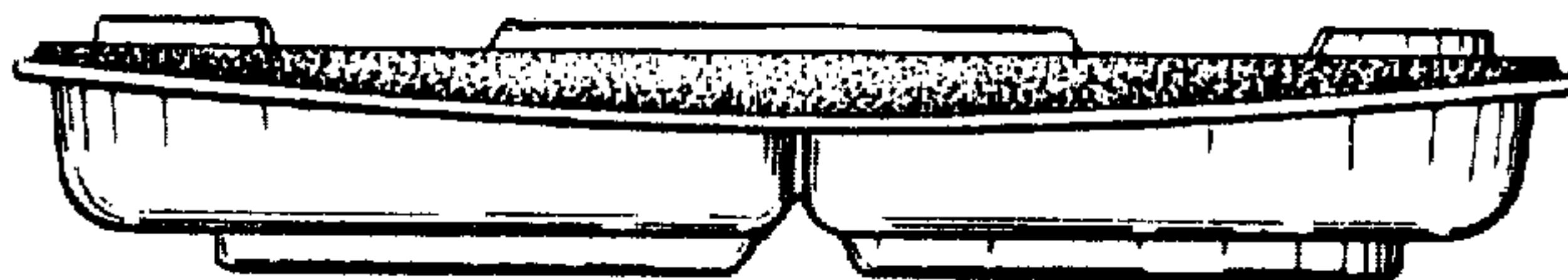

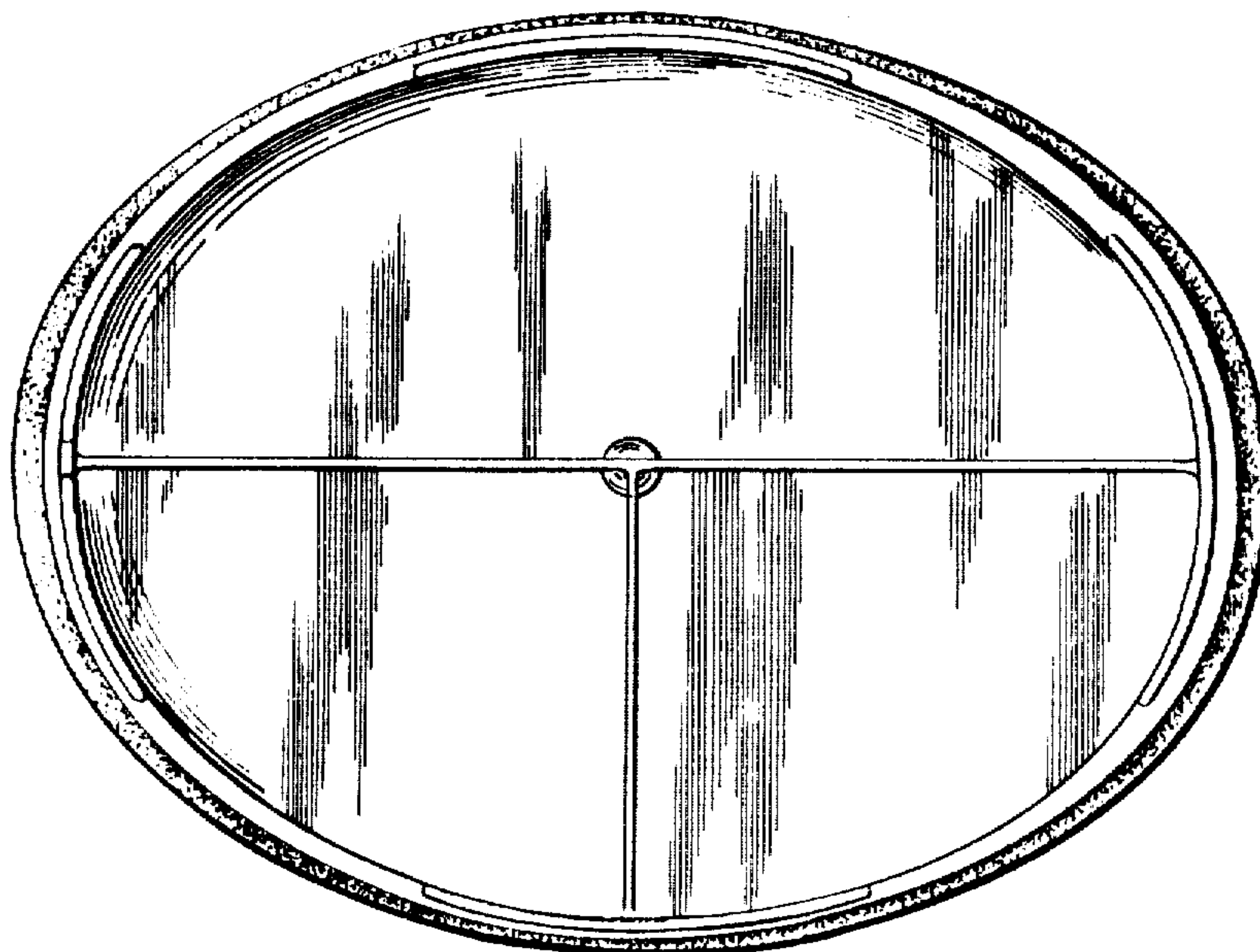

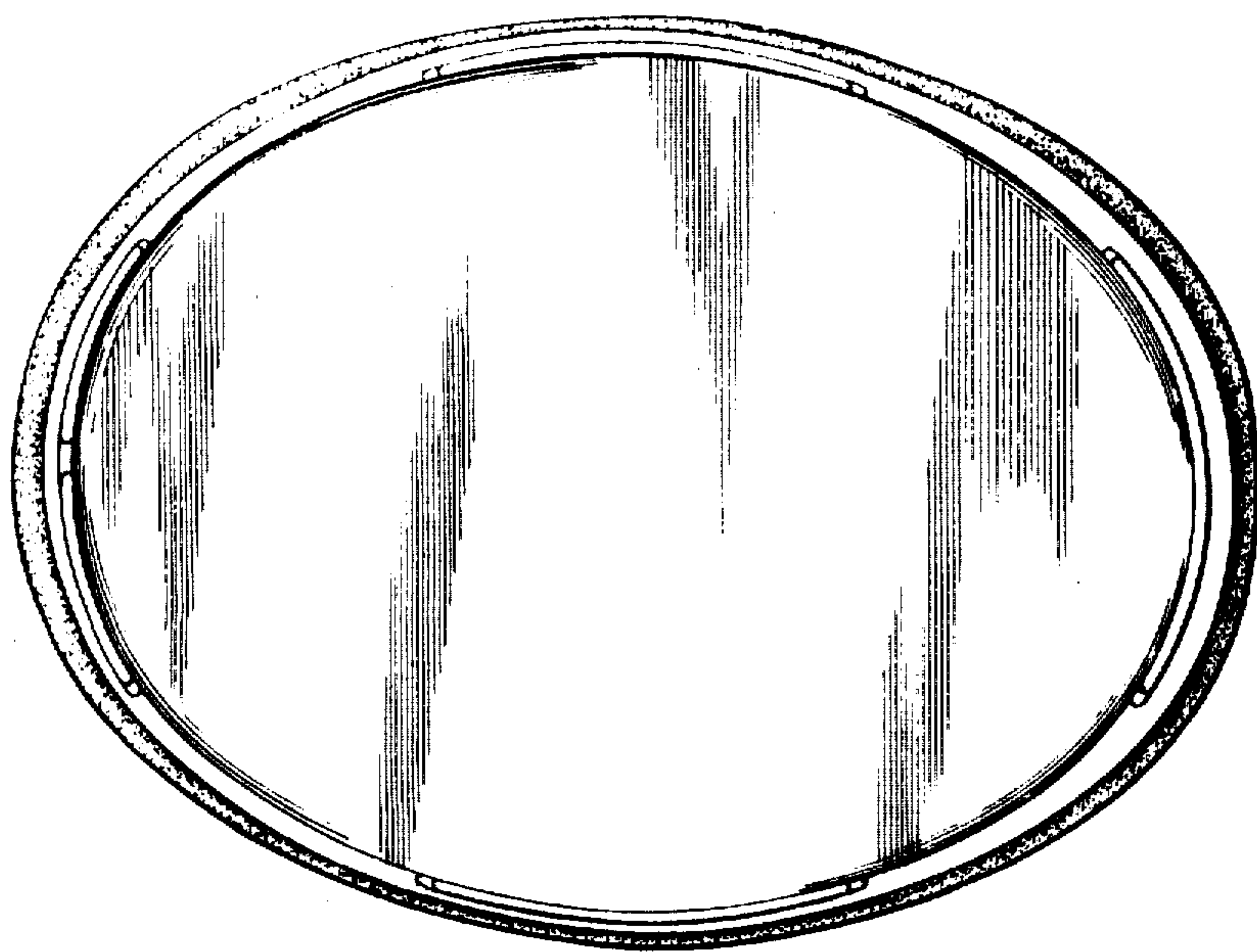

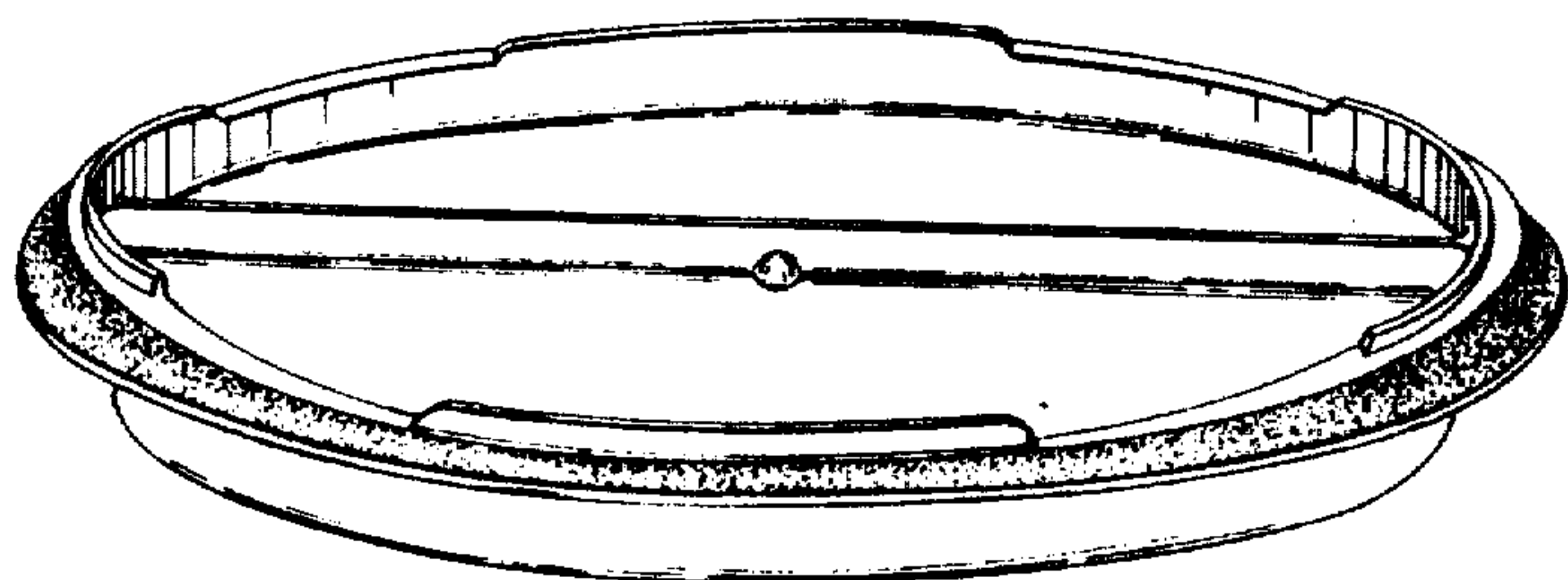
