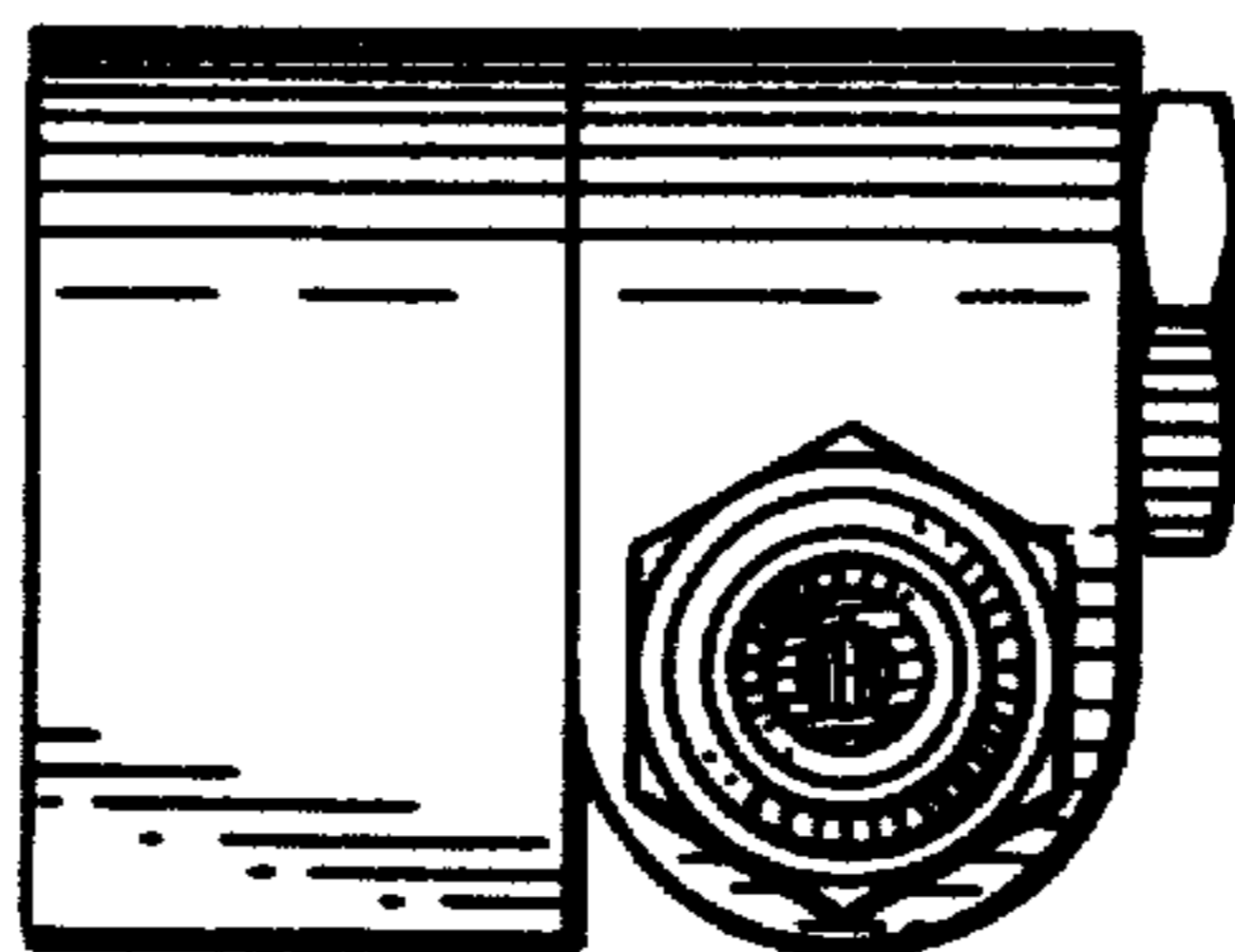

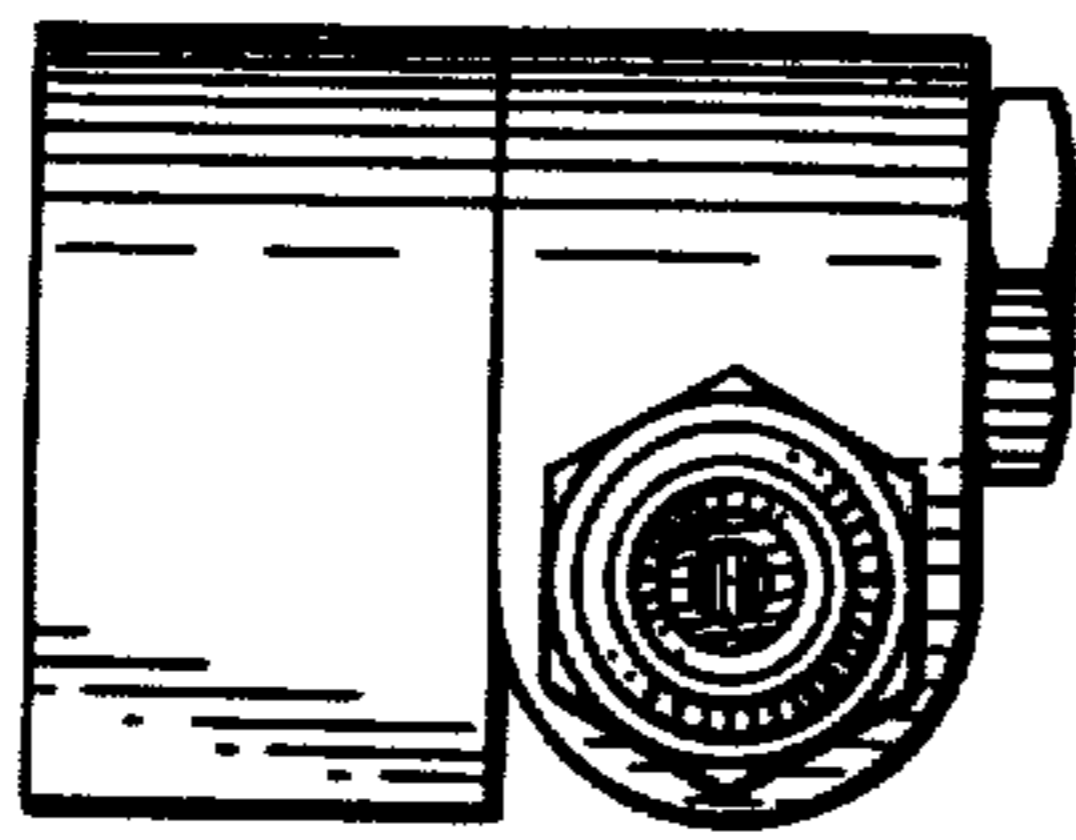
The ornamental design for a universal pneumatic swivel, as shown.

DESCRIPTION

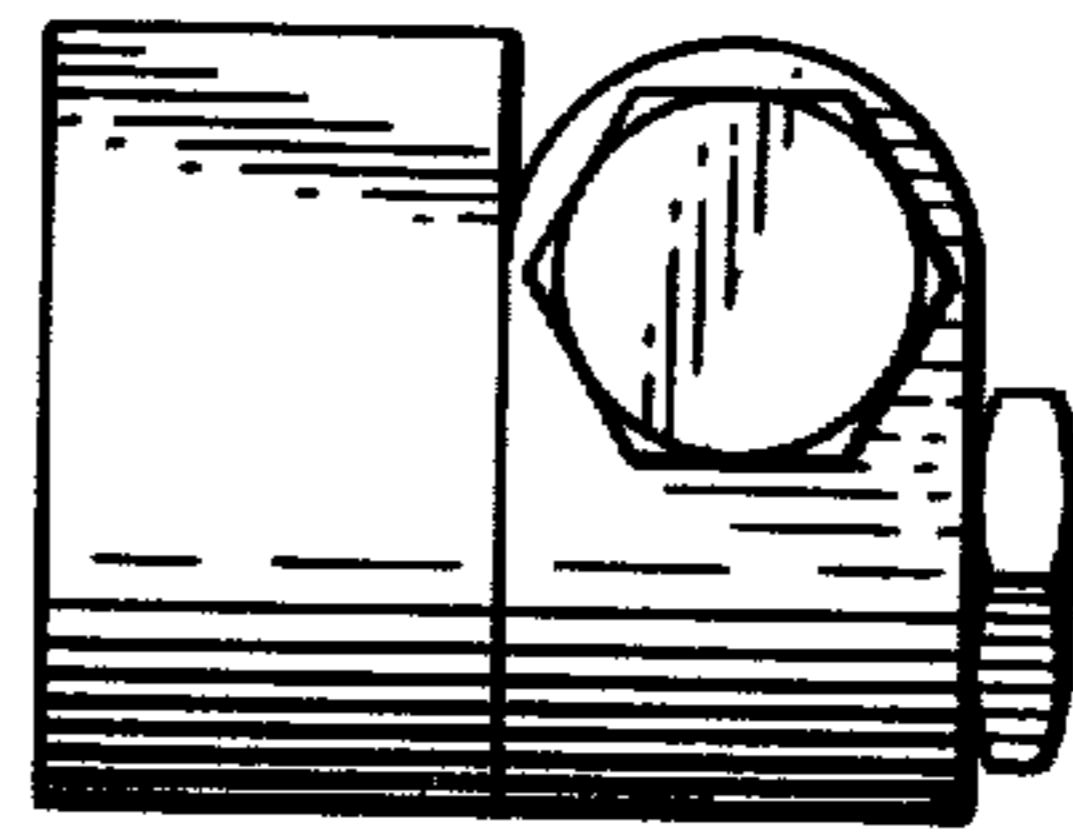
FIG. 1 is a front elevational view of a universal pneumatic swivel, showing my new design;

 FIG. 6 is an opposite side elevational view thereof.



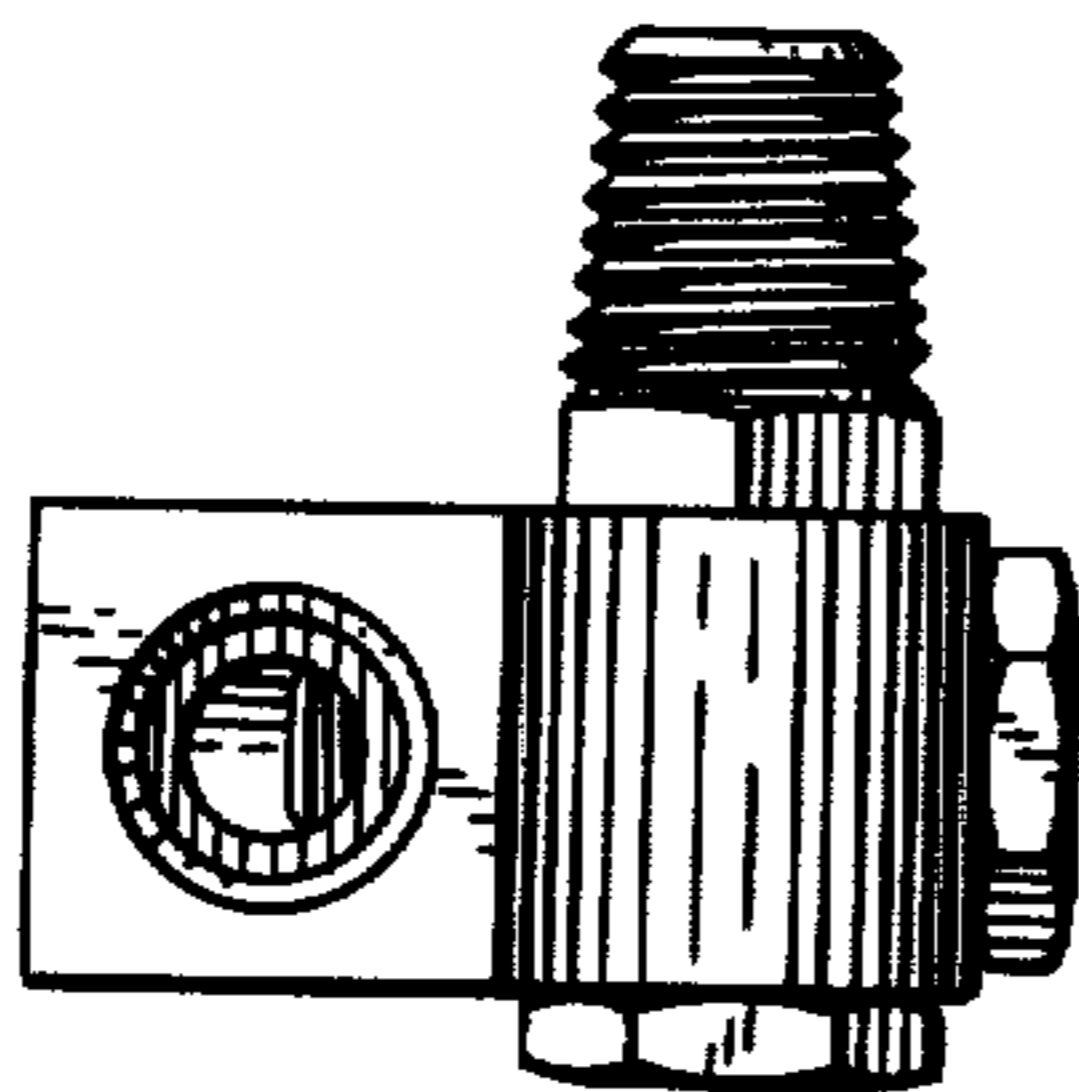

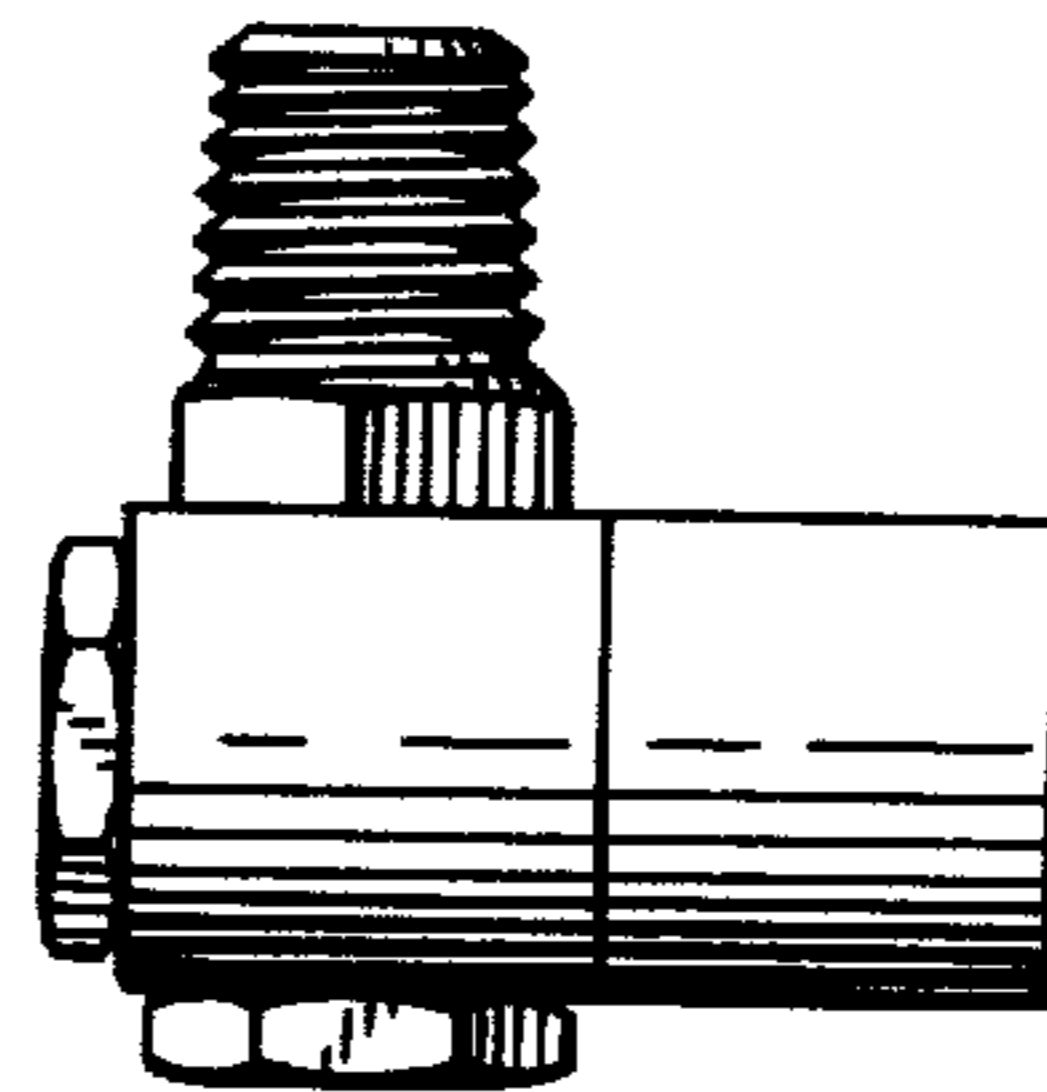

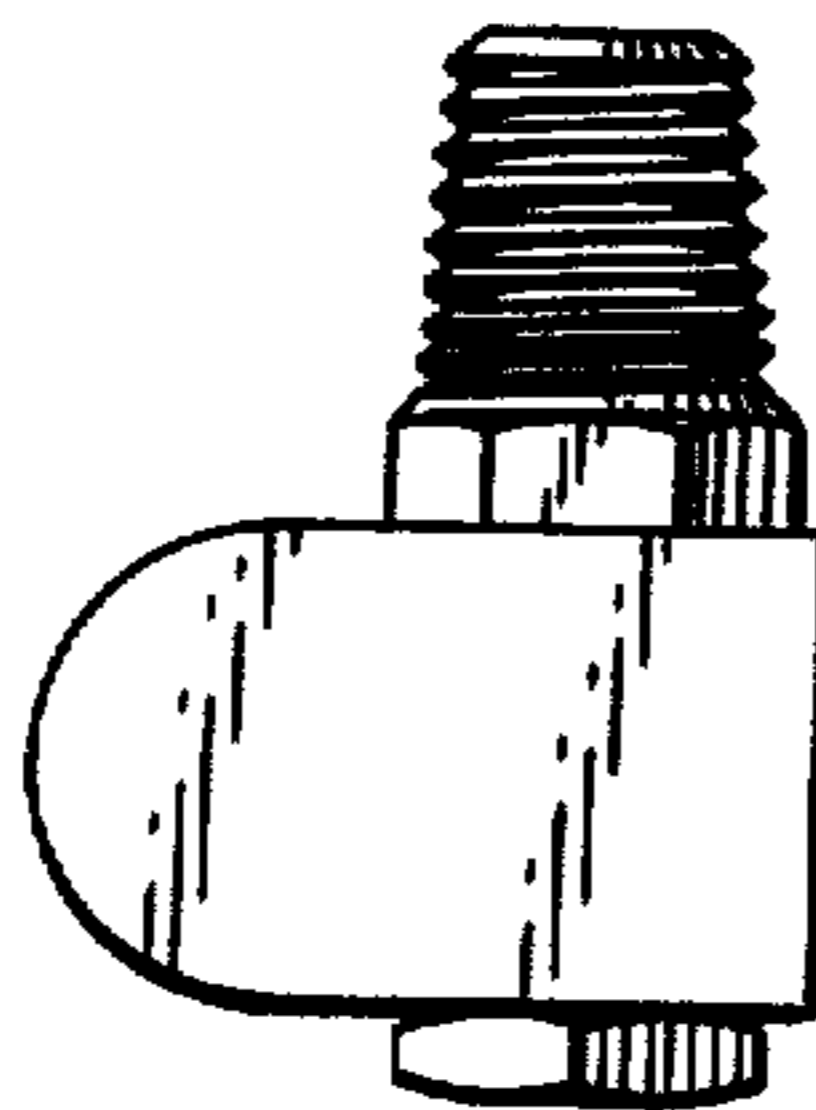
