[57] **CLAIM**

The ornamental design for a packaging container, as shown and described.

FIG. 1 is a front perspective view of a packaging container showing our new design;
FIG. 2 is a front elevational view;
FIG. 3 is an elevational view looking from the right of FIG. 2, the opposite side being a mirror image thereof;
FIG. 4 is a top plan view;
FIG. 5 is a bottom plan view;
FIG. 6 is a front elevational view with the lid removed;
FIG. 7 is an elevational view looking from the right of FIG. 6 with a portion of the container body broken away to illustrate, in cross section, ribs integral with the rear wall of the container;
FIG. 8 is a rear elevational view;
FIG. 9 is a bottom plan view with the lid removed;
FIG. 10 is a top plan view with the lid removed from the container;
FIG. 11 is a front elevational view of the lid removed from the container;
FIG. 12 is a rear elevational view of the lid shown in FIG. 11;
FIG. 13 is a cross sectional view taken along the line 13-13 of FIG. 12;
FIG. 14 is a top plan view looking in the direction of the arrows 14-14 of FIG. 11;
FIG. 15 is a bottom view looking in the direction of the arrows 15-15 of FIG. 11;
FIG. 16 is a front elevational view of another embodiment of my design with the lid removed differing from the first embodiment only in the arrangement of the internal ribs shown;
FIG. 17 is an elevational view looking from the right of FIG. 16 with a portion of the container broken away to illustrate in section internal wall arrangements, the opposite side being a mirror image thereof; and
FIG. 18 is a sectional view taken along 18-18 of FIG. 16.

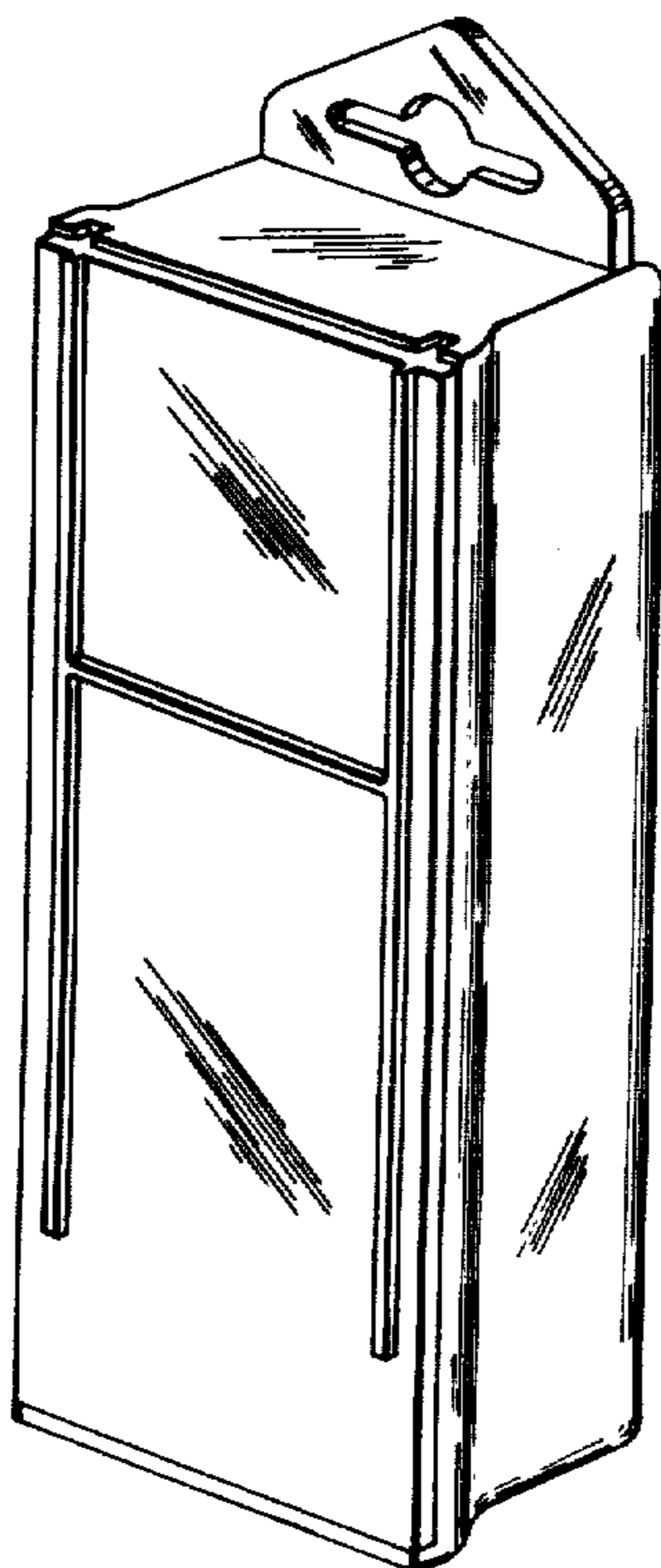

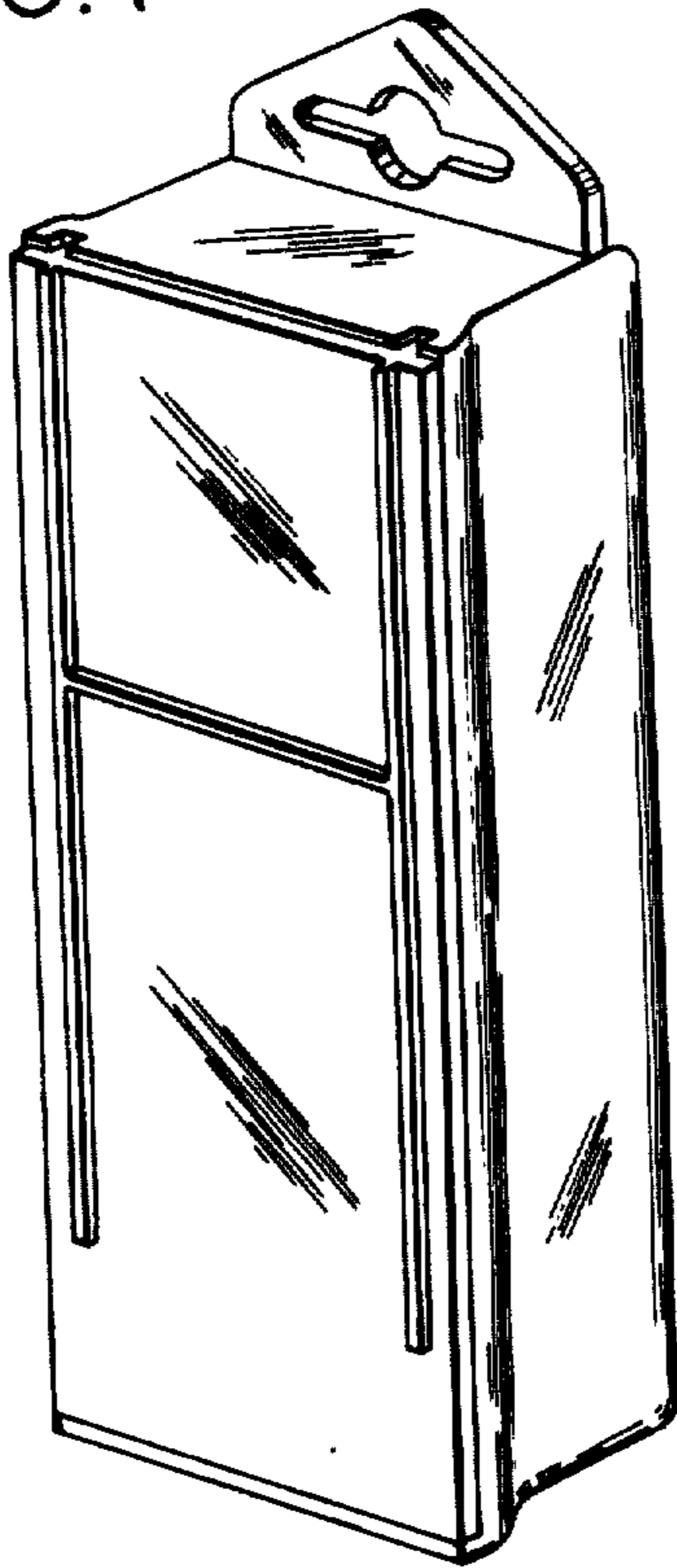

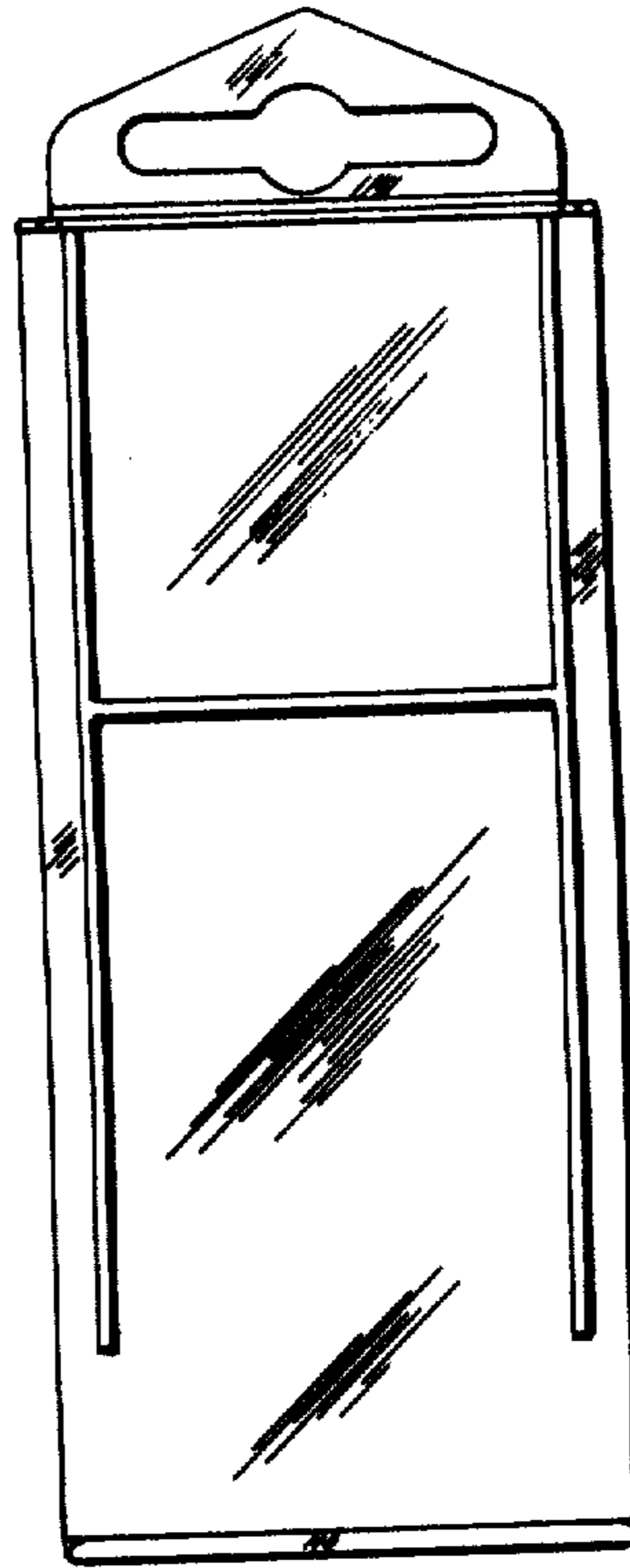

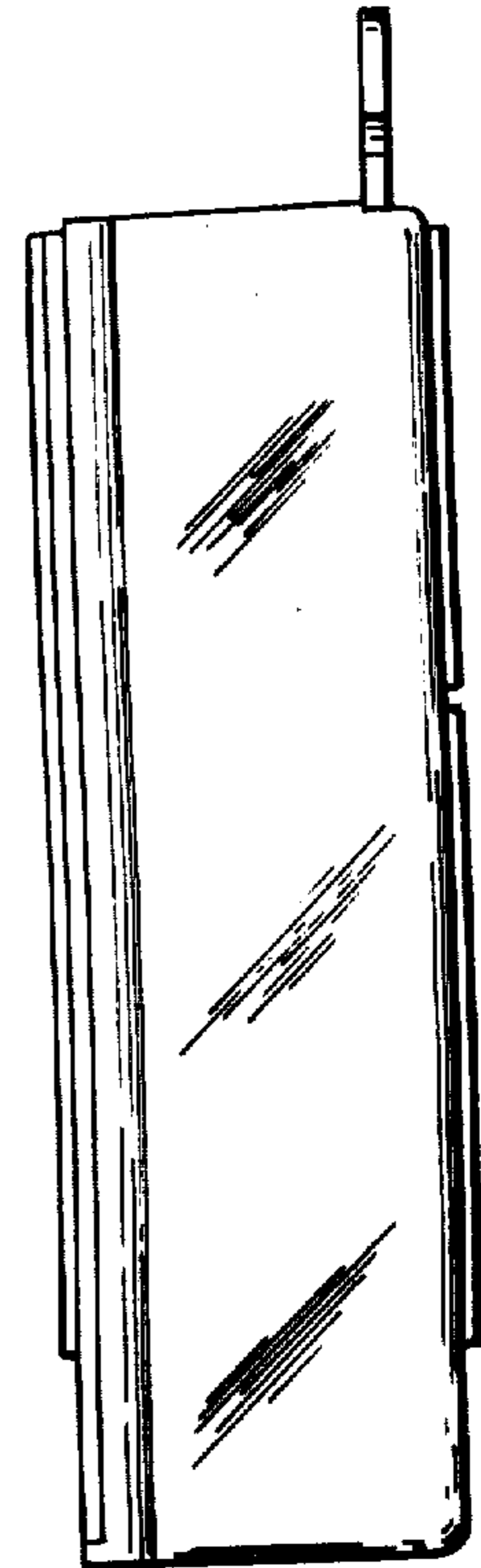

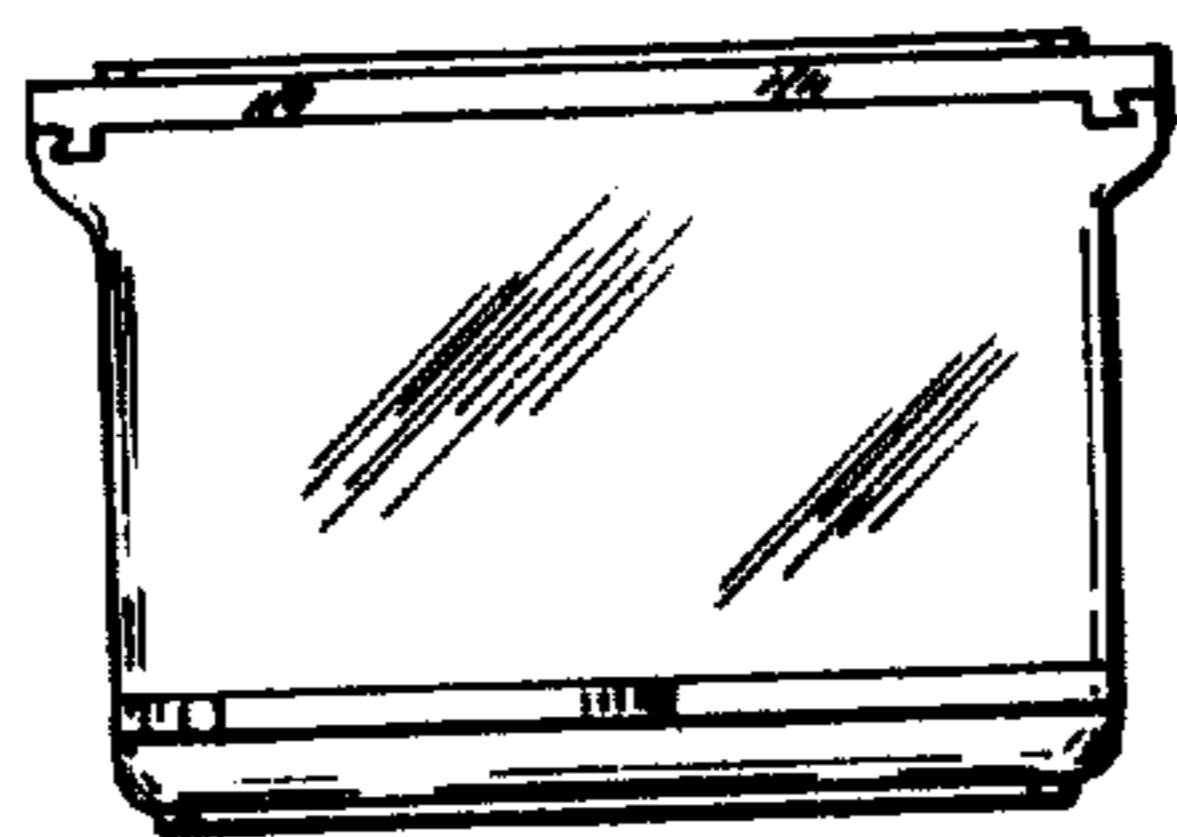

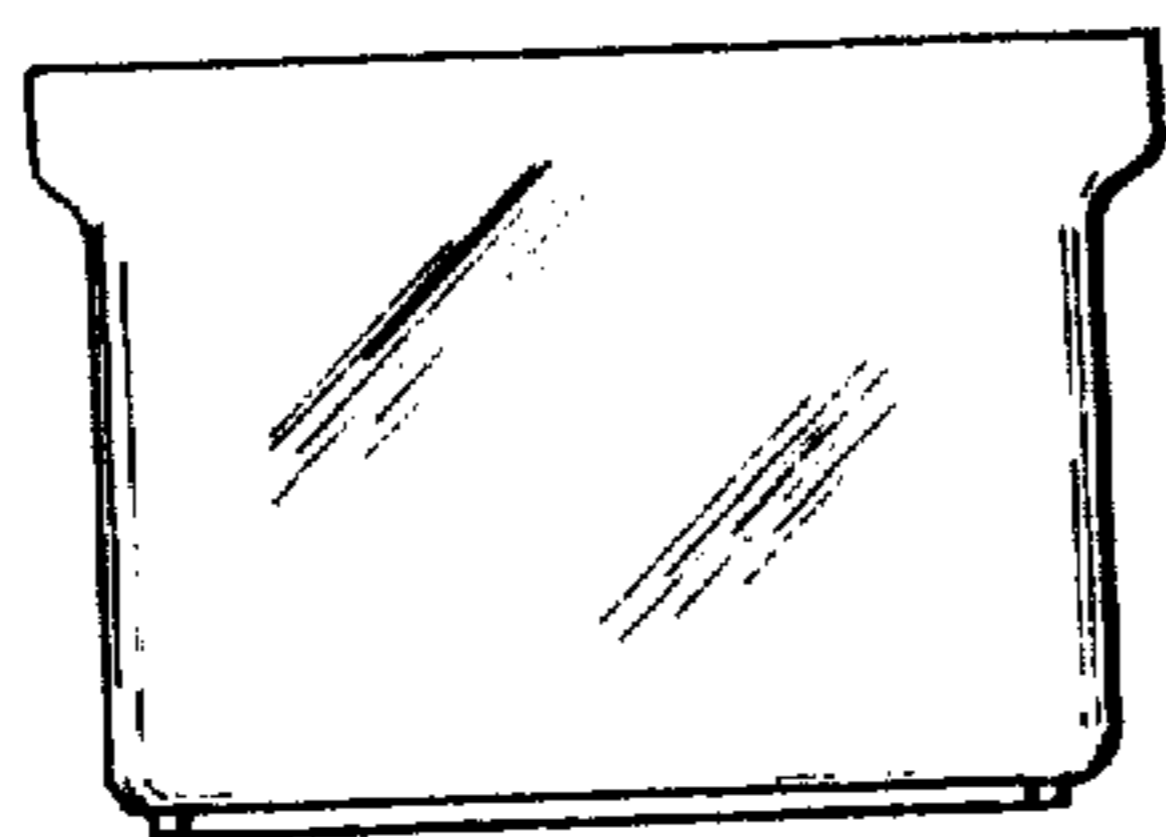

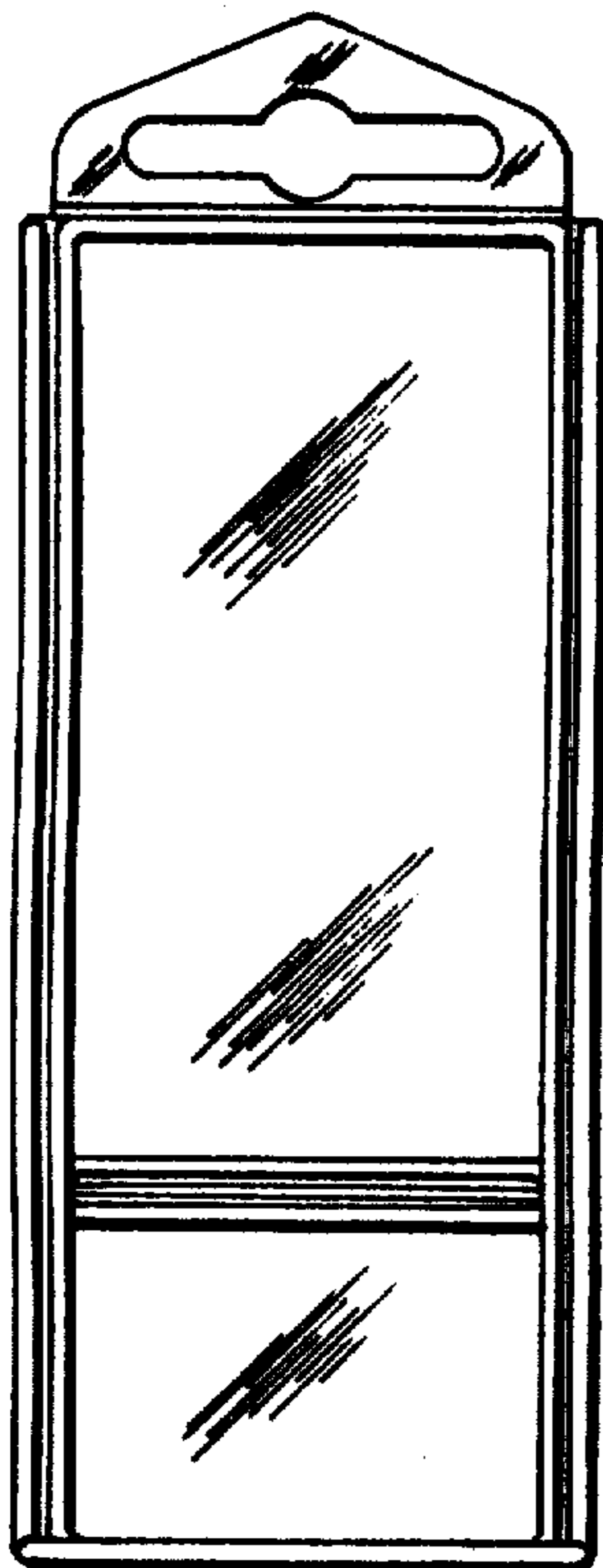

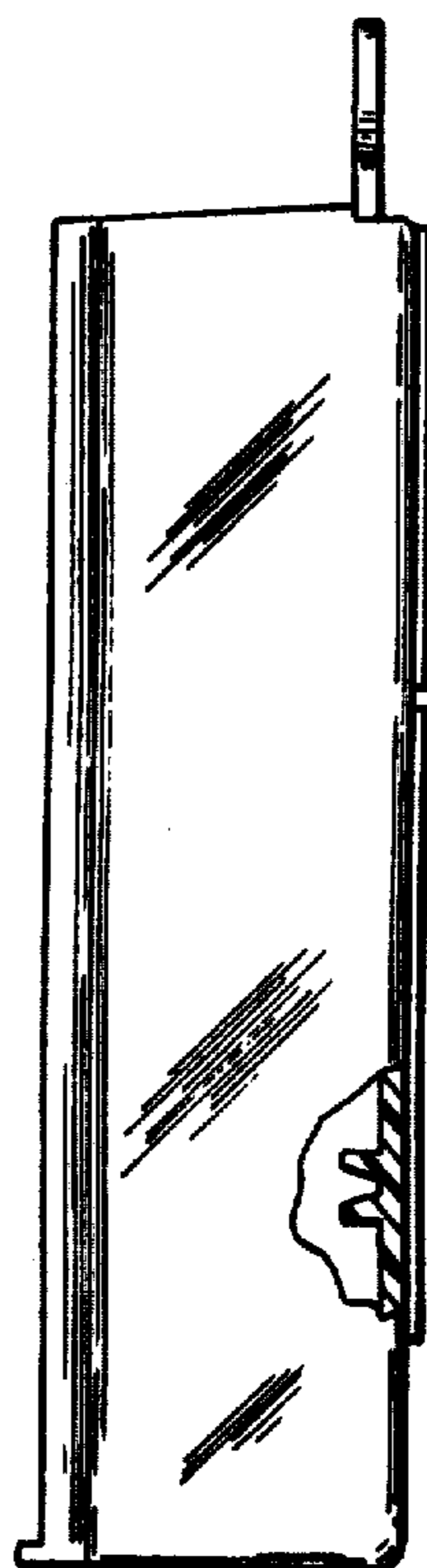

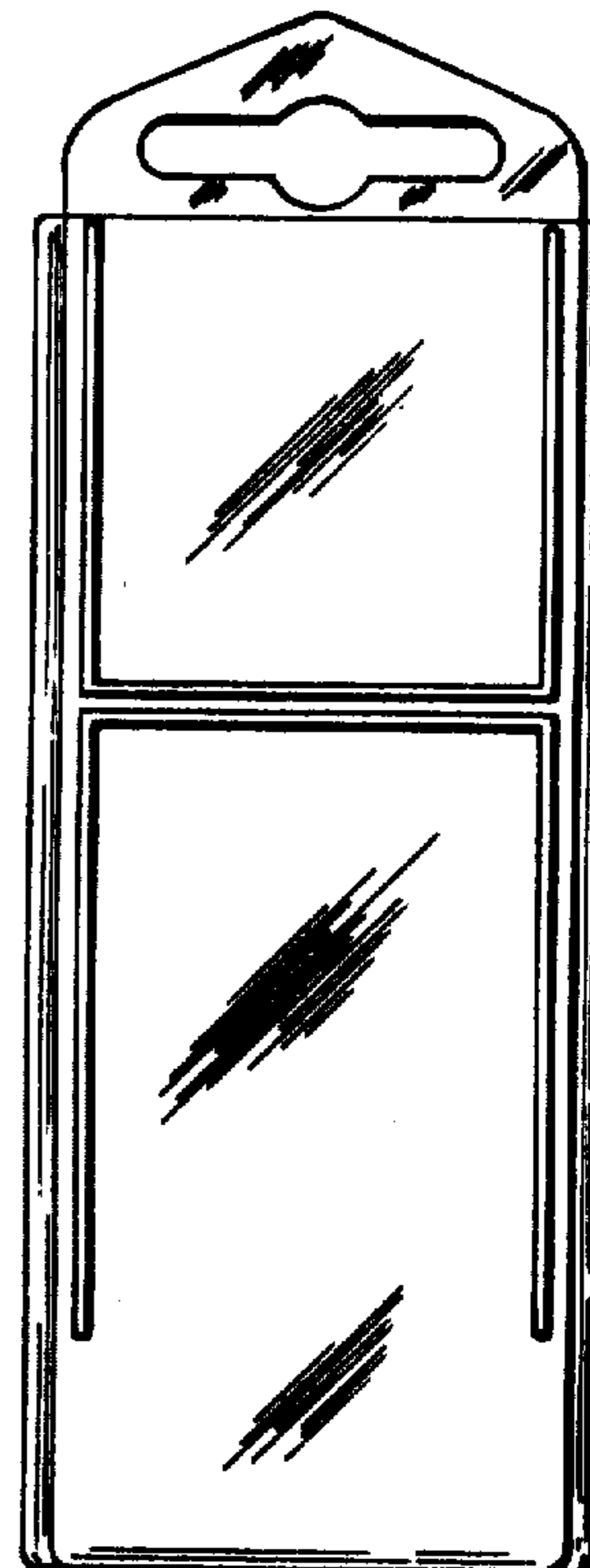

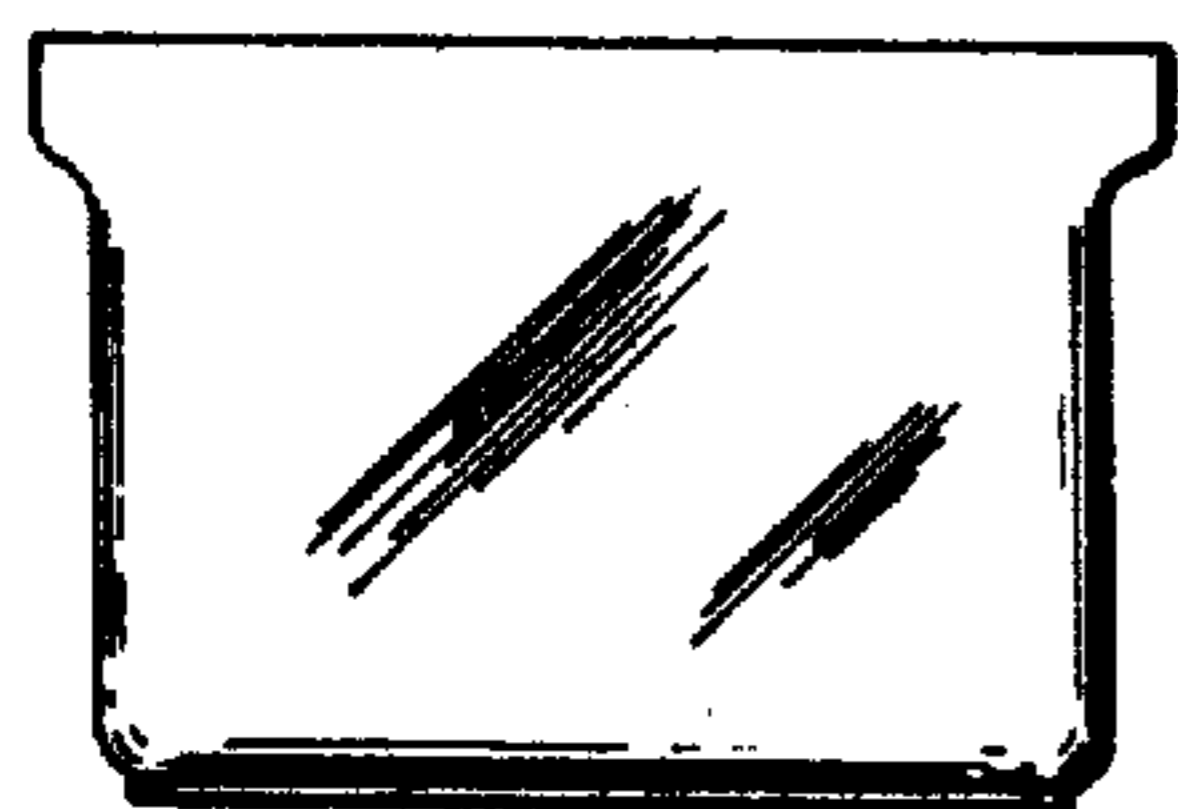

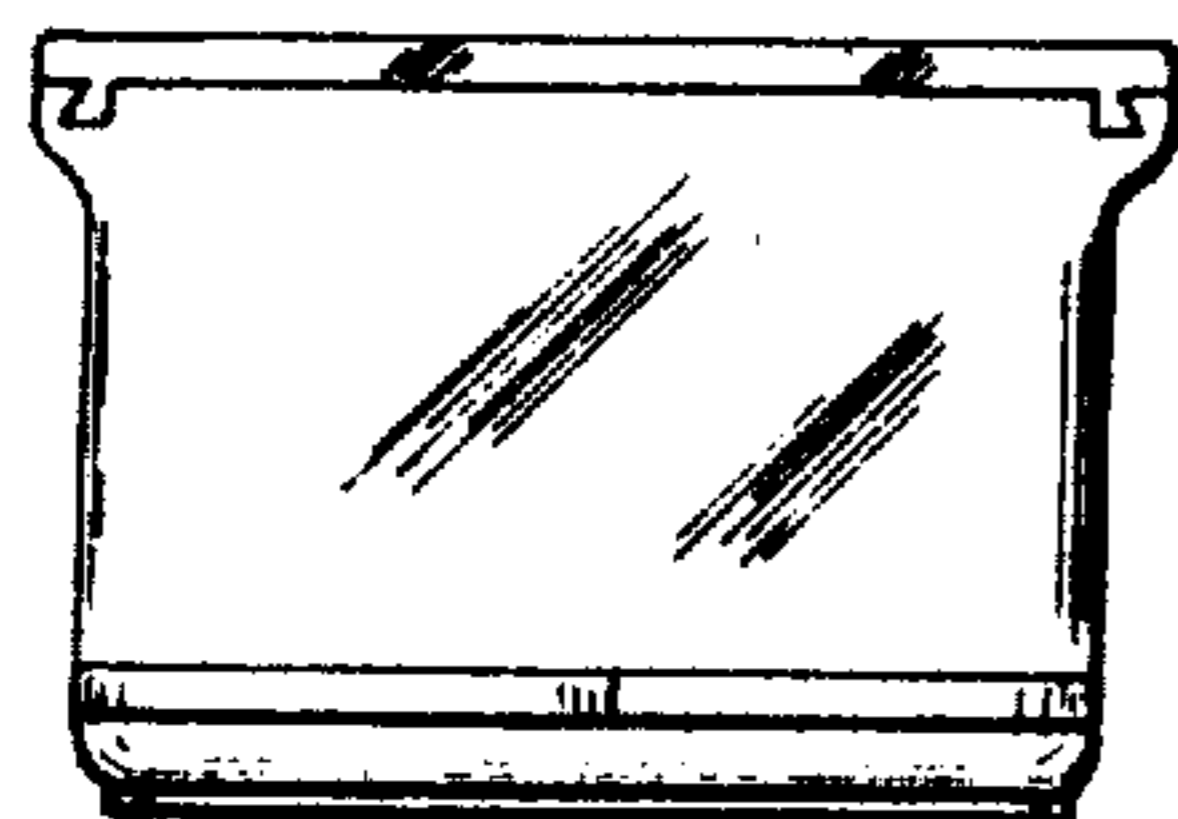

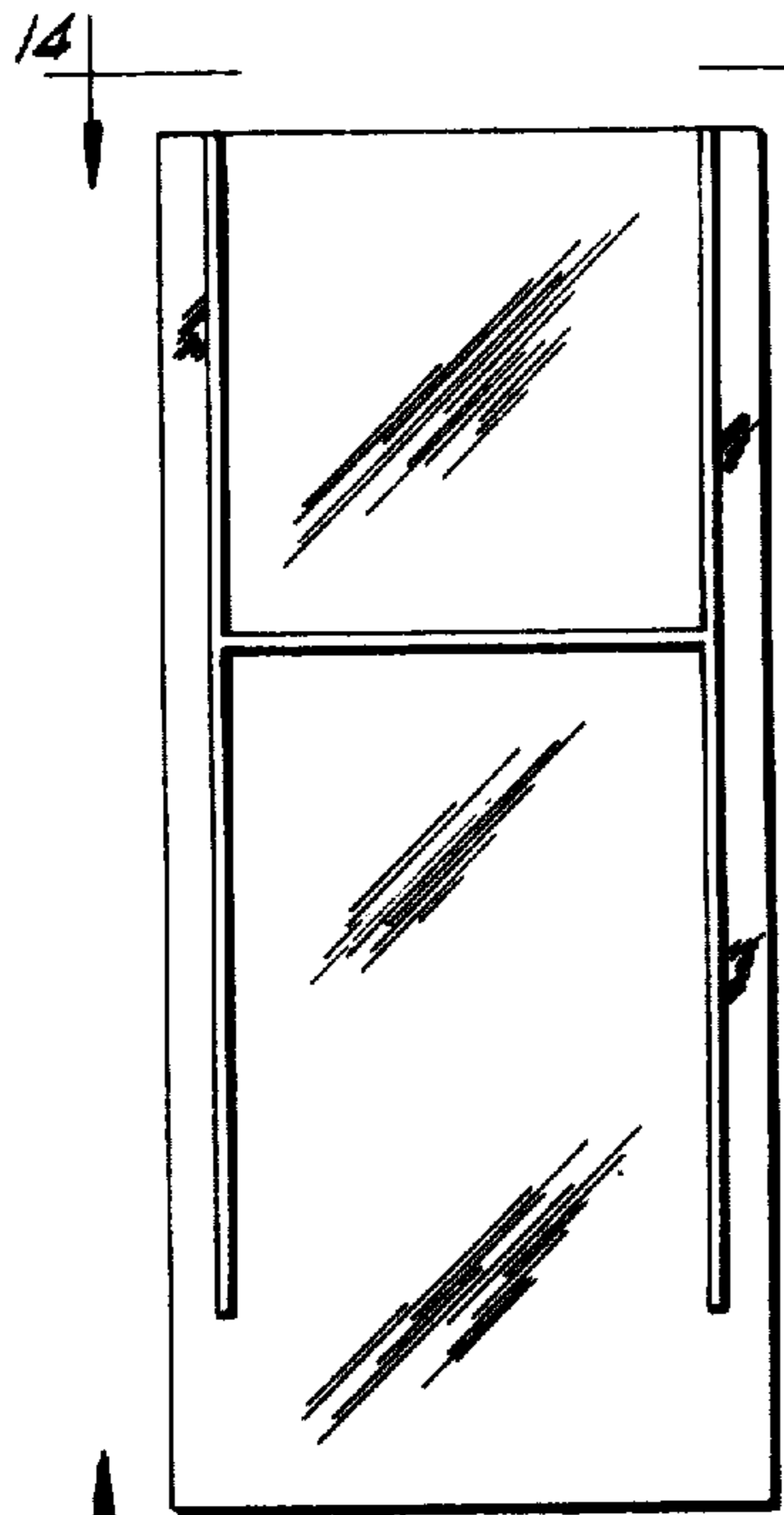

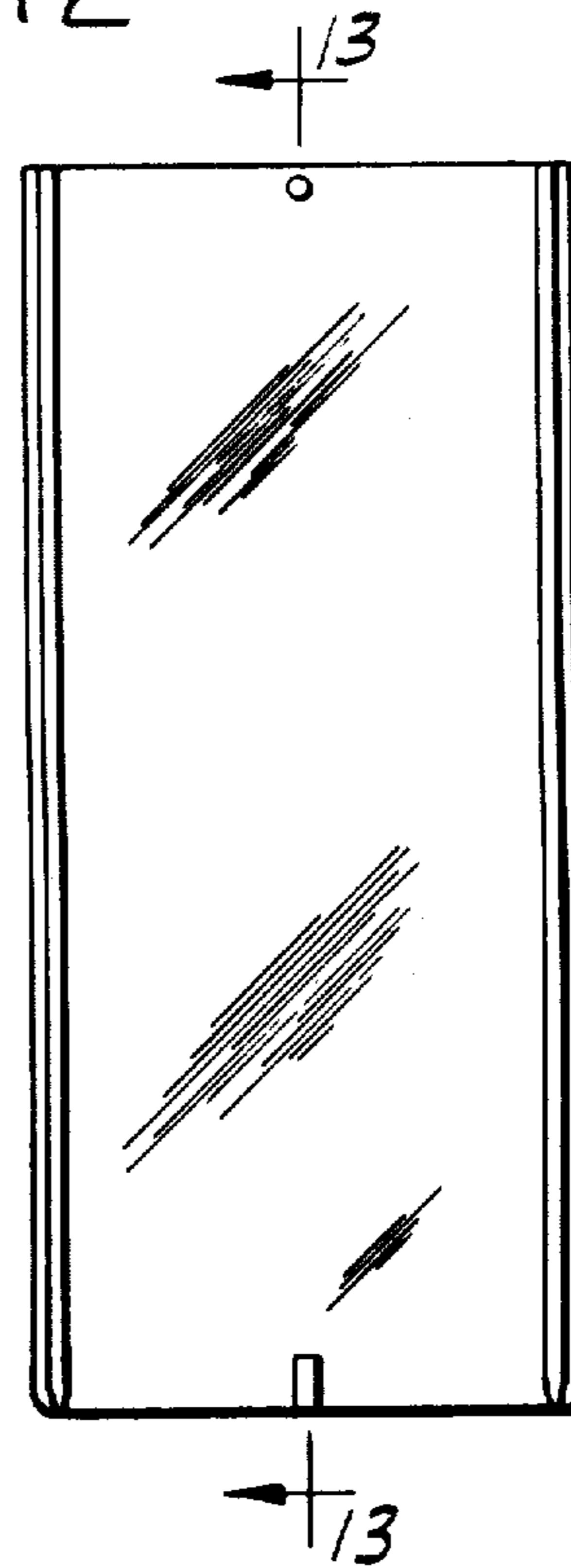

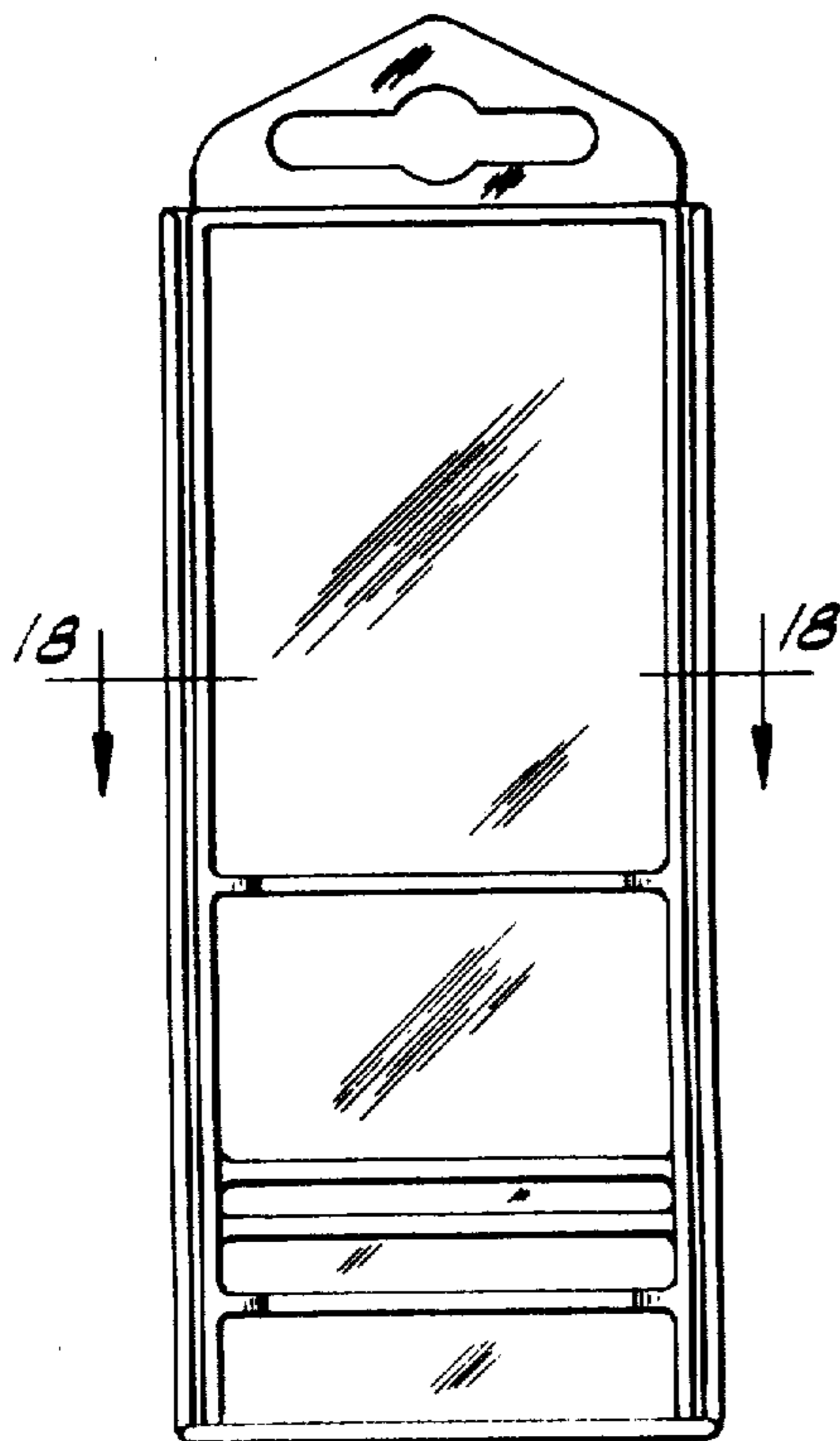
