The ornamental design for a chair, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from the front, top and one side of a chair embodying my design;

FIG. 2 is a perspective view from the rear, top and other side of the chair in FIG. 9;

FIG. 3 is a top plan view of the chair in FIG. 9;

FIG. 4 is a side elevational view of the chair in FIG. 9;

FIG. 5 is a perspective view from the front, top and one side of a second modification of a chair embodying my design;

FIG. 6 is a perspective view from the rear, top and other side of the chair in FIG. 13;

FIG. 7 is a top plan view of the chair in FIG. 13;

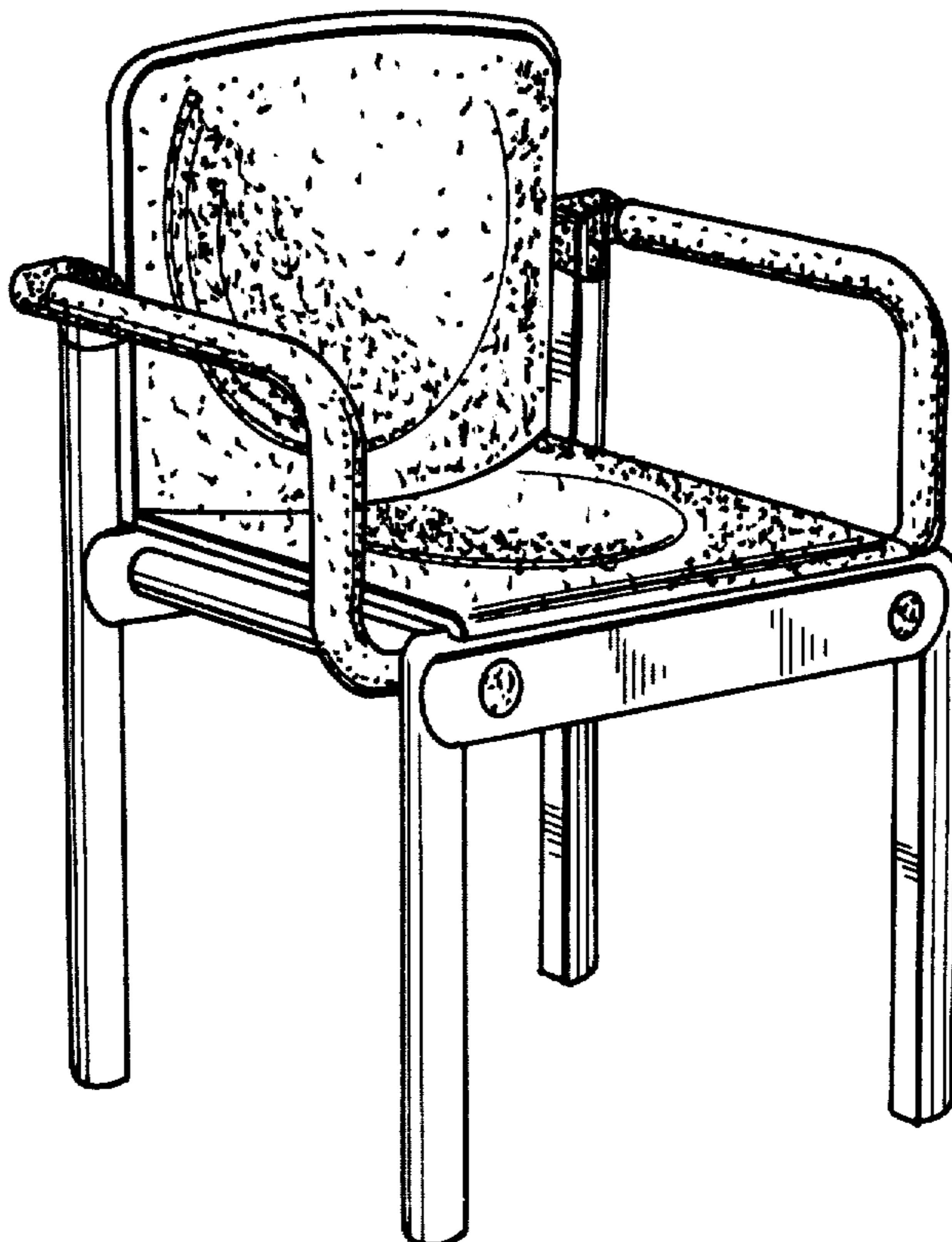
FIG. 8 is a side elevational view of the chair in FIG. 13;

FIG. 12 is a side elevational view of the chair in FIG. 17.



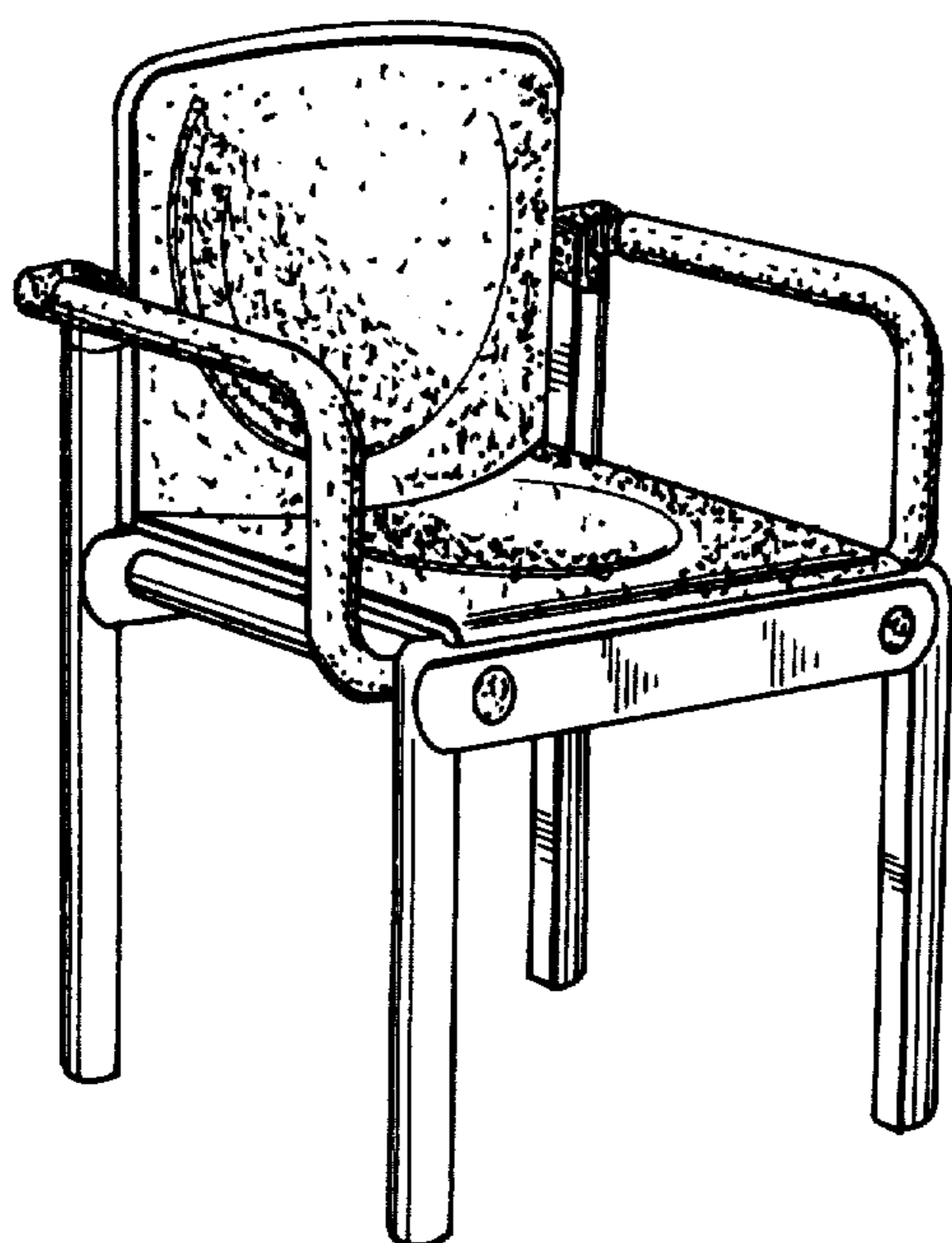

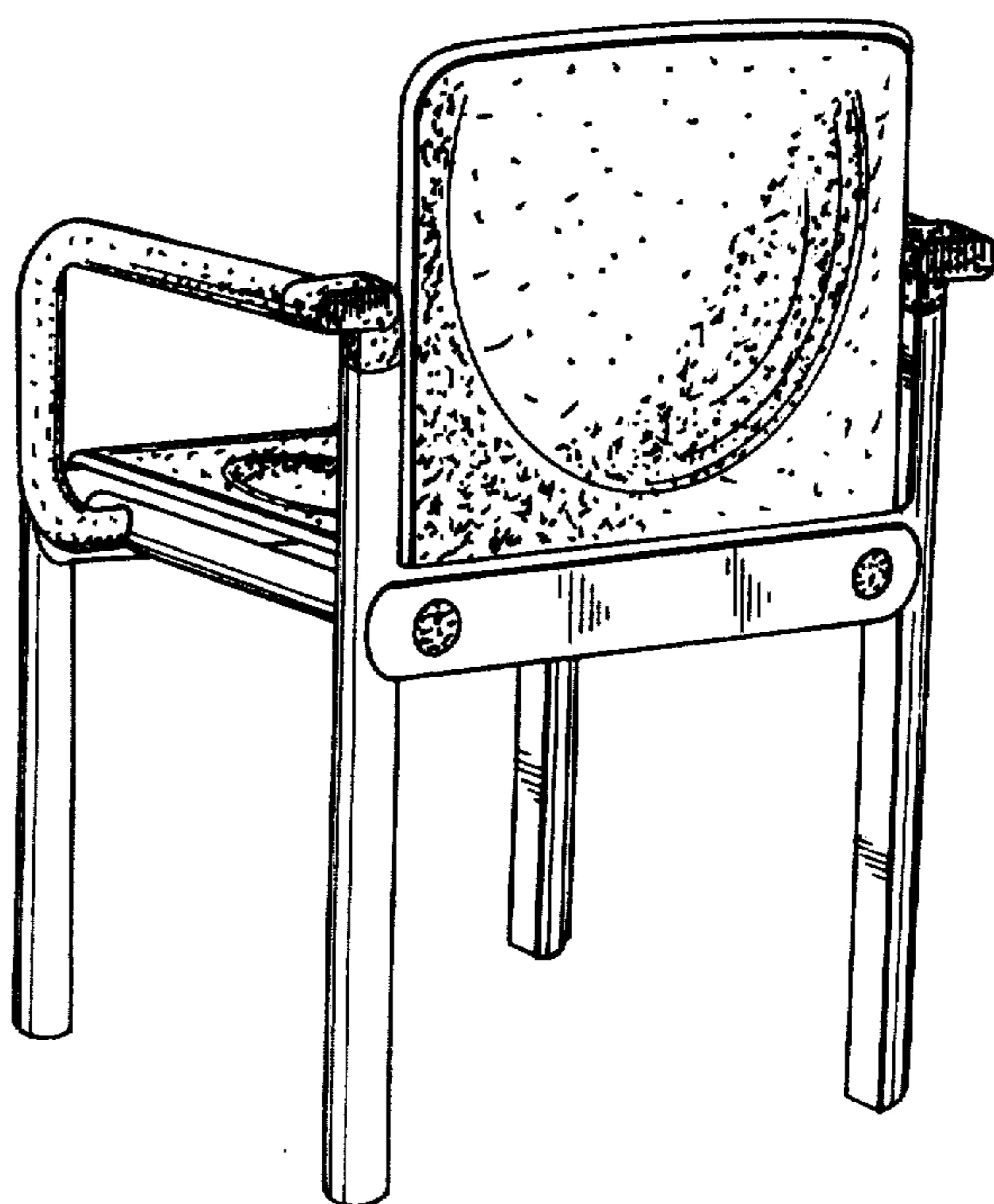

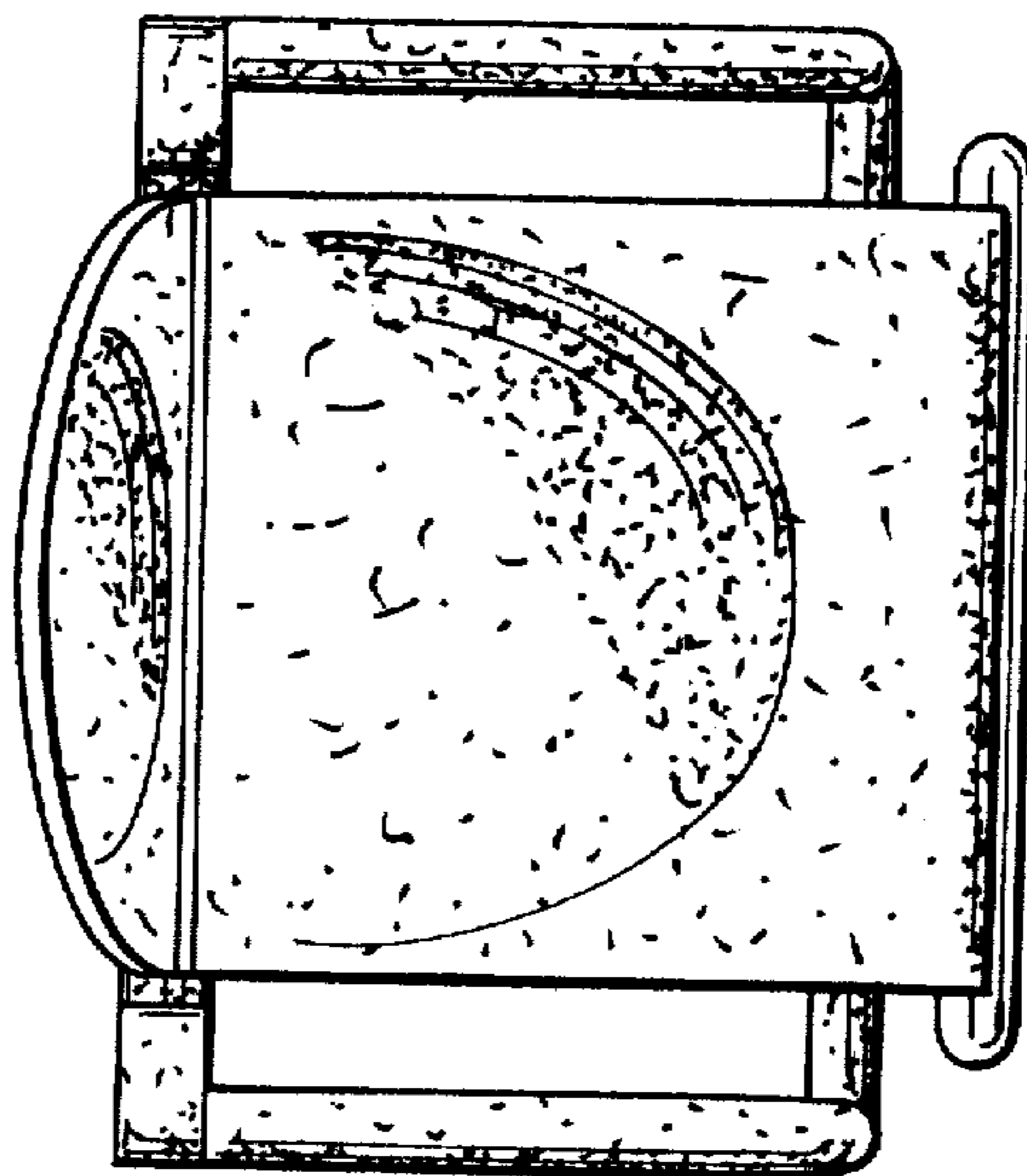
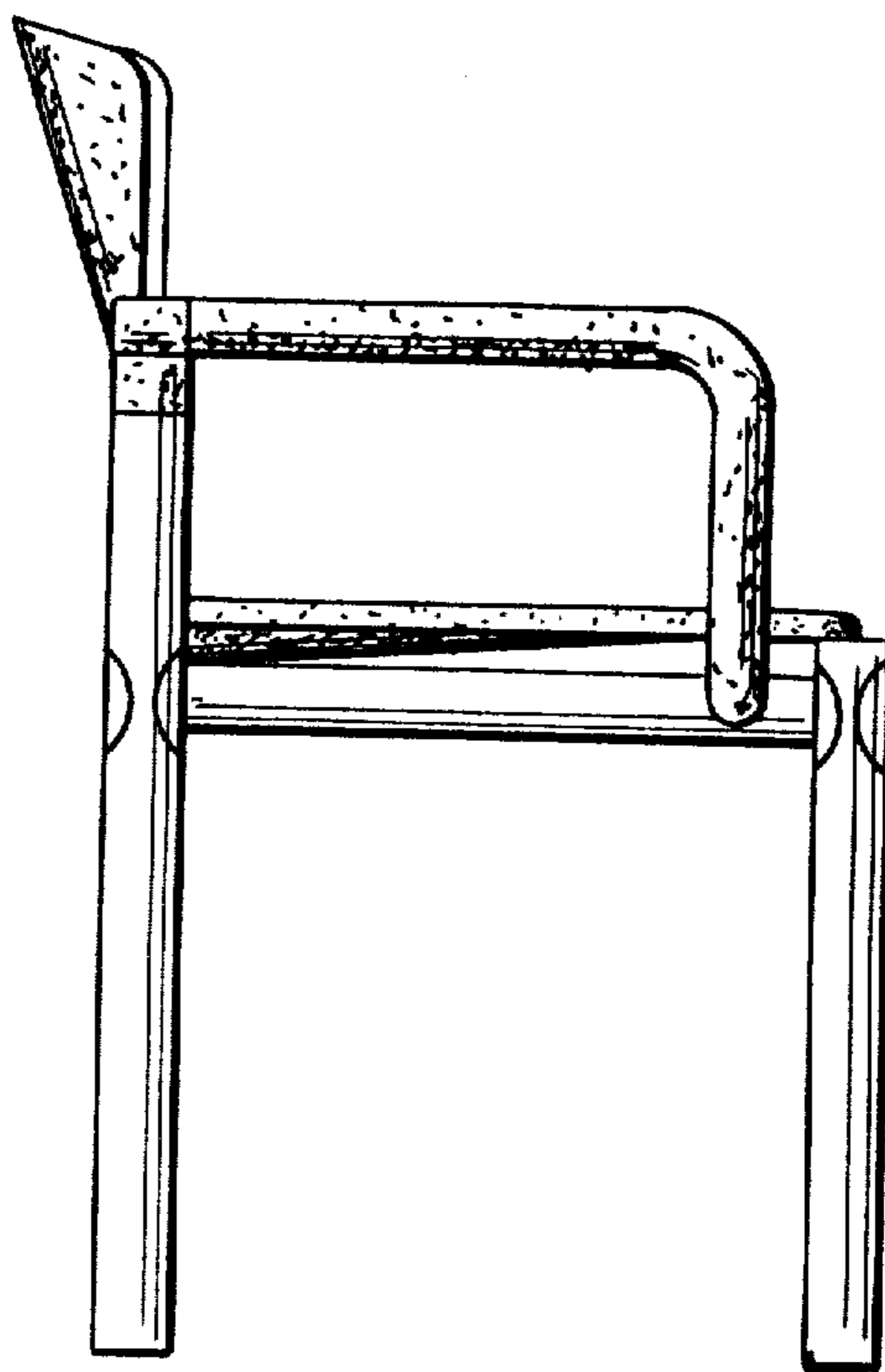

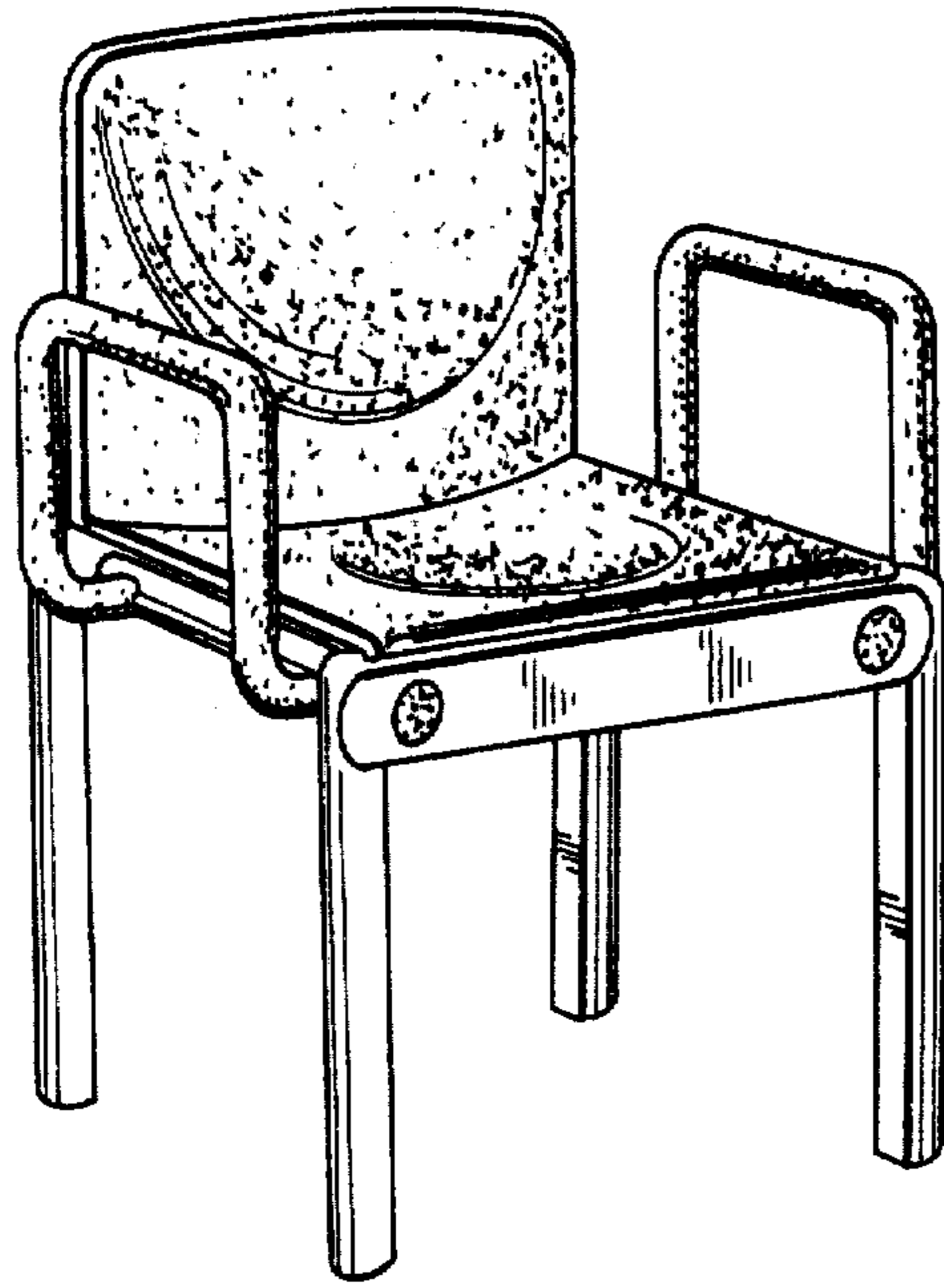

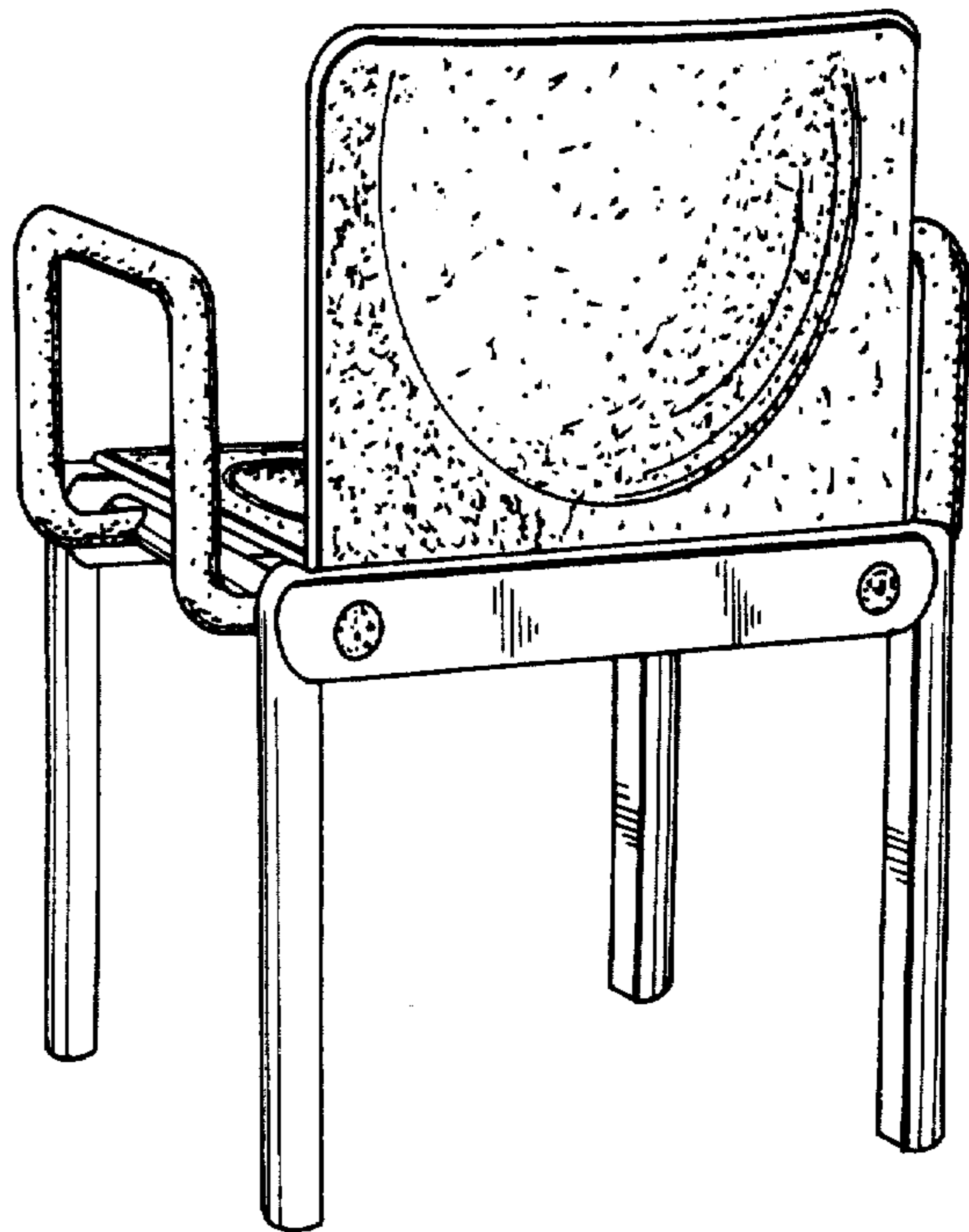

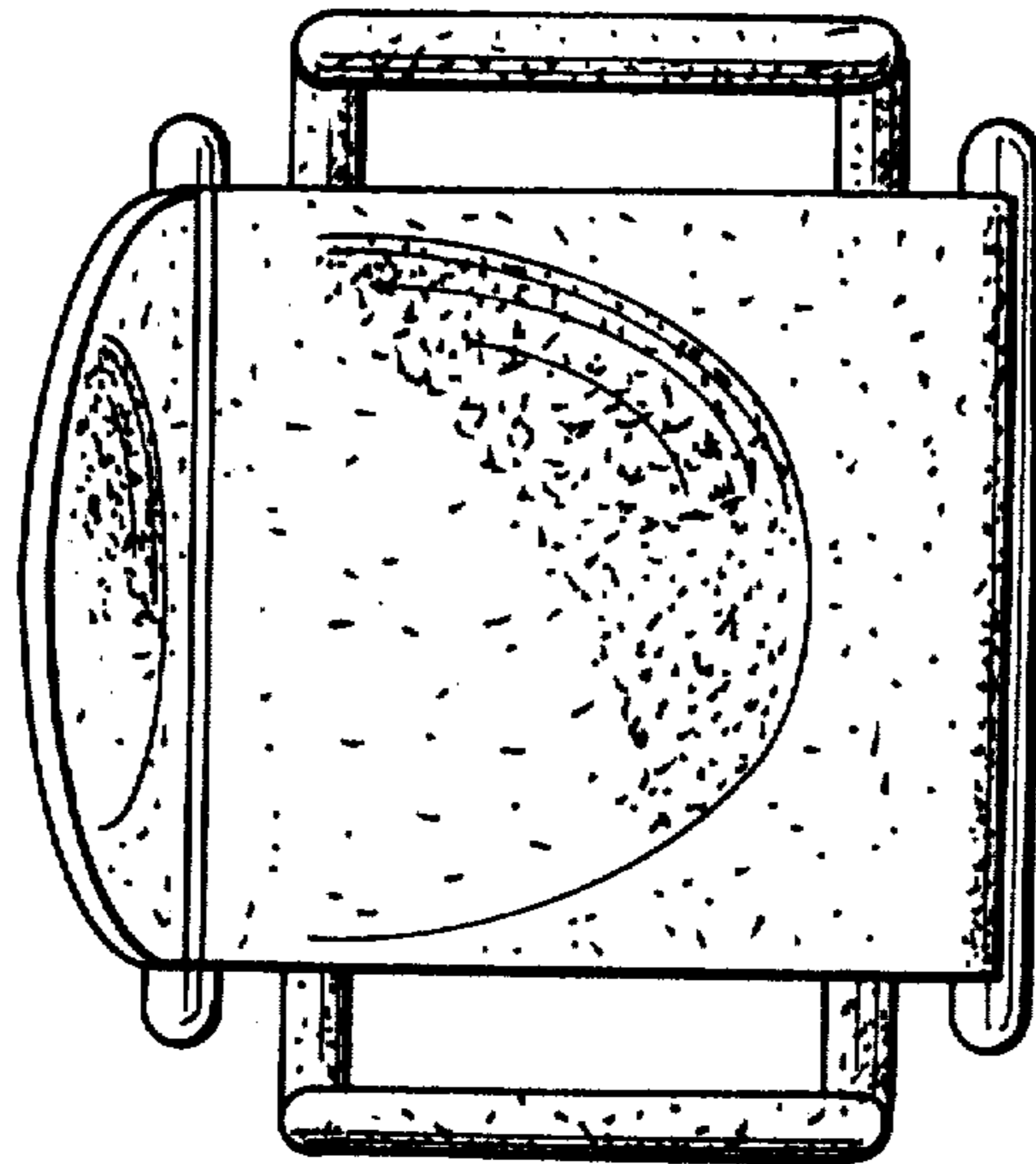
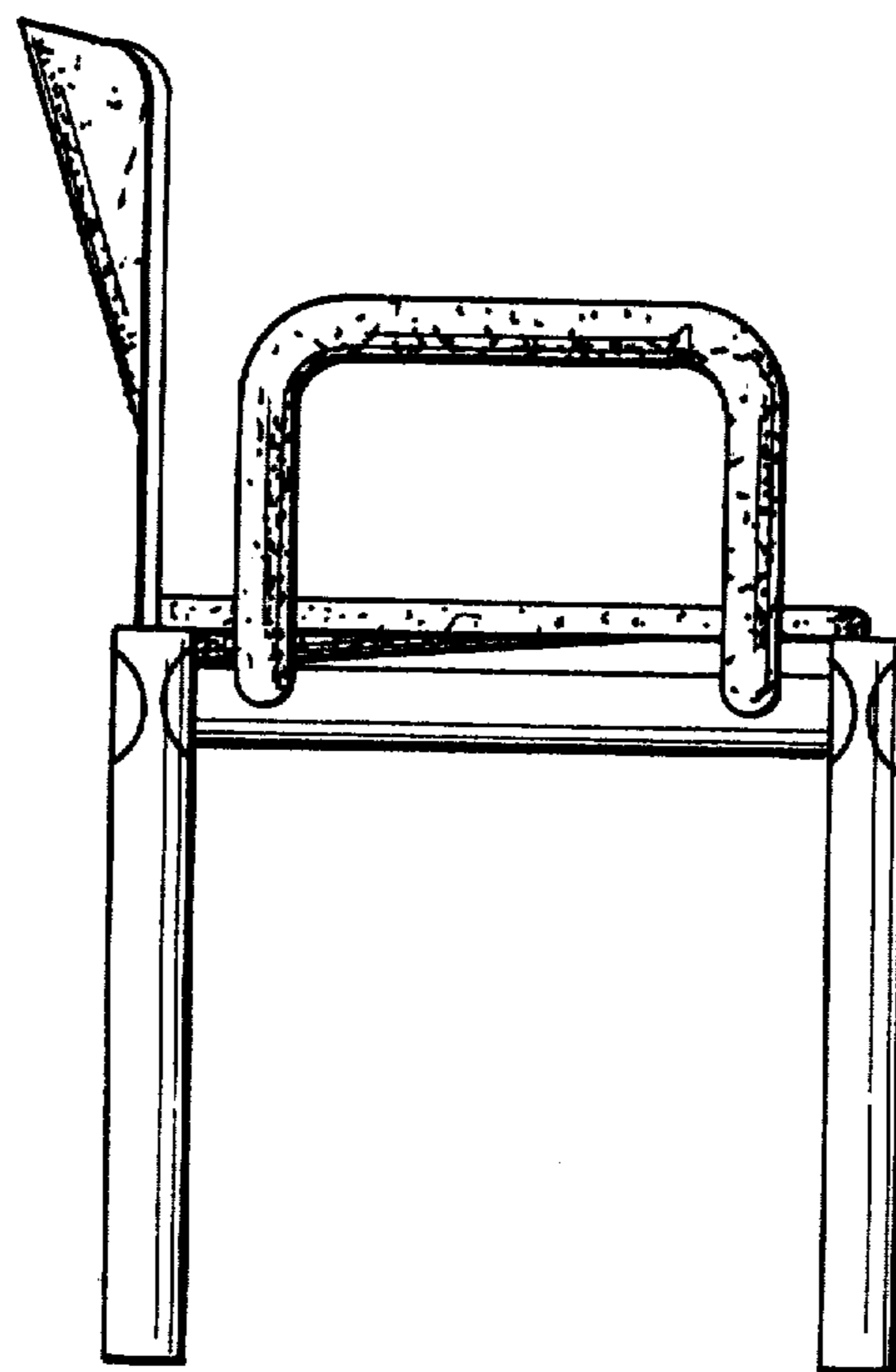

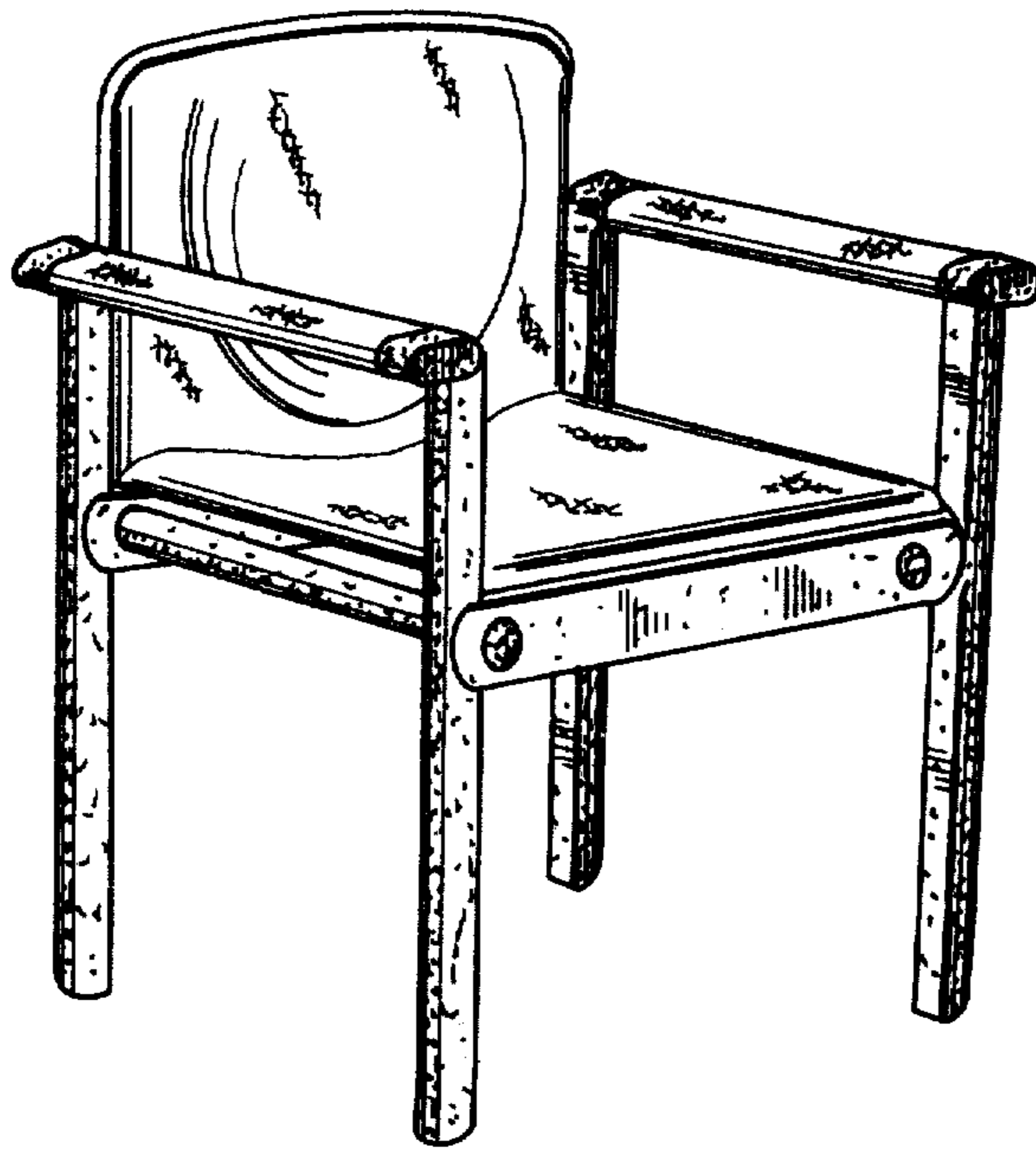

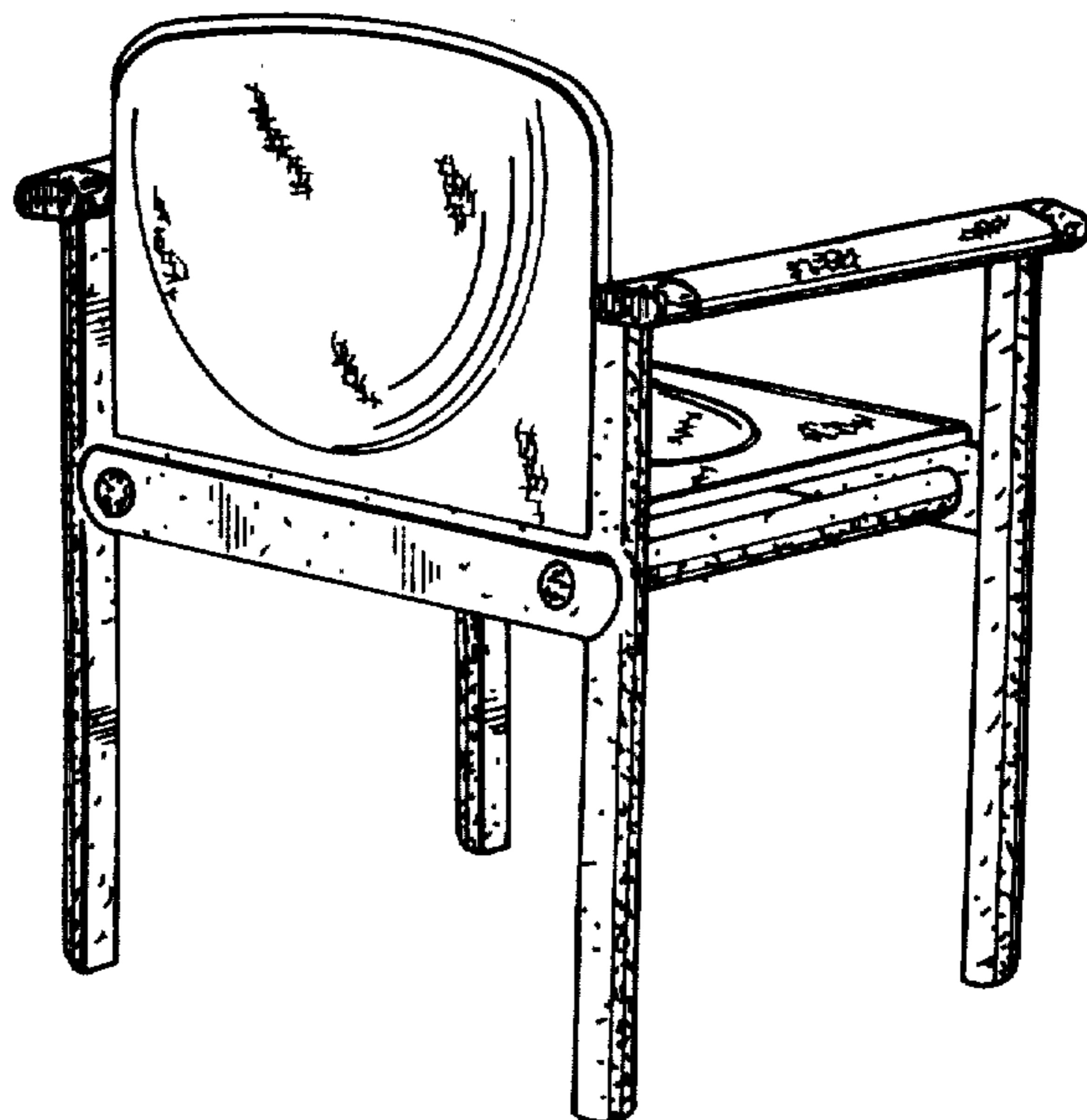

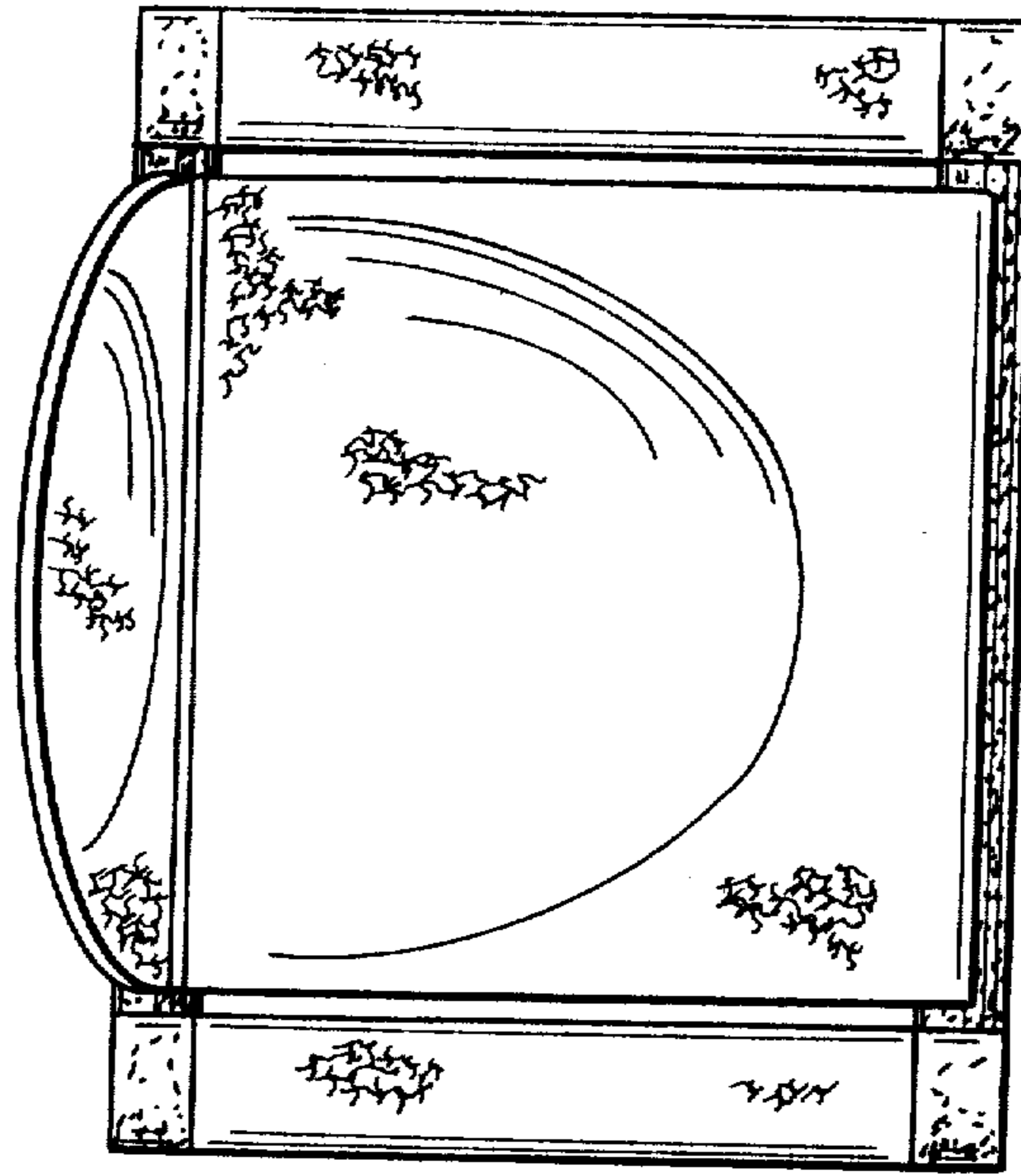

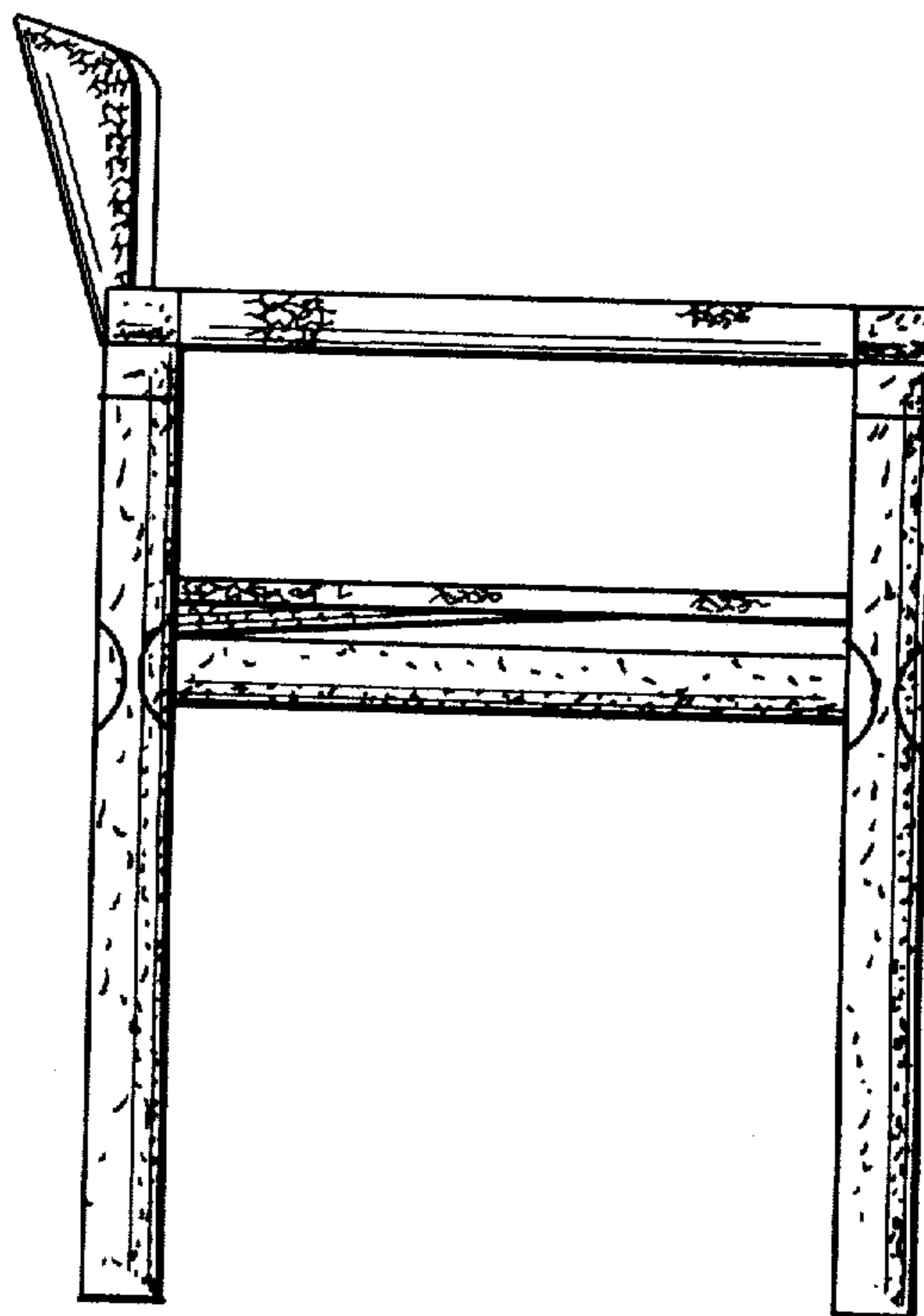
