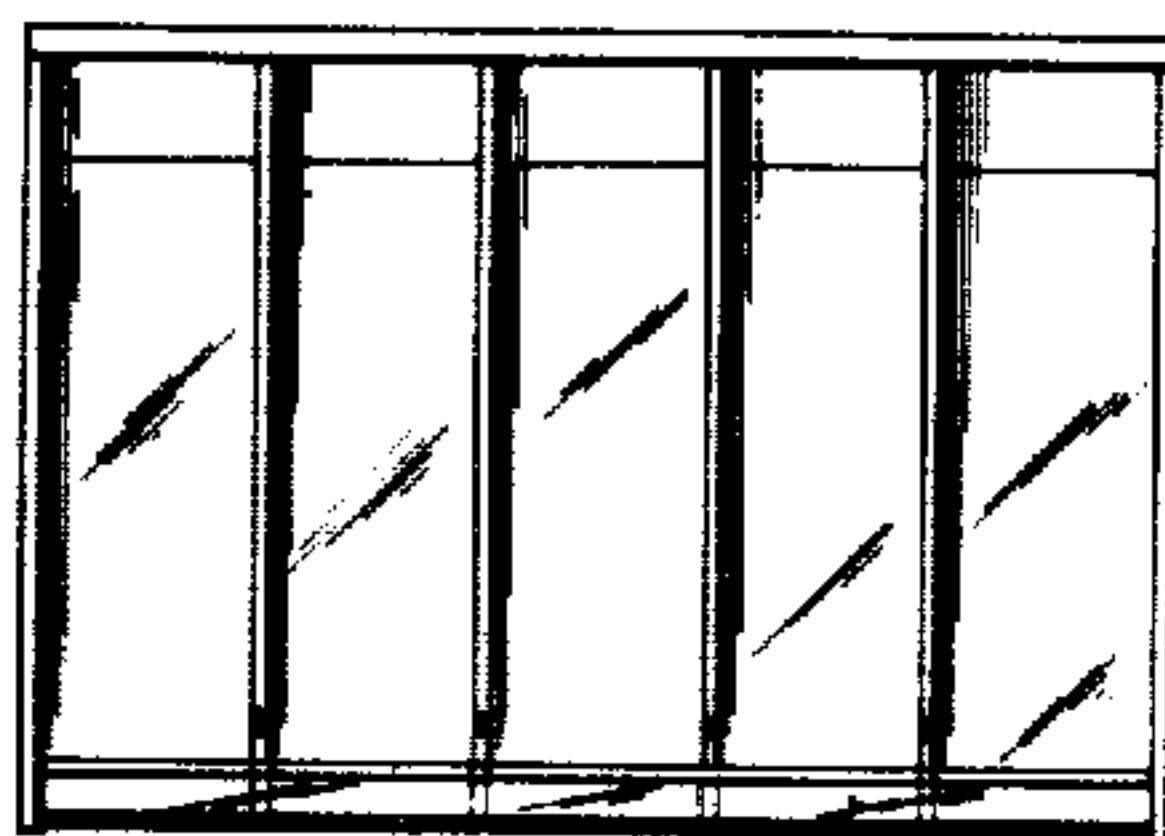
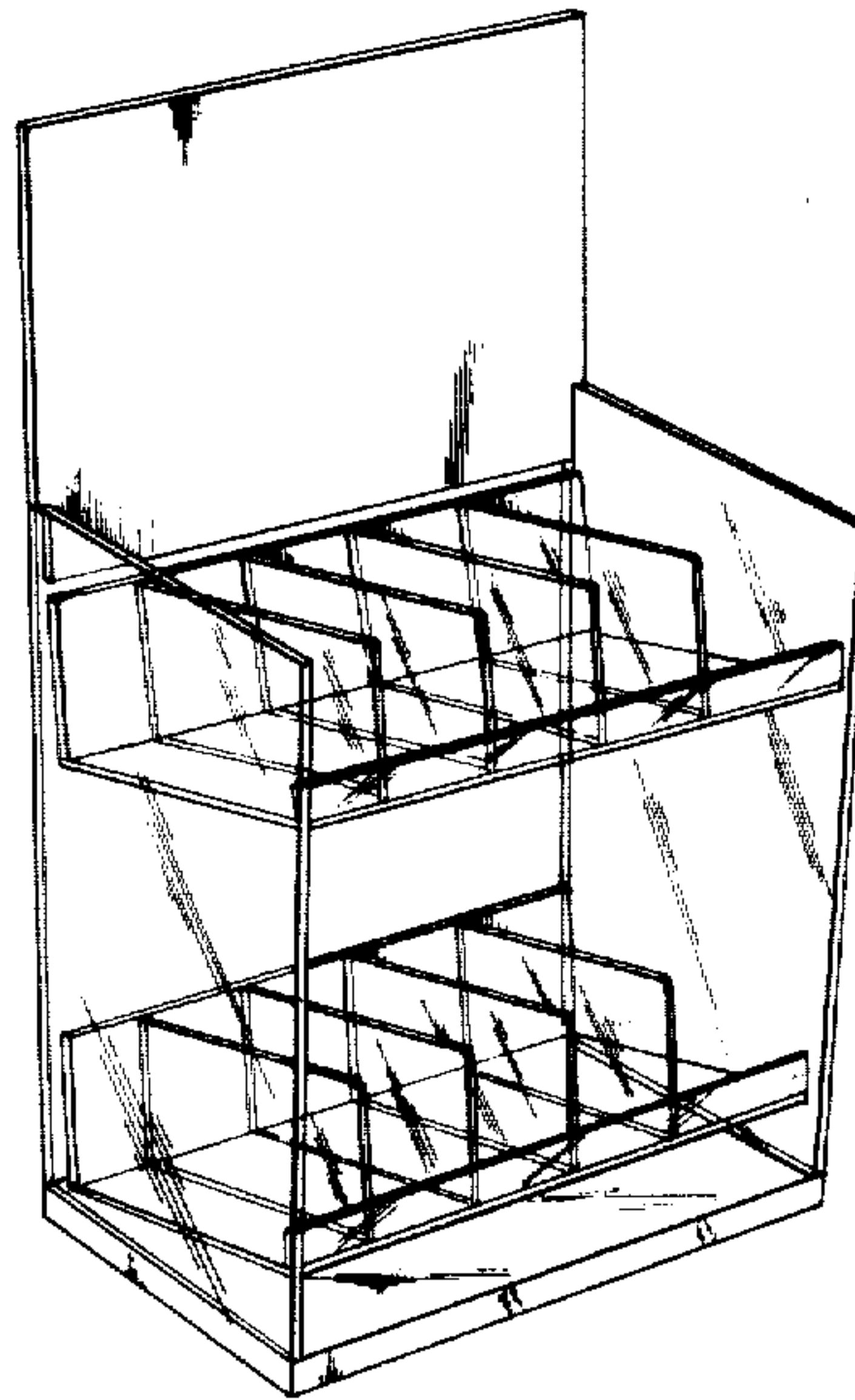

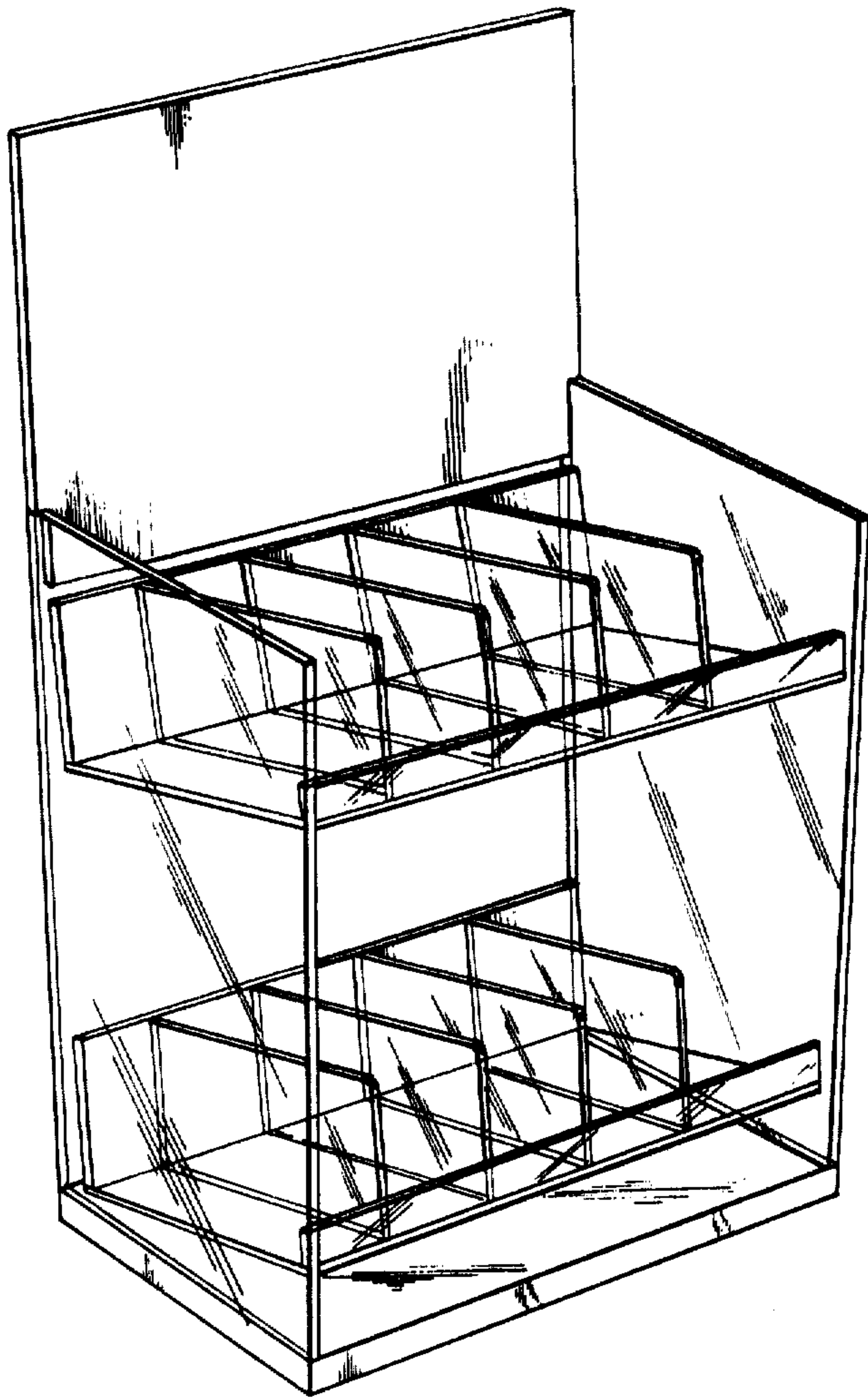

The ornamental design for a display holder, as shown and described.

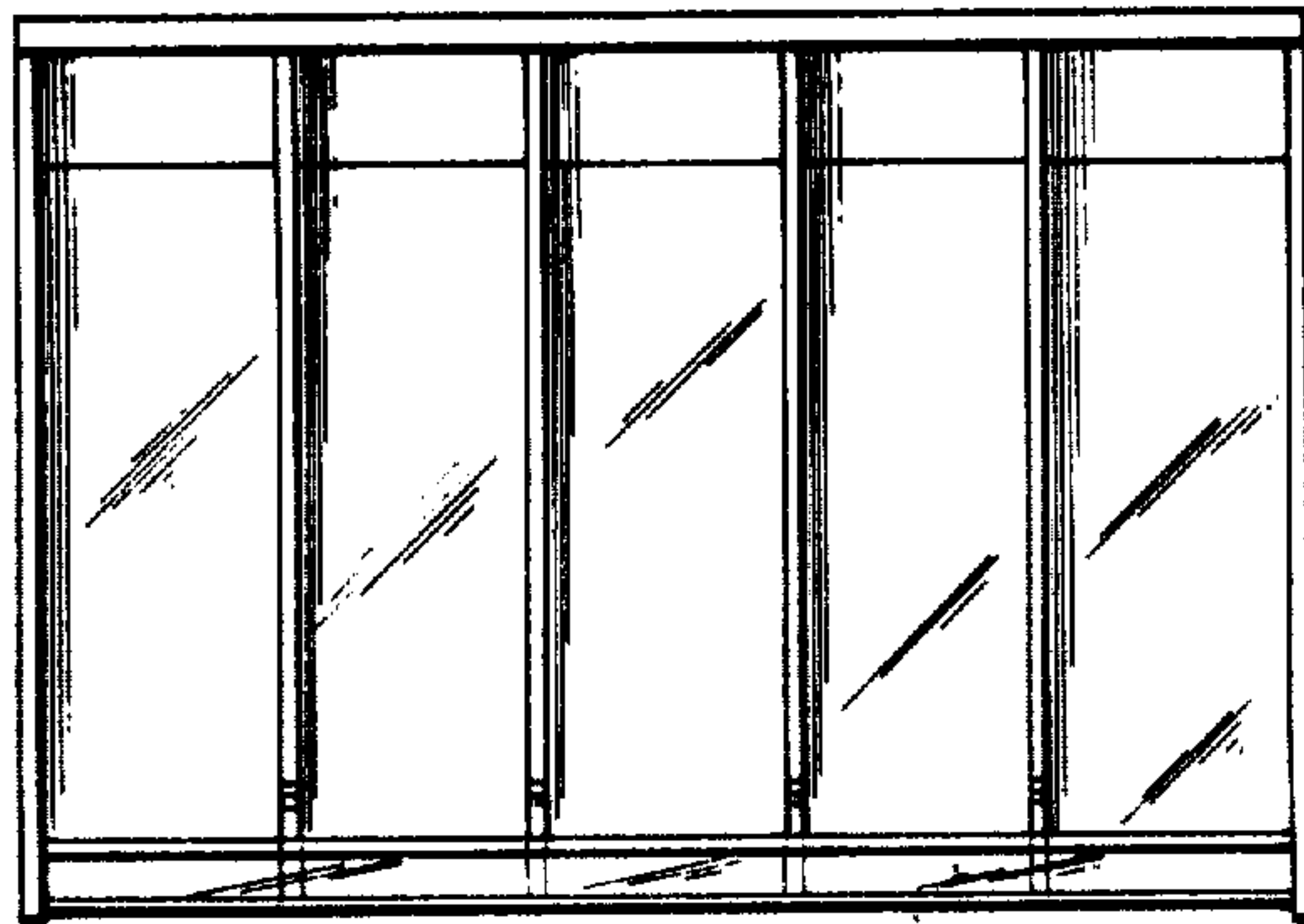
**DESCRIPTION**

 FIG. 14 is a bottom plan view thereof.

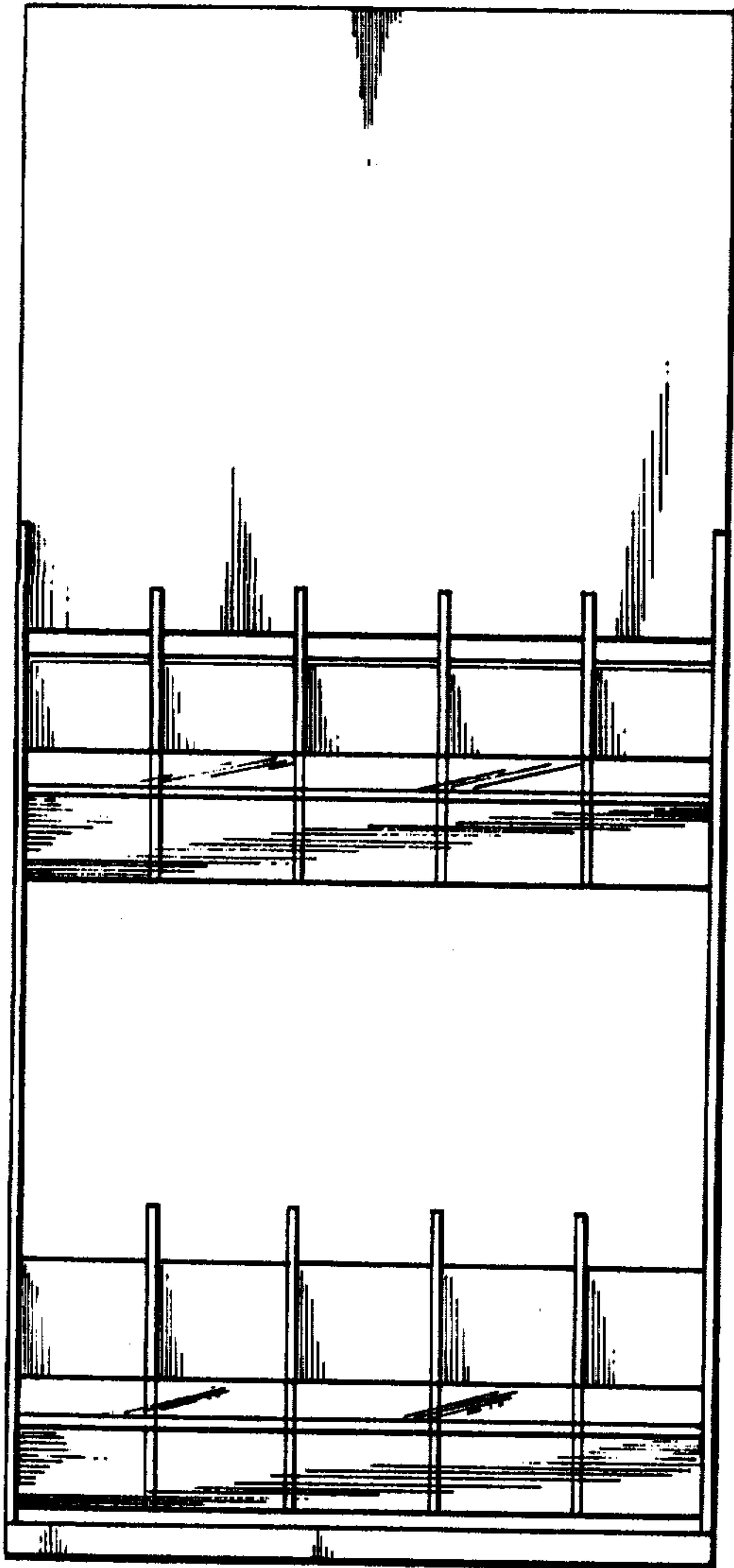




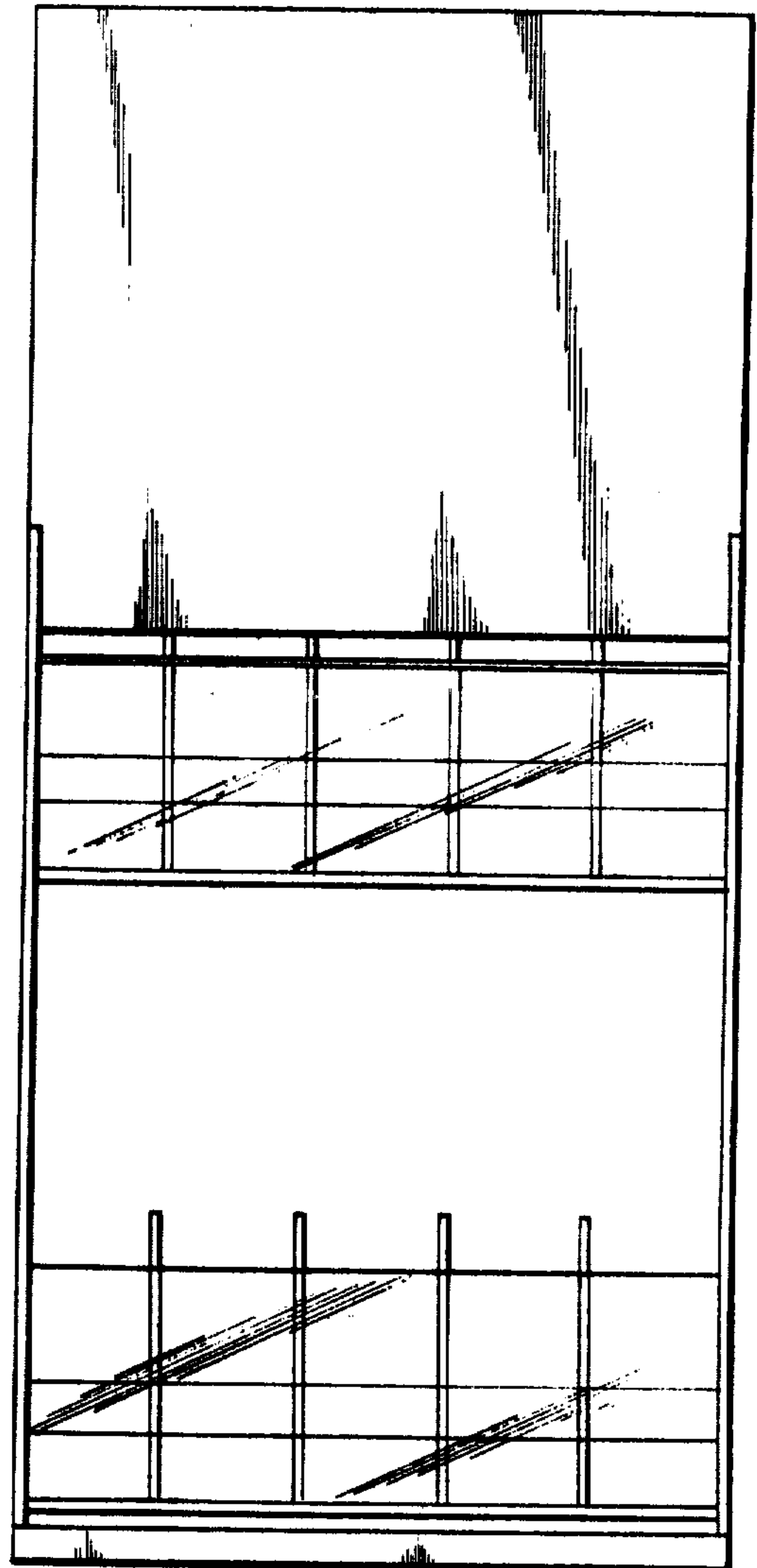

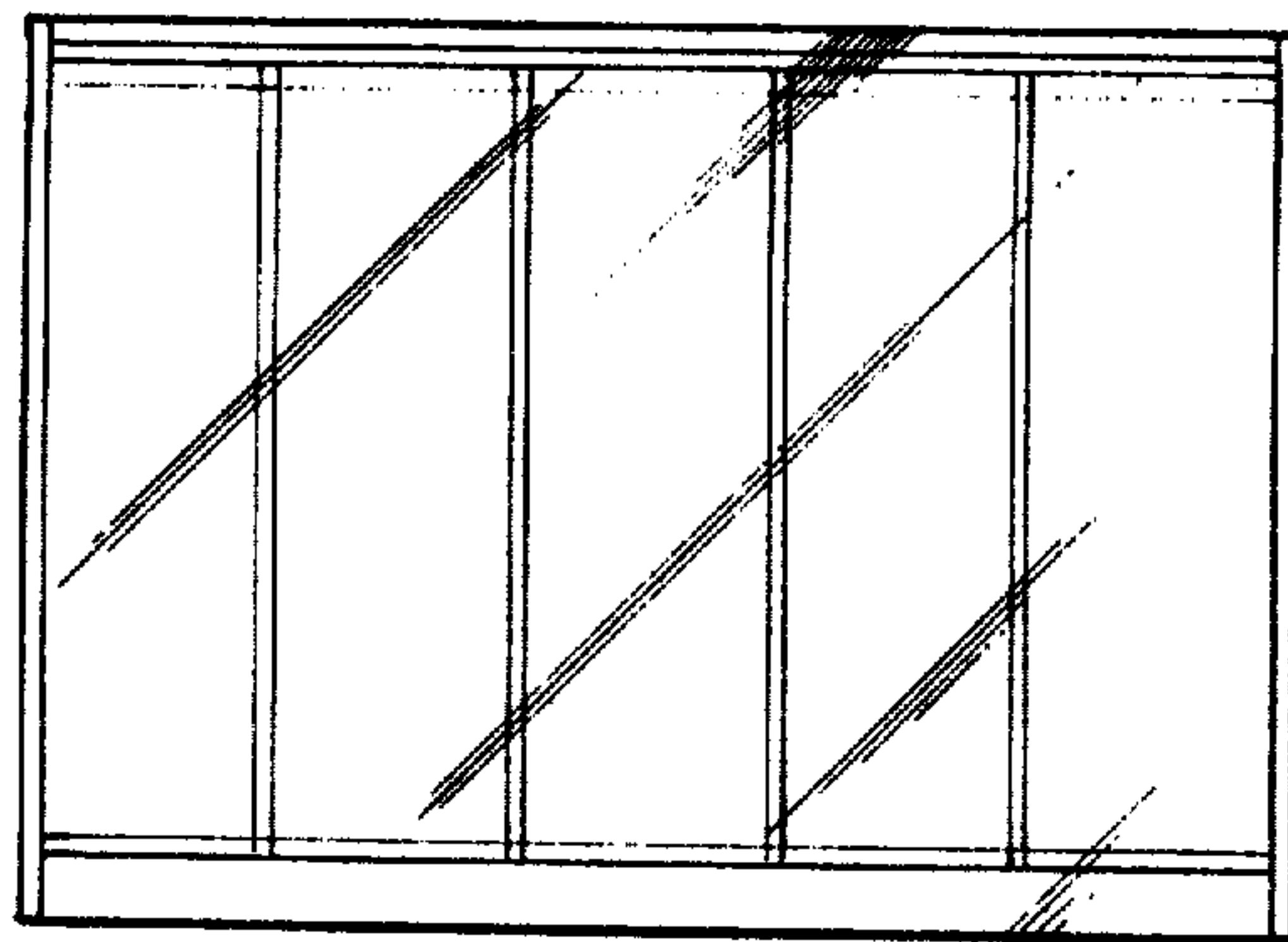

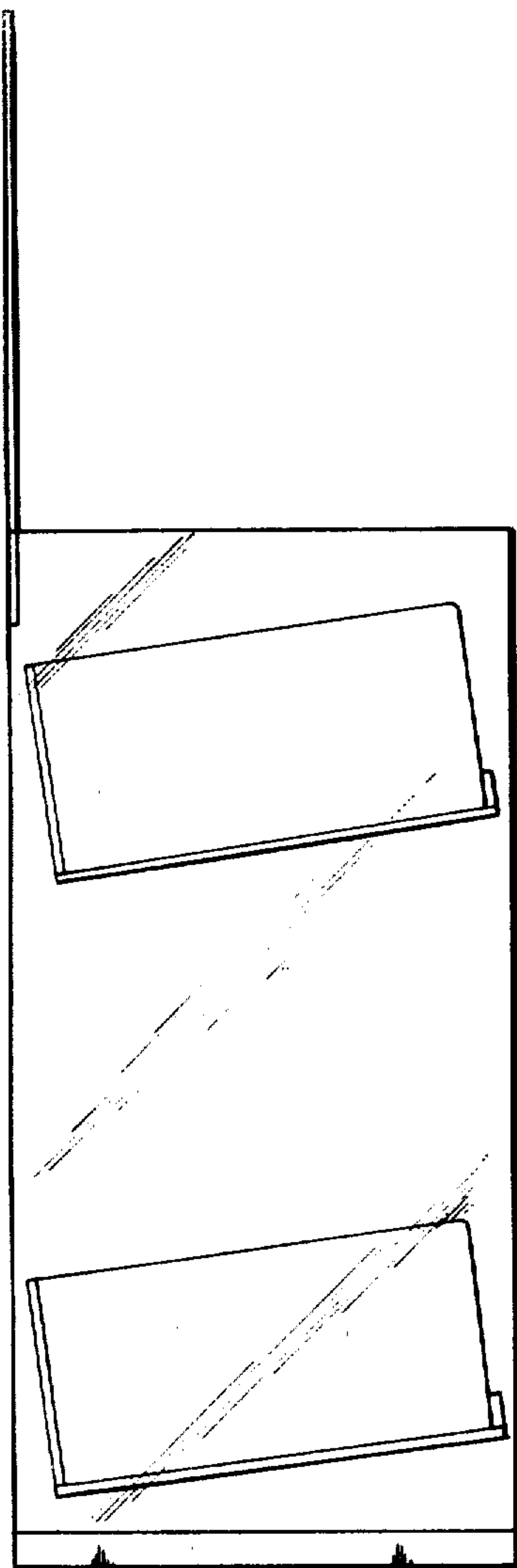

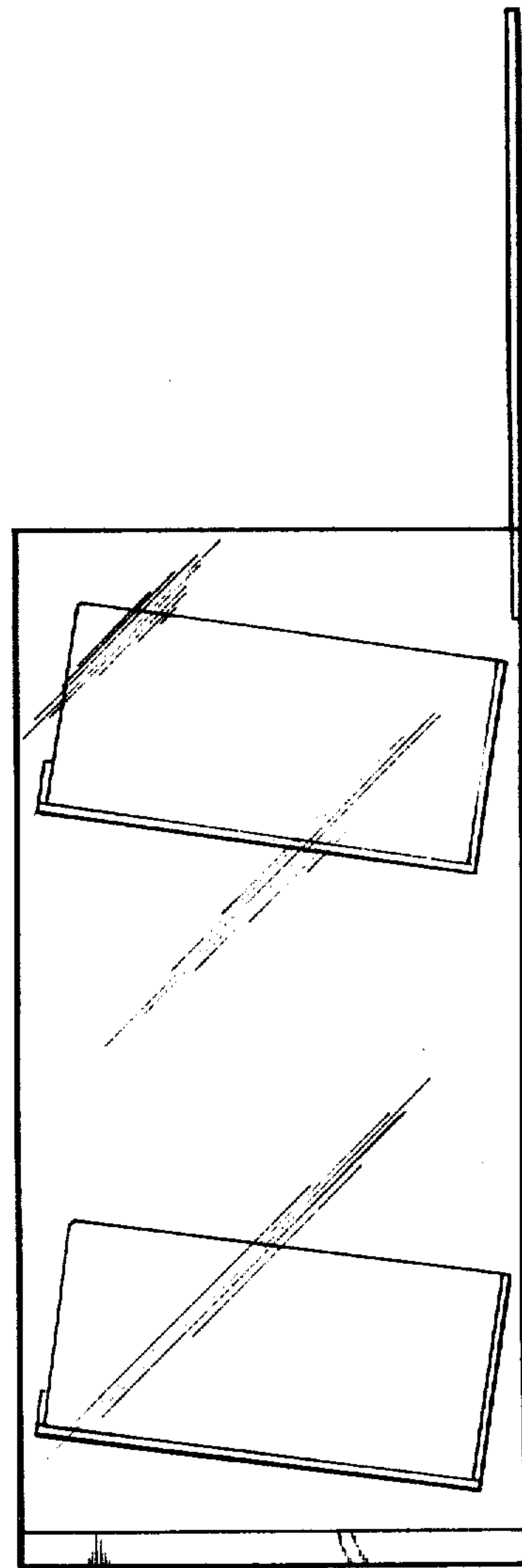

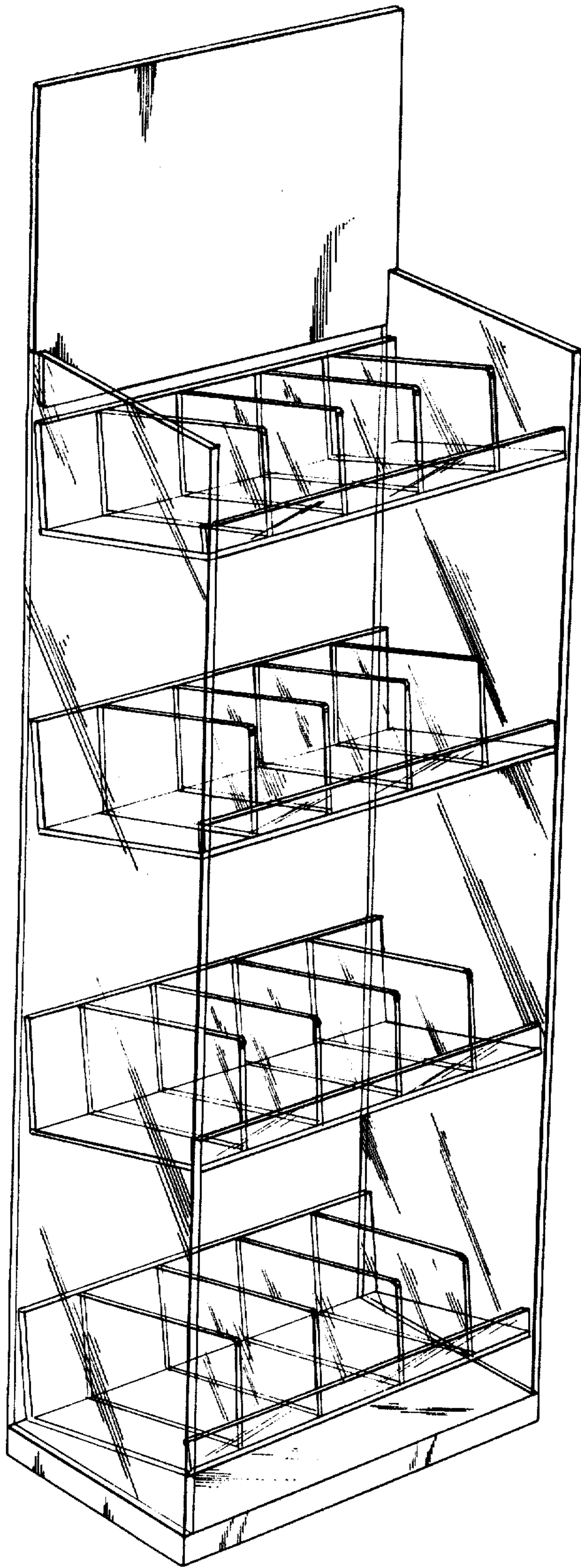

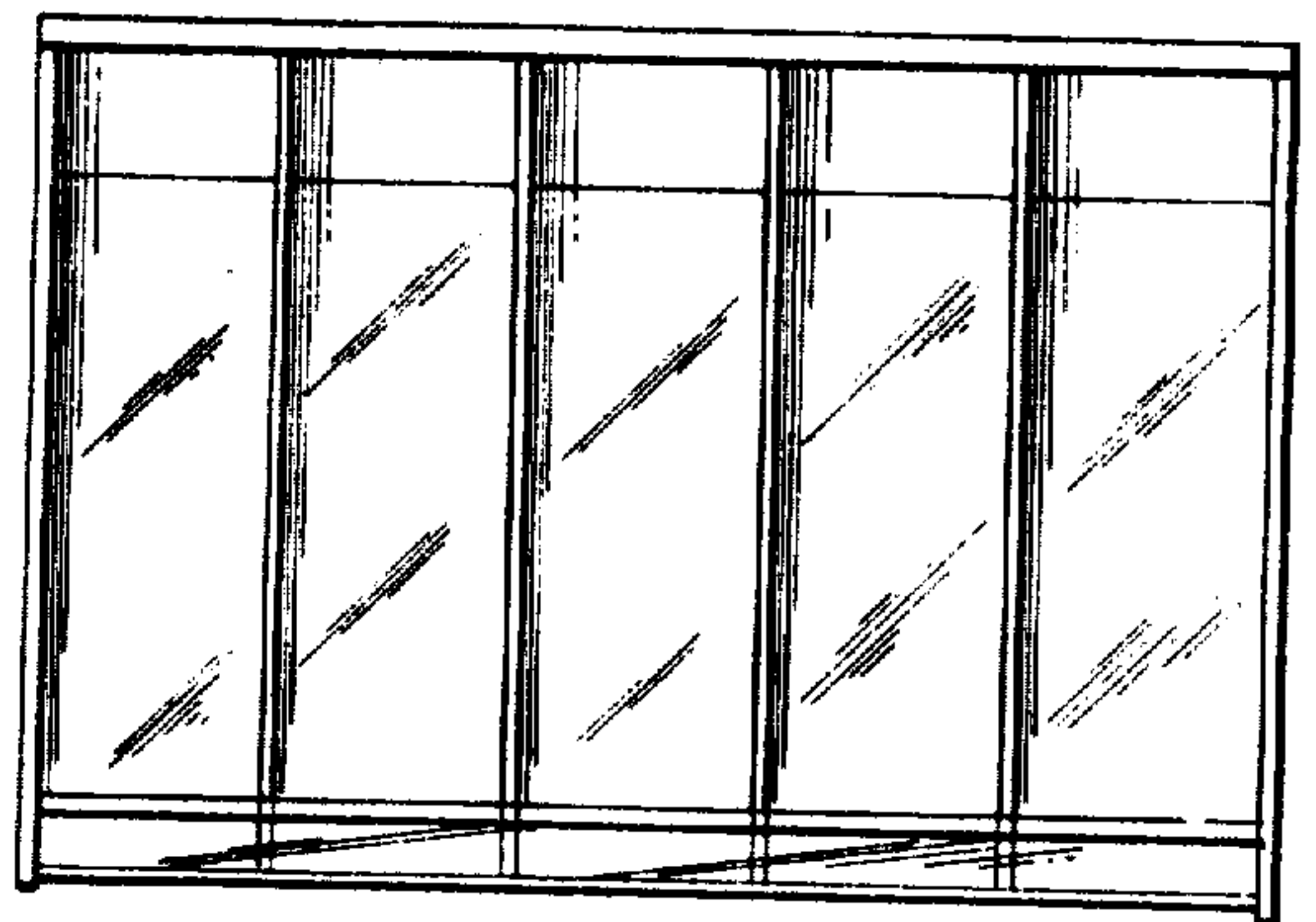

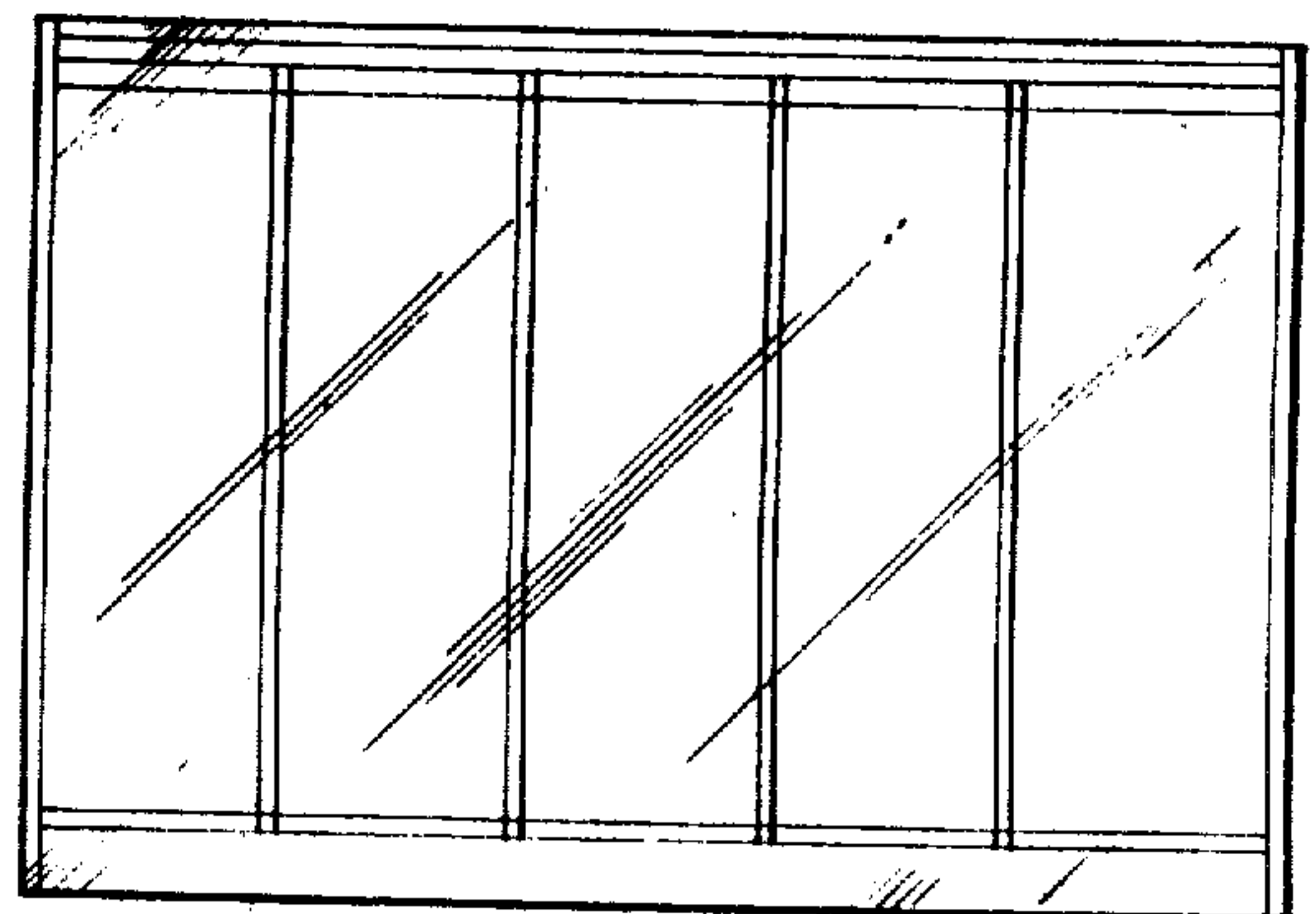




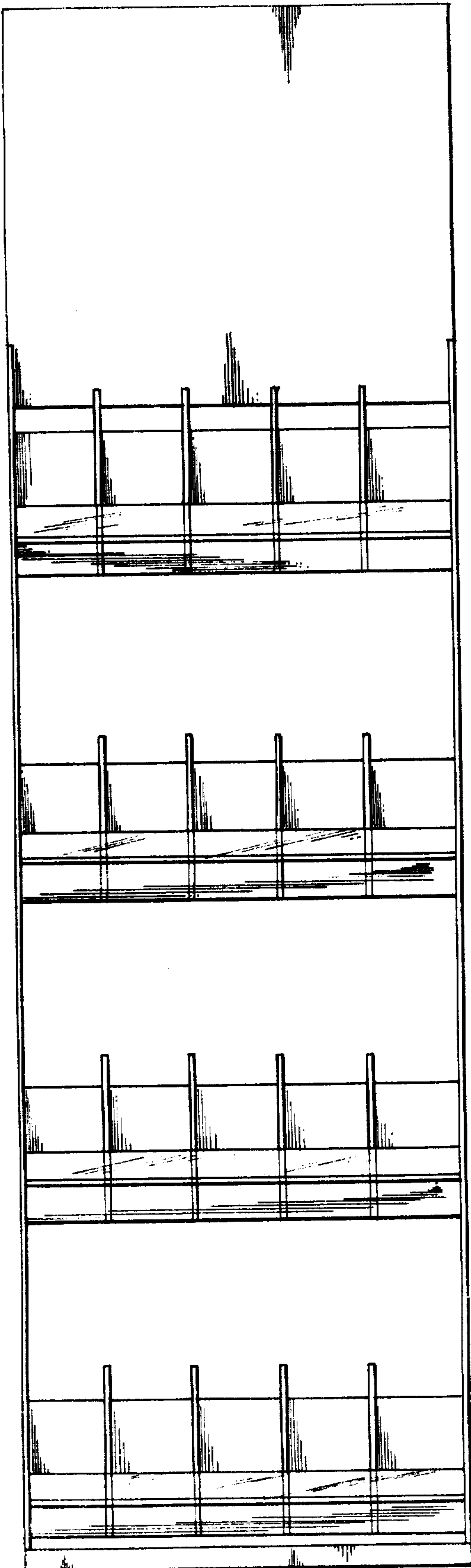

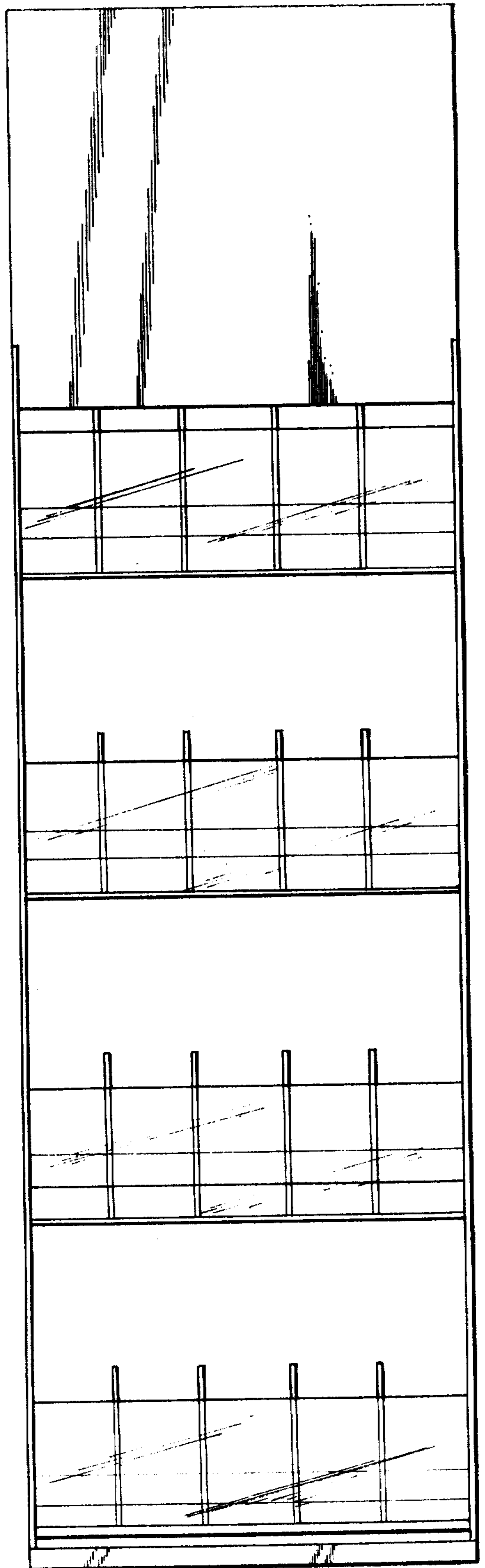

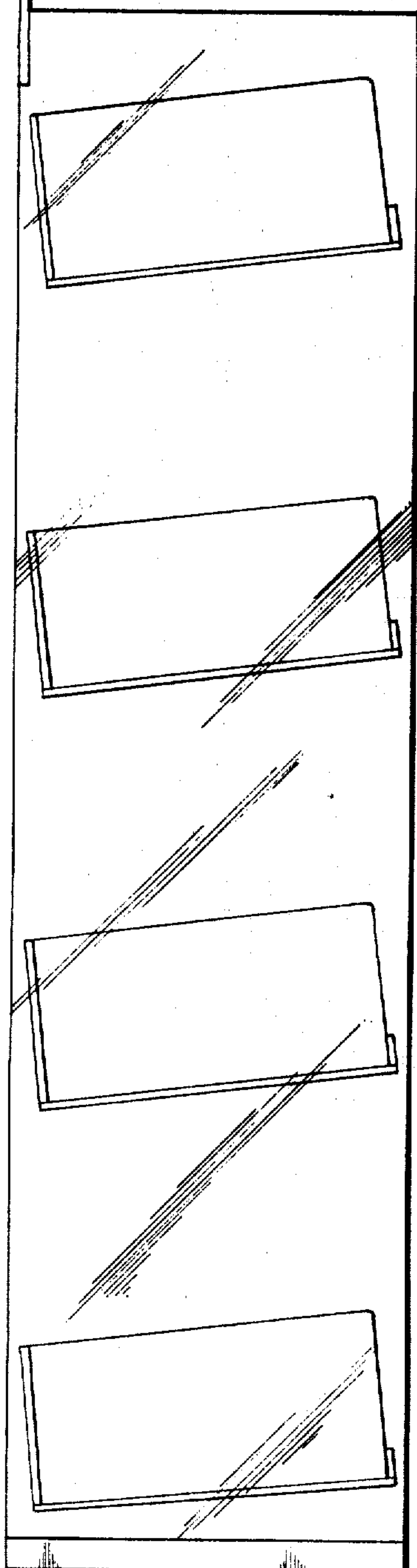
