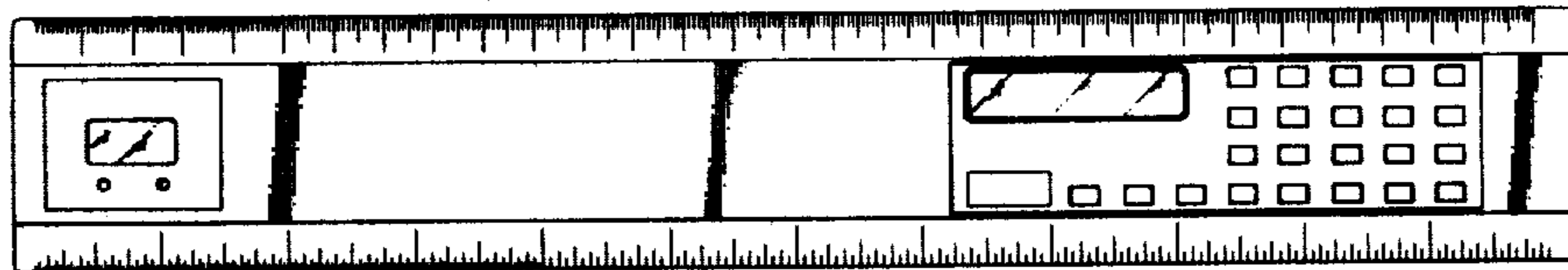

[57] CLAIM

The ornamental design for a combined ruler and electronic calculator, substantially as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a combined ruler and electronic calculator showing my new design;
 FIG. 2 is a bottom plan view thereof;
 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a left side elevational view thereof;
 FIG. 5 is a right side elevational view thereof;
 FIG. 6 is a top plan view of a second embodiment of my new design of FIGS. 1-5.
 FIG. 7 is a bottom plan view thereof;
 FIG. 8 is a front elevational view thereof;
 FIG. 9 is a left side elevational view thereof;
 FIG. 10 is a right side elevational view thereof.



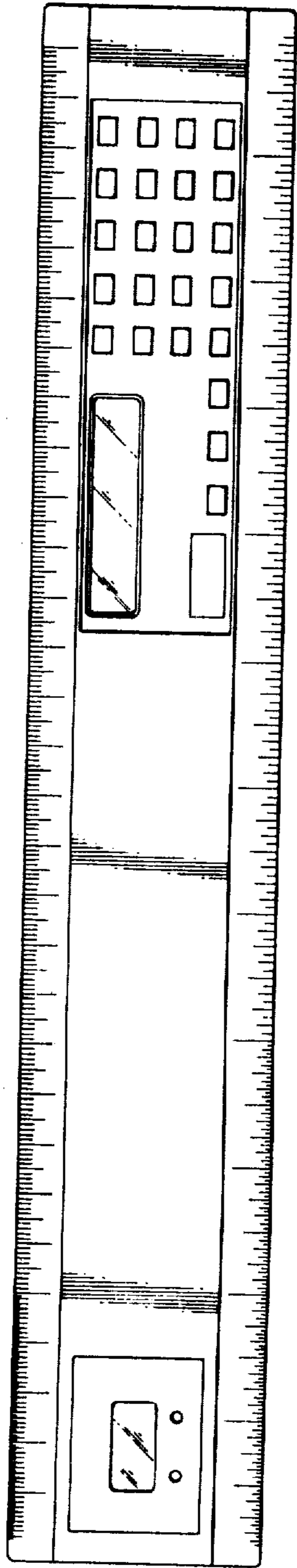

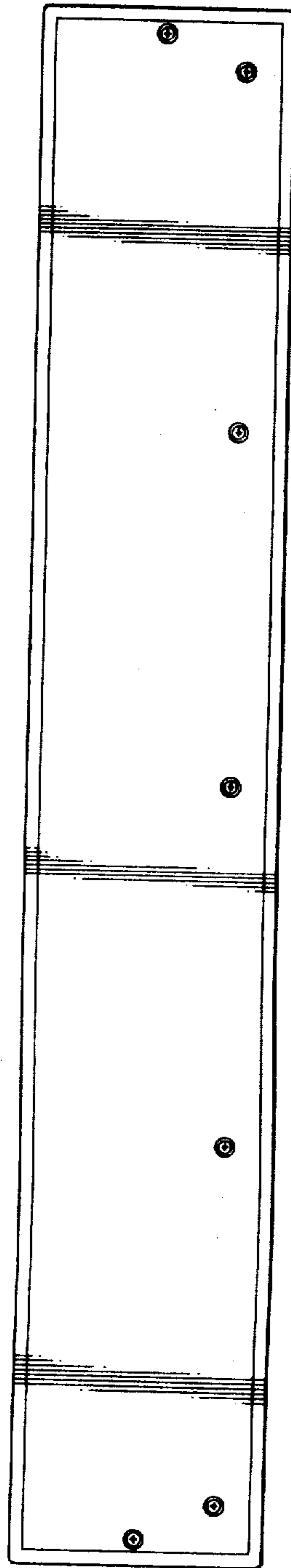

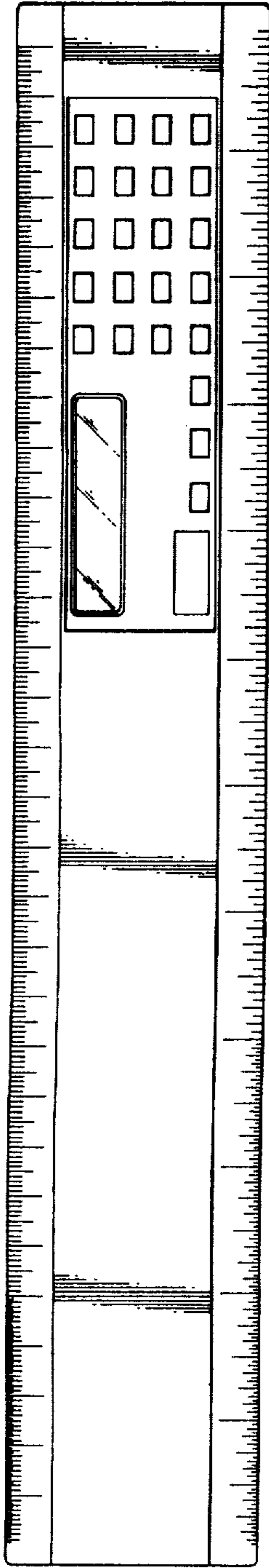

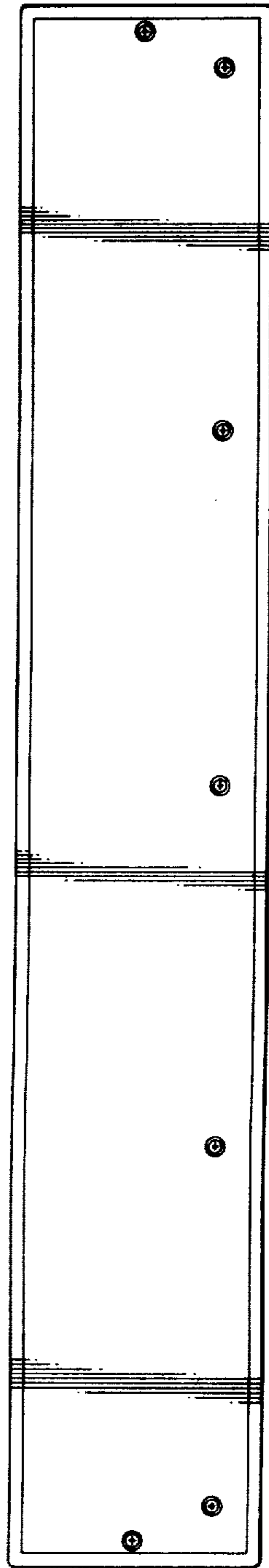

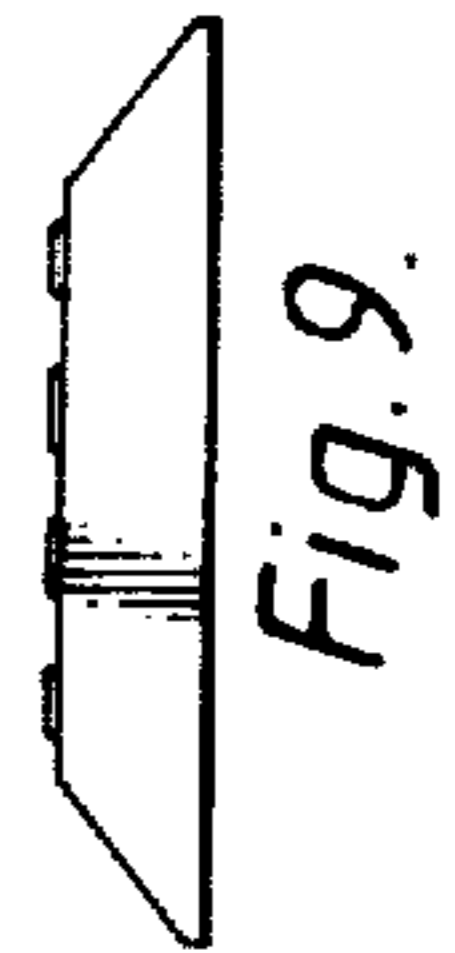
