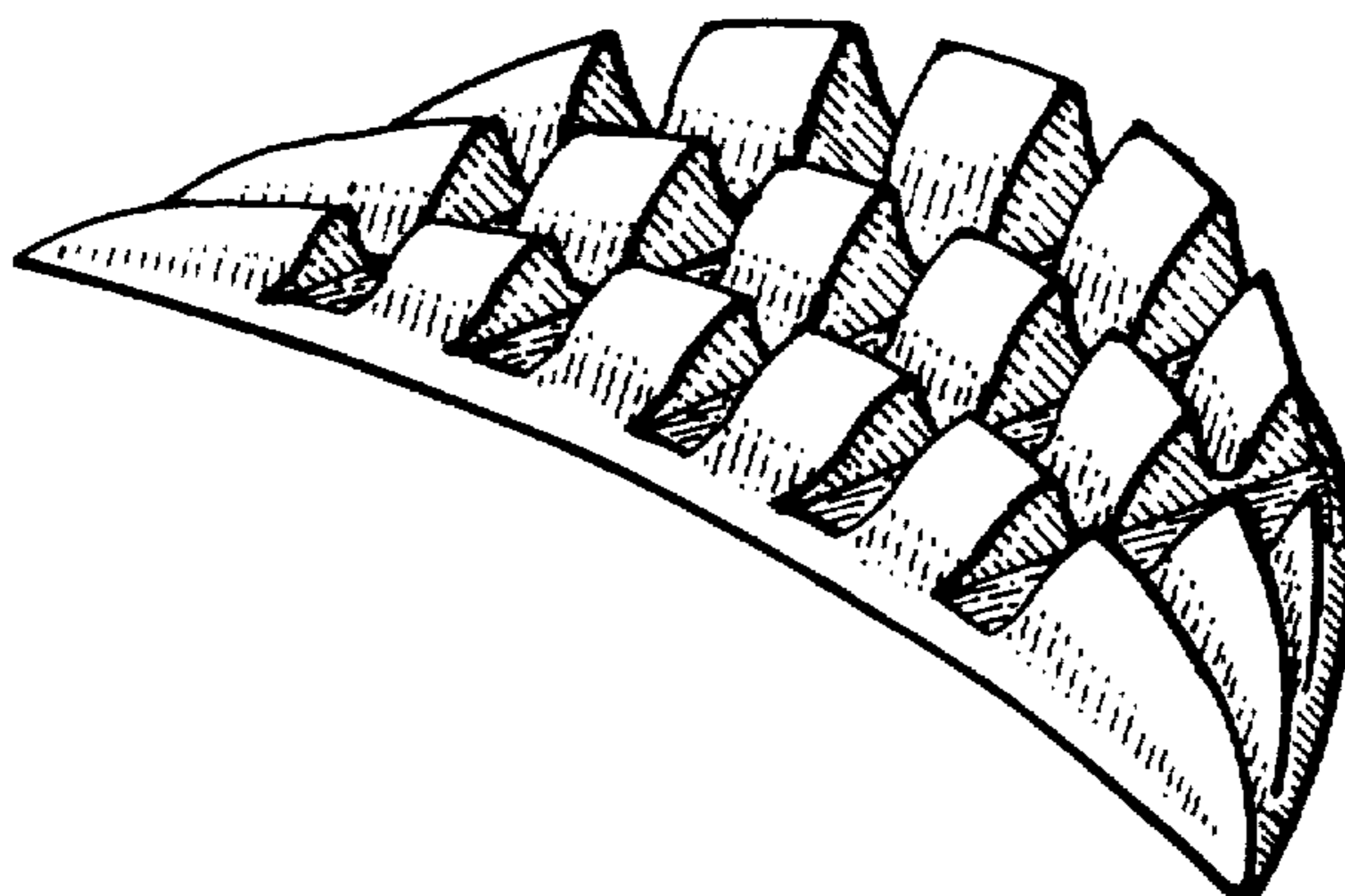

DESCRIPTION

 FIG. 21 is a right side elevational view of FIG. 15.



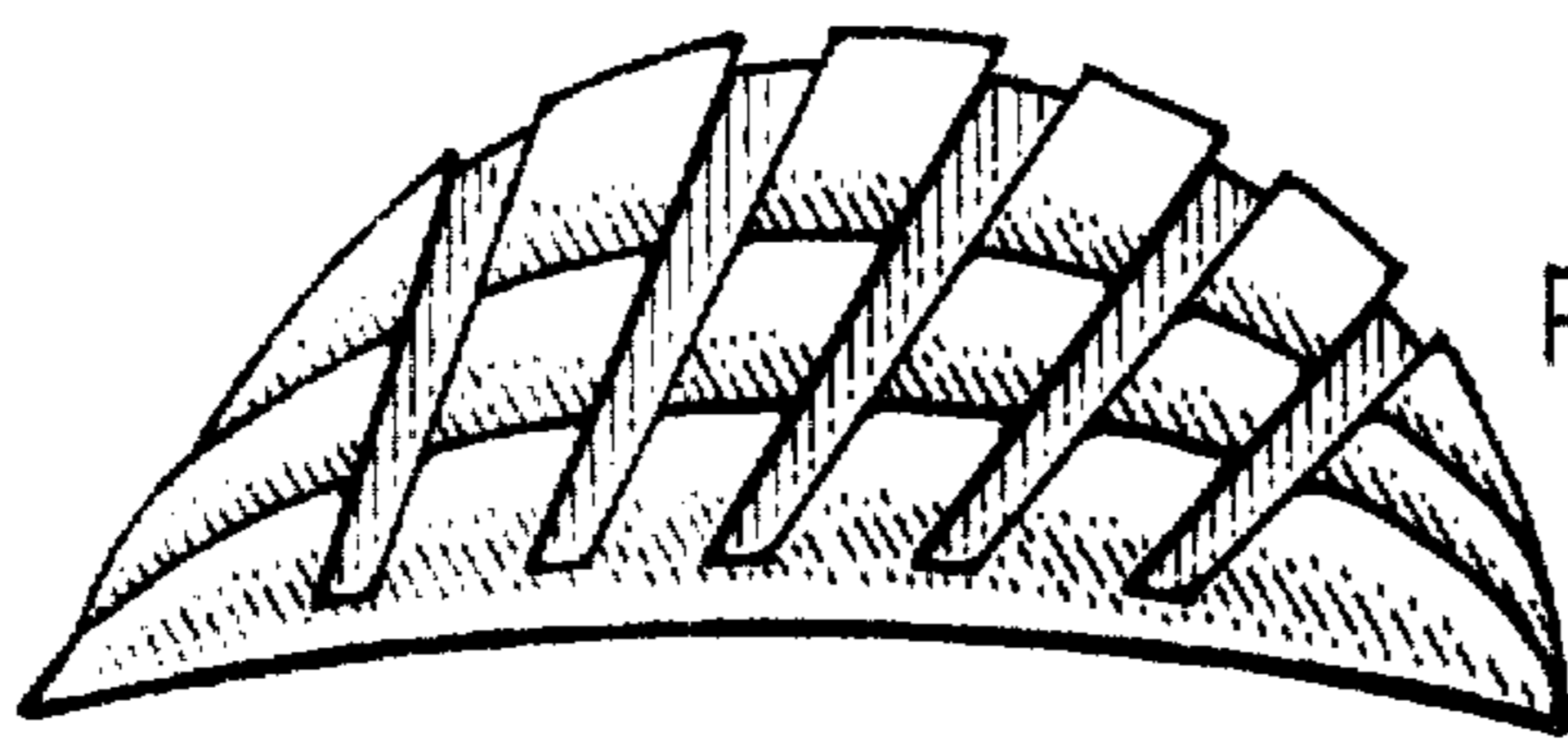

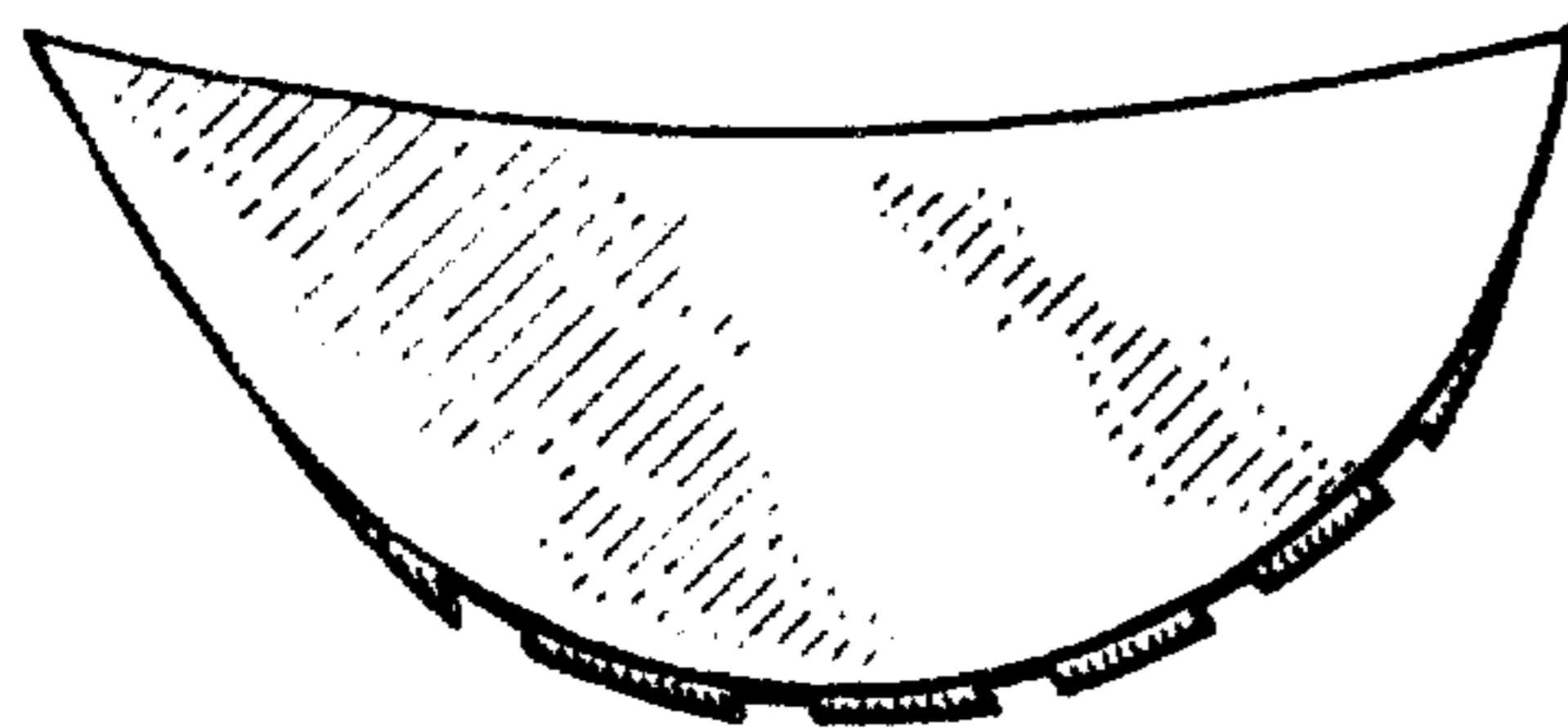

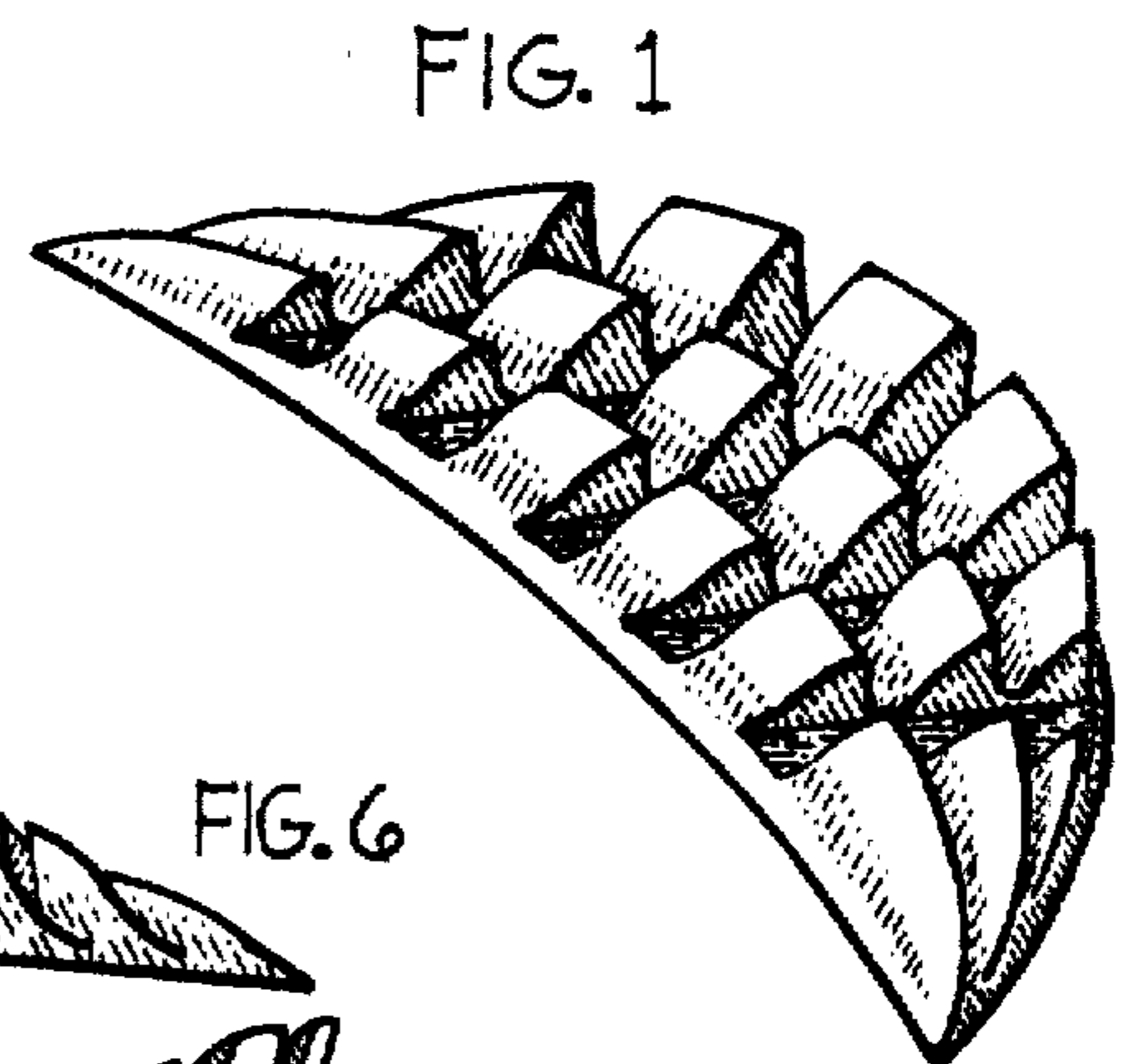

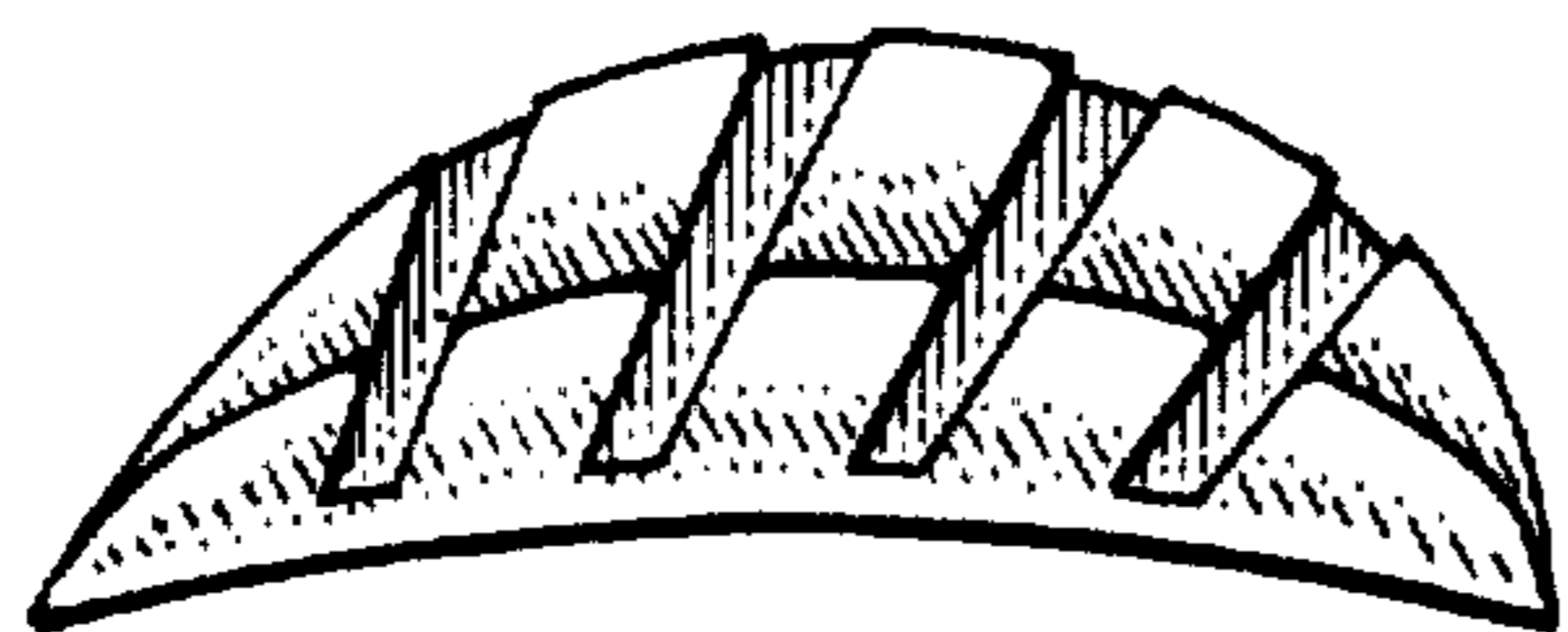

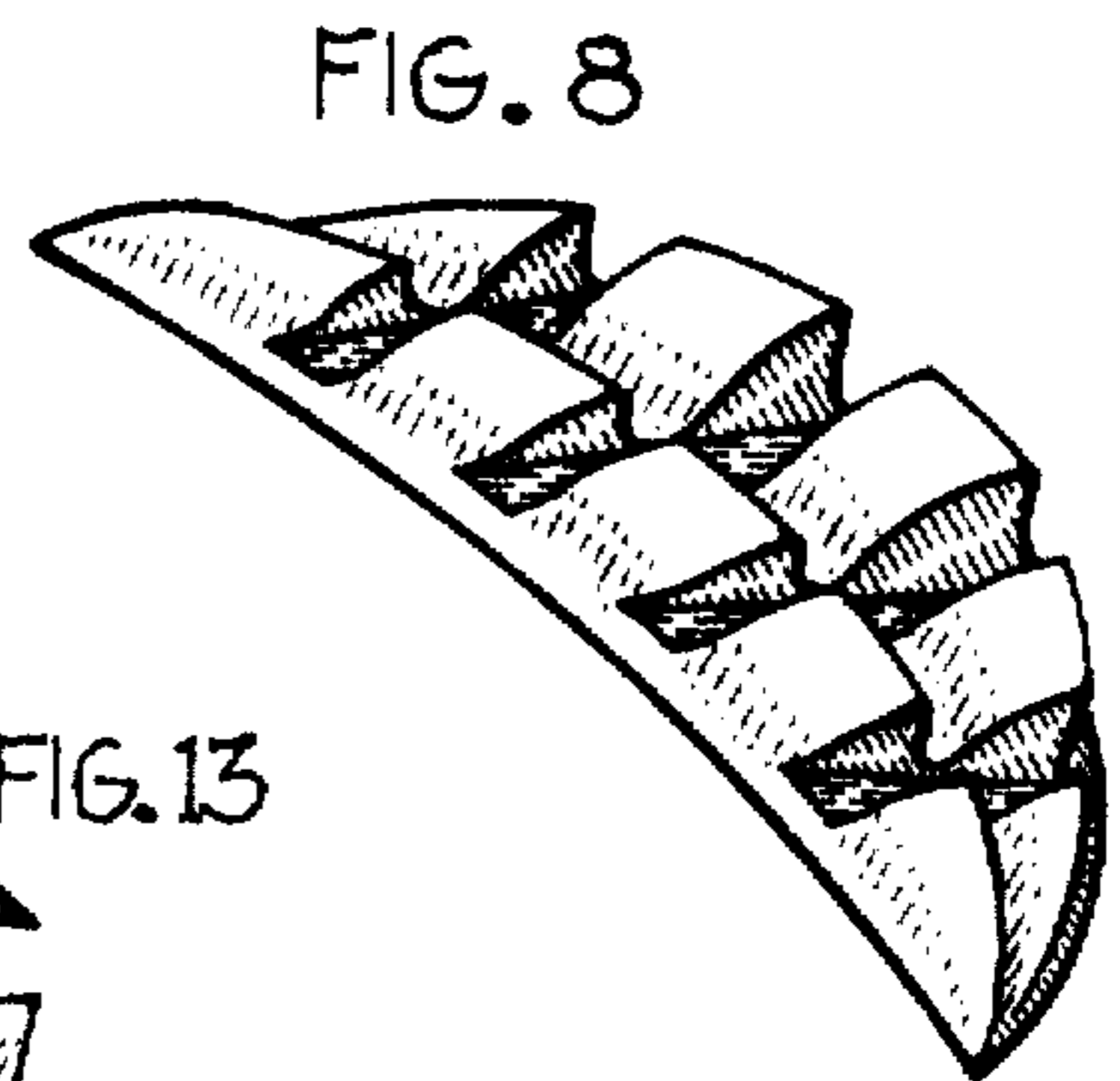

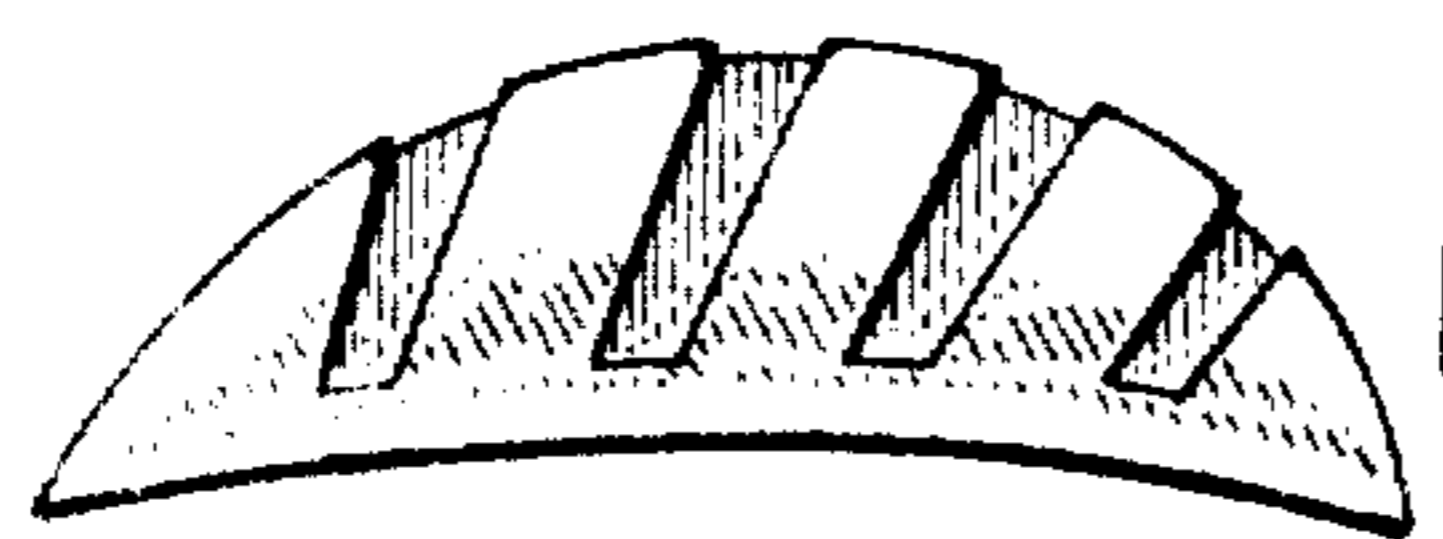

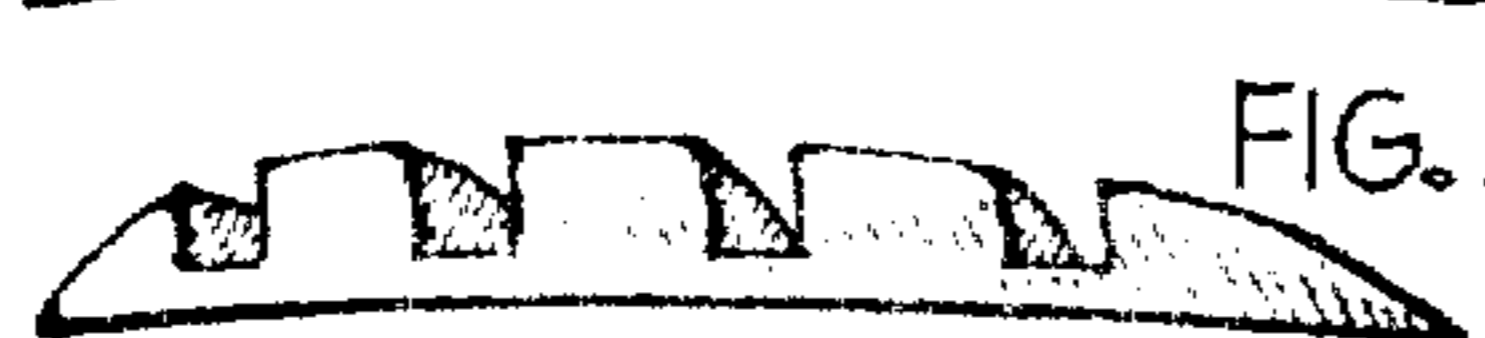

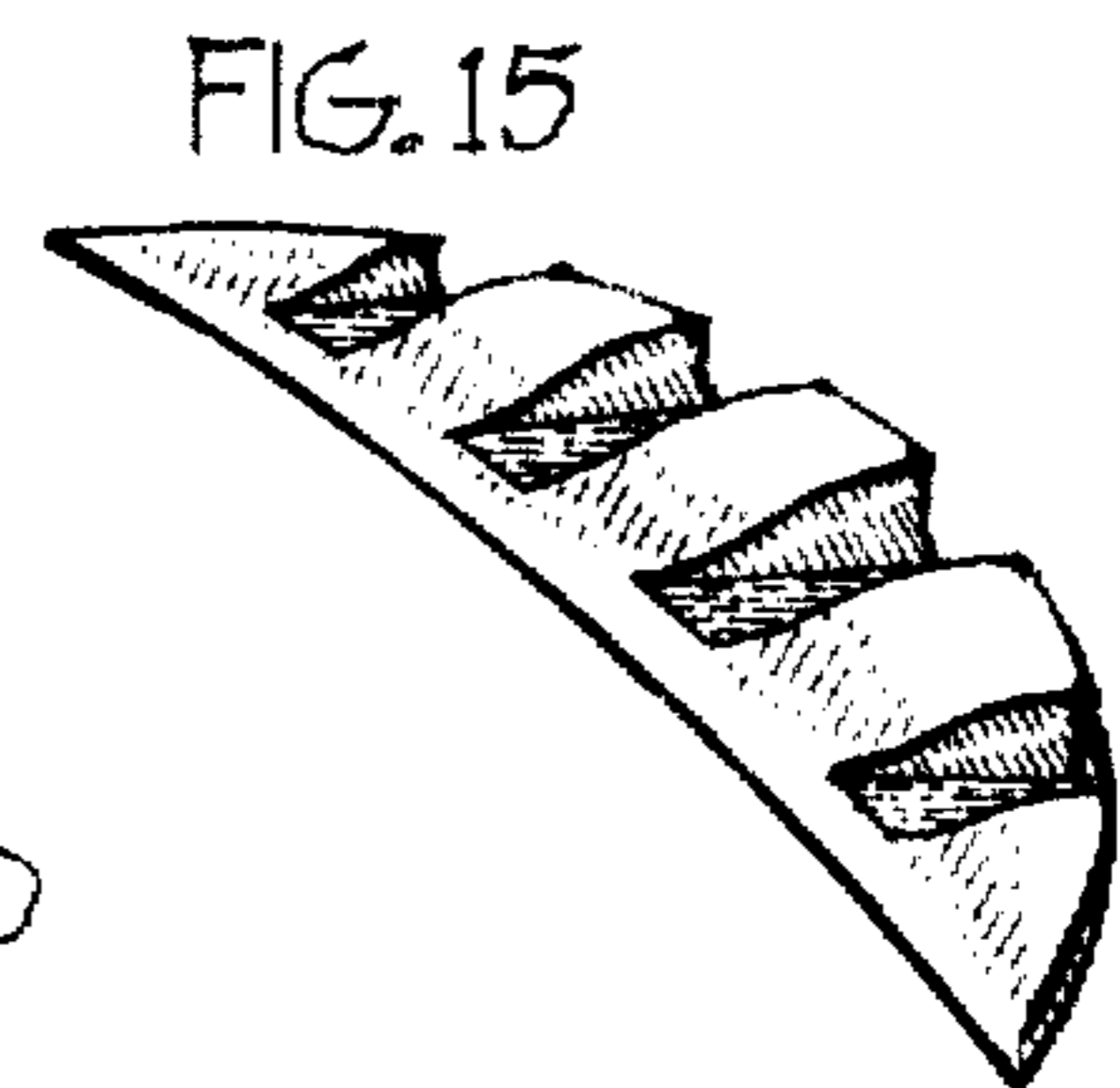
