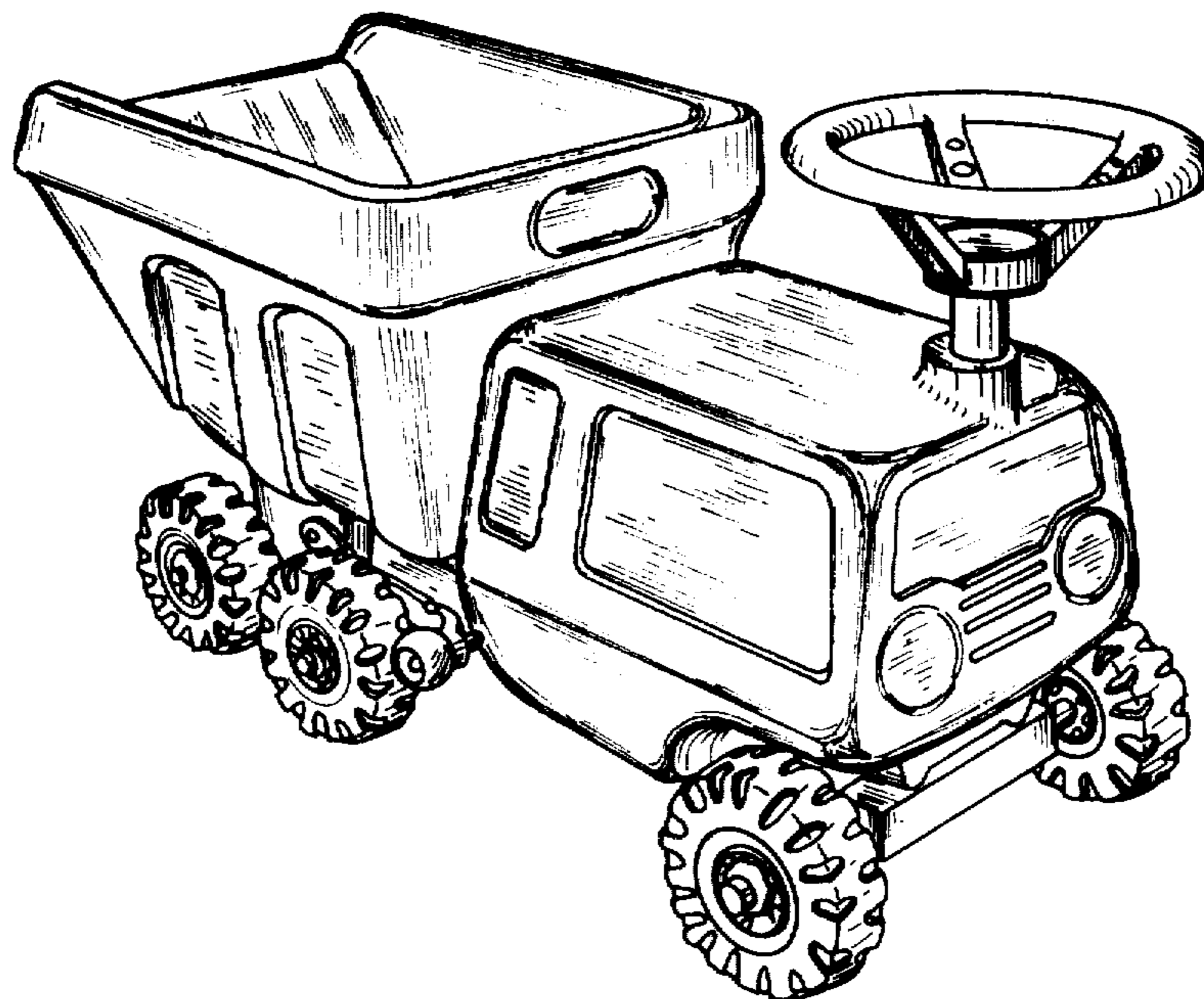

[57] CLAIM

The ornamental design for a toy dump truck, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a toy dump truck showing my new design;
FIG. 2 is another front perspective view thereof with the container member in a tilted position;
FIG. 3 is a perspective view of lower portion of the container member shown on an enlarged scale partially in fragment;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a side elevational view thereof the side opposite being substantially a mirror image;
FIG. 6 is a rear elevational view thereof;
FIG. 7 is a top plan view thereof;
FIG. 8 is a bottom plan view thereof;
FIG. 9 is a side elevational view of a wheel member;
FIG. 10 is a side elevational view of a wheel member of the side opposite that shown in FIG. 9;
FIG. 11 is a side elevational view of the handle member shown on an enlarged scale partially in fragment;
FIG. 12 is a front elevational view thereof;
FIG. 13 is a front elevational view of a modified form of the cab member shown in the design of FIGS. 1 through 8; and
FIG. 14 is a side elevational view thereof, the side opposite being substantially a mirror image.



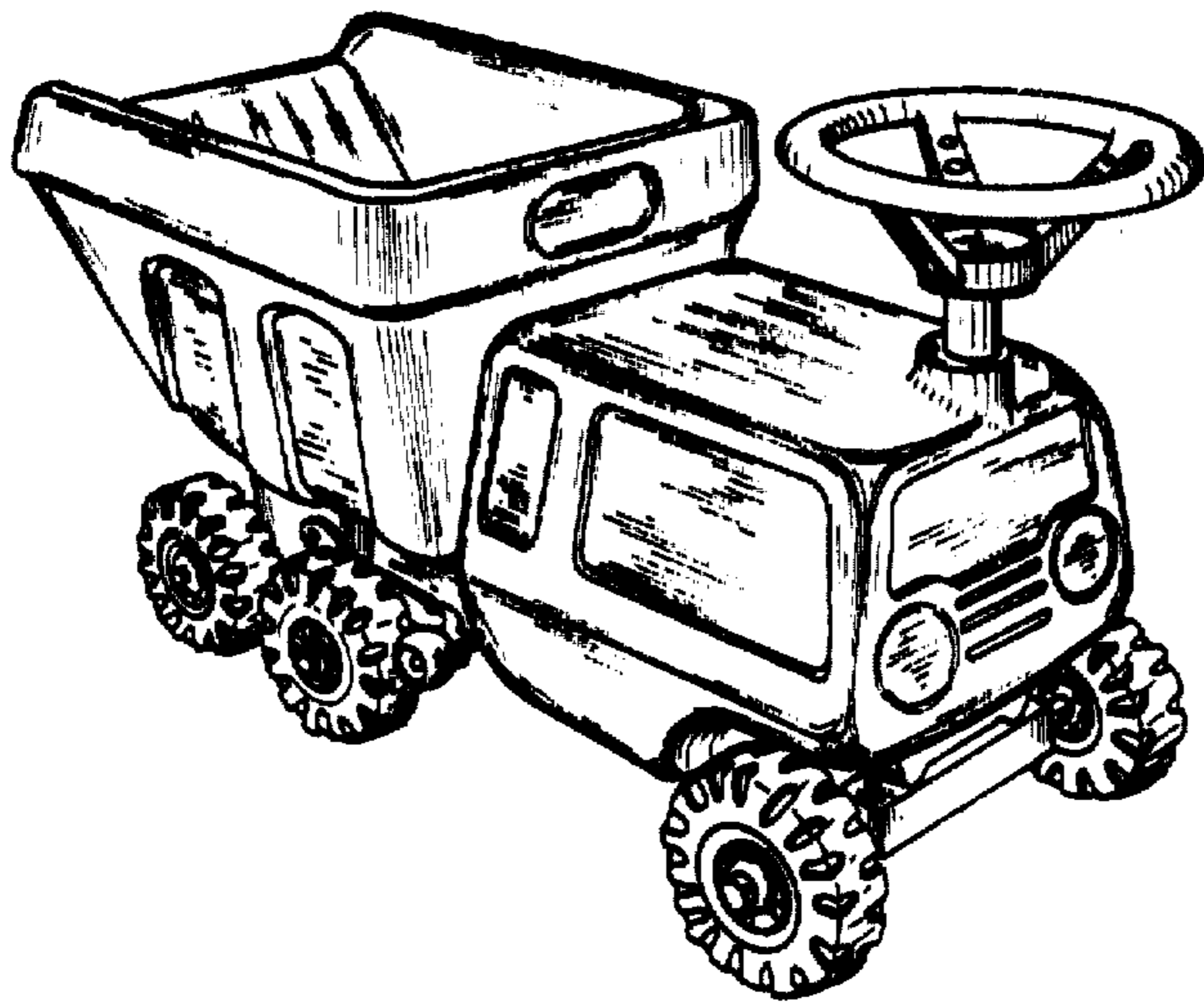

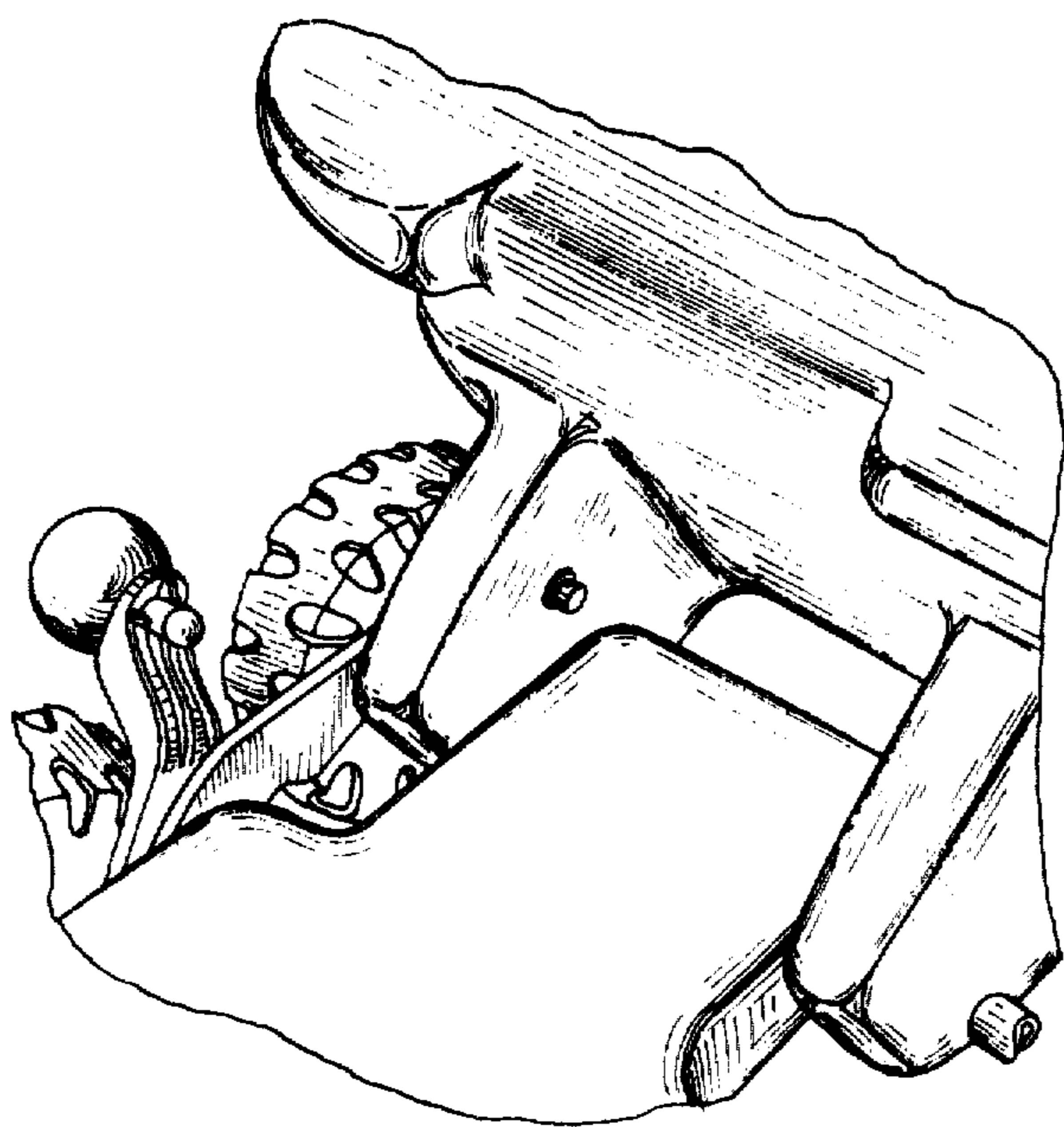
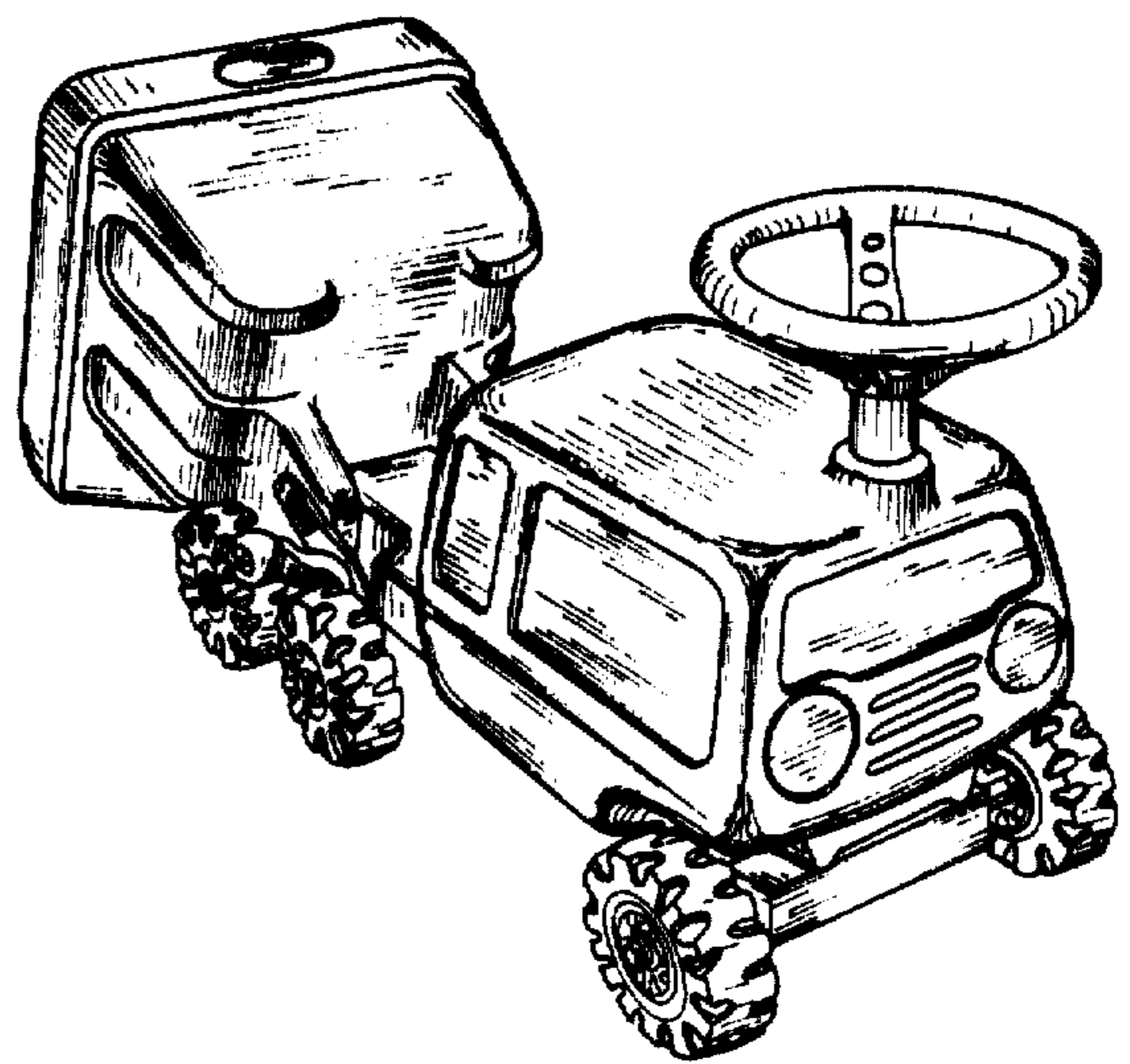

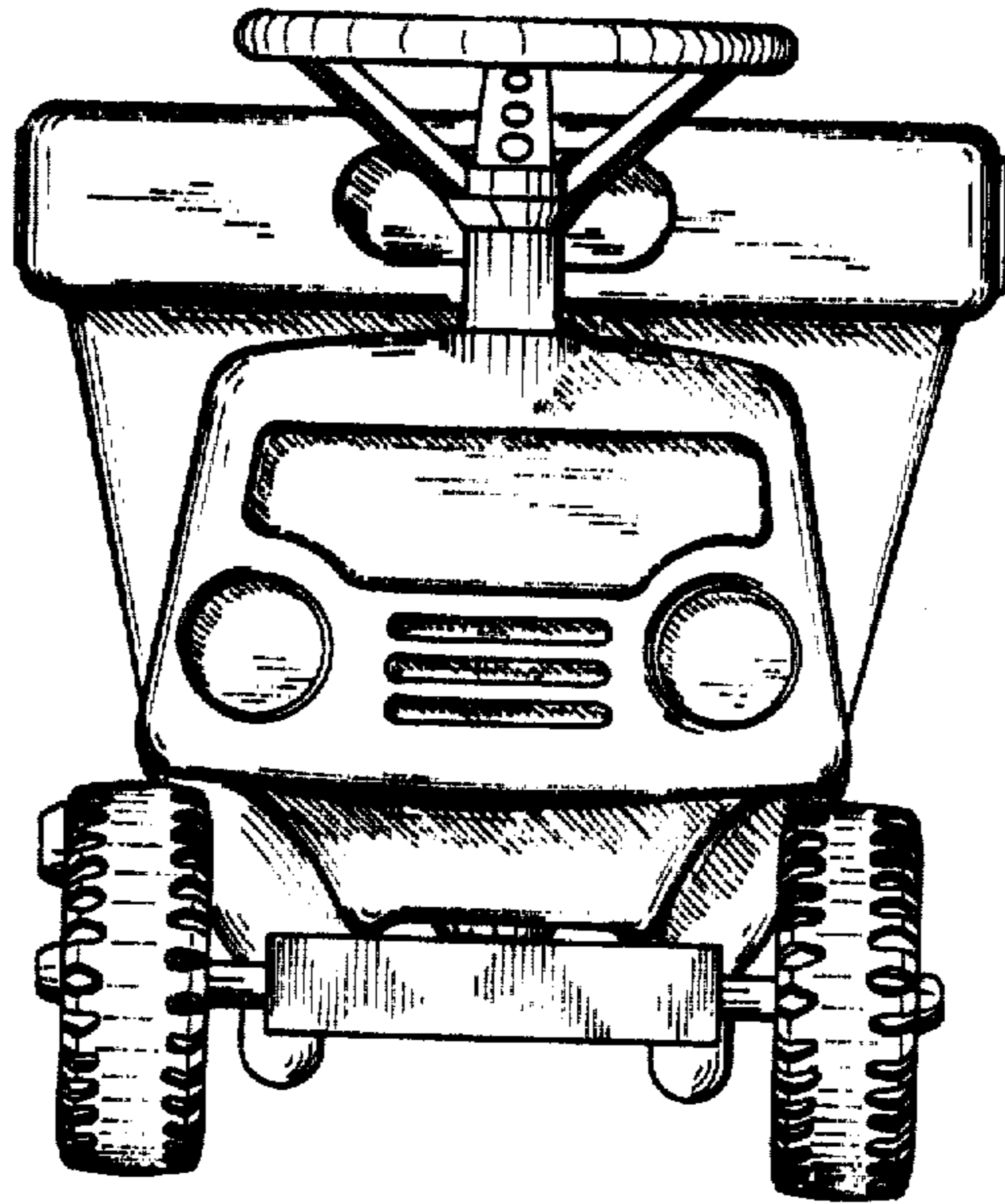

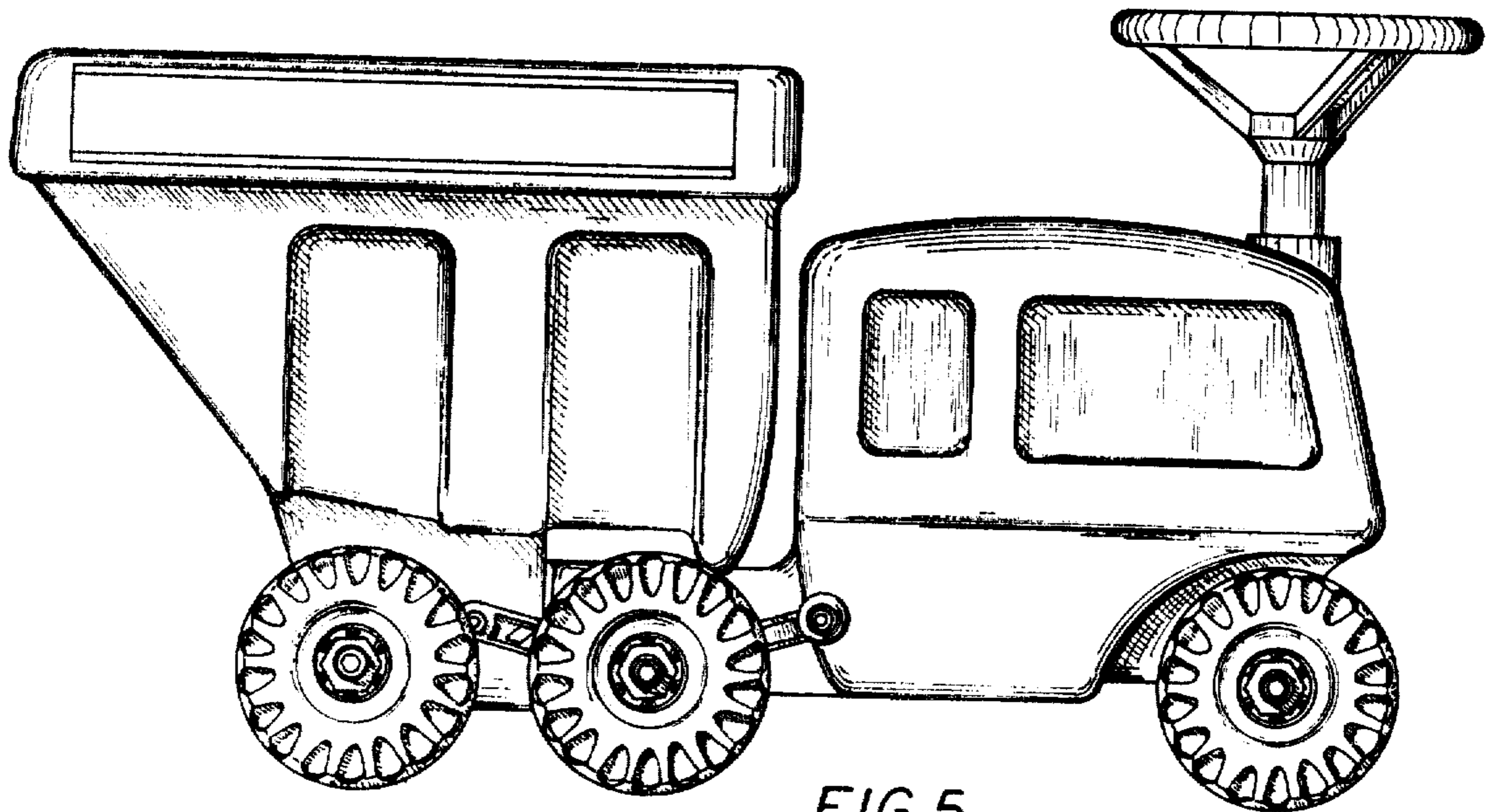

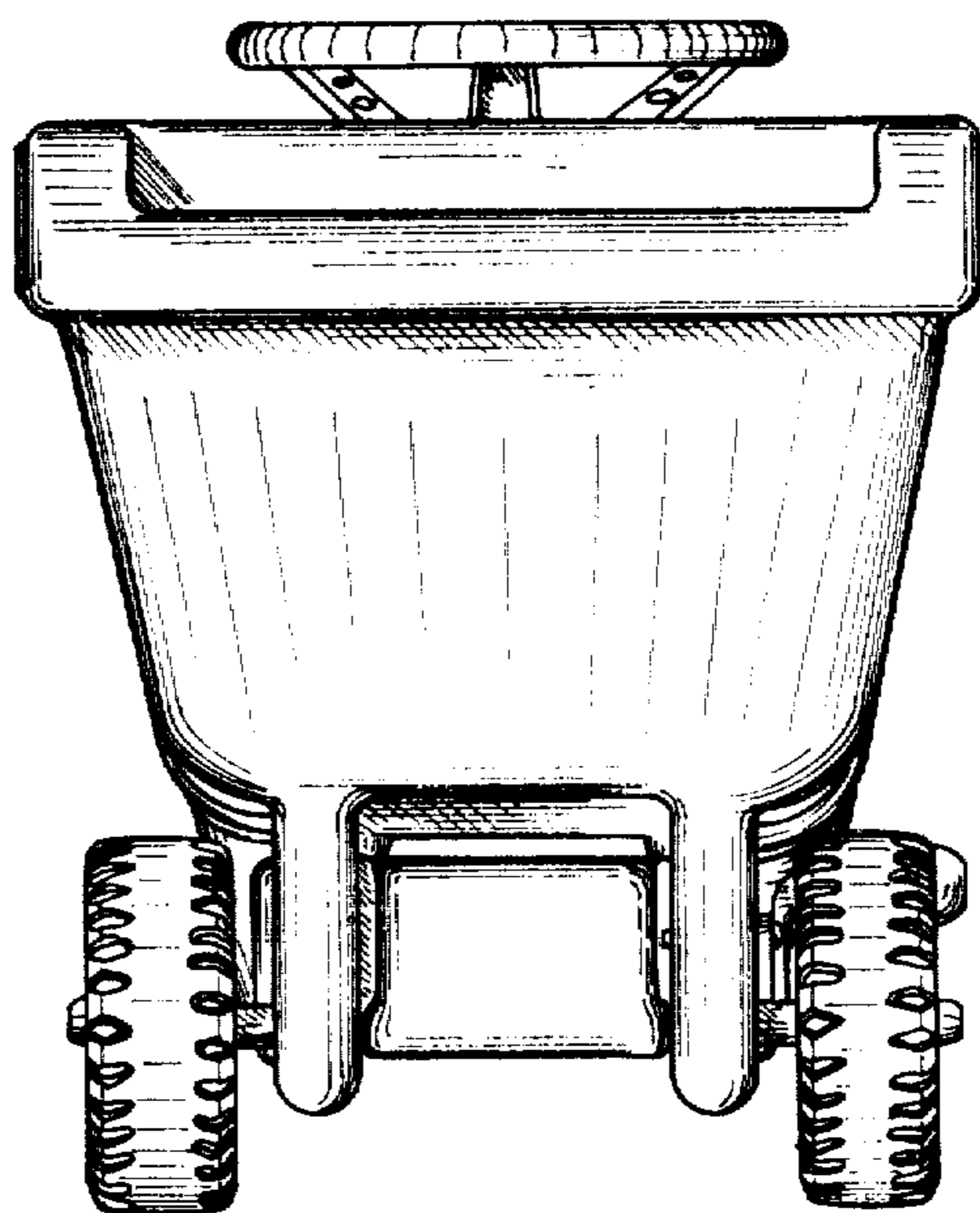

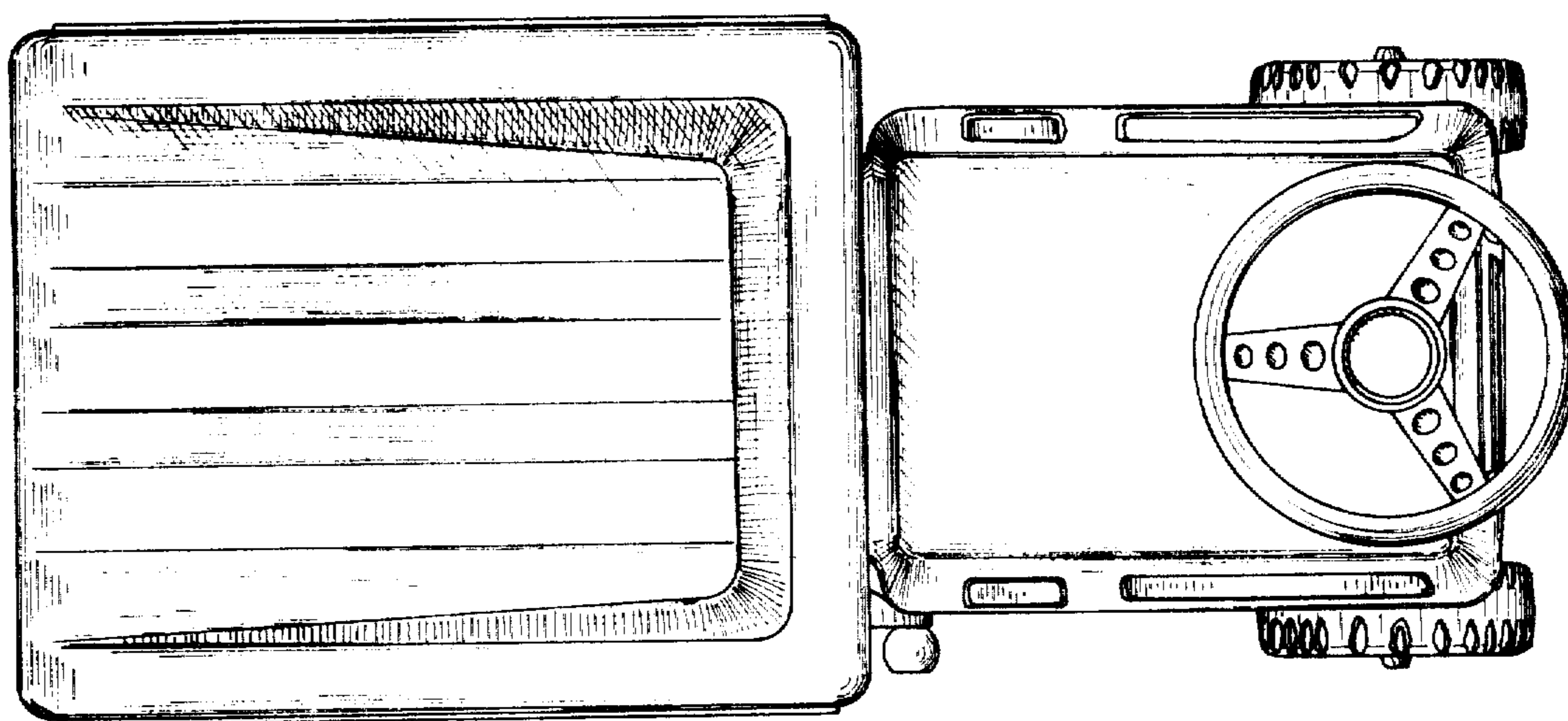

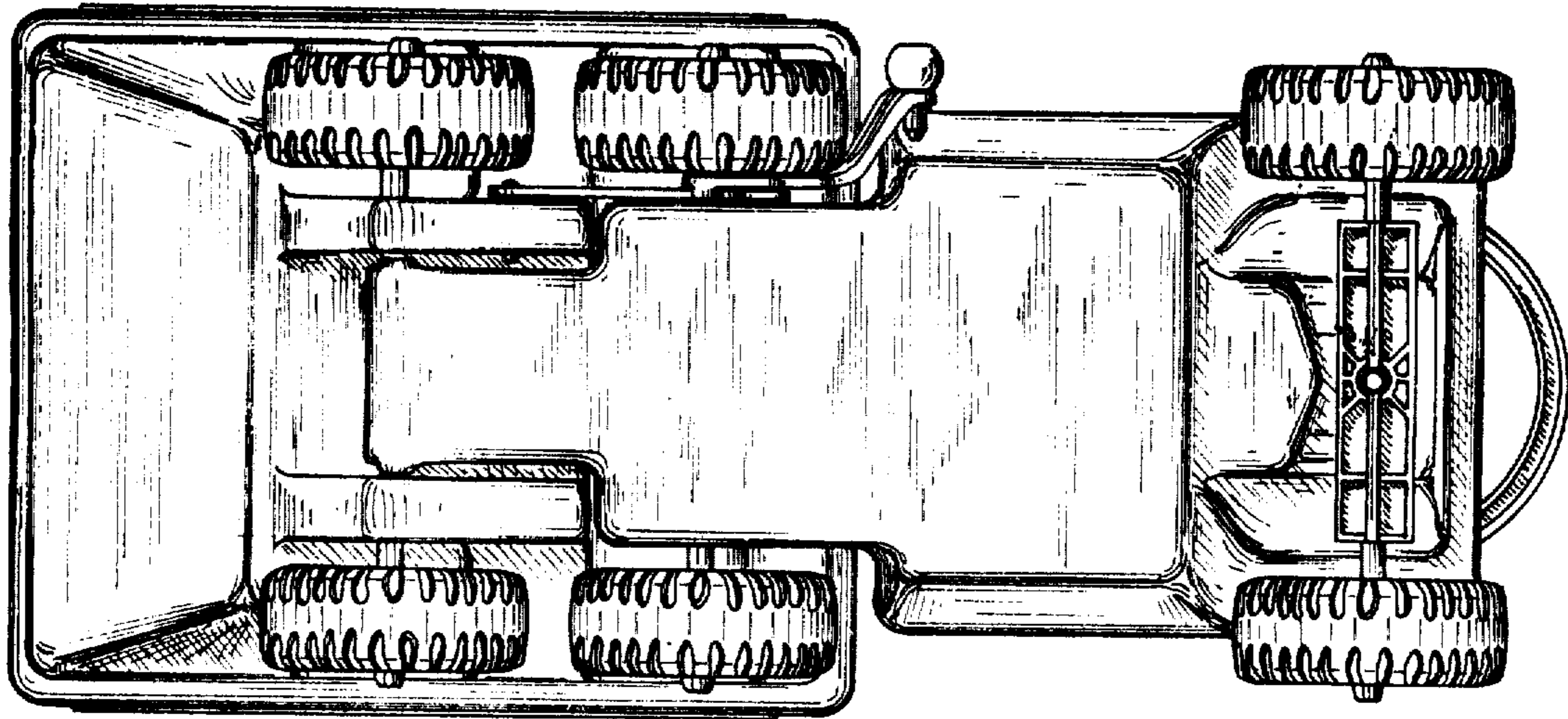

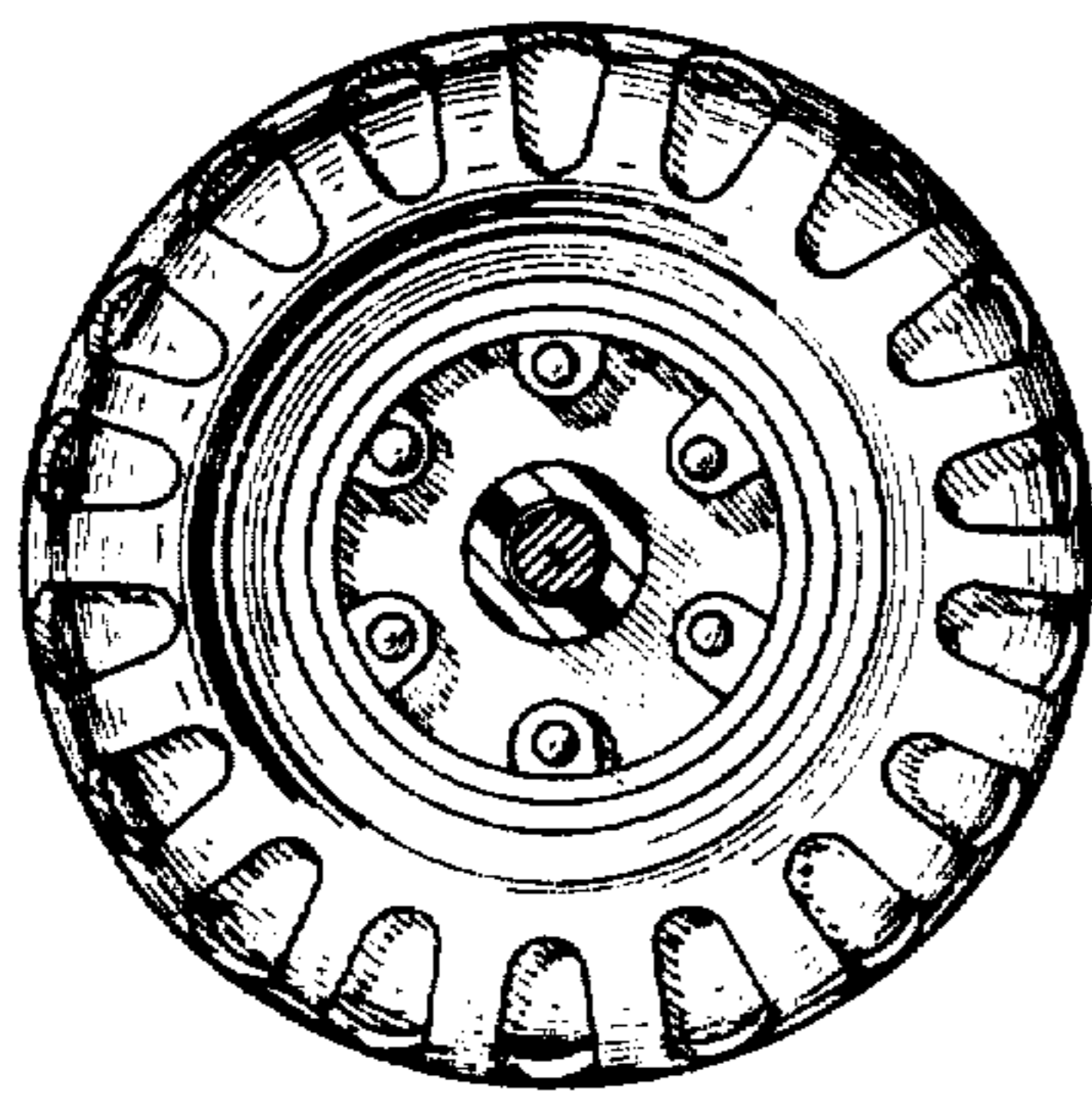

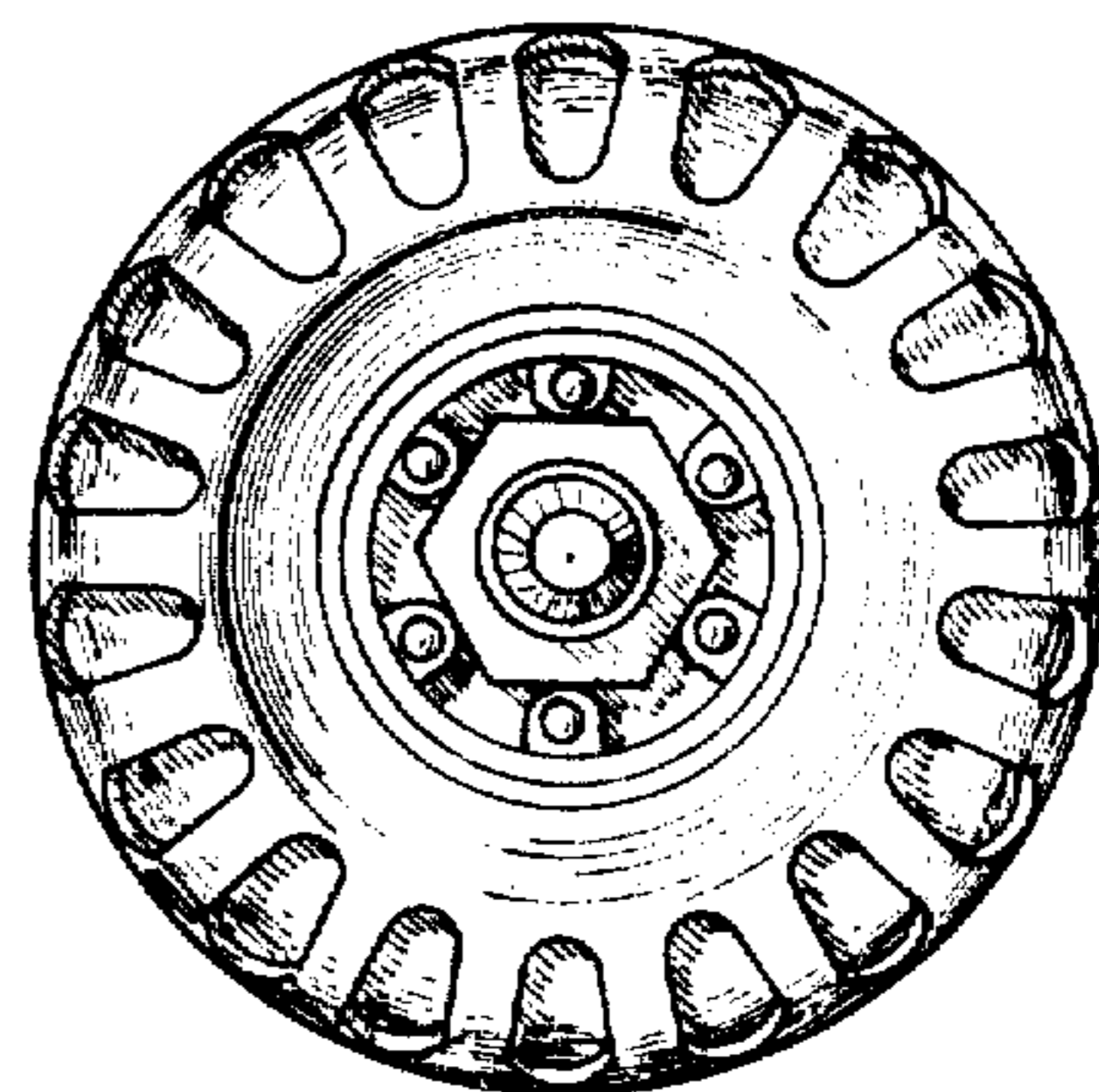

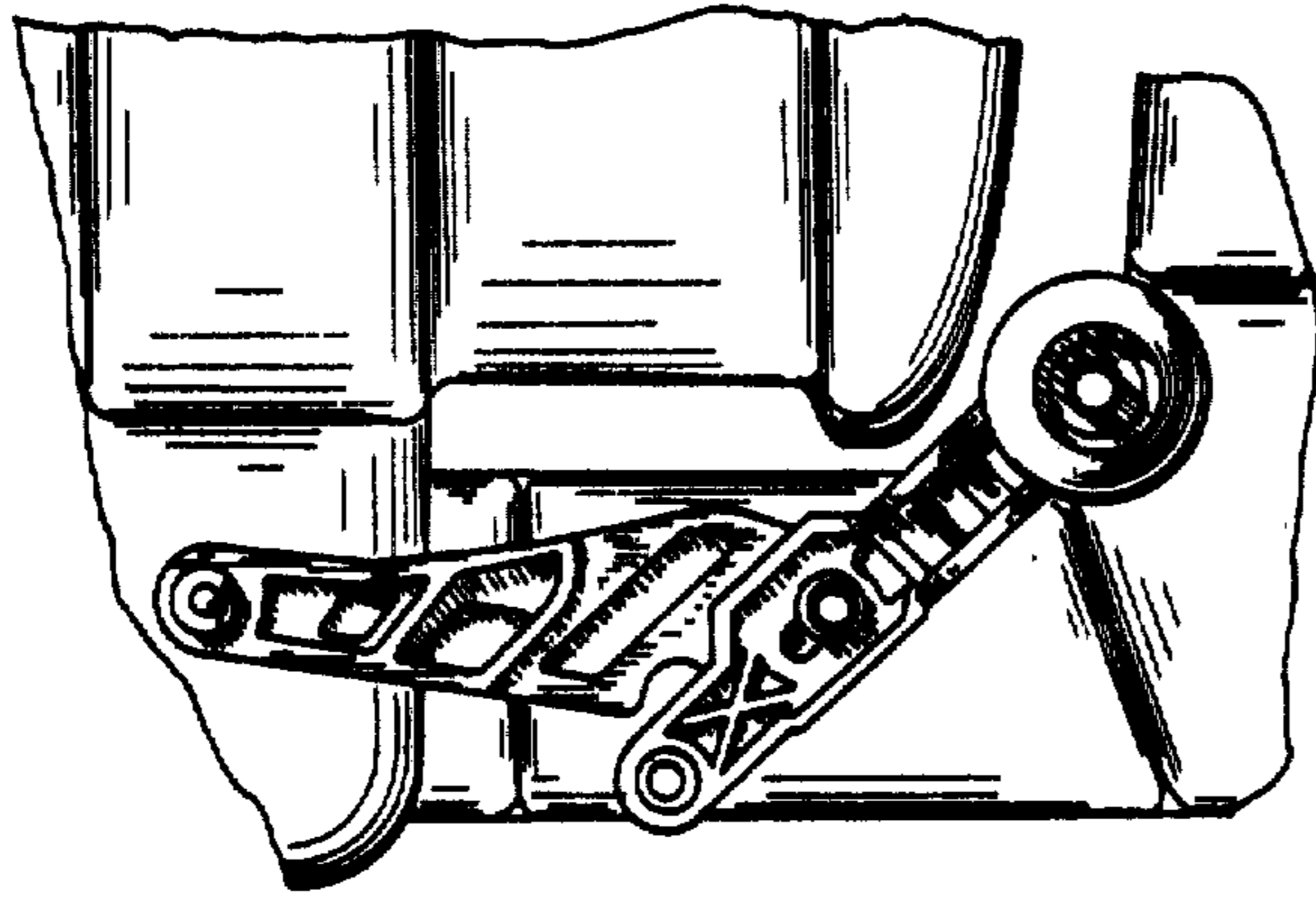

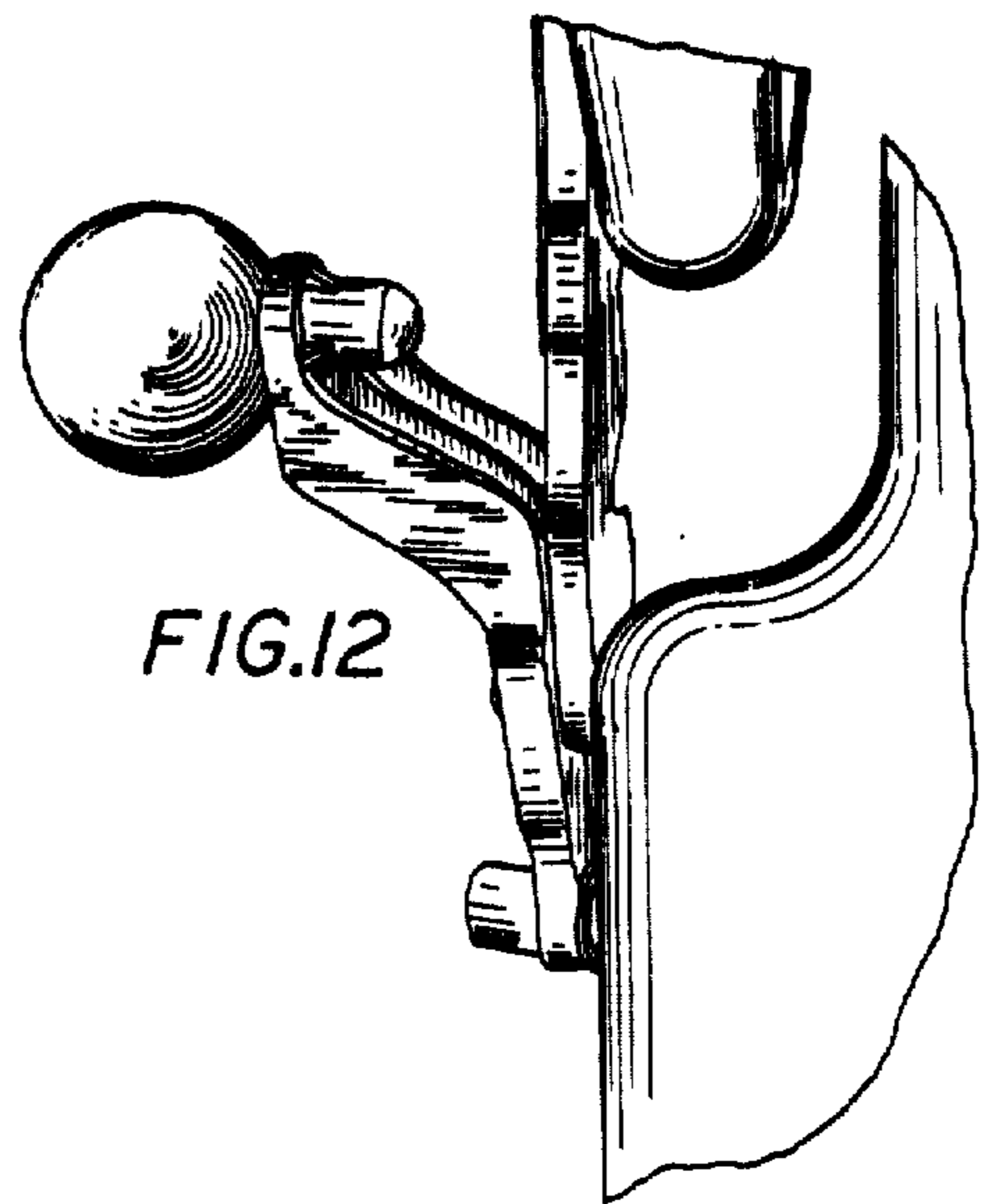

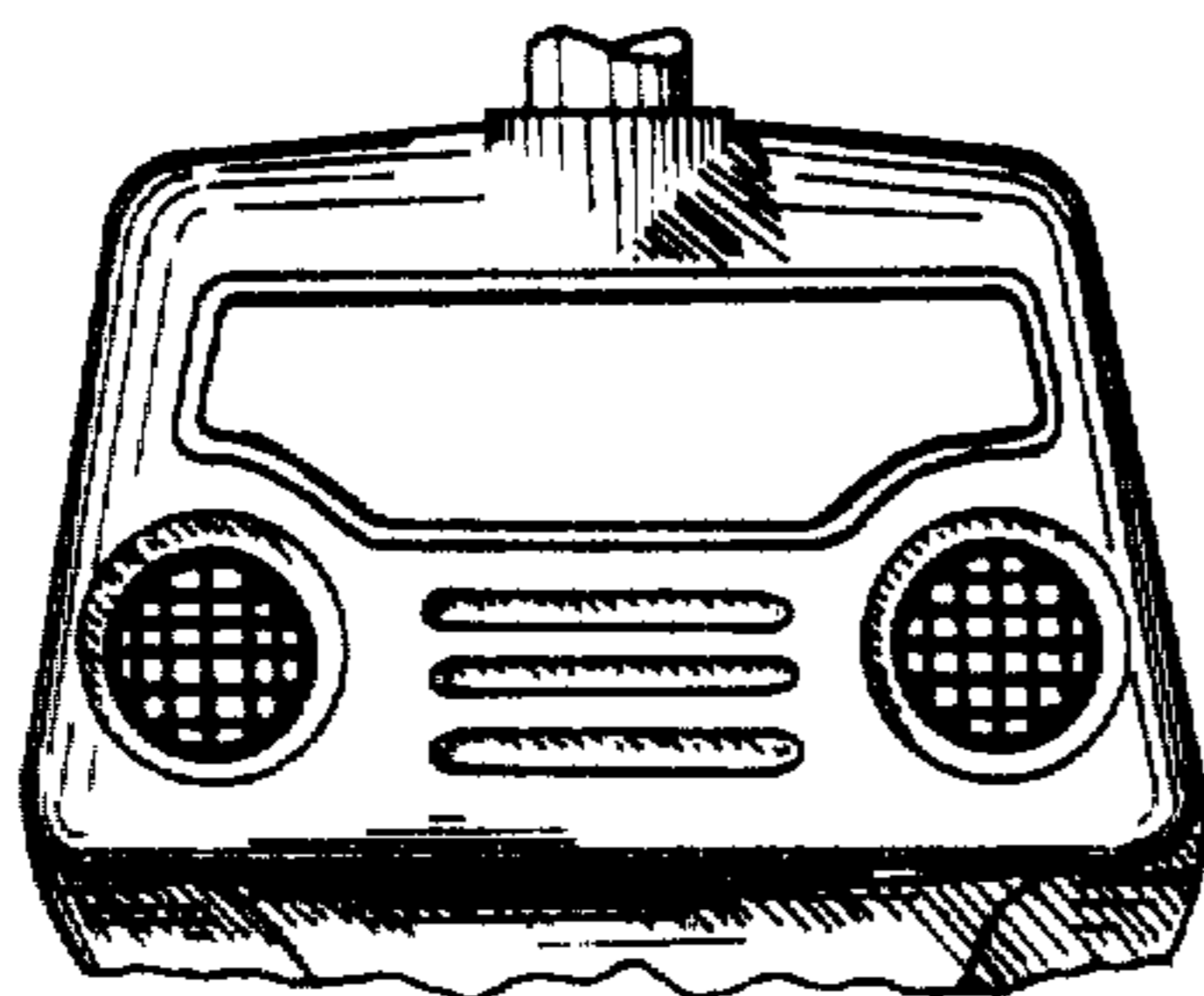

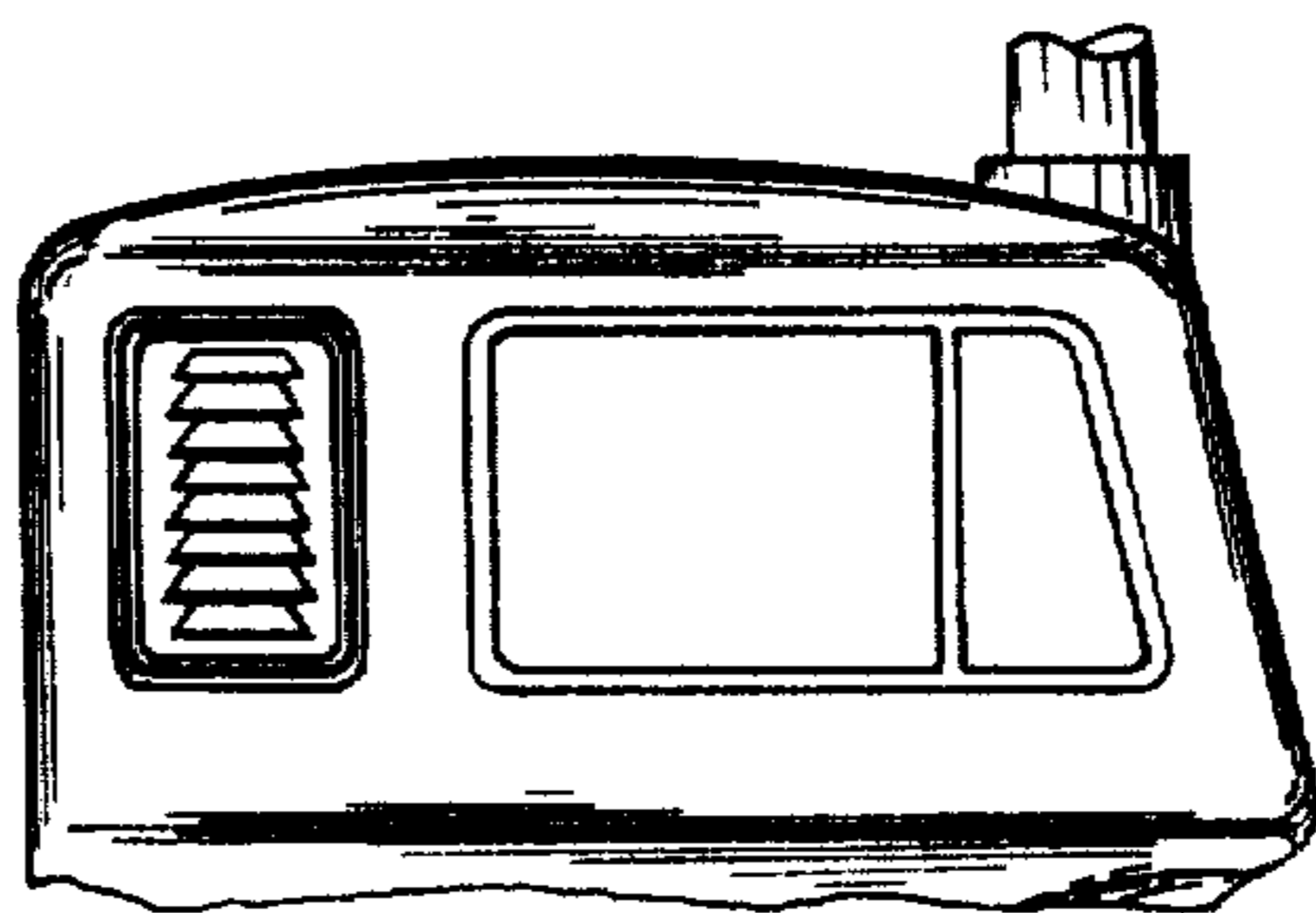
