[57] **CLAIM**

The ornamental design for a linear anastomosis stapler, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a linear anastomosis stapler showing our new design;
 FIG. 2 is a side elevation;
 FIG. 3 is an elevation as seen from the left of FIG. 2;
 FIG. 4 is an elevation as seen from the side opposite FIG. 2;
 FIG. 5 is a bottom plan view; and
 FIG. 6 is an elevation as seen from the right of FIG. 2.

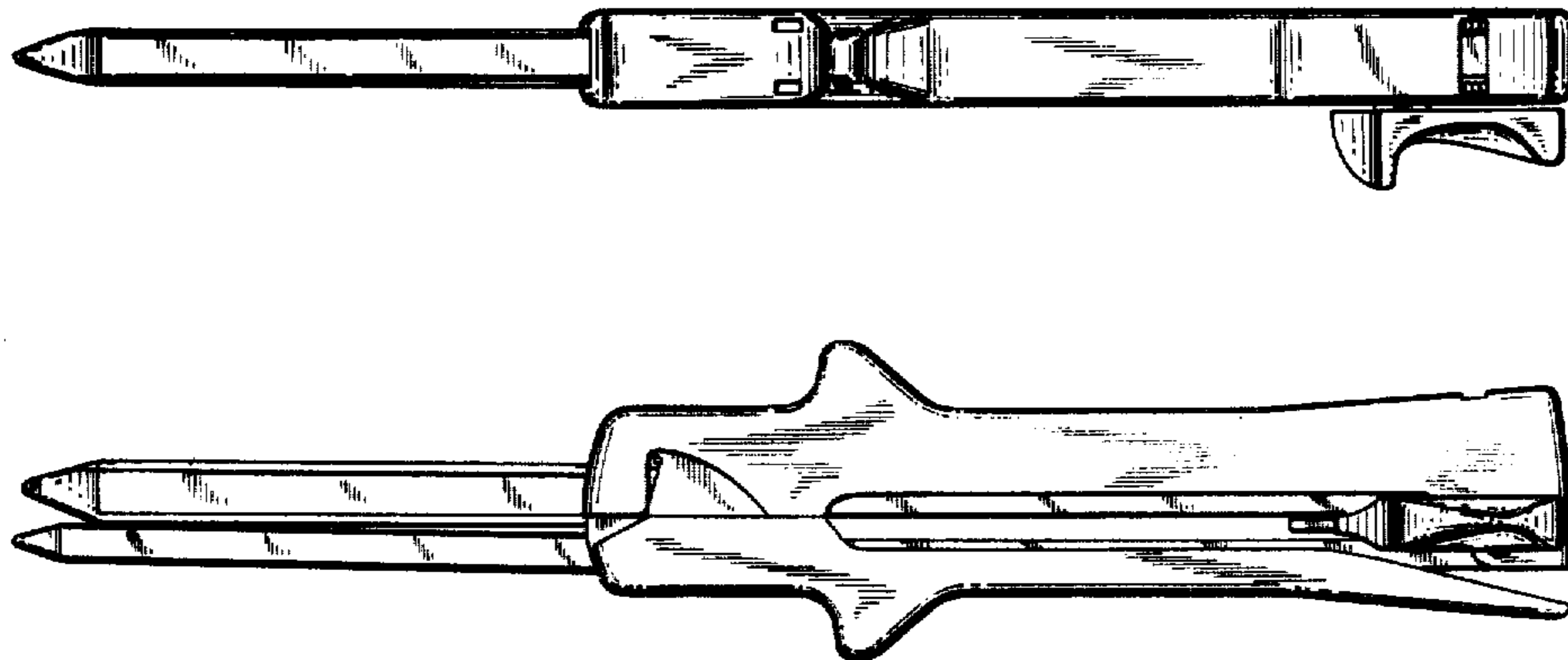

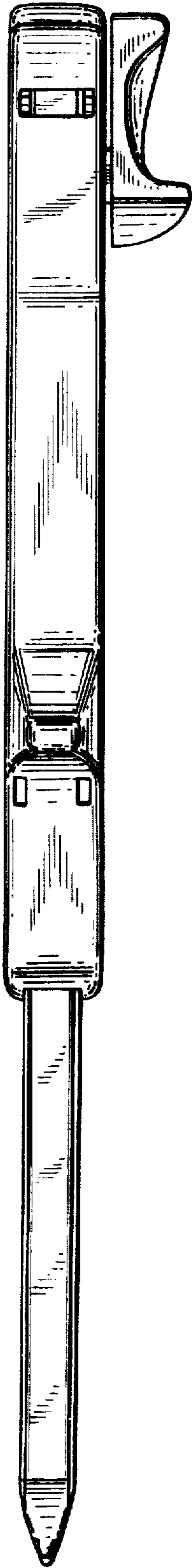

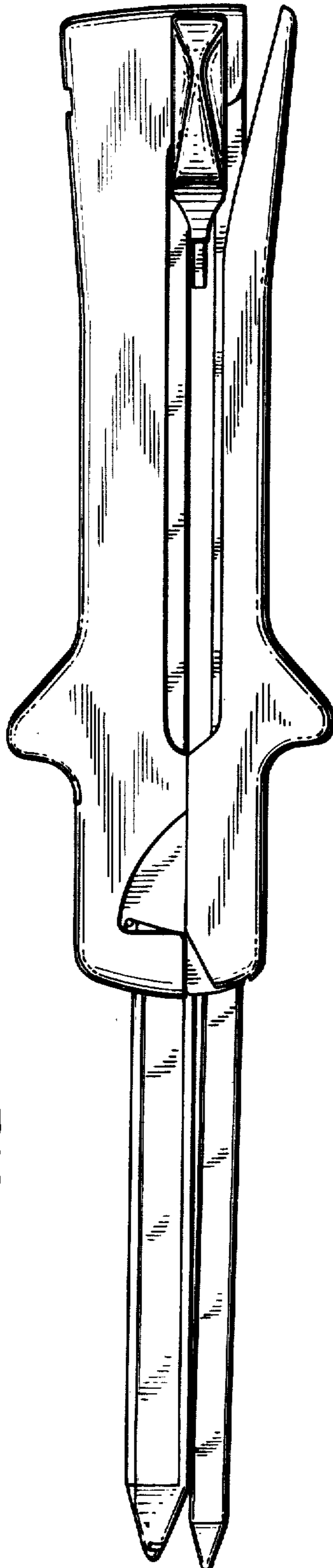

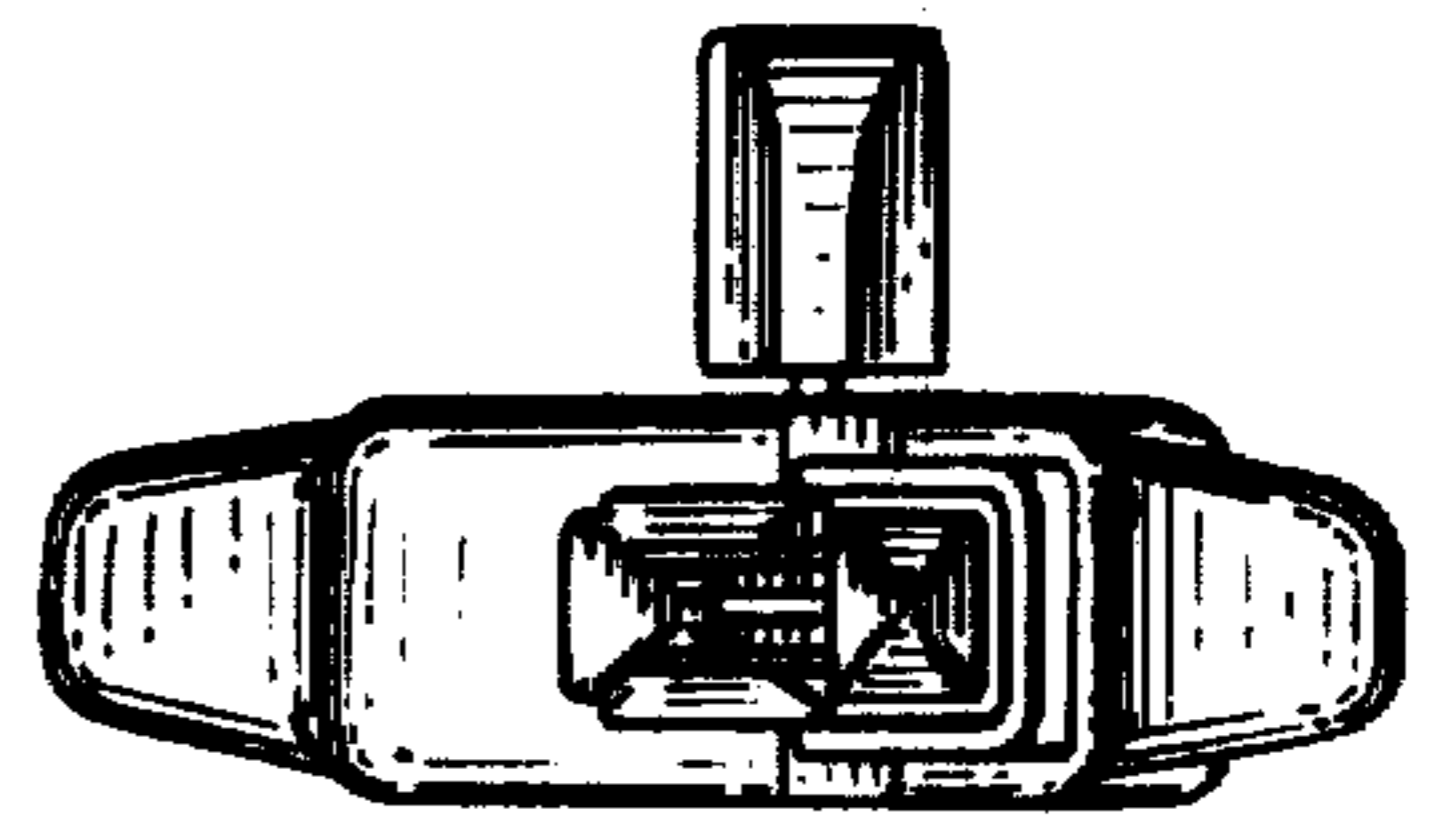

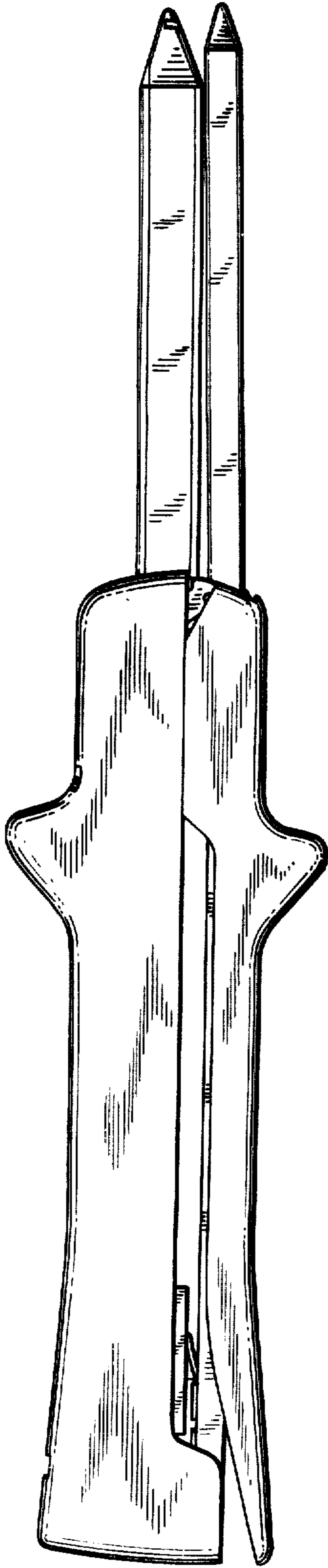

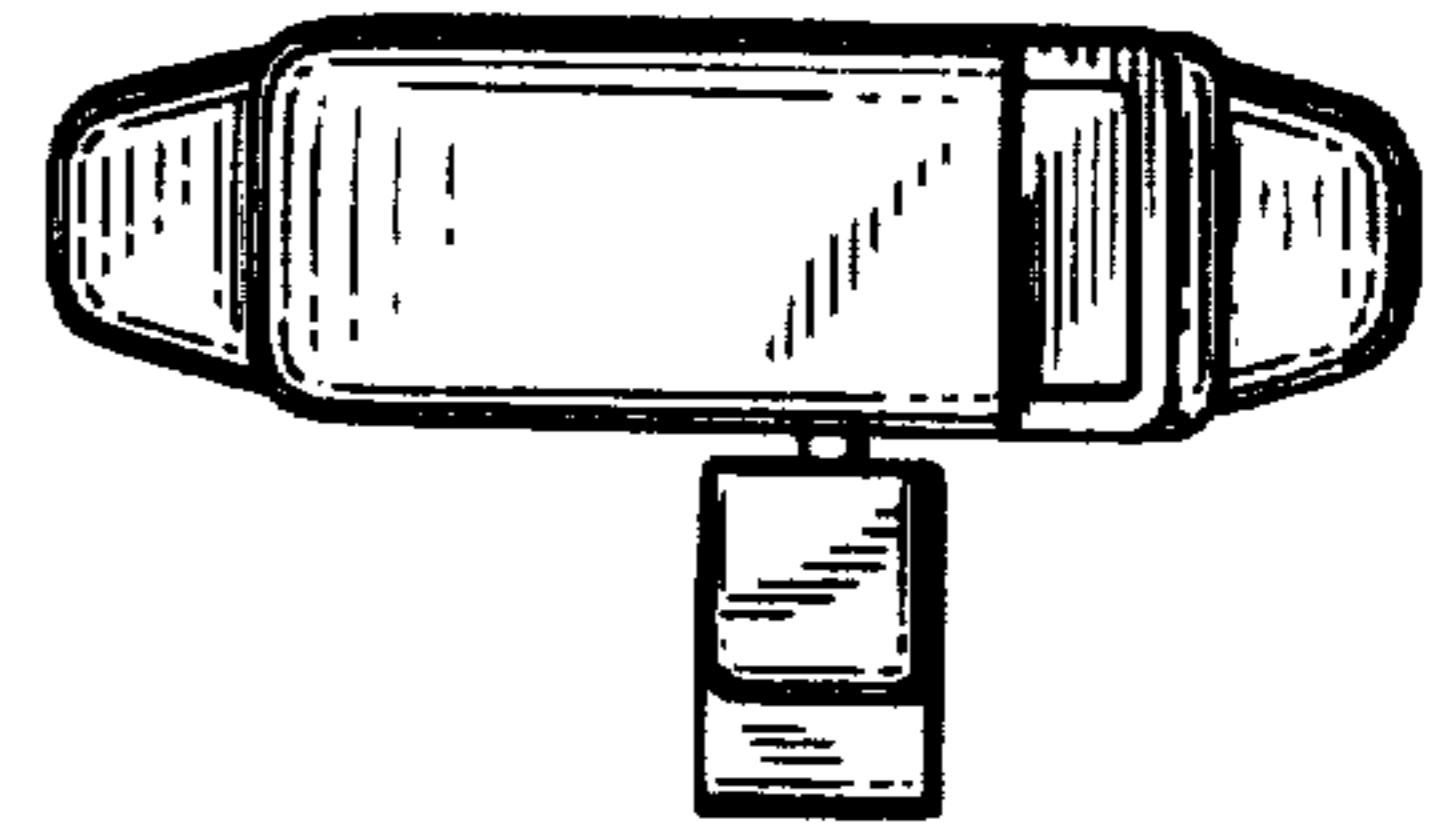
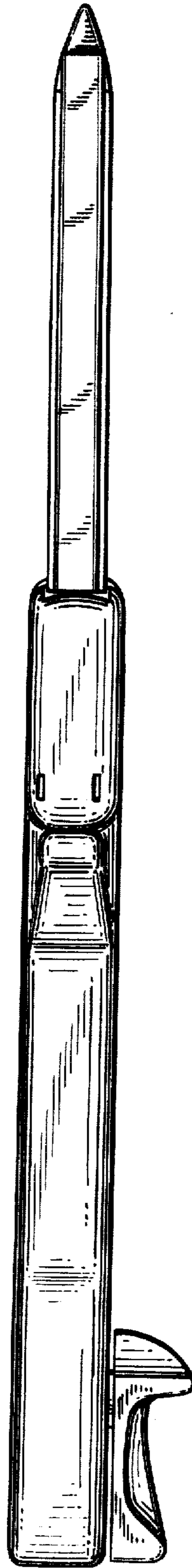
