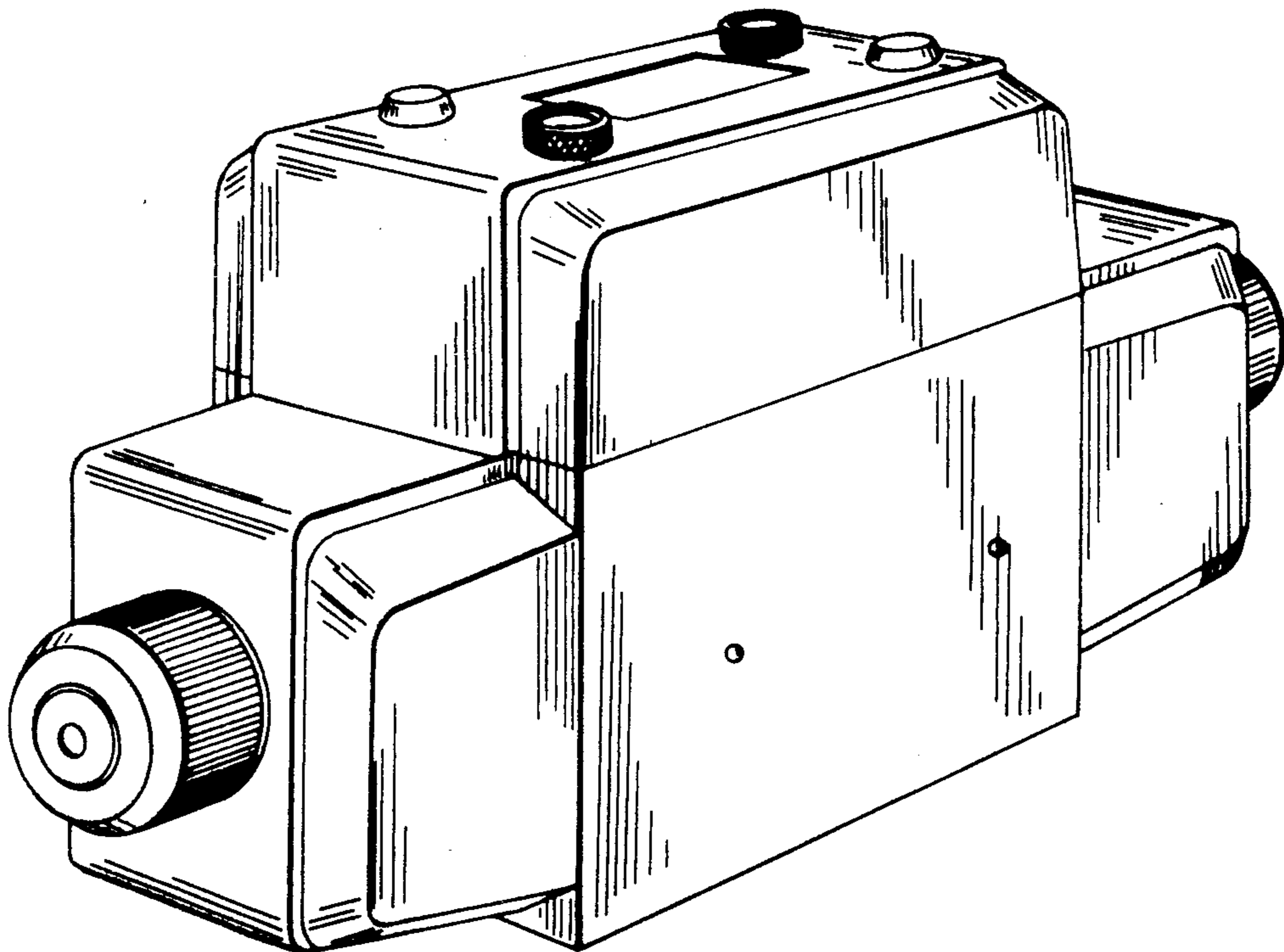

[57] **CLAIM**

The ornamental design for a solenoid operated valve, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a solenoid operated valve showing our new design;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a bottom plan view thereof;  
 FIG. 4 is a rear elevational view thereof;  
 FIG. 5 is an elevational view taken from one end thereof;  
 FIG. 6 is an elevational view taken from the end opposite that shown in FIG. 5.  
 FIG. 7 is a perspective view taken from the top, front and one end thereon;  
 FIG. 8 is a top plan view of a modified form of the solenoid operated valve shown in FIG. 1;  
 FIG. 9 is a front elevational view of FIG. 8;  
 FIG. 10 is a bottom plan view of FIG. 8;  
 FIG. 11 is a rear elevational view of FIG. 8;  
 FIG. 12 is an elevational view taken from one end of FIG. 8; and  
 FIG. 13 is an elevational view taken from one end of FIG. 8.



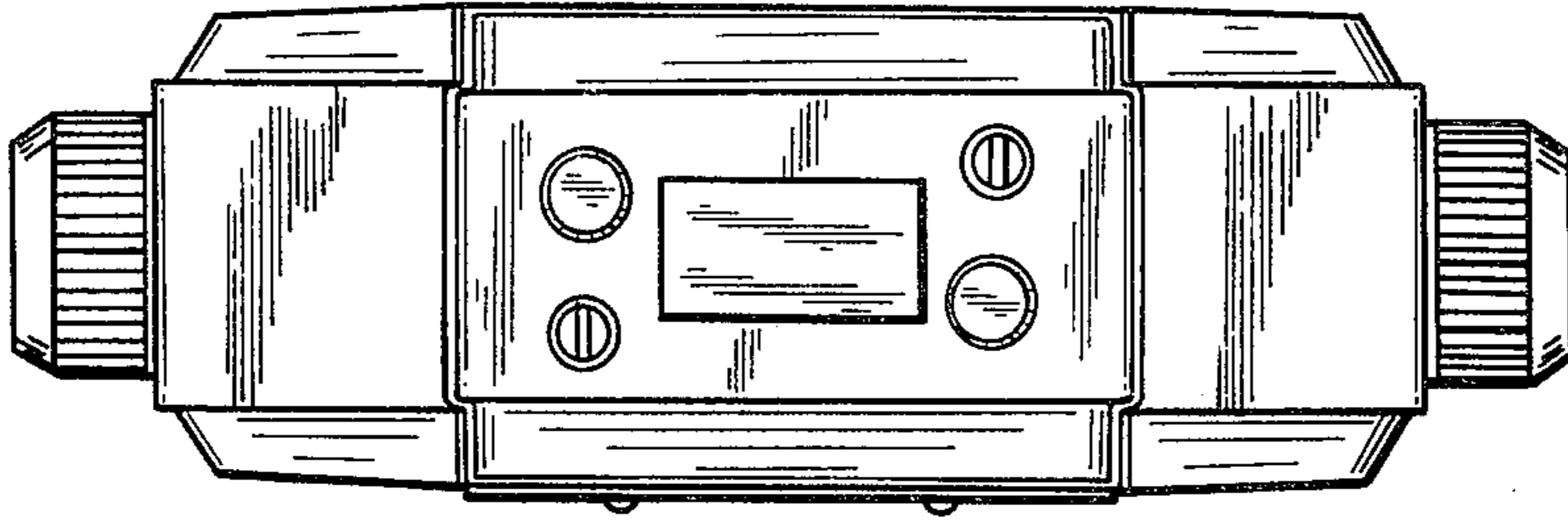

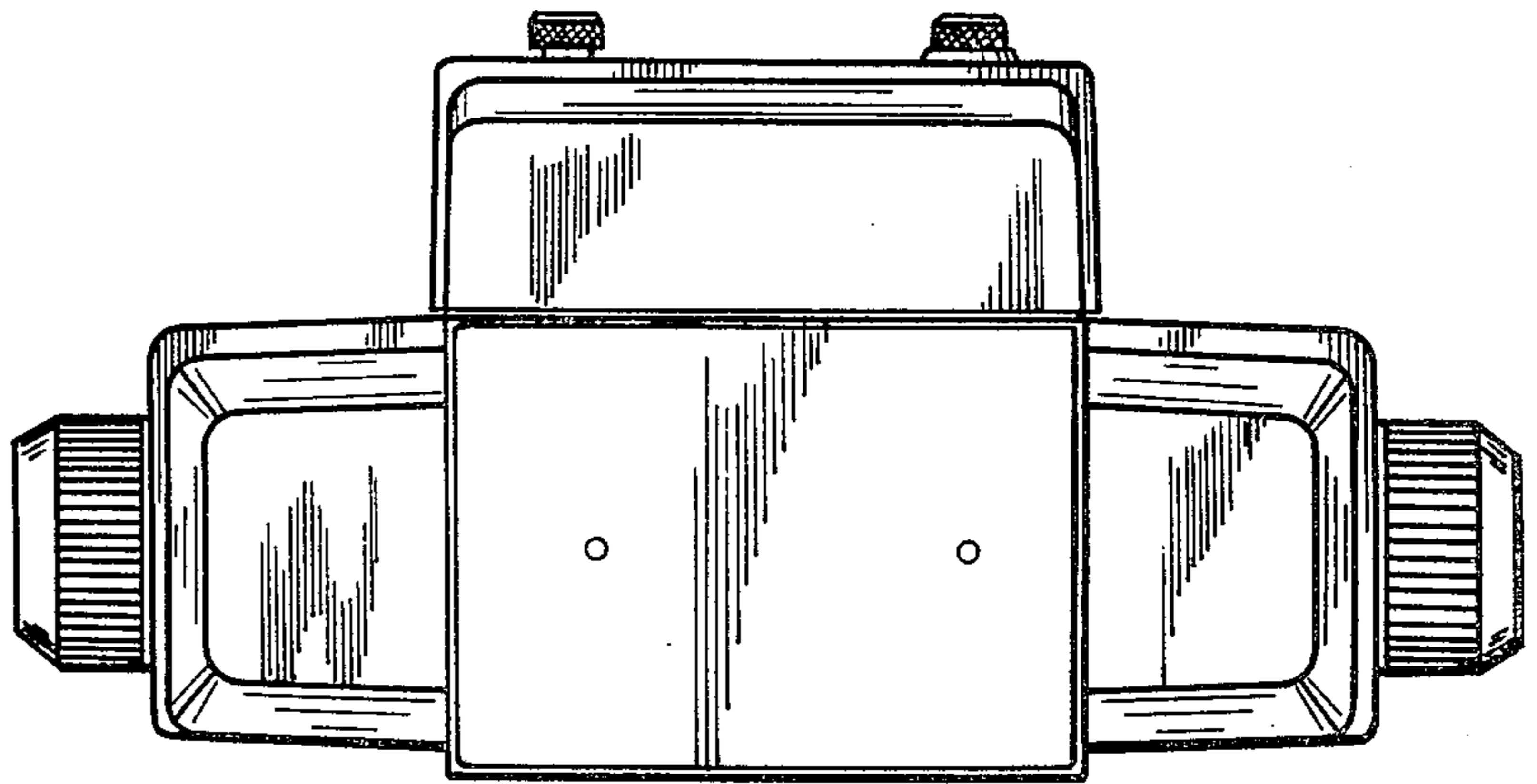

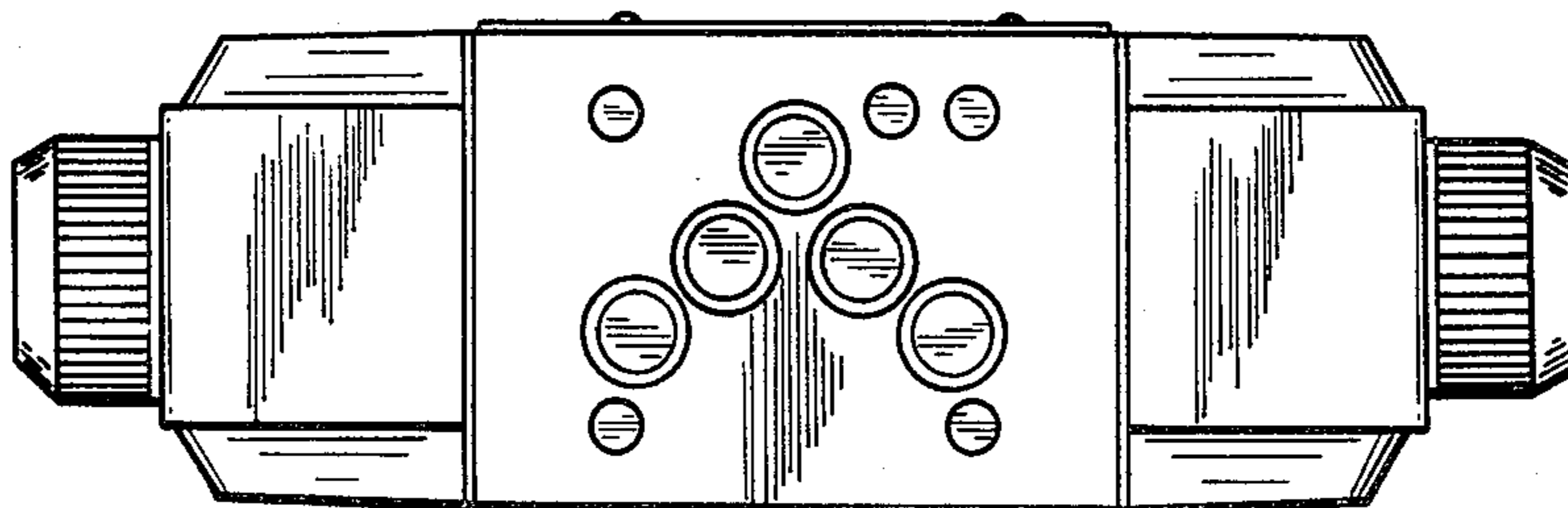

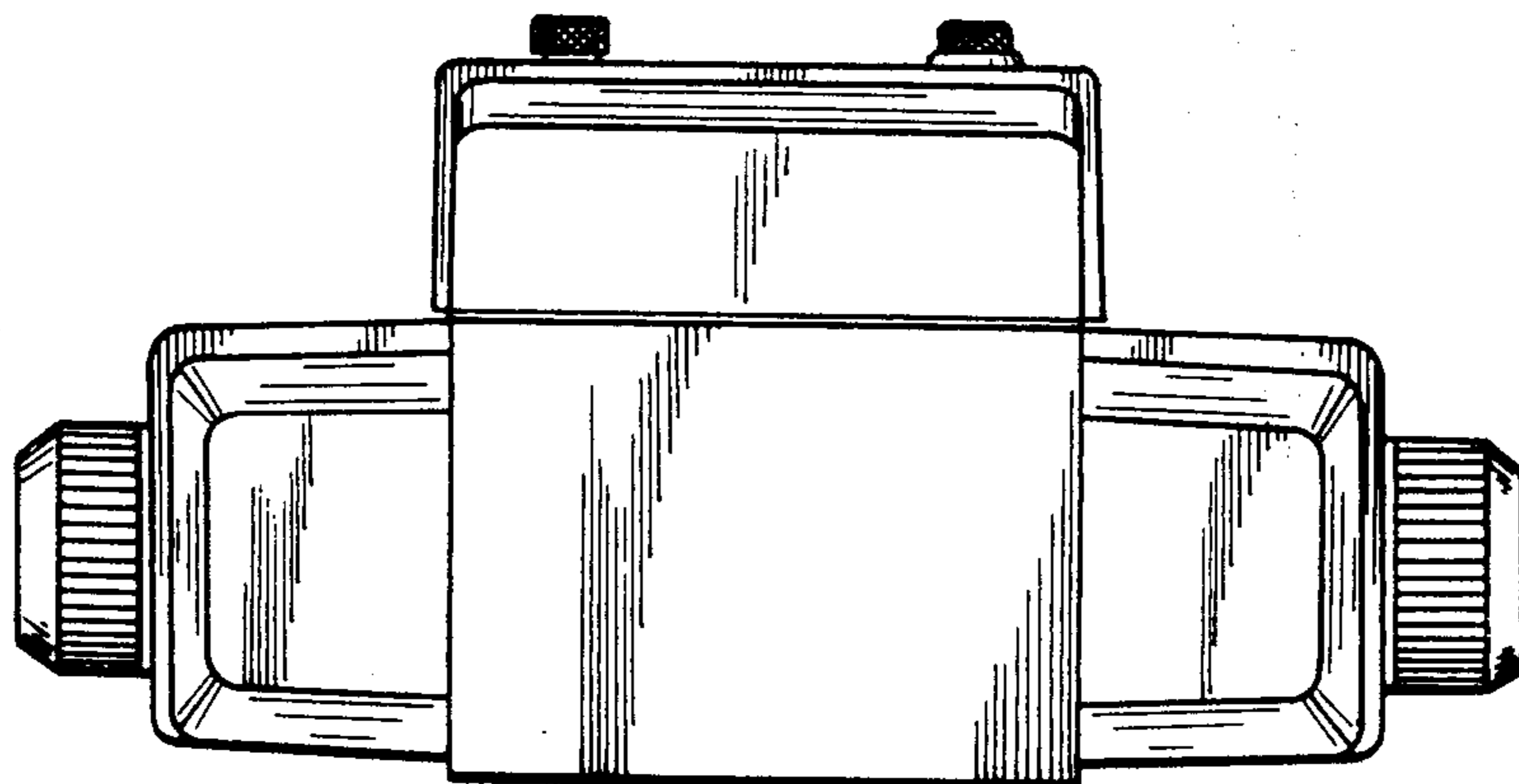

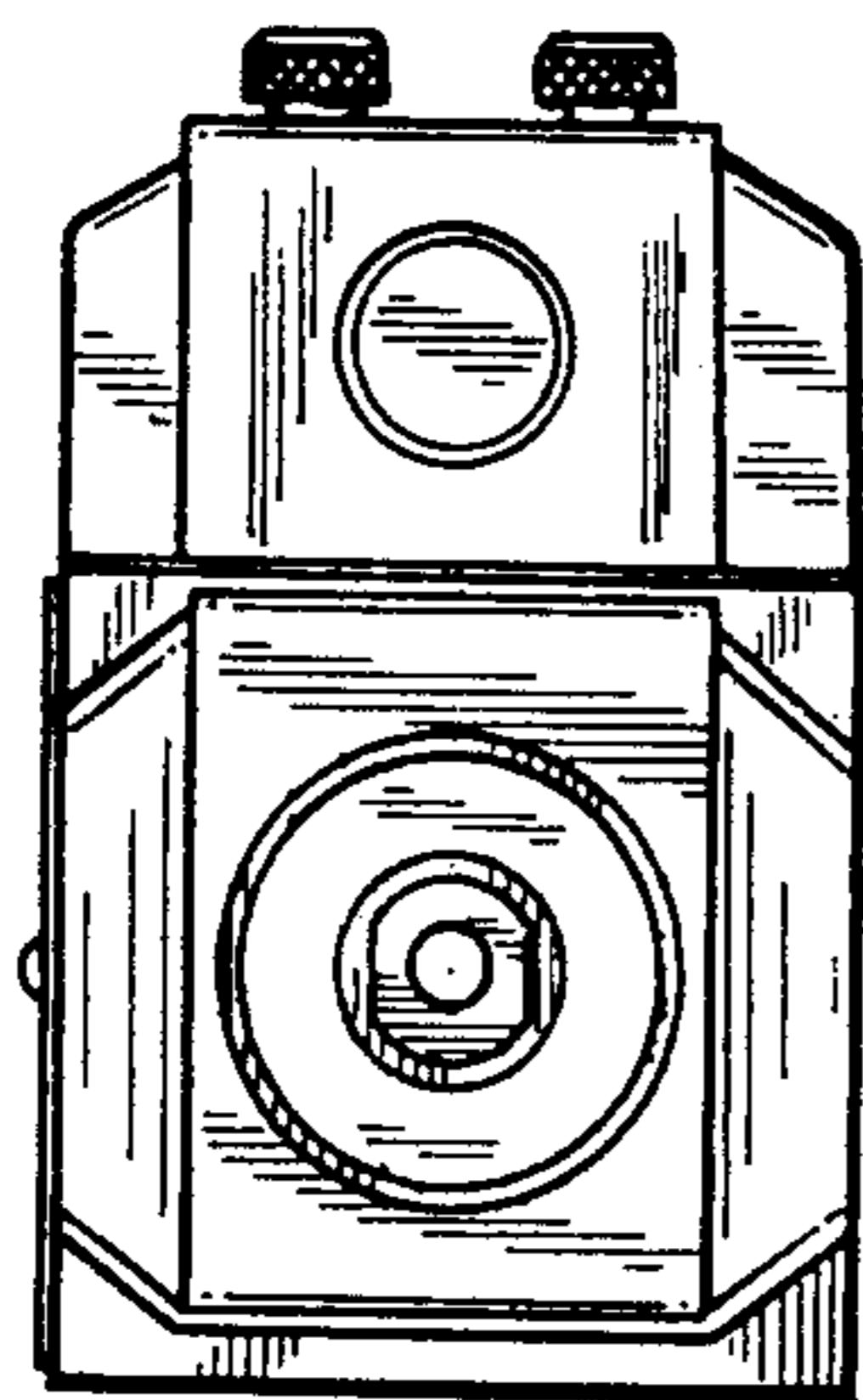

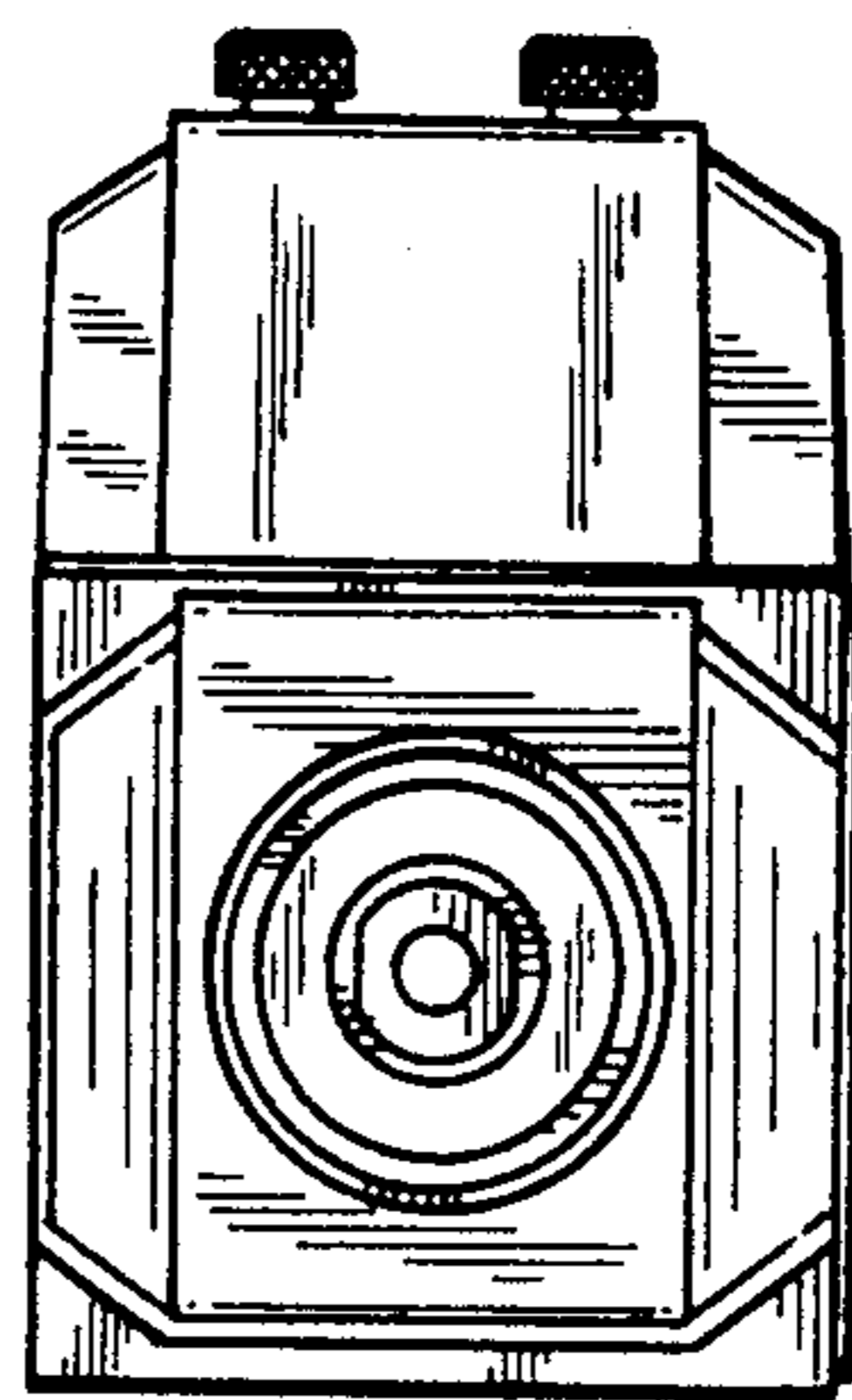
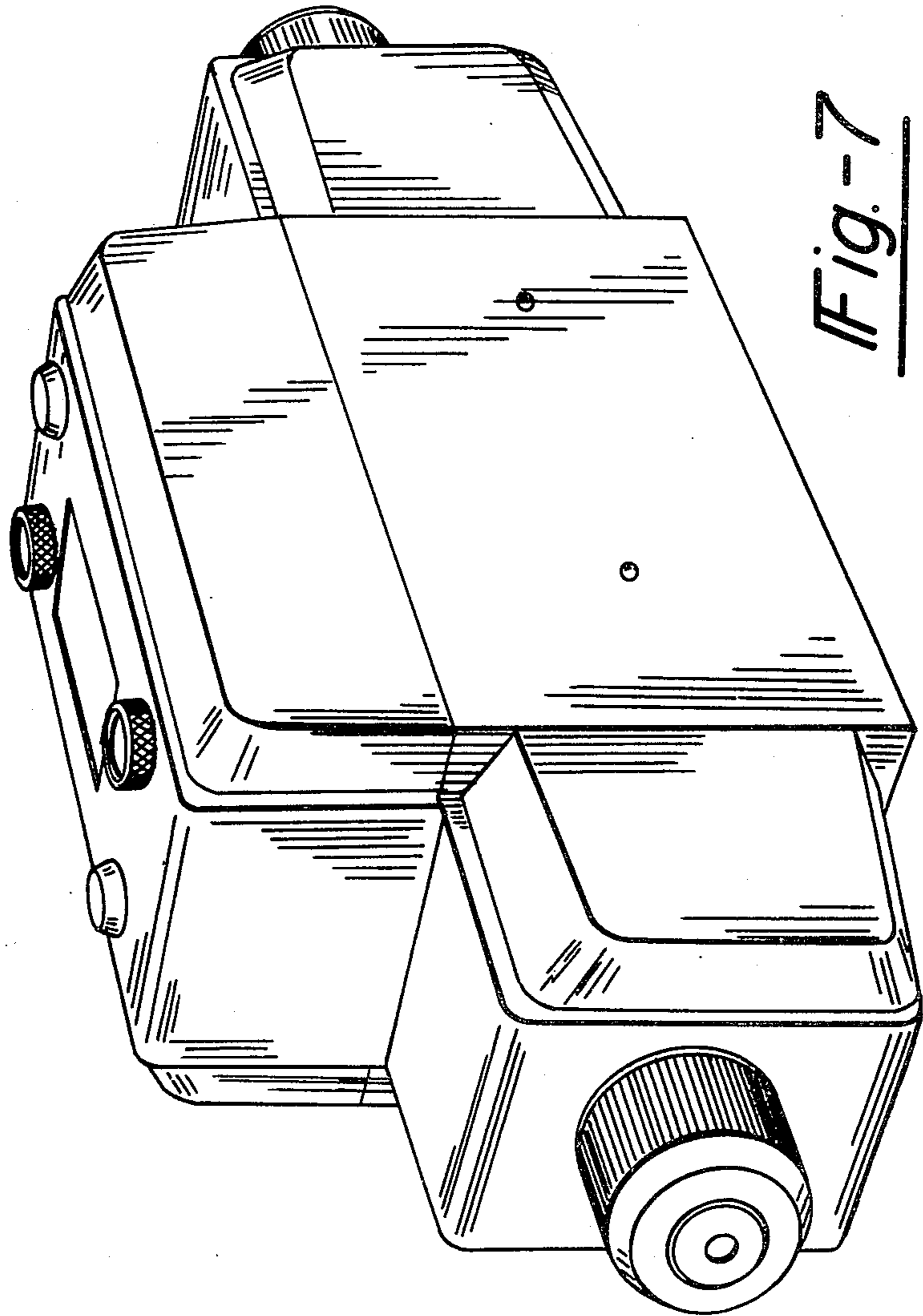

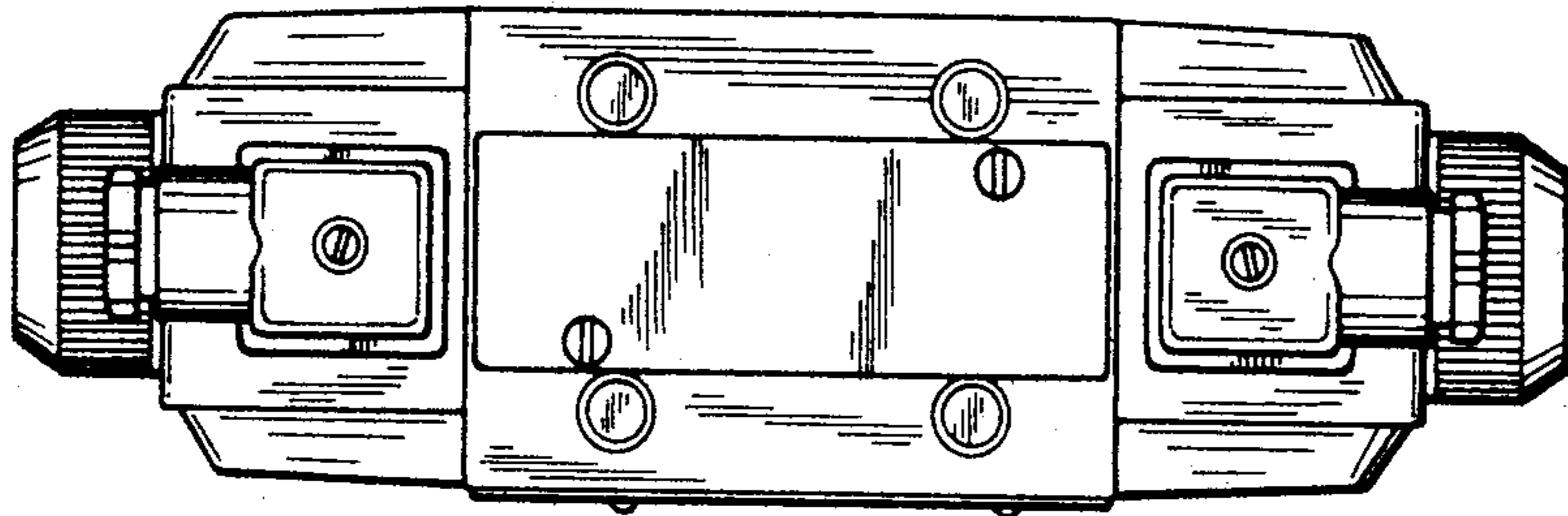

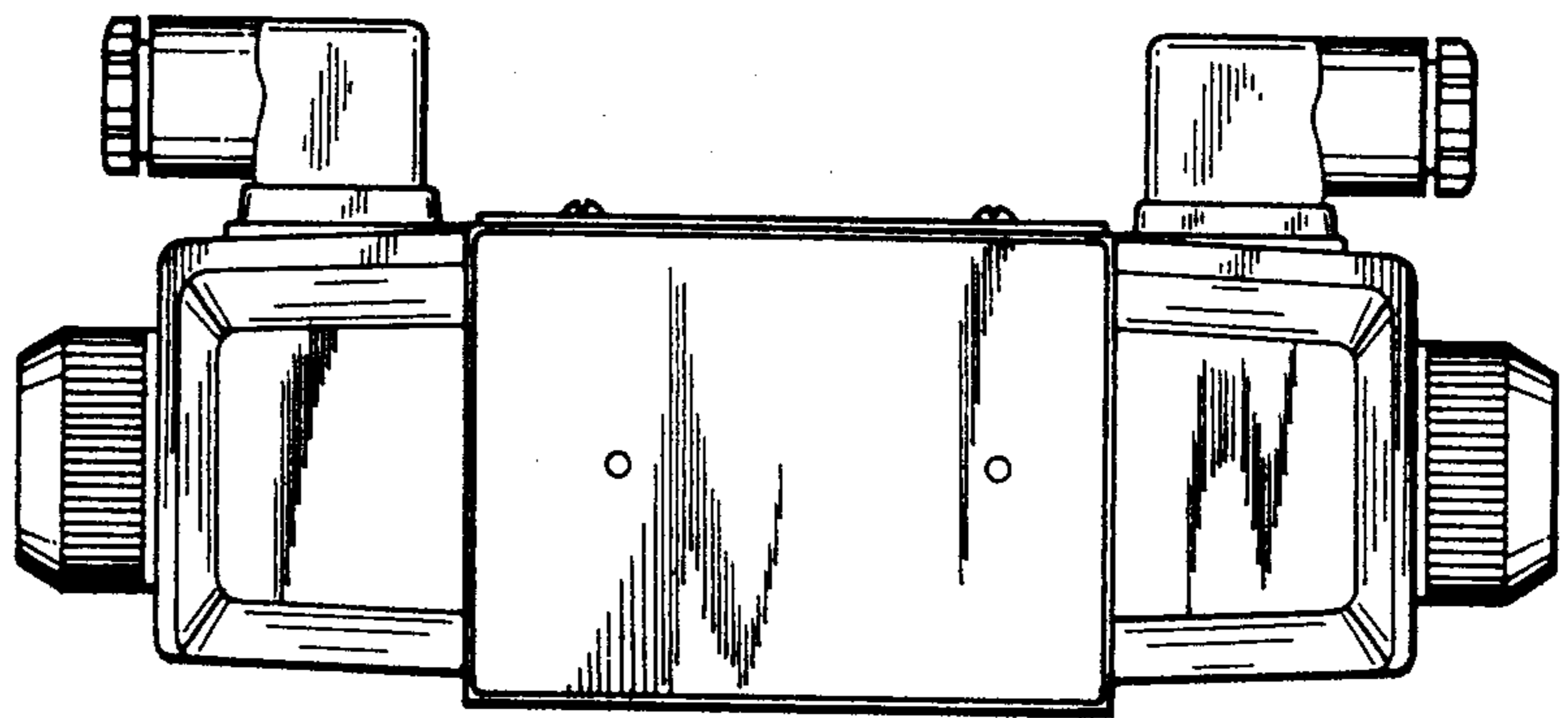

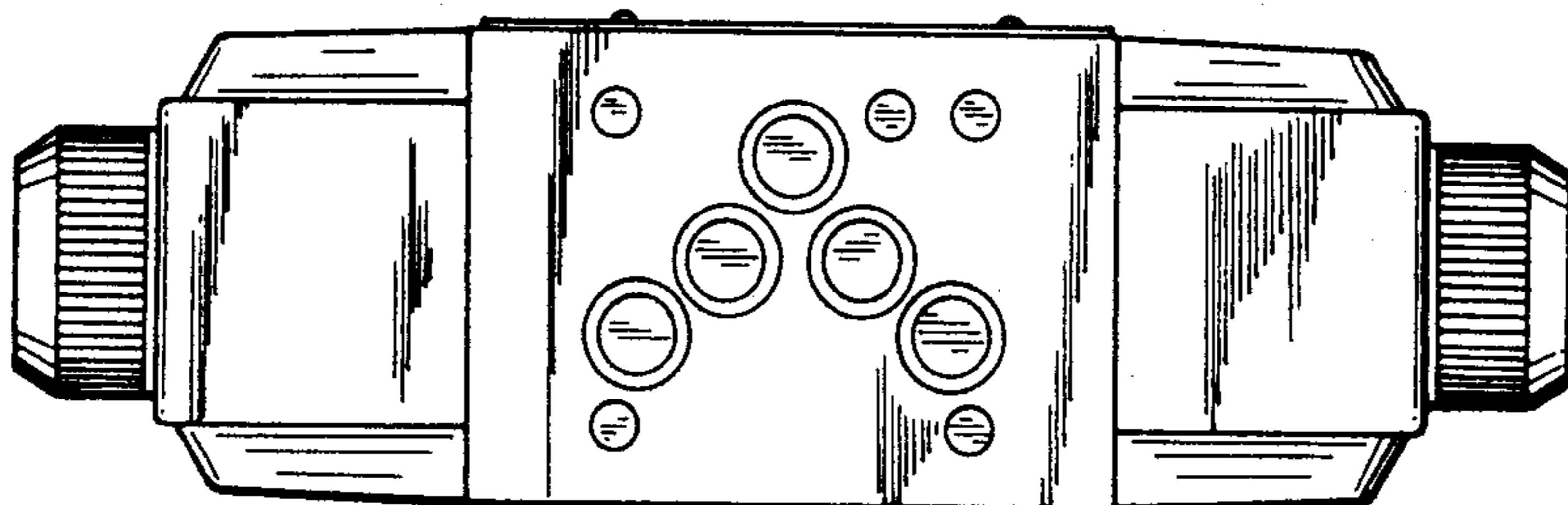

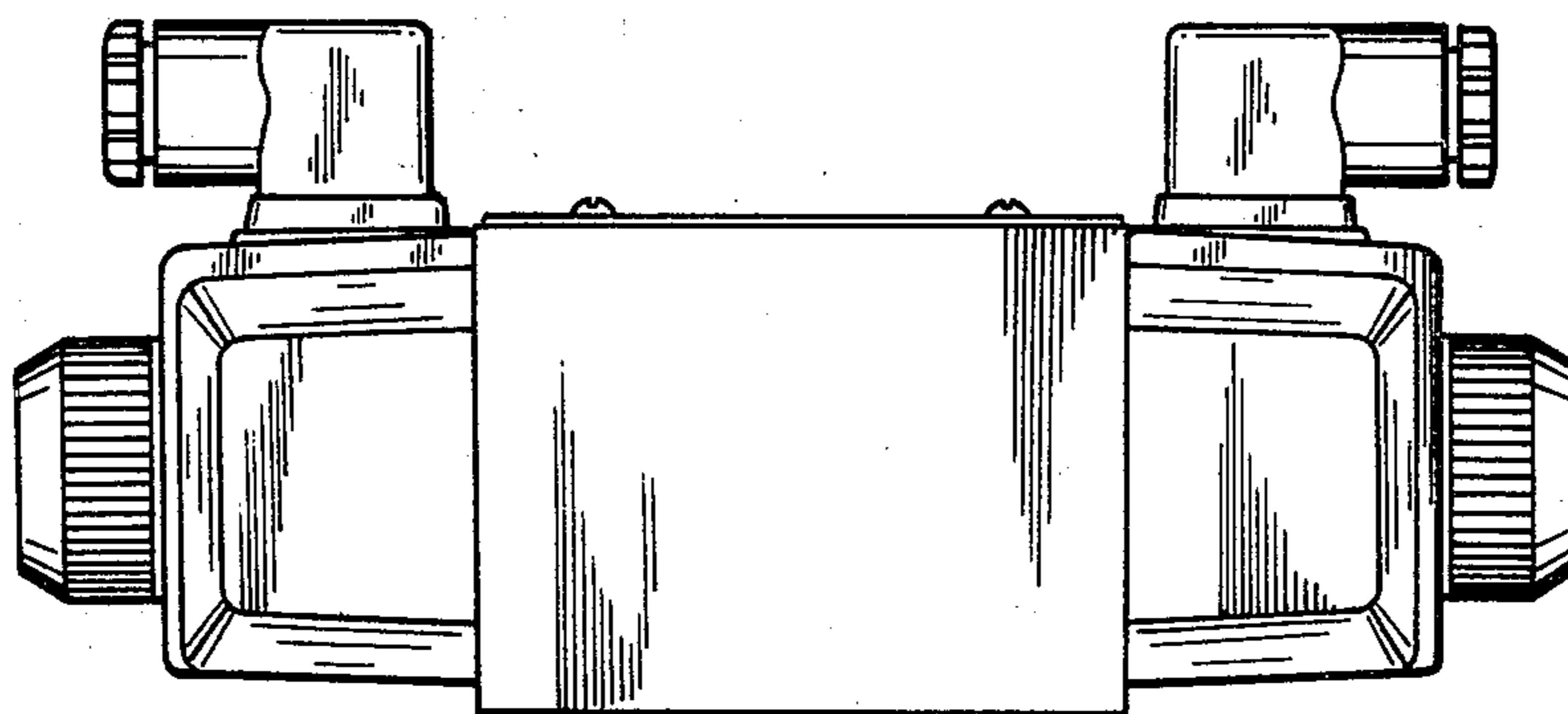

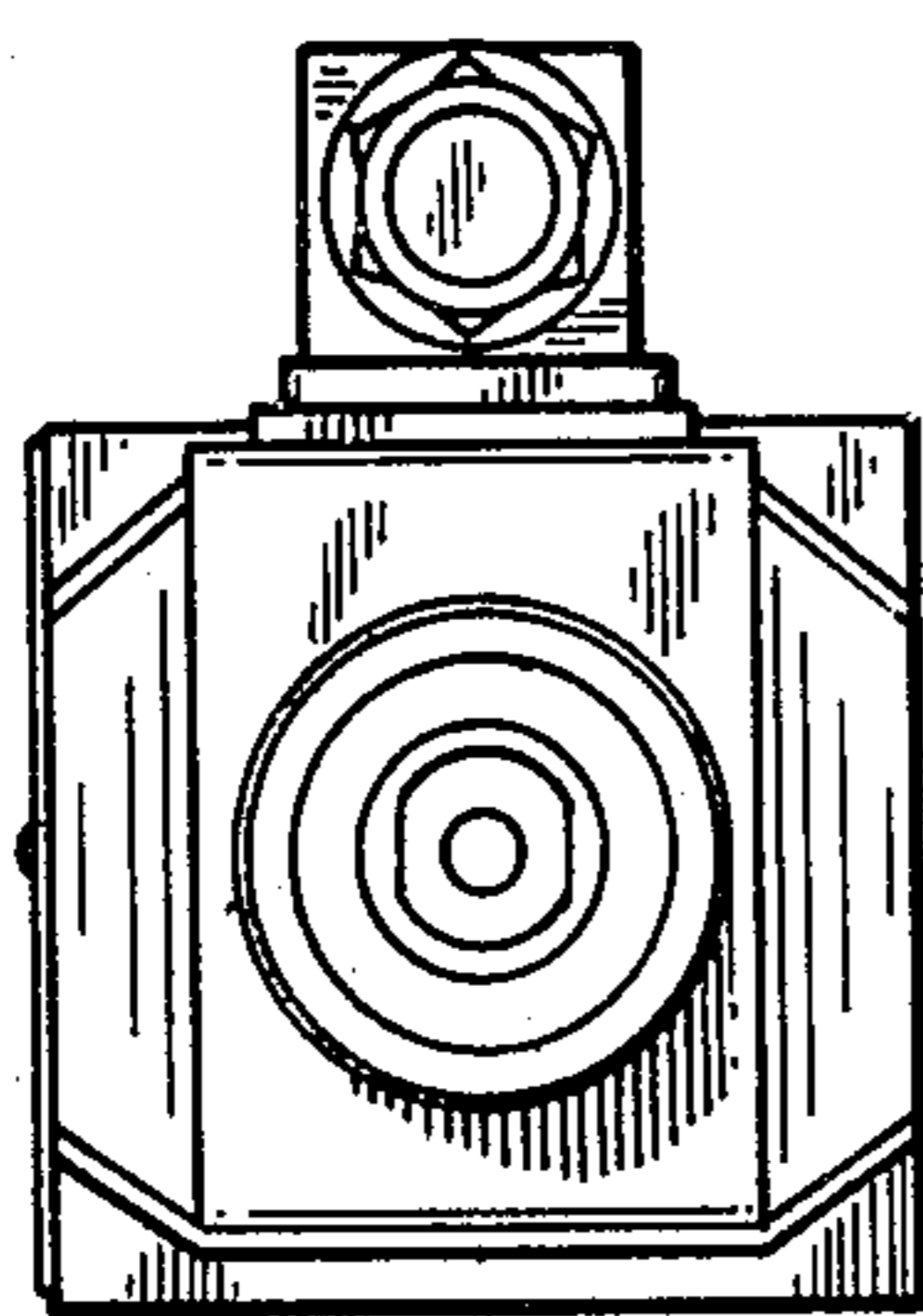

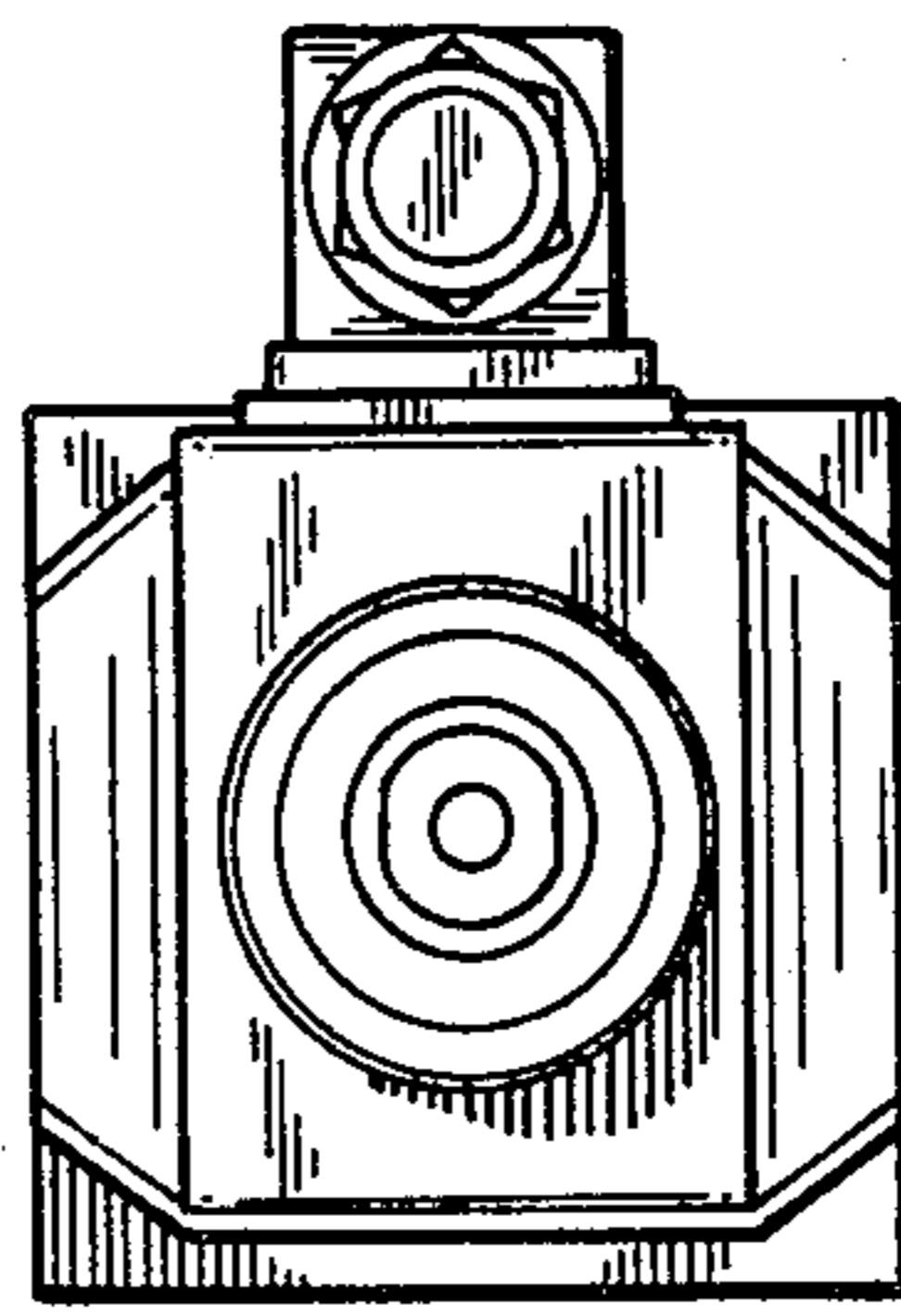
