[57] CLAIM

The ornamental design for a container for liquids or the like, substantially as shown and described.

DESCRIPTION

FIG. 1 is an elevational view of a container for liquids or the like showing my new design, the opposite side being the same in appearance;

FIG. 2 is a sectional view taken along the line 2—2 of FIG. 1;

FIG. 3 is an elevational view looking from the right of FIG. 1, the opposite side being the same in appearance;

FIG. 4 is a top plan view thereof; and

FIG. 5 is a bottom plan view thereof.

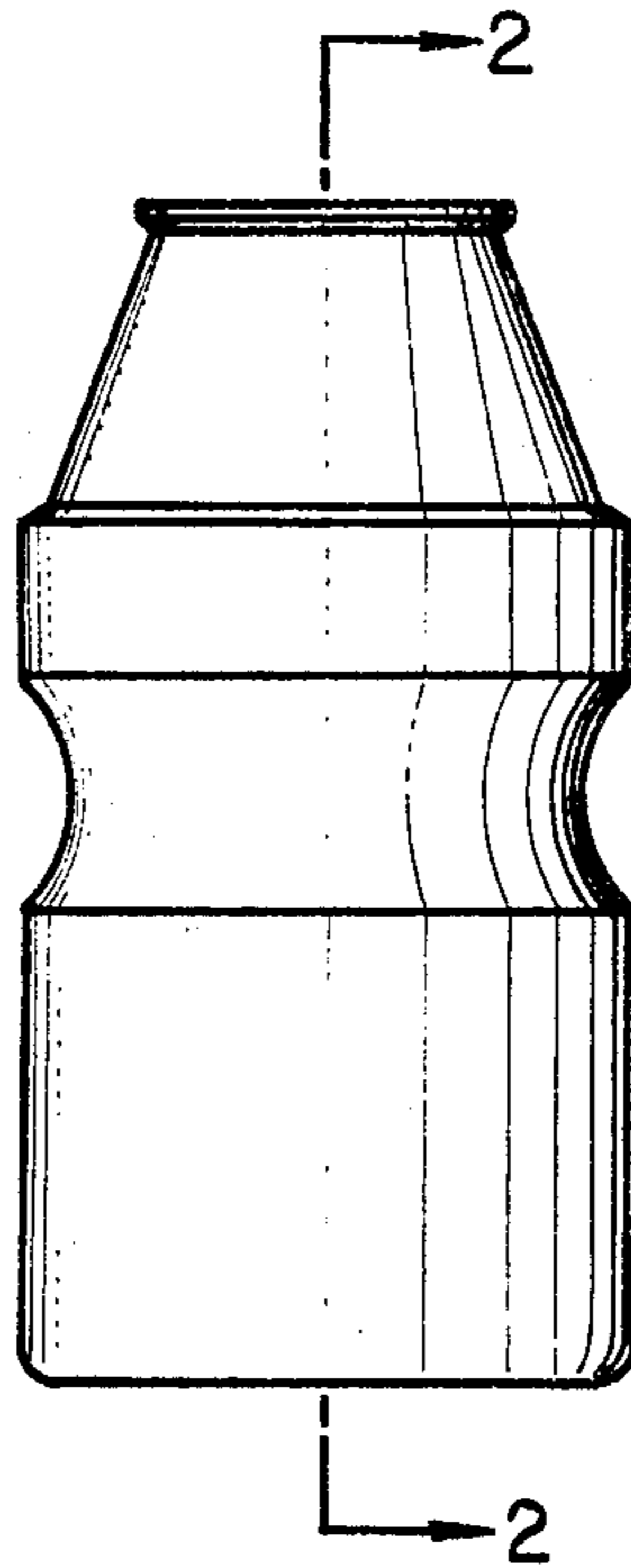

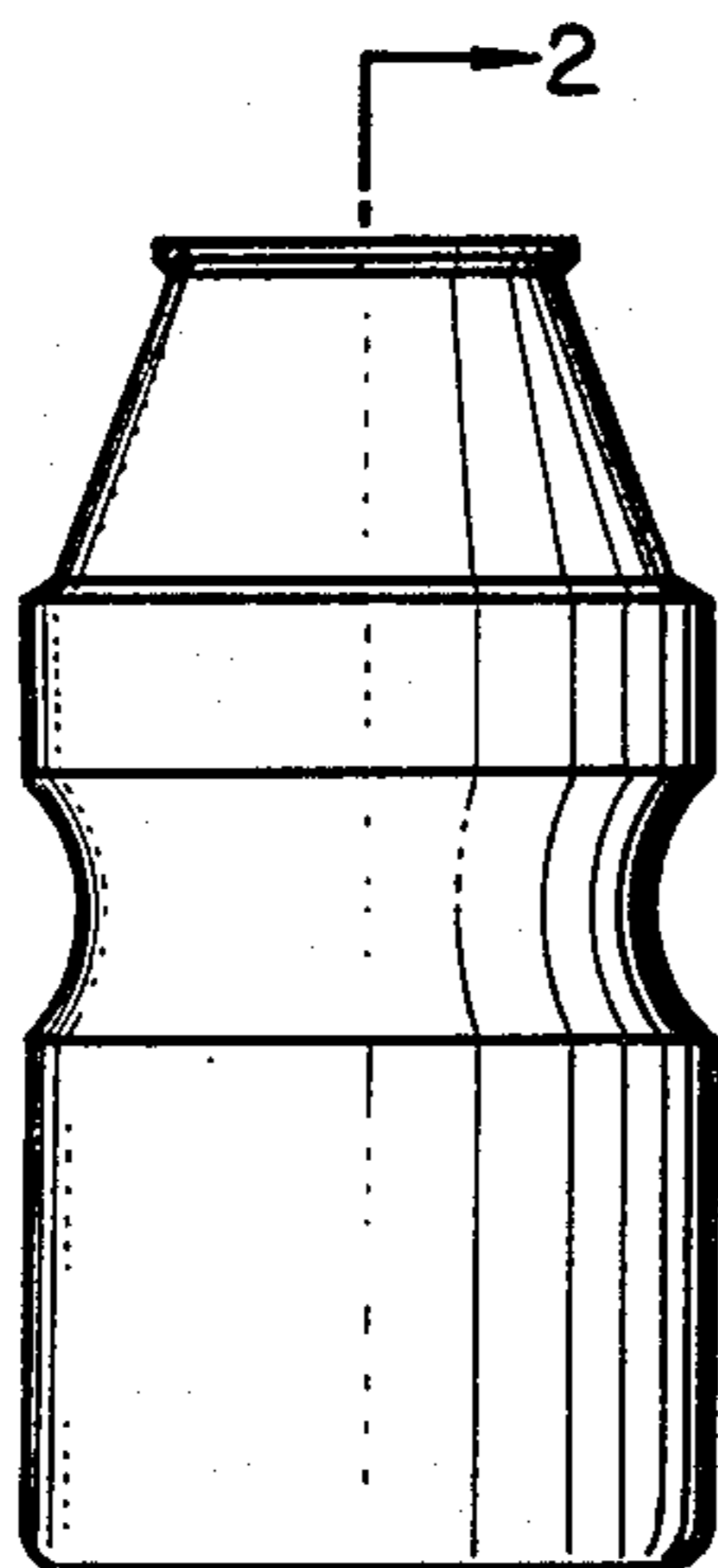

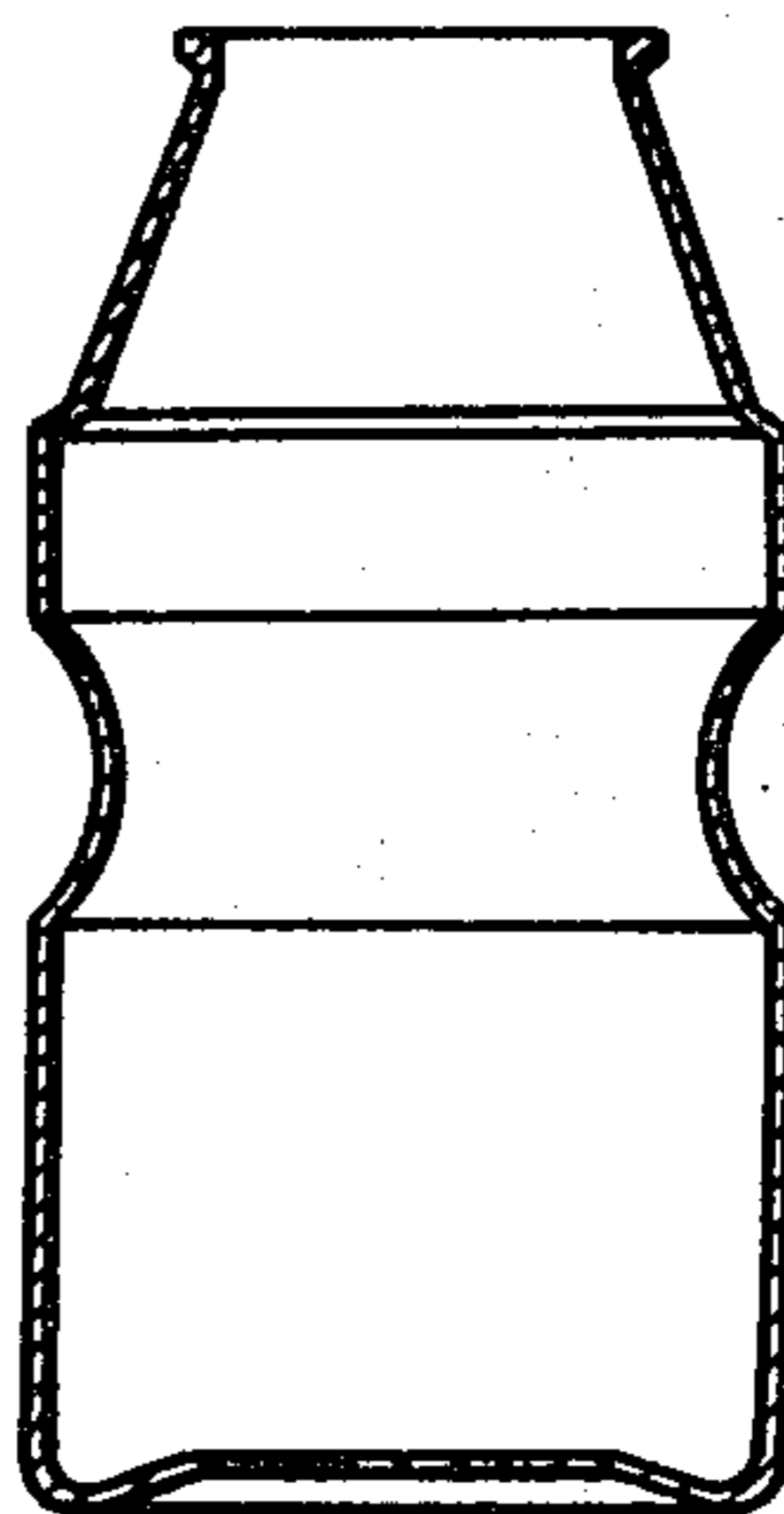

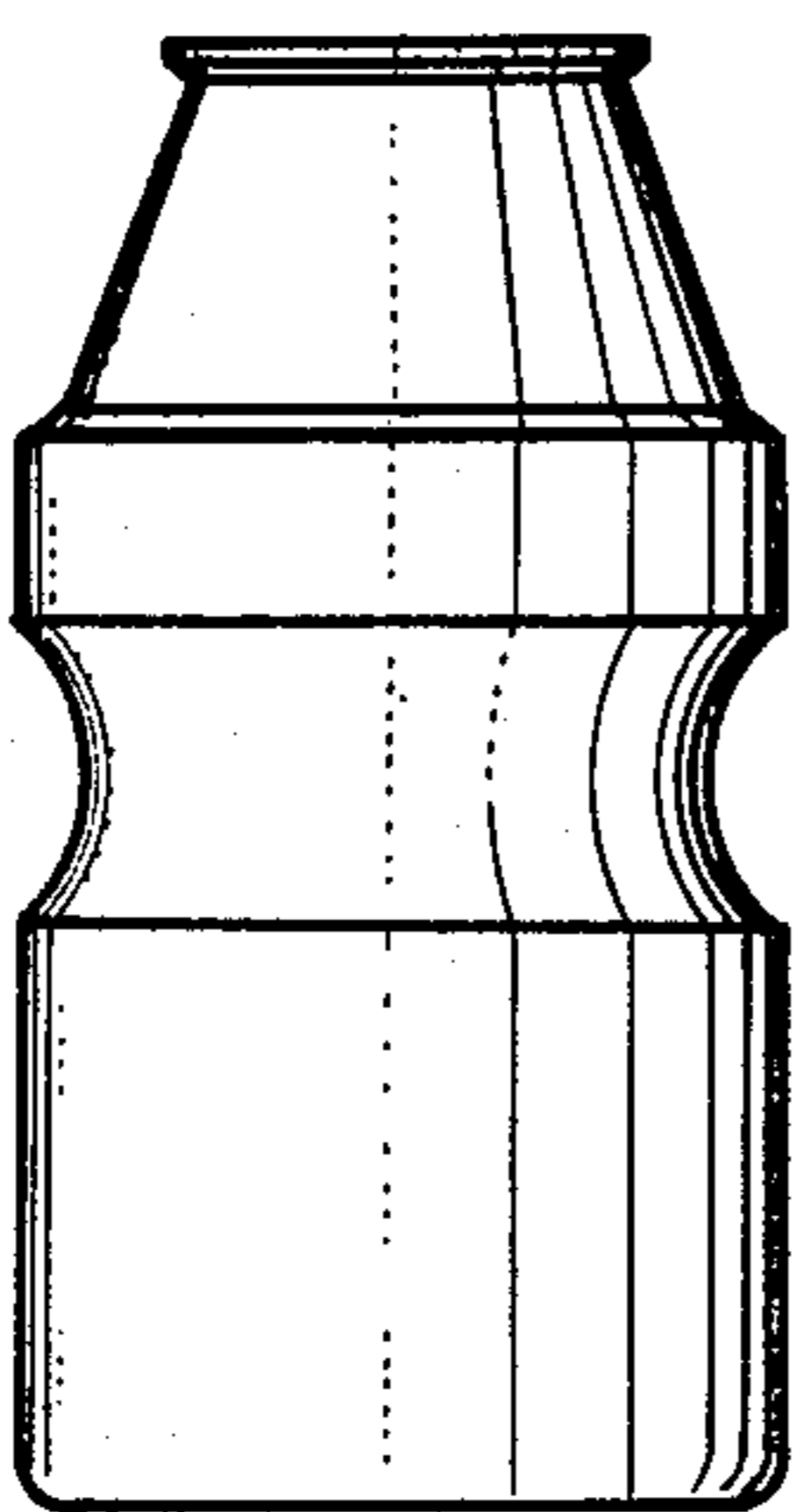

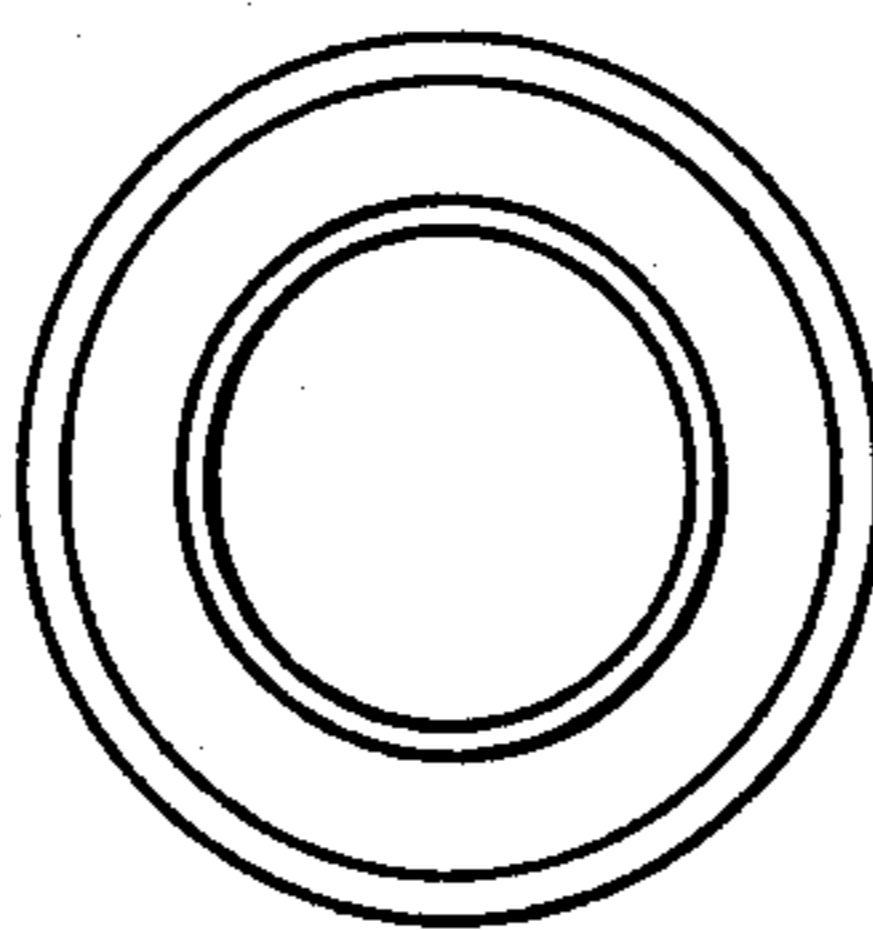
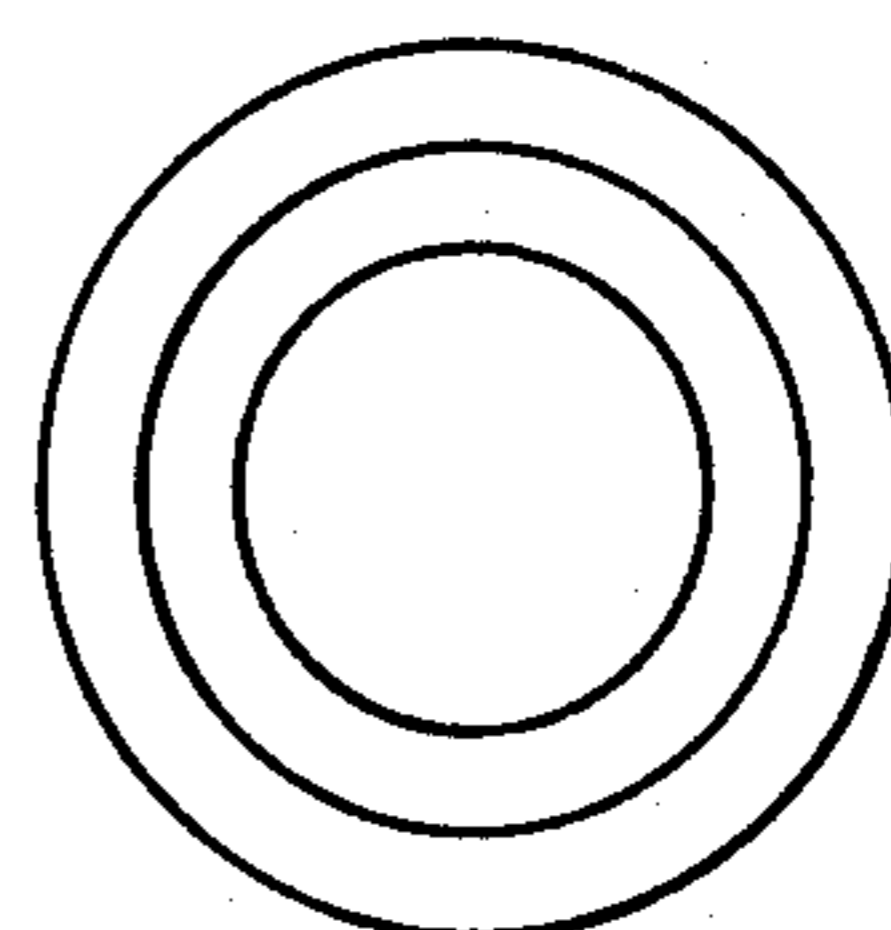
