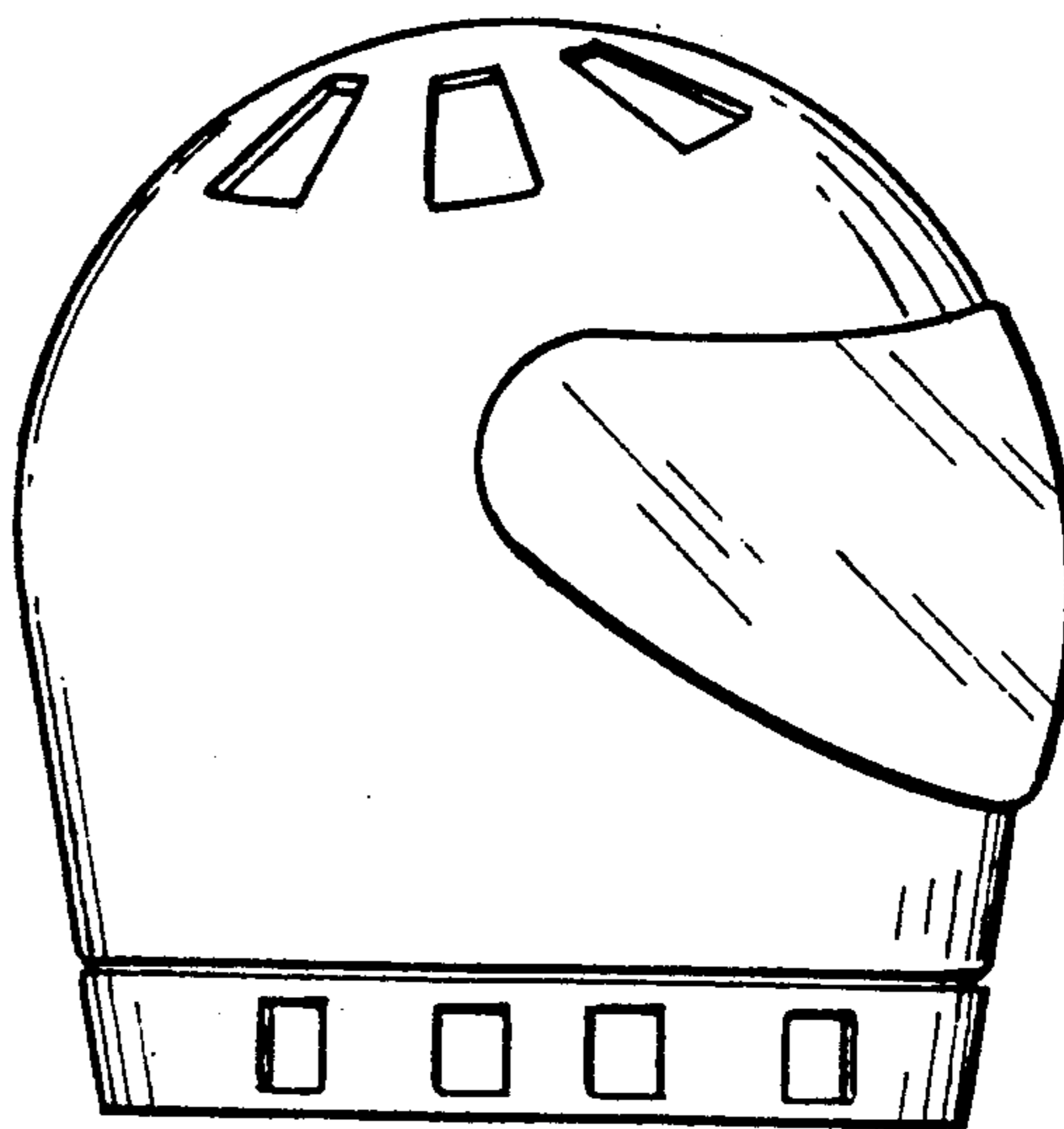
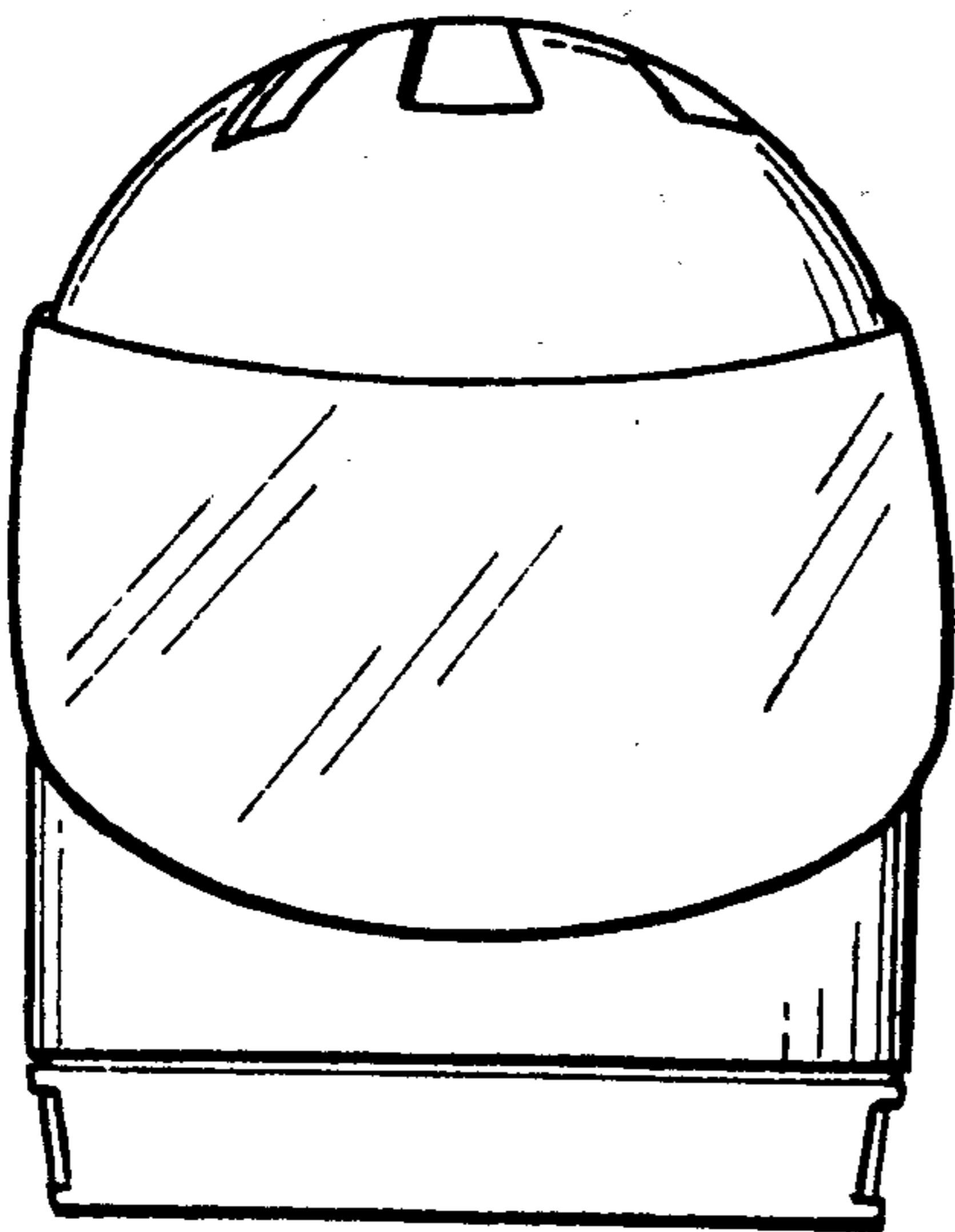

[57] **CLAIM**

The ornamental design for a dispensing container for air freshener, essentially as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a dispensing container for air freshener showing my new design; FIG. 2 is a left side elevational view thereof, the right side being a mirror image of the left side shown; FIG. 3 is a rear elevational view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a front elevational view of a modified form of the dispensing container for air freshener shown in FIG. 1; FIG. 7 is a right side elevational view of FIG. 6, the left side being a mirror image of the right side shown; FIG. 8 is a rear elevational view of FIG. 6; FIG. 9 is a bottom plan view of FIG. 6; FIG. 10 is a top plan view of FIG. 6.



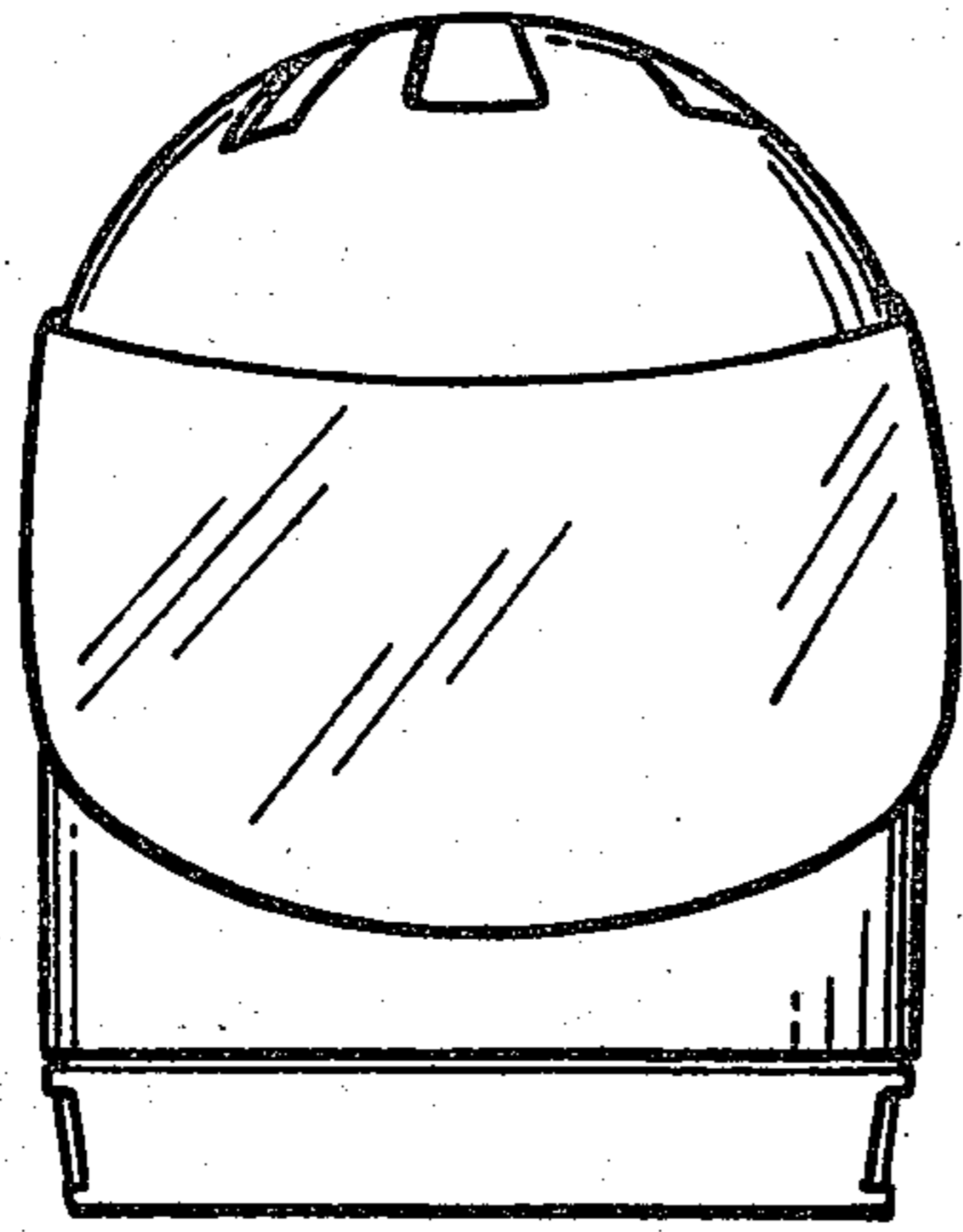

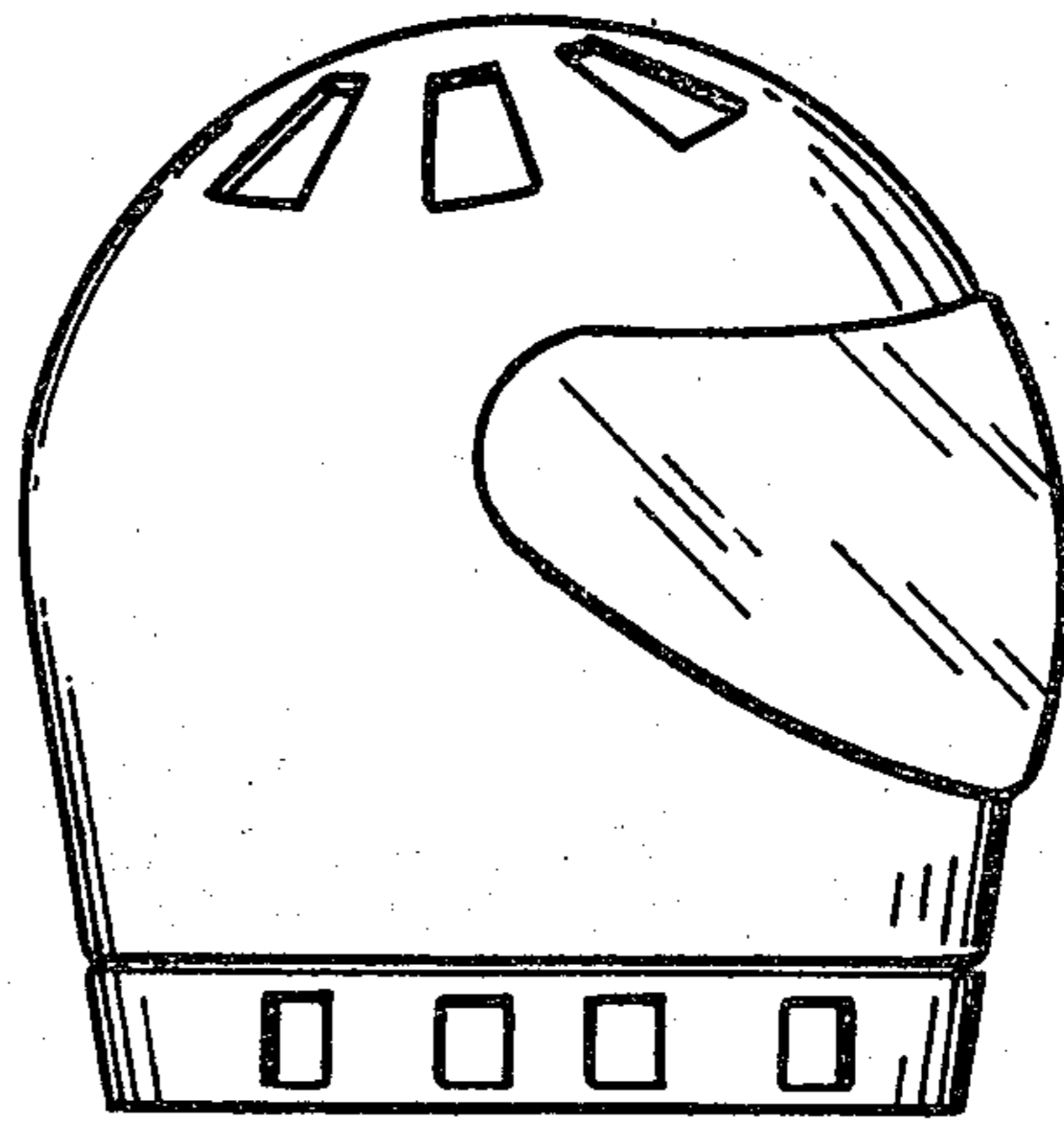

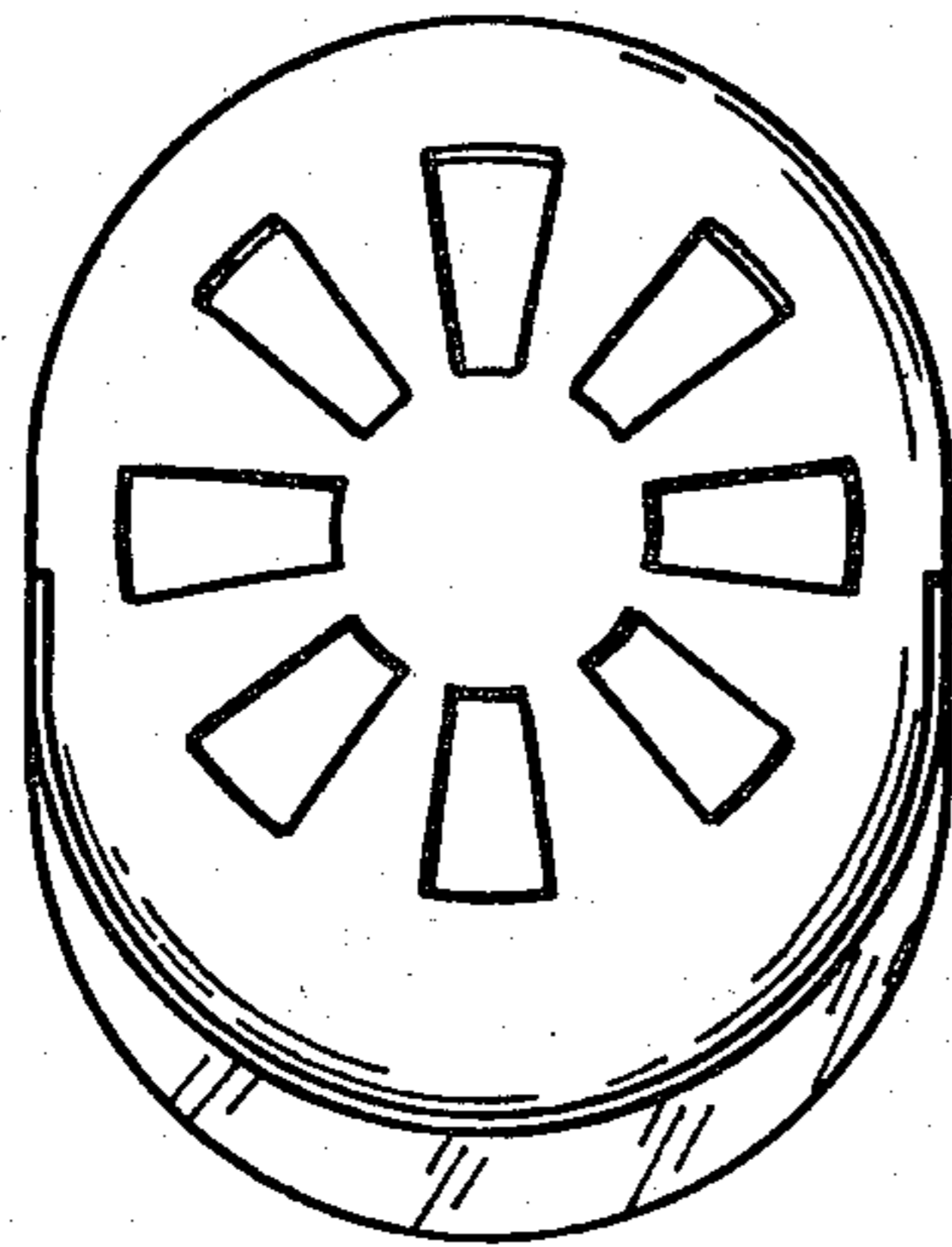

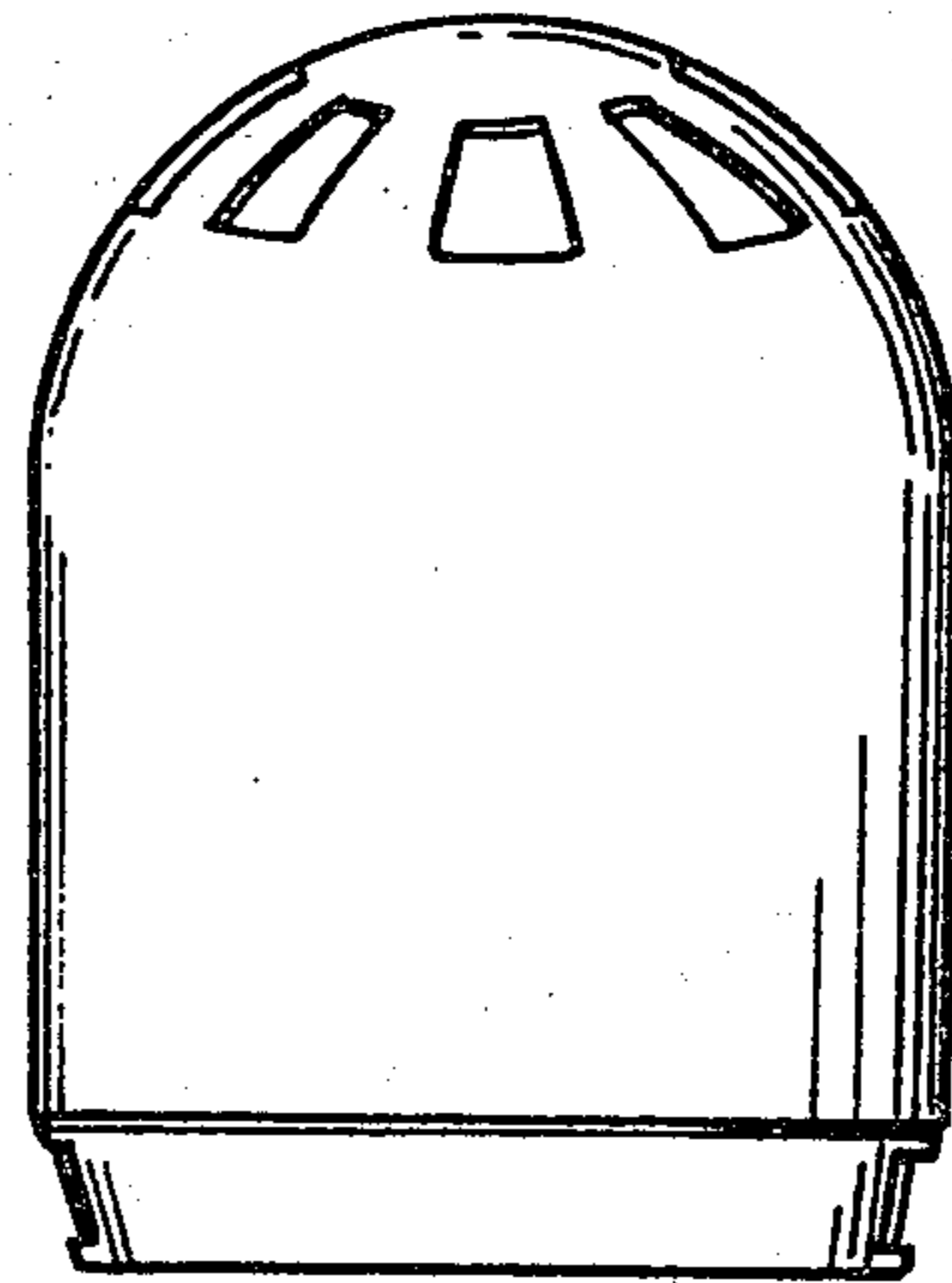

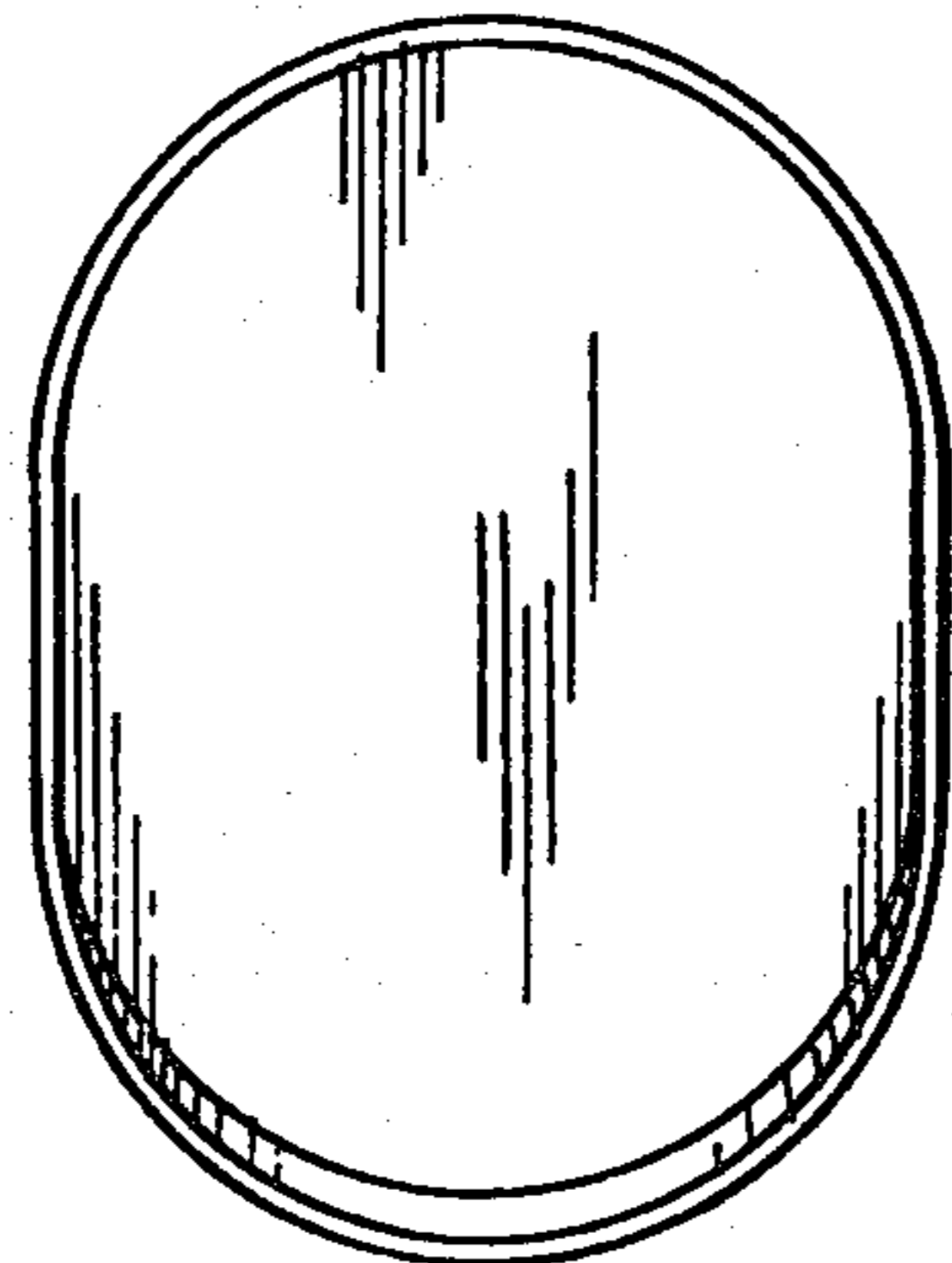

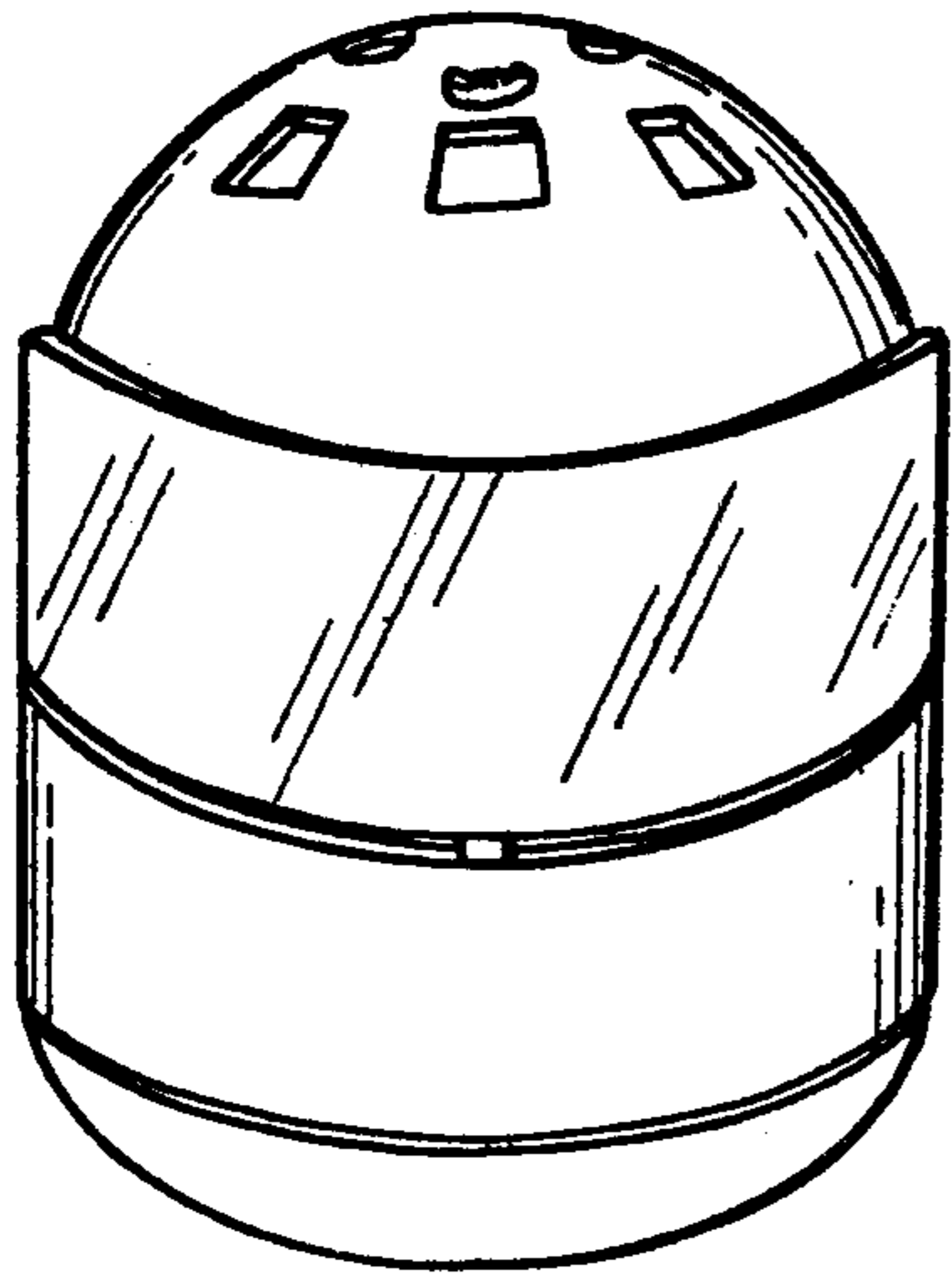

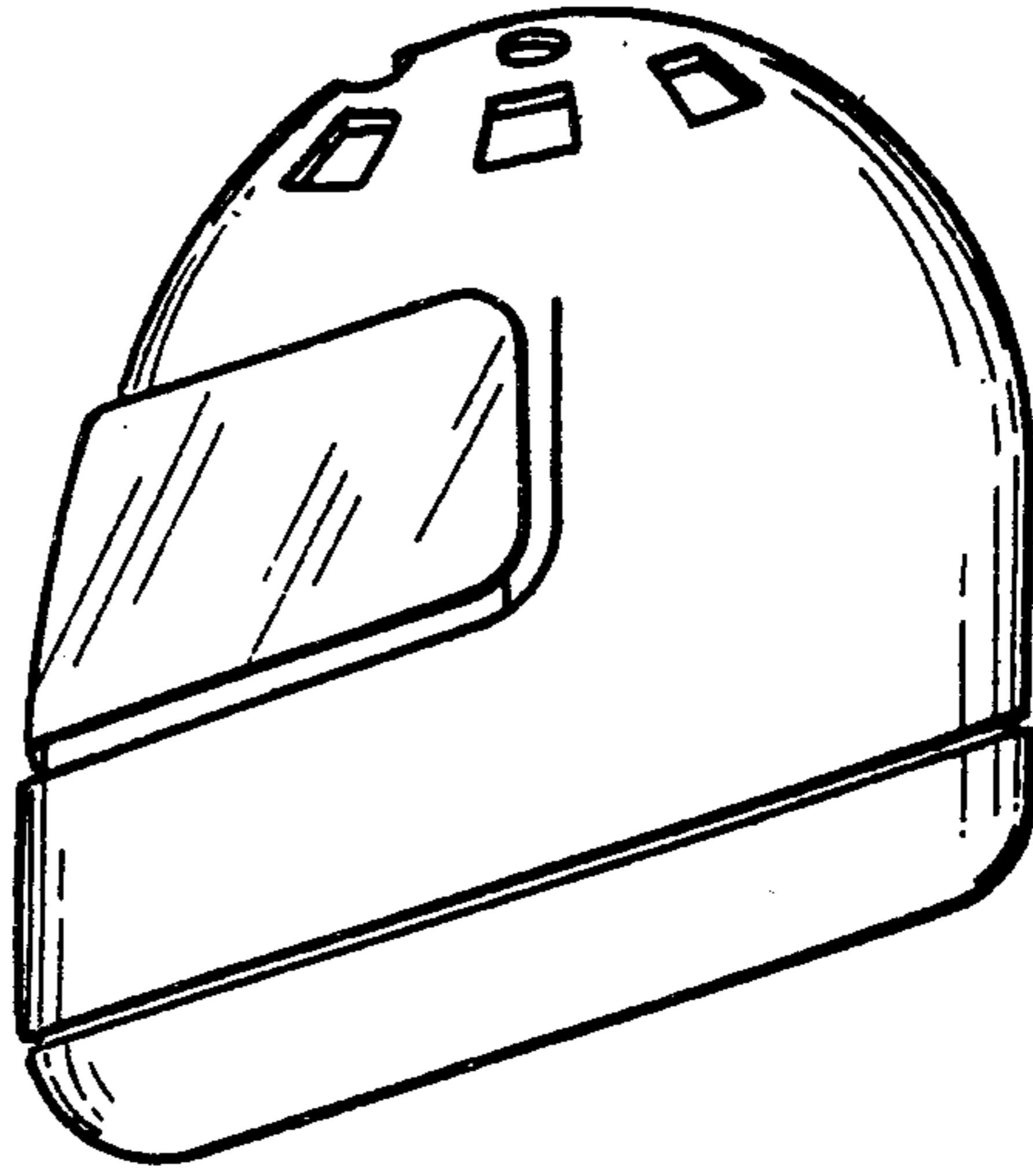

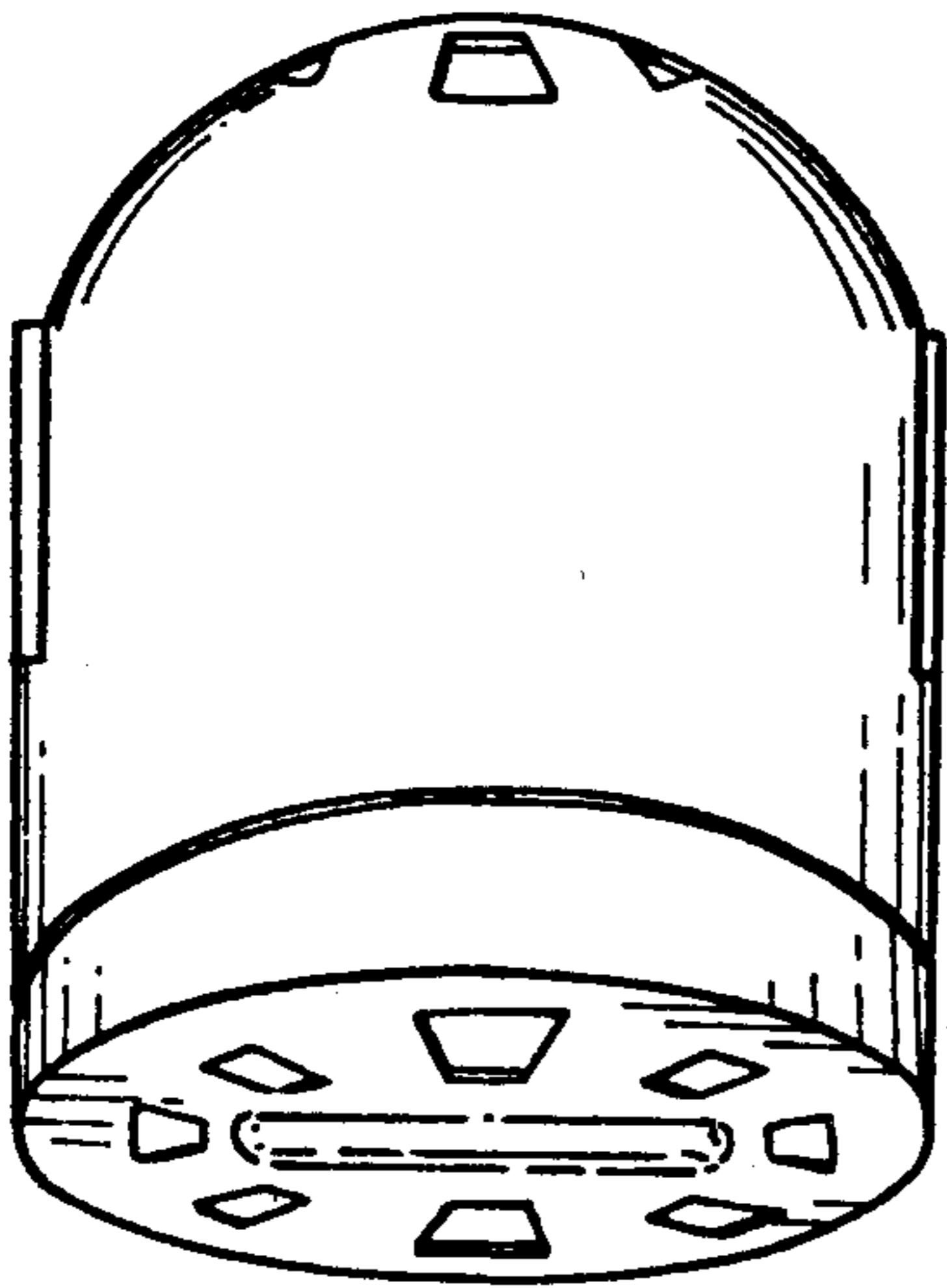

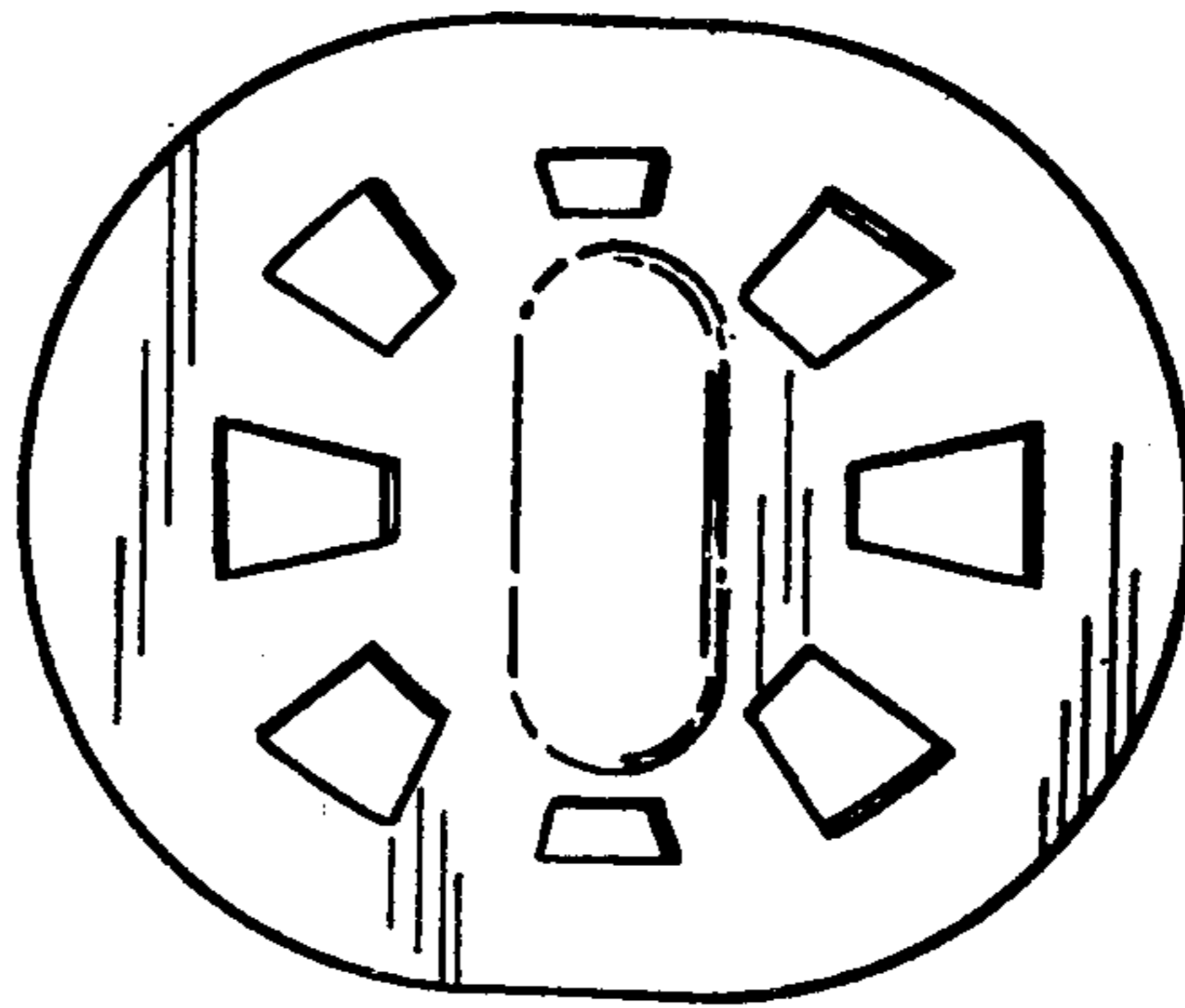

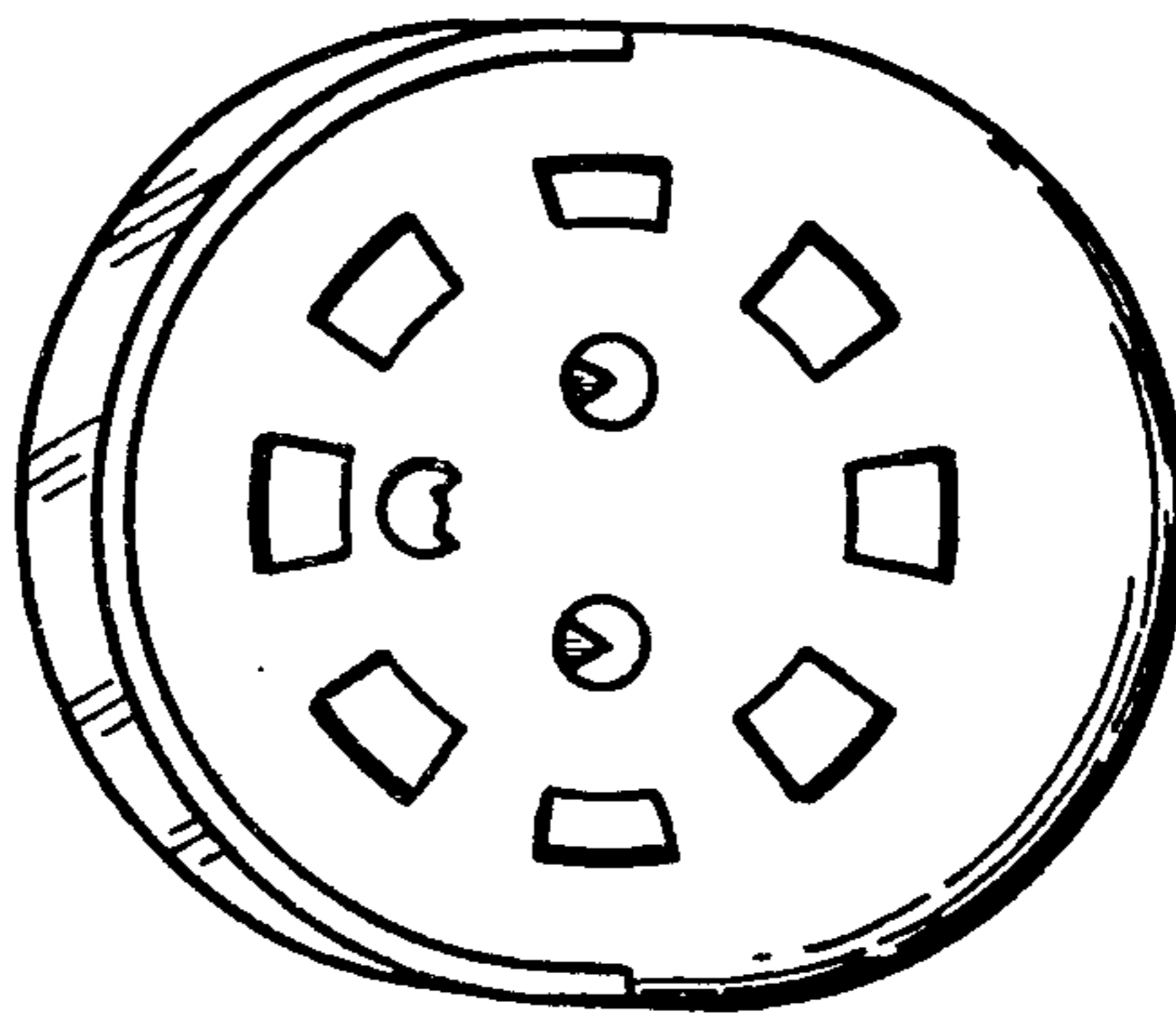
