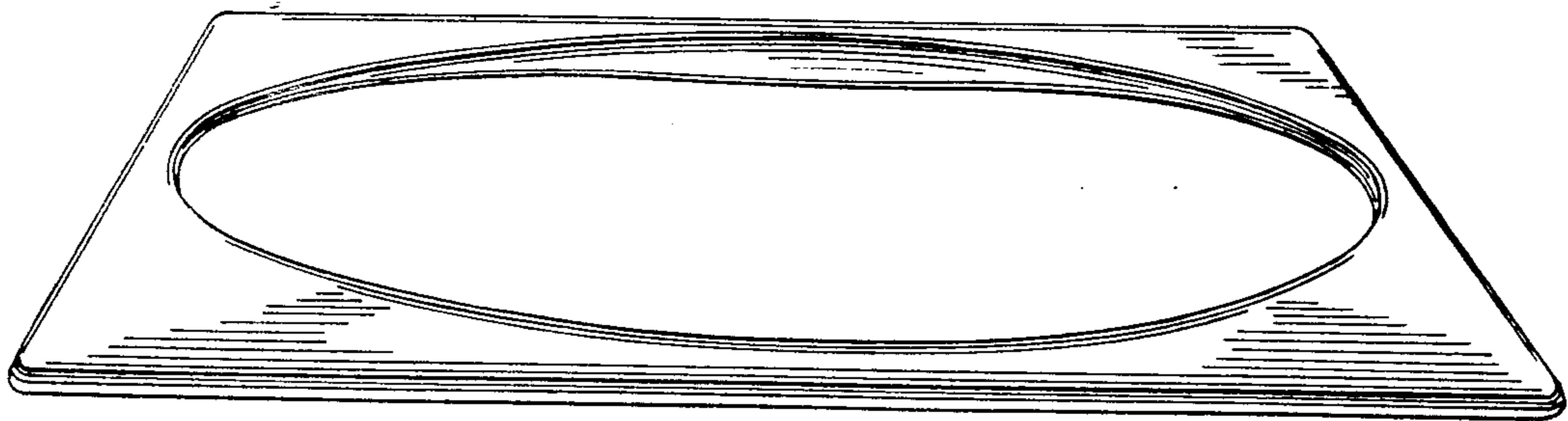

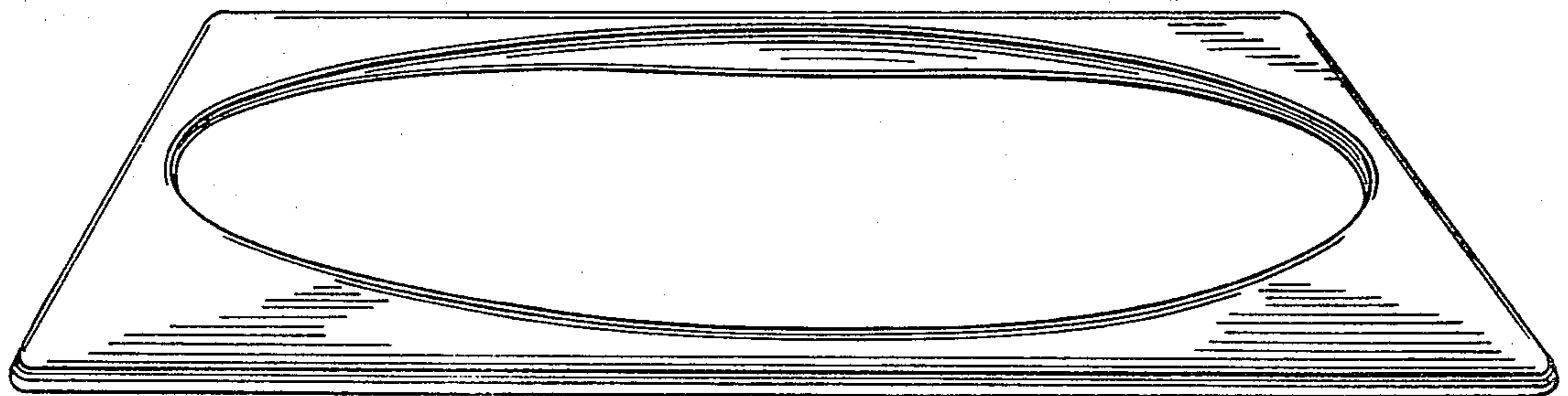
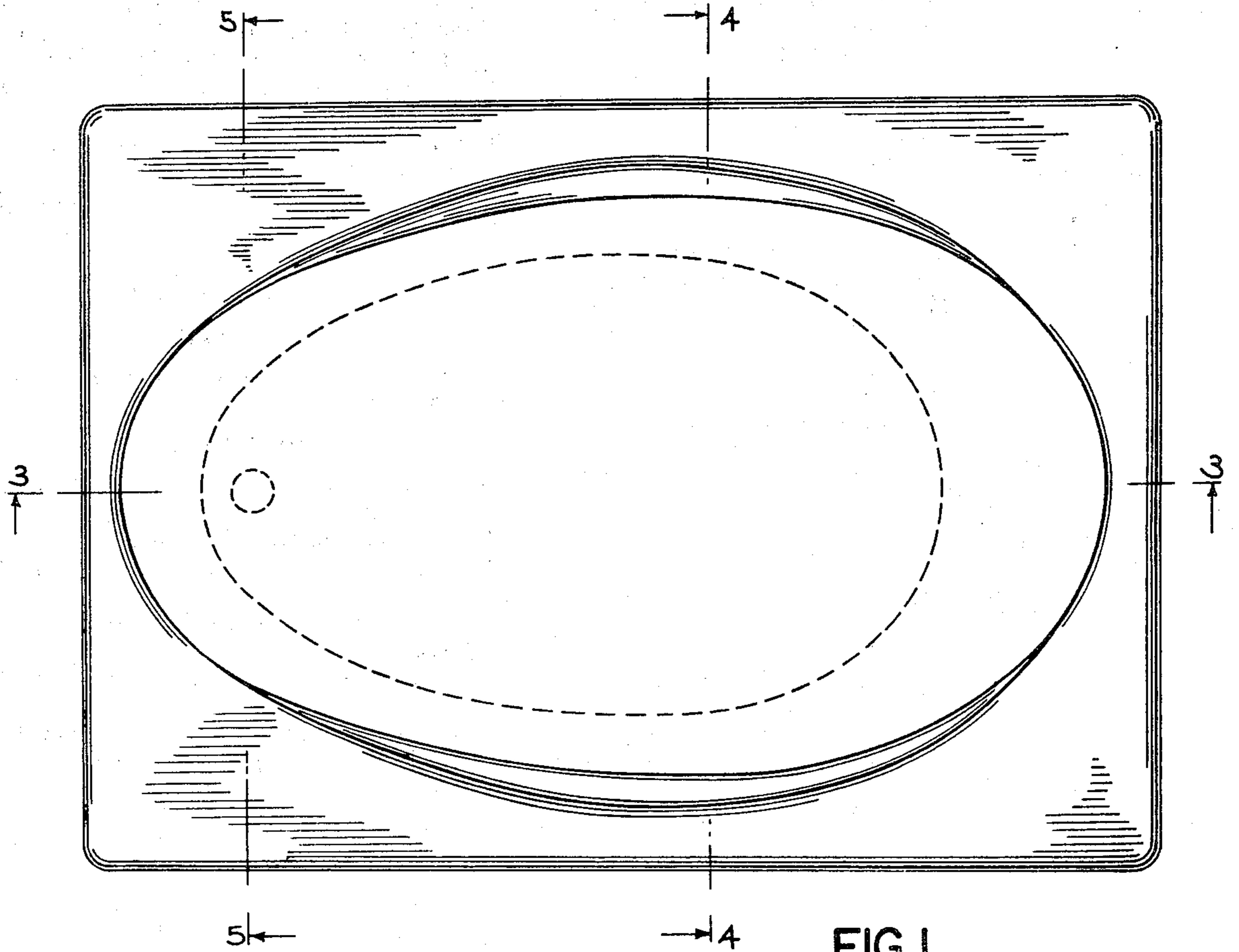
[57] **CLAIM**

The ornamental design for a top for a bathtub, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a top for a bathtub showing my new design;  
FIG. 2 is a perspective view thereof;  
FIG. 3 is a cross sectional view taken on line 3-3 of FIG. 1;  
FIG. 4 is a cross sectional view taken on line 4-4 of FIG. 1; and  
FIG. 5 is a cross sectional view taken on line 5-5 of FIG. 1.  
The broken line representation of a bathtub in FIGS. 1, 3, 4 and 5 is for purposes of illustration only.





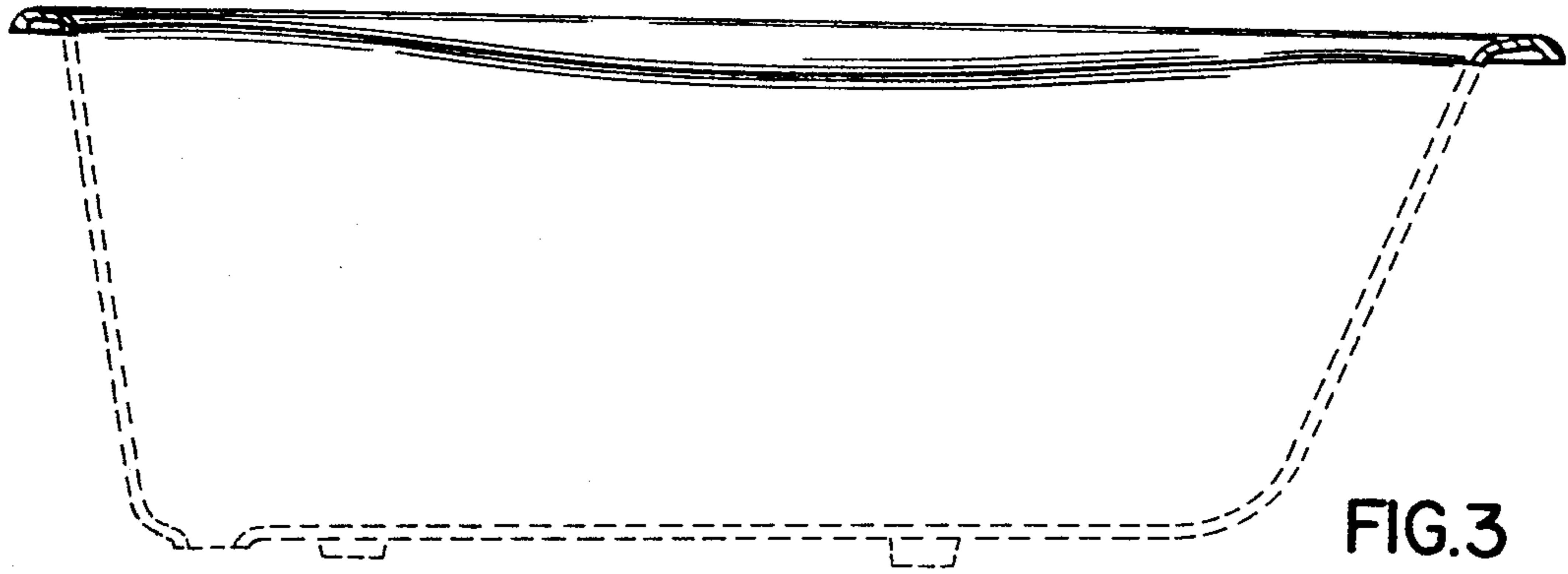

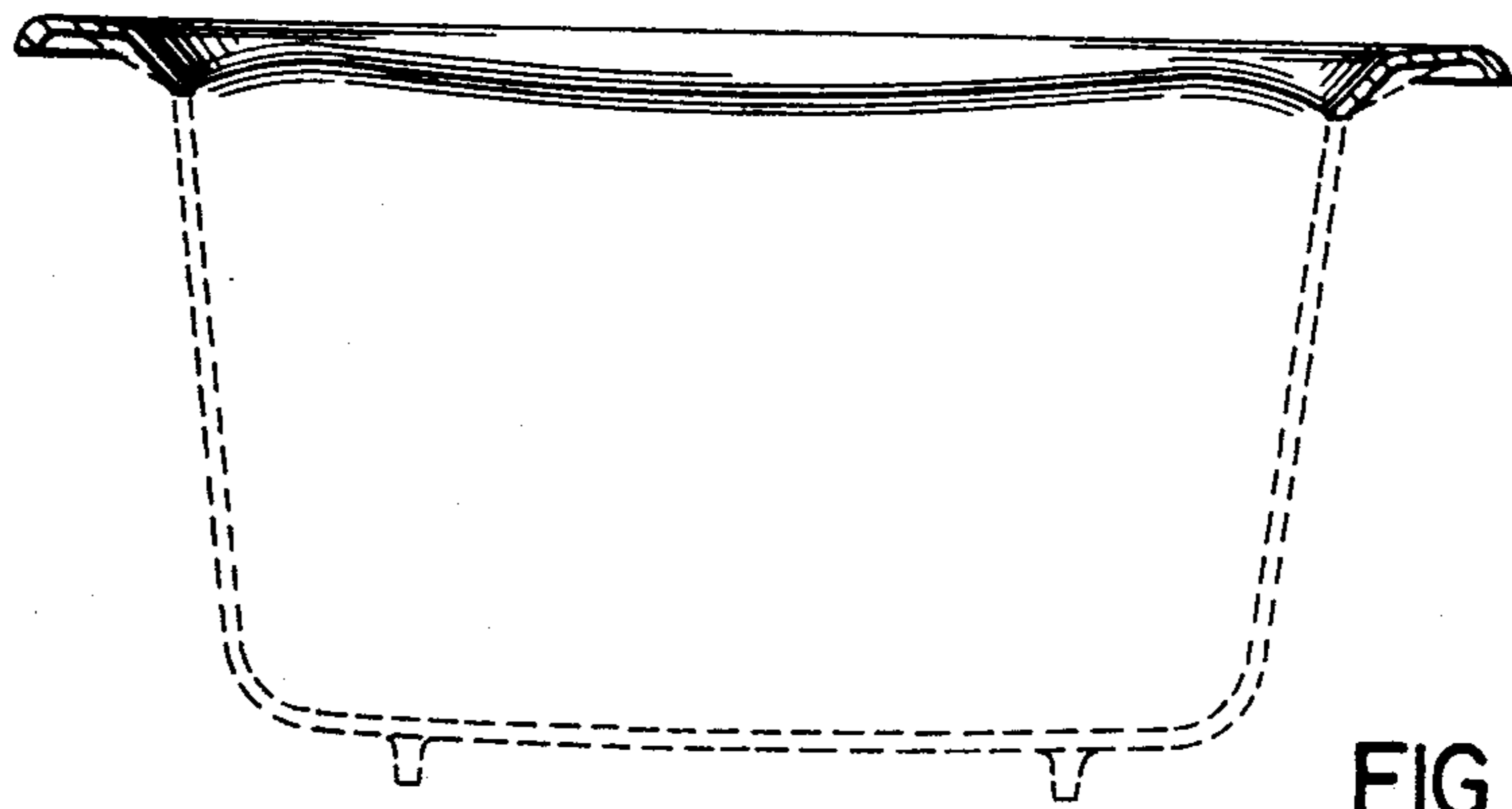

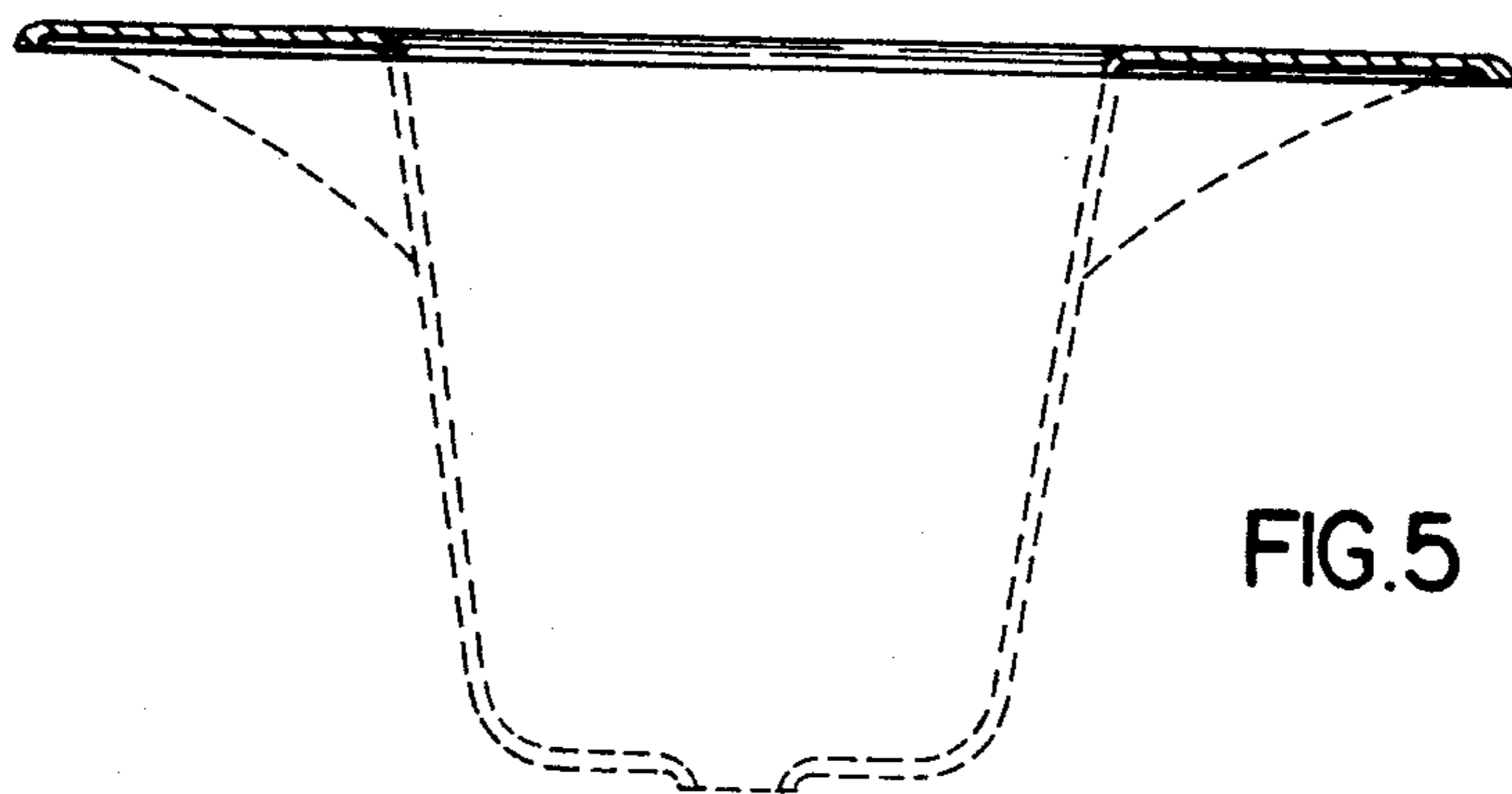
