The ornamental design for shoelace knot retainer or similar article, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a shoelace knot retainer or similar article showing my new design; FIG. 2 is a right side elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a left side elevational view thereof; and FIG. 5 is a bottom plan view thereof.

FIG. 6 is a front elevational view of a shoelace knot retainer or similar article showing a second embodiment of my new design; FIG. 7 is a right side elevational view thereof; FIG. 8 is a left side elevational view thereof; FIG. 9 is a top plan view thereof; and FIG. 10 is a bottom plan view thereof.

FIG. 11 is a front elevational view of a shoelace knot retainer or similar article showing a third embodiment of my new design; FIG. 12 is a right side elevational view thereof; FIG. 13 is a top plan view thereof; FIG. 14 is a left side elevational view thereof; and FIG. 15 is a bottom plan view thereof.

FIG. 16 is a front elevational view of a shoelace knot retainer or similar article showing a fourth embodiment of my new design; FIG. 17 is a right side elevational view thereof; FIG. 18 is a left side elevational view thereof; FIG. 19 is a top plan view thereof; and FIG. 20 is a bottom plan view thereof.

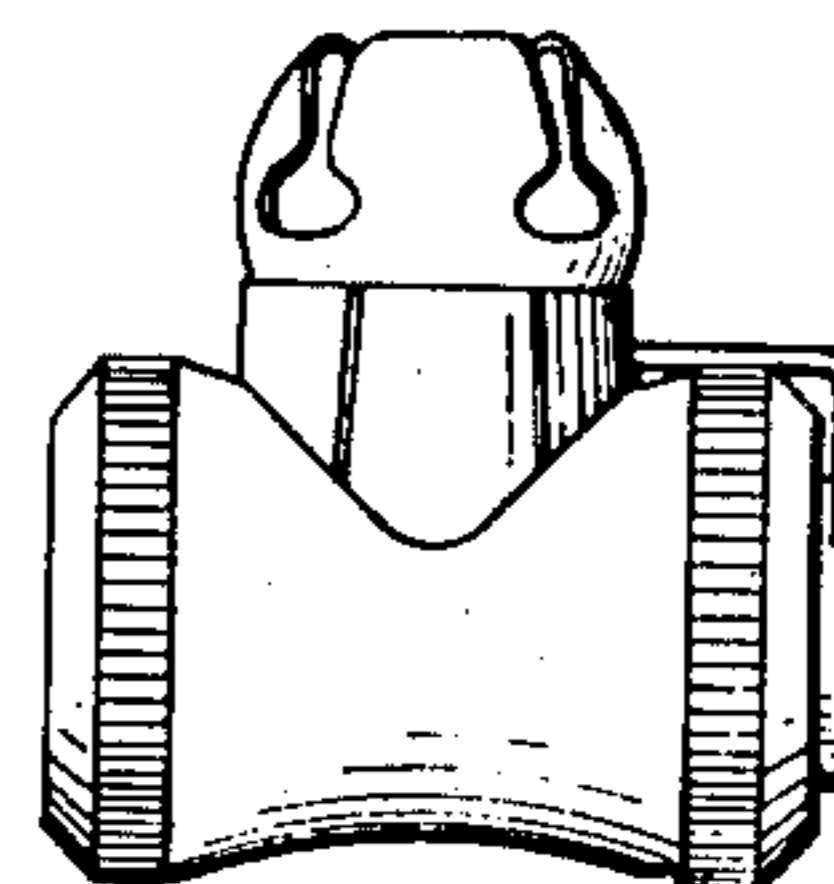
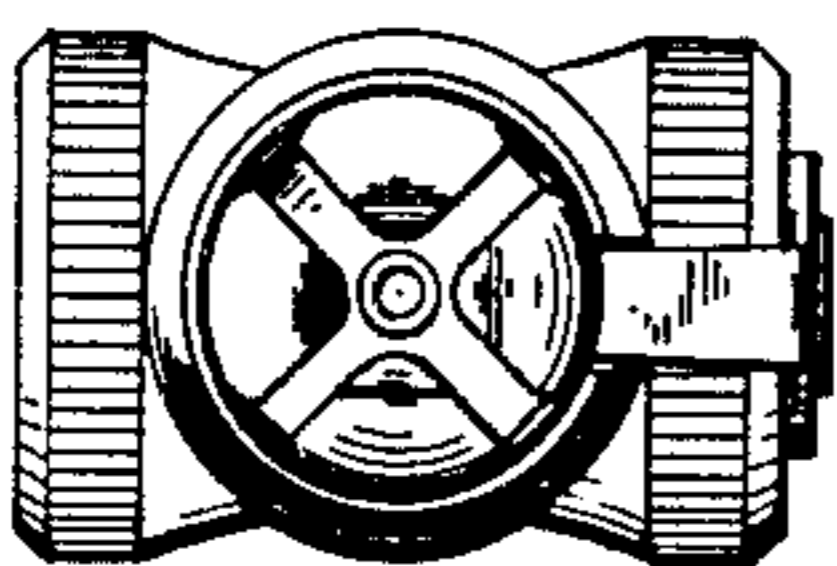
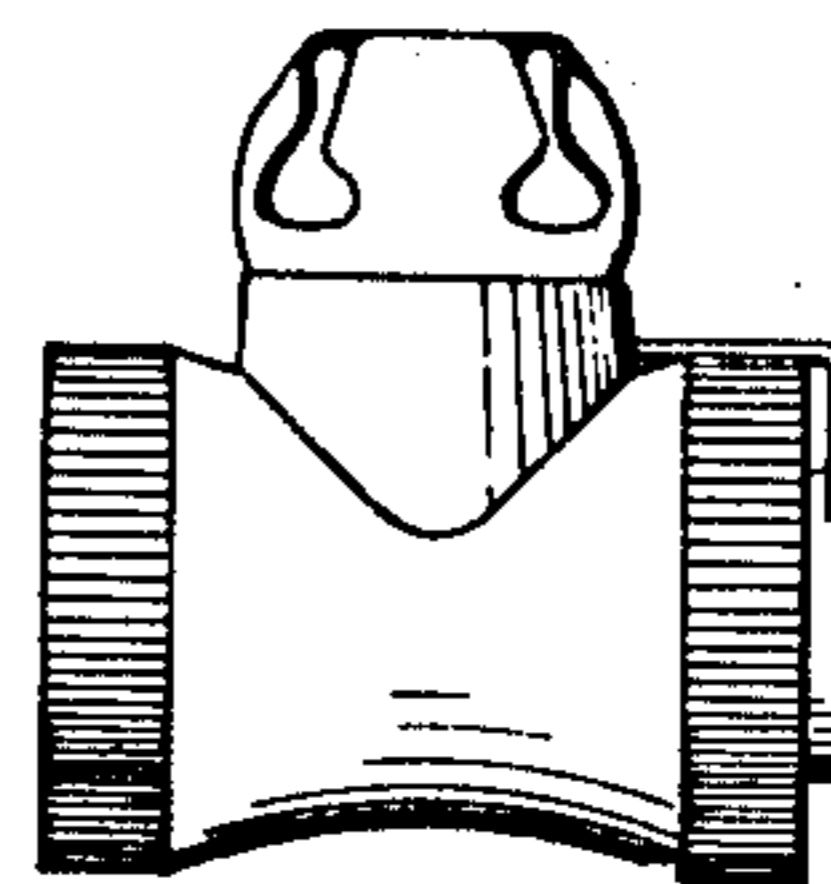
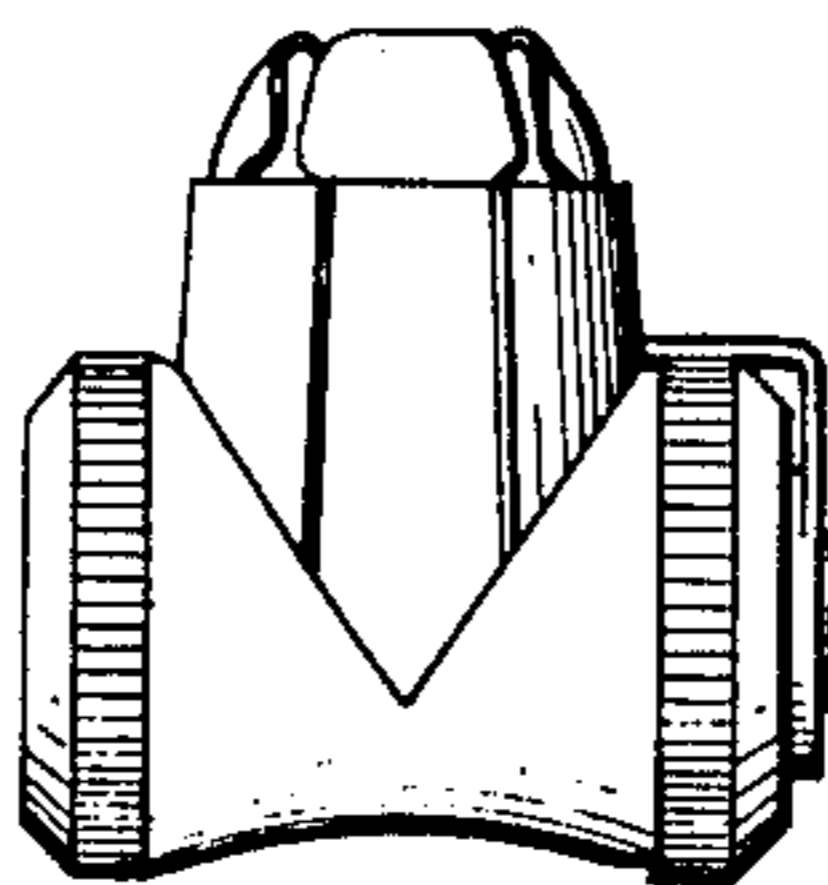
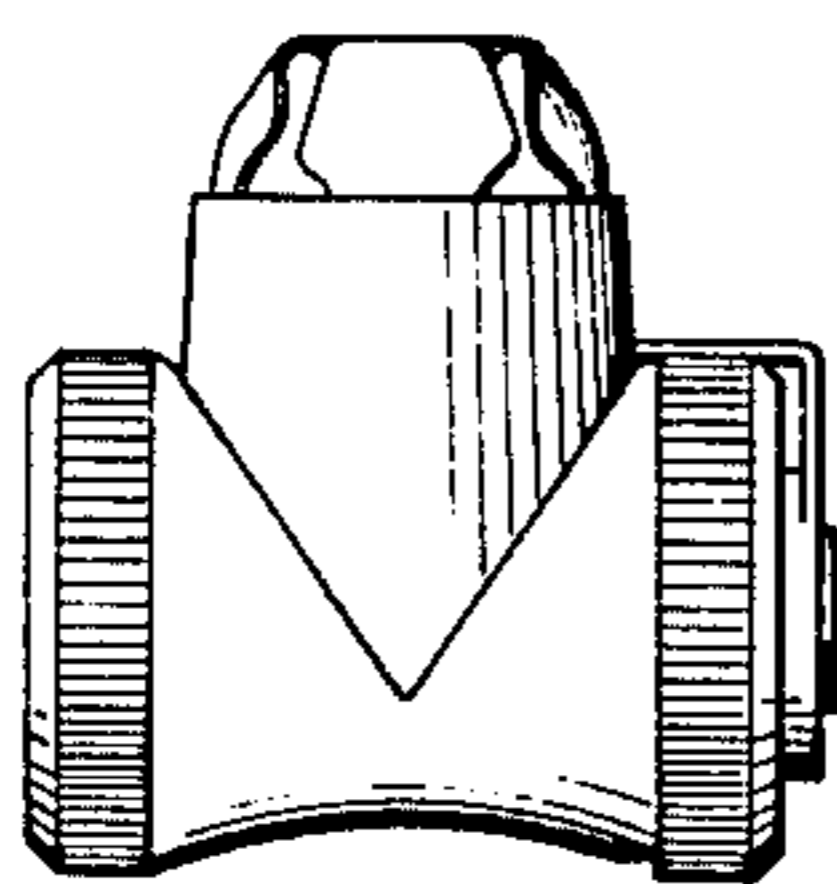

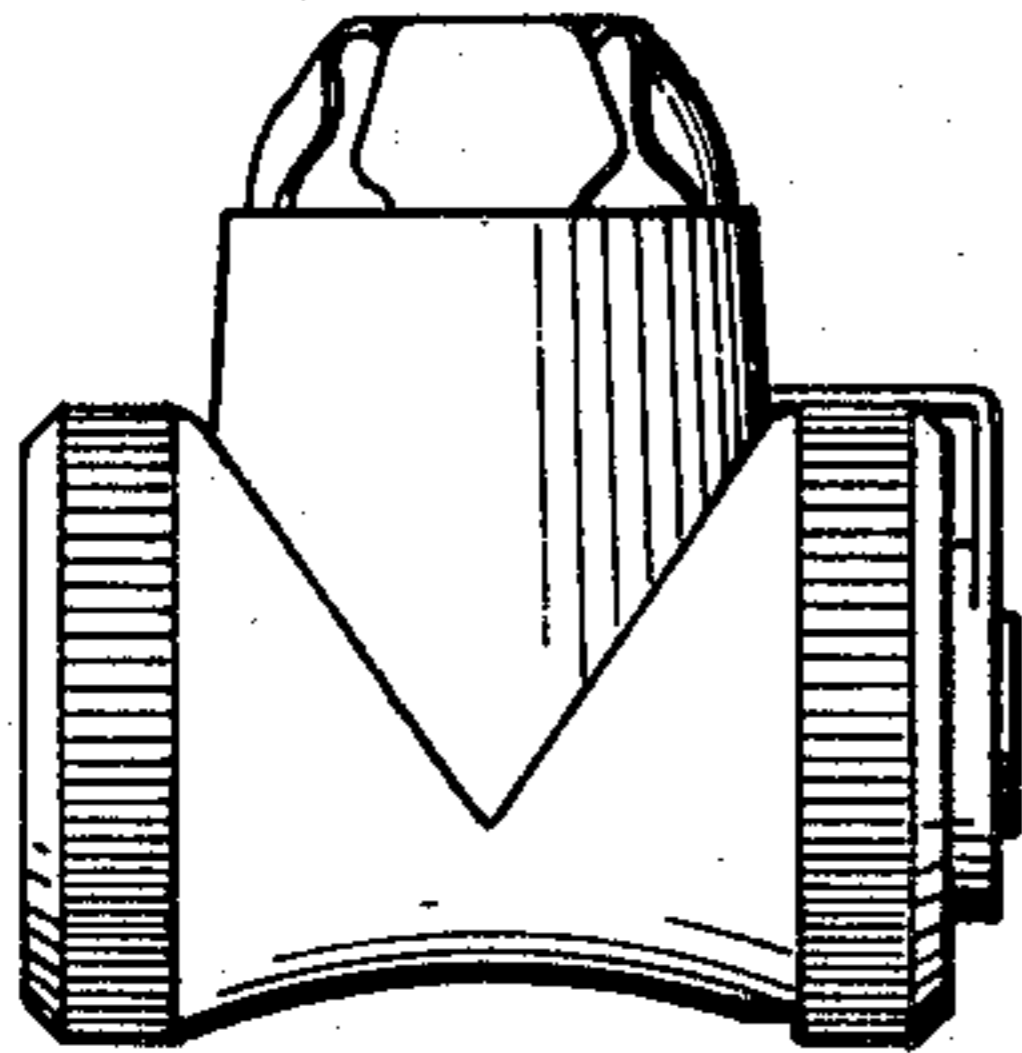

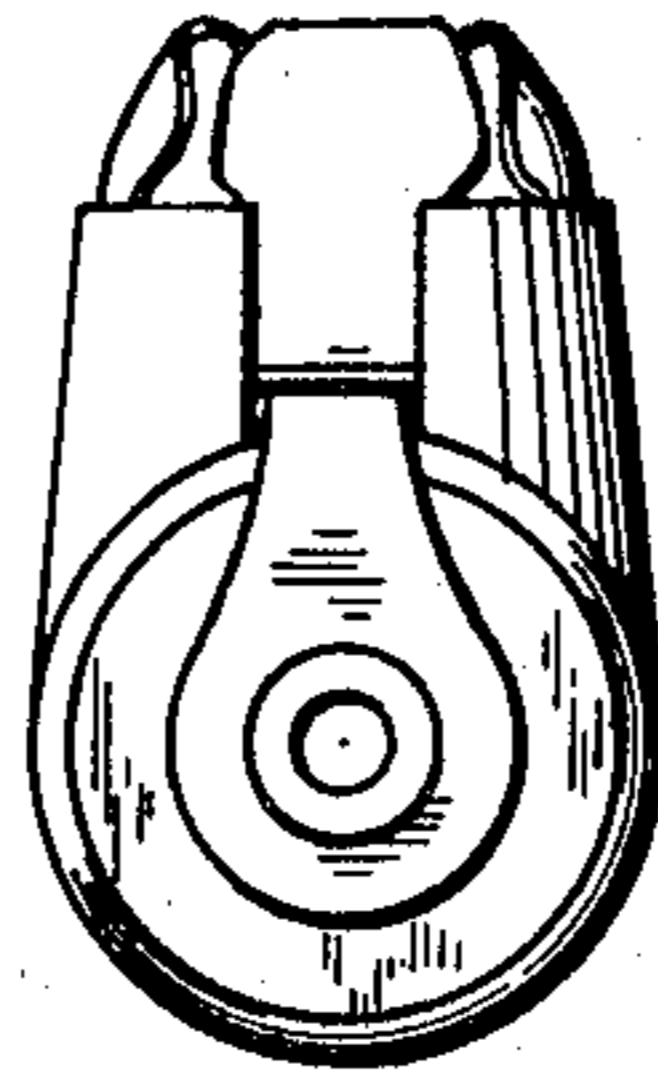

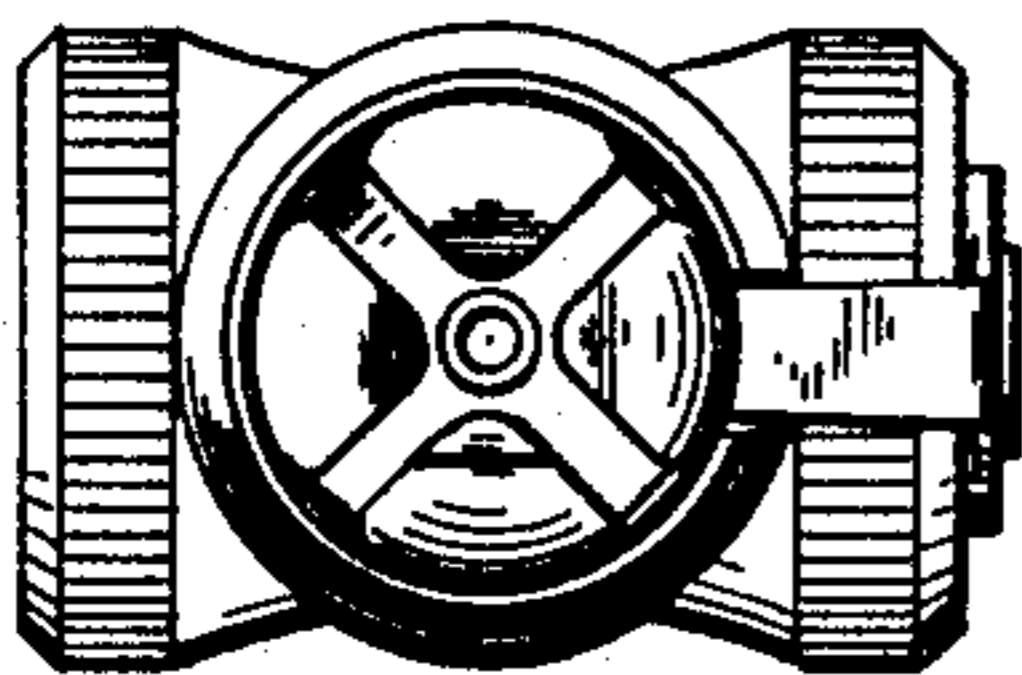

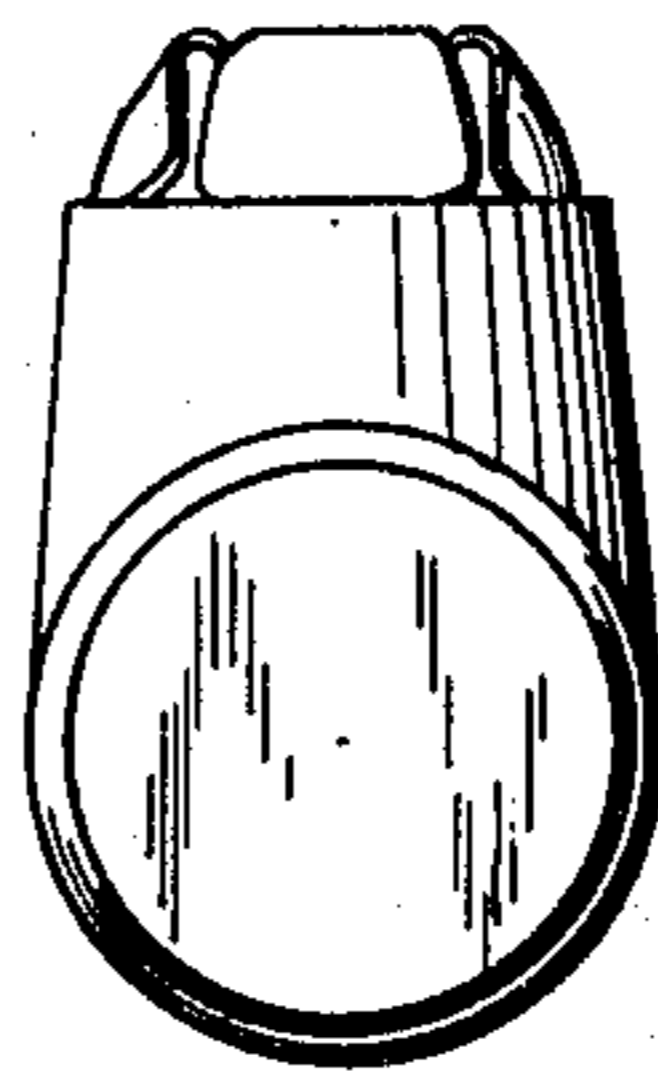

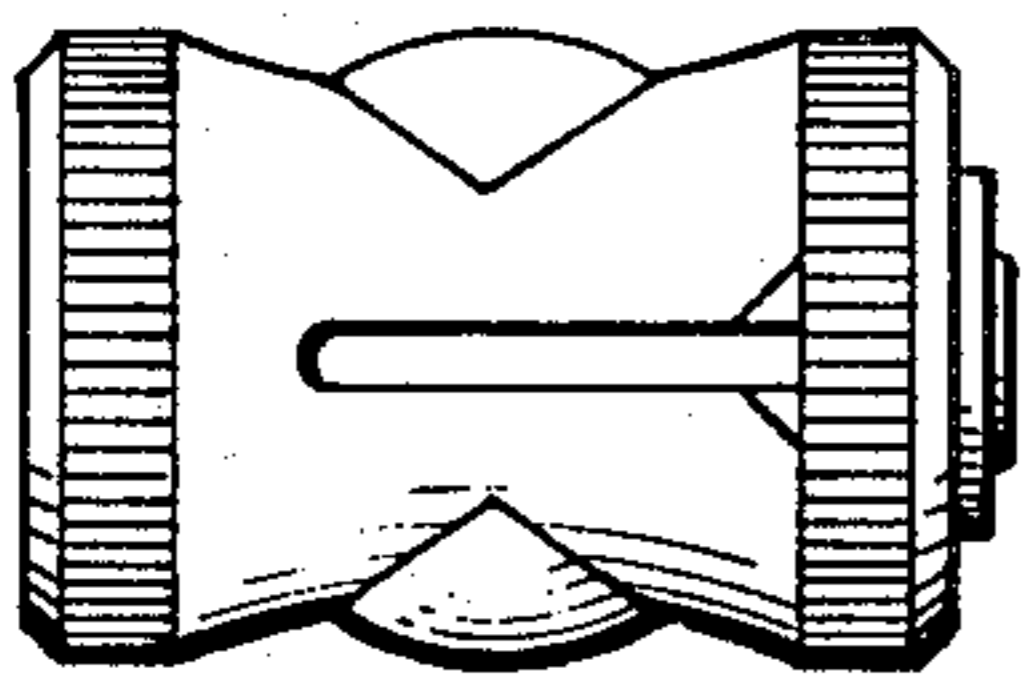

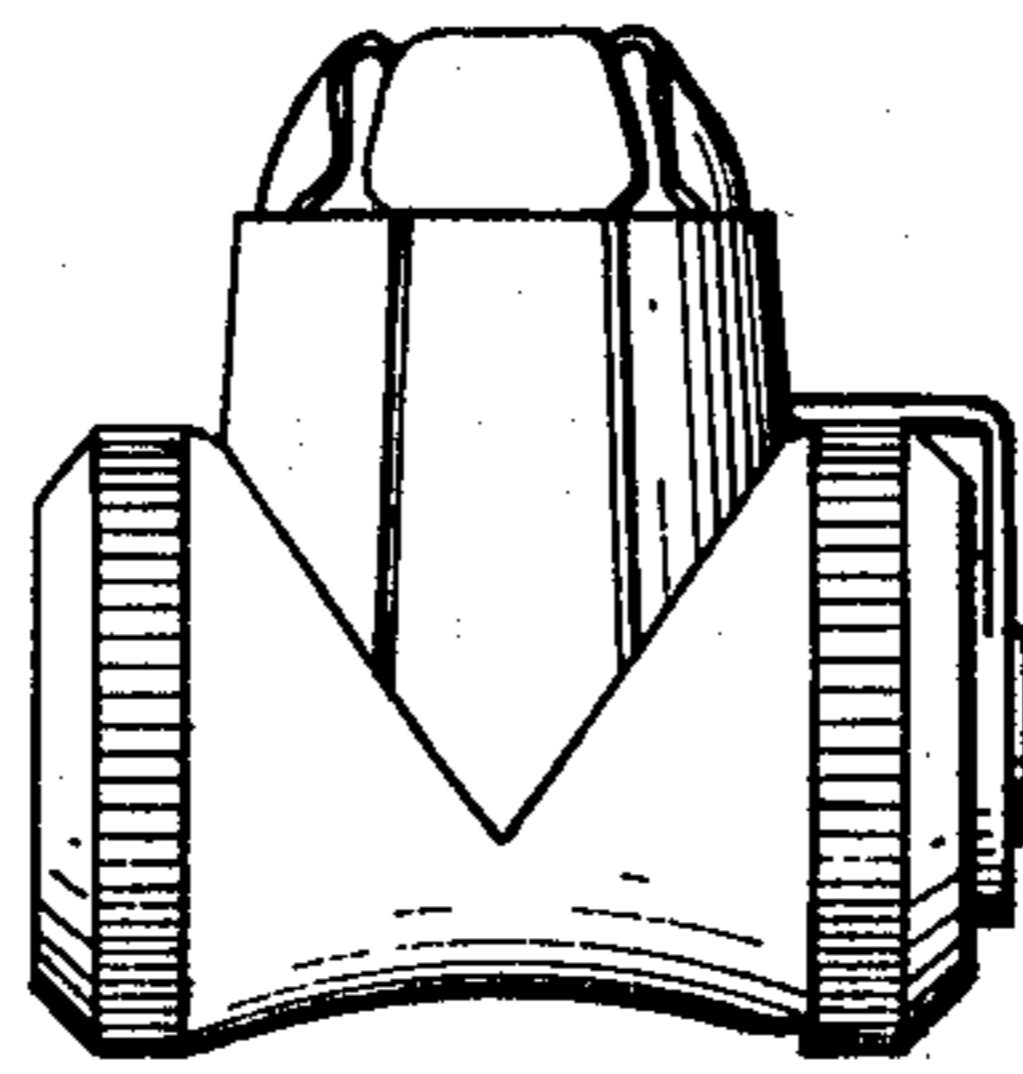

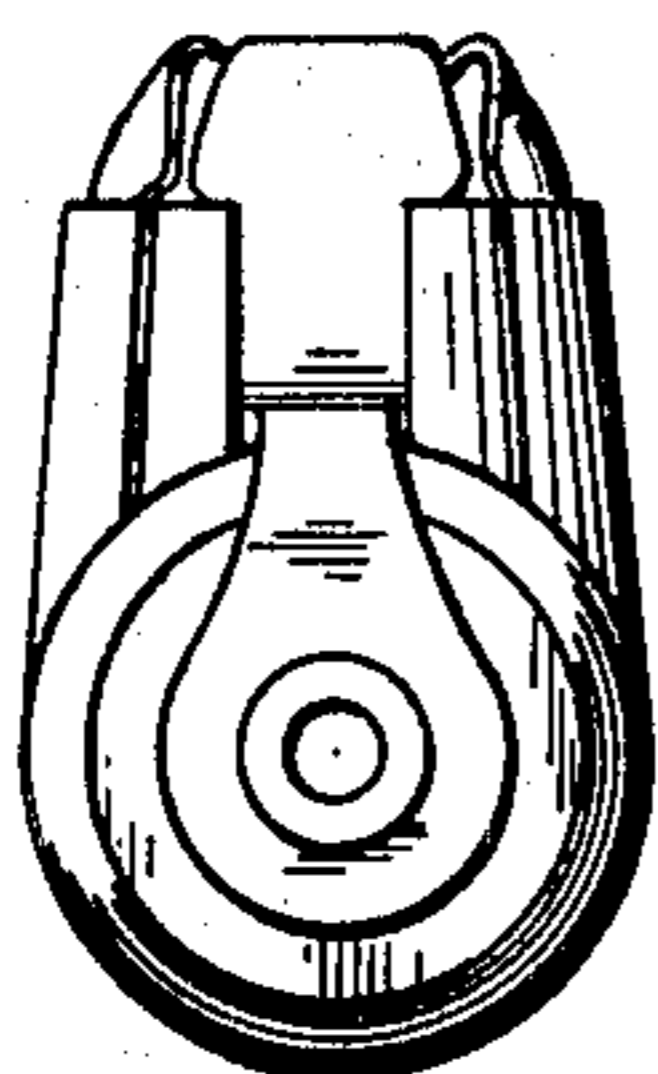

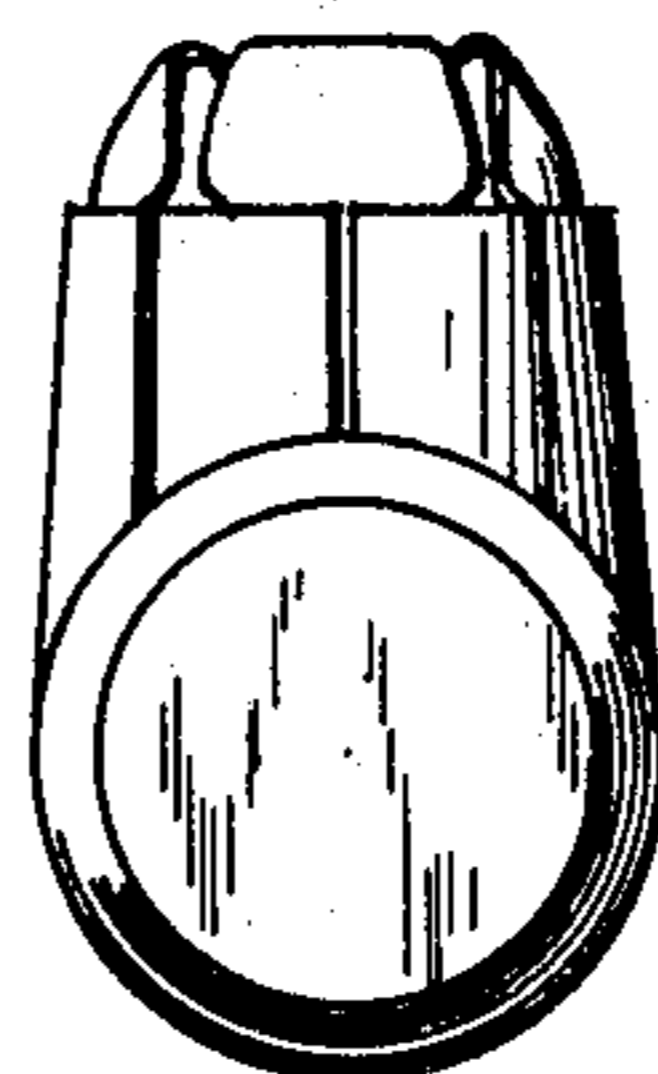

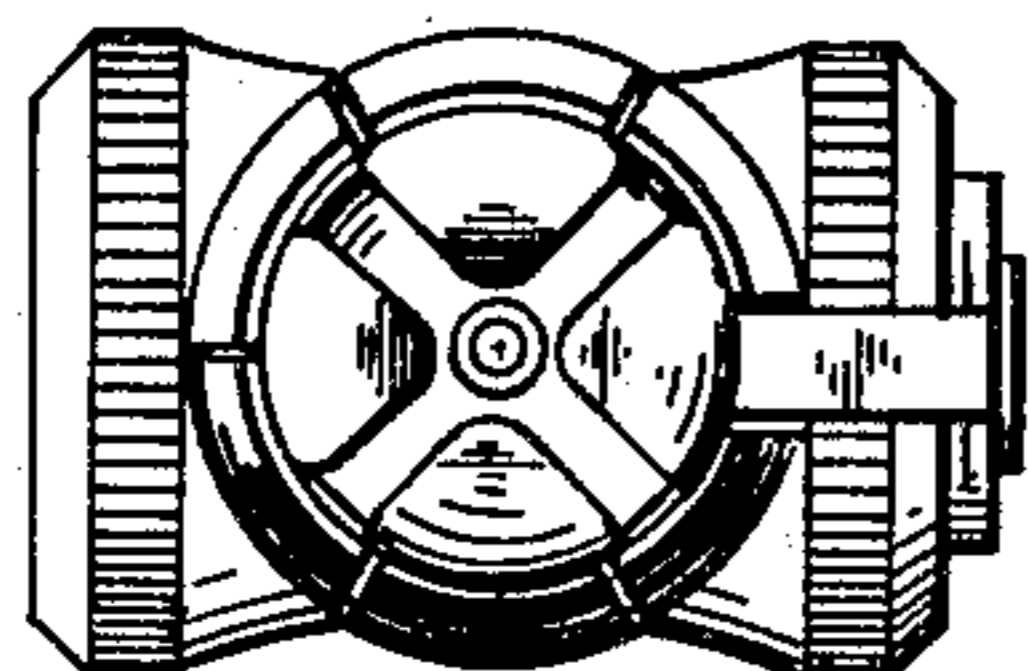

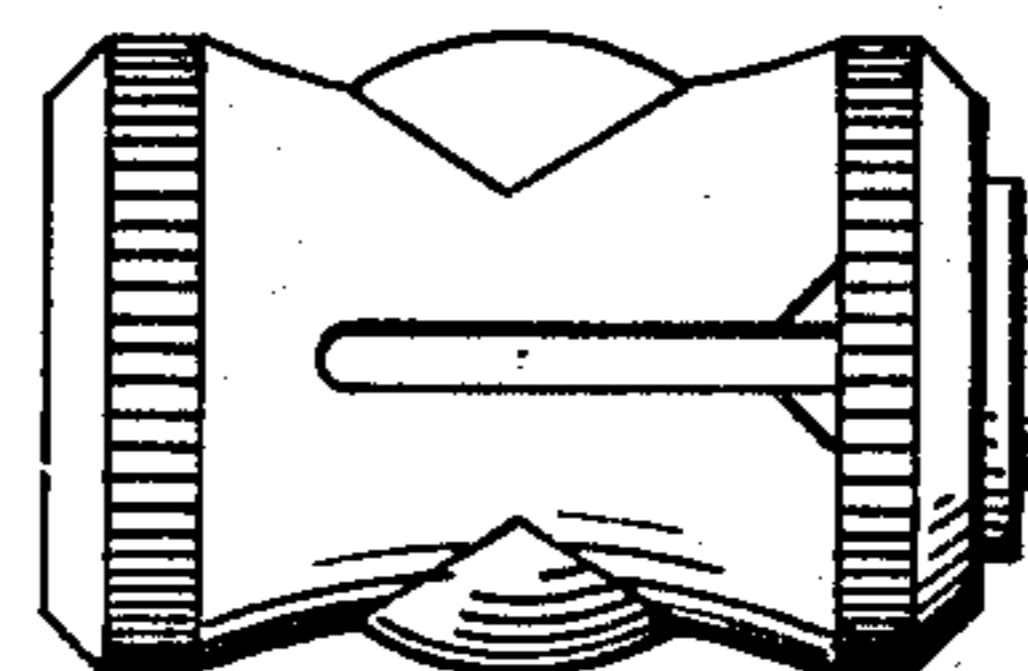

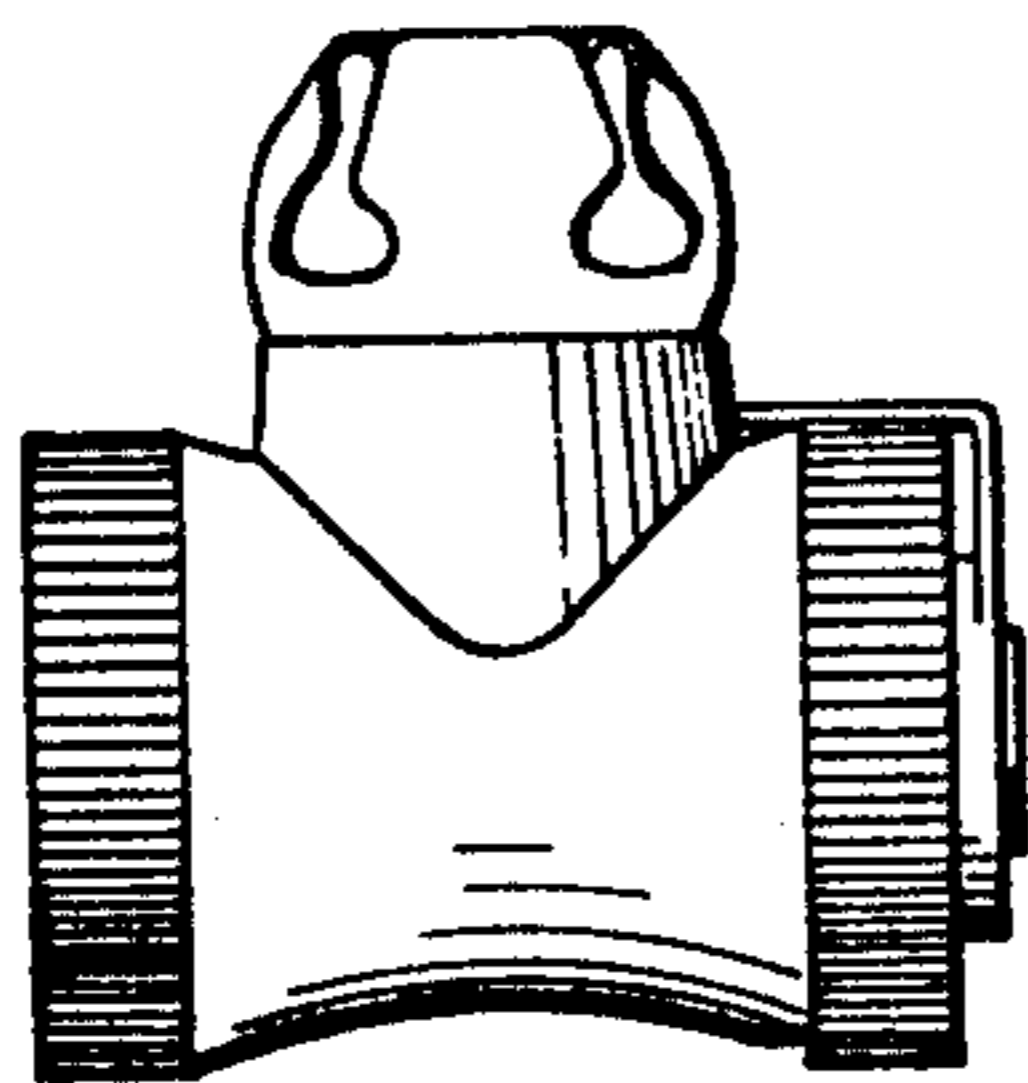

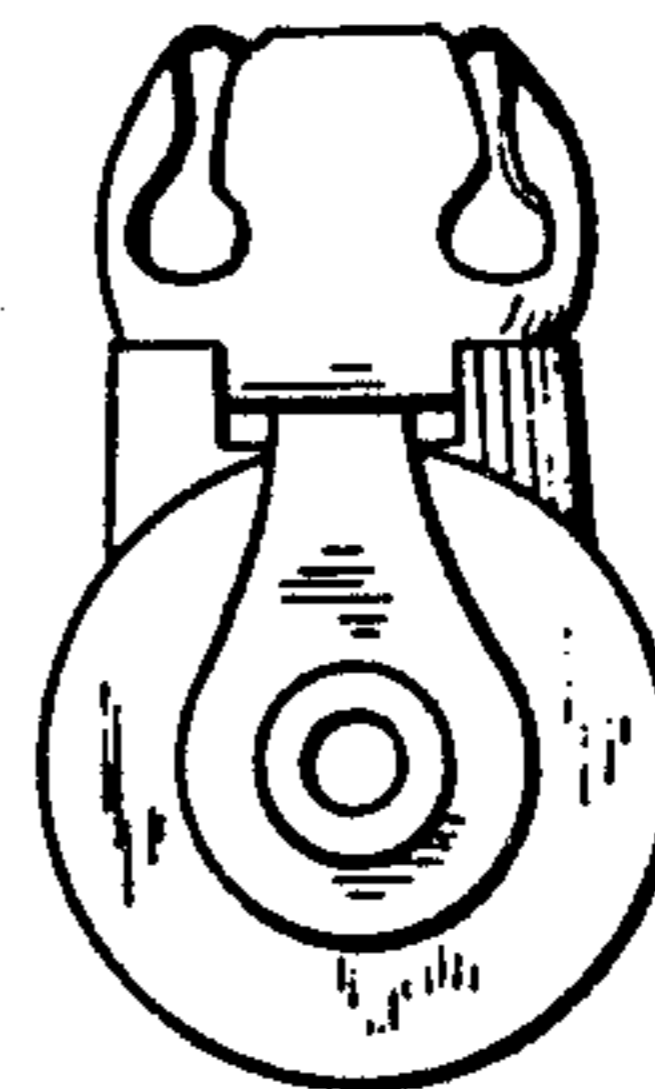

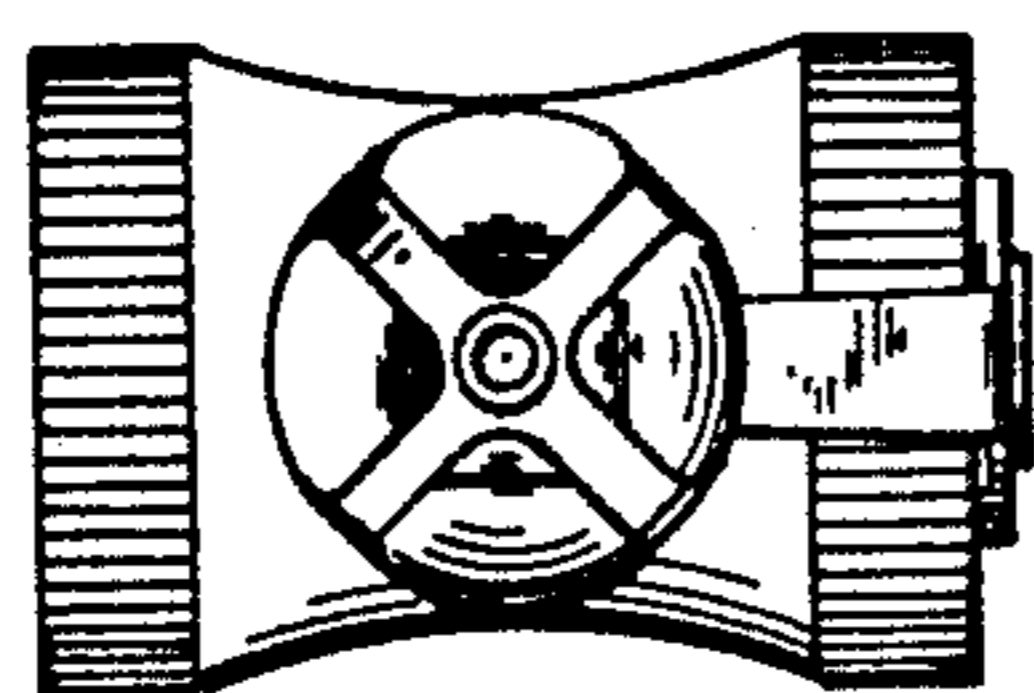

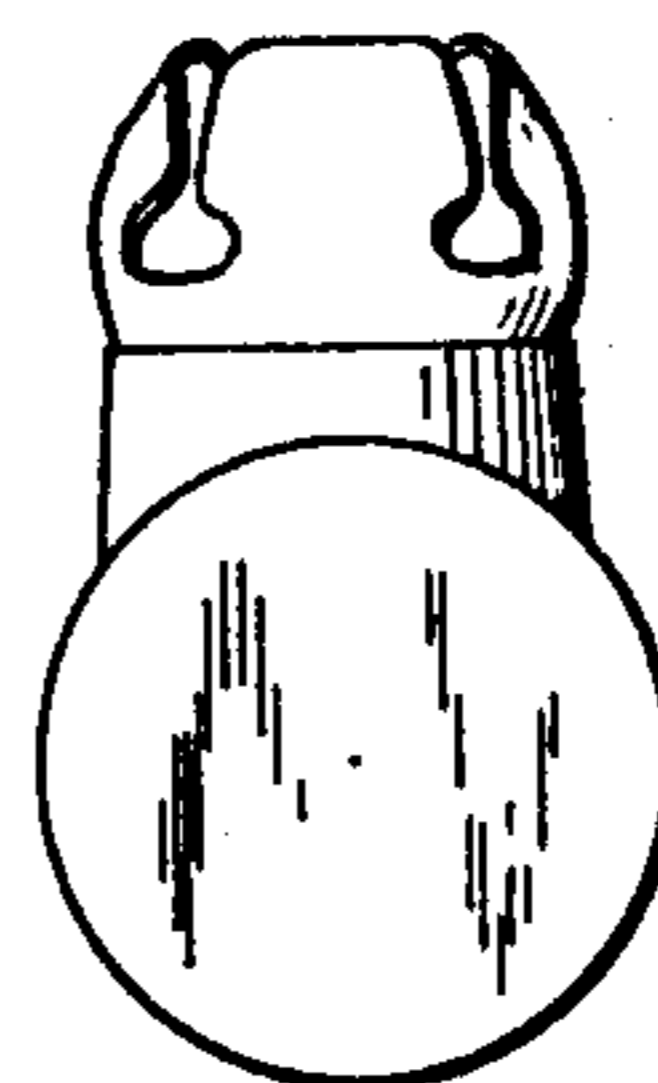

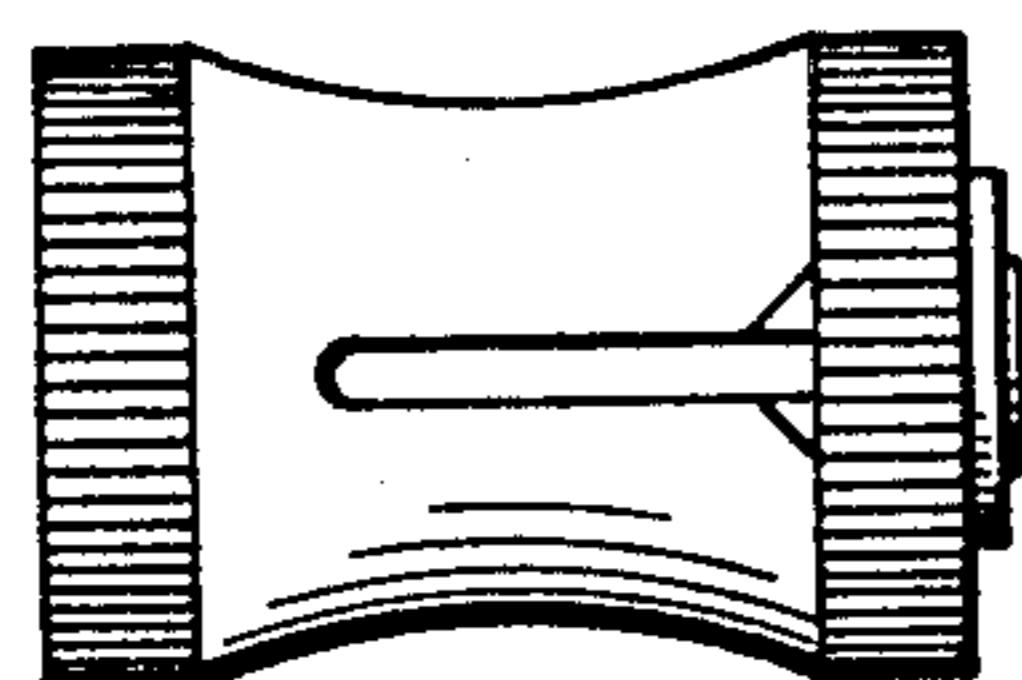

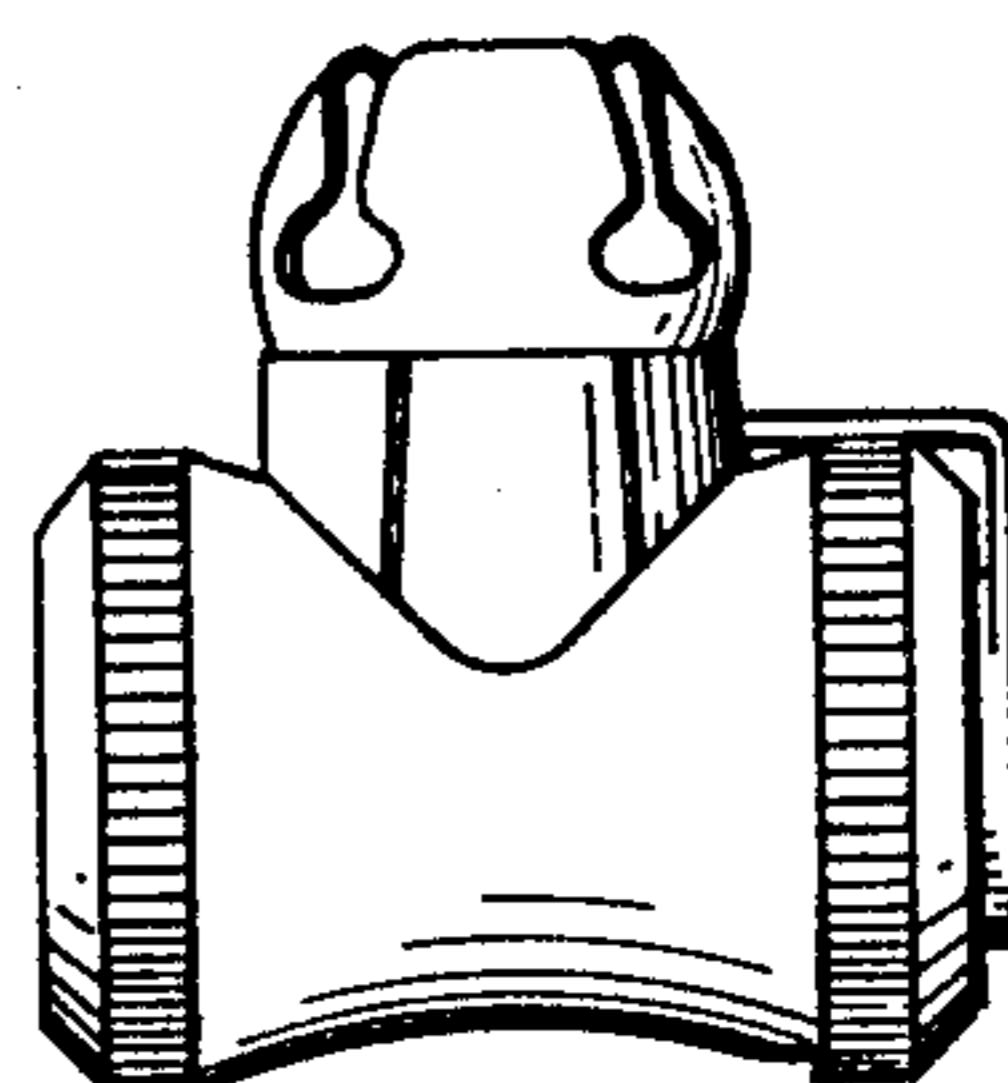

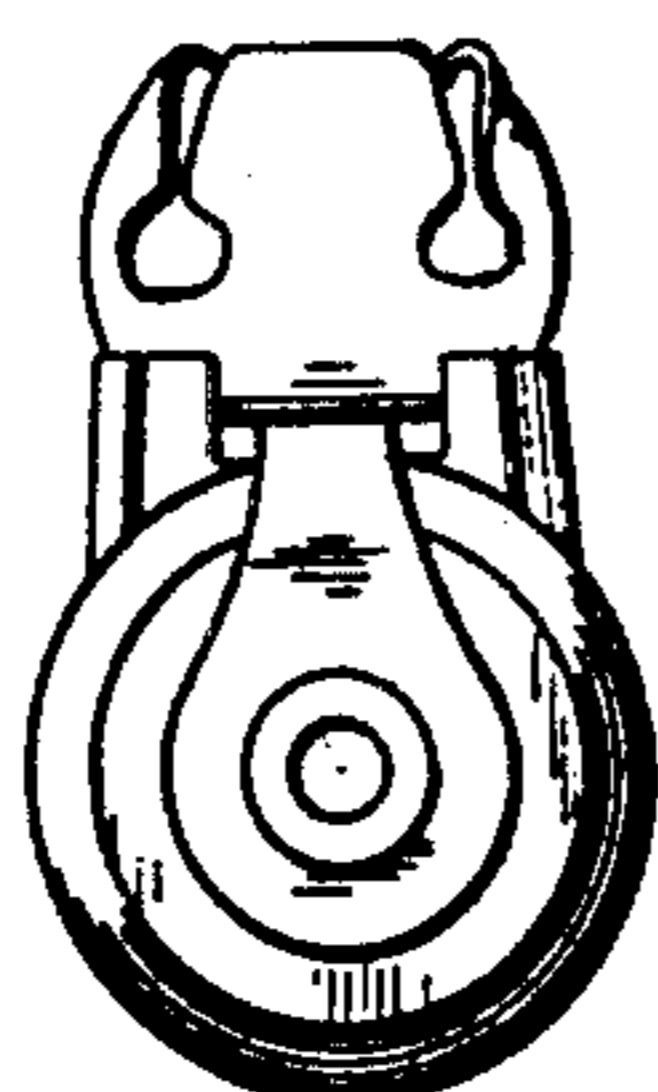

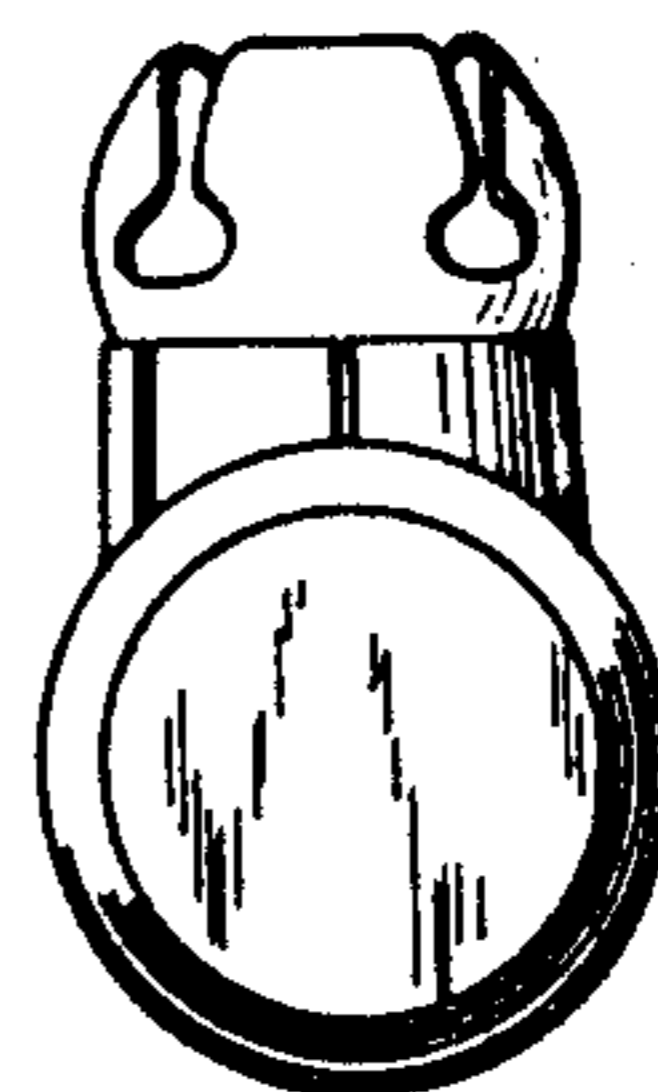

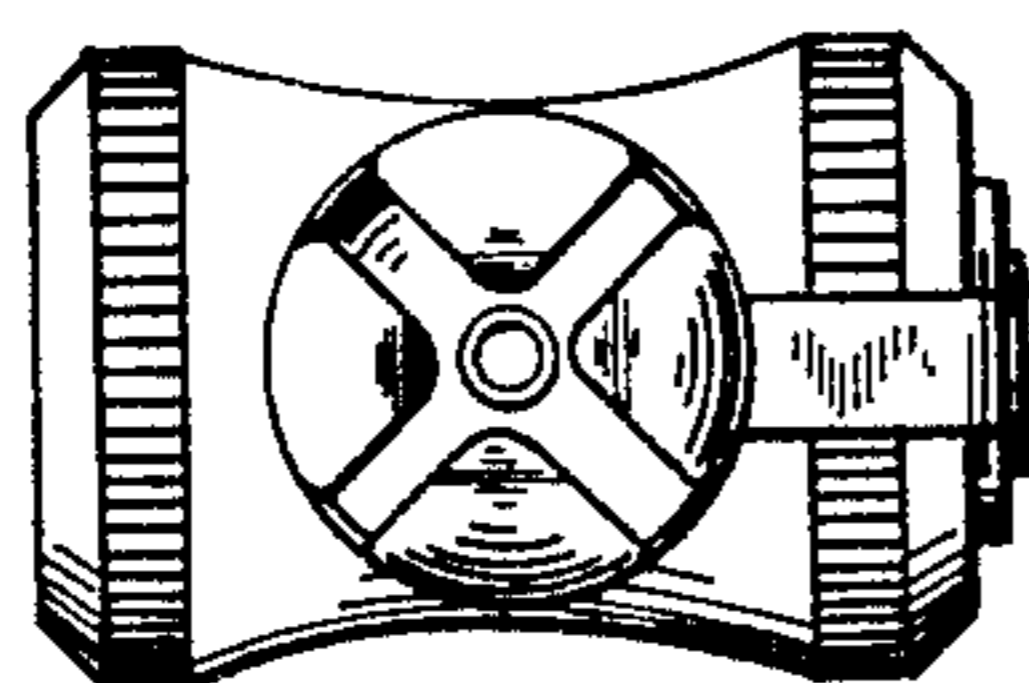
