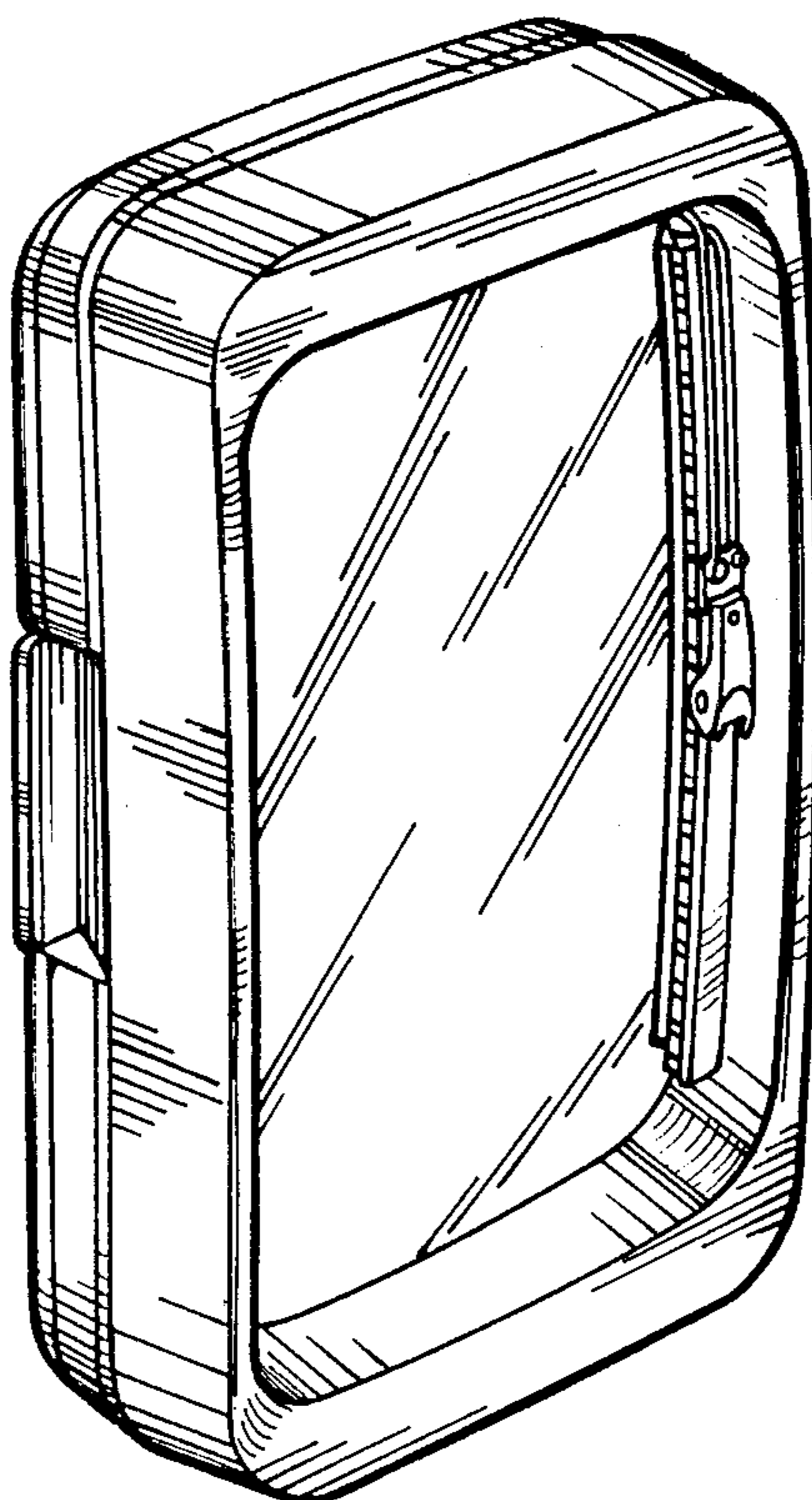

[57] **CLAIM**

The ornamental design for a rear view mirror, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the front, top and left side of a rear view mirror showing my new design which is mountable on the left side of an automobile; FIG. 2 is a perspective view of the front, bottom and left side thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a rear elevational view thereof; FIG. 9 is a perspective view of the front, top and right side of a rear view mirror showing a second embodiment of my new design, the difference being that it is mountable on the right side of an automobile; FIG. 10 is a perspective view of the front, bottom and right side of the embodiment of FIG. 9; FIG. 11 is a left side elevational view of the embodiment of FIG. 9; FIG. 12 is a front elevational view of the embodiment of FIG. 9; FIG. 13 is a right side elevational view of the embodiment of FIG. 9; FIG. 14 is a top plan view of the embodiment of FIG. 9; FIG. 15 is a bottom plan view of the embodiment of FIG. 9; FIG. 16 is a rear elevational view of the embodiment of FIG. 9.



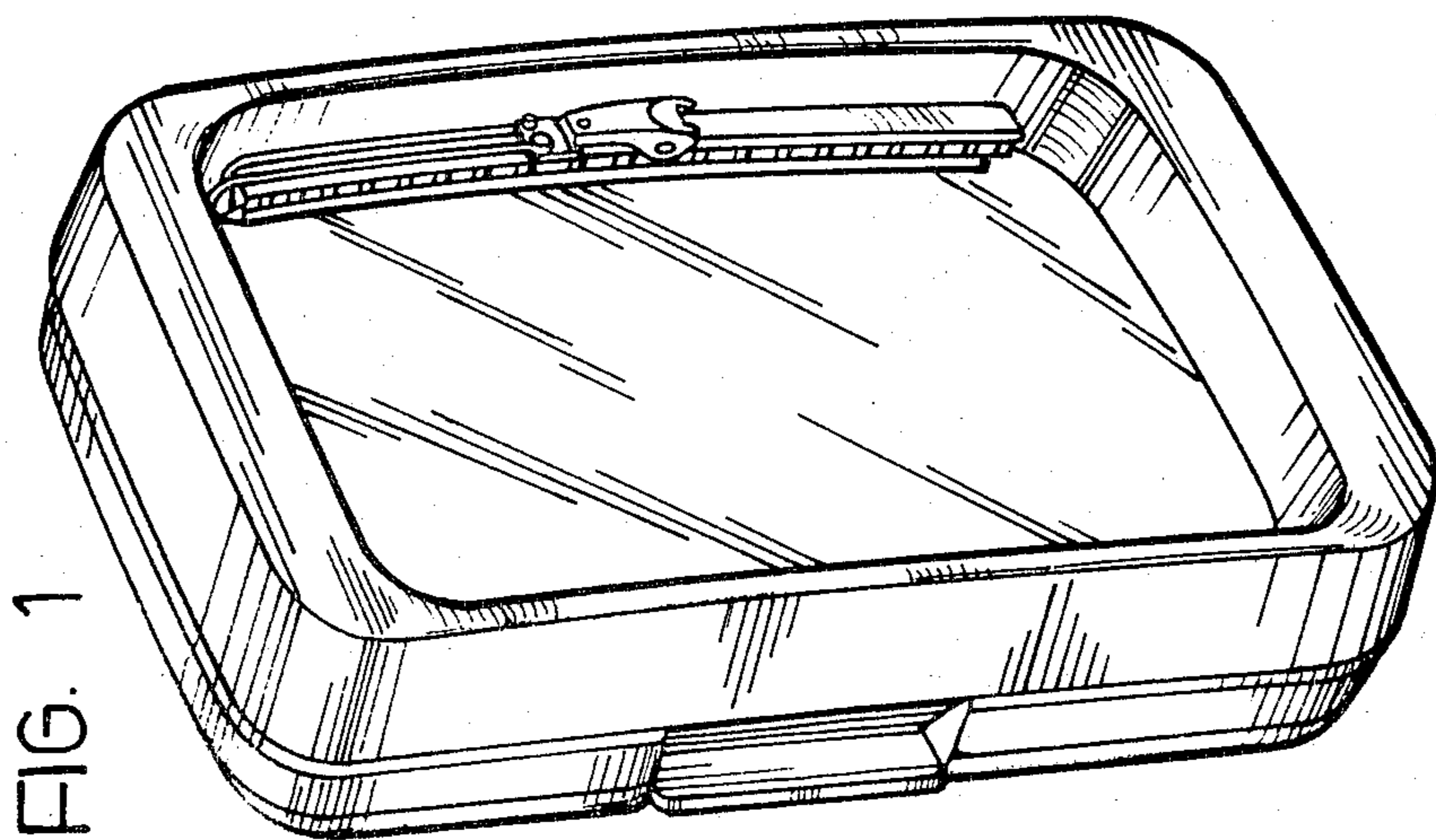
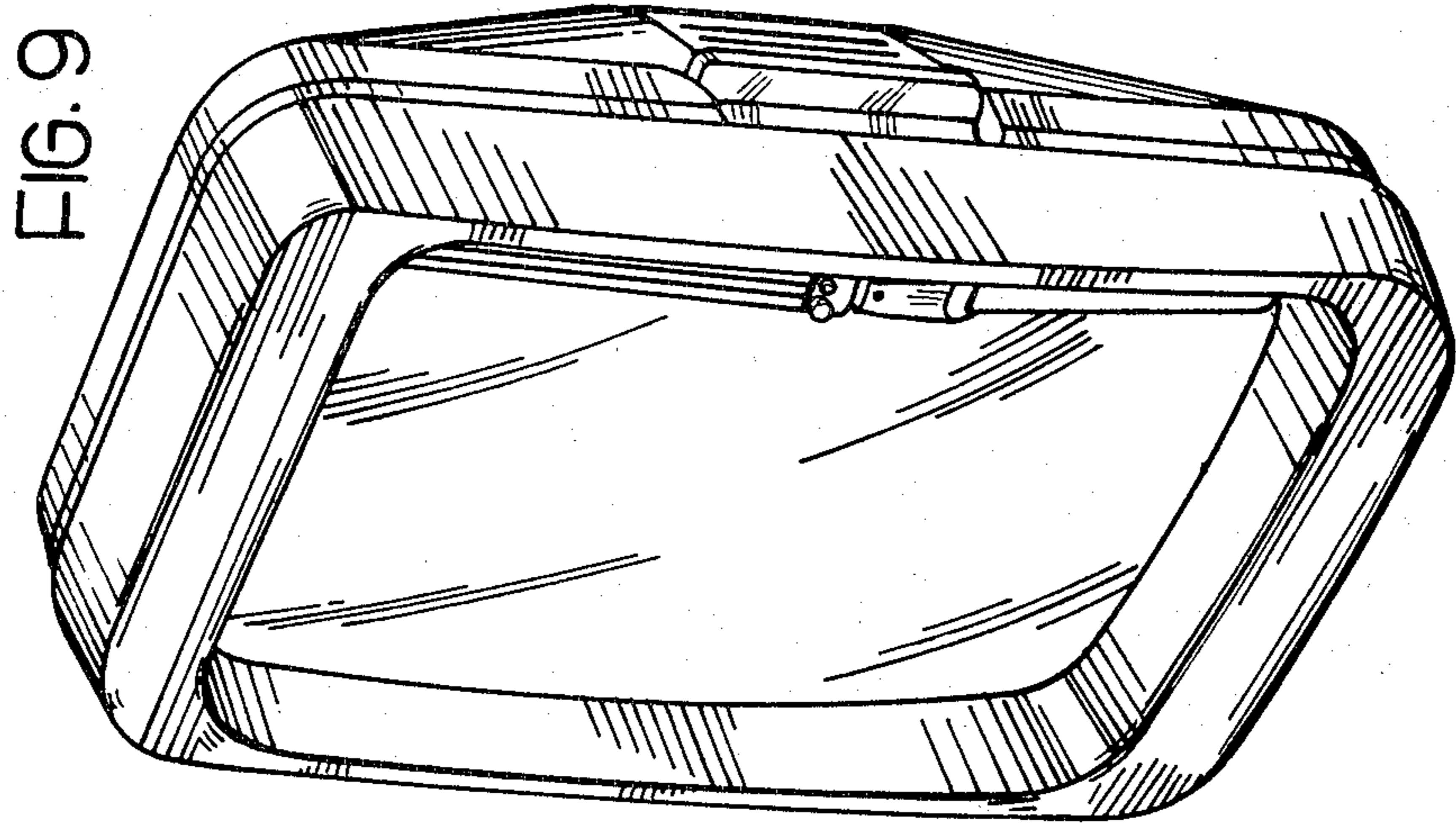

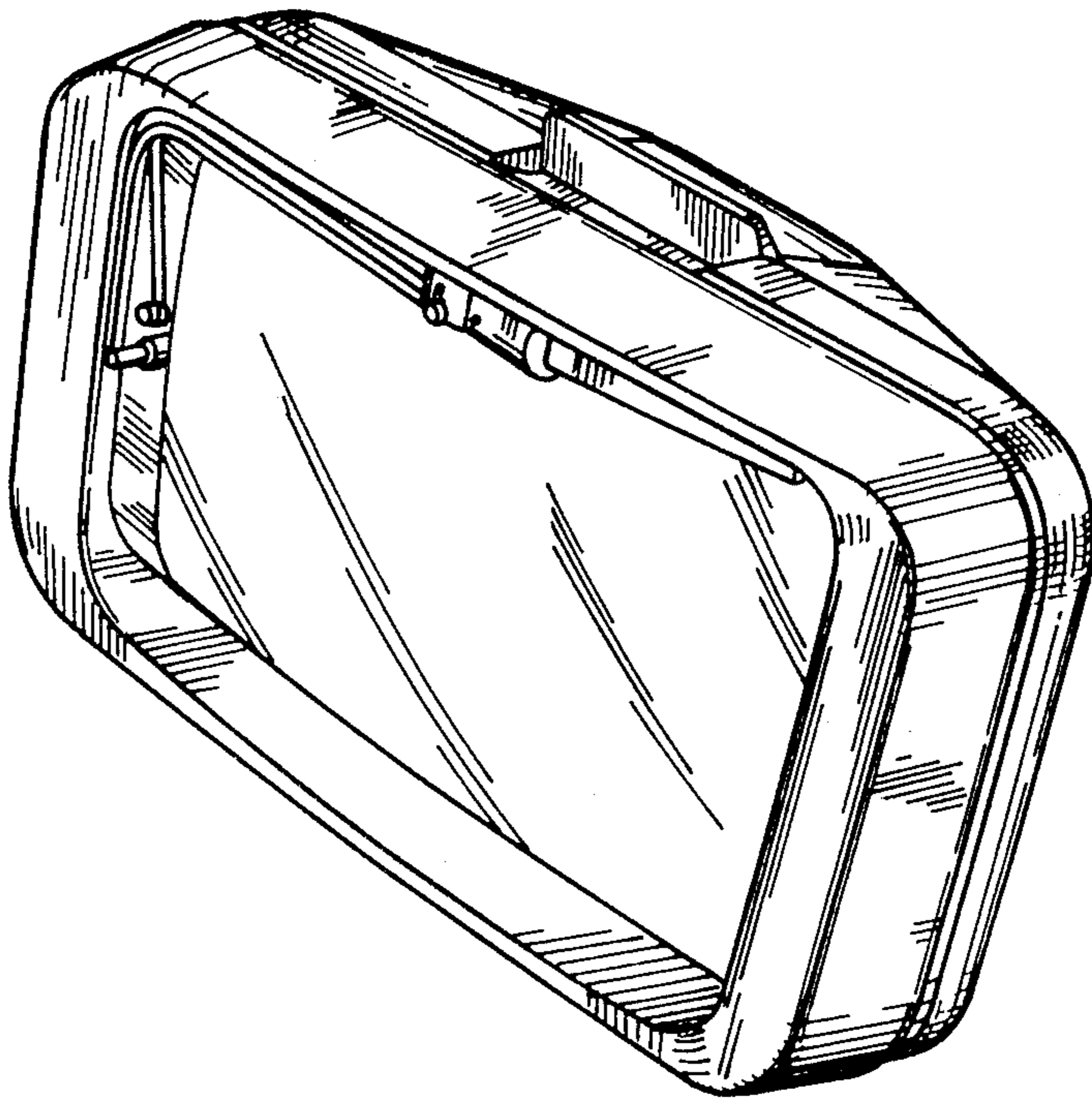

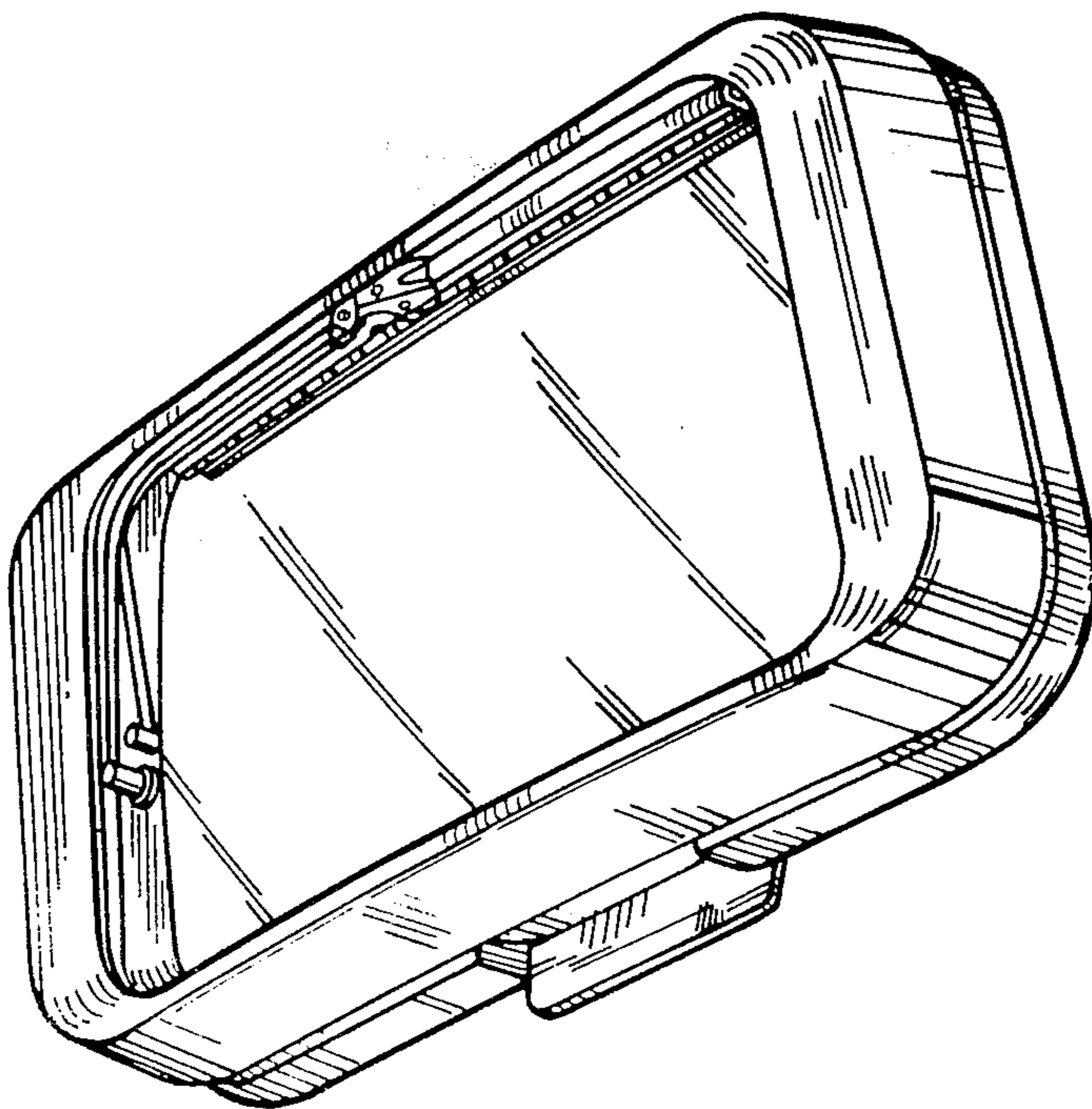

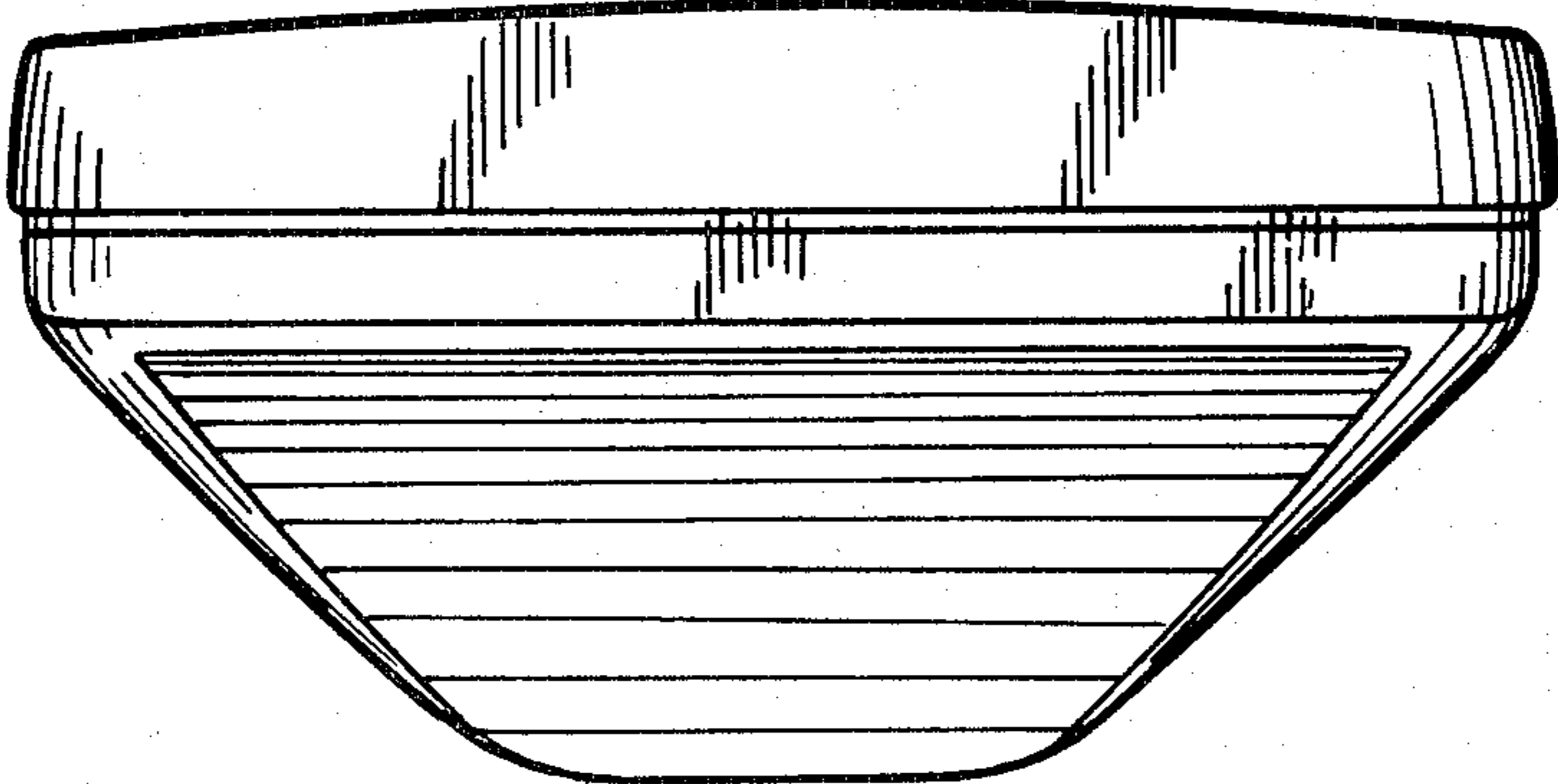

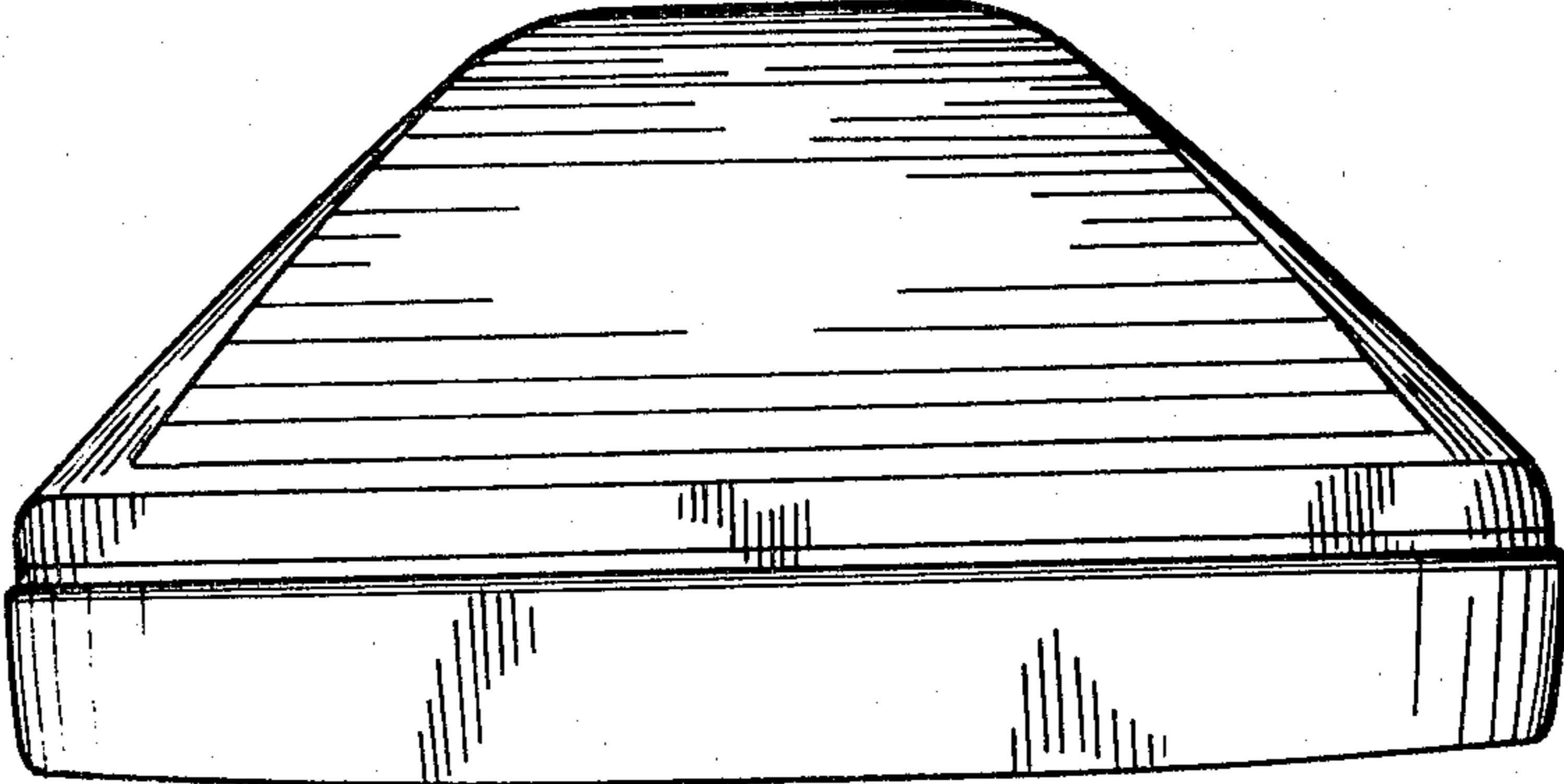

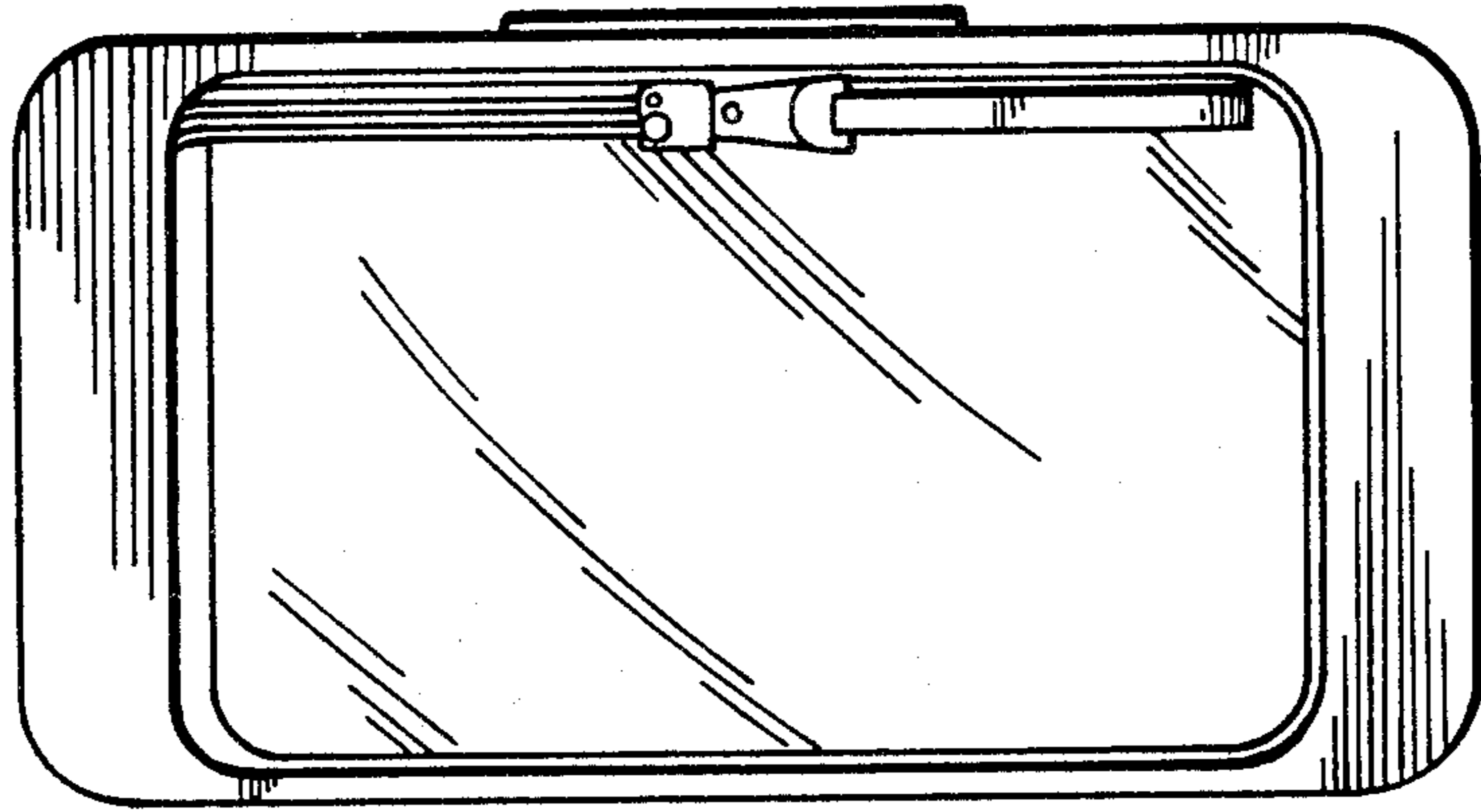

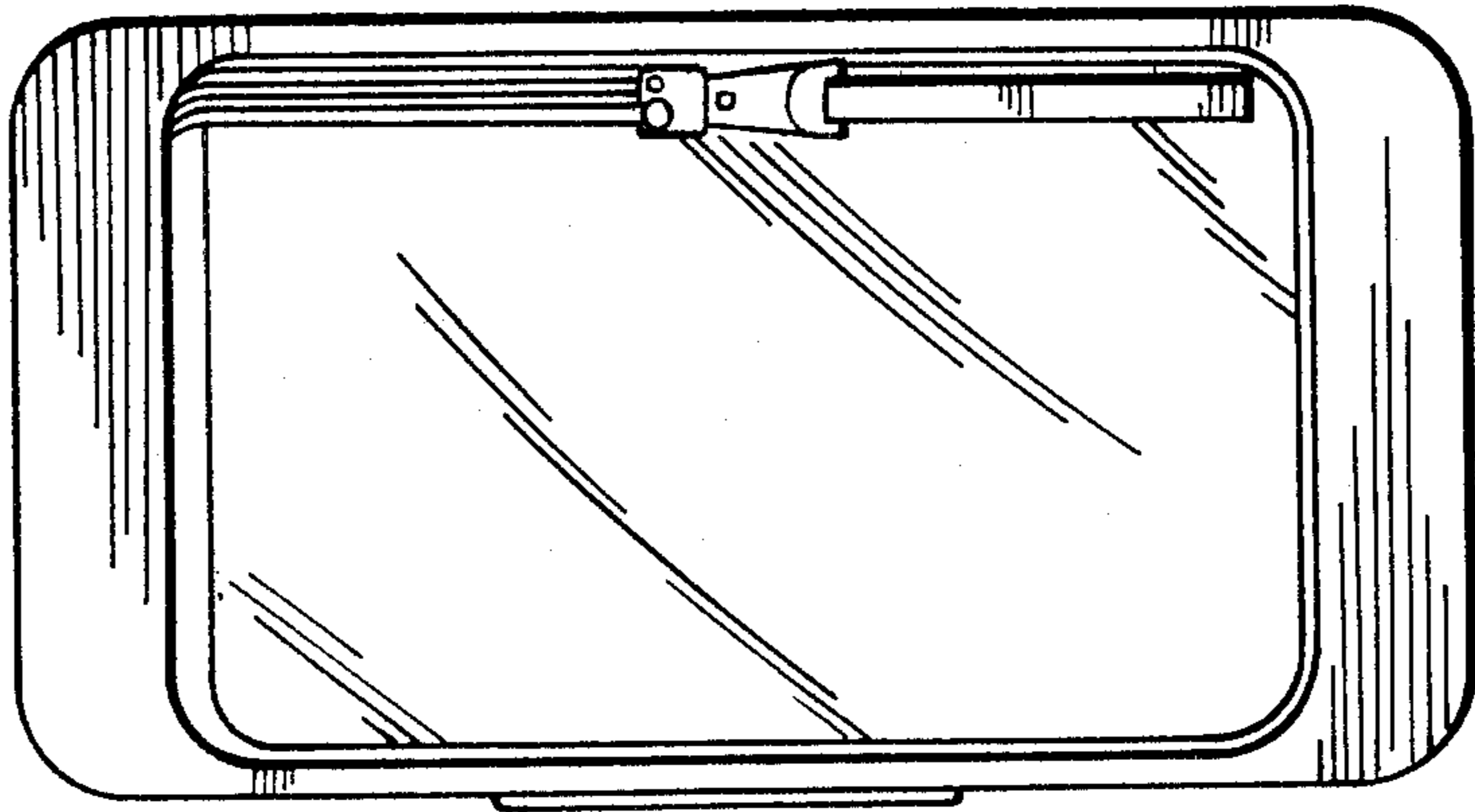

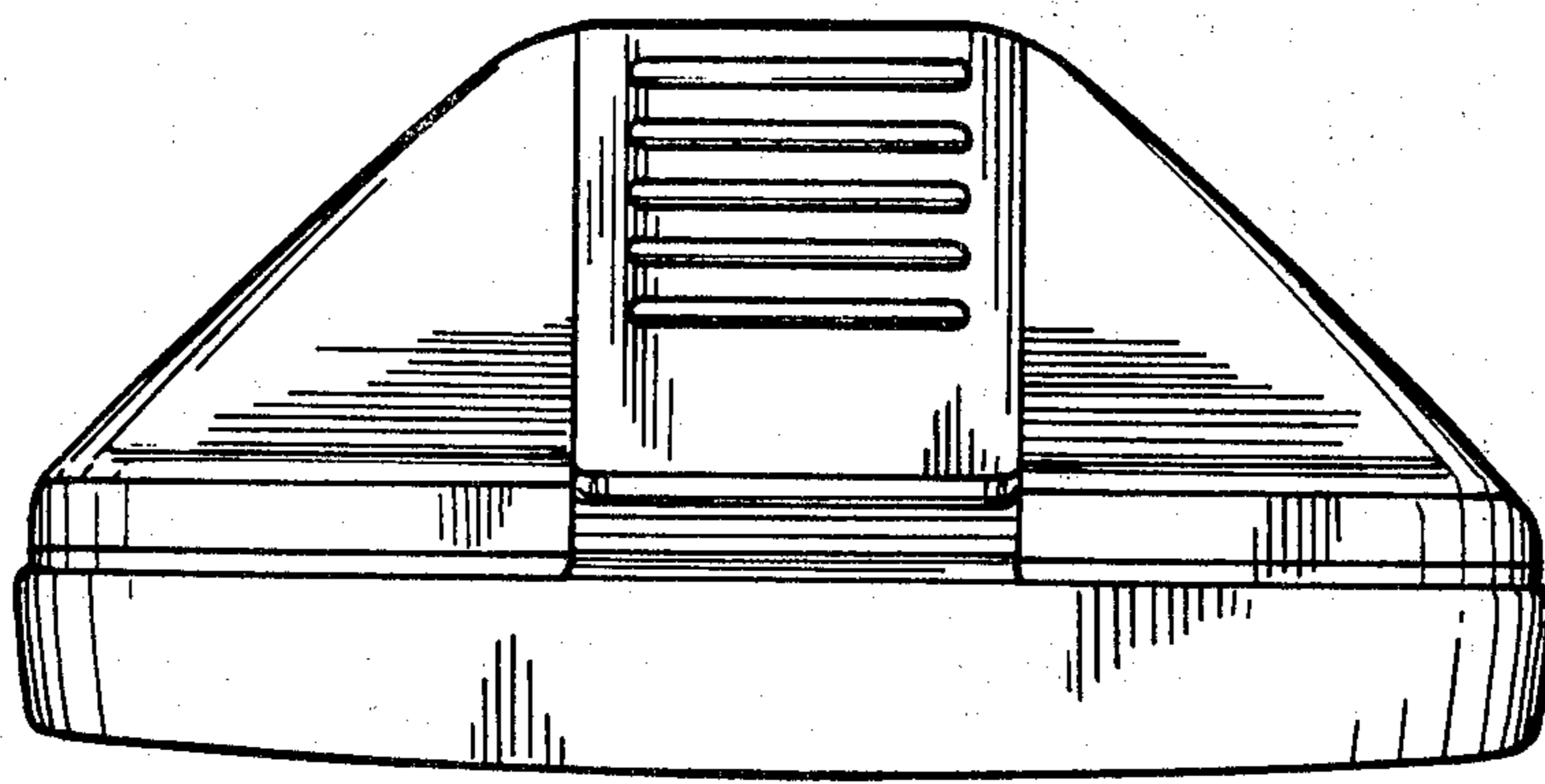

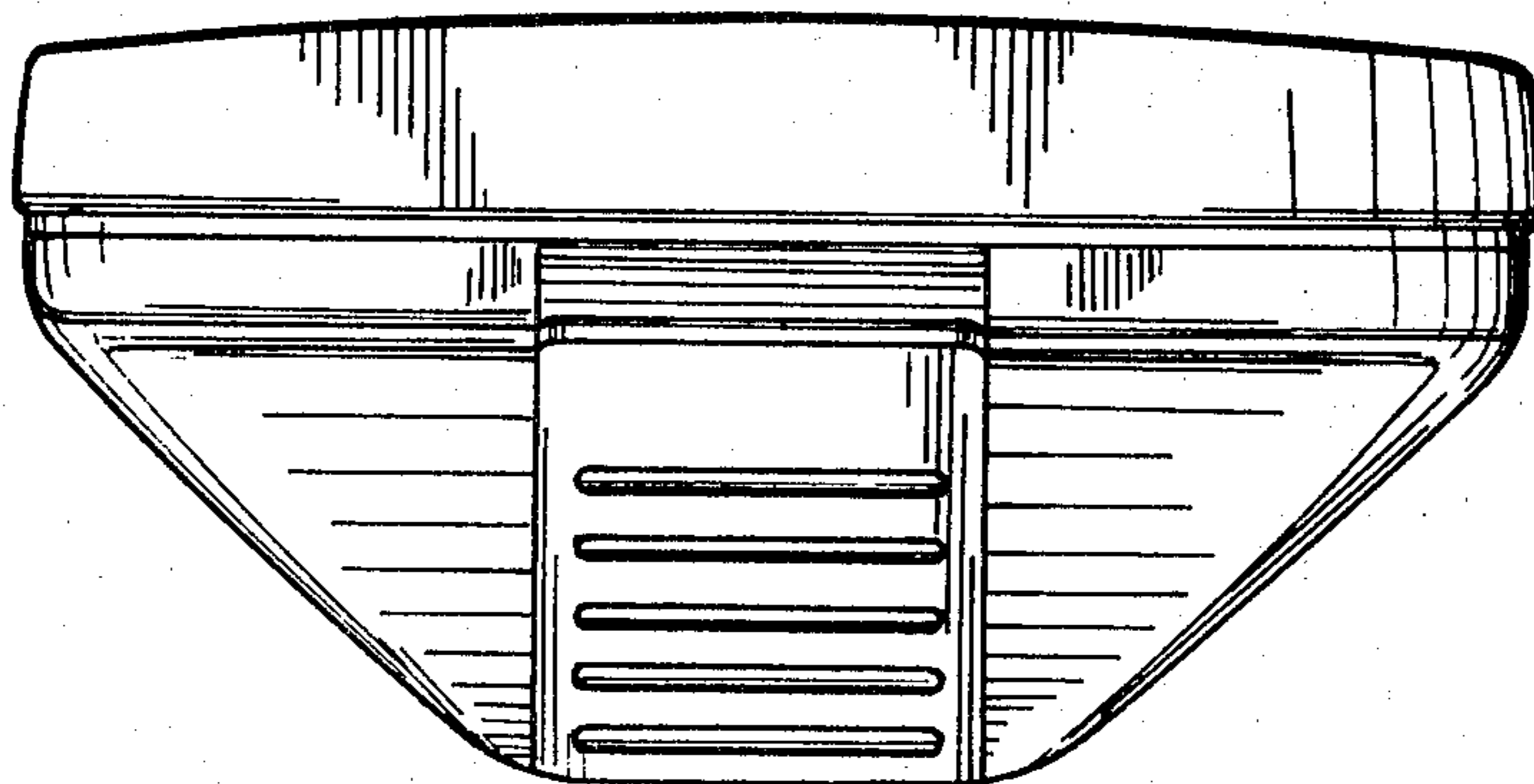

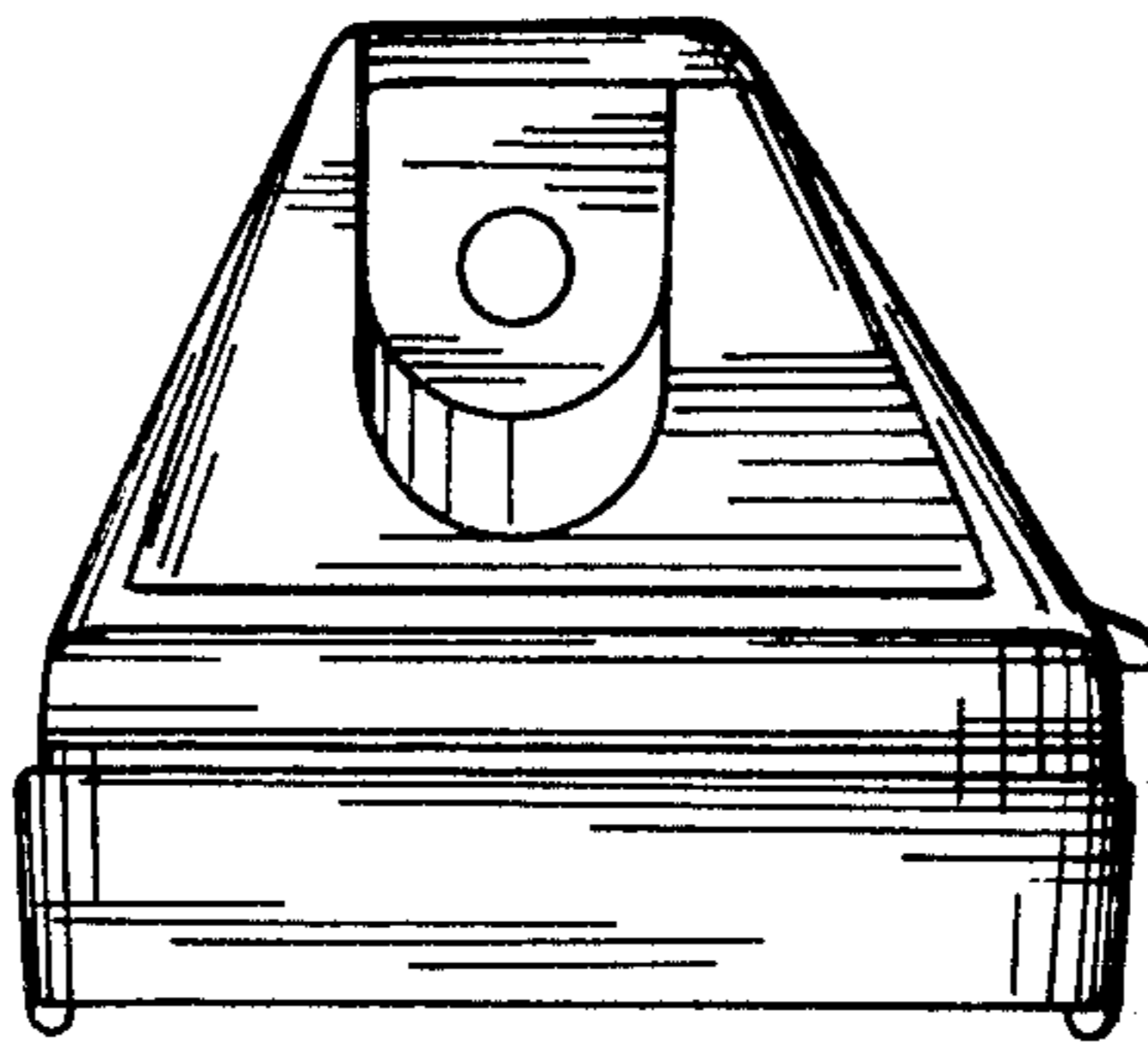

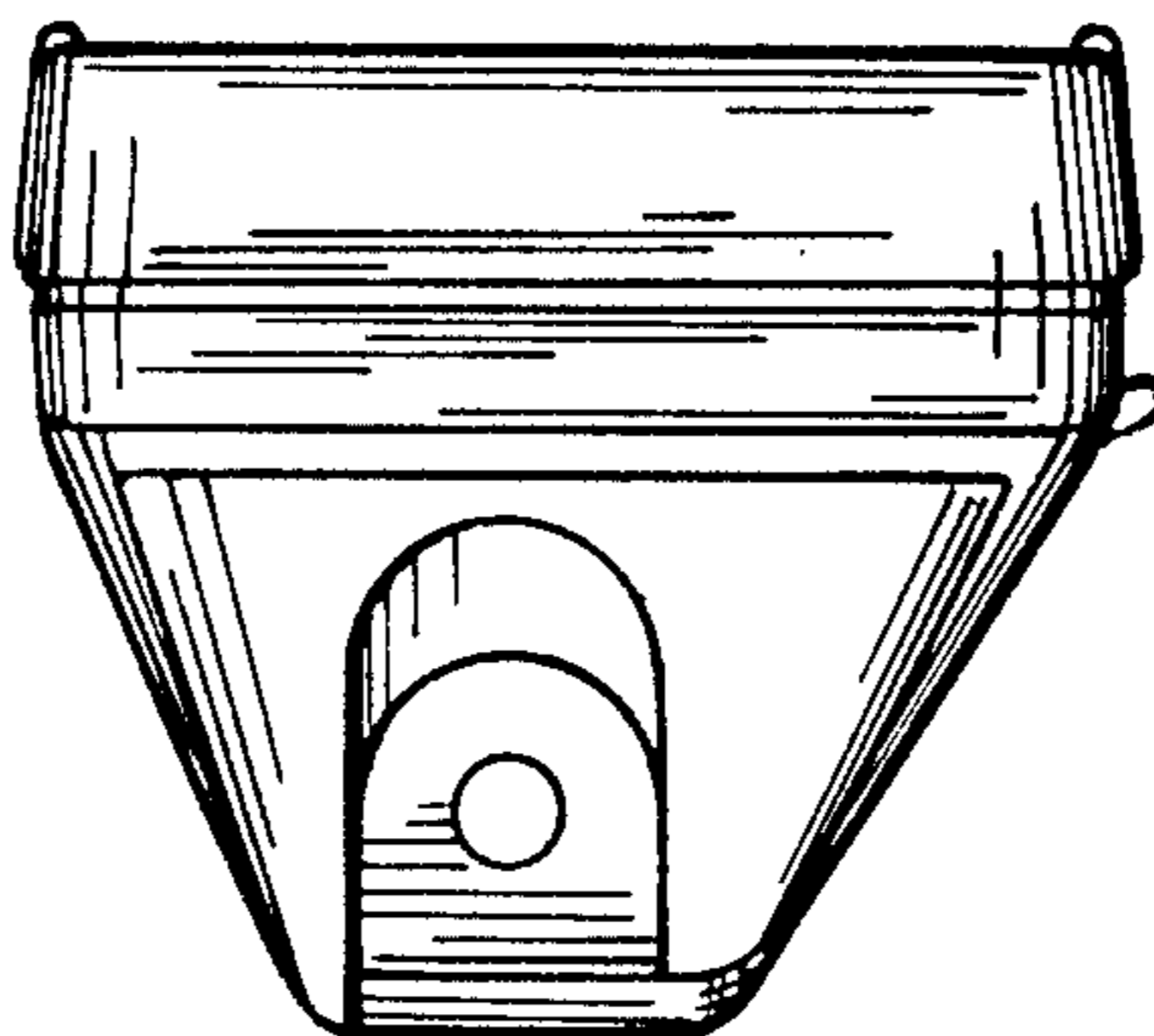

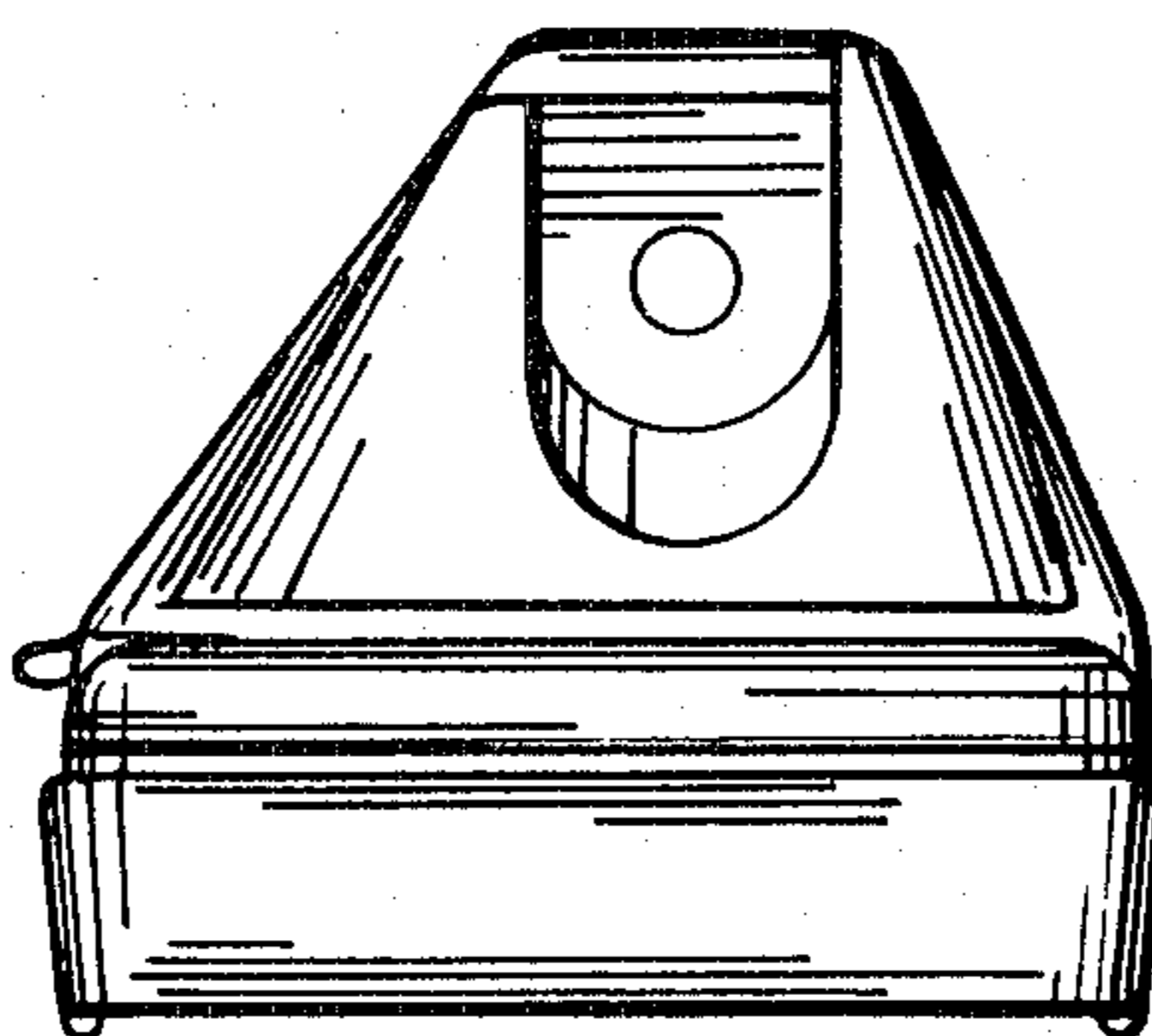

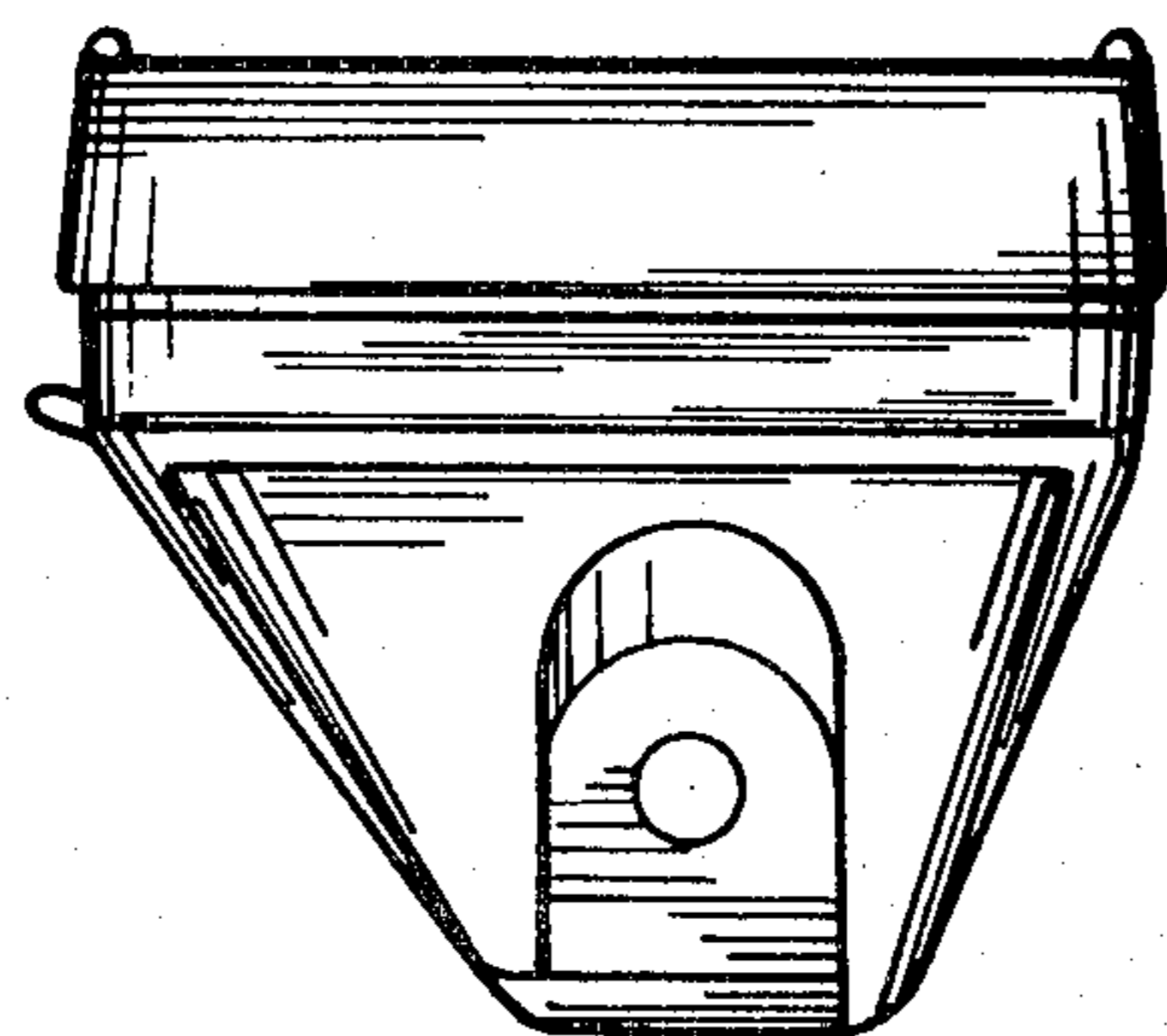

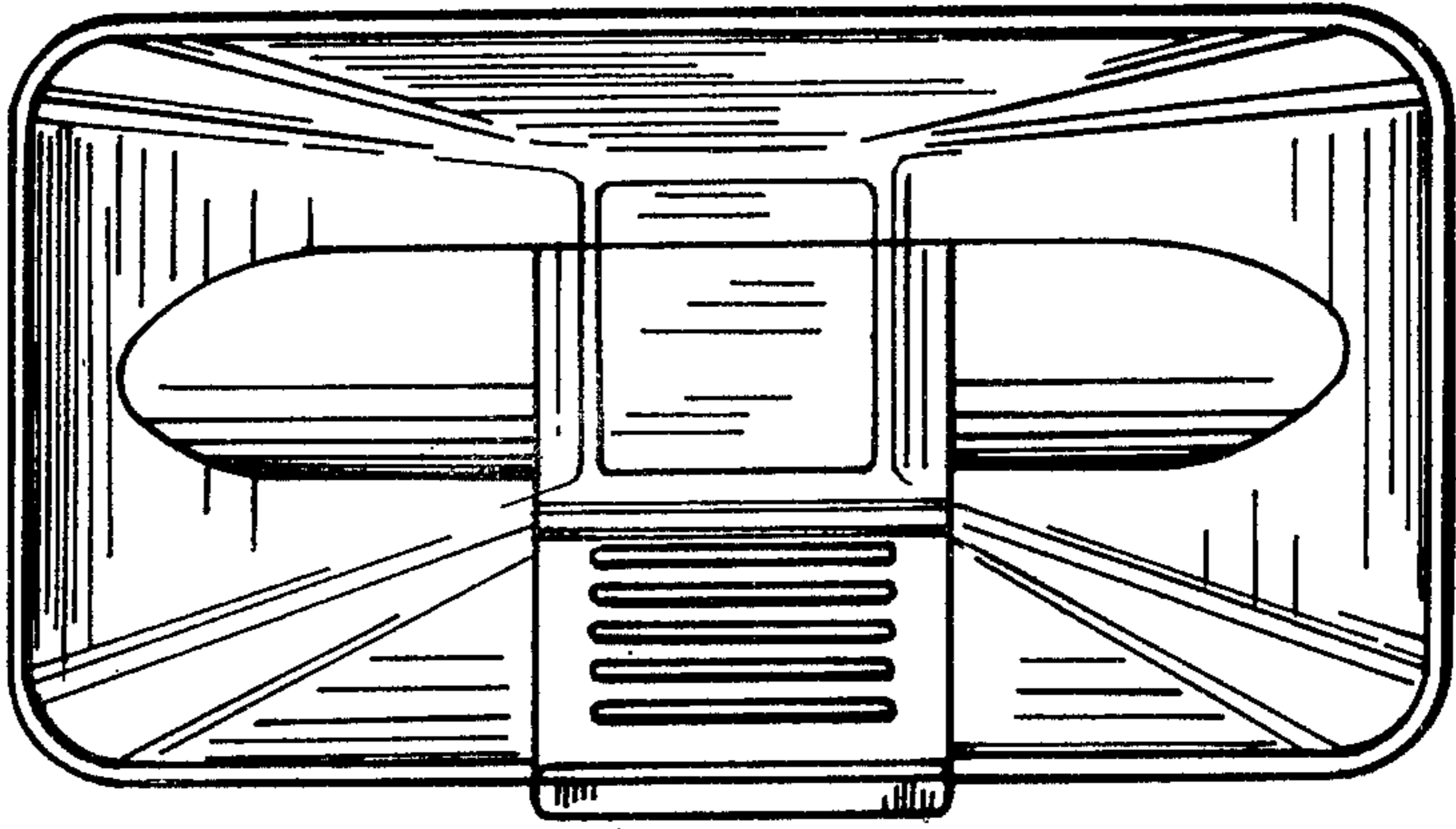
