[57] CLAIM

The ornamental design for an elevator hoisting engine, substantially as shown.

DESCRIPTION

FIG. 1 is a front elevational view of an elevator hoisting engine, showing our new design;

 FIG. 18 is a right side elevational view thereof.

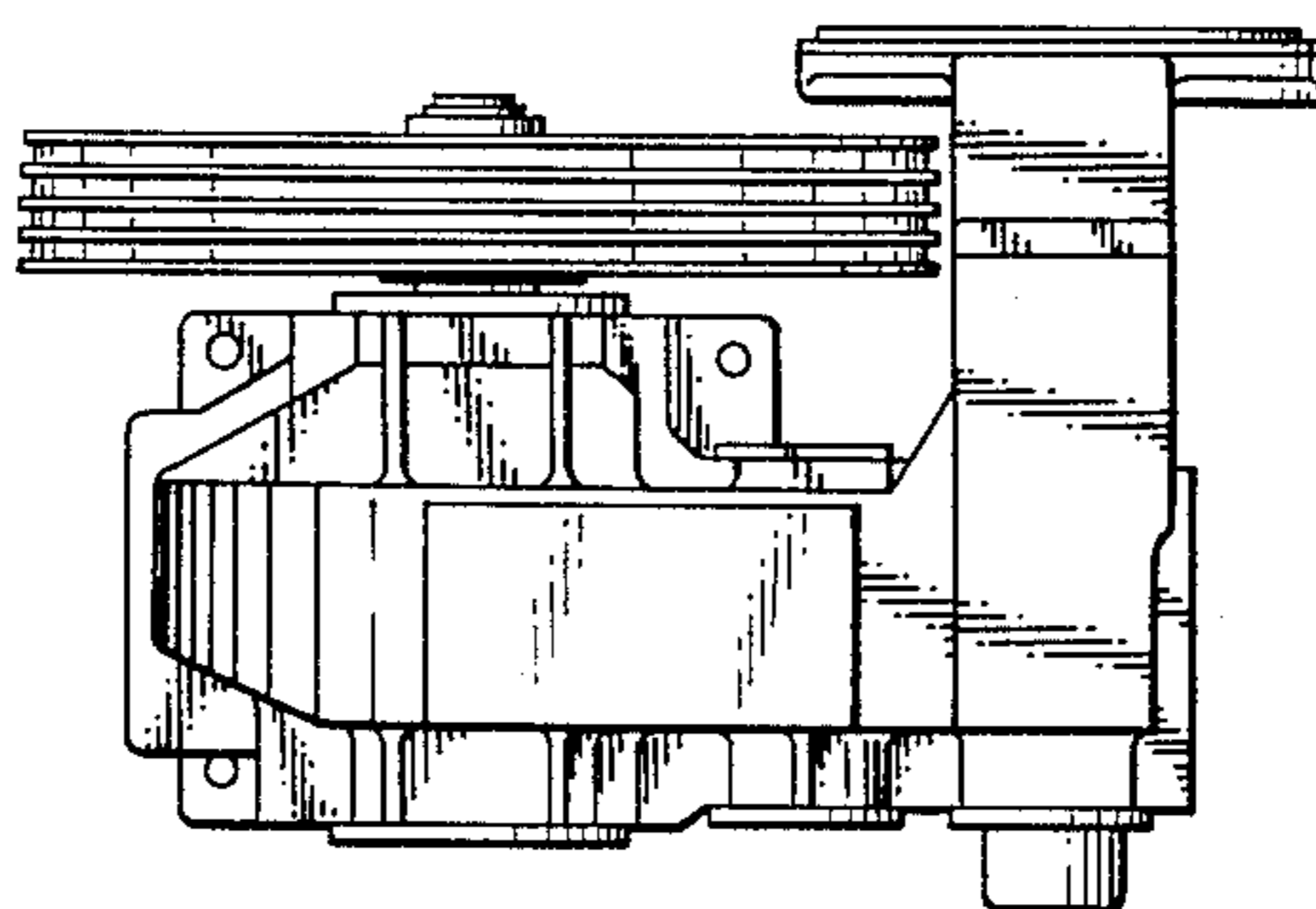
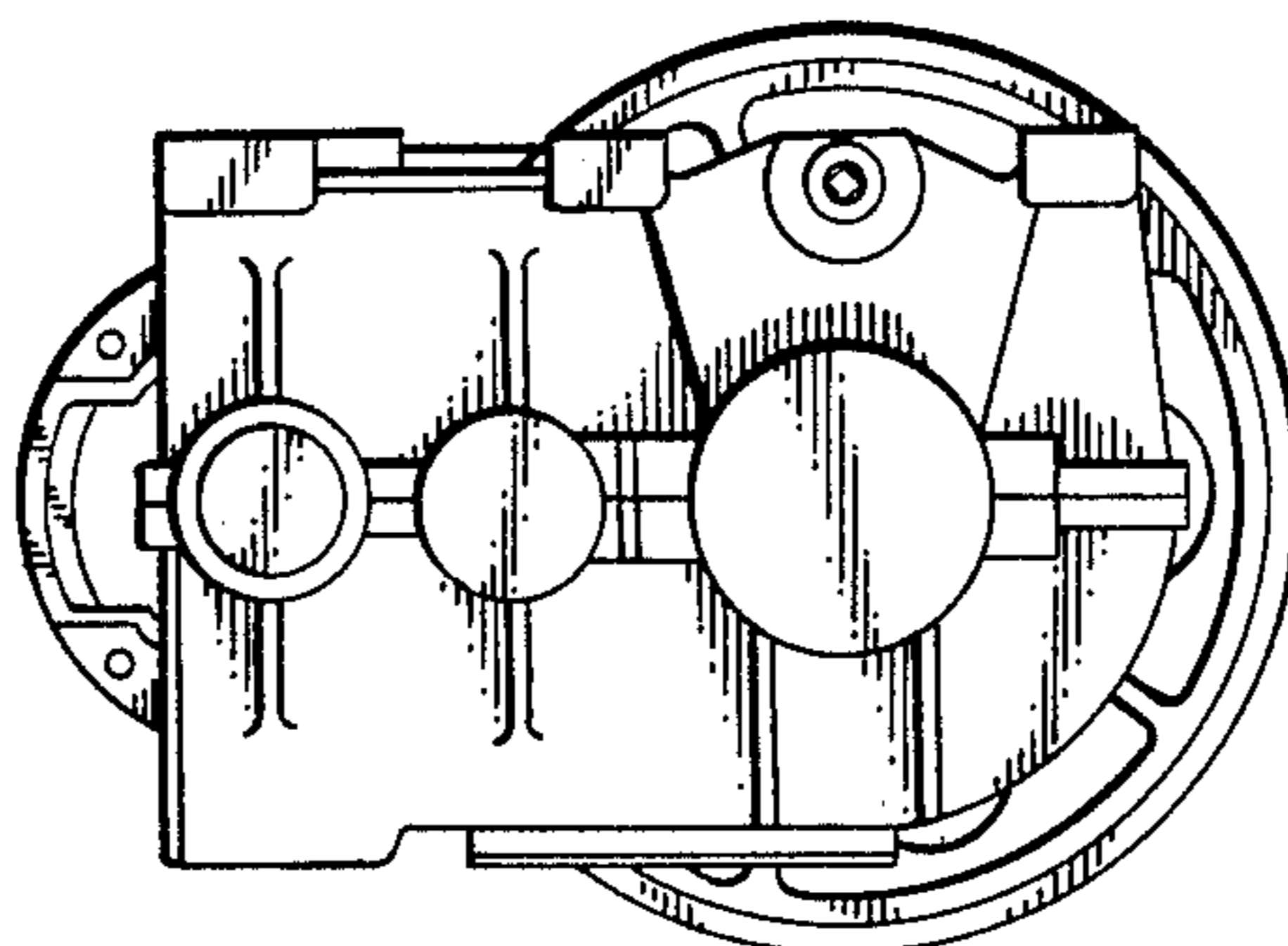

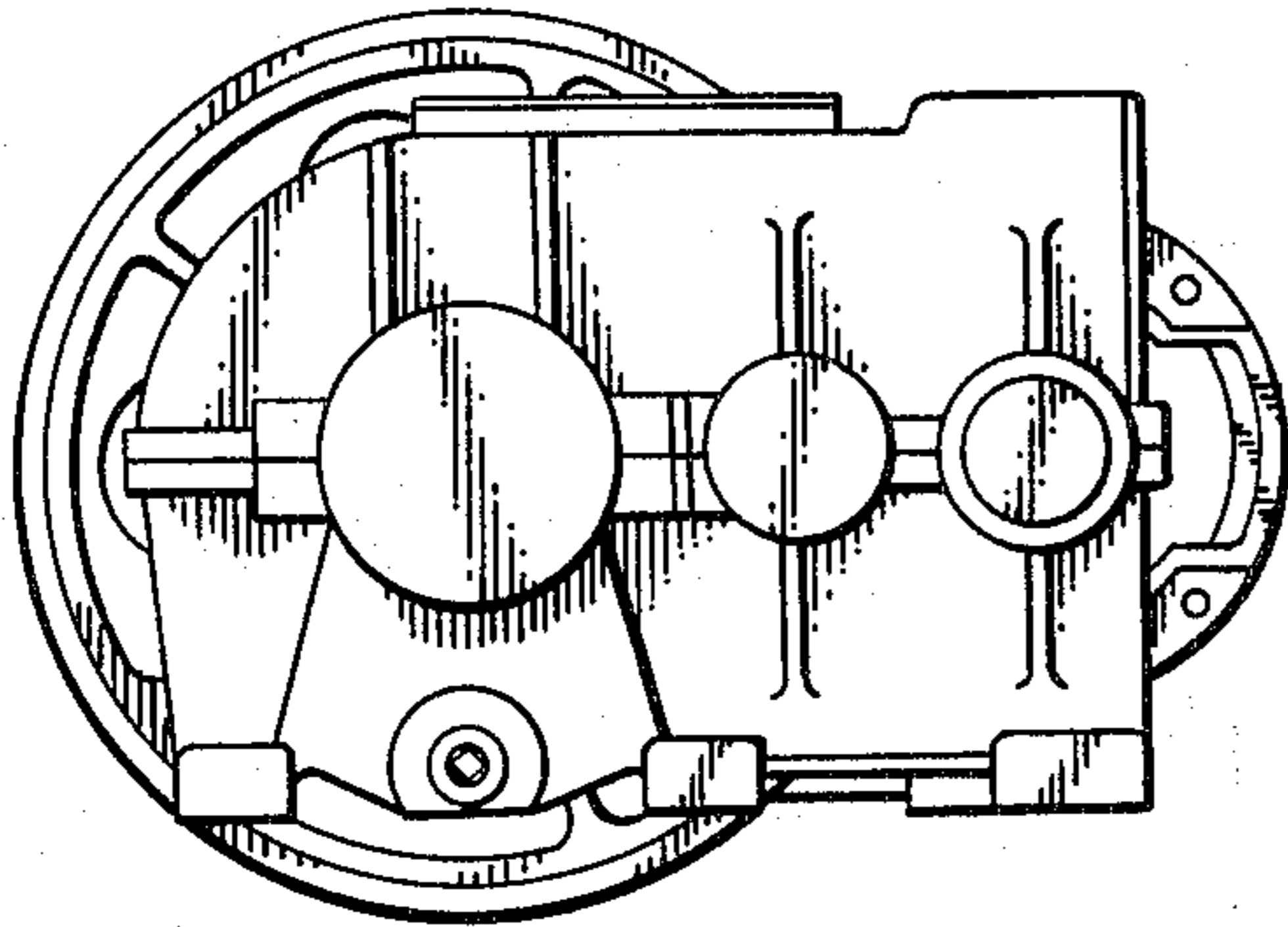

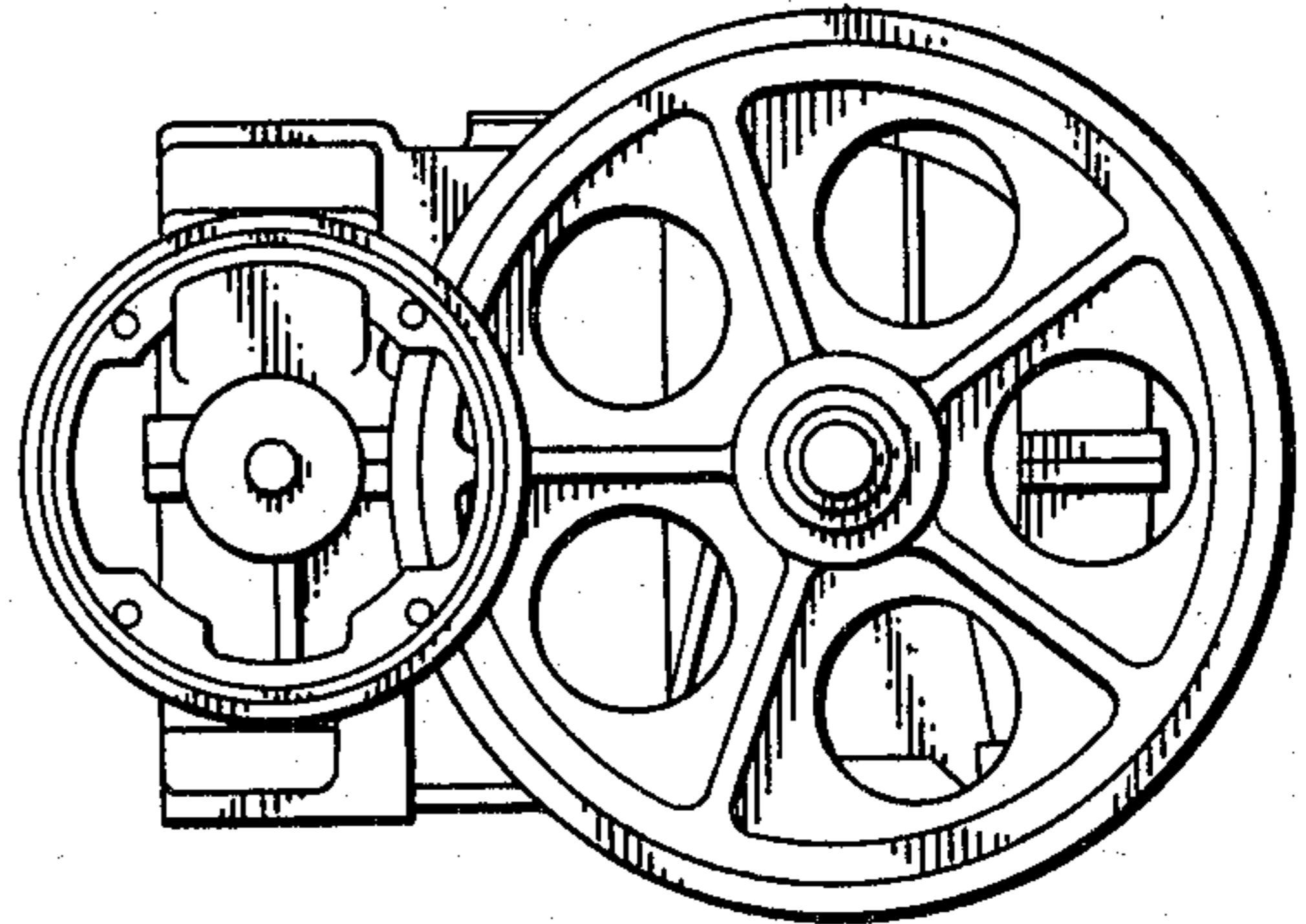

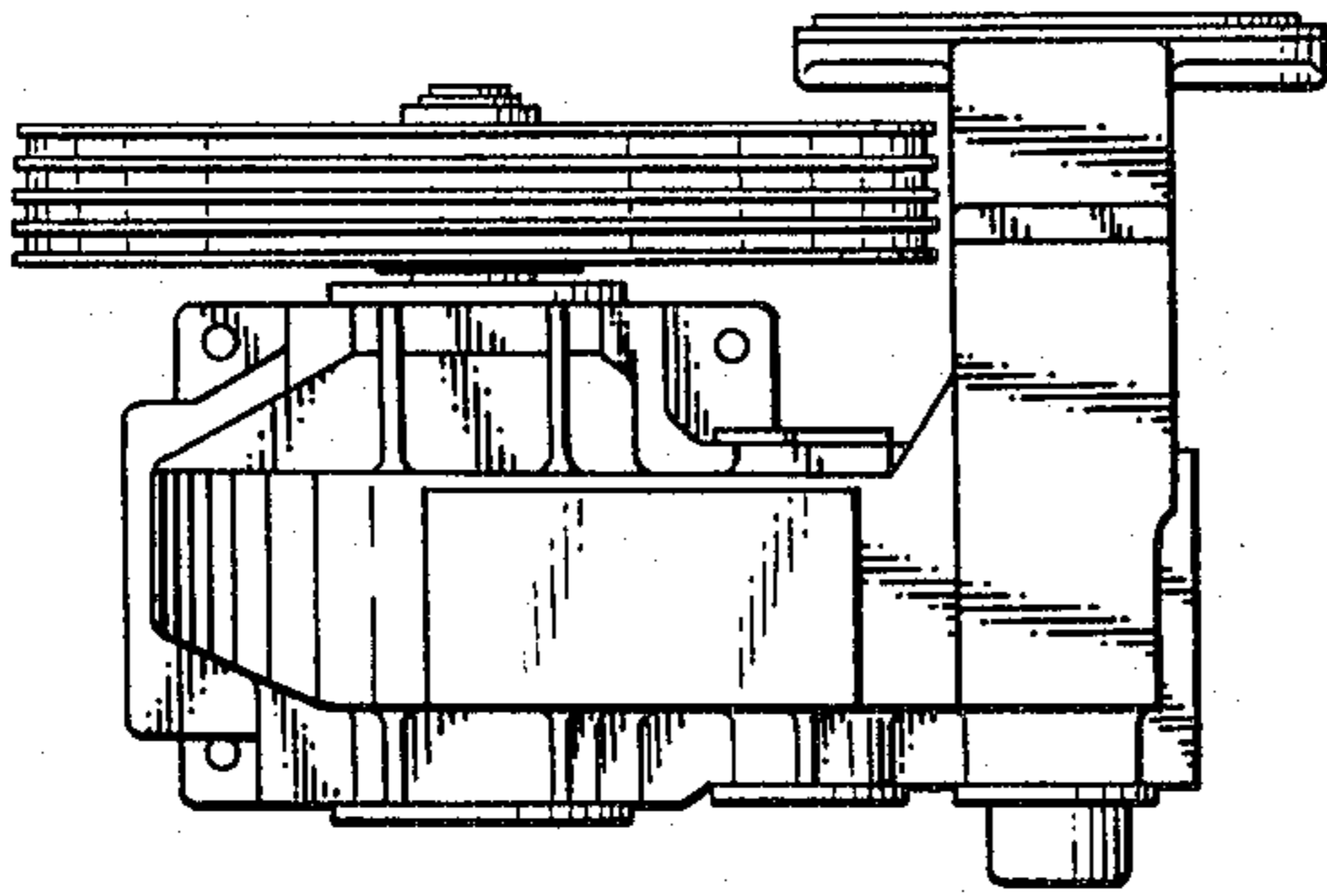

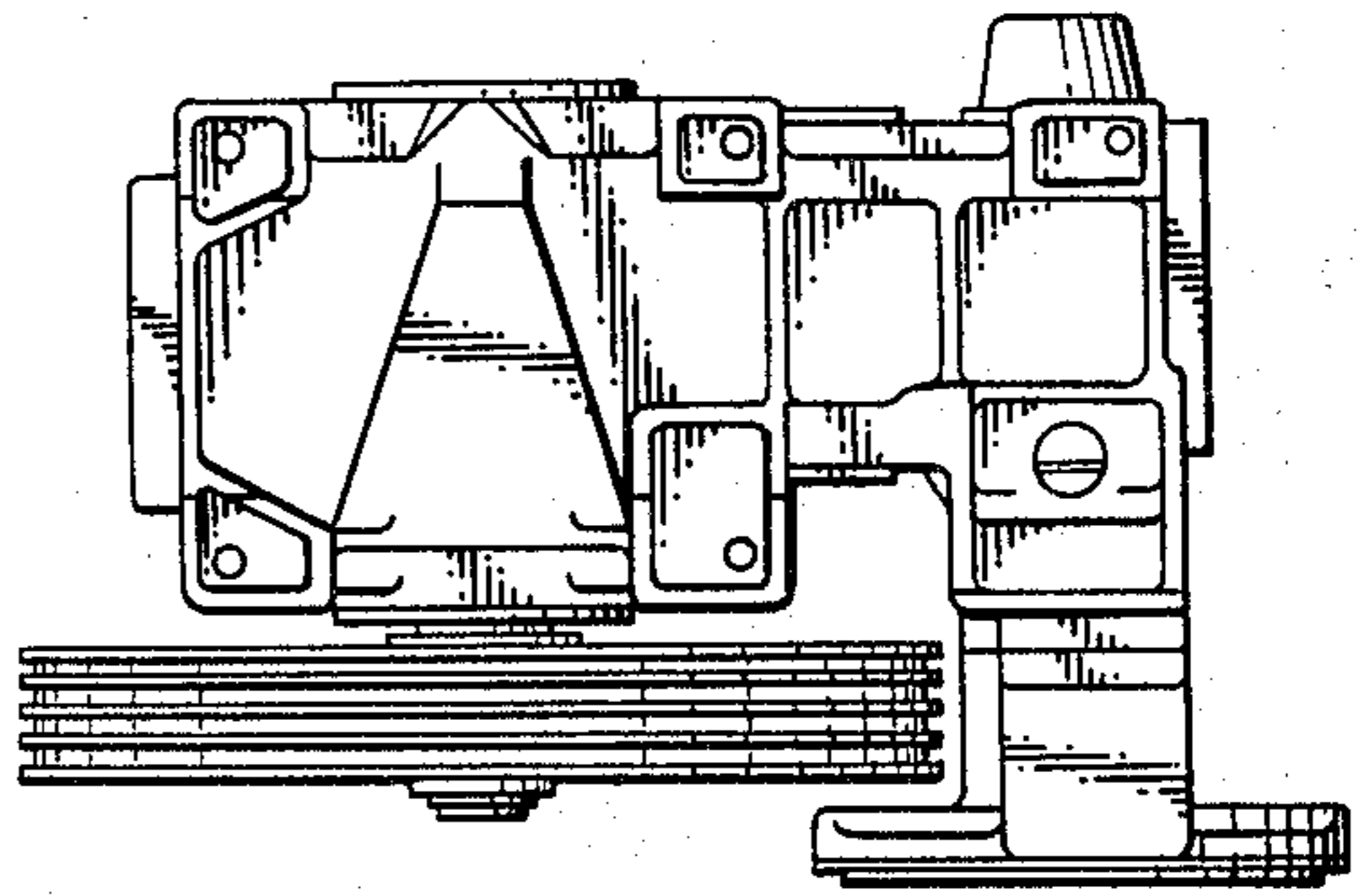

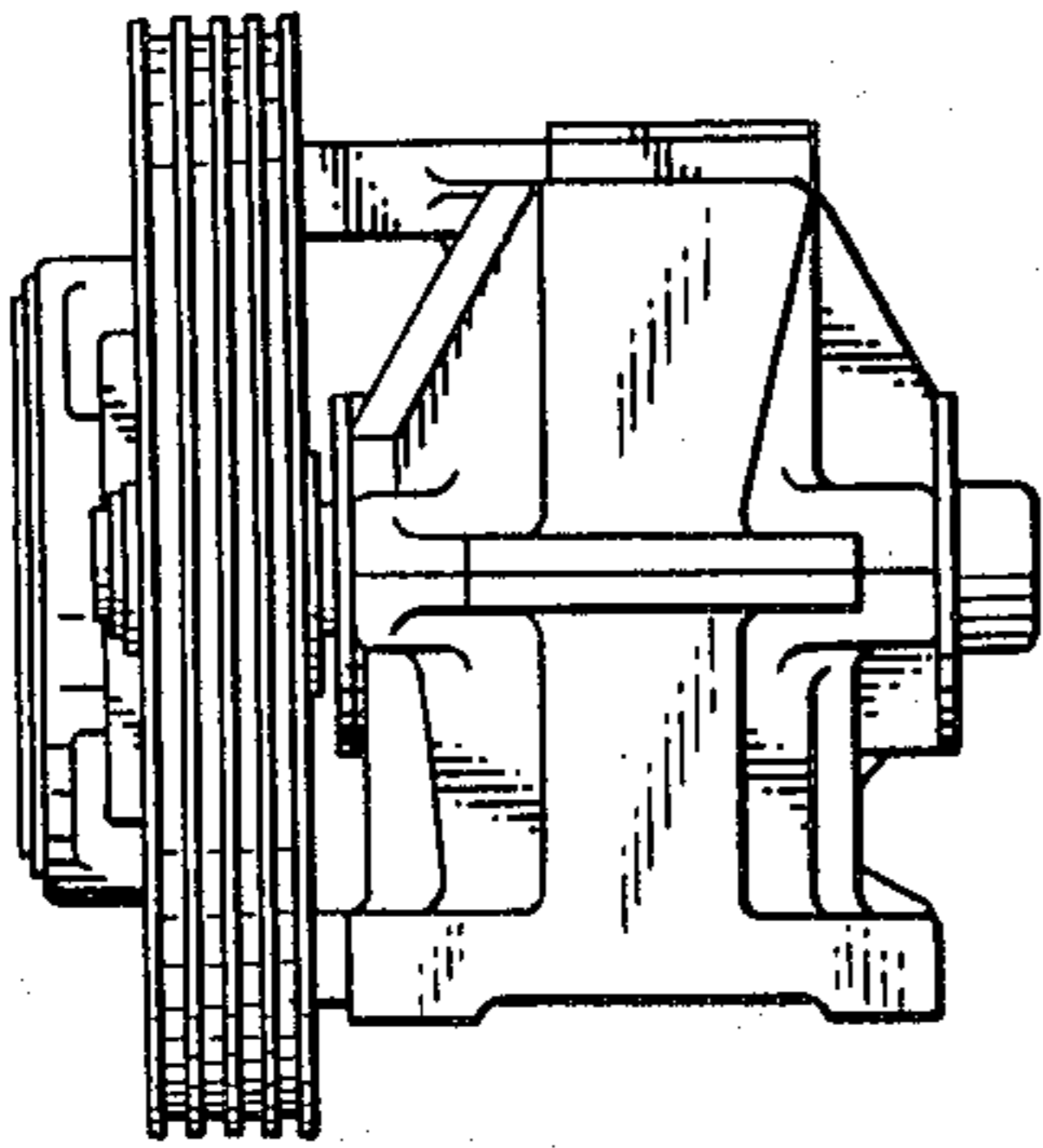

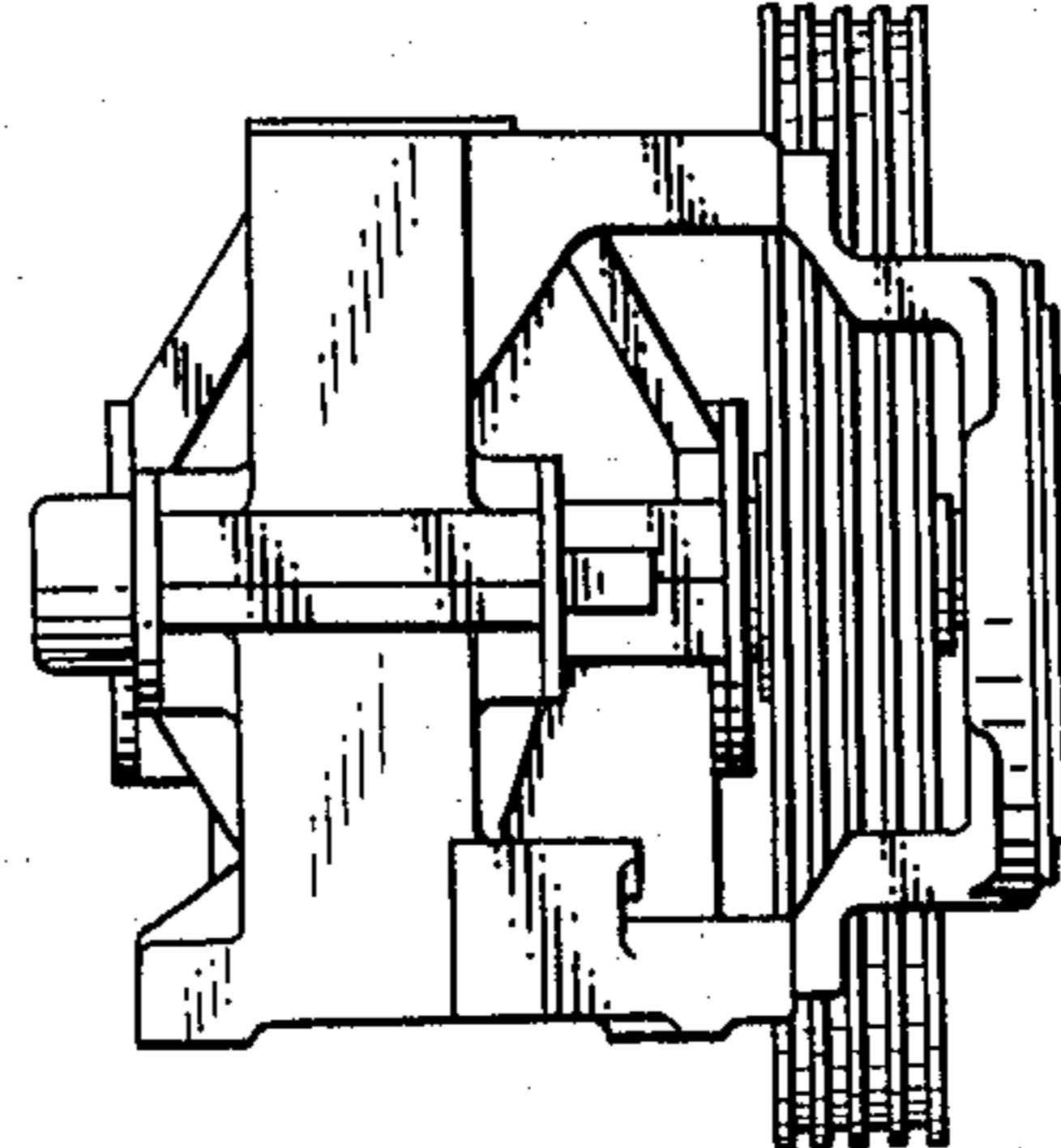

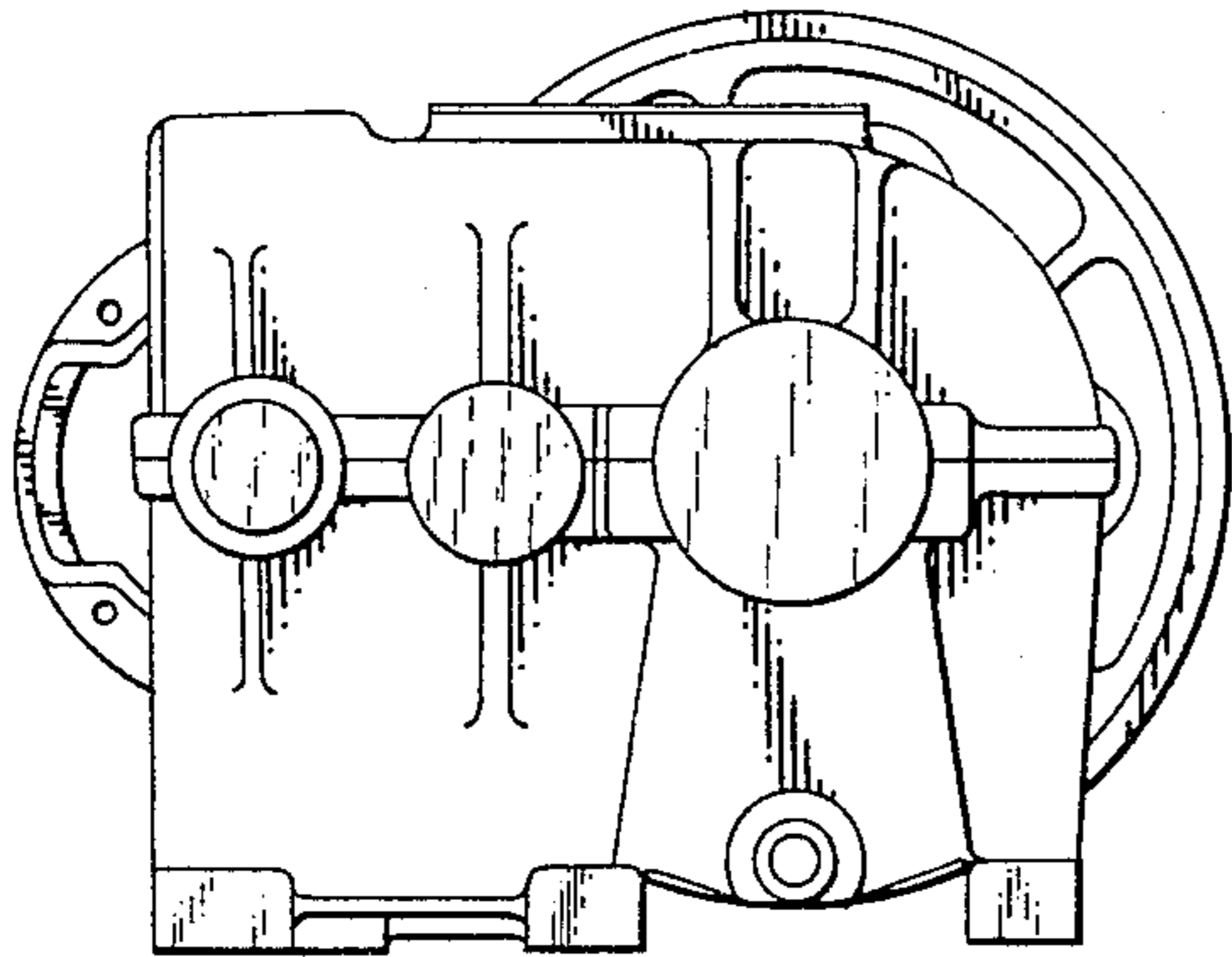

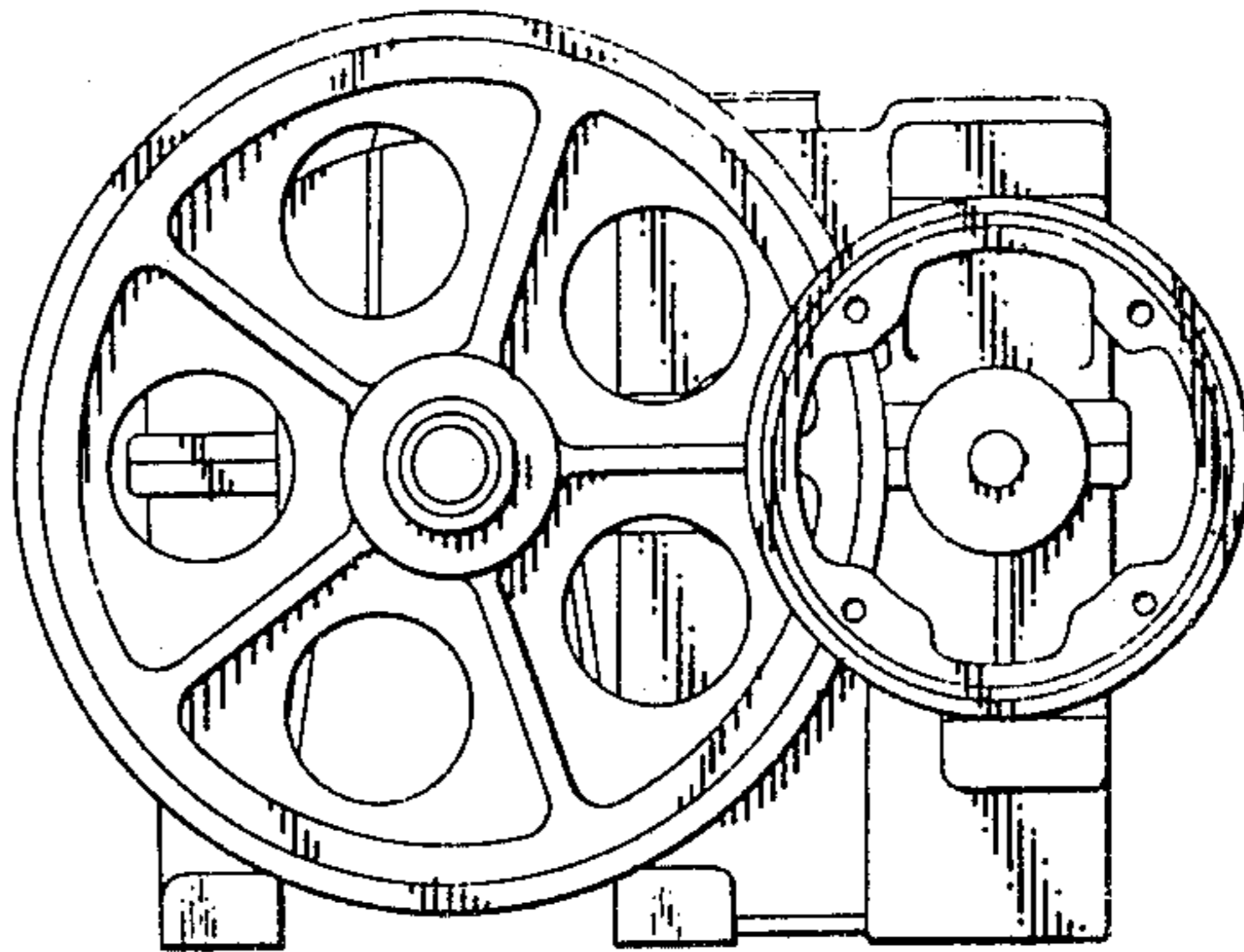

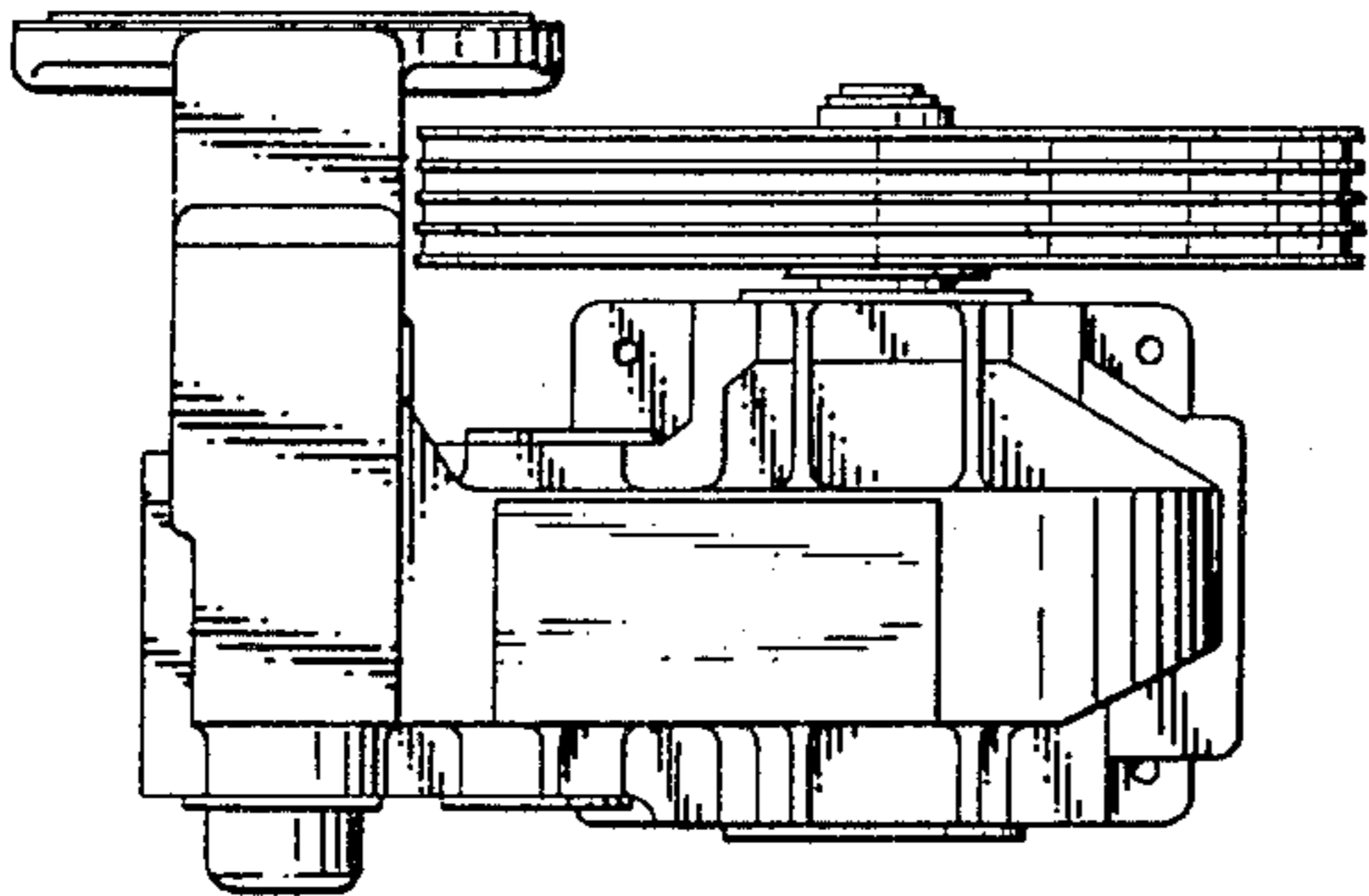

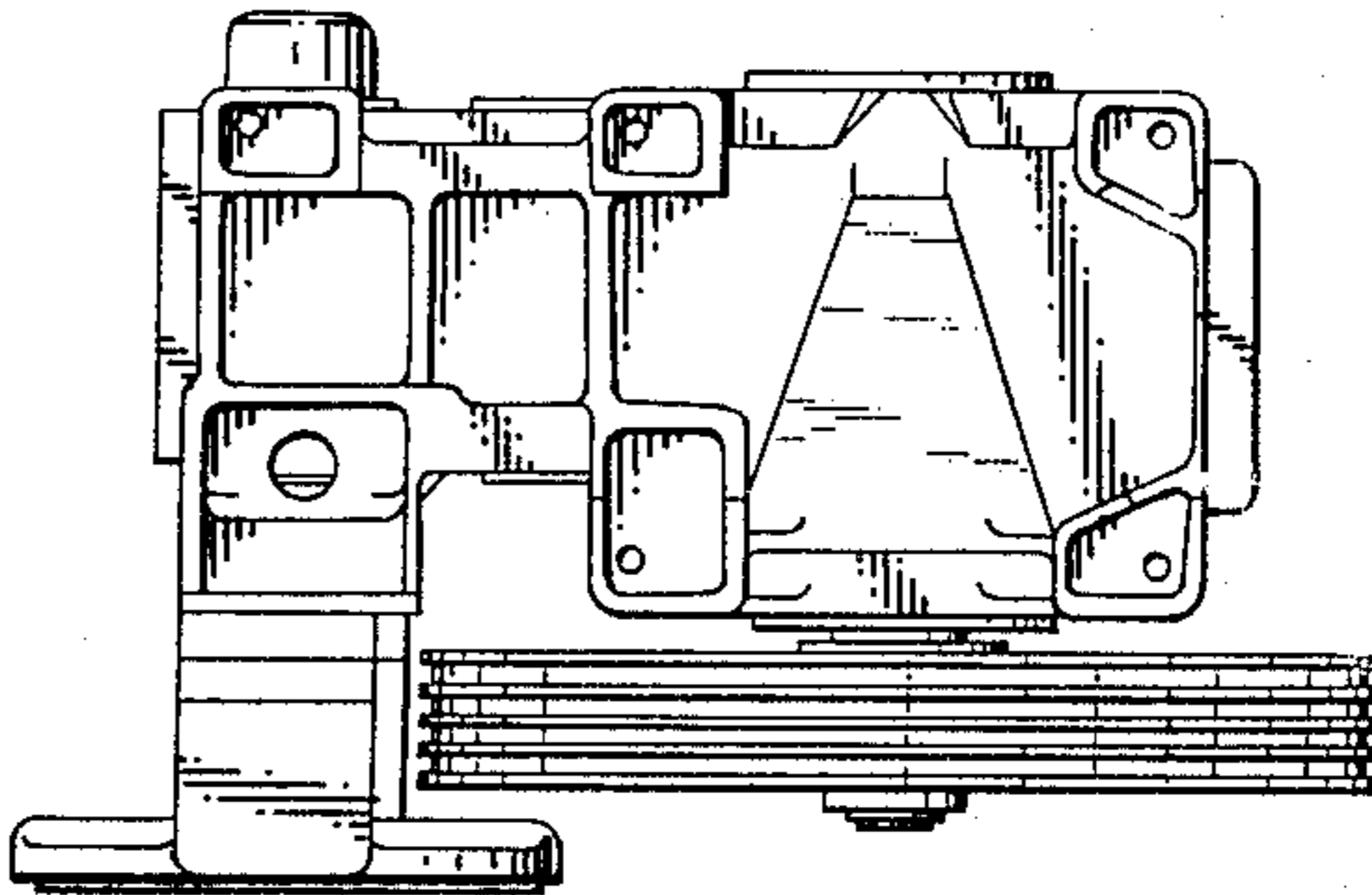

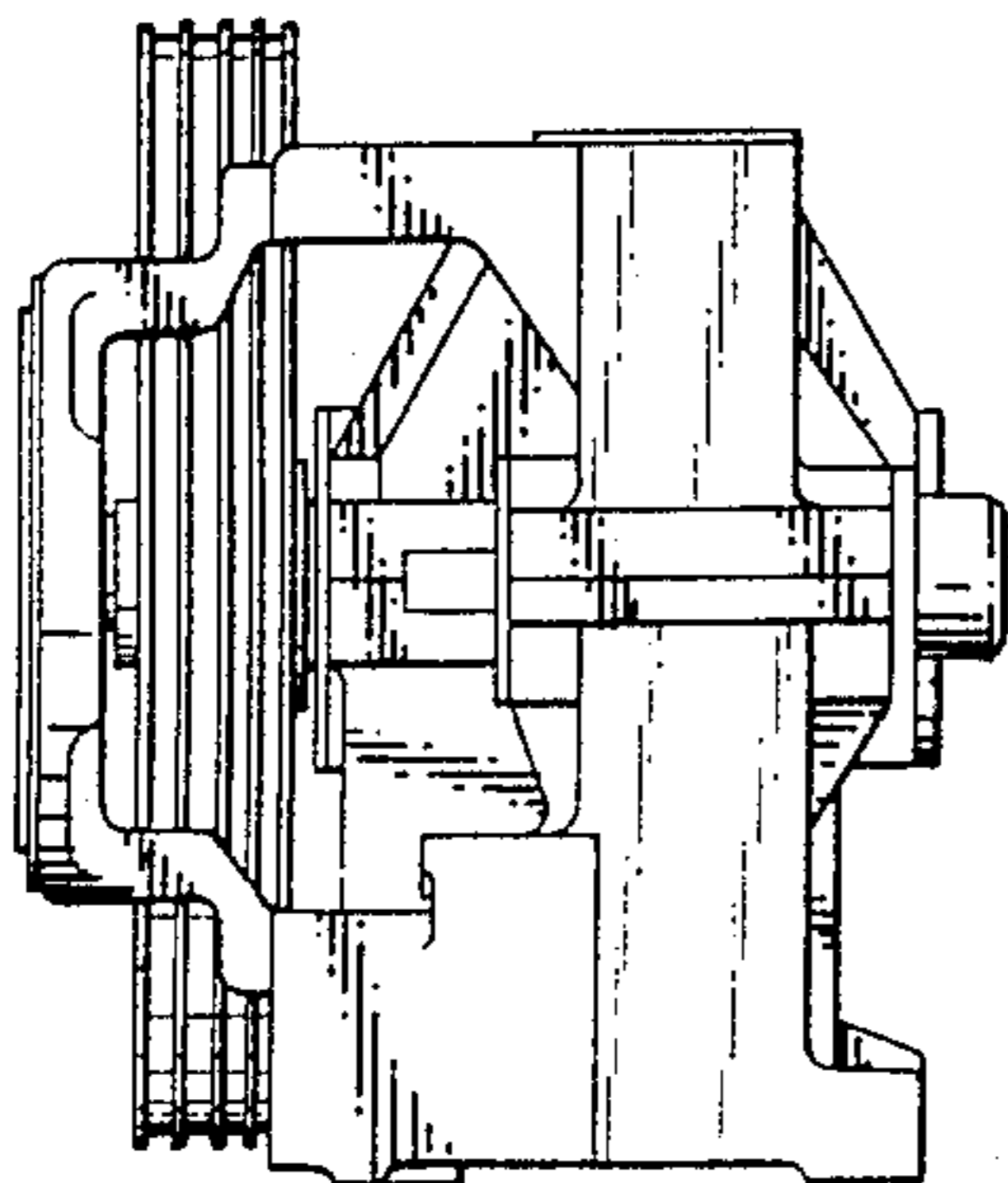

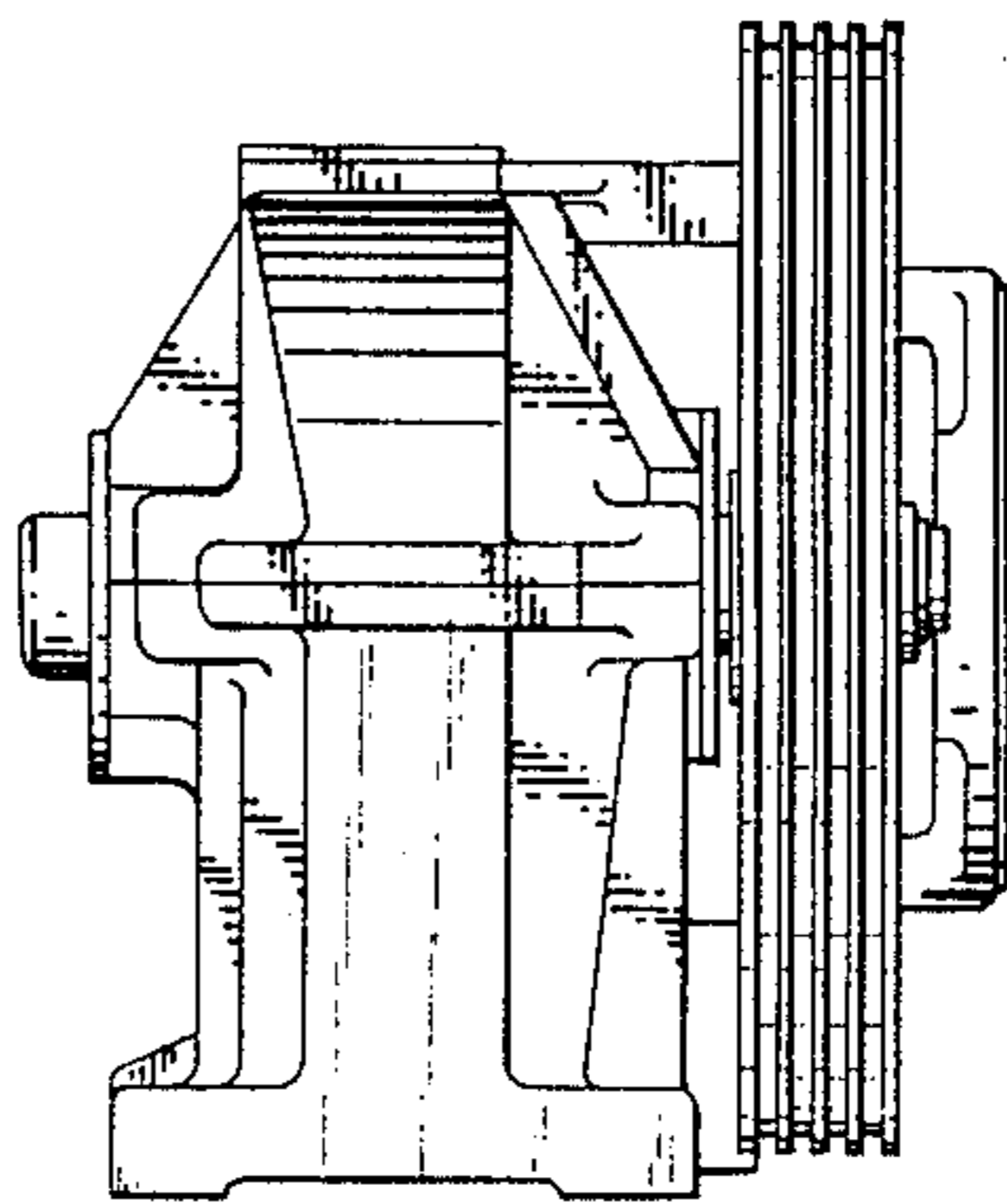

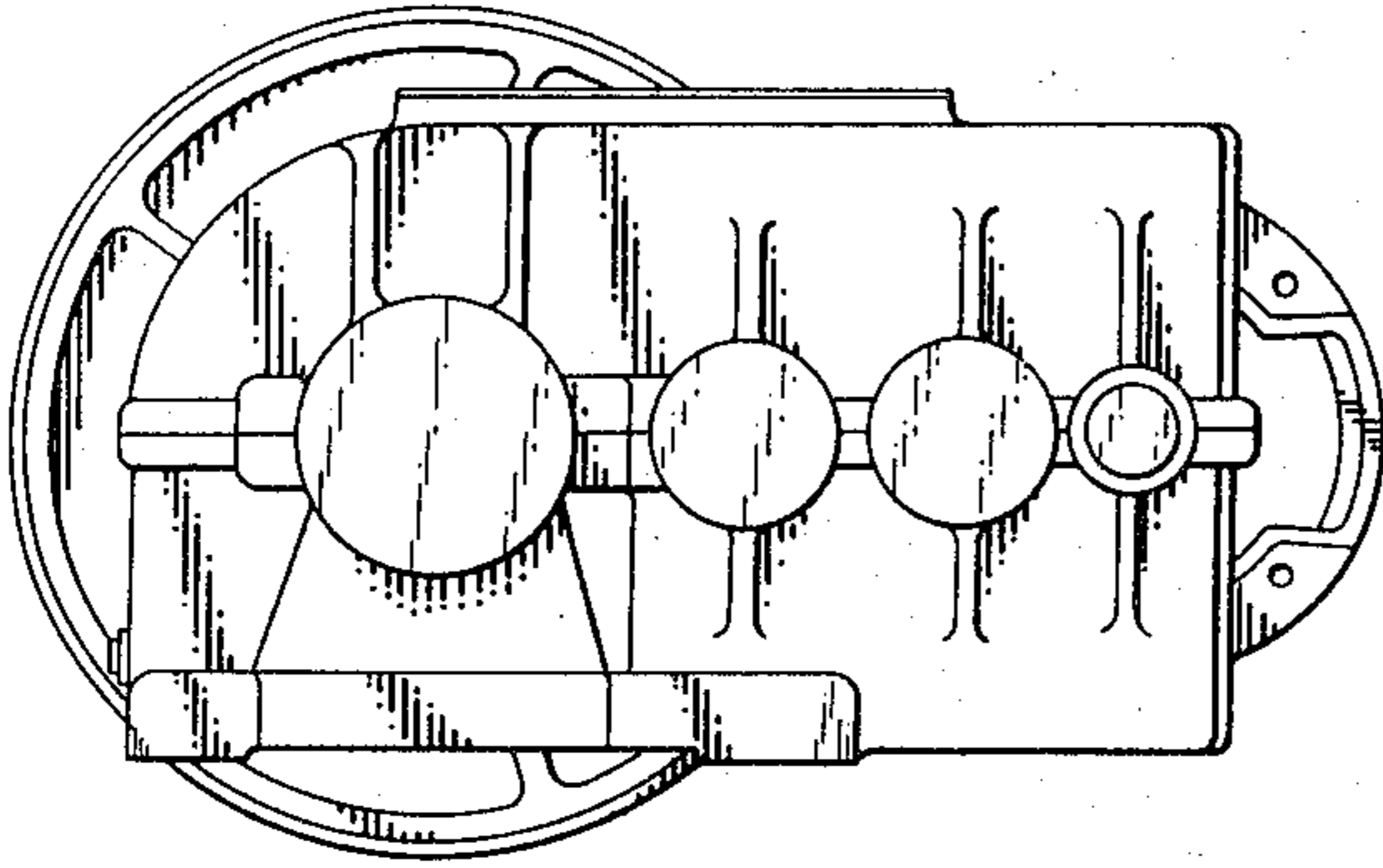

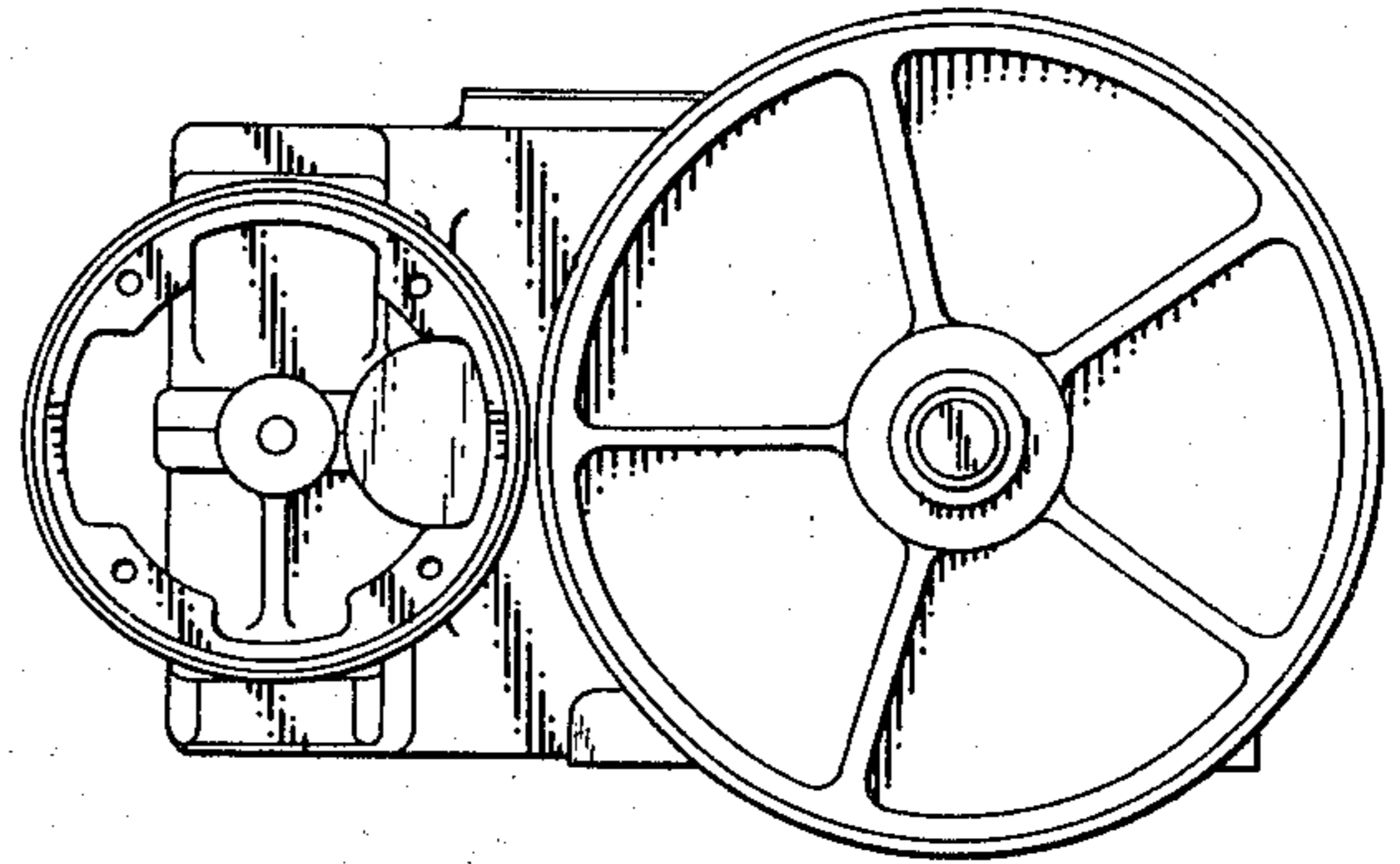

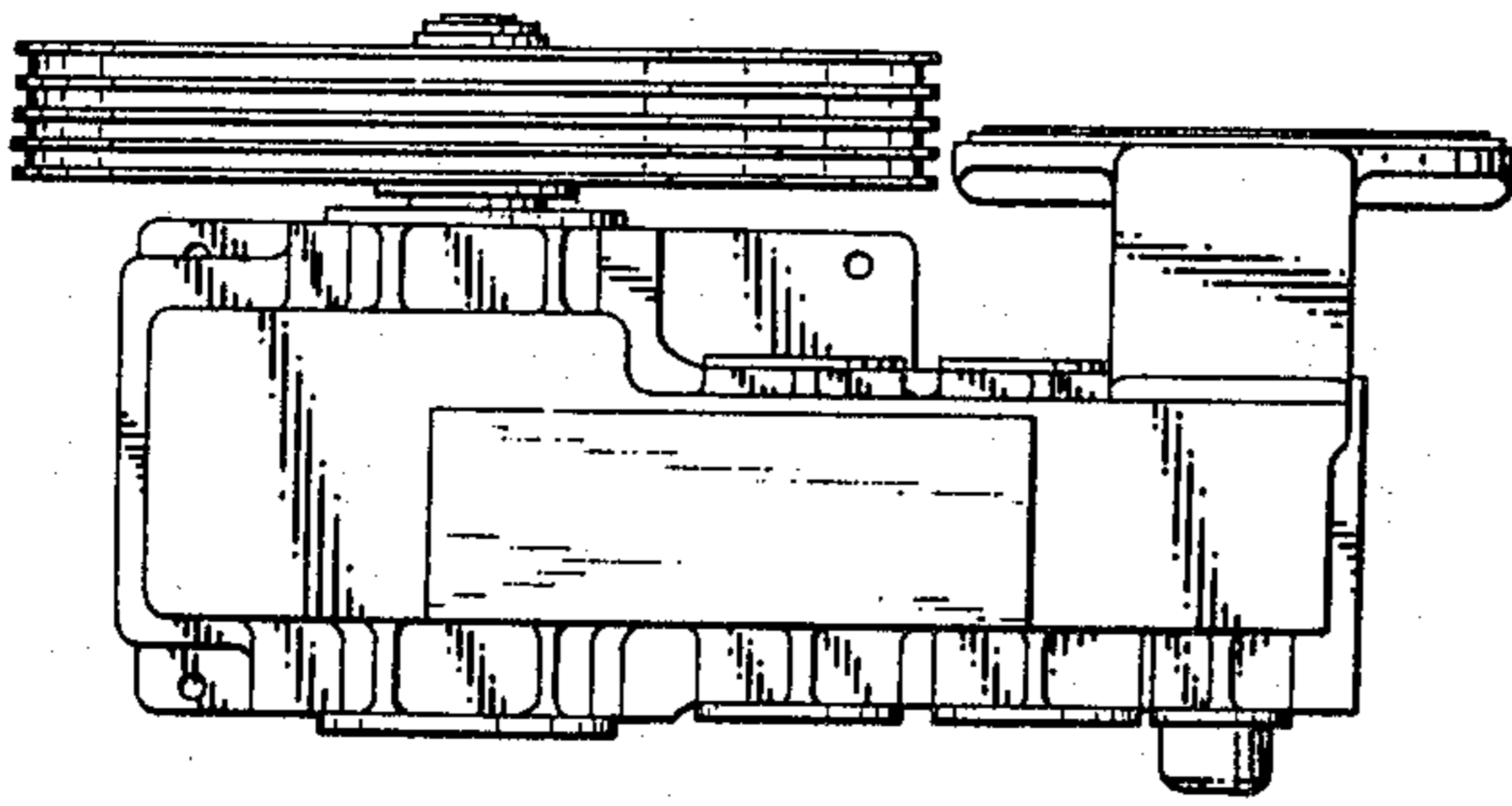

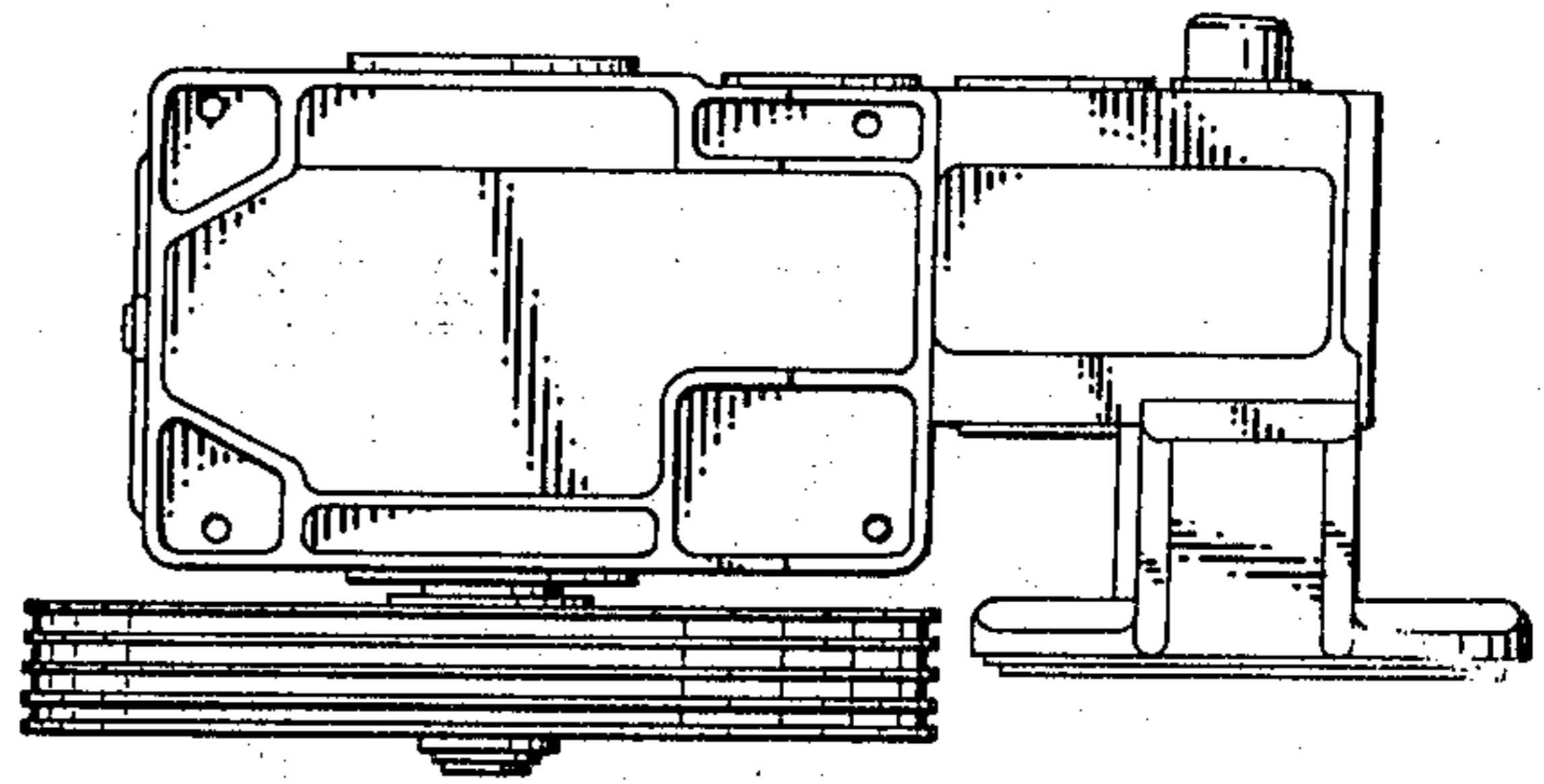

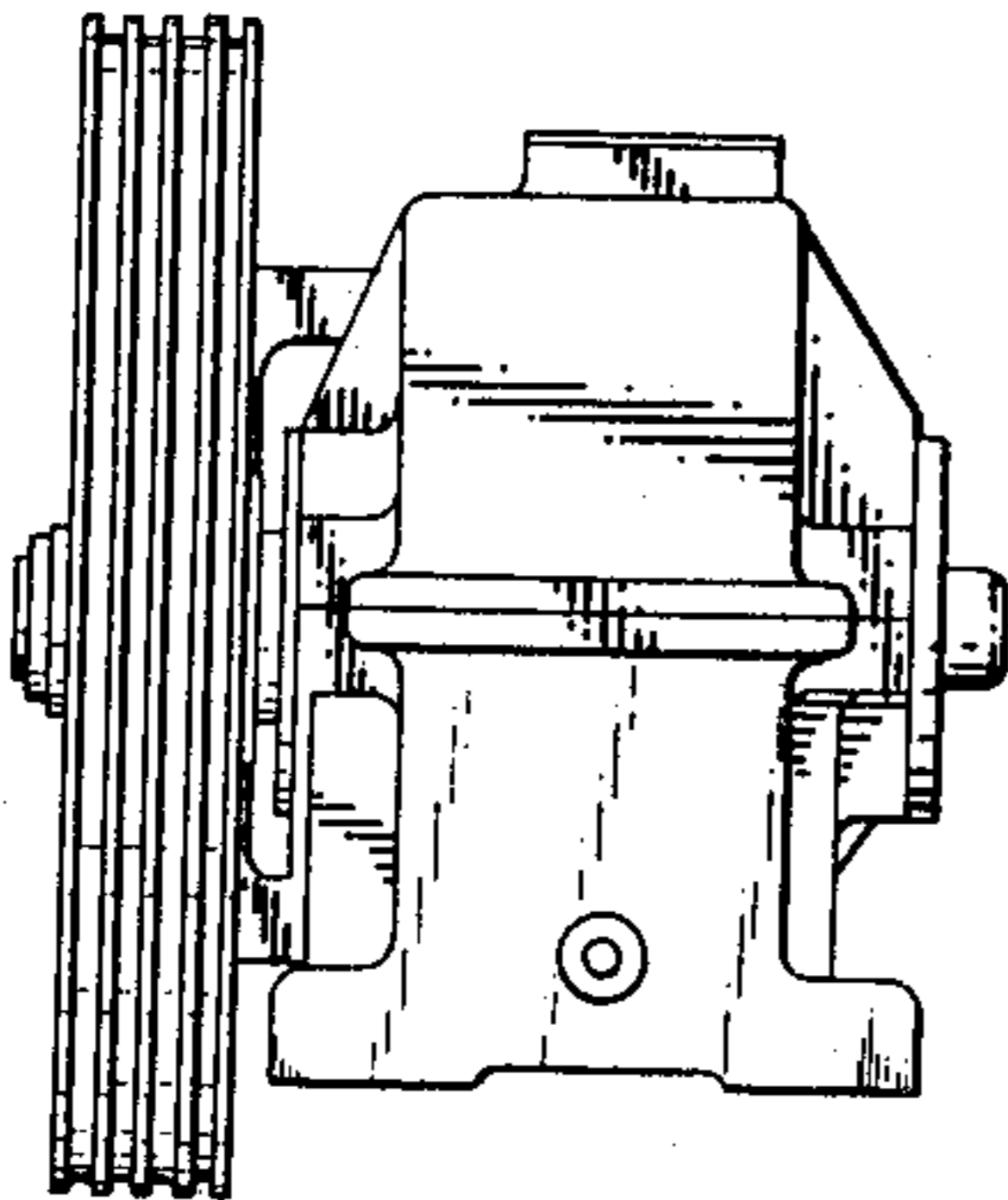
