FIG. 2 is a left side elevational view;

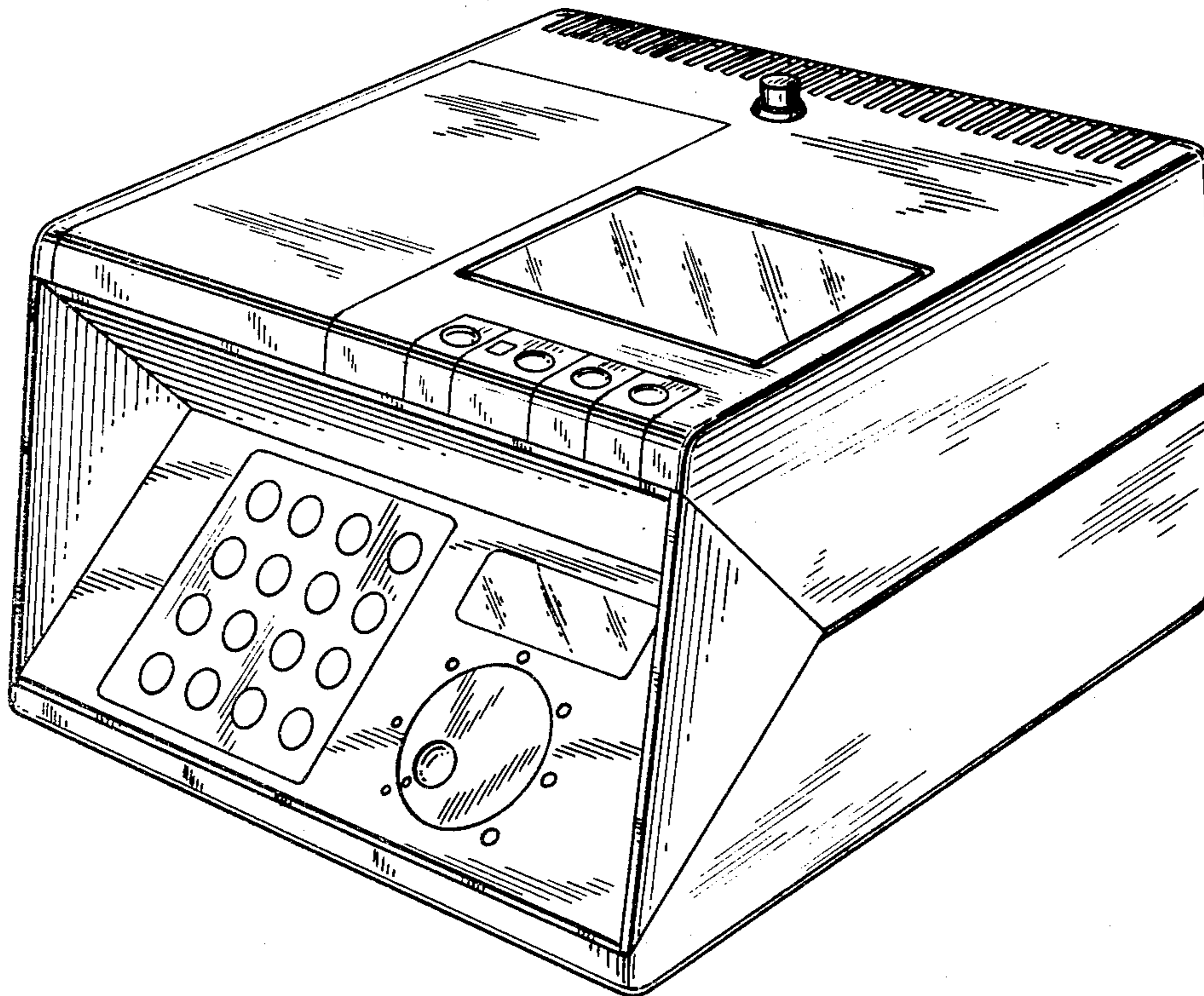
FIG. 3 is a top plan view;

FIG. 4 is a front elevational view;

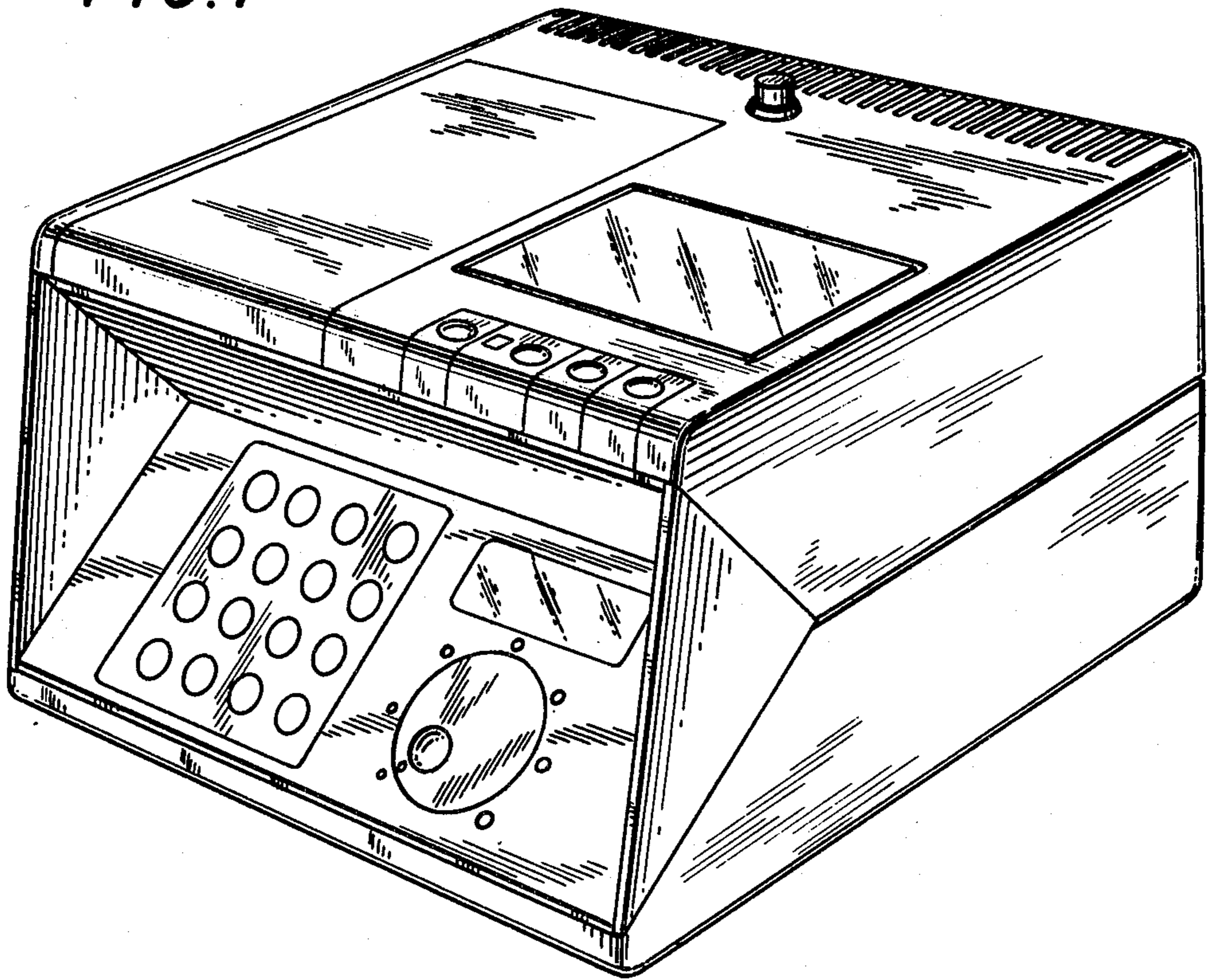
FIG. 5 is a rear elevational view;

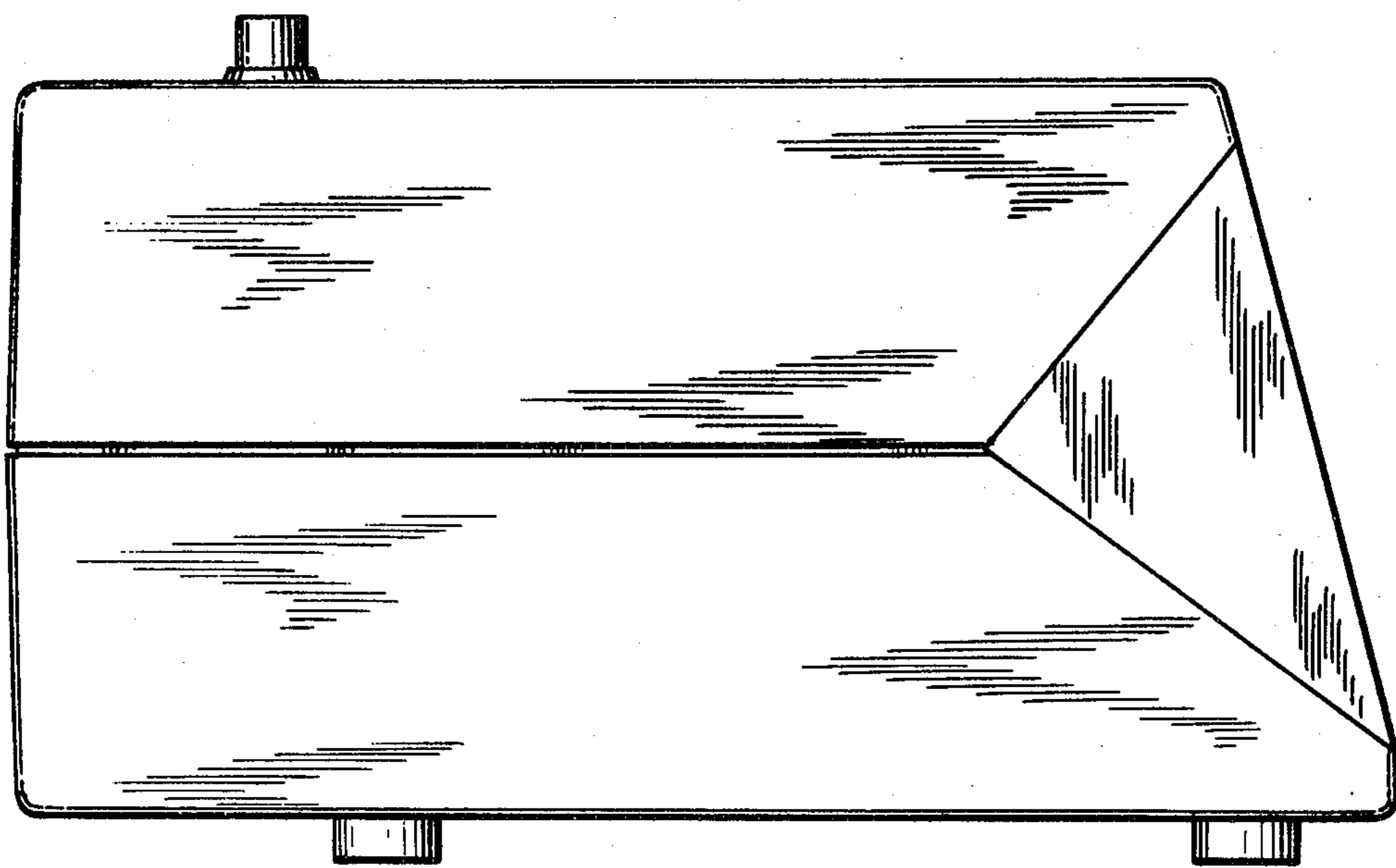

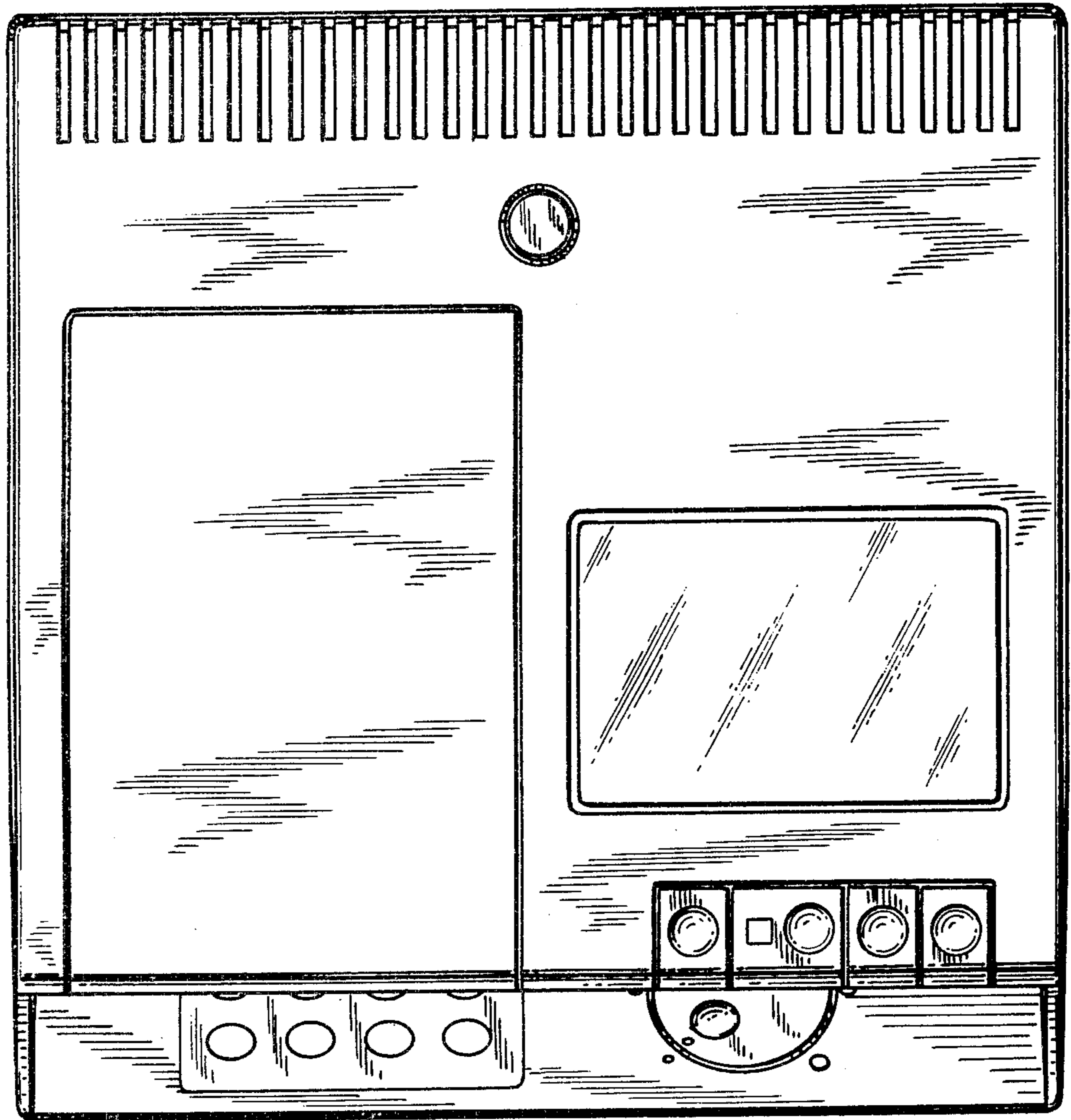
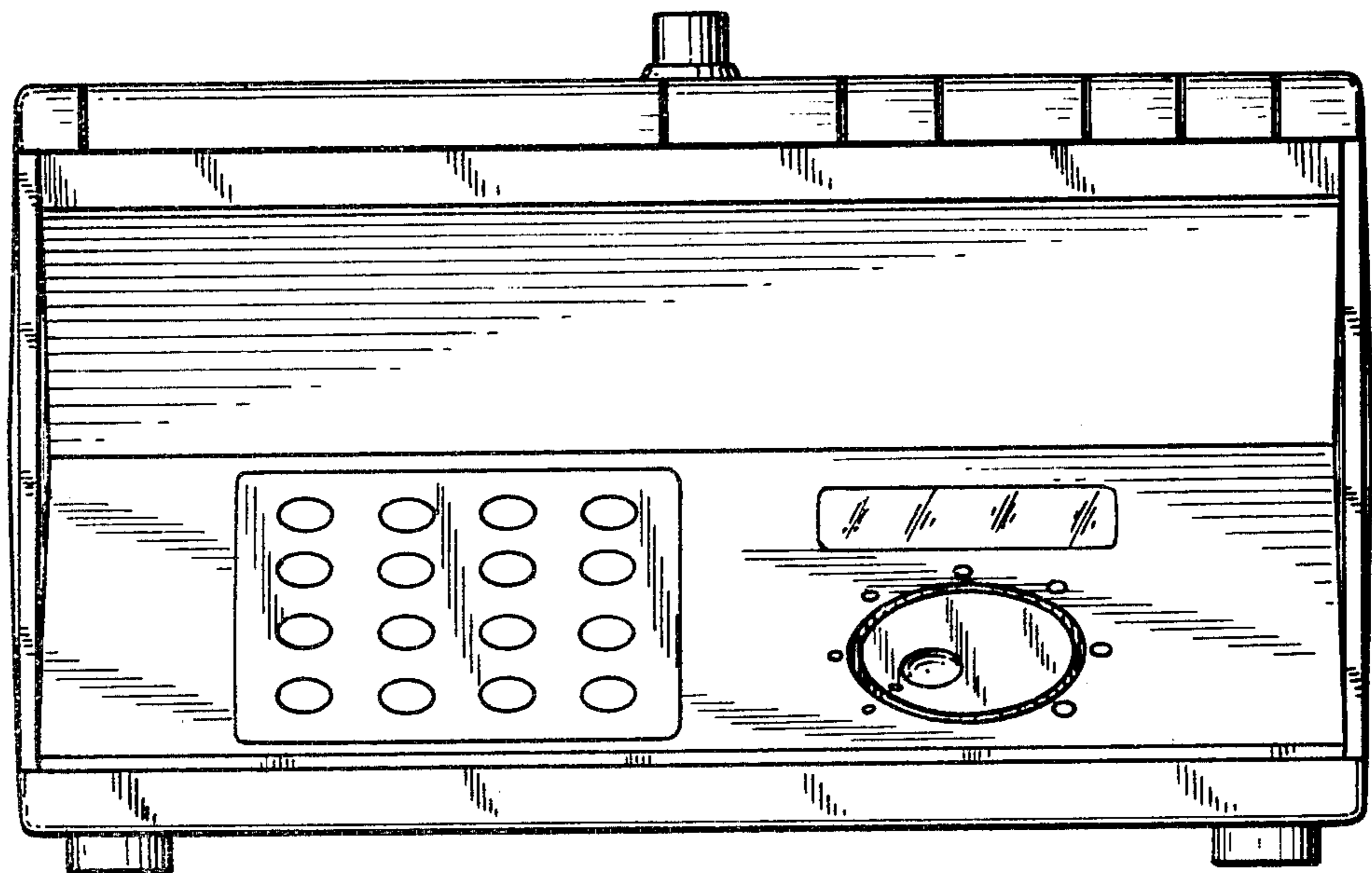
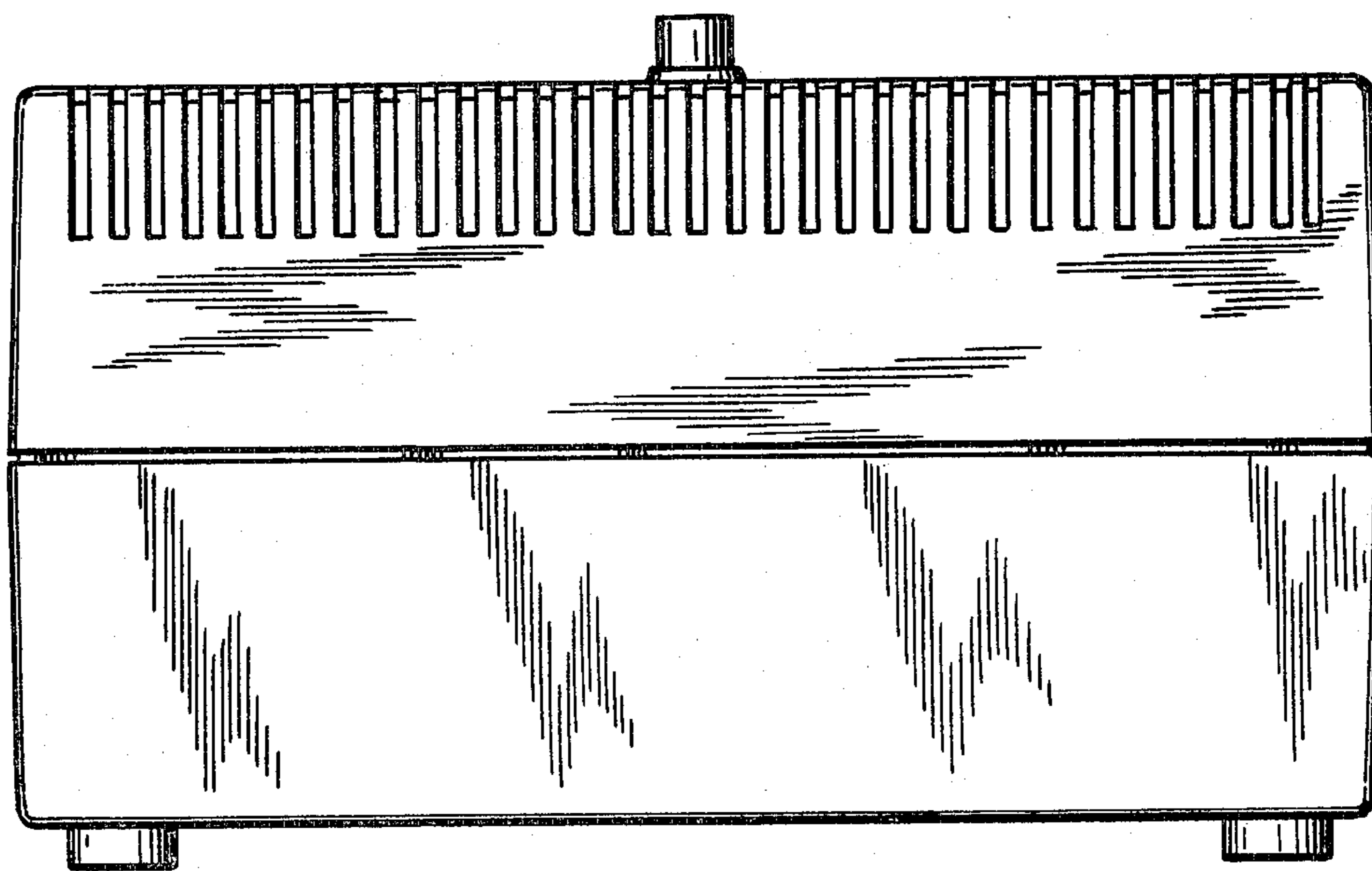


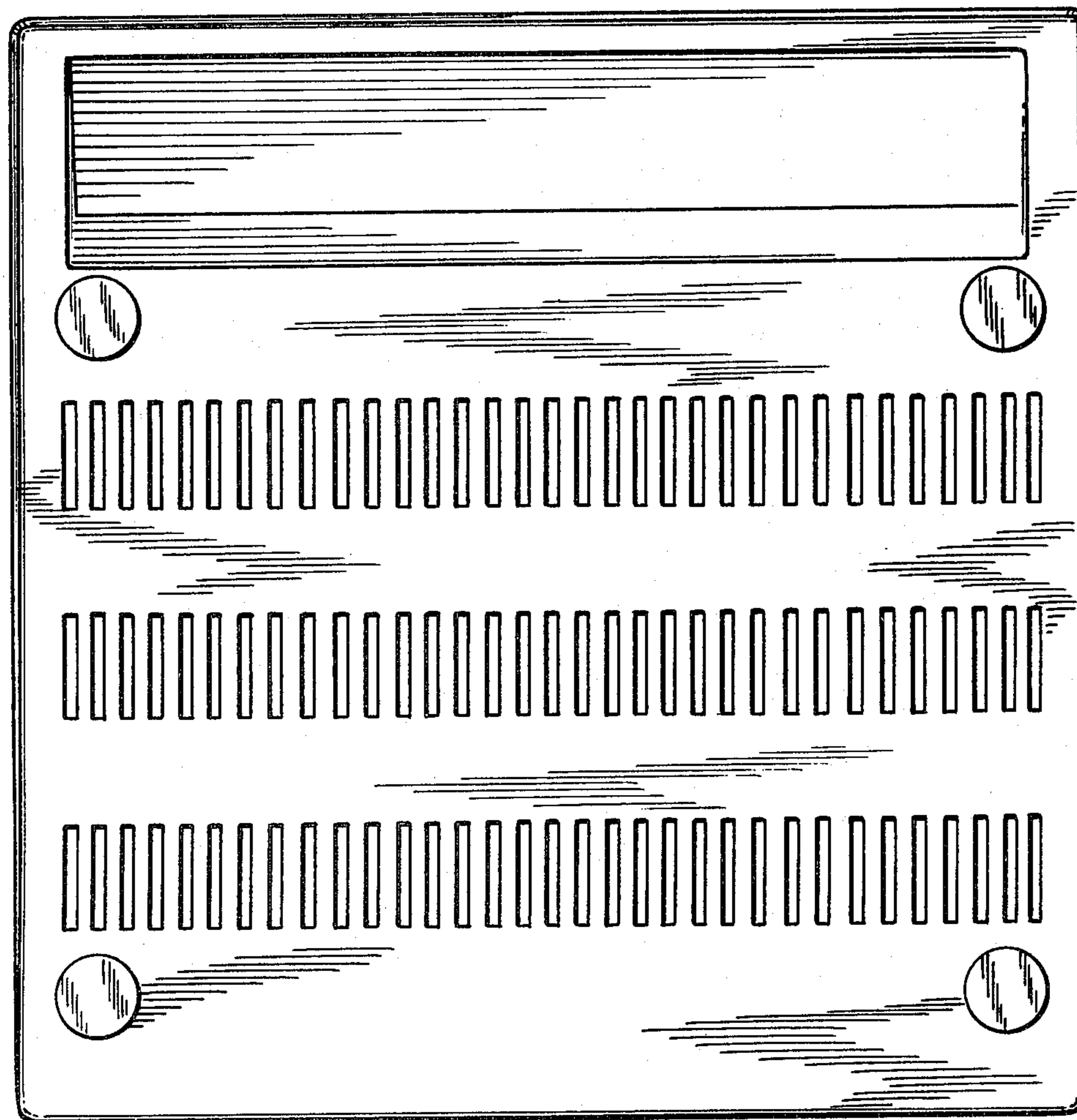
