The ornamental design for a pressure regulator control module for self-contained breathing apparatus, as shown.

**DESCRIPTION**

FIG. 1 is a front elevation of a pressure regulator control module for self-contained breathing apparatus showing my new design;  
FIG. 2 is a top view thereof;  
FIG. 3 is a left end view thereof;  
FIG. 4 is a right end view thereof;  
FIG. 5 is a rear elevation thereof; and  
FIG. 6 is a bottom view thereof.  
The broken lines in FIG. 2 are shown for illustrative purposes only.

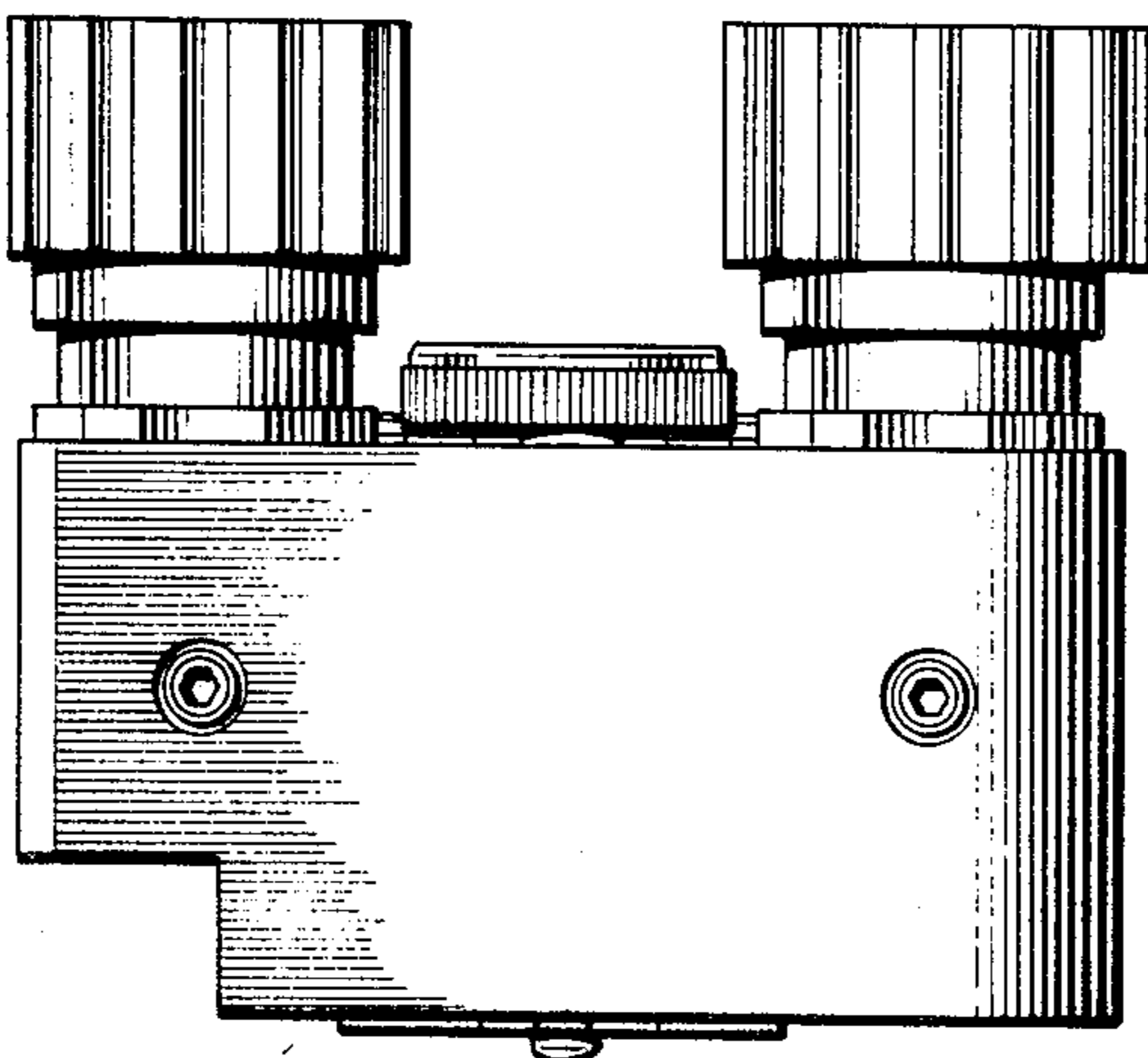
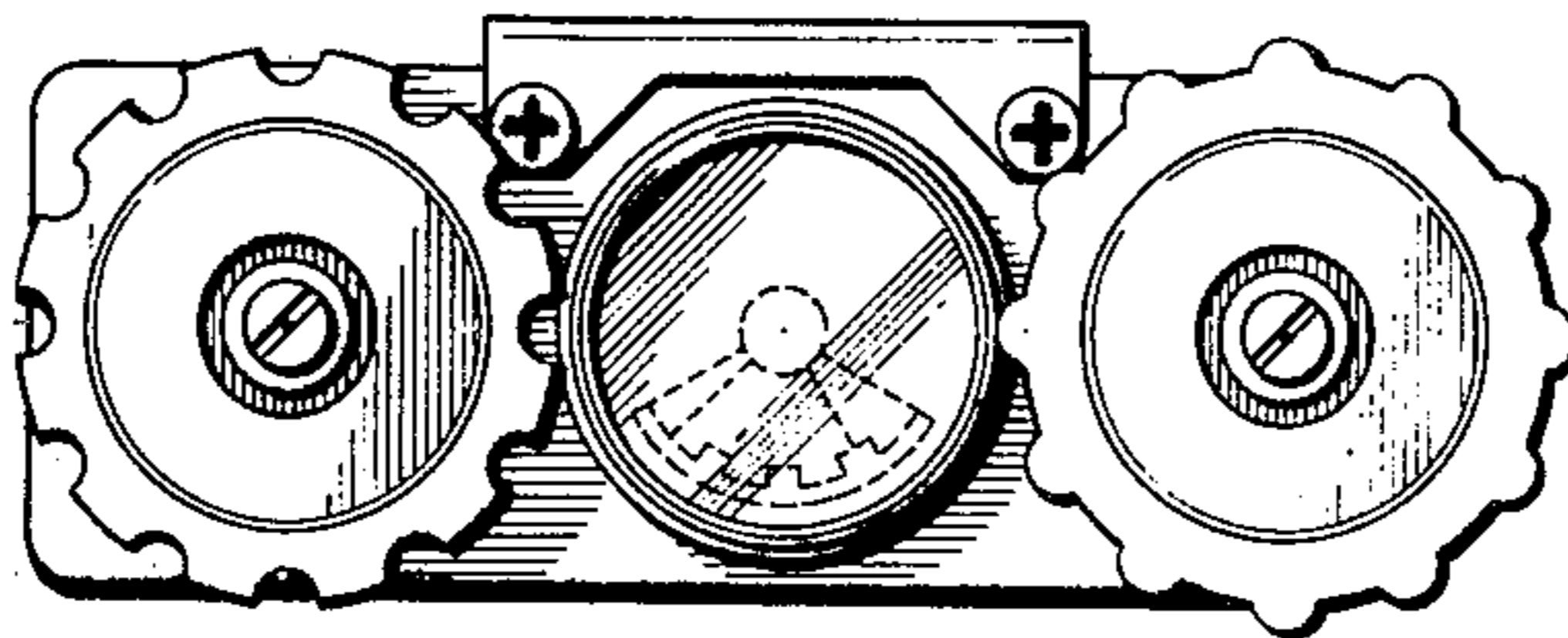

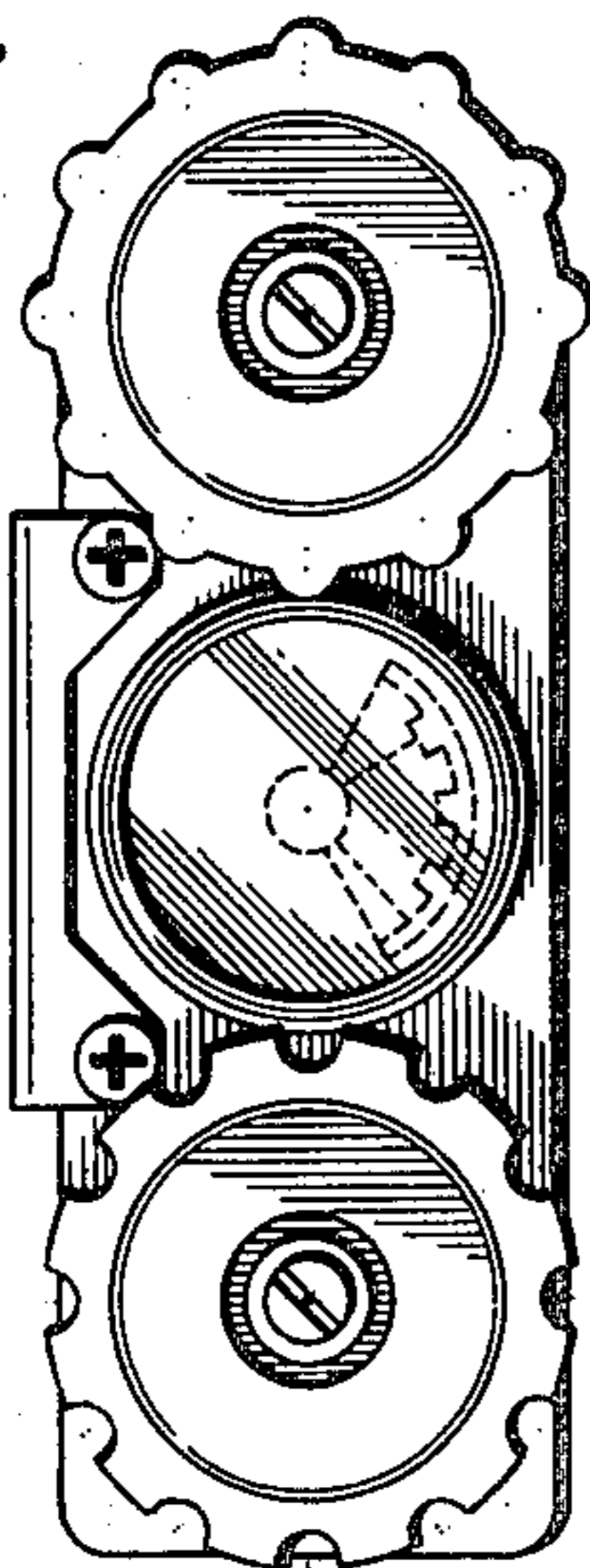

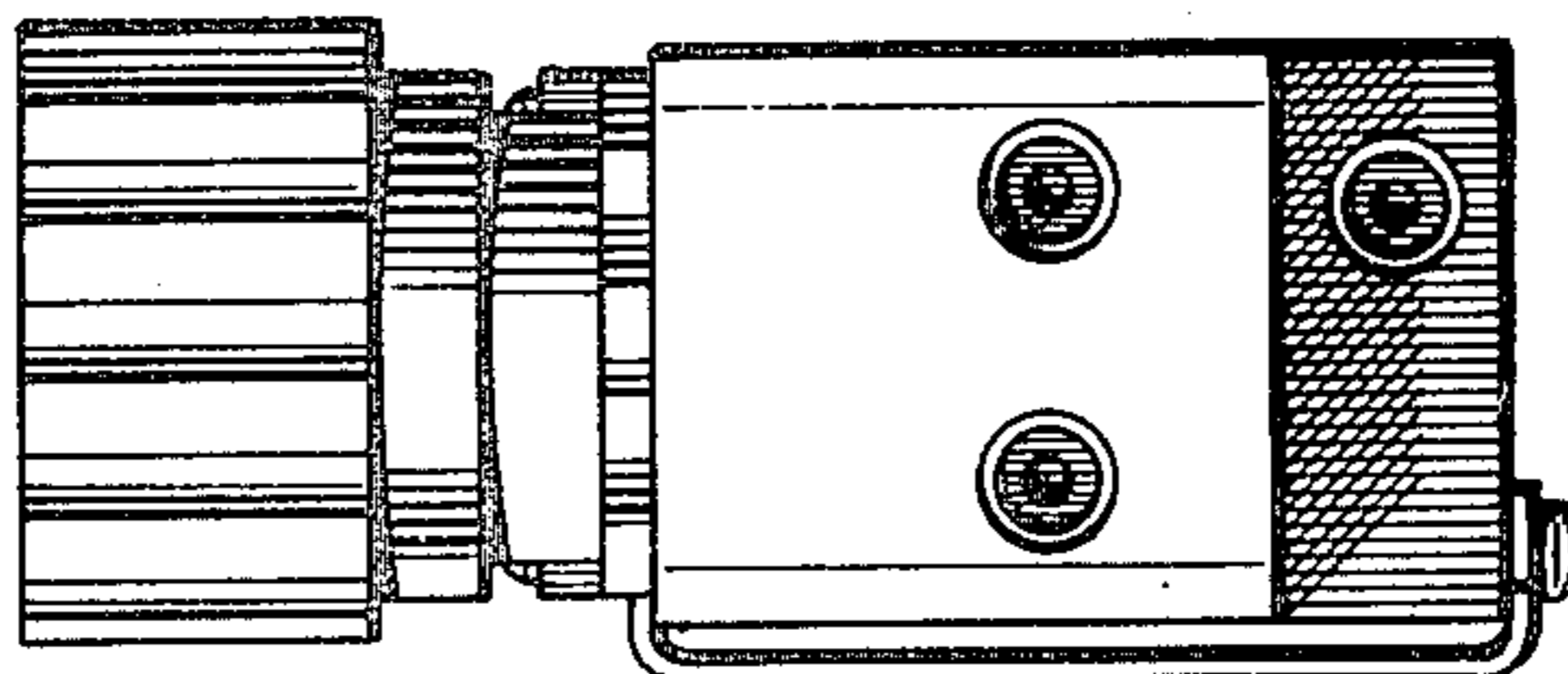

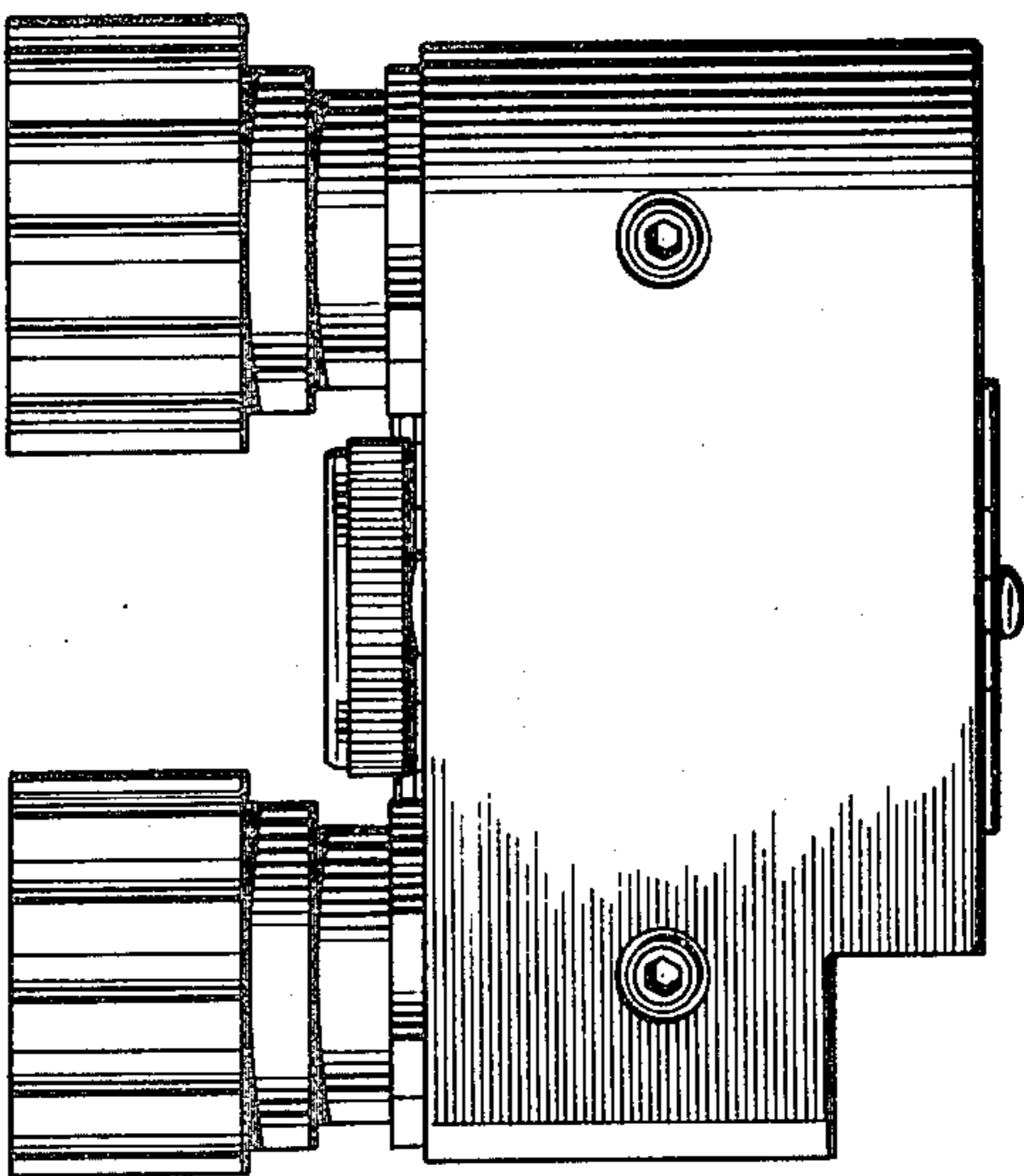

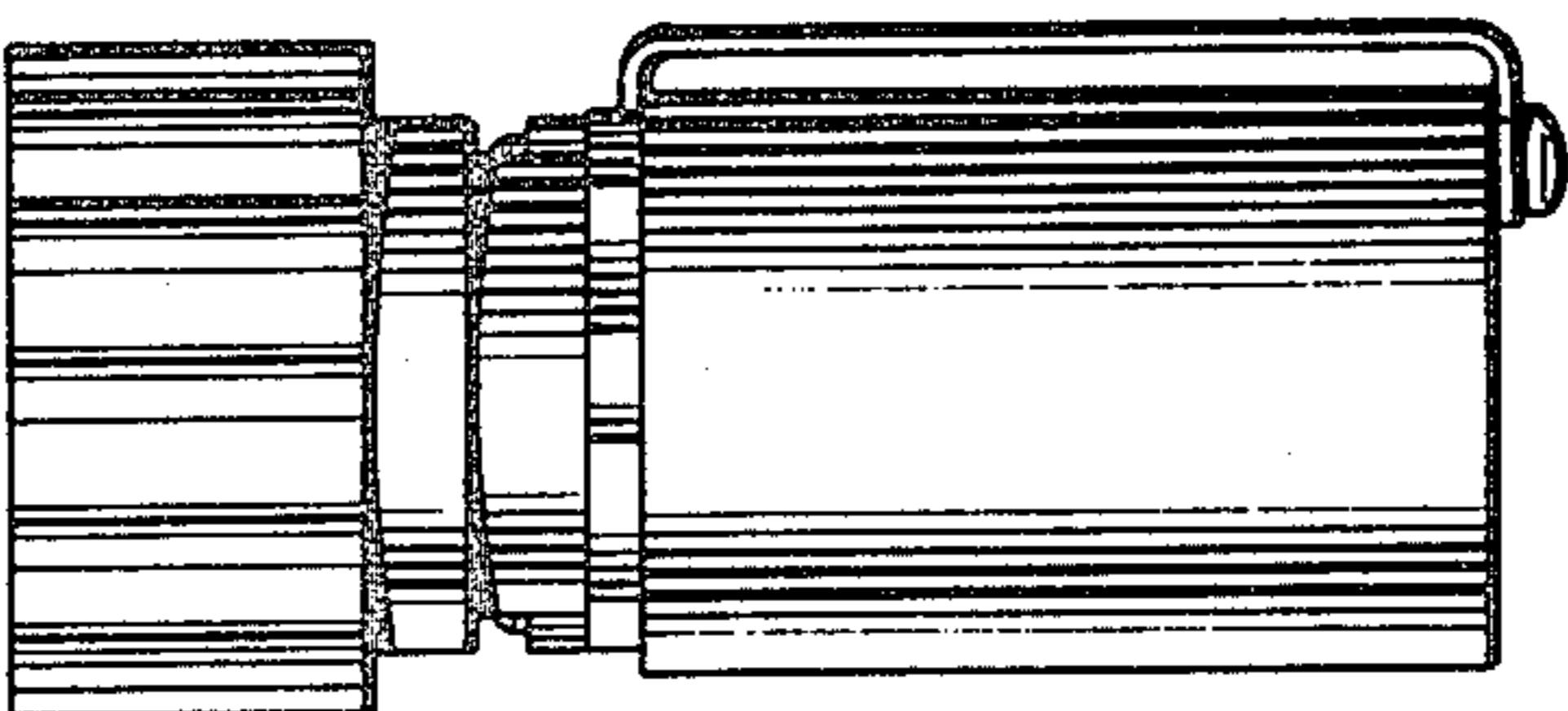

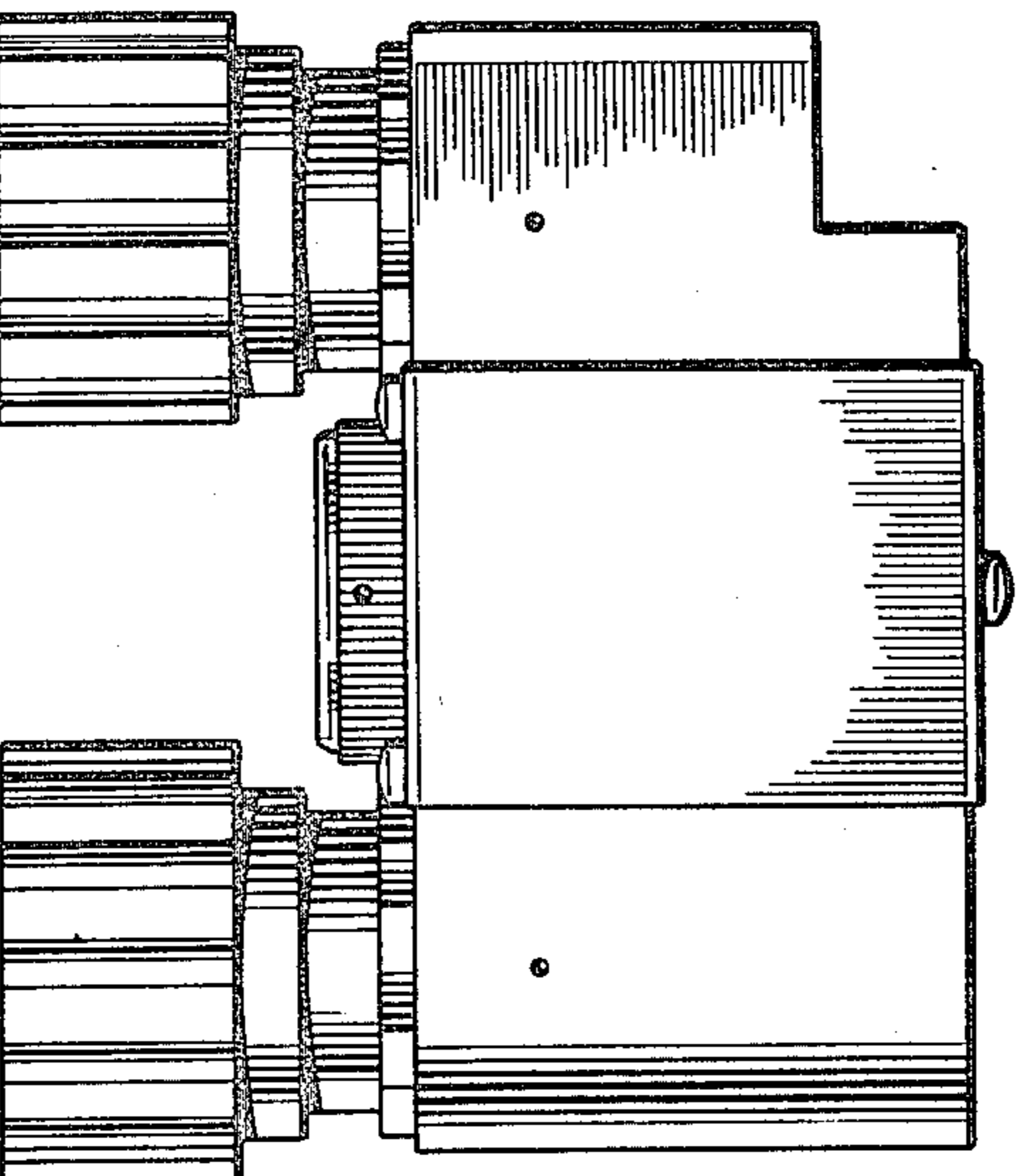
