[57] CLAIM

The ornamental design for a bottle carrier, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bottle carrier showing my new design;
 FIG. 2 is a bottom plan view thereof;
 FIG. 3 is an end elevational view thereof;
 FIG. 4 is a fragmentary cross-sectional view taken along line 4—4 of FIG. 2;
 FIG. 5 is a fragmentary cross-sectional view taken along line 5—5 of FIG. 2;
 FIG. 6 is a fragmentary cross-sectional view taken along line 6—6 of FIG. 2;
 FIG. 7 is a fragmentary cross-sectional view taken along line 7—7 of FIG. 2;
 FIG. 8 is a fragmentary cross-sectional view taken along line 8—8 of FIG. 2; and
 FIG. 9 is a fragmentary cross-sectional view taken along line 9—9 of FIG. 2.

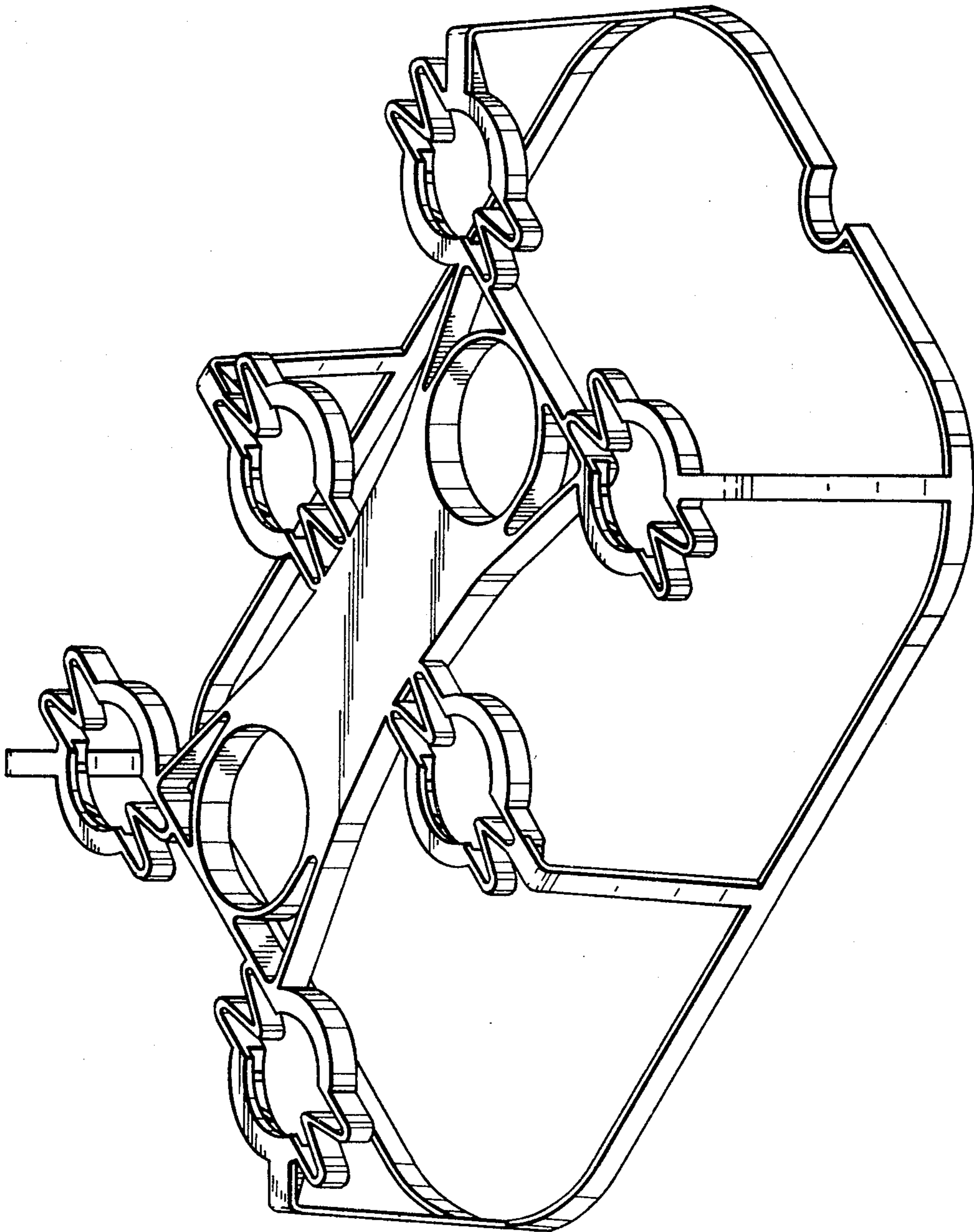

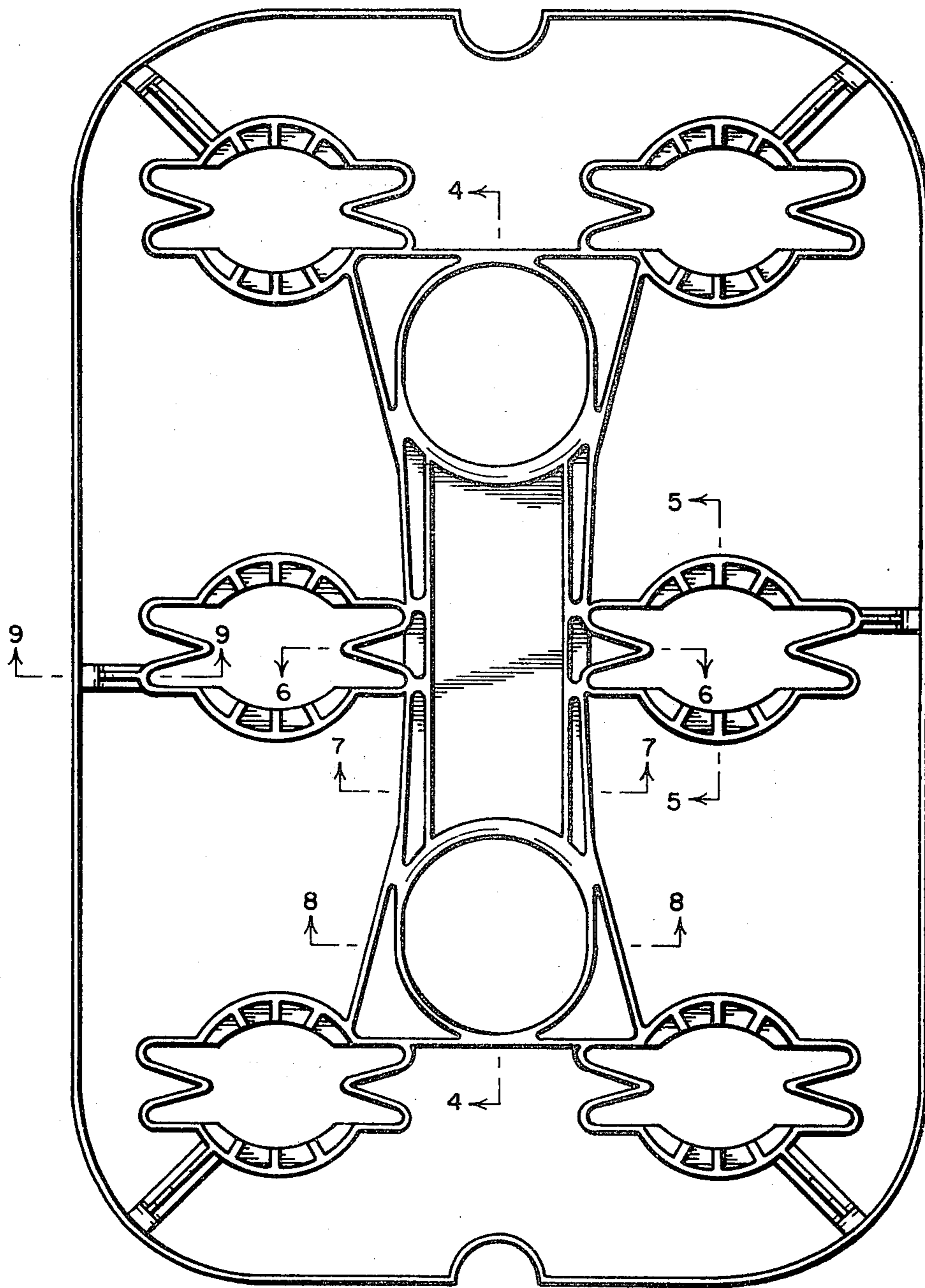

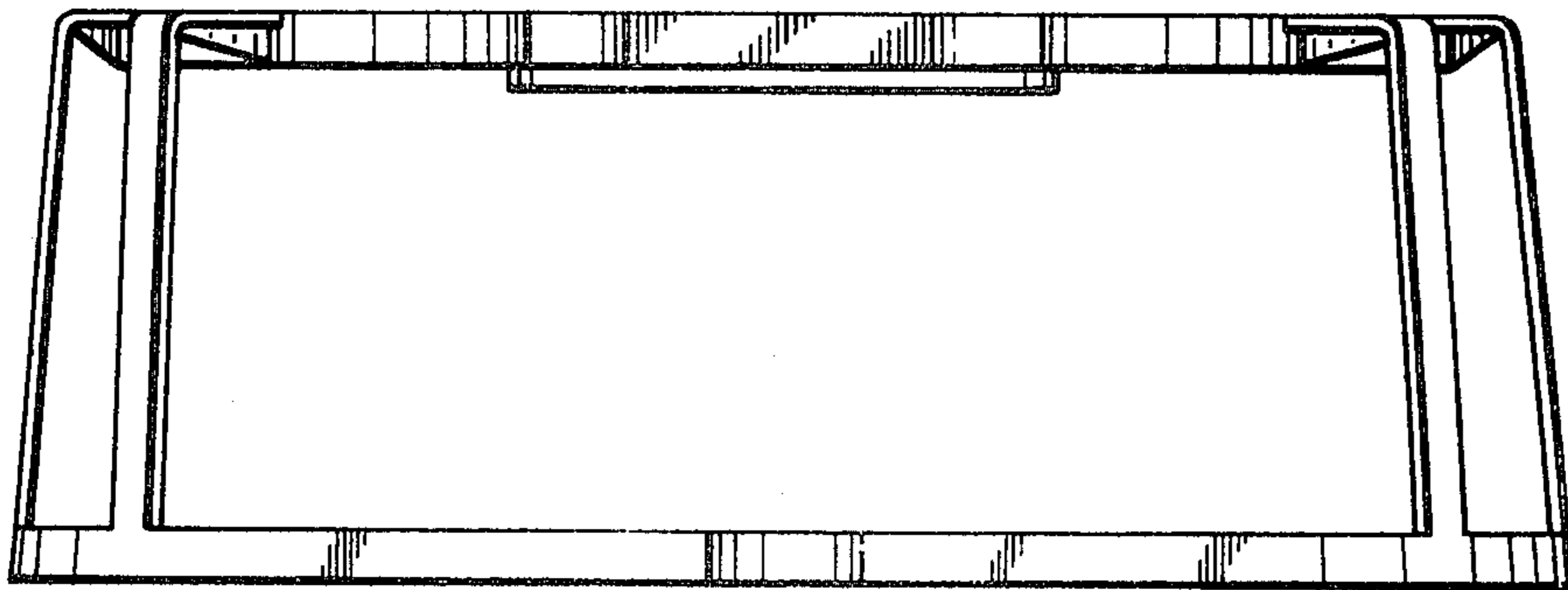

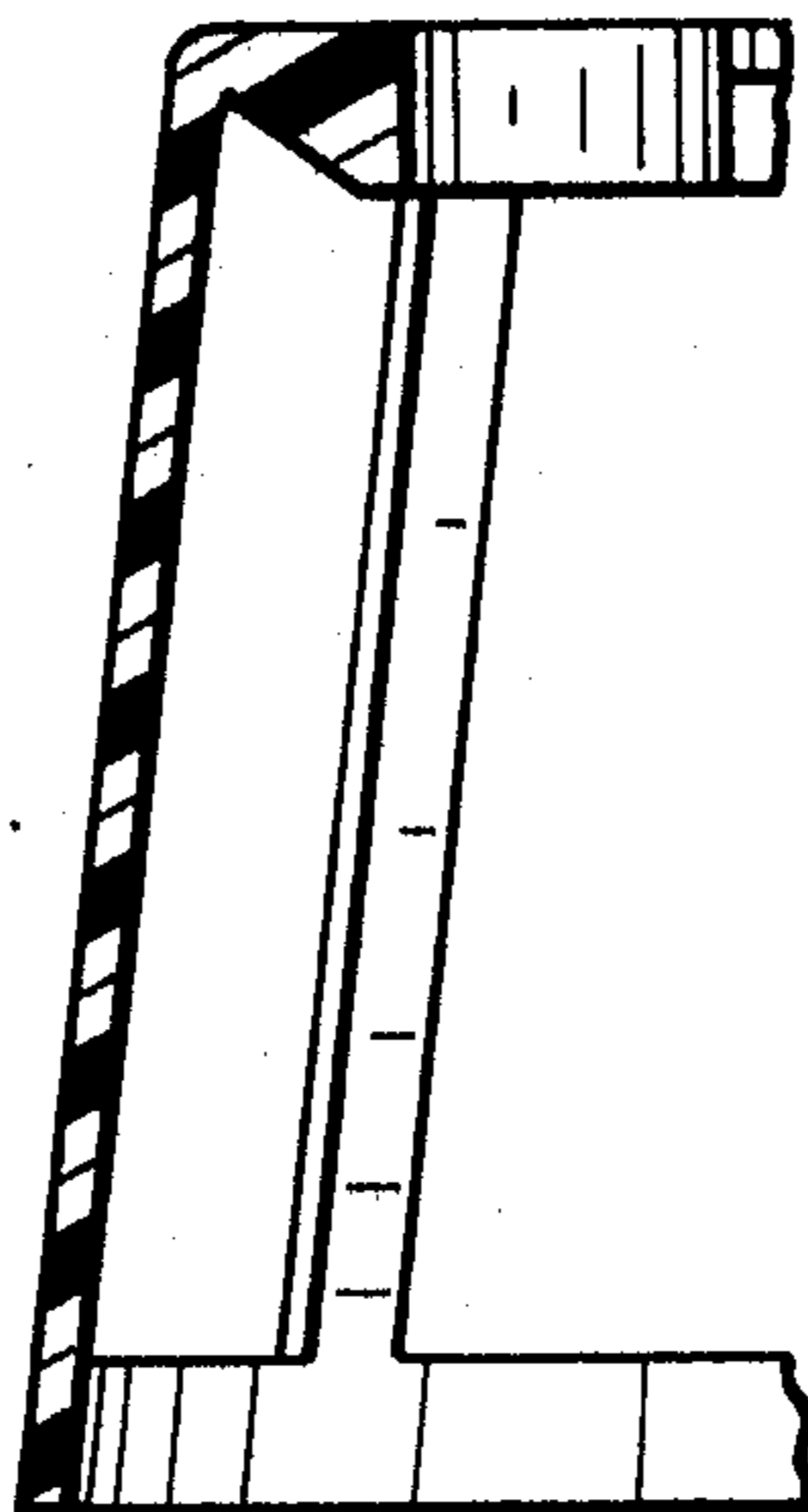
